DRY DOCK.

COMMITTEE ROOM, CITY HALL, Oct. 18th, 1910.

To the City Council :

GENTLEMEN, - The Special Committee on Dry Dock begs to report as follows :-

1. By the Dry Docks Subsidies Act, 1910, (Chapter 17 of the Statutes of Canada for 1910), provision is made for the payment of subsidies by the Federal Government to incorporated companies undertaking to build dry docks of certain classes, with two of which only we are concerned, namely :—Those of the first class, costing not more than \$4,000,000, whose length on bottom is 900 feet, width 100 feet and depth of water over sill at high water, ordinary spring tides, 35 feet; and those of the second class. costing not more than \$2,500,000, whose length is 650 feet, width 85 feet and depth 30 feet (Sec. 7.) Before a subsidy is granted the Governor-in-Council must be satisfied, on the report of the Minister of Public Works, that the dry dock is needed in the public interest. (Sec. 3, SS. 2). To docks of the first class, above mentioned, the Government may grant a subsidy of $3\frac{1}{2}$ p. c. of the cost for a period of thirty-five years, and to docks of the second class, a subsidy of $3\frac{1}{2}$ p. c. of the cost for a period of twenty-five years. (Sec. 8) The value of an existing dock, capable of enlargement, so as to become a dock of the first class or a dock of the second class is to be taken into account for the purposes of the subsidy calculation as part of the cost under the Act (Sec. 4); but such value has to be determined before the agreement is entered into with the Government. (Sec. 4, SS. 3). The cost on which the subsidy shal be calculated shall include the cost of all necessary equipment and plant and any sum expended or to be expended for a site. (Sec. 5).

Under the provisions of the above mentioned Statute, the Directors of the Halifax Graving Dock Company, Limited, are considering the matter of enlarging the existing dry dock in Halifax, and Mr. S. M. Brooktield, on their behalf, has approached the Committee with a request for civic assistance to the project. It has not yet been made clear to the Committee whether it is intended to enlarge the dock, so as to bring in within the designation of docks of the first class or that of docks of the second class.

2. Mr. Brookfield has asked in the first place for a subsidy from the City to supplement whatever Federal subsidy the Company becomes entitled to under the Act. The civic subsidy sought is \$5,000 a year for a period of twenty-five years. The Committee has heard several citizens, both in support and in opposition to the application for such subsidy, and the majority of the Committee (one member dissenting) are of opinion that no good reason has been shown for giving the cash subsidy asked for.

3. Coupled with the request for a cash subsidy was an application to exempt the dock from taxation for a period of twenty-five years. The Committee was asked not only to exempt the additions or extensions to be made to the existing dock, but also to exempt the existing dock itself, which is now assessed, under the provisions of Chapter 77 of the Acts of 1903, at \$200,000. The conclusion arrived at by the majority of the Committee was that the existing assessment should stand, but that any additions or extensions made to the dock should not be taxed in the period during which the Federal subsidy is paid.

DIFFERENTIAL FREIGHT RATES.

November 9th, 1910.

To His Worship the Mayor and Members of the City Council:

GENTLEMEN, — For some years the Council of the Halifax Board of Trade has been grappling with the differential rate of one cent per hundred pounds on import and export freight which exists against this port, and acting on the advice of expert traffic men, we first took up the case against the Intercolonial Railway with the result that Mr. Tiffin, General Traffic Manager, has stated that his railway is willing to place Halifax on the same basis as other Atlantic ports, but are unable to carry it into effect on account of an agreement between the Intercolonial Railway and the Grand Trunk Railway, which was ratified in Parliament in 1899.

Previous to 1898 there was a difference of several cents against Halifax in favor of other Atlantic ports, but that year a tentative agreement was agreed to with Mr. A. H. Harris, then General Traffic Manager of the Intercolonial Railway, reducing it to one cent, with the understanding that should this difference prove disadvantageous to the port it would be rearranged.

Without the consent of the Halifax merchants the one cent extra charge was incorporated into the agreement previously referred to, and we are now taking the case against the Grand Trupk Railway before the Railway Commission, and have reason to believe that we will be successful in having this differential removed.

NOVEMBER 10TH, 1910.

We have recently held two joint meetings of the Council, Commercial Committee and Transportation Committee, at which your Council has been represented; at the last meeting held on November 2nd, it was decided to employ Counsel, and the matter of financing the case was also discussed and the following resolution passed :--

"That in the opinion of this joint meeting the City Council should vote a sum of money not exceeding \$500, towards defraying the cost of case in question."

As the matter is one of very great importance to this city, as the removal of the differential will greatly increase the export and import trade of the port. I have been desired to write the foregoing facts and ask your honorable body to favorably consider the financial assistance, as outlined in the above resolution.

To His Worship the Mayor and City Council: HALIFAX, N. S., Nov., 7th, 1910.

GENTLEMEN, -I am not satisfied with the working of the water meters attached to my properities 96 and 106 Granville Street.

I am convinced that these water meters are useless for recording the actual quantity of water passing through them.

In a large number of instances in this City, all of which should have come to your notice meters are alleged to have registered, and citizens have been charged with hundreds of thousands and millions of gallons of water which they never used and which never and your officials without the apparent knowledge of the City Council.

In many other instances much larger quantities of water are belived to pass through the meters than the readings show.

Thus some citizens are relieved of their fair proportion of water rates, while the rest of the people have to pay a great deal more than their fair share.

I believe that much more water is used in the buildings Nos. 96 and 106 Granville Street than the meters record, and that consequently I am not paying my fair proportion of water rates on those proporties. I am therefore removing the meters so that they may be tested by some competent and unprejudiced authority; and I again repeat the request made to your officials over a year ago, to be assessed at the same legal flat rate for water on these properties that other citizens are taxed on their assessed values.

Sin - In reference to your article in last evening's Recorder on "City Planning, I wish to call attention to the hideous m ss which the railways have made of the street leading out of the north end of the City during the last few years and apparently with out serious protest from either the legal custodians of our public rights or the citizen thomselves.

When the Cotton Factory siding was laid the I C R, was permitted to take the whole east rn side of Kempt Road for the track instead of carrying it through the adjoining fields, and although the railway has since acquired this property the track still remains on the public street, and its use is a continued menace to the public.

Since the erection of the new Round House this Cotton Factory Branch has become a main line and has very dangerous crossings both on Lady Hammond Road and Campbell Road. Gottingen Street and Longard Road are important City thoroughfares, but they have both been completely cut off from the water fronts at their north ends.

The worst damage, however has been done to Campbell Road, which has been practically ruined for driving purposes by the railway. This street is supposed to be sixty feet wide, but is now barely eighteen feet in many places.

GENTLEMEN,—Doubts having arisen as to the meaning of Legislation passed 1910 in re School Board matters, and feeling that these should be set finally at rest in order to place the financial relations of the City Council and the School Commissioners on a clearly defined basis, I would ask that your Council take this matter up and finally dispose of it

I am convinced from the attitude of the School Commissioners in the case of Unexpended Balances that it will be necessary in order to have same passed to credit of Sinking and Reserve funds to have the amount of same deducted when ascertained from next payment by the City to the School commissioners, unless said unexpended balance has been already passed over by the School Commissioners to the Trustees of the Sinking and Reserve Funds; also that the Board of School Commissioners be placed in exactly the same position as other spending departments in re limitations for expending in any year from that year's appropriation only instead of carrying same continuously from year to year; and further that the Act put in force shall state at what date it becomes iaw and that the full intention of the City Council as laid down by Chapter 47, Acts of 1910, sec 9 be confirmed as well as Chapter 48 sec. 817, otherwise we will be again placed in the position of seeing unexpended balances used contrary to the meaning of the City Charter as has been done in the past two years to the extent of \$7.861.68 simply because a commission which draws 88% of its revenues from the ratepayers of this City do not consider they are bound by the general requirements of the Charter.

I do not think that the legislation of 1907 Chapter 67 amending the Education Act so far as it relates to the 'ity of Halifax deals at all with the refunding or payment of outstanding debentures issued by the School Commissioners previous to that date and as there are \$64,600 of $4\frac{1}{2}\%$ debentures falling due July 1st, 1911, it will be imperative that an Act be secured at next-ession of the Provincial Legislature making it clear that the City of Halifax deal with said amount as well as others falling due later.

Trusting your Council will agree with me in this matter, and that same may have your early attention, I am,

At the request of the Committee Messrs. McCurdy and Covert, representing the promoters of the proposed new Company, and Mr. J. J. Ritchie, Solicitor for a number of woodworking and ratail lumber concerns, appeared before and addressed the Committee.

Mr. McCurdy submitted and read an amended proposal to the one submitted to the Council on the 10th ult. containing a clause that the Company be exempt from taxation for twenty years, also free water for the same period, and further that the assurance be given that the Council will undertake to put the water system in the vicinity of the Works in such a condition that insurance rates will not be raised on Company's property.

Mr. J J. Ritchie asked that a clause be inserted in the Agreement (if made) protecting the interests of small contractors and dealers in builders' supplies who are large taxpayers, also to restrict the right of the proposed new Company to go into the retail business in competition with them.

The Committee decided to adjourn the meeting until to-morrow, Friday at 2.15 p. m., to make up their report.

I find the City's scurity in the Company as required by Acts 1907, Chap. 70, amended by the Acts of 1908, Chap. 73, to be as follows :--

I have in my possession fire insurance policies to the amount of \$101,000 00, fully paid to April 7th, 1911.

The total bond indebtedness of the Company to the City is \$135,476.00, on which all interest has been paid to June 30th, 1910, and there is in their Sinking Fand to November 11th, 1910, the sum of \$9,803.53.

Read letter A. M. Bell re Silliker Car Company.

HALIFAX, N. S., November 17, 1910.

J. A. CHISHOLM, ESQ, Mayor,

City.

DEAR SIR, —Referring to the matter of the Silliker Car Company and the relation of the City Council to the proposals to come before it, it occurs to me that few more important questions have ever been brought before that body. I am presuming that there will be no disposition to interfere with the loan to the Company. The City has ample scurity, and the additional capital, part of which is to be invested in buildings and machinery, will give still further security for this loan.

The only other matter in which the City Connell it interested is that of exemption from taxation for ten years and an assessment limited to \$50,000 for another ten years. As three years have passed there is now only seven years more and this is the first good reason for not interfering with existing conditions. Seven years is a very short time in the history of a city or a corporation, and looking at the matter from a comercial standpoint the first matter and the large field bunded by North Street. Windsor Street and Chebucto Road were assessed jointly at the sum of \$15,000 00 before these works were established. To-day the value of these properties, exclusive of the Car Works, is at least \$150 000.00, while in various other parts of the Caty other houses have gone up as the direct result of this industry. To-day I am told that Halifax is sending \$6,000.00 per week to Ontario for beef and mutton, and the Silliker Car Company his been drawing from the West and other points say \$10,000.00 per week, \$4,000.00 of which has been circulated in wages.

The Dry Dock received \$200,000.00 from the City in cash and freedom from taxation for twenty years fis annual pay roll has not averaged over \$70,000.00 to \$80,000,00 per annum. The Cotton Factory \$65,000.00 The Sugar Reinery about \$30,000,00. The Silliker Car Co. has this year spent in wages more than any two of these, probably as much as the three put together. They expect to employ many more men and thus still further increase their pay roll, but it depends entirely on the action of the Council.

If the Council refuses to extend to the new Company the privileges held by the present Company what will it mean? First it will mean a direct loss to Halifax citizens (and a few outsiders) of \$375,000 00 in stock subscribed and pand for, and it will be a blow from which Halifax will not recover for many a year to come. It will be a repetition of the Sugar Refinery and the Cotton Factory—those who have invested will lose everything. The works will go into the melting pot, be bought in by those who are proposing this new move, and will go on and succeed. At a very largely attended meeting of the shareholders of the Company held a few weeks ago after the scheme was laid before the meeting, a unanimous vote was passed favoring the project, and it will be a grave blunder if the City Council puts a straw in the way.

In addition to the amount invested in the stock, the Directors are personally responsible for a very large amount to their brokers, and there are also heavy trade liabilities, much of which is to Halifax houses. Together these amount to about \$400,000 00, all of which will be jeopardized if any hindrance is put in the way of a reorganization. I do not think the members of the Council would knowingly do their fellow citizens such harm as they would if they vote to repeal any part of the present arrangement, and I write thus fully so that you may understand the situation and act intelligently when the matter comes before you. Those who now control the Company state most positively that unless the City agrees to continue to the reorganized Company all the privileges it at present enjoys, it will shut down the works, and when they come under the Sheriff's hammer will buy them in. If this happens Halifax citizens stand to lose altogether not less than \$500,000.00.

Read report Finance Committee re Silliker Car Company,

HALIFAX, December 9th, 1910.

The Finance Committee beg to report as follows : --

The Silliker Car Company, Limited, was organized in 1907, with a total bonded indebuedness to the City of \$135,476, on which all interest has been paid to June 30th, 1910, and the sinking funds to November 1st, 1910, \$9.803.52, leaving a balance due on this bonded indebtedness of \$125,672 48.

Common stock was issued at par to the amount of about \$259,000. Subsequently, they issued preferred stock to the amount of about \$125,000, the great r part of which, we understand, has been paid in.

By a letter dated October 27th, 1910, F. B. Mcturdy & Co., acting on behalf of a proposed new company, proposing to take over the Silliker Car Co. Ltd., asked that the City of Halifax continue to the new Company all the rights and exemptions now enjoyed by the Silliker Car Co., Ltd., under thapter 70 of the Acts of 1907, entitled "Au Act to authorize the City of Halifax to assist the Silliker Car Co company, Limited." In a letter addressed to the Chairman of the Finance Committee, dated December 5th, 1910, F. B. Mcturdy stated that "more capital is required than at first thought necessary, owing to the discovery that losses have been suffered which were not known to us on October 27th. We are obliged to request that the City grant exemption from taxation for twenty years, furnish free water for the same period, and undertake to place the water service at the works in the condition required by the Board of Fire Underwriters, so that the insurance rate may be lowered "

In a letter from Mr. McCurdy, addressed to the Finance Committee, dated December 9th, 1910, Mr. McCurdy varies the above requests as will appear by his letter, of which the following is a copy:-

"Referring to my letter of yesterday, the various newspaper and other reports of the concessions which the Nova Scotia Car Works require from the City before money is available for the use of the Company, differ so much from one another that I wish to here restate what is required.

My letter to you yesterday asked that the City grant :--

1.-Complete exemption from taxation for twenty years.

2.-Free water for twenty years.

3.—Undertake to place the water service at the works in the condition required by the Board of Fire Underwriters so that insurance rates may be lowered.

I saw that it was impracticable that the Council could make any definite progress

with the latter of these three at the present moment, and I therefore off-red to withdraw that provided the Council would pass a resolution recommending that this work be undertaken so soon as practicable

To meet your objections to free water I also offered to modify No 2 so that free water be given only to the extent of five million gallons per year, (I am informed the quantity used by the works this year was some 15,000,000), but in return for this modification that No. 1 should be extended by fixing the valuation of the properties for taxation purposes for the ten years following the twenty years exemption at the assessed value of the land before any buildings were erected on it.

1 wish to be explicit, for in business of such importance to all concerned it would be unfortunate if there were a misunderstanding."

The Nova Scotia Car Company, Ltd., has an authorized capitalization of \$3,000,000, divided into (a), 10,000 first preference shares of \$100 each, bearing a seven per cent cumulative dividend redeemable at \$110; (b) 250,000 divided into 2500 second preference shares of \$100 each, bearing seven per cent non-cumulative dividend payable after all dividends are paid on the first preference shares and redeemable at \$110 per share; (c) 500,000 divided into 5000 third preference shares of \$100 each and bearing a non-cumulative dividend of six per cent. ranking after all dividends are paid on the first and second preference shares; (d) \$1.250,000 divided into 12,500 ordinary shares at \$100 each

They propose at once to issue \$600,000 of first preferred stock, \$125,000 of second preferred, and \$250,000 of third preferred. The \$125,000 of second preferred gues to the present preference stockholders of the Silliker (ar Company, Limited; the \$250,000 of the third preference gues to the common shareholders of the Silliker Car Company, Linued, dollar for dollar in each case.

The proposed charter of the Nova Scotia Car Company, Limited, contains all the powers contained in the old charter of the Silliker Car Company, Limited, besides some additional powers as regards capital, etc.

The members of the Finance Committee are so divided in opinion that it is necessary in this report to give their individual views.

Aldern an Bligh agrees to grant the concession of exemption from taxation as asked for twenty years, but no concession as to water.

Alderman Thompson would recommend the continuance of the Silliker Car Company's concessions

Alderman Hoben and Alderman Smith are willing to grant exemption from taxation for twenty years as asked. They will grant the new Company free water for twenty years to the extent of five million gallons per year.

The Committee recommend that the Council pass a resolution recommending that the work of improving the water service at the works be undertaken as soon a^{s} practicable. All are agreed, also, to let the balance due on the mortgage to the City remain as at present, the new Company undertaking all the obligations of the Silliker Car Company in respect to the same.

Alderman Whitman and Alderman Edwards are not agreed to give the exemption of tavation of water at all.

WHITMAN,—I had a notice to attend a meeting of the Finance Committee to-morrow (Thursday), but in conversation with Mr. Bligh over the telephone, he states that certain members of that committee want to attend a meeting of the School Board, and that it would suit them better to postpone this meeting until early next week.

As I must go to Montreal to-morrow morning on business in connection with the Car Company, this will also suit me equally well.

I shall telegraph Mr. Covert from Montreal as to the exact date of my return, and would be glad if you could arrange to call a meeting then on short notice.

It seems to me it would be well to have the meeting held before the regular meeting of Council next Thursday night, and if possible, before the meeting of shareholders next Tuesday.

Our principals intend to request that you grant exemption from taxation for twenty years for the Nova Scotia Car Works, free water, and an undertaking from the City to place the water service at the works in the condition required by the Board of Fire Underwriters, so that the insurance rates may be lowered.

If satisfactory arrangements can be made, it is the intention of the new company to spend a sum of money, from 60,000 to 100,000, on additions and improvements, which will of course improve the City's security on their present outstanding loan, and it is expected that the output at the works will be at least doubled. This will of course entail the employment of a large additional number of men, a matter in which the City is greatly interested.

DEAR SIR.—Referring to our letter of October 27th, 1910, to the Mayor with respect to exemptions, a modification of our original offer has been presented to and accepted by Silliker Car Company, Limited, involving further concessions from the City than those asked for in our letter to the Mayor More capital is required than was at first thought necessary, owing to the discovery that losses had been suffered which were not known to us on October 27th.

We are obliged to request that the City grant exemption from taxation for 20 years, furnish free water for the same period, and undertake to place the water service at the works in the condition required by the Board of Fire Underwriters, so that insurance rates may be lowered. Subscriptions for \$600,000, new capital to be put into the business, are based on our securing the concessions asked for.

We have no wish to unduly hurry the consideration of such an important measure, but it is only fair to point out that it is of the utmost importance that whatever is done done quickly in order to continue the Car Works a going concern.

GENTLEMEN. — Referring to my letter of yesterday, the various newspaper and other reports of the concessions which the Nova Scotia ('ar Works require from the City before money is available for the use of the Company differ so much from one another that I wish to here restate what is required.

My letter to you yesterday asked that the City grant :--

- 1. Complete exemption from taxation for twenty years.
- 2. Free water for twenty years.
- 3. Undertake to place the water service at the Works in the condition required by the Board of Fire Underwriters, so that insurance rates may be lowered.

I saw that it was impracticable that the Council could make any definite progress with the latter of these three at the present moment, and I therefore offered to withdraw that, provided the Council would pass a resolution recommending that this work be undertaken so soon as practicable.

To meet your objections to free water I also offered to modify No. 2, so that free water be given only to the extent of five million gallons per year. (1 am informed the quantity used by the Works this year was some 15,000,000), but in return for this mod fication that No 1 should be extended by fixing the valuation of the properties for 'taxation purposes for the 10 years following the 20 years exemption at the assessed value of the land before any buildings were erected on it.

I wish to be explicit, for in business of such importance to all concerned it would be unfortunate if there were a misunderstanding.

Moved by Alderman Smith, seconded by Alderman Hoben, that the Council do now adjourn until 3 o'clock to-morrow afternoon.

COUNCIL CHAMBER, CITY HALL, December 10th, 1910.

A meeting of the City Council was held this afternoon at the above named hour pursuant to adjournment. Present His Worship the Mayor and Aldermen Wilson, Shaffner, Whitman, Hebb, Bligh, Smith, Douglas, McManus, Hubley, Kelly, Hoben, Thompson, Corston, Martin, Edwards, Rankine and MacKenzie.

His Worship the Mayor stated a delegation from the Anti-Tuberculosis league now present desired to address the Council.

Moved by Alderman Smith, seconded by Alderman Hebb, that said delegation be heard. Motion passed unanimously.

The Council is now addressed by Dr. John Stewart and Mr. L. J. Mylius. Dr. Stewart stated that the present request of the League was that the City make a grant of fifty cents a day for each patient in the proposed tuberculosis hospital, not exceeding ten patients a year which would amount to about \$1800.00 a year, and that a committee be appointed to confer with the League on the subject.

Moved by Alderman Whitman, seconded by Alderman Hebb, that a special committee be appointed to confer with the Anti-Tuberculosis League on the matter of the proposed establishment of a tuberculosis hospital, and that the matter of a civic grant for the same be referred to the Finance Committee for consideration when making up the estimates. Motion passed.

His Worship the Mayor nominates as such special committee Aldermen Wilson, Hebb, Douglas, Kelly Martin and MacKenzie. Approved.

The Council, pursuant to adjournment, resumes consideration of the Finance Committee in re Silliker Car Company.

Alderman Edwards asked for a ruling as to whether any member of the Council who may be an underwriter of stock of the proposed new company or a creditor of the Silliker Uar Company is entitled to speak or vote on this matter. The City Solicitor gave as his opinion that no member of the Council could speak or vote upon any question in which his personal interests are involved.

Alderman Edwards asked for a ruling on the point that if the concessions asked for by the company are granted the action of the Council would be invalidated if aldermen personally interested vote for the granting of the concessions.

The City Solicitor stated that if the total num er required for a majority vote included the vote of any disqualified member the action of the Council would be void.

Moved by Alderman Hebb, seconded by Alderman Whitman, that the report of Finance Committee containing F. B. McCurdy & Co's letter be again read. Motion passed.

The same is now again read.

Moved by Alderman Douglas, seconded by Alderman McManus, that the clauses of the report not already dealt with be taken up clause by clause.

Alderman Hoben submits the following amendment :

Resolved, that the City of Halifax do authorize and empower the application to the Legislature of Nova Scotia at the ensuing session for such legislation as shall enable the City to give and grant to the Nova Scotia Car Works, Limited, when incorporated, when and as soon as it has purchased the property of Silliker Car Company, Limited, exemption from taxation for a period of twenty years covering the real and personal property now used and owned by said Silliker Car Company, Limited for manufacturing purposes, and also such legislation as shall enable the City to furnish to said Nova Scotia Car Works, Limited, five million gallons of water free of cost or charge yearly for a period of (20) twenty years and the balance of all water used at the minirum rate for manufacturing purposes charged by the City.

Moved by Alderman Hoben, seconded by Alderman Smith.

His Worship the Mayor ruled Alderman Hoben's amendment out of order, it not being an amendment to the original motion.

Alderman Douglas and McManus, with the consent of the Council, withdraw the original motion, and Alderman Hoben's proposed amendment becomes the resolution before the Council.

Alderman Edwards submits the following amendment :

Whereas, the matter of granting certain concessions asked for by the Nova Scotia Car Company involves a large sum of money and directly affects the taxpayers of this City and is a matter in which the ratepayers should be given an opportunity of expressing an opinion.

Therefore be it resolved, that this matter of concession to the Nova Scotia Car Company be submitted to a plebiscite of the taxpayers on the fourth Wednesday in April next or at any other date that this Council may agree upon.

Moved by Alderman Edwards. Amendment not seconded. Ex-Mayor J. C. Mackintosh being in the Chamber was invited to and accepted a seat beside His Worship the Mayor.

Alderman Wilson submits the following amendment.

That the Nova Scotia Car Company be granted the following concessions by the City of Halifax—Ten years' tax exemption; a further term of ten years' taxation at \$50,000.00 valuation; the continuation of the Silliker Car Co's loan on the same conditions. These concessions to go into effect when the Nova Scotia Car Company has completed the purchase of the Silliker Car Company on the basis contained in their letters to the Finance Committee and the necessary legislation is procured.

Moved by Alderman Wilson.

Amendment not seconded.

Moved in amendment by Alderman Thompson, seconded by Alderman Wilson, that the concessions asked for by the Nova Scotia Car Company and incorporated in Alderman Hoben's resolution, with the exception of granting them 5,000,000 gallons free water yearly be granted.

Amendment put and lost, 3 voting for the same and 14 against it, as follows :--
