# MOTOR FIRE APPARATUS.

Halifax, N. S., May 6th, 1912.

# To the Committee of Fire Wards:

Gentlemen:--I find on enquiry that motor driven or motor drawn fire apparatus is used to a very large extent all over the world specially in Great Britian and the United States.

Canadian cities using such apparatus include Montreal (1 piece) Toronto, Winnipeg, Vancouver (12), Victoria, Prince Rupert, Saskatoon, New Westminster and Amherst, N. S.

The following advantages are claimed for motor driven apparatus:

Lower cost of maintenance. A matter dealt with at the end of this memorandum.

Speed. Automobile fire equipment has the prime of speed over horse drawn apparatus; speed in getting started, in going to a fire and also in avoiding traffic on the way.

A fire cannot be reached too quickly. The presence of apparatus in the first few minutes will frequently svoid ringing in a second or third alarm.

Several pieces of apparatus are generally combined into one piece of motor driven apparatus, e. g. chemical, ladder truck; capacity for seven men and necessary hand tools and implements.

Pumping engine, 1200 feet hose, and capacity for ten or twelve men.

This enables a whole fire department to arrive on the scene all at the same time

The Fire Chief, Lowell, Mass., writes:—"I prefer motor driven (apparatus) if it should cost a little more than the horse driven because of the time saved in getting to and from an alarm, as all firemen know that the first few minutes are worth more than hours after it if a little late."

Fire Chief, Haverhill, Mass., says:—"I consider that (even if) the expense is more than that of the horse drawn apparatus (it) is not to be compared, as the speed with which you can reach the fires, no matter what the distance, increases the efficiency of the department."

Area of Operation. Having greater speed and no muscles to tire, the radius of operation of motor apparatus is considerably larger than horse drawn equipment. As a consequence, a city with several districts covered by motor apparatus, dispenses with one or more fire stations.

In Springfield, Mass., for the year ending Nov. 30, 1909, 20 pieces (including 3 motor driven pieces) answered 2176 alarms, an average of 108.8 alarms apiece.

The three motors averaged 252 alarms each.

# The 17 horse pieces averaged 83.5 alarms each.

Chief, Haverhill, Mass., "We have been able to save a number of houses in the outlying districts which we would not have been able to do with the horse drawn apparatus."

Hill Climbing. In a test run at the Ontario Association of Fire Chiefs at Guelph, Ontario, in December, 1911, an English machine went up a 16 per cent. grade covered with four inches of snow on a glare of ice, with apparent ease. The machine carried two 35 gallon chemical tanks, 1200 feet of hose and twelve men.

Chief, Haverhill, Mass.:--"Here are some of the grades which we have tried with the combination:

Main Street, 5 3-10% high gear at 15 miles per hour.

Chick Ave., 16% low gear at 6 miles per hour.

School Street, 8% for 540 feet and 10% for the rest of the way, intermediate gear, 10 miles an hour on last 10%."

Space. A considerable portion of the fire department buildings is occupied at the present time with stables for horses, accomodation for hay, feed, &c.

Sanitation. While the purchase of one piece of automobile apparatus will not revolutionize the fire department, the sanitary advantages should be pointed out.

The necessity of maintaining stables is unavoidable where horse drawn apparatus is used. These stables mean the presence and accumulation of manure which is a menace to the health of the firemen iving in the fire houses, particularly in summer weather.

*Price.* Prices vary according to type of apparatus and power of engine, from \$4,500 to \$12,000.

In my enquiries I have endeavored to obtain information on the following points:

1. Snow interference.

2. Mechanical troubles with apparatus.

3. Life of apparatus.

4. Cost of maintenance.

Snow. The Chief of the Fire Department Montreal writes:-

"I may say that since April 1909, the City of Montreal has furnished me with an auto for my use as Chief of the Fire Brigade, and ever since, no weather has prevented me driving out my car."

W. C. Blackstock of the Industrial Motor Trucks, Ltd., Toronto, writes:-

"As to the question of usefulness of the motor driven apparatus under bad weather conditions, the only chance of any trouble would be very deep snow, and if proper chains were used we think the conditions would have to be abnormally bad to cause any trouble. We have had no weather conditions this year in Toronto which would have prevented motor driven apparatus from reaching a fire."

Fire Chief Ten Eyck of Hamilton, writes regarding a combination chemical and hose car:-

"It will plow through the snow two feet deep or any place it can get good traction. We have had trouble where the snow was very deep, that is, in heavy drifts when the snow was packed very hard."

Motor apparatus is in use in St. Petersburg, Moscow and Odessa, where the weather conditions in this respect are exacting.

It should be pointed out that with the usual fall of snow in Halifax our heavier apparatus is never able to leave the streets which have been swept by the street railway.

Mechanical Trouble. In reports made by 17 fire departments to United States manufacturers, covering 3452 alarms, the cars answered all but five alarms, three while car was undergoing repairs, and twice because of inexperienced drivers.

Most of the trouble reported by fire chiefs is due to the use of air-inflated tires. Where solid rubber tires are used the expense and trouble are minimized.

In this connection it should be pointed out that in the Halifax department sick or injured horses may at any time prevent the use of apparatus.

Depreciation. One manufacturer writes:-"The method now recognized (for) calculating depreciation) by experts as the best, as well as the most logical, is that known as depreciation by mileage. Taking the case of a three ton commercial truck, the life of which is assumed to be 140,000 miles, some 15% to  $17\frac{1}{2}\%$  is written off each year for depreciation, but it must be remembered that in this case an annual mileage is calculated upon. Considering the comparatively small mileage of a fire truck, depreciation ought to be amply covered by writing off 5% or 71% each year."

Maintenance. The item of maintenance would seem to be largely in favor of the motor driven apparatus. Speaking generally, the motor driven apparatus costs little except when at work; whereas the up-keep of horses is a continuous expense, whether they are idle or at work.

The cost of maintenance of motor driven apparatus depends largely upon the mileage travelled.

The following is the report at the Syracuse Firemen's Convention, arrived at by an investigation of the experience of various departments throughout the country.

Chief, New York:--"The comparative cost of maintenance is very much in favor of motor apparatus."

Commissioner Waldo, of the New York Fire Department, reports his three ton Knox high pressure hose waggon costs \$85.00 per year including gasolene, oil and repairs, and answers something like 250 alarms a year in the down-town district, having been in commission since March, 1909.

This department now has in service 20 pieces of motor apparatus. All heavy apparatus is equipped with solid tires. The Chief Engineer writes:—"The comparative cost of maintenance is very much in favor of motor over horse drawn apparatus. The cost of maintenance of our combination hose cars averaging annually responses to 150 alarms of fire, is about \$50.00 per year; that of the ladder trucks \$200.00."

*Passaic*, N. J. The Chief Engineer writes:—"In 1910 I had 27 horses in our department and at the present time I have only 7, and by May 1st I will not have a horse in the department. I figure we will save about 6,000.00 per year by the use of auto fire apparatus. The cost of maintaining our horses amounted to 6,500.00, and our autos only 1,000.00 per year."

Lowell, Mass., (2 pieces, buying 3 more,) "Outside of tire trouble the cost of maintenance last year was less than one half the cost of horse driven. I put on hard rubber tires on the big combination car last August and the cost since then for tire trouble has been very slight." Fire Chief, Lowell, Mass.

Haverhill, Mass., (3 pieces.) Fire Chief's car - Jan. 24th, 1910, to February 6th, 1912, has answered 552 alarms; travelled 6,100 miles.

The water pipe is laid in this block with the exception of about 135 feet, and I would recommend that the missing link be filled in. The estimated cost is \$270.00.

It would not be necessary to fix a special rate, as the whole cost of the extension would not be chargeable to Messrs. Barnes Bros.

6. If the men themselves were desirous of obtaining additional benefits these can doubtless be obtained by their paying the additional premiums.

7. It should be pointed out that while the amounts payable for disabilities other than death are in some respects more generous than those now paid by the City, the weekly indemnity payments (\$.00 a week) under the proposed insurance would be less than the amounts now paid the firemen when off duty (\$.00 call men to \$10.00 or \$12.50 permanent force.)

8. Several tenders for insurance on the lives of firemen have been received in answer to the advertisement for tenders. The cost of such insurance of course depends upon the age of the insured, and we understand the firemen themselves contemplate taking out such policies for the benefit of dependents, the premiums being paid out of their own Benefit Fund. If such life insurance is effected it would not be necessary that the benefits under the accident policies should cover accidental death, and it is probable that a small reduction could be effected in the amount of the premiums or the weekly indemnities slightly increased.

 If the firemen themselves decide to effect life insurance on their own lives, and the City decides to arrange for accident insurance, we recommend that a joint committee on insurance be organized.

Since the preparation of the foregoing paragraphs, respecting the subject of life insurance:

10. Your Committee have received tenders from the Mutual Life Insurance Company of New York and the Equitable Life Assurance Society of the United States.

11. The tender of the Mutual Life Insurance Company is based on the different ages and occupations of the various men in the force and may be said to be the ordinary straight life insurance of each man. The total amount of yearly premiums for such insurance on the 31 members of the permanent force would be \$1,436.29, and on the 89 members of the call force \$2,576.41-\$4,111.70.

These policies would be on a participating plan.

12. The tender of the Equitable Life Assurance Society deals with the 120 firemen constituting the Department as a group. The Society takes the entire list of firemen without regard to their individual insurability, accepting the present force as a whole without further medical examination. One blanket policy is issued covering all lives, with flexible provision for terminations and additions. The policy is issued on the term plan and renewable from year to year. The cost per man will work out to about \$1.38 per month for an indemnity of \$1,000.00 at death, the total cost being \$1,987.20.

13. The income of the Firemen's Benefit Fund averages \$325.00 a year, varying according to the number of fires in the year and the number of deaths in the force. The average amount paid by the City each year has been \$774.00 Total say \$1,100.00 a year.

14. Your Committee finds:

(1) That the insuring the men for accident and health purposes under the several proposed plans while somewhat less expensive to the City, would result in considerably less benefit to the men than under the present system.

(2) That the cost of insuring the men for life purposes would be considerably more expensive to the men than under the present system.

(3) The situation would be considerably modified with a proportionately larger permanent force, and in such a case it might be to the advantage of both the men and the City to consider such insurance.

Dear Sir:—I am in receipt of yours of this date re Police Officer Robert Young, and the extent of his several attacks of sickness, which have led up to the recommendation by the Police Committee of his Superannuation. Policeman Young during the last few years has been the subject of comparatively frequent attacks of rheumatism. During the past civic year to date he had five separate spells of sickness, covering a period in all of  $69\frac{1}{2}$  days, 68 of which were because of rheumatism. Taking his medical history, say from January 1st, 1908 to date, I find that for 1908 Policeman Young was absent from duty 63 days—56 because of rheumatism; in 1910 and 1911 he was absent  $40\frac{1}{2}$  days—39 because of rheumatism, and in 1912 to date 46 days because of rheumatism—in all 203 days.

I have no reason to think that these attacks of rheumatism will not recur in the same ratio of frequency.

# ABATTOIR.

#### Be it enacted by the Governor, Council and Assembly as follows:-

1. Every carcass of any animal slaughtered within the City of Halifax intended for food, or a portion or product thereof, prepared for food within the City of Halifax, shall be inspected during the whole course of such slaughtering and preparation in accordance with the provisions of "The Meat and Canned Foods Act" being Chapter , of the Act of the Parliament of Canada of the year

2. No person shall keep or sell or offer for sale within the City of Halifax any carcass of cattle, sheep or swine or any part or portion thereof, either by wholesale or retail, unless the same shall have been first inspected under the said "Meat and Canned Foods Act" and passed or approved by inspectors appointed thereunder.

3 Every person who by himself or his servant or agent slaughters any animal intended for food within the City of Halifax, or prepares any product thereof for food within said City or sells or keeps or offers for sale any such carcass of such animal or portion or product thereof as aforesaid, contrary to the provisions of this Act, shall be guilty of an offence, and on summary conviction shall be liable to a penalty of one hundred dollars (\$100.00), and in default of payment of such penalty to imprisonment for a term not exceeding three months, with or without hard labor.

4. The City of Halifax is hereby authorized and empowered to exempt from all civic rates and taxes, excepting water rates, for a period not exceeding ten years, the property real and personal of any company formed in the City of Halifax to construct and operate an abattior in the said City of Halifax, for a period not exceeding ten years, any such abattoir to be subject to such regulations as the City Health Board of the City of Halifax shall enact.

5. This Act shall not come into force until proclaimed by the Governor-in-Council.

And whereas said legislation provided that representatives of the press should be admitted to the meetings of a local authority corresponding with our City Council; but also provided that such a body may exclude such representatives at any meeting when in the opinion of a majority of the members of such a body present at such meeting such exclusion is advisable in the public interests;

And whereas said Chapter 43 of the said Parliament of Great Britain and Ireland further provided that representatives of the press should be excluded from any meeting of a committee of such a body as our City Council, unless such a committee themselves admitted such representatives to the meeting, which legislation was simply declaratory of the common law of England in force prior to such legislation;

Now therefore resolved that this Council hereby indorse the principle of the said Imperial legislation, and hereby declare that the City Council and the committees of the City Council shall, as regards the admission of representatives of the press to their meetings, have the same power and be governed by the same law as now exists in England.

I communicated with the petitioners, asking if they desired the curb and gutter only, and on receipt of an affirmative answer, I informed them that the construction of a curb and gutter on Young Avenue had been ordered for this year and it was unlikely that any amount in addition to the cost of this work, would be taken from the street appropriation.

The petitioners then sent a second petition asking for the construction of a sidewalk, curb and gutter.

A temporary remedy has been applied, but the same trouble is liable to occur unless a new sewer is constructed or the old one thoroughly cleaned out. It would cost more than is justifiable to clear out the old sewer and at the completion of such work conditions would still be unsatisfactory.

I would recommend that a new sewer be constructed in Bilby Street between Agricola Street and Kempt Road. The estimated cost is \$2,350.00; estimated assessment \$925.00.

The surface water has to run for a long distance, and at the intersection of Morris Street and Tower Road, the water collects during the cold season. Frequently the depth of water is so great that pedestrians cannot cross the street unless they are wearing high boots.

A short sewer on Morris Street from Park Street to Tower Road would carry off the greater part of the surface water and remove the nuisance complained of. This sewer would collect the water from seven catchpits, and is very necessary for City purposes. I would therefore recommend that it be constructed.

#### City Engineer's Office, May 10th, 1912.

Sir:—Messrs. W. R. & J. A. Scriven ask for a rebate in the charge made to them for water from September 1, 1911 to March 7, 1912—\$31.91—on the ground that there has been an extraordinary consumption for a short time during that period.

Section 6 of Chapter 84 of the Acts of 1909, provides that a reduction may be made if the amount of water charged ior is fn excess of that fairly required by the owner, and that such excess has passed through the meter by reason of unavoidable accident or otherwise, without the negligence, default or failure to use proper care and precaution on the part of the owner or o ccupant of such premises.

A similar claim was allowed once before for this property, as a leak had broken out underground, and had been running for a time before it was discovered. In the case under consideration, there was a leak which had not been discovered, but it was not underground as in the former case. It was in a part of the water system difficult of access, and Messrs. Scriven had no knowledge of it until they got their bill. They had no notice in the usual way by the meter reading, as the record left by the Inspector was unintelligible, the original record being hereto attached.

Section 467 of the City Charter requires that the owner or agent shall receive a record showing the amount of water consumed since the last reading. As the Meter Inspector has not complied with the law, I feel that it is my duty to recommend that a reduction should be allowed and I would therefore recommend that the bill, \$31.91 be reduced to \$14.26, the amount paid during the same period of the year previous.

City Engineer's Office, May 10th, 1912.

Sir:-Mr. J. P. Wambolt has applied for a reduction in the amount charged him for water by meter measurement for the period from September 1908 to March 1909.

I find on enquiry that there was, during the period mentioned, smallpox in the property, and it was impossible to correct the defects in the plumbing as the house was quarantined. Since the meter was installed, up to that period and during the period since that in question, the consumption has been very moderate.

Under the circumstances, in my opinion, as required by section 6 of Chapter 84 of the Acts of 1909, I have to report that the quantity charged for was in excess of that which was fairly required by the owner or occupant of the premises, and that such excess passed through the meter in consequence of a defect in the plumbing, which was not due to the failure of the owner to use proper care and precaution, in consequence of smallpox in the premises. I would recommend that the bill -\$1.78—for the period from September 1908 to March 1909 be reduced to \$2.74, the amount charged for the next half year.

#### His Worship the Mayor:

#### City Engineer's Office, May 10th, 1912.

Sir:-Mr. J. A. R. Wier is asking for a reduction in the amount charged for water by meter measurement at No. 166 Lockman Street during the period from March 1907 to March 1908.

I find on enquiry, that there was smallpox in the house and consequently the defects in the plumbing could not be attended to.

Under the circumstances, I must report, as required by section 6 of Chapter 84 of the Acts of 1909, that the quantity charged for was in excess of that which was fairly required by the owner or occupant of the premises, and that such excess passed through the meter in consequence of a defect in the plumbing, which was not due to the failure of the owner to use proper care and precaution, in consequence of smallpox in the premises.

The consumption since the period in question has been moderate. I would recommend, therefore, that the bill, \$37.16, for the year from March 1907 to March 1908, be reduced to \$8.20, which is the average charge for the four years since that.

# CITY ADVERTISING.

The Halifax Herald, May 16th, 1912.

#### L. F. Monaghan, Esq., City Clerk:

Sir :- We are in receipt of yours of May 13th, which reads as follows:-

"I have the honor to inform you that at a meeting of the City Council held on the 10th inst., the report of the Tenders Committee recommending the acceptance of your tender for advertising in the *Herald* was adopted." This is in reply to our proposition for advertising, which was as follows:-

"The rate for display advertisements in either the *Herald* or the *Mail* for the ensuing year is 1.25 per inch for the first insertion and 42c. for each subsequent insertion.

We shall be glad to publish whatever advertising is desired by the City at this rate, on the condition that of the total amount payable therefor during the year one-half shall be expended by the City in improving the sidewalks and streets of ward three and the other half is paid in equal parts to the Society for the Relief of the Poor and the Society of St. Vincent de Paul."

The City advertising aggregates about \$1,200.00 per year. We are willing to do all the City advertising this year without we ourselves receiving one cent of remuneration therefor, providing that the City will devote the money that would under ordinary circumstances be paid for this service—one-half to the much needed repairs of streets in Ward Three, which would be \$600.00 in round figures, and the other half in equal proportion for the Society for the Relief of the Poor and the Society of St. Vincent de Paul, about \$300.00 each.

We are aware that objection was made to this by Alderman Hawkins at the last meeting of the Council as not being in accordance with the strict letter of the law; but possibly this Council may feel that it is able to act according to the dictates of common sense in a case of this kind instead of indulging in splitting hairs over petty technicalities.

If the Council cannot see its way clear to accept our offer of doing city advertising free for the year 1912 and devoting the money that would otherwise be paid for it for the public purposes indicated— then we withdraw our proposition.

# REPORT SPECIAL COMMITTEE RE OWNERSHIP HORSE CITY PRISON.

# Committee Room, City Hall, May 3rd, 1912.

#### To His Worship the Mayor and City Council:

Gentlemen:-Your special committee appointed on the 12th April last, consisting of Aldermen Whitman (Chairman) Hoben and Martin, to decide upon the ownership of a horse claimed by the late ex-Governor Murray, beg to report as follows:-

Mr. F. J. Tremaine, Solicitor for the Murray family, appeared before the Committee and submitted a draft of a letter prepared by him and which was to be signed by Mr. Murray the day he met with the fatal accident outside of his office door. In this letter Mr. Murray claimed the ownership of a mare now at the Prison as his property, claiming that it was purchased by the late Alderman Lane to replace a horse belonging to the Governor which he claimed was kicked by one of the other city horses and received injuries which necessitated its destruction.

Mr. Macdonald, underkeeper, was called by your Committee, and stated that he was first employed at the Prison in 1892, that Mr. Murray had a black mare which was traded in 1894 for a bay horse and he gave \$25.00 to boot. He then sold this bay horse to Mr. Flemming for \$85.00 after using her about two years. This was a heavy horse and not suitable for light work and he used one of the City horses after in his waggon. In August 1900 a horse was reported dead to the Committee and the mare in question purchased from Estate of J. M. Geldert for \$150.00.

Mr. Keating, underkeeper, gave evidence that Mr. Murray brought a horse with him to the Prison and that he had shot him when he was twenty-seven years old because he had a bad spavin on the hind leg; that the Governor then purchased another horse; this was traded for another horse and the traded horse then sold.

Ex-Alderman Hubley was called by the Committee and stated that he and subsequent Chairmen of the Prison Committee thought that the horse bought from the Geldert Estate was the property of the Governor, he having always stated it was purchased to replace his own horse that had to be destroyed.

The Chairman procured the Minutes of City Prison Committee of Augus\_ 1st, 1900, when the death of a horse was reported. The Governor was then instruct ed to purchase a suitable one to replace it. This was paid for out of City funds' as per entry in City Auditor's report September 27th, 1900—Est. J. M. Geldert, \$150.00 for one horse.

After hearing the evidence Mr. Tremaine stated that owing to the death of Mr. Murray he was afraid he would not be able to prove ownership, and asked permission to withdraw the claim, which was granted.

# REPORT CITY PRISON COMMITTEE.

Committee Room, City Hall, April 18, 1912.

# To His Worship the Mayor and City Council:

Gentlemen:—Your Committee on City Prison beg to report that at a meeting held this day, there being present Aldermen Hawkins (Chairman), Harris and Hines, the following matters were dealt with:—

1. The Chairman reported verbally on the matter of the ownership of the horse that had been used by the late Governor and claimed by him as his property; and laid before the Committee the Minutes of a meeting of the Prison Committee held on the first day of August, 1900, when the death of a horse was reported. The Governor was then instructed to purchase a suitable one to replace it.' In the published report of the expenditure of the City Prison an item appears, on Sept. 27th, 1900, of \$150.00, paid Estate J. M. Geldert for a horse. This is the horse referred to and was paid for out of City funds and is certainly the property of the City.

The Chairman reported further that he had given instructions to Governor Grant to allow ex-Governor Murray the use of this horse whenever he wanted it, and that on all occasions, whether night or day, he was to accompany him and drive the horse, as he did not consider it safe for Mr. Murray to take the horse out alone.

Your Committee, after hearing the report of the Chairman and examining the evidence submitted, is of the opinion that the said horse is the property of the City, and endorse the action of the Chairman in reference to the orders given to Governor Grant to allow Mr. Murray the use of the horse whenever he so desired it while under Mr. Grant's charge.

Gentlemen:—The matter of assistance to the Dry Dock was reopened at the request of the Council of the Board of Trade, and Messrs. J. E. DeWolf, W. A. Black, Hector MacInnes, K. C., W. S. Davidson, J. W. Brookfield, A. M. Bell and A. Hobrecker, were heard in support of the application of the Dock Company.

At a meeting on November 10th, 1910, a report on this subject was submitted to the Council, and the conclusions arrived at by the Committee (Alderman Martin dissenting) are to be found in that report.

The undersigned have carefully considered the request to grant a subsidy of five thousand (\$5,000) dollars for twenty-five years and total exemption of the Dock during the same period, and have come to the conclusion that they cannot recommend the Council to grant the said privileges.

# CITY PRISON IMPROVEMENT.

Committee Room, City Hall, July 4th, 1911.

# To His Worship the Mayor and City Council:

Gentlemen:—Your Committee on City Prison beg to report that at a meeting held this day, there being present Aldermen Hawkins (Chairman) Harris, Connolly, McManus and Hines, the following matters were dealt with:—

1. Your Committee having under consideration the report of the Prison Committee November 19th, 1909, in re the matter of reorganization of the internal affairs of the Prison report and recommend as follows:—

(1) As directed by the provisions of the City Prison Ordinance, your Committee visited the Prison, and in company with the Governor has carefully inspected the buildings and the farm and rough land adjacent.

(2) The staff consists of the following persons:-

2. With the exception of Keeper Grant and Messenger MacDonald, the staff, owing to increasing age, cannot much longer perform their duties as efficiently as might be desired—Governor Murray, age 83; Keeper Higlett, age 76; and Keeper Keating, age 64.

3. The Prison building built in 1854 is well fitted for its purpose, is well built and in good preservation. The walls are kept whitewashed, the floors clean and the general interior appearance of the building is good.

4. The farm operated in connection with the Prison is in our opinion capable of producing under efficient management vegetables and hay sufficient for all the needs of the Prison.

5. The sanitary arrangements of the Prison are in need of improvement :--

(a) Although water closets were provided in all wards of the Prison in 1854, no water connections seem to have been made, and prisoners, male and female, are now forced to make use of most unsanitary outhouses and earth closets in the Prison yard. (b) The prison has no proper drainage or sewerage system The sewerage from the buildings and the earth closets have not been removed for a great many years, but is allowed to find its way down the hill in the direction of the Infectious Diseases Hospital.

(c) Although Rule 15 of the City Prison Ordinance No. 9 provides that "Every person shall be allowed the means of bathing the whole person once a week, either in cold or tepid water" no facilities whatever are provided for their doing so, and prisoners are consequently never allowed to take a bath during the whole term of their sentence.

(d) The ventilation of the cells and ward corridors is inadequate, particularly when the weather requires the windows to be closed.

6. Although Rule 19 of the City Prison Ordinance No. 9, directs that half a pound of bread be served to every male prisoner and four ounces to every female prisoner every day, this rule has not been observed for nearly thirty years, except on Christmas Day each year.

7. Although Rule 20 of the City Prison Ordinance requires that the prisoners shall eat their meals in their cells, no forks or knives are provided for this purpose and prisoners are obliged to make use of rudely made wooden forks.

8. Considerable use is made at the present time of some waggons, sleighs, blacksmithing tools and other property which the Governor alleges he owns. He also states that he owns three cows which supply the Prison with milk and which are pastured, with a horse, which he also claims he owns, on the Prison farm.

9. Although Rule 18 of the City Prison Ordinance directs that "The prisoners shall wear a uniform prescribed by the Committee, so distinguished by color or other peculiar marks as to make their escape more difficult," use is made of cast-off military uniforms.

#### Your Committee recommend:-

1. That in view of the long and faithful service for the City of William Murray during the past forty-nine years, both as a member (without pay) of the Fire Department and since 1882 as Governor of the Prison, he and Mrs. Murray be retired on 1st nex month with or without a pension as the City Council may see fit. Governor Murray has in the opinion of your Committee administered the affairs of the Prison economically and to the best of his ability, and owing to advancing years he deserves the very best treatment possible at the hands of the Council.

2. That George Grant, now underkeeper, be appointed Governor, and his wife Matron, at a salary of \$700.00 for both. Keeper Grant is an active man of middle age, well qualified by his experience as Keeper during the past nine years to be promoted in responsibility.

3. That Messenger MacDonald be promoted to the position of Underkeeper.

4. That legislation amending the City Charter at the next session be obtained providing for the consolidation of the Police and City Prison Committees, the Police Committee being appointed with jurisdiction over all matters now administered by the Police and Prison Committees. The proposed amalgamation would probably result in doing away with the necessity for a Messenger at the Prison, and the maintenance of a horse and special patrol waggon for the conveyance of prisoners from the Police Court to the Prison.

5. That the farm continue to be operated in connection with the Prison and brought up to the fullest possible production. At present the average value of the produce is about \$600.00, while the highest rent offered for the same is \$200.00 per annum.

6. That the existing outhouses now used as closets be done away with and hat the water service of the city be extended to the four ward corridors now used for the custody of prisoners and that the water closets be renovated and made use of as originally intended, and that a closet be provided in the house for the use of the Governor and his family.

7. That the proper and necessary drainage and sewerage facilities be provided for the disposal of the sewage from the Prison premises, and that the City Engineer be asked to report on the best means for accomplishing this object.

8. That a shower bath and other facilities be provided for the use of the prisoners so that the provisions of the City Prison Ordinance may be carried out in this respect.

9. That the City Health Board be asked to report on the best means of improving the ventilation of the cells and ward corridors.

10. That arrangements be made so that meals will be supplied to keepers while on duty.

11. That the cook house be enlarged in the direction of the stores room so that meals may be eaten by the prisoners in the cook house instead of in their cells.

12. That forks and knives be provided for the use of prisoners.

13. That the personal property belonging to the Governor be separated from the Prison property and that the property belonging to the Gove nor be replaced where necessary with the City's property.

14. That the female prisoners be employed in future in the making of uniforms so that they may be more in accordance with the requirements of the City Prison Ordinance.

15. That if legislation be required to carry any of the above recommendations into effect, the City Solicitor prepare such legislation for approval.

16. Your Committee further recommend that Rule 31 of Ordinance No. 9, relating to the City Prison be complied with.

The Board of Trade has within the past month received no less than six inquiries asking what policy the City of Halifax followed regarding inducements, etc.

Trusting that the above resolution will receive favorable consideration at an early meeting.
