### His Worship the Mayor:

Sir:—As instructed, I beg to report on the following items contained in the memorandum from the Civic Improvement League which are already in hand or have been reported on before.

\* 3. Improved scavenging service—This was reported on in detail as far back as 1902-3, and may be found in the annual report of the City Engineer of that date. Additional cleaning of the streets has been discussed from year to year by the Works Department and the City Council for a long time.

7. The passing of a regulation requiring all paper for disposal of the collectors to be wrapped tightly in bundles. This regulation was adopted by the Works Department some time ago.

8. Regulation of bill boards. This matter has already been before the Council and is being considered by the Laws and Privileges Committee.

11. Construction of a public comfort station. This matter has been reported on from time to time and may be found in the Annual Reports of this Department. The City Engineer is at present under instructions to make a report in detail on the matter, a resolution to that effect having been moved by Alderman McManus in the City Council some time ago.

13. Establishment of a garbage incinerator. This matter has been reported on from time to time. The last special report may be found in the City Engineer's report for 1908-9. A short time ago the City Engineer was instructed by the Works Committee to make a special report on this matter.

14. Inspection of Milk and construction of an abattoir. These matters are under consideration by the Health Board and a Committee of the City Council.

City Engineer's Office, March 9th, 1911.

Sir:-In compliance with the instructions of your Committee, I beg to report on the following items contained in the memorandum from the Civic Improvement League:-

### 1.

#### Railway Grade Crossings.

This matter has been under consideration by the Works Committee for some time. It is a matter that cannot be settled in a few moments, but requires careful consideration before the best policy to be followed can be determined. Your Committee realize the importance of the subject and will take definite action at an early date.

#### 2. Appointment of a Joint Committee to Prepare a Plan for City Improvement.

The memorandum is very vague and does not indicate very clearly the lines which the Civic Improvement League propose to follow. Such committees or associations have been organized in other cities for the purpose of laying out a scheme of development to be followed in future. The Committee suggests that an appropriation of \$2,500.00 be provided to cover expenses, including the services of an expert. I assume that they propose to employ an expert in city planning. This matter was referred to the Works Committee, who were addressed by representatives of the Civic Improvement League, and I can give no further imformation than they received on that occasion.

### MAY 16th, 1912.

#### Improved Scavenging Service.

The League ask for an increase in the estimates for 1911 of \$10,000 for improvement in the scavenging service. It is out of the question for this year. The improvements suggested are:—barrels to be taken from the yards by the collectors and not to be put out on the sidewalk by the citizens; the principal thoroughfares to have at least one additional cleaning during the year. This was reported on in detail as far back as 1902-3, and may be found in the annual report of the City Engineer of that date. Additional cleaning of the streets has been discussed from year to year by the Works Committee and the City Council for a long time. The improvements suggested are very desirable, but it is solely a matter of cost and cannot be undertaken until the appropriation is increased.

#### 4. Provision of a Sum to Destroy the Tussock Moth and other Tree Pests.

This matter has also been under consideration by the Works Committee eve since the first warning received respecting this pest. The Committee are in con-r sultation with the Superintendent of the Public Gardens and will report shortly what in their opinion is the most suitable sprayer to obtain, and other recommendations.

## 5. The Appointment of a Committee of the Council to confer with the Owner of the Market Wharf Regarding the League's Proposal for the Development of the Ferry Landing.

The City Works Committee would seem to be the most appropriate Committee to deal with this matter.

## 6. Passage of a Regulation Requiring the Citizens to Drain the Moisture from Garbage and to Wrap the Solid Matter in Paper before Putting it in Barrels or Cans.

While such a regulation is desirable, it would be difficult to enforce it, and it would create antagonism which at present seems to be unnecessary. In my opinion further education is required before the imposing of onerous and annoying regulations, so long as they can be avoided. In making this suggestion I do not fail to appreciate the desirability of establishing such a custom, but in view of the method which the City is following in disposing of the garbage at present I think the time has not come to make any changes.

7. Requiring Paper to be Wrapped Tightly-in Bundles.

This regulation was adopted by the Works Committee some time ago.

8. The Passing of Regulations Dealing With the Bill Board Nuisauce.

This matter has already been before the Council and the Laws and Privileges Committee, and is therefore not within the province of the Works Committee.

9. The Amending of the Ordinance Governing Street Noises.

This would be a most desirable improvement and I would suggest that the League be invited to make more definite suggestions for improvement than their memorandum contains.

### 10. Securing Legislation Respecting Shade Tree Planting.

This memorandum is very indefinite and does not convey any idea of the intention of the League. We have tree legislation on the statute book now, and if the League have some better system to suggest, I would recommend that they be invited to submit the details of their proposed improvement.

#### MAY 16th, 1912.

### Construction of a Public Comfort Station.

This matter has been reported on by the Works Committee and is now before the Council.

12. The Regulation of Construction Work on the N. W. Arm.

I understand that this memorandum refers to the character of buildings erected. We have no such legislation at present except to regulate houses constructed on Young Avenue, and this legislation was obtained by consent of the property owners interested. I have heard grave doubts expressed by practical and professional men as to the power of the legislature to place restrictions on the character of buildings to be erected by any property owner on his own premises. I do not feel competent to deal with this question, and if it is considered desirable that it should be taken up it should be referred to the Laws and Privileges Committee to look into the legal point and decide that first.

13. The Establishing of an Incinerator for the Disposal of Garbage.

This matter has been reported on from time to time. The last special report may be found in the City Engineer's report for 1908-9. Under instructions from the Works Committee I am preparing a special report on this matter now which will deal with the subject in full.

## 14. The Appropriation of Money to Carry out the Board of Health's Proposals Respecting Milk Supply, Abattoir and Meat Supply.

This is a matter with which the Works Committee has no connection. It comes more properly under the jurisdiction of the Health Board.

## 15. The Favorable Consideration of the Proposition for the Establishment of a Home for Incurables.

This is a matter of policy for the Council and the City Health Board respecting which I have no comment to make.

### His Worship the Mayor:

Sir:—I beg to report on the accompanying petition from property owners on the west side of Edward Street, asking for the construction of a concrete sidewalk between Coburg Road and Jubilee Road.

The City has not made any expenditure on this street for street purposes, and as the west side is getting pretty well built up, the construction of a permanent sidewalk is becoming more desirable every day.

About two-thirds of the-frontage is represented by the petitioners. The sidewalk would connect with the concrete sidewalk on Coburg Road, making the work continuous.

The estimated cost is \$2,906.00. I would recommend that the sidewalks on Edward Street between Coburg Road and Jubilee Road be placed in the sidewalk schedule, and that a concrete sidewalk curb and gutter be constructed on the west side of Edward Street between Coburg Road and Jubilee Road under the Permanent Sidewalk Act, 1906.

### **REPORT COMMITTEE OF FIRE WARDS.**

Committee Room, City Hall, Feb. 12, 1912.

## His Worship the Mayor and City Council:

Gentlemen:-The Committee of Fire Wards met this afternoon at four o'clock. Present Aldermen Martin (Chairman), Hines, MacKenzie, Harris and Gates.

Your Committee beg to report and recommend as follows:-

1. Your Committee had before them the resolution of Council exonerating Robert Warner, Engineer of the Fire Engine Alexandra, from blame in connection with the burning out of the tubes of the said engine at fire January 12th, 1912, and returning to him retained pay, and concur in the said resolution.

2. In regard to the suggestion of the Council that fines imposed upon Callmen John O'Brien, James Barnaby and Vincent. Brunt for absence from third alarms of fire, your Committee decided to adhere to their former recommendation to inflict these fines, as it is inadvisable to break the rules in this respect and would seriously interfere with the discipline of the Department.

3. The Nova Scotia Hospital has requested your Committee to render them such assistance as may be in the power of the Department should the need arise, and ask upon what terms such assistance would be given. The Secretary was instructed to inform the authorities of the Hospital that the Halifax Fire Department would be quite willing to give any assistance in their power, and would make no further charge than for the loss of time to men and for reimbursement for any damages that might be occasioned and any other actual cost to the Department.

4. It is recommended that the Chief be authorized to send fire apparatus to attend fires outside the City upon obtaining permission from either the Chairman or Acting-Chairman of the Committee. 5. The Committee have under consideration a letter from His Worship the Mayor relating to fire risks, and are dealing with the matter.

6. A joint meeting was recently held of representatives of the N. S. Board of Fire Underwriters and other insurance companies, the Halifax Board of Trade and representatives of this Committee to discuss the matter of water front fire protection, at which it was recommended that a report be obtained from Messrs. N. A. Currie, Boiler Inspector, and W. A. Moir, in co-operation with Engineer Edward Condon, on the three Government boats at present in the harbor, namely: "Alfreda," "Elmira" and "Minoca," shewing: 1. The present capacity of the boilers and pumps of each boat; 2. What equipment or appliances it would be necessary to instal on each boat to properly fit them for fire boat purposes; 3. An estimate of the cost such additional equipment would entail to make the boats effective fire fighting machines.

Your Committee concur in the said suggestions, and recommend that the Council authorize any expenditure that will be necessary in obtaining such report.

## **RE DALHOUSIE COLLEGE STUDLEY PROPERTY.**

Sir:-The clause under which Dalhousie College claims an exemption reads as follows:-

"Every building used as a college, incorporated academy, school house or other seminary of learning, and every building used for public Worship, and the site, appurtenances and furniture of each."

The College now claims an exemption on the Studley property, which has been assessed at the sum of \$40,000. There is no college on the site, and there may not be for a number of years to come.

I am of opinion, and the authorities I think bear me out, that the site must be the site in connection with the actual building and cannot apply to a site merely purchased for the purpose of erecting a building in the future and which there is nothing to prevent the College in the meantime using for commercial purposes.

If it is the wish of the Council to extend the exemption to the Studley property, the matter should be made clear by legislation at the approaching session.

Mrs. Robinson states that she was away for two months and during that time, the pipe burst in the cellar. The lower flat was used by a Mr. Ryan for storage. An aged sister occupied the upper flat while Mrs. Robinson was away. Immediately on her return she had the leak in the pipe repaired. The readings were kept by her sister until she returned. The plumber reports that Mrs. Robinson has her plumbing repaired promptly.

The meter has been on about three years, and during that time the consumption and consequent charges have been moderate. The bill for the same period last year was \$3.40, while this year it is \$13.60. The consumption in April was 2,000 gallons, May, 2,000 and July 2,000, while the consumption in June was 59,000 gallons.

Under the circumstances I think it is a case which should be decided under the Act. I would recommend that the quantity of water charged for, be reduced by 57,000, making the June reading the same as April, May and July.

Respecting the placing of a hydrant on Windsor Street between Quinpool Road and Allen Street, an additional hydrant is necessary, as there is no hydrant on Parker Street or Welsford Street. As the installation of an additional hydrant in this neighbourhood is important, and the season is getting late, I have instructed the Foreman of the Water Department to place one without delay.

Respecting the advisability of changing the location of the fire hydrant on McFatridge's Wharf, there can be no question that the hydrant cannot give good service where it is situated at present, while the owner of the wharf piles junk all around it. The practice of depositing so much rubbish around it, should be stopped, or the hydrant removed to some point where it can be easily reached. It is a matter over which the City has very little control, however, as the hydrant is private propérty and was installed on the wharf at the expense of the owner. If the owner sees fit to maintain it as it is at present, I do not think that the City has any right to interfere.

### Chairman Finance Committee:

Sir:—In response to your enquiry, I beg to report that the City Works Committee has asked the Council for \$50,000 for sewer construction this year. They have recommended the acceptance of tenders for pipe and valves, contemplating the change in water distribution and construction of a reservoir this year, which will require \$100,000.

They have also recommended the acceptance of a tender for an incinerator plant which will require the borrowing of the \$46,000 provided by law.

### GARBAGE INCINERATOR.

City Works Office, May 17th, 1912.

#### To the City Council:

Gentlemen:-Attached hereto is a report from the City Engineer covering tenders for Garbage Incinerator.

Your Committee on Works beg to recommend for acceptance the tender of Messrs. Longard Bros.

### His Worship the Mayor:

Sir:--I beg to report on the tenders received for the erection of a garbage incinerator.

Tenders were received from three companies:-The Toronto Furance & Crematory Company, Messrs. Laurie & Lamb and Messrs. Longard Bros. The tender of the Toronto Furnace and Crematory Company is the lowest.

The City Engineer's specification requires a capacity of fifty tons per 24 hours. The Toronto Company makes several different offers, only one of which in any way approaches the conditions of the specification, namely their tender, \$30,175.00 for a furnace of forty to fifty ton capacity. The building contempleted by the Toronto Company is to have a roof and walls of galvanized iron, a material which does not stand in our climate. It is not in accordance with the City specification. The crematory will not destroy garbage at as high a temperature as it would with forced draft. No steam will be generated and many other requirements of the specification will not be complied with. The amount named in the tender, therefore, is not a fair basis for comparing this tender with the others. If all the requirements omitted were to be supplied, and the cost added, doubtless the amount of the tender would be as large, if not larger than the others. There is one feature of the furnace which in my opinion, must prevent the City of Halifax from adopting it:—the night soil is to be mixed with the garbage in order to prepare it for destroying.

The amount of the tender of Messrs. Laurie & Lamb is \$39,850.00. In this case, also, the amount of the tender is not a fair basis for comparison with that of Longard Bros.

Messrs. Laurie & Lamb tender on their own specification and do not provide all the requirements specified in the City specification. Comparing the destructor offered with that offered by Longard Bros., the buildings would be about the same, Messrs. Longard Bros. offering to reduce their tender \$3,000 provided a reinforced concrete building and reinforced concrete chimney is accepted. This makes the tender of Longard Bros. \$44,775.00. Messrs. Laurie & Lamb offer a chimney 5 feet in diameter by 110 feet high, lined with fire brick only 30 feet; Longard Bros. chimney is 6 feet in diameter by 125 feet high, lined with fire brick to the top. There is a difference in value here of probably \$900.00 and in my opinion it is necessary to line the chimney to the top, as the temperature inside the chimney will be high. Laurie & Lamb do not include dynamo, engine and lights in their quotation, while Longard Bros. include them as specified by the City Engineer, and provide for 12 arc lamps to light the plant and the premises around it, and all lamps required and connections for all lamps required in illuminating the building, at a difference of probably \$2,000. Laurie & Lamb do not include a clinker railway track, which is included in Longard Bros. tender as required, making a difference of probably \$50.00. Laurie and Lamb do not provide for a feed water heater for the boiler; this is included in Longard Bros. tender as required. Longard Bros. agree to bring the foundation up to the street level, which makes a difference in their favour, of perhaps \$1,000. Laurie & Lamb also require the City to remove the surplus material excavated. Longard Bros, provide the instruments specified, while Laurie & Lamb offer to provide them for the test only, which may make a difference of \$500 or \$600.

As the omissions mentioned are contrary to the specification, an addition of about \$5,000 would be required to Messrs. Laurie & Lamb's tender, making it \$44,850.00, or about the same as Longard Bros. tender.

If these omissions were made good, I conclude that the two incinerators would be equal as far as first cost goes. There is, in my opinion, a grave disadvantage in the Laurie & Lamb destructor. They contemplate a mixing of the night soil with the garbage before it is placed in the furance. They propose that the garbage shall be dumped into a storage hopper, that the night soil shall be dumped in withit and mixed in the hopper, being raked from the hopper into a skip which travels up an inclined track, at the upper end of which it empties into a container and from time to time the container is discharged into the furnace. As we have at times, as high as 15 tons of night soil in one night, I cannot believe that such a system can be operated without being offensive. The hopper, skip and container must surely give off offensive odors, and I do not feel justified in taking the risk of recommending the adopting of any such system.

In the furnace offered by Longard Bros., special provision is made for the destruction of night soil. It will be discharged directly from the night soil collecting carts into the combustion chambers. All the heat and gases from the burning of the night soil sill pass through the combustion chamber and the liquid will be evaporated with the least possibility of offensive odors or other objectionable features.

The conditions in Halifax, I am informed, are unusual, the quantity of night soil to be disposed of, being very large in comparison with other cities of the same size.

Under the circumstances, Longard Bros. tender is the only one which complies with the specification, and I would recommend that their offer be accepted, provided they sign a contract to be prepared by the City Solicitor, as there are certain details which should be settled beyond dispute, so that there will be no extra work if it can be avoided.

Moved by Alderman Martin seconded by Alderman Hawkins that the tender of Messrs. Longard Brothers be accepted.

Moved in amendment by Alderman Denn's seconded by Alderman Whitman that this matter be referred back to the City Engineer for further report.

The amendment is put and lost. The original motion is put and passed.

Moved by Alderman Dennis seconded by Alderman Hoben that the Council do now adjourn. Motion passed.

Council adjourns 11.55 o'clock.

## **REPORT CHARITIES COMMITTEE.**

Halifax, June 6th, 1912.

### His Worship the Mayor and Members of the City Council:

Gentlemen:-The Charities Committee met this day and beg to submit the following report. Members present, the Chairman, Aldermen Morrow, Keltie, Scanlan and Martin.

The Superintendent's report for May 1912, shows that during the month there were 24 persons admitted into the City Home, 3 born, 44 discharged and 5 died. Of the number admitted 6 were chargeable to the Province and 18 to the City. The total number of inmates May 31st was 290, made up of 161 men, 124 women and 5 children. On the same date last year there were 174 men, 125 women and 2 children. A total of 301. There were 3 patients chargeable to the City admitted into the Nova Scotia Hospital and 1 patient died.
