Dear Sir:, I have before me your letter of the 22nd, in regard to up-to-date booklets descriptive of the City of Halifax, with copy of letter enclosed from the Office of the High Commissioner for Canada, asking for a supply of same.

I am sorry that at the present time that I have only two booklets on hand one, our regular tourist booklet; the other, descriptive of Halifax as a manufacturing site, but neither of these would, I think, fill the bill for the High Commissioner.

During the year 1911 the Board of Trade expended practically \$600.00 in printing, the larger portion of which was of an advertising nature; this did not include our tourist advertising, and the result of this expenditure has all been distributed by me.

Owing to the work in connection with the proposed developments for this Port the Board of Trade has been put to considerable extra expense during the past year, and at the present time, I am sorry to say that our funds will not allow the issuing of a pamphlet.

I trust, however, that the City Council will assist in the advertising of the City with a grant in keeping with the grants made by other City and town Councils in the Maritime Provinces.

During the past year, I am informed that the City Council of St. John expended \$2500.00 through the Board of Trade, for advertising purposes and also made a grant of \$500.00 for Tourist Association work. Amherst, Sydney and other City and Town Councils voted sums of money for the same purpose, and it would seem only fair that the public of Halifax, at large, should contribute a sum of money towards the advertising of the City, and not allow the total expenses, besides the work, to fall upon the Board of Trade.

CIVIC IMPROVEMENT BOARD RE CITY PLANNING.

Committee Room, City Hall, Nov. 27, 1912.

His Worship the Mayor and City Council:

Gentlemen:-The Committee on Improvement met this evening, there being present Aldermen Clarke and Hattie (Chairman) and Messrs. Longard, Davidson, Kelly and Sexton, and the City Engineer.

The Committee recommend as follows:-

First:--That a Comprehensive plan of the future improvement and development of Halifax be prepared.

Second:—That a City Planning Commission be appointed in connection with this work and the general question of improvements, the same to be an advisory Commission and to carry on a study of the City's needs in these matters; that the commission consist of four members of the City Council, four citizens and the City Engineer.

Third:—That a City Planner be retained by the City to prepare the proposed comprehensive plan in conference with the City Planning Commission and the City Council, to present a report and recommendations in connection with the plan, and to advise the City with respect to Civic regulations and policies that would be desirable for the carrying out of the City Planning project; and that in order to defray the expenses involved, the sum of Four Thousand Dollars be borrowed on long term debentures and that legislative authority be secured for this purpose.

The City Engineer concurs fully in the Committee's opinion that a comprehensive plan, and the services of an expert in City planning in connection therewith, are essential.

To His Worship the Mayor and City Council:

Gentlemen:-The Civic Improvement Committee met this evening, there being present Aldermen Clarke, Keltie, Hattie (Chairman) and Messrs. Longard, Sexton, Kelly and Davidson, and the City Engineer.

First:—The Committee recommend that the Finance Committee ascertain the cost of obtaining a park site at Fort Needham and report on the same to the City Council.

Second:—Under date of October 21st, the City Engineer reported regarding a proposed amendment of the Street Ordinance in favor of such amendment. The Committee ask that this amendment to the Ordinance be now accepted by the City Council.

The proposed amendment was as follows:-

"29 (b) Where any sidewalk has been in part covered with sod, the occupier of the premises adjoining such sidewalk, or if the property is not occupied the owner thereof, shall keep the part of the sidewalk so sodded, close clipped, clean and in good order."

Third:—Respecting the extension of Grafton Street through Poplar Grove to Barrington Street, this having been reported on by the City Engineer, the Committee would ask the City Council to direct that this extension be placed on the Official Plan. The City Engineer is of the opinion that this action should be taken. This extension would run from the north end of Poplar Grove to the intersection of Barrington Street and Proctor Street, as shown on the accompanying plan.

Fourth:—The Committee also recommend that the diagonal street known as City Hall Avenue, as at present marked on the Official Plan, be accepted. The City Engineer concurs in this recommendation.

Fifth:—The Committee recommend that the proposed extension of Brunswick Street northward through the Admiralty and Wellington Barracks grounds in order to connect with North Albert Street be placed on the Official Plan; that the military and naval authorities be communicated with by the Works Department in order to secure their observance of the new lines in the placing of any new buildings that may hereafter be erected on their respective properties. The City Engineer approves of the proposed extension.

Sixth:—The Committee recommend that the City Council seek legislative authority which will enable the Works Department to provide for all prospective sewer connections, between the street line and the sewer, on streets where it is proposed to build permanent sidewalks or other permanent street work. This is also approved by the City Engineer.

Seventh:—The Committee draw the attention of the City Council to the fact that the gas works may be removed to the shores of the North West Arm. It is considered that this would greatly disfigure the North West Arm, and it is recommended that the Halifax Electric Tramway Co. be communciated with to see if they cannot be induced to select a site where the presence of the works would not be so objectionable.

Read clause 1 re Park site at Fort Needham.

Moved by Alderman Hattie, seconded by Alderman Connolly that said clause be referred to the Finance Committee for report. Motion passed.

Read clause 2 re proposed Ordinance relating to sodded sidewalks, covering draft Ordinance.

Moved by Alderman R. V. Harris, seconded by Alderman Whitman that said clause be referred to the Committee on Laws and Privileges for report. Motion passed.

Read clause 3 recommending that the proposed extension of Grafton Street through Poplar Grove to Barrington Street be placed on the Official City Plan.

Moved by Alderman Hattie, seconded by Alderman Connolly that the said proposed extension be placed on the Official City Plan.

Moved in amendment by Alderman Whitman, seconded by Alderman Hoben that the clause be referred to the Committee on Works for report.

Alderman Scanlan here arrives and takes his seat in Council.

His Worship the Mayor rules Alderman Hattie's motion out of order, the requirements of the City Charter preliminary to the adoption of alterations to the City Plan not having been complied with.

The amendment, being now the only question before the Council, is put and passed.

Read clauses, 4 5, 6 and 7 on various matters.

Moved by Alderman R. V. Harris, seconded by Alderman Hawkins that said clauses be referred back to the Civic Improvement Board for further report.

After discussion it is moved by Alderman Whitman, seconded by Alderman Hawkins that the whole report be referred back to the Civic Improvement Board for further report. Alderman Whitman's motion is put and passed, 10 voting for the same, and 6 against it, as follows:-

His Worship the Mayor:

Sir:-I beg to report on the accompanying communication from the City Health Board recommending the construction of a sewer in Duffus Street.

The ledge rock is exposed in the gutter on the north side of Duffus Street and the houses drain to the gutter as there is no other means of disposing of the waste. The conditions are offensive, to say the least, and there is urgent need of better

provision being made for the disposal of sewage along this street. Further, the quantity of surface water running down the hill during rains, causes a great deal of damage and keeps the street and sidewalks cut up.

The estimated cost of constructing a sewer on Duffus Street from Acadia Street to Campbell Road and along Campbell Road to the Roome Street outlet, is \$8530.00; estimated assessment \$2912.00.

I have written to the firm asking where they expect that such structures shall be placed. They state that it is their intention to erect the kiosks in public or commercial squares or streets. They desire to use them for advertising purposes and in order to get permission offer to instal barometers, animometers, thermometers and thermohygroscopes which they will maintain.

The desirability of such structures is questionable. They would be of advantage to Messrs. Degrys & Company, but their advantage to the City may well be questioned, as they propably would come in competition with local advertisers. Further, the City has no power or authority to grant permission to erect such struc-tures on public streets and squares and it would be necessary to obtain legislation to enable the City to give permission if it was considered desirable to do so. I do not feel justified, therefore, in reporting favorably on their request.

The petitioners claim that they are not receiving justice, because residents on other streets in the neighbourhood get their water on the regular rate.

Water extensions have been made for a great many years only on a special rate which would produce a revenue equal to five per cent on the cost of installing the pipes. There have been only one or two exceptions to this rule. If there had been no such regulation, it is pretty certain that the water pipes would have been extended whenever they were asked for by any individual in any part of the City, regardless of cost. The extension of the water pipe to this part of North Street was petitioned for by the property owners and was ordered by the Council, the work to be done provided the petitioners would agree to pay a special rate. They signed a bond to pay the rate, and under the circumstances I would not be justified in reporting favourably on their request. They are not singled out for special treatment, but there are 169 houses being supplied on the special rate secured by a bond in the same way that buildings on North Street are supplied.

This case is identical in point of law with the claim of Mr. Lindsay on which I reported on the 3rd of June last.

It is not a case of anything done by the City, but arose entirely out of the inability of the City with the funds at its disposal to maintain the streets in such a condition that no accident can possibly happen upon them.

I believe the law to be clear that for such accidents the City is not liable, for the reasons set out by me in my report on the Lindsay matter, and I would therefore recommend that the action be defended.

Sir:-I beg to report on the accompanying communication from Mr. S. M. Brookfield, President of the Halifax Development Company. Mr. Brookfield asks that the City give the Company permission to use the poles in the streets of the City for the company's wires.

Section 44 of the Pole and Wire Ordinance Number 8 provides for the granting of a permit to the Comapny by the City Engineer. I should not grant a permit, however, until the question of terms is settled so far as the City is concerned. This Company would be doing business in competition with existing companies which pay taxes to the City, including a percentage of their earnings.

While it is desirable to encourage competition, it must not be forgotten that competition will reduce the earnings of existing companies and consequently the amount received from such companies in taxes will be less than at present. Some scheme of assessment or taxation should therefore be determined, under which the Halifax Development Company will pay to the City a percentage of their revenue

or a tax, equivalent to the amount which the City will lose by the change. The terms of the permit, and the conditions and details under which the Company are to be allowed to use the poles, will have to be worked out by the City Engineer, but the financial arrangement will be determined by the Works Committee or Council.

Dear Mr. Mayor:—On behalf of the Halifax Development Company of which corporation Mr. S. M. Brookfield is President I beg to formally apply for a permit for the stringing of wires on the poles in the City at present used by the Halifax Electric Tramway Company for the purpose of supplying electric power and energy.

It is very vital for my clients that they should receive a definite reply on this point immediately as several options which they hold are expiring on the 15th inst all of which require payment of large sums for renewal and as it is essential to the existence of this Company that the permit asked for be granted it is hardly worth while to renew the options unless the usual permit will be given.

It is immaterial to the Company whether the poles are to remain the property of the Tram Company or are expropriated. The power to grant the permit asked for exists in either case.

If it is necessary to get the sanction of the City Council I would respectfully ask that a special meeting of the Board of Works be called so that the matter may be taken up at the next meeting of the Council which I am instructed will be held on Thursday or Friday of this week.

I would respectfully ask you to accede to my request which, for the reason stated, is urgent.

The contract originally was for a period of five years and expired on the first of July 1912. It was extended by mutual agreement to the end of the year 1912. The original contract was for a moonlight schedule service at \$65.00 per light per annum. The Company in extending the contract for a period of six months, agreed to give an all night and every night service for the same price, namely \$65.00 per annum.

An all night and every night service is a big improvement on the old service, and of course means an additional expense to the Company, but does not cost the City any more than the service under the contract as originally drawn.

The time is very short for making a new contract, as there is less than a month to agree on terms, prepare the contract and have it executed.

In preparing the new contract, the conditions should be the same as the old one, except that an additional section should be inserted, providing that the City shall have the right to use the surplus power, if any, from the incinerator for the purpose of lighting the streets or City buildings. This need not interfere with the contract in any way, and would mean only that a certain number of lights would be taken care of by the City independently of the Company, and probably would not reduce the total number of lights that the Company would be called upon to maintain, but would rather increase the total number of lights which the City would have to pay for.

The Committee on Works, at a meeting held this day, decided to refer said letter to the Council for its information.

Gentlemen:—The undersigned being the Arbitrators selected to appraise the compensation to be awarded Dr. A. C. Hawkins as the result of the expropriation of a portion of his property situate on the corner of Cunard and Gottingen Streets, City of Halifax, beg leave to submit the following:—

1. Provision has been made by the City of Halifax for the payment of a fee of six dollars to each Arbitrator for assessing the compensation to be allowed each owner whose land is expropriated in the widening of Cunard Street.

2. This fee was probably fixed under the impression that while the appointees were styled Arbitrators their work would be simply that of Valuators who would meet together, look at the property and decide what the compensation should be. For such work the fee of Six Dollars is not unreasonably low.

3. When the Board met to take up the Hawkins matter it found both the City and the owner represented by counsel with a large array of witnesses to be examined under oath. Many lengthy sessions were held, the enquiry being carried on as a regular court under the Arbitration Act. Points of law were freely taken and argued at length by counsel and one hundred and twenty nine pages of type-written evidence taken.

4. After finishing the taking of evidence the Arbitrators were compelled to hold many sessions to go over the evidence, to agree upon facts proven and to endeavour to reach an agreement on points of law raised and prepare their award.

5. The Arbitrators were not able to reach a unanimous agreement and two separate awards were filed, the preparation of each entailing a large amount of work.

In consideration of the above the Arbitrators feel that a fee of six dollars is most unreasonable and submit that they should at least receive one hundred and twenty-five dollars each or that their costs should be regularly taxed under the Arbitration Act.

All of which is respectfully submitted.

His Worship the Mayor, Chairman Committee on Works:

Sir:-In reply to your request for a report on the awards which have been made for compensation for land and damages in connection with the widening of Cunard Street, I beg to say as follows:-

At the present time all the contested claims have been disposed of except that of the Halifax Rifles.

As to the law governing arbitration and awards, I think there is no doubt. When parties to a dispute have submitted the matters involved to arbitration the award of the arbitrators on any question of fact properly coming before them is conclusive, and no tribunal has any power to review their findings. The Court, however, can deal with an award if either the arbitrators have misconducted themselves, or have omitted to deal with matters with which they should have dealt, or have dealt with matters with which they should not have dealt. In such cases the Court acts, not by way of appeal, but by directing that the award be either set aside, or referred back to the arbitrators with instructions either to deal with matters which should have been dealt with, or to omit any item which they have improperly dealt with.

Dealing with the awards which have been made on these principles, there does not appear to me to be any legal ground for objection to any of them, with one exception. In all of them the amounts tendered have been increased, some of them very considerably; but the increases have been made on a consideration of the value of the land taken or the damage to buildings, matters properly within the jurisdiction of the arbitrators. In one case, that of Mr. Connolly, the amount has been very largely increased, owing to the fact that it appeared from the evidence that the buildings injured could not be moved back without the destruction of other buildings belonging to Mr. Connolly immediately in the rear, and that consequently either the buildings on Cunard Street or those in the rear must be allowed for. This, however, as I have said, is a matter with which the arbitrators could properly deal. The awards have been generous, but that is a thing which apparently the City must expect, and of which perhaps it ought not to complain. At any rate it is certain that there is no legal objection on that score.

The one exception is the case of Dr. Hawkins, in which a sharp diversity of opinion on a question of law regarding the mode of determining the compensation arose, and which is made plain both in the award of the majority and in a full statement by the minority arbitrator, Mr. Ross. The majority have awarded \$13,500.00, Mr. Ross \$11,000.00. The point of law involved is this:—When Dr. Hawkins acquired his property a number of years ago it had solely a residential value, and it has been assessed on that basis up to the present time. If compensation were to be awarded for the property on this residential basis, its market value (which is what the abitrators would have to determine) would be ascertained by calculating the value of the land for residential purposes, and also the value of the buildings on it taken or injured by the expropriation. It appeared, however, from the evidence that in the interval which has elapsed since the property was purchased the land has acquired a commercial value quite apart from its residential value, and considerably greater.

It was established by a number of witnesses, whose evidence was accepted by all the arbitrators, that the property had a commercial value in the vicinity of \$15,000. That price would cover the whole property, both land and buildings, although the witnesses added that for the purpose for which it would then be required the present building would be of no value. What the majority of the arbitrators have done is to value the land taken on this commercial basis and then add to the value so ascertained an additional sum for the loss of the house, thus giving the owner compensation in both ways, or, putting the same point another way,

allowing him the value of the house twice, once as part of the lump sum commercial value, and a second time as an item making up a residential value. The effect of doing so is apparent. The award is \$13,500.00. Dr. Hawkins' own witnesses value the remaining part of his property, a corner lot 34 by 150, at \$6,000, making a total valuation of \$19,500.00. Even deducting the amount presumably allowed for compulsory removal, which would not exceed \$1,000, it is evident that the valuation thus worked out is between \$3,000 and \$4,000 higher than the highest sum named by the owner's own witnesses.

I am of opinion that on this question of principle Mr. Ross is correct and that an application could be made to the Court with a good prospect of success to have the award remitted to the arbitrators for correction. As the point is clearly stated in the award, both majority and minority, I do not see that any papers would be required except the awards themselves, and the matter could be disposed of quickly.

POLICE DEPARTMENT.

Mayor's Office, December 16th, 1912.

To the City Council:-

Gentlemen:—At a meeting of the Police Committee held this day, there being present Aldermen Hines and Scanlan and myself, petitions were read from the Deputy-Chief, Detective, Assistant-Detective, City Marshal, Sergeants and Police Officers asking for an increase in pay.

After duly considering the matter, a majority of the Committee, consisting of Alderman Hines and myself, decided to recommend to the Council for their consideration an increase of pay to the six sergeants and thirty-nine men of thirty-five (\$35.00) dollars a year each. Alderman Scanlan desired that the increase should be one hundred (\$100.00) dollars each.

The Committee unanimously decided to recomme d an increase to the Chief of Police of one hundred (\$100.00) dollars, making his salary fifteen hundred (\$1500.) dollars instead of fourteen hundred (\$1400.00) dollars.

It was also decided to recommend that the Deputy-Chief and the two Detectives be given the increase that was voted them by last year's Council, viz:—fifty (\$50.00) dollars each, and a further sum of fifty (\$50.00) dollars each this year, making the salary of the Deputy-Chief one thousand (\$1000.00) dollars; Detective Hanrahan nine hundred and fifty (\$950.00) dollars; Assistant Detective Kennedy eight hundred and fifty (\$850.00) dollars. Also the Committee were unanimously of opinion, in order not to make any invidious distinction, that the City Marshal should receive an increase of fifty (\$50.00) dollars; but would recommend that legislation be procured abolishing this office at the resignation, superannuation or death of the present incumbent, his duties then to be taken over by the Chief and Deputy-Chief.

For all of these increases legislation will be required, and your Committee recommend that the Council instruct the City Solicitor to prepare the necessary legislation to carry these recommendations into effect and to enable the City to assess upon the citizens for the year 1913-14 the amount necessary to meet this increase.

The Committee also had before them for consideration the question of increasing the number of the force, for which the Chief has applied or several years. Some years ago the Chief asked for an increase of ten men, since then only two have been granted him, last year. Alderman Hines and Scanlan, being a majority of the Committee, were favorable to the increase requested by the Chief, viz:—that the force be increased by eight men. I, however, objected to this, and am only in favor of an increase of the force by two additional men. It will be for the Council to determine what (if any) increase shall be made to the force. If these additional men are appointed, of course the increase of thirty-five (\$35.00) dollars a year will apply to them as to the present members of the force.
