Sir:—I beg to report that all the awards in connection with the widening of Cunard Street have been filed in this office. At the date of my last report, Nov. 27th, the awards totalled \$24,401.00. Since that date, the arbitrators have awarded Mrs. Esther Lindsay \$4550.00 (amount paid into Court \$31250.00) and the Halifax Rifles Armoury Association \$3000.00 amount paid into Court \$1615.00) making the total awards \$31,951.00.

The land bought and sold cost \$3650.00 additional, making the total cost for land damages \$35,601.00, providing the award for the Hawkins property stands at the figure named by the majority of the arbitrators.

The money should be paid into Court as far as the authorized appropriation will permit, otherwise interest claims will be made.

His Worship the Mayor reads a message to the Council relating to the salaries of officials and other employees of the City.

#### SALARIES OF OFFICIALS AND OTHERS.

#### To the City Council:

Gentlemen:--I was surprised on a return to the City from the country where I had been absent since Christmas to read on the train in Saturday morning's papers that an all-round increase of the salaries of City officials had been recommended by a majority of the finance committee. With the gentlemen who made this rec-commendation I have no quarrel. Each one must judge for himself whether the civic employees dealt with in the report are at present receiving sufficient remuneration and whether the civic exchequer at this time will stand any increase in salaries. From my point of view these increases are unjustifiable, and if they pass this council and become law it will have to be over my veto. The applications of officials re-ceiving less than \$1000.00 a year, say from \$8.00 to \$18.00 a week, or from prac-tically \$1.50 to \$3.00 a day, are in a different position. and I would be the last to oppose slight increases in these cases, such as the firemen's increase of \$20.00 apiece, the policemen \$35.00 each and some of the other officials in the City Hall such as stenographers, librarians, messengers, etc., but those who are in receipt of \$1000.00 or more, and many of whom received increases last year, I cannot favor-ably consider the giving of increases to this year. The argument is made that living expenses have increased. This is true, but it tells two ways. The burden of the taxpayer is increased in increasing these salaries, and the taxpayers' living expenses have increased. The increased tax upon the citizens this year will be, as I am credibly informed at least \$46,000 or \$1.00 per head of the population of Halifax—an average of \$5.00 a family, averaging rich, poor and all classes of the com-munity. The wealthier classes will not feel this, but those whose incomes are only from \$8.00 to \$18.00 a week are the people whom we should consider when we increase the wages of any receiving more than \$1000.00 a year. There may be some cases where an increase would be justifiable if the City funds permitted. I have personal friends on the City Hall staff whose salary personally I should like to see increased and some of whom may not be too well paid, but I feel in my position as Mayor that it is my duty to the citizens to forego any personal feelings that might ordinarily Moreover, I would call attention to the fact that the local and federal actuate me. government employees of this City with certainly not half a dozen exceptions are no better remunerated than the officials of the City Hall, and this notwithstanding the fact that the federal government has a buoyant and increasing revenue. believe the increase to the firemen to be justified, but I oppose the increase to the policemen of \$60.00 a year, thinking \$35.00 the equivalent increase of what the firemen are getting. Before the Exhibition Commission, of which I was a member, I opposed increases of salaries and gave as my grounds that I intended to oppose an increase to all the men higher up in the City Hall. Last year I opposed an in-crease to the City Solicitor, so I cannot be accused of inconsistency. It may be said that I have recommended an increase to the Chief of Police—the only man ensure to the getting over \$1000.00 whom I have recommended for increase. In answer to this I wish to say in justification of my position that the Chief of Police of St. John Citygets \$200.00 a year more than our Chief, besides having extra fees, as I am informed, making his salary \$300.00 or \$400.00 more than our Chief, and in other cities in Canada of the same size a still greater salary is given. Moreover, I have recommended that legislation be asked abolishing the office of the City Marshal on the death, resignation or superannuation of the present incumbent whose duties are to be performed by the Chief and his Deputy, which will make the pay of the officials of the Police Department less than at present. As to the increases in salaries of the School Board and the Board of Health, this Council has no control over them. With most of them I would have concurred and to a few I should have objected had I the power. As Chairman of the committee on works I made no recommenda-

tions, although requested for increases by officials of that department, and I believe as a class to say the least they are equally entitled to an increase with those who have been granted them by the committee, but I could make no invidious distinction, and will veto all increases to men receiving over \$1000.00 a year. It has been charged by some citizens ignorant of the history of the matter that the mayor's salary is increased from \$1000.00 to \$2000.00 and he should veto that if he vetoes anything. In answer to this I would say that this salary is fixed by statute under the new Board of Control Act, an Act which I personally opposed, but when the citizens voted in favor of it I agreed that this system should have a fair trial. The salary was not fixed by me and was intended by the promoters of the bill I imagine for some other person. Let me say in this connection, however, that the new Act makes the Mayor devote more and practically half his time to the duties of the office, that he is elected annually, and that I know from experience of former Mayors and in my own case that no one can be elected Chief Magistrate of Halifax if he has opposition, however weak, without expending for his legitimate expenses the present salary of \$1000.00. I trust that the Council will not compel the exercise of the veto power, as I wish to act in harmony in every way with the members of the City Council if possible. If I am compelled, however, to veto I shall only consider that the members of the Council who differ from me have a perfect right to the exercise of their judgment as I trust they will consider I have to the use of mine.

## LIONS FOR MEMORIAL TOWER.

Halifax, N. S., January 6th, 1913.

#### His Worship the Mayor:

Dear Mr. Mayor:—I beg to enclose copy of a letter just received from the Secretary of the Royal Colonial Institute respecting their gift of two bronze lions for the Tower.

You will notice that he gives certain dimensions which your Engineer will require for the foundations and bases.

May I suggest that the Tower should be inspected and if there is an accumulation of moisture on the floors that it should be dried off before the hard frost sets in.

#### Royal Colonial Institute, London, W. C., Dec. 24th, 1912.

#### D. Macgillivray, Esq., The Canadian Bank of Commerce:

Dear Mr. Macgillieray:—I have just heard from Mr. A. Bruce Joy, the Sculptor, that the casting of the Lions will not be complete until July next. You may probably be aware that Mr. Bruce-Joy is one of the leading Sculptors in England of the present day, and he is most desirous that the Lions themselves should be true works of art. He writes expressing regret that so long a time must elapse before

their delivery, but feels sure that when they arrive and are erected at the base of the Tower, they will give great pleasure not only to Sir Sandford Fleming but to the residents of Halifax also. Perhaps it would be possible to make some arrangement for their unveiling at that period. It may possibly be better to have such a function in July than earlier in the season, as a large number of people from other parts of the Dominion will no doubt be in Halifax and its neighborhood.

As regards the size of the pedestals, the height of the Lions will be between 4' and 5'; the length (from paws to back of the Lion) 10', and the width about 3' 6''. The length measurement is from the end of the extended paws to the back of the body, namely—the total length. The lions will to a very great extent resemble those at the foot of Nelson's Column in Trafalgar Square. I am sorry that there will be delay in their delivery, but this has been unavoidable.

I shall forward you an Album containing the names of those who have subscribed to the cost, which it is suggested might be preserved in the Tower itself.

We can later on discuss the question of the function when the unveiling will take place. It might be possible to get His Royal Highness the Governor General to perform the ceremony in his capacity as Vice-Patron of the Royal Colonial Institute, as the presentation from him would be most appropriate.

I will write a line to Sir Sandford Fleming, letting him know the arrangements now suggested.

Read correspondence between the Local Council of Women and His Worship the Mayor relating to the occupancy of the residence of the late George Wright, Young Avenue.

#### THE GEORGE WRIGHT RESIDENCE, YOUNG AVENUE.

#### 45 Coburg Road, Halifax, Jan. 4th, 1913.

#### His Worship Mayor Bligh:

Dear Mr. Mayor:—You are no doubt aware of the provision made in the will of the late Mr. George Wright as to his residence on Young Avenue. That provision is as follows:—"And I also give my freehold residence at Halifax to my Executors in trust for the Council of Women, as an institution for carrying out their work, and assist in suppressing other evils such as I have been writing about and trying to put down." The executors of the estate have obtained the opinion of the Supreme Court (Mr. Justice Drysdale) that the Halifax Local Council of Women is entitled to the possession of the property for the purposes indicated in the will that is "to be used as an institution for carrying out their work." He gave no opinion as to the effect of Section 763 of the City Charter on the carrying out of the will, apparently assuming that there was nothing in the will which necessarily implied such a use of the house as would constitute a violation of this provision.

The Local Council is now in possession of the property, and are preparing to carry out the provisions of the will and use the house in accordance with the wishes of the testator. The Council intends to use the building as a meeting place and headquarters for itself and such of its affiliated societies as care to use it. The Council wishes to use a part of the house as a residence for the Nurses of the Victorian Order (one of its affiliated societies). The Board and lodging of the Nurses would be met partly by the Council and partly by the Victorian Order. Some of the residents of Young Avenue have objected to such a use of the house, basing their objections on Section 763 of the City Charter.

I am instructed by our Committee, who have charge of the matter of the occupation of the house, to communicate with you as Mayor of the City with a view to ascertaining what the rights of the Local Council are and the attitude of the City with respect to the section mentioned above. In particular the Council wishes to know whether, if complaints are made by residents of Young Avenue on account of the buildings being used as indicated, the City would take action on their behalf; and also is such a use of the property a violation of the Young Avenue section of the Charter.

I omitted to state that the Society are not intending to make any use of the Wright house of a commercial nature nor to use it in any way which they think could depreciate the value of the surrounding property, but rather are anxious that its work should be the pride of the women of Halifax and its outward appearance a credit to the Avenue.

#### Mrs. Agnes Dennis, President Local Council of Women:

Dear Madam:—I am in receipt of your letter of the 4th inst. dealing with the occupation of the house corner of Inglis Street and Young Avenue devised to the Local Council of Women of Halifax by the late George Wright and asking what attitude the City would take in reference to the same in view of Section 763 of the City Charter.

Your letter will be read to the City Council on Thursday, the 9th inst., and doubtless will be referred by the Council to the Laws and Privileges Committee, and I will endeavor to have a prompt report from that Committee to the Council so that an early official answer can be given.

In the meantime I may express my personal views and say that for reasons I need not here give in detail I believe that the use to which you intend to put the property will not be a violation of the City Charter. I cannot conceive of any resident of Young Avenue objecting to such use by the Local Council of Women; but if it should be found that the proposed use of the property should be a technical violation of the Charter I am convinced that the City Council would memorialize the Legislature asking for such amended legislation as would permit the property to be used as your Council intends rather than have the will of the late Mr. Wright prove abortive in respect to this property.

Sir:--I beg to report on the accompanying letter from the Dennis Realty Corporation, Ltd., respecting the value of the land required from the property at the north-west corner of Argyle and Sackville Streets to widen the street to the official line.

The City paid the Association for the Relief of the Poor \$100 for 76 square feet, which is \$1.32 per square foot, the property being at the north-west corner of Argyle and Prince Streets, one block north of the property of the Dennis Realty Corporation. The City paid Mr. J. W. Allison for land taken from his property at the corner of Duke and Water Streets, \$2.70 per square foot. The Merchants Bank paid the City \$150.00 for 34 feet at the south-east corner of Duke and Granville Streets, which is \$4.41 per square foot.

The property at the corner of Argyle and Sackville Streets is, I think, more valuable at present than the property at the corner of Argyle and Prince Streets; in fact, I think I am justified in the opinion that it is worth as much as the rate paid Mr. Allison.

Ninety-four square feet at \$2.70 per foot, would be \$253.80. I would recommend that that amount be offered the Dennis Realty Corporation.

#### **RE HOUSES OF PROSTITUTION.**

#### Office of Chief of Police, January 9th, 1913.

#### To His Worship the Mayor, Chairman of Police Commission:

Sir:—For your information I beg to report that in accordance with resolution of Council passed 7th November, 1912, notices were served upon keepers and inmates of all well-known houses of prostitution. The detectives were directed to visit these houses as frequently as possible, and in addition to the uniformed men on duty, plain clothes men were detailed to keep strict watch upon them at night.

One house was entered with warrant and keeper and inmates arrested. The keeper was convicted and sentenced to be imprisoned for three months without the option of a fine. The case was appealed, and the appeal will be heard by His Honor the County Court Judge in month of February, I understand. In the meantime, the defendant is at liberty, having given bail.

Since this conviction and sentence I have not learned of an open violation of the law with regard to this class of offence. The red-light district, so called, has been practically wiped out, as with two or three exceptions the inmates who were served with the notices have left the City and the only persons in the houses are

persons living in them as caretakers of the properties. One house has been converted into a lodging house for men and is kept by a man and wife, owners of the property. This district must be carefully watched in order to prevent a return to former conditions.

Numerous rumors of other houses of the same class having been opened in various parts of the City, have been investigated, but up to the present no evidence has been obtained which would warrant the police in commencing a prosecution.

Sir:—On November 28th, in accordance with the instructions of the City Council, I made an offer in writing to the property owners whose lands are required by the City for the site of the proposed High Service Reservoir. None of the offers made have been accepted. I have received replies from most of the property owners, and their estimate of the value of their property is very much higher than that of the Assessors. The offers made were 25 per cent. increase on the assessed value of the property. In some cases the property owner asks five times the amount of the assessment.
