Sir:-Since submitting my report dated April 14th on the streets which Messrs. Carrick, Limited desire to open in their property Oxford Park, so called, certain objections have been made by owners of property in the vicinity.

Carrick, Limited have agreed to connect Norwood and Mott Streets by opening a street east and west through their property at that point. The only serious objection which would seem to stand in the way of unanimous approval now, is that of Mr. A. C. Theakston. Instead of laying down an extension of Jennings Street east of Oxford Street, it would seem desirable to extend Cambridge Street through to Waegwoltic Avenue. It seems impossible to obtain approval for a street running westwardly from Cambridge Street through the Geldert property. As such streets must be laid down where they will be most satisfactory from a general point of view,

and as the City should not prevent any property owner from opening up his property at all, I think the direct extension of Cambridge Street to Waegwoltic Avenue will be less objectionable than the other proposals.

I therefore recommend that the consent of the City Council be given to Carrick Limited to lay out and open the streets in their property shown on the plan submitted herewith, and that the City Engineer be authorized to lay down upon the Official Plan of the City, Cambridge Street, Pepperell Street, Beech Street and Mott Street as shown on the plan herewith submitted, the said plan being filed in the City Engineer's Office as Plan No. 2249.

Maintains that its said request ought not to have been refused;

Repeats and renews its said request;

Insists, that directly representing, as it does, a community of approximately fifty thousand souls, its views and desires respecting matters of civic concern ought seriously to be considered;

Contends that upon its request a plebiscite upon any matter of civic concern ought to be granted as of course, and that when granted the expressed views of this City's citizens, upon proper provision for the financial rights of all parties affected by the subject-matter of such plebiscite, ought to prevail;

Remonstrates that as all legislative power affecting the people of this City proceeds from such people themselves, when their direct representatives, as a civic corporation, speaking for them, demand an expression of the popular will, refusal of such demand operates as a denial of a fundamental right of citizenship, against which denial this Council ought to and does earnestly protest;

Objects to any increase in the capital stock of said Tramway Company (a) because such increase is not necessary for any legitimate purpose of said company, and (b) because such increase is calculated to render more difficult the ultimate acquisition by the said City of the said assets and franchises;

Further Resolved, that the City Clerk do communicate these resolutions unto the Premier of Nova Scotia and the President of the Legislative Council, and that the Board of Control be directed to take such action, as respects the subject-matter hereof, as to said Board may seem proper and advisable.

Moved by Controller O'Connor, seconded by Controller Scanlan and passed unanimously.

Read reports Board of Control and City Engineer re sidewalks and water extension Rosebank property.

SIDEWALKS AND WATER EXTENSION, ROSEBANK.

Gentlemen:—At a meeting of the Board of Control held this day the attached report of the City Engineer re sidewalks and water extension Rosebank property was read and recommended to the Council for approval.

City Engineer's Office, May 9th, 1913.

His Worship the Mayor.

Sir:—I beg to report on the accompanying communication from Mr. R. P. Bell, asking if the City will put water pipe, sidewalks and curb and gutter in the streets in Rosebank property, or if the property owners do it, if the City will reimburse them for the whole cost of the water pipe and half the cost of the sidewalks and curbs, the owners of the property guaranteeing interest on the two amounts for three years.

This proposal is similar to that made by Messrs. Carrick Limited. As I have dealt with the principle pretty thoroughly in that report, it is unnecessary to repeat it. It is an established policy of the City to extend the water pipe wherever there are houses or houses under construction, provided the owners of the property will pay five per cent. interest on the cost, not for a period of three years only, but until the revenue equals the interest. I presume the City is prepared to follow the same policy in this property. The City refused a similar request made by Mr. Bell's father for the property west of Windsor Street along Charles and Willow Streets, on the ground that the City should not finance the development of residential property at the expense of the general taxpayer and for the direct benefit of private speculators who were in competition with other private owners. The sidewalks, curb and gutter could not be put down by the City because the streets do not belong to the City but are still private property. No grading has been done on any of the streets but Connaught Avenue, and that has not been graded so that it could be accepted. The cost of the work, added to the estimated cost of the work already ordered would exceed the appropriation. Further, if the work were done as proposed by Mr. Bell, it would mean that the same value of work already ordered to be done on streets where houses are now occupied, could not be done until the City obtains legislative authority for an additional appropriation. The adoption of such a course would seem to me very unfair to those who have already constructed houses and developed their property at their own expense. Further, I have been notified by two gentlemen who are developing another property for residential purposes, that they propose to erect houses and construct sidewalks on it, at their own expense. It seems to me that the heavy expense which the City will probably incur to put in the water pipe and sewers for this property, an expenditure which will reach many thousands of dollars, should be sufficient for the general taxpayer to be called upon to pay to develop property for private speculation.

LOAN FOR STREET IMPROVEMENTS.

Gentlemen:—At a meeting of the Board of Control held this day it was decided to recommend for the approval of the City Council the attached resolution submitted by Controller Hoben respecting the decision of the local Legislature to disallow the authorization of a loan of \$50,000.00 for improvements to the streets of the City.

Moved by Controller Hoben, seconded by Controller Harris that said report be received. Motion passed.

Controller Hoben submits the following resolution:-

Whereas, on the 26th day of March, 1913, the following Aldermen being present— R. V. Harris, Morrow, Gates, Hattie, Hoben, Keltie, Hines, Hawkins, Martin, J. C. Harris, MacKenzie, Upham and Gough—the City Council of Halifax unanimously passed a certain resolution to borrow the sum of fifty thousand dollars;

And Whereas, said sum of fifty thousand dollars was intended to be expended in the macadamizing of the main arteries leading into the City, such as Campbell, Kempt, Jubilee, Longard, Chebucto and Quinpool Roads, Windsor and Robie Streets, thus releasing the inadequate street appropriation for expenditure upon many other streets, some of which are in very bad condition;

And Whereas, a bill was introduced into the Legislature of the Province of Nova Scotia whereby the City asked authority to borrow the said sum of fifty thousand dollars to be expended for such purpose, but said bill was defeated in the Legislature, and because of the defeat of said bill this City will be unable, for at least a year, or until a similar bill is put through the Legislature, to properly repair and keep in order its streets and roads;
Therefore Resolved, that this Council protests against the action of the Legislature and declares that, in its opinion, the direct representatives of the citizens of the City of Halifax are best capable of determining upon the local needs of the City, and that when, in the opinion of the City Council, it is necessary that moneys be borrowed for civic purposes, which moneys are chargeable to and payable only by the citizens of Halifax, the Provincial Legislature might well refrain from interference with the discretion which the citizens of Halifax, by their suffrages, were content to repose in such civic representatives;

Further Resolved, that this Council resents the said action of said Legislature as quite unwarranted and improper under the circumstances;

Further Resolved, that the City Clerk be directed to forward a copy of this resolution to the Premier of the Province of Nova Scotia.

Sir:—I have taken all the preliminary steps required by the City Charter for the purpose of expropriating the land required for the extension of Oakland Road and beg to submit the accompanying resolution which has been approved by the City Solicitor and which, when passed and the money paid into Court, will complete the expropriation proceedings.

The following resolution is submitted:-

Whereas, the City of Halifax requires the land and premises hereinafter described for the purpose of extending Oakland Road in the City of Halifax from Oxford Street to the shore of the North West Arm, and the City Engineer has duly prepared a plan of the said land and premises together with a description of the same, and also a report on the expropriation of the same, and submitted the said report, description and plan to the City Council for its approval, and the said report, description and plan were duly approved by the City Council on the fifth day of May in the year A. D. 1913, and a copy of same has been filed in the office of the City Engineer as required by law;

And Whereas, on the sixth day of May in the year A. D. 1913 a notice containing a description of the land and premises so required was duly served on the alleged owner of the said land and premises, together with a notice of the intention of the City Council to expropriate the land of the said owner after the expiration of the time required by law from the date of service of such notice;

And Whereas, on the 7th day of May A. D. 1913 a notice containing a description of the land so required and a notice of the intention of the City Council to expropriate the said land and premises after the time required by law from the date of such publication was duly published by the City Engineer in the Morning Chronicle and Acadian Recorder, two newspapers published in the City of Halifax, for two weeks from the said seventh day of May by two insertions each week;

Therefore resolved, that the said land and premises be and the same hereby are expropriated for the purpose aforesaid which said land and premises are described as follows:—

All that lot, piece or parcel of land, situate, lying and being in the Oaklands property (so called) in the City and County of Halifax, the said lot being more particularly described as follows:—

Beginning at a point formed by the intersection of the existing west line of Oxford Street with the existing south line of Oakland Road; thence in an easterly direction by the said existing south line of Oalkand Road for a distance of one hundred and five (105) feet; thence southerly at right angles to the said existing south line of Oakland Road for a disance of twenty nine (29) feet more or less or until it meets the proposed new south line of Oakland Road as laid down on the Official City Plan; thence westwardly by a prolongation of the said new south line of Oakland Road as laid down on the Official Plan for a distance of eighty-five (85) feet more or less; thence farther westerly for a distance of five hundred and seventy-three (573) feet more of less or until it meets the eastern shore of the North West Arm at a point distant twenty-nine (29) feet measured at right angles to the prolongation of this line from an iron bolt set in the rock at or near high water mark at Black Rock Point so called; thence further westwardly by a prolongation of the last described course for a distance of one hundred and sixteen (116) feet nore or less or until it meets the western boundary of the water lot owned by the said Roderick Macdonald; thence northerly by the said western boundary line of the said water lot until it meets a line drawn parallel to the last described course and distant sixty (60) feet northerly therefrom; thence easterly by a line parallel to the second last course described above and distant therefrom sixty (60) feet, for a distance of one hundred and fifty (150) feet more or less or until it meets the eastern shore of the North West Arm; thence further easterly by a prolongation of the last described course for a distance of five hundred and sixty (560) feet more or less or until it meets the existing west line of Oxford Street; thence in a southeasterly direction by the said western line of Oxford Street for a distance of forty-five (45) feet more of less to the place of beginning.

The above described lot being all that part of the property known as Oaklands belonging to the said Roderick Macdonald and the water lot in front thereof shown on the accompanying plan as the "Extension of Oakland Road" and also a portion lying to the south of Oakland Road.

Be it further resolved, that the City Clerk be and he is hereby authorized and instructed by and on behalf of the City of Halifax to pay into the Supreme Court at Halifax for the said land and premises, the sum of five hundred dollars (\$500.00), the said sum being in the judgment of this Council a reasonable value for the said property, and that the City Engineer notify the said alleged owner that in case he within one month from the date of service upon him of such notice notifies the Mayor of the said City that the amount paid into Court for him is not sufficient, that the said alleged owner shall be at liberty to name an arbitrator to act for him within one month from the date of service of such notice upon him, to act with other arbitrators as by law provided, to make a new award.

We communicated with the manufacturers of boilers and obtained prices for installing a new boiler on this roller.
