As there is no prospect of an early demand for a sewer in the district which the proposed outfall would provide for, I do not think it would be in the interest of the City to make any expenditure in that direction now.

CITY ABATTOIR.

Read report Board of Control covering reports City Health Board and Controller Harris in re the establishing of a City Abattoir.

Gentlemen:—In order that legislation may be sought at the present session of the Legislature Assembley authorizing the City to establish a City Abattoir, the accompanying report of the City Health Board covering the report of the Chairman of that Board and Controller Harris, is submitted for favorable consideration of the City Council, His Worship the Mayor and Controller Hoben dissenting.

F. P. BLIGH, Mayor.

The Necessity:-The matter of proper inspection for our meat supply is of vital importance and an urgent necessity. Apart from the fact that the slaughter houses in this City are most offensive to the neighborhood and depreciate the values of the neighboring land, it is only necessary to visit them to be disgusted with the filthy conditions existing in some of them, especially in summer. Conditions which I have seen at slaughter houses in this City are absolutely unpardonable. Pigs are fed on the offal of animals in defiance of the regulations. The pig pens are filthy and in summer time flies swarm in myriads about the place. I am advised by the Veterinary Director General of Canada, that in at least one case even of the house killing for export, a Dominion Government Inspector would not be supplied because of the absence of proper sanitary conditions. It is a safe statement to make that at least 10% of the entire meat supply from these slaughter houses would not pass inspection, and that a fair proportion of sound meat sent there to be killed becomes infected from unclean conditions and careless handling. With regard to the supply of meat killed elsewhere and brought to Halifax, Dr. A. T. McLean, veterinary inspector of Truro states that he believes meat which would not pass inspection by him for sale in Truro because of slaughter house conditions is being sent to Halifax for sale. Truro is the only town in Nova Scotia, which has inspection of its meat supply at the slaughter house. Meats shipped from other sections of the Province cannot be any better than the cattle sent here to be killed. Dr. McLean informed the board that when he began his work seven months ago about 80 out of 450 cattle in the vicinity of Truro were affected with tuberculosis. Dr. C. A. Hodgets, medical adviser to the Conservation Commission Ottawa, writes:

Owing chiefly to our large export trade in meat, the Federal Government has established a very efficient system of inspection both of the animals before slaughter and at the time of slaughter in all the abattoirs engaging in export trade. This system, most excellent in many ways, has acted more in the interest of the foreign consumer than it has to the Canadian consumer. Indeed, with few exceptions where retailers handle exclusively meat the product of the Federal licensed and inspected, abbatoirs, the city consumer of meat is today supplied with meat inferior in quality to the Canadian meat sold to the consumers of Canadian meat in the foreign cities to which it is exported. Our city authorities have no system of modern meat inspection which guarantees to the inhabitants the meat of healthy animals,. In the main, we export the best and eat that which would not pass Dominion inspection either alive or dead, and yet the price is as high. We in Canada get quantity without any guarantee as to quality, and under the existing laws the civic authorities are powerless. Our laws in this respect have outlived the conditions which existed when they were made, and are quite unsuitable for present methods of trade and commerce. Meat to be pure and fit for food must be derived from sound and healthy animals, yet there is no efficient law whereby you can protect yourselves.

Evidently the money and the lives and the market of the foreigner are of more value to the state than the lives, the money and the markets of our own country. Apparently it is a case that the city dweller—and they now number millions— must eat what he can get to exist, and vote.

History:—The subject of a municipal abattoir for Halifax has been considered for a number of years past both by the Board of Health and the City Council. In April 1909, the Board of Health had a consultation with the victuallers owning slaughter houses with a view of arriving at a mutually satisfactory proposition for a central slaughter house for the City, but no satisfactory agreement was arrived at. The matter went to the Council, then to a special committee. That committee reported that a preliminary step to build a civic abattoir would be legislation regulating the inspection and killing of all cattle offered for sale in the Porvince or brought into the City for consumption. The matter dragged on for a year or so the Board of Health directing the attention of the Council to the unsanitary and unsatisfactory conditions in connection with existing slaughter houses, and urging the Council to make some provision for a public abattoir, and the Council failing to act. In March 1912, the Health Board inspected the various slaughter houses

of the City with a view to utilizing one or more of them as a civic abattoir and recommended the purchase of Messrs. Edwards' and McLeod's properties and the making of necessary improvements. The Board recommends that legislation be obtained for the establishment and operation of a civic abattoir, and further obliging all meat sold within the City to be slaughtered in such abattoir or be stamped with a Dominion Government inspector's mark. The proposal was lost (March 21st, 1912.) in Council, owing to its not receiving a two third's vote (10-3) and again (April 4th, 1912) for the same reason (11-4). This proposal for a public abattoir owned and controlled by the City had the support of various proprietors now engaged in the business (see Min. Council p. 436).

In April 1912, Mr. Heber Hartlen made a proposal to the City Council to establish a private abattoir, provided the City secure legislation requiring all meat sold in the City to be inspected during the whole course of slaughtering by. Dominion Government Inspectors. The legislature had adjourned however before the proposal was considered by the Council (May 10th, 1912). In July and August, 1912 the Board again had the matter under consideration and urged the City Council to procure such legislation as might be necessary to provide that all animals killed in the City for food purposes be slaughtered under inspection. Since then little or nothing has been done.

The Present Situation. At present under 'The Meat and Canned Food Act', (Dom. Legis. 19 Ch) all slaughter houses doing a foreign or inter-provincial trade are required to have their meats inspected. Houses trading within the Province in which they are situated do not come under this inspection at all. The Maritime Provinces are regarded as one province or district.

Under the City Charter, (sec. 853) the Board of Health may make bylaws in relation to the location and regulations of slaughter houses and the manner in which the same shall be conducted; also the inspection and regulation by license or otherwise of the food supply and the condemnation and destruction of food unfit for comsumption. Meat sold in Halifax comes from three sources:. [1] Meat killed outside the Maritime Provinces which of course must have passed Dominion Government Inspectors. [2] Meat killed outside the City but within the Maritime Provinces none of which passes any inspection. [3] Meat killed in Halifax which does not pass inspection and nearly all of which is killed under conditions which I have described.

Each has to be dealt with in a different way. Class [1] takes care of itself, being under Dominion Government inspection.

Class [2] can be taken care of in the way Dr. A. T. McLean recommends namely by requiring the vendor to produce for inspection the vital organs &c. at the railway Station. Further Provincial Legislation is not required to carry out this recommendation.

Class [3] can be dealt with only by the establishment of a civic abattoir, and refusing a permit to all other abattoirs not complying with the bylaw of the Board of Health which is now virtually a dead letter so far as inspection of the slaughter houses is concerned.

Proposal Financially. \$1500 would have solved the difficulty in March 1912. Another estimate for the second proposition later in the year was \$20,400. Assuming that \$25,000 be the cost of the building, I submit the following estimate of income and expenditure.

The prices are the present charges and the numbers are those of cattle &c killed in the City during 1911. Since then the numbers per year have increased considerably. The estimate of expenditure then made provided for three men and a boy receiving wages amounting to \$40 a week. Assuming the wages to be \$55 a week, the estimates would be as follows:

One inspector would be for abattoir work, the other for outside inspection [at the railway station and elsewhere]. The profitableness and financial safety of the proposal is undoubted as the almost universal experience in the matter of Municipal abattoirs shows a balance on the right side. The primary reason however for the abattoir is the protection of the public health "the first obligation of every municipality."

Municipal Abattoirs. In the most European countries slaughtering has been confined to public abattoirs for years. France, Germany, Austria and Denmark do not permit private slaughtering houses to be established at all. In the British Isles a very large number of the smaller cities and towns and a few of the largest centres have established and operate municipal undertakings most successfully and profitably.

The Municipal abattoirs of Adelaide S. Australia prepare the meat supply of the state and represent the very latest ideas in every department. Their control is vested in members of the various local governing bodies and the annual gross return is $21\frac{1}{2}\%$ on the capital invested.

In the United States public abattoirs with municipal inspection are maintained at Paris, Tex., Montgomery, Alabama, Nashville, Tenn., Duluth, Iowa, Los Angeles, Cal, and elsewhere. Grand Forks, N. D. has just passed favorably upon a bond issueof \$12,000 for the erection of a model municipals laughter house. The system of federal Government inspection inaugurated after the "Jungle" expose of 1906, is supplemented by state live stock sanitary boards, but where municipal abattoirs exist the situation is hardly better than in Canada.

In the Dominion the movement for proper municipal conditions is very pronounced. Ottawa, Saskatoon, Victoria, Calgary, Winnipeg, and Montreal are all moving in the matter. Toronto has completed and equipped a city abattoir on an extensive scale. In a recent report of the veterinary director of Canada occurs the following:

"I am satisfied that once the Canadian public has become seized of the situation, they will insist, upon the adoption by the various municipal authorities throughout the country, of a much more thorough system of dealing with butchers and the meat trade generally, than has hitherto been tolerated.

It does not appear to me that there is any need for or likelihood of conflict. We are setting a fairly high standard, and all that is required is for the municipal authorities to adopt, under the legislation now existing, regulations somewhat similar to ours, with a view of rendering unmarketable diseased or otherwise unsound meats, which, under present conditions, cannot enter establishments engaged in export or inter-provincial trade.

The first and most important step in this direction, will, it is needless to say, be the providing of public municipal abattoirs to be conducted under inspection methods similar to those required by the Meat and Canned Foods Act, especially as regards the admission either of live animals or their carcases. The sooner the private slaughter house is abolished altogether the better for all concerned, as most of the objectional meats placed on the markets emanate from these undesirable and unsanitary places.

The trade in home killed dressed carcases, will also, for similar reasons, gradually be wiped out of existence, and although the abolition of this form of meat disposal will probably cause some temporary dissatisfaction among farmers, matters will soon adjust themselves and the profits to the producer will be in no wise lessened although the livers and other offal hitherto utilized by the household.

The municipal abattoir is a modern necessity and must come."

Boards of Health and Municipal authorities have been too long neglectful of the necessity for intelligent action, in the matter of meat inspection.

It is the duty of every man to see that his family, as well as himself, does not eat diseased or unwholesome meat. In places where establishments under Federal inspection do not exist, safety in this regard can be secured only by the establishment of a municipal abattoir conducted under the constant supervision of a skilled professional inspector.

Recommendation: I recommend (1), that permissive legislation be obtained providing for the establishment of a City Abattoir, within or without the City at a cost not exceeding \$25,000.

(2) The rigid enforcement of the existing by-law in respect of present slaughterhouses with the additional requirement that each abattoir maintain an inspector at its own expense.

(3) The enactment of a by-law requiring all meat sold in the City to be delivere in the City with the viscera attached for inspection.

OAKLAND ROAD BOAT LANDING.

Read report Board of Control, May 4th, 1914, re boat landing at the foot of Oakland Road, at the North West Arm.

City Hall, May 4th, 1914.

The City Council,

Gentlemen:—On September 25th, 1913, the Board of Control submitted to the City Council a report recommending that Joseph Boutelier be granted the exclusive privilege of obstructing the street at the foot of Oakland Road for the purpose of a ferry landing, but not for the purpose of hiring out boats; the size, character and location of any structure to be erected, and the agreement to be entered into, to be to the approval of the City Engineer and the Board of Control. The report of the Board of Control has never been acted upon by the Council. On February 27th., Mr. R. T. MacIlreith appeared before the Board of Control, on behalf of Joseph Boutelier, requesting that the application made by Mr. Eoutelier to erect a building at the foot of Oakland Road in connection with his ferry be granted on the usual conditions. The Board acquiesced in the request.

The matter is submitted to the Council for its determination.

F. P. BLIGH, Mayor.

Moved by Controller Harris, seconded by Controller Hoben that the report be adopted.

Moved in amendment by Alderman Smith, seconded by Alderman Murphy that this matter be referred back to the Board of Control for further report.

After discussion it is moved by Aldermen Murphy seconded by Alderman Riordon that the application of David Dixon for the privilege of hiring boats at the foot of Oakland Road be granted.

After further discussion, it is moved by Alderman Parker, seconded by Controller Hoben that the report of the Board of Control be referred back to the Board, for further report at the next meeting of this Council.

After further consideration, Controller O'Connor, by leave of Council, submits the following amendment:—

That in the opinion of this Council, the Board of Control should consider along with the application of Joseph Boutelier for ferrying privileges at the foot of Oakland Road the application of David Dixon for the privilege of keeping boats for hire at the foot of said road, and report back to this Council.

The amendment moved by Controller O'Connor is seconded by Alderman Murphy, and is put to Council and passed.

PROPOSALS FOR AMENDING ASSESSMENT ACT.

Moved by Controller O'Connor, seconded by Alderman Riordon that No. 5 on the Deferred Business Paper be now taken up. Motion passed.

Read No. 5 namely,—Report Board of Control covering Controller O'Connors proposals for amendment to the Assessment Act, submitted City Council March 4th, 1914, read April 24th, 1914.

Halifax, N. S., January 20th. 1914.

To the Board of Control.

Gentlemen:—Under authority of a resolution passed by the Board on the 2nd day of January 1914, I recommend that the Board, for the purpose of providing an increased annual civic revenue and more equitably distributing the burden of the city's financing, should obtain from the Council a direction that the Legislature be approached and asked to legalize the following changes in the city's assessment, taxation and license systems.

1. That land and the improvements thereon and, as well, all manner of personal property liable to assessment, be separately valued for assessment purposes at their full value.

2. That the rate of taxation to be borne by land be arrived at in the same manner as the general rate is now ascertained.

3. That the rate of taxation on improvements upon land be fixed for 1915-16 at one dollar on the hundred, (being about one-half of the present rate), the said rate to be .75 for 1917-18, and .25 less each succeeding two years until this tax has been totally eliminated.

4. That personal property of a total value of under \$500.00 contained n shops, stores or dwellings, and whether such personal property is held or purposes of sale or otherwise, be exempt from taxation.

5. That all plant and machinery actually installed and in use in any mill, factory, printing office or other industry be exempt from taxation.

6. That the rate of taxation on personal property in shops, stores or dwellings, and whether such personal property is held for sale or otherwise, be fixed for 1915-16 at one dollar on the hundred, the said rate to be .75 for 1917-18 and .25 less each succeeding two years until this tax has been totally eliminated. 7. That the present so called Poll Tax be abolished and that in its stead be provided a "Capitation Tax" which shall be payable by all male persons over 21 years of age residing or employed within the City, and whether or not otherwise assessed or taxed. That in the case of persons employed by others, whether those so employed are or are not residents of Halifax, this tax shall be payable by the employer and employee, but payment by either shall discharge from liability the other. The employer may deduct the tax from the employee's salary or wages. The City Collector upon payment of ten cents, to furnish to any employer or employee or other person liable a certificate of payment which certificate shall be the employer's only defence to a demand for payment of his employee's capitation tax. The capitation tax of any person whose name does not appear on the last prepared Provincial Electoral List for the City of Halifax before time of payment to be six dollars. The capitation tax of all other persons to be three dollars. If capitation tax be paid before March 1st a person not otherwise assessed to have the right to vote.

8. That all persons in receipt of salaries or incomes of \$1200.00 and over, but less than \$5000.00, pay an income tax of one per centum per annum thereon. That incomes of \$5000.00 and over pay an income tax of two per cent. The usual means of ascertaining incomes should be provided in any statute that may be drafted, and, in addition, in case the assessors are unable to secure satisfactory information they should be empowered to estimate to the best of their judgment and impose such estimate, subject to an appeal. The amount of the income tax should be made a lien on any real or personal property of the assessed person at any time found within the City.

9. That the "Special Taxes" upon Banks, companies, etc., be revised so that branch banks be brought within the provisions of the statute.

10. That retail liquor licenses be fixed at \$1000.00; wholesale at \$1500.00, and hotels at \$1500.00. Brewers' license fee should be relatively increased. That the necessity for obtaining signatures to license papers be dispensed with. That illicit selling be rigidly put down and that with that object in view any necessary amendments to the License Act be provided.

11. That all laundries owned or conducted or in the charge of male persons, be licensed at the rate of \$200.00 per annum. That billboards be licensed and pay a fee fixed by the area thereof. That public automobile garages be licensed at \$100.00 per annum. That butchers, fish dealers, cigarette dealers, milk dealers, and master barbers, be licensed. That licenses be granted only for premises and locations satisfactory to the Board of Control. That the license fees of some of the occupations mentioned should be small and designed more for the purpose of controlling locations than for revenue: but serving at the same time both aims. That the license fees paid by all itinerant traders, opticians and other persons of similar genus. That all present licenses except as varied be retained.

12. That automobiles be exempt from general taxation but that, instead, their owners pay an annual license fee of \$25.00 for each machine. That motor cycles also be exempt but pay a license fee of \$10.00.

13. That \$15,000.00 per annum be transferred from the surplus shown upon the operations of the city water system and applied to reduction of taxation. The surpluses of that department since 1896 aggregate about \$315,000.00 and are increasing in amount. I maintain that the amount levied for fire protection should be applied in whole or in part against the expense of conducting the fire department, the cost of which is annually assessed upon the citizens of today, whereas the water surplus is expended mostly upon the expenditures of the water department, the benefits of which expenditure the citizens of the future will share without having paid for the same. Our water charges are relatively low, so I do not favor a reduction of the water rate.

As the result of several meetings with the Auditor, Treasurer, Collector, and Chief Assessor, and after full discussion and obtaining the Chief Assessor's best possible estimate of what effect the preceding recommended changes would have upon our taxation system, I proceed to set forth a table showing what would be the probable revenue of the city if the changes could be brought into force for 1914-15, which, of course, they cannot. The estimate is made upon the assumption that the land tax would be \$2.00 per \$100.

It will be noted that I estimate personal property at \$10,000,000.00 for assessment purposes. This is at full value. It is valued under the present system at 75 per cent. But the present rate is \$1.99 Under the scheme proposed the rates is \$1.00 and this would shade down .25 every alternate year. Land and improvements are likewise estimated at full valuation. The improvement tax would likewise be but 1 per cent instead of \$1.99 as at present.

I now proceed to give a few concrete examples of the operation of the proposed system, assuming that the preceding estimates are about correct. Remember that in so far as they may be incorrect the making up of any deficiency will fall upon **land** pure and simple. The rate upon personality and upon improvements to land is "anchored" at 1 per cent. All the examples are based upon the present rate being 2 per cent. It is actually \$1.99.

If the calculations as above are too optimistic and if the land rate were 3 per cent-

No. 1's taxes would be \$ 8.00 less than at present. No. 2's taxes would be \$24.00 less than at present.

No. 3's taxes would be \$32.00 less than at present.

No. 2 might have an income of \$1500 and so be liable to pay \$15.00 income tax. He could pay it and yet be \$15 better off than at present.

No. 3 might have an income of \$4000 and so be liable for \$40.00 income tax.

He could pay it and yet be \$12.00 better off than at present.

The personal property tax of all three would be less. No. 1 would pay none. Nos. 2 and 3 half of what they pay at present. Ultimately none of them would have to pay taxes on personalty or improvements upon land.

Examples under personal property provisions.

1. Personal property in Mr. A's home now assessed at \$500. Mr. A pays about \$10.00 taxes. Under he new scheme he would pay no taxes, except the \$3.00 capitation tax.

Mrs B. runs a small shop and her stock is assessed for \$500. She now pays about \$10.00 taxes but under the new scheme she would pay no taxes.

Mr. C. is now assessed \$20.00 on his house furniture, value \$1000. 3. Under the new scheme he would pay but \$10.00. Ultimately he would pay no taxes.

Mr. D. carries \$10,000 of merchandise for sale. He is now assessed 4. for \$7500 and pays about \$150. Under the new scheme he would pay 1 per cent on \$10,000 or \$100.00. Ultimately he would pay no taxes.

Mr. E. is a manufacturer employing 100 hands. His land is valued at \$10,000, his factory at \$40,000. He has \$20,000 worth of machinery. He now pays about 2 per cent on \$70,000. or \$1400.00. Under the new system he would pay no taxes on his machinery, one per cent on his factory, and say 2 per cent on his land. His total taxes would be \$600.00. Ultimately he would pay taxes on his land alone.

Example under the income provisions.

Mr. F. is an estimable citizen whose line of business enables him to 6. earn an income of \$6000 per annum within a rented office furnished with a \$20.00 desk, two chairs, some ink, some pens and some writing pads. He employs no help and under the present system he pays no taxes. Under the proposed system he would pay \$120, being the equivalent of a property assessment under the present system of \$6000. There are a good many Mr. F's in Halifax.

Many persons, noting that notwithstanding the liberal tax reductions and exemptions which the preceding examples illustrate, will ask:-"Where is the money coming from? How is the difference made up?"

Certain gains are anticipated to be made in pure revenue by way of licenses and that sort of thing. If this source of revenue could be multiplied a little more than six fold it would not be necessary to impose any general taxation at all.

The \$40,000 gain of this kind is the equivalent of \$2,000,000 of assessable property at a 2 per cent. rate.

The \$75,000 income tax, (which I believe that I underestimate) is the equivalent of \$3,750,000 of assessable property at a 2 per cent rate.

The \$25,000 of anticipated gain from special assessments is the equivalent of \$1,250,000 of assessable property at a 2 per cent rate.

The \$15,000.00 from the water department, proposed to be devoted to reduction of the general tax rate, is the equivalent of \$750,000 of assessable property at a 2 per cent rate.

These few items alone could care for a reduction of \$8,000,000. in the general assessment.

I have not proposed a particularly scientific system, as I know. An out and out "single taxer" will probably sniff at it because it leans both ways. While from one aspect it seems a long step in the direction of the single tax, from another it may be said to incline towards the theory that the proper office of the tax gatherer is to "so pluck the goose as to secure the greatest possible amount of feathers with the least possible amount of squawking." The fact is that I would advise holding to our present anchors for a time even though we may slack the rope. Let us measure our waters and be sure. I have endeavored to put theories behind my back and to deal as best I could with real conditions. I would approach the land tax by stages, not with one jump. I have had the benefit of the kindly help and guidance of the civic officials closest in touch with financial affairs. The result can hardly be pleasing to all; but such as it is, here it is. I shall probably not be able to be present to support my ideas during the discussions to which this expression of them will inevitably give rise, so I ask for them on that account consideration and forbearance.
