His Worship the Mayor.

Sir:-I beg to report on the application of the Halifax Electric Tramway Company for permission to erect a gas plant on Water Street south of Morris Street.

The Gas Company's distribution system is laid out the same as the water supply system; the larger pipes starting from the works and smaller pipes branching off, each pipe becoming smaller as the distance from the gas works is increased. Conequently, the gas plant must be located in the neighborhood of the old one, or a great deal of reconstruction must be done in the distribution. The tearing up of the streets for this purpose is not desirable, to say nothing of the expense. The location proposed by the Company is the nearest available one north of the old plant.

The properties in the immediate vicinity of the proposed location have been in the neighborhood of the gas plant ever since they were erected. The water front is the proper location for the gas plant, as it must be readily accessible from the water coal supply, and as this neighborhood is already an industrial locality and must continue to be used for that purpose, I think the proposed location should be regarded favorably.

It is proposed to remove the two existing south car barns at the tramway property and erect in their place, the gas plant, except the gas holders for which there is no room east of Water Street. It is proposed to erect the holders on the west side of Water Street south of Morris Street as shown on the plan.

A possible serious objection has been met by the railway and the company in anticipation. If the gas plant buildings were not hidden by the new station, there might be a valid objection from the public to the erection of such a plant there. It is proposed, however, to erect a large new car barn to meet the requirements of the tram company on the south side of the proposed gas buildings, and to design the building architecturally so that it will harmonize with the station buildings and consequently appear to be a part of the Terminal system. It is proposed to plant trees on the north side of Fawson Street and erect a fence. There will be a square between Fawson Street and the new station which will no doubt be ornamented.

The plan proposed, means a more economical solution of the problem than any other, and collects the tramway property into one enclosure instead of being, as before in several different locations.

Sir:—I beg to report on the complaint made to the Board of Control that the domestic hydrant at the corner of Preston Street and Jubilee Road is wasting water very frequently.

This hydrant was installed to supply all the houses in the neighborhood including some houses on Jubilee Road, and some on Preston Street. Like all other domestic street hydrants it is located where it can be readily tempered with by mischievous boys, and it is usually put out of order either by boys or by water takers who use the brake and spring too roughly. There are not desirable installations and we avoid them wherever it is possible.

In this case, water extension has been made since the installation of the hydrant so that all but two houses are supplied with water from the main. There are two houses west of Preston Street on Jubilee Road, which the water pipe does not pass. The pipe extending from Oxford Street east is supplied from the low service, but extension has been made as far as that service will supply. The supply at Preston Street is high service and it will be necessary to extend the high service system down the hill westerly to reach the two houses which are now without water.

It would be advisable in making this extension, to connect up the two services The distance 240 feet; size of pipe required, 6-inch. Two valves are required, and the estimated cost is \$689.00.

It would not be just, however, to charge the whole cost of the extension, or rather the interest on it, to the owners of the two properties to be supplied, as the connecting up is for the benefit of the whole service in that neighborhood, not solely for the two property owners.

I would recommend that the extension be made and that the owners of the two houses be charged a special rate of \$5.00 each, and that the domestic hydrant be removed as soon as the water can be turned on to the two houses.

Dear Sir:—Immediately upon receipt of your letter of this date, enclosing copy of one of the 24th from Lt.-Col. Dean, asking whether the Exhibition Commission would be disposed to permit of certain of their buildings and grounds being used for quartering of troops, and if so, on what terms, I immediately placed the matter before our Board and after a full discussion, it was decided that in so far as the City's interests are concerned, we think it advisable in view of the situation obtaining, that every assistance should be extended the authorities in this work, and that if these buildings can be utilized to advantage, it would be perfectly agreeable to us that they be tendered the Department of Militia without charge.

The undertaking as suggested by Lt.-Col. Dean that the Department of Militia is prepared to assume full responsibility for any alterations found necessary, also for any deliberate or accidental damage done the property during their occupancy and to return to us the buildings in as near their original state as could reasonably be expected, would seem to us to be entirely satisfactory.

In as much as your letter would indicate that the matter is pressing we would ask you to be good enough to place before the Hon. Mr. Armstrong at the very earliest opportunity, the City's position as set out above, and to inform him in so far as we are concerned we shall be glad to assist as far as possible in having these arrangements concluded at the earliest date.

My Dear Sir:—I have the honor to acknowledge receipt of your valued favor of this date on above subject, and as requested have placed the same before the President, the Hon. Mr. Armstrong.

I may point out that the Department of Militia has, as yet, given no undertaking that they will assume full responsibility for any alterations found necessary, or for any deliberate or accidental damage done to the property which they might occupy. I am assuming, however, that they are prepared to give this undertaking. If any undertaking is made, it must be on the distinct understanding that no alterations are to be made without the consent and approval of the Commission, because the necessary alterations may be of such a character as to be detrimental to the future occupation of the buildings for Exhibition purposes.

I may also point out that no undertaking has been given to the Commission by the Department of Militia as to when they will vacate the buildings, or that they will leave them in their original state as far as can be reasonably expected. And even if this undertaking were given, its terms are too general to enable us to arrive at any satisfactory estimate of what it might mean in the future as far as expense to the Commission is concerned.

As pointed out in my first letter, it must be quite apparent that the buildings which the Department of Militia will require must undergo a very considerable depreciation as the direct result of their occupation for the purposes under consideration.

On behalf of the Commission, I beg to suggest-

1st. That the Department of Militia be requested to specifically state what buildings they will require, when they will require them and for how long they will require them.

2nd. That they will state exactly what alterations and repairs will be undertaken by them.

3rd. That they will undertake to repair any damages that the buildings or property may suffer as the direct result of their occupation for the purposes required.

4th. That they give an undertaking that these repairs will be made or paid for immediately after they shall have vacated the property. I make this stipulation because if there is any delay in this matter, it may nterfere with our programme for future exhibitions.

5th. I think the Militia Department should be willing to pay the insurance premiums upon the property they occupy during their occupancy.

6th. I note that you agree that as the benefit to the City from the quartering of so many men would naturally be great, the City would be willing to make good to the Exhibition Commission any repairs to property arising from ordinary wear and tear. I am not quite clear as to the meaning of this proposal.

I have therefore to submit for your consideration, that the City agree to pay to the Exhibition Commission a certain sum, either to be determined in advance, in lieu of rent, or that what would be a fair and reasonable allowance be made to the Exhibition Commission for repairs to the property, arising from necessary wear and tear, be determined on the termination of their occupancy, by some competent disinterested party or parties to be named by the City and the Exhibition Commission.

I am further instructed to assure you that the Commission has no desire to make any profit on this matter, but desire to preserve the property so that any deprecciation in its value, either directly or indirectly, caused by the occupation of the buildings for the purposes under consideration, should not be borne by the Commission for the reasons which I have pointed out in my other letter. The Commission has no means from which it may draw for any such purpose.

The President wishes me to further state that if it is necessary to arrange any further details he would be very glad to meet either your good self or any person whom you may name and further discuss the matter.

If these details can be arranged in accordance with these suggestions, I have no doubt a satisfactory answer on the part of the Commission may be given to the Militia Department.

Dear Sir:-Your further communication of the 26th acknowledging ours of the same date was today placed before the Board for their consideration.

We do not feel that any of the points raised should be difficult in so far as the Department of Militia is concerned in being met. Clauses 1, 2, 3 and 4 as set out on page 2, have so far as we know already been complied with. We do not feel that it would be worth pressing clause 5 as the amount involved would hardly justify it. Regarding clause 6 we do not quite see what further undertaking the City could make in this regard. Would suggest that the interpretation of same be left in the hands of two representatives, one to be named by your Commission, the other by the City. These representatives could make an inspection of the buildings as they now stand, and when the Department of Militia is handing them over it would be left to them to say just what would be necessary to place them as near the original condition as could reasonably be asked.

The Board felt that the Commission and the City should stand in the same position as on all other matters, that rather than permit of any question which might hamper the work of the Department in arranging for suitable quarters, they would undertake the responsibility of making good any ordinary wear and tear which might come to the buildings so loaned.

Sir:—I have the honor to forward herewith for your information, copies of extracts from correspondence on the matter of housing troops at the Exhibition Buildings, Halifax, N. S.

Copy of an extract from a letter from E. H. Armstrong, President Nova Scotia Provincial Exhibition, to Lt.-Col. E. C. Dean, A. D. S. & T. Division, Halifax, N. S.

1. That the cost of all necessary alterations be borne by your Department. It must, of course, be clearly understood that these alterations are not to be such as to render any of the buildings or property unsuitable for Exhibition purposes. The details of these can, I have no doubt, be reasonably agreed upon by your Engineer. and our own.

2. That your Department pay all costs and expenses connected with or incidental to the installation and supply of heat, light, sewerage and water.

3. That your Department is to repair or replace or pay to the Commission the cost thereof, for all damages to the buildings or property as the direct result of your occupation of the same for any of the purposes under consideration. These repairs to be effected by you, without any unreasonable delay, and so as not to interfere with our holding an Exhibition on our usual dates. 4. That your Department vacate the buildings and property occupied not later than the 1st day of June, 1916.

If the buildings, however, should be required by your Department for a further period so that the holding of an annual Exhibition might be interfered with written notice of such request must be given to the Secretary of the Commission on or before the first day of February, 1916, and an extension may be had upon ike terms.

5. As the Commission has no means at its disposal from which it can make good any depreciation of its property resulting from your proposed occupation of the same, your Department in lieu of rent, to agree to pay to the Commission by way of compensation for such depreciation, if any, such sum as may be decided upon by a competent and independent appraiser to be agreed upon.

The Commission has no desire to make any profit under this provision, but only desires to have its property returned in no worse condition, and with no additional cost, after your occupation, and as a result of it, than it was before or without it. Any payments under this clause are in addition to any referred to in clause 3.

6. That if the above terms are accepted the details be completed without delay, and an agreement executed by both parties in accordance therewith.

Telegram from G. O. C., Sixth Division to The Secretary, Militia Council, Ottawa:-

Halifax Exhibition Commission offer buildings free conditional upon being handed over in same condition as received and payment of depreciation caused by occupation to be determined by independent appraiser.

Gentlemen:-Having carefully considered the proposal of the Imperial Oil Company contained in their communication of July 27th, your Board beg to report as follows:-- 1. Realizing the importance of having such an industry as is proposed by this Company established in our City, we would feel inclined to meet them in any reasonable proposition that would not involve the taking of all the water front at the Africville property. If it werefound necessary to exercise the legislation we now have for the expropriation of the property known as Africville, we would retain the right to treat with the application for whatever part of the property that would in the opinion of the Board and Council be necessary for the proper carrying out of their undertaking, said portion to be disposed of to them at a price to be agreed upon.

2. In the first place the diversion of Campbell Road could not reasonably be considered unless the cost of diverting the road were borne by the Imperial Oil Co. and the work carried out under the supervision of the City Engineer and in accordance with plans, subject to the approval of the Board of Control and City Council.

3. In the matter of tax exemption we would recommend for your favorable consideration that the Company be exempt from taxation on any additional plant for a period not to exceed ten years, provided that the Company make an undertaking that at the expiration of three years they have buildings and plant to a valuation of at least \$250,000.00 for assessment purposes at the termination of the exemption period.

4. As to the request that we assist them in procuring from the Marine Department and Provincial Government whatever permission is necessary to construct suitable wharves, we would of course render any assistance possible.

5. We would further report that the Company could procure the water lots adjacent to the premises they now occupy, and also about twenty-five acres of land in the immediate vicinity. This, with whatever water front the City might feel inclined to dispose of, would be a matter for consideration by the Imperial Oil Company as to whether it would meet their requirements.

TRAMWAY FARES AND EXTENSION ACROSS THE COMMON.

Read message His Worship the Mayor re reduction of tramway fares for school children and for workmen and re entension of the tramway line from the corner of Cogswell and Gottingen Streets to the corner of Quinpool Road and Windsor Street across the Common, covering resolution.

Halifax, N. S., November 1st, 1915.

To the Members of the City Council.

Sirs:—I wish to bring to your attention the need that in my opinion exists for a further reduction in the rates charged by the Halifax Electric Tram Company for school children and workmen. The only reductions now allowed are in the morning hours between 6 and 8 o'clock. In other cities reductions to these classes are allowed not only in the morning hours but in the evening as well. In Montreal, for instance, the Company is bound to furnish school children's tickets at the rate of ten for twenty-five cents, which can be used at any hour and also workmen's tickets at the rate of eight tickets for twenty-five cents, which can be used on any week day between the hours six and eight in the morning, and also between five and seven in the evenings. In Toronto eight tickets are sold for twenty-five cents (not necessarily to workmen) good before eight in the morning, and five and six-thirty in the evening. A special Sunday ticket is also sold, seven fortwenty-five cents. In Winnipeg the rates for children and workmen's tickets are the same as in Montreal, except that workmen's tickets are available in the evenings only from five to six-thirty instead of until seven.

It appears to me that the time has come when the people of this City are entitled to as favorable terms as those of the cities I have mentioned, and others. The Company here is long past the experimental stage, and is now highly profitable and there does not seem any good reason why the morning reductions should not be made to apply to the evening as well. If it can be done in other places why not here?

I wish also to call your attention to another matter in connection with the Tram Co. In his letter to Mayor Bligh of 1st April 1913, Mr. Robert promised if the Council would grant permission to extend the Company's line up Cogswell Street across the Common to join the Belt line at the corner of Quinpool Road and Windsor Street. This is a matter of increasing urgency. The district west of the Common is rapidly filling up, and the present round-about route is the cause of great delay and inconvenience, and the Company should be asked to make good its promise.

I submit herewith for your consideration a resolution which has been approved of by the Board of Control dealing with both the above points.

Therefore Resolved that the said Company be requested to make the tickets now issued at reduced rates to school children be negotiable at any hour in the day and also to make the tickets issued to workmen at reduced rates for the hours between five and seven o'clock in the evening as well as between the hours of 6 and 8 a. m.

Further Resolved that this Council request the said Company at the earliest date possible to extend their line of rails up Cogswell Street and across the Common to connect with the Belt line at the corner of Quinpool Road and Windsor Street as premised by the President of the Company.

Further Resolved that the Board of Control do communicate this resolution to the Company and request an immediate conference for the purpose of considering the same.

The resolution is moved by Controller Harris, seconded by Controller Murphy and passed unanimously.

BILLBOARDS.

Alderman Parker asked when the Board of Control would report on the matter of the advisibility or otherwise of granting licenses for bill boards for the next civic year and as to the scale of fees that should be charged if licenses are granted, etc.

CROWN SIDE.

GEORGE, THE FIFTH, by the Grace of God, of the United Kingdom of Great Britain and Ireland, and of the British Dominion beyond the Seas, King, Defender of the Faith.

TO THE COUNCIL OF THE CITY OF HALIFAX,

GREETING:--

Whereas the City of Halifax is a body politic and corporate under Section 4 of the Halifax City Charter, which came into force by proclamation of the Governorin-Council on the twenty-sixth day of January in the year of our Lord One Thousand Nine Hundred and Fourteen.

And Whereas by Section 134 of the said Halifax City Charter it was enacted that the Council of the City of Halifax should from time to time upon the nomination of the Board of Control of said City of Halifax appoint a fit person, to fill, inter alia, each of the following offices, that is to say : Chief City Assessor and two Assistant Assessors.

And Whereas we have been given to understand in our Supreme Court before us, as follows:—

(a) That on the third day of December in the year of Our Lord One Thousand Nine Hundred and One, Francis C. Stevens, of the City of Halifax in the County of Halifax and Province of Nova Scotia, Gentleman, was duly appointed by the said Council of the City of Halifax to the Office of Assistant City Assessor of the said City of Halifax, and on the seventh day of December in the year of our Lord One Thousand Nine Hundred and One took and subscribed the oath of allegiance and oath of office, as required by said Halifax City Charter, thereby becoming a member of the Board of Assessors of said City of Halifax;

(b) That from the said seventh day of December in the year of Our Lord One Thousand Nine Hundred and One to the fifteenth day of June in the year of Our Lord One Thousand Nine Hundred and Fifteen the said Francis C. Stevens was and remained such Assistant City Assessor, at the statutory salary of said office, and in his said office of Assistant City Assessor always behaved and governed himself well;

(c) That the said Francis C. Stevens was on the fifteenth day of June in the year of Our Lord One Thousand Nine Hundred and Fifteen without any reasonable cause whatsoever, unjustly and illegally suspended from the performance of the duties of his said Office of Assistant City Assessor of the said City of Halifax, by Peter F. Martin, the Mayor of the said City of Halifax;

(d) That you the said Council of the City of Halifax, on the sixth day of July in the year of Our Lord One Thousand Nine Hundred and Fifteen at a special meeting thereof, without any reasonable cause whatsoever, unjustly removed the said Francis C. Stevens from his said Office of Assistant City Assessor of the said City of Halifax;
