NOVA SCOTIA CAR WORKS.

Read report Board of Control covering proposition of Ralph P. Bell re the reorganization of the Nova Scotia Car Works.

Gentlemen:—The Board of Control beg to submit herewith a letter from Ralph P. Bell, proposing on conditions named therein, to endeavor to effect a reorganization of the Nova Scotia Car Works, Limited.

The Board unanimously recommend that the proposition made by Mr. Bell be favorably considered by the Council, and that any necessary legislation in that behalf be prepared and submitted to the Legislature.

His Worship the Mayor and Board of Control.

Gentlemen:—Since the beginning of last December I have spent a large part of my time as a member of a committee of the preferred shareholders of the Nova Scotia Car Works, Ltd., endeavoring to effect a reorganization of this Company in the interests of the shareholders.

The matter finally reached a stage where it was felt that unless an individual would devote practically his entire time to the matter that very little could be accomplished. I agreed to undertake a scheme which involved the formation of a syndicate that would put up sufficient money (approximately \$80,000) to offer the general creditors a cash compromise of fifty cents on the dollar, assuming always that if we were able to raise such a sum and effect a settlement of this nature that the City would renew their mortgage, consolidating its over-due interest and payments with its present face, and that the owners of the five year gold notes (amounting to \$200,000) would renew their loan.

After a great deal of hard work I was successful in accumulating a fund of \$60,000 and felt justified in approaching the largest creditors, so as to get the thing definitely started. Unfortunately they refused to accept the offer, and as a consequence, from the stand-point of the shareholders generally, the effort for reorganization has failed.

Having spent so much time I feel that it would be a pity to drop the matter without trying to interest outside capitalists to take hold of this plant and make a success of it, and provided I can get the consent of the City to the following proposal I will use my best efforts to negotiate a deal of this kind.

The proposal is as follows:-

That the City of Halifax give me an agreement to the effect that if I can interest a reputable concern, or parties, who are financially able to carry out such an undertaking, to a point where they are willing to purchase this plant, that the City will agree to renew their present mortgage and the franchise that the Nova Scotia Car Works, Limited now have, consolidating the overdue interest and installments with the present face of the mortgage.

As I understand it legislation would have to be asked for at this session of the House, so that there might be no delay in bringing to a speedy completion negotiations of this character when once started.

Will you kindly give this matter your careful consideration at today's meeting and, if possible, arrange to have it brought up at tonight's meeting of the Council, so that I may have definite information at the earliest possible moment which will enable me to proceed with the work at once.

The said assessor shall with the help of the said assistants perform and discharge the duties now to be performed by the Board of Assessors, and shall subscribe the rate book in his own name, and the forms of notices of assessment and any other notices from or to the Board of Assessors shall be modified accordingly.

4. The Council may appoint a person to be assistant assessor who shall perform such duties as are assigned to him by the assessor, and in the event of the illness or absence of the assessor, any duty to be performed by him may be performed by such assistant assessor. Such assistant assessor shall be appointed and hold office under section 137 and shall be paid such salary as the Council yearly determines.

The list of benefits and advantages, which the Union has obtained for all our municipalities, is a very long one, and a splendid record of the public-spirited municipal men of Canada. Out of the work of the Union have grown all the laws protecting our highways and streets from the encroachments of Railway, Telephone, Electric and other Companues, as well as of irresponsible charter sharks; all of the provincial telephone systems; all the great public hydro-electric plants and commissions; all the provincial municipal unions; innumerable parks and improvements; a great deal of the municipal and expert matter lavishly published in the volumes of the Canadian Municipal Journal; over fifty valuable municipal Conventions, and a constant stream of correspondence in response to requests for every kind of municipal information and help.

No municipal body in the world has accomplished so much in these fields. Few public bodies of any kind have ever accomplished more. Water takers should be careful to watch the record of meter readings left by the Meter Reader each month, and either remedy the waste which the meter readings show or report to the Water Department at once if the cause of excessive consumption cannot be ascertained.

Sir:-I beg to report on the attached bill and communication respecting charge for water supplied at No. 3 Willow St., owned by James McGrath.

Mr. McGrath states that he received a notice from the Clerk of Works, calling attention to waste of water at his house, and on receipt of notice, sent a plumber at once to make repairs. He further states that on investigation he found that his tenant was duly notified of the amount of water consumed monthly, but that he was not aware of it.

The City is under no obligation to notify either the owner or tenant when water is being wasted; it is the duty of the property owner himself to be familiar with the conditions of his plumbing at all times. It would be admitting responsibility if we were to agree that any such contention were correct. The readings for No. 3 Willow St. are left at the house, and if Mr. McGrath desires it, they can be sent to him.

The inspector not only reported a closet wasting but also reported that the water was allowed to run during winter months. The wasting closet was reported for nearly a year. The law does not permit me to recommend any reduction.

On enquiry and discussion of the question, I find that my off-hand opinion on this question is perhaps not reliable advice. The agent for the manufacturers of the lead pipe, states as his opinion that the price of pipe, which has already doubled since the war began, will probably go higher. Other men in business are of the same opinion. The opinion of men who have to watch the market constantly, is, of course of much more value than that of any man who is not familiar with it. At the same time there is a probability that the termination of the war will bring down the price.

It is a difficult question to decide, as the purchase of 15 tons of pipe means the expenditure of nearly four thousand dollars. While there is a difference of opinion on the question, the weight of opinion seems to favor the purchase of the quantity required for this year at the price quoted. In any case it is a speculation and must be decided by the business judgment of the Board and Council.

Estimated on the total number required to hold the cement, Brookfield Bros. will pay \$1500 and J. C. Calder \$1700; a net advantage in Mr. Calder's tender, of \$181.25. Brookfield Bros., however, claim that they have always taken the City's count of bags returned and paid accordingly. It therefore would be fair to offer the contract to J. C. Calder provided he will agree to that condition. If he does not do so, it is not so clear that he has made the lowest tender.

Brookfield Bros. have written me a letter since the tenders were opened, stating that if they are awarded the contract they will guarantee to receive the returned bags on the basis of our count as to condition and number, and that such returns will net the City not less than 9c each. Sir:—I beg to report on the proposal of Alderman Isnor to obtain legislation that 15% should be retained as final payment on contracts for a period of sixty days, and which shall not be paid until otdered by the City Council.

I think it would be a mistake to obtain general legislation as it would apply to every contract, and nearly all our contracts are for supplies or for small sums. In either case it should not be necessary to withhold 15%, as competition is keen, prices are cut fine and payment should be made practically on a cash basis as soon as the work is certified to be satisfactory or the quantity of supplies ordered is delivered.

It is our custom to insert a clause in specifications for important work such as the Reservoir and Market Building, to provide for the retention of 15% for thirty days to cover the requirements of the Lien Law, and in all cases the final payment on the contract is sent to the Council to be passed before paying. If we were not following that custom now, it might be desirable to pass a resolution of Council, adopting it, but as it has been the policy of the City ever since I have been in the City's service and is the policy of all architects and engineers, I do not see the necessity for it. Alderman Isnor proposed a period of sixty days, but I have heard no reason given or argument made to support a contention that the sixty days is necessary or desirable.

LEGISLATION RE FIRE HAZARD.

Read report Board of Control covering a draft Act providing for inspection by the Chief of the Fire Department of premises affecting the fire hazard.

Gentlemen: — The Board of Control submit for the approval of the City Council the accompanying Act providing for inspection by the Chief of the Fire Department of premises affecting the fire hazard.

It is recommended that the City Solicitor be authorized to insert amendments in the draft act providing that notices may be served on agents of properties or by registered letter; that the Chief shall not take any action involving penalty on persons disobeying his orders without first submitting a report in writing to the City Solicitor and receiving the City Solicitor's approval in writing.

A Bill Entitled An Act to Amend the Law in Relation to the City of Halifax.

Be it enacted by the Governor, Council and Assembly as follows:

1. It shall be the duty of the Chief of the Fire Department to inspect or cause to be inspected by Fire Department Officers or members or by an official appointed for the purpose, as often as may be necessary, but not less than twice a year in outlying districts and four times a year in closely built portion of the City all public thoroughfares, buildings and premises, except the interior of private dwellings and any private dwelling may also be entered for a special eason or when complaint is made that dangerous conditions exist, for the purpose of ascertaining and causing to be corrected any conditions liable to cause fire or any violation of the provisions or intent of this Act or of any Ordin ance of the City relating to the fire hazard.

2. Whenever the Chief of the Fire Department or any Fire Department Officer or member or the official appointed for inspection purposes as aforesaid shall find any building or other structure which, for want of repairs or by reason of age or dilapidated condition or for any other cause is, in his or their opinion especially liable to fire and which is in his or their opinion so situated as to endanger other property, or shall find in any building or upon any premises or other place any combustible or explosive material or dangerous or unnecessary accumulation of rubbish, waste paper, boxes, shavings or any other highly inflammable materials especially liable to fire, and so situated as to endanger other property in case of fire, or shall find obstructions to or on fire escapes, stairs, passage-ways, doors, windows or other entrances to or exits from buildings liable to interfere with the operation of the Fire Department or egress of occupants in case of fire, he or they shall by notice in writing to the owner or occupant order the same to be removed or remedied and such order shall forthwith be complied with by such owner or occupant of such premises or buildings.

3. Whenever the Chief of the Fire Department shall find that the appliances on or in any building, structure or premises for protection against fire are not in proper condition or of insufficient size or number or are otherwise insufficient for the purpose for which the same are designed or intended, or shall find that such appliances are reasonably necessary for the protection of such building, structure or premises and are wholly wanting, he shall order by notice in writing to the owner or occupant of such premises in the case of such improper condition or insufficiency of such appliances that the same be placed in proper condition and rendered reasonably sufficient to afford reasonable protection against fire, and in the case of absence of such appliances where, in his opinion, the same are reasonably necessary for protection against fire, he shall order by similar notice in writing the installation of appliances sufficient to afford such reasonable protection in case of fire in said building, structure or premises and to the occupants thereof or persons rightfully on or in the same.

4. Any owner or occupant failing to comply with any such order within ten days after the service of same shall be liable to a penalty as hereinafter stated. The service of any such order or notice in writing upon the occupant of the premises to whom it is directed may be made by either delivering a true copy of same to such occupant personally, or by delivering the same to and leaving it with any person in charge of such premises, or in case no such person is found upon such premises, by affixing a copy thereof in a conspicuous place on the door or entrance of the said premises, and the service of any such order or notice in writing upon the owner of such premises may be made by delivering a true copy of same to such owner personally or if such owner is absent from the City, by mailing such copy addressed to the owner at his last known address or place of abode.

5. No person, firm or corporation shall manufacture, transport, use, care for, keep, sell, give away or otherwise dispose of any explosives or inflammables or other substances of like nature or materials, compounds, combinations, or things whatsoever which may tend to increase fire hazard or conduct any hazardous business or operation or perform any service of like dangerous character within the City without first obtaining a license or permit therefor, which license or permit shall set forth and describe the amount or quantity of said explosives, inflammables, or other substances or things which may be manufactured, kept or otherwise dealt with by such licensee and the terms, conditions and restrictions under which the same shall be so manufactured, kept or otherwise dealt with. Application for such license or permit shall be made in writing to the Chief of the Fire Department and shall be accompanied by such particulars or facts as he shall require or deem necessary and the said Chief of the Fire Department shall investigate the facts and circumstances in connection with such application and may either grant or refuse such li-cense or permit, and no fee or charge shall be made for such license or permit.

6. No person shall kindle, maintain, or assist in maintaining any bonfire or other exposed fire within the City except under written permit from the Chief of the Fire Department and any such fire shall be confined within metallic receptacles approved by him and be conducted under such proper safeguards as he may direct as to time and weather and other conditions, and-such permit shall carry with it an obligation on the part of the person to whom the same is granted to keep a sufficient safe control of said fire and to be responsible for all damage therefrom and that all resultant embers shall be extin guished and hot ashes removed or wet down after said fire.

7. Any person, firm or corporation violating or failing to comply with any of the provisions of this Act or of any license or permit issued hereunder shall for each day on which such violation or failure to comply continues be liable to a penalty not exceeding twenty-five dollars and in default of payment to imprisonment for a period not exceeding sixty days and for a second or any subsequent offence, shall be liable to a penalty not exceeding one hundred dollars, and in default of payment to imprisonment for a period not exceeding three months and in addition to the said penalties in case of fire resulting directly or indirectly from any omission or neglect to properly comply with any order or notice in writing of the Chief of the Fire Department, the person, or persons culpable or negligent in respect thereto shall be liable in a civil action at the suit of the City of Halifax to pay all costs and expenses of the Fire Department incurred in and about the use of employees, apparatus and materials in the extinguishment of any such fires. Any such civil action may be commenced and prosecuted by the City of Halifax before either the Stipendiary Magistrate of the City of Halifax or the County Court Judge at Halifax and the amount of all such costs and expenses when collected shall be paid to the Treasurer of the City of Halifax.

8. Any person dissatisfied with any order or decision of the Chief of the Fire Department under this Act shall have the right of appeal therefrom to the Judge of the County Court for District No. 1, who upon such appeal, shall determine whether such decision- or order was just or reasonable and the decision or order of such Judge upon such appeal shall be final.

The said Act is read.

Moved by Controller McKeen, seconded by Controller Halliday that the said draft Act as proposed to be amended in the report of the Board of Control be adopted, and referred to the City Solicitor to incorporate the amendments suggested, and submit to the Legislature for enactment. Motion passed.

BILL BOARDS.

Read report Board of Control re license fee for bill boards.

City Hall, March 31st, 1916.

The City Council.

Gentlemen:—Agreeably to request of the City Council, the Board of Control beg to report that they have again considered the question of fixing the license fee for bill boards at a higher rate than now exists, namely $\frac{1}{2}c$ per

square foot. The original recommendation of the Board of Control was that the fee be increased from $\frac{1}{2}c$ per square foot to 2c per square foot. The City Council referred the recommendation back to the Board with the suggestion that the fee be increased to 5c. The Board then recommended that the tax be placed at 3c. The Council having again referred the matter back to the Board they have given further careful consideration to the matter, and heard the objections of the E. L. Ruddy Co. to the proposed increase. The Company was requested to state their case in writing, which they have done, and their letter, together with a telegram from their head office at Toronto, is submitted herewith.

The Board now again recommends that the fee be fixed at 2c per square foot, as recommended in their original report.

Halifax, N. S., March 30th, 1916.

To His Worship the Mayor and Members of the Board of Control.

Gentlemen:—Following your request to put my statements made relative to Bill Board taxation at the Board of Control meeting of March 29th, in writing, as representative of the E. L. Ruddy Co., I take pleasure in placing before you such matters pertaining to the business of this Company in Halifax as will assist you in arriving at a reasonable taxation for the said Company.

I might first bring to your attention the capitalization of this Company in Halifax. The E. L. Ruddy Co., Ltd., have owned the billboards in Halifax for about seven years, and in that time their investment is approximately \$8,000.00—which money has been spent in purchase of the business, and in repair work from year to year. Notwithstanding the fact that they have invested this amount of money in Halifax their capital account is approximately \$3500.00. The reason for this is that they have about 3500 lineal feet of billboards, and in this business one dollar per lineal foot is all that a plant can be valued at. It costs on an average of \$2.50 per lineal foot to construct a bill-board but if same were torn down and sold, there would be few cases where you would receive \$1.00 per lineal foot for it; thus we arrive at a value of \$1.00 per lineal foot.

Now, having acquainted you with the capital or value of our business we will take the following figures to show what an increase in taxation would mean. We are paying, according to the existing tax, $\frac{1}{2}c$ per square foot; having 35,000 square feet, we pay the sum of \$175, which means we are paying \$175.00 on a capital of \$3500.00. If this was increased, as suggested, to 2c, we would pay \$700.00, at 3c we would pay \$1050.00; and at 5c we would pay \$1750.00. Now we will take the amount of business done and we will take the year 1915, which was an average year for us. In 1915 our total business in Halifax was \$6560.68; the cost of maintaining our plant was \$6167.61, which shows a profit of \$393.07. On this amount of business we are paying \$175.00, and the increases proposed would work out as previously stated on amount of capital.

I have given you now a full knowledge of our business in Halifax, and from the above figures (which are taken from our Auditor's annual statement, and sworn correct) you can see that any increase in our present taxation would be unfair, and unreasonable, and would simply legislate us out of business in Halifax. I might further state that our taxes at present in Halifax are higher than that paid by any Bill Posting Co. in any town or city in Canada, and there is not a live town of four or five thousand population and upward in Canada or United States that has not a billboard business. We are willing to pay any reasonable tax, and co-operate with the City authorities in any way to arrive at a satisfactory arrangement, and we will at any time remove any board to which a reasonable objection is made; we also state that at no time will we post any paper that may be objectionable, and if required by the Authorities, will present our paper for inspection before posting to any person appointed to inspect same.

I have covered everything in connection with this matter that I think would be of interest to you, but if there is any further information that you require, I will be only too pleased to give it, and I now leave the matter in your hands and am confident that you will deal fairly with it.

Colwell that the report be referred back to the Board of Control with the recommendation that the bill boards on Windsor Street on the Nova Scotia Car Works property be removed, that the E. L. Ruddy Co. be requested to give an undertaking to the City that all bill boards petitioned against will be removed, and that in future no bill boards will be erected until first sanctioned by the City Council. Motion passed, Alderman Kelly dissenting.

ADDRESS TO HIS WORSHIP MAYOR MARTIN.

By unanimous consent of Council Controller Harris reads to the Council and presents to His Worship the Mayor the following address signed by all the members of Council present at the meeting—

City Hall, Halifax, N. S., April 6th, 1916.

Peter F. Martin, Esq., Mayor of Halifax.

Your Worship:-With the closing of your first year as Chief Magistrate of this City, we, the members of the Board of Control and City Council, desire to tender you our best wishes and sincerest felicitations.

We are pleased to do this because:-

(1) Our relations during the term have been of the most pleasant nature. Your genial personality has won our warmest sympathies and your firmness and fairness our sincerest admiration. While on many occasions you have overlooked our shortcomings, we nevertheless realized that you were possessed of a determination to do only that which in your judgment you deemed the right thing to do, and that the citizens had in you one who would to the best of his ability strive to advance their every interest without fear, favor or bias. (2) Apart from the personal features of your regime, we desire to congratulate you on the marked success which has attended your efforts to promote the well-being of the City at large. As the Chief Magistrate of the City, you have ever been mindful of its diversified interests. All parts and all sections, all classes and all interests have ever found you ready to listen and if need be to act, to remedy injustice and to use your good offices with an impartial and liberal hand. (4) Questions of more than usual importance have been dealt with by the bodies over which you have had the honor to preside, yet all matters have been considered with a single eye to the general good and future prosperity of the people as a whole.

It is therefore our hope and our earnest desire that you will re-offer your valuable services to the City and we desire to say in all sincerity that we look forward with pleasure to having you preside over the destinies of the City for at least another term.

We have no idea of what your inclinations in this direction are, but we feel sure that the acceptance of another term of office would be a matter of profit and pleasure to the citizens who feel that your experience and ripe judgment will ever be at hand to guide and direct and ensure another year of harmonious and well directed civic government.

Trusting you will favorably consider above suggestion, and pledging ourselves to do all in our power to strengthen your hand, we have the honor to be.

DAYLIGHT SAVING.

His Worship the Mayor announced that before proceeding with the general business for which the meeting was called, the Council would be pleased to hear the views of citizens in attendance on the proposed scheme for daylight saving.

Read letter Secretary Board of Trade informing the Council of a resolution passed at a meeting of citizens held April 15th, at which the City Council, the Board of Control, the School Board, the Board of Trade, the Banks, Wholesale and Retail Merchants, the Commercial Club, the Rotary Club, and other organizations were represented, endorsing the proposal to put forward the clock one hour from the 30th day of April to the 30th day of September.

Also read endorsement of the scheme from the Retail Drug Merchants of Halifax and Dartmouth and from the members of the Nova Scotia Board of Fire Underwriters.

The Council is addressed in favor of the proposal by G. W. C. Hensley, President of the Board of Trade, Dougald Macgillivray, Manager Canadian Bank of Commerce, McC. Grant, Robert Rosborough and W. E. Schwartz.

Moved by Controller Halliday, seconded by Alderman H. S. Colwell that His Worship the Mayor, by advertisement in the newspapers, request that all citizens move their clocks forward one hour at midnight on the 30th day of April and so maintain them until the 30th day of September. PROVINCIAL EXHIBITION DEFICIT 1914.

Read report Board of Control recommending that legislation be procured authorizing the City to pay its share of the Exhibition deficit 1914, during which year no Exhibition was held.

In order that there may be no delay in the printing of such Bonds as may be required, it is recommended that the City Treasurer be authorized immediately upon the passing of the Bill to arrange for the necessary alteration in the steel dies.

FREE TRANSPORTATION OF OFFICIALS ON STREET CARS.

Gentlemen:—The Board of School Commissioners having requested that the City Council seek legislation whereby certain of its employees would secure free transportation on the street railway cars when on their official duties, the Board of Control beg to report that they have considered the matter from a general City standpoint. It appears that under their Charter the street railway Company is not permitted to offer privileges to one corporation not available to other corporations, and that the Board of Public Utilities takes this view. The Board therefore recommends that the City seek legislation directing that the Halifax Electric Tramway Co. shall provide free transportation for the following officials:—

Inspector of Public School Buildings, Inspector of Janitors, the School Nurse and the Truant Officer.

City Health Board.

Health Inspectors (3).

Works Department.

City Engineer, Assistant City Engineer, Assistant Engineers, Superintendent Water Department, Assistant Superintendent Water Department, City Hall Messenger, Meter Readers, Turn Keys and Assistant Building Inspector.
