Alderman Power not being present to move for the reconsideration of the question the matter is dropped.

HOUSING ACT

Read extracts from Minutes of meetings held May 12th and 16th, 1921 in re Housing Act covering Alderman Whitman's notice of reconsideration.

Mayor's Office, City Hall, May 16th, 1921.

To the Members of the City Council. Gentlemen:-

The Committee on Works has for several months past been engaged in collecting information on which the City Council might be able to come to a decision as to the proper course to be adopted by it in regard to the St.Margaret's Bay hydro-electric development. In addition to obtaining information from the Water PowerCommission, the committee has obtained reports from City Officials, has had conferences with representatives of the Board of Trade and also with some of the probable customers for power in the City.

It is generally within the knowledge of members of the Council that previous to November 1919 a corporation known as the Halifax Power Co. Ltd. was engaged in the development of hydro-electric power at the North East River, St.Margaret's Bay, and there does not appear to be any necessity of reviewing the operations of that Company.

Having received a notification from the Halifax Power Co. Ltd. of its inability to proceed further with the hydro-electric development at St. Margaret's Bay, the City Council on November 27th, 1919 passed a resolution favouring the acquisition by the Water Powers Commission of the St. Margaret's Bay power with a view to its development by that Commission and its introduction into the City of Halifax. The resolution went On to request that Commission"to proceed at the earliest possible moment, to take such measures as may be required in that behalf". The resolution above referred to was in due course transmitted to the Water Power Commission. That Commission has since acquired, by espropriation, certain of the rights and property of the Halifax Power Co.Ltd. necessary to the above mentioned development and has proceeded to erect the necessary buildings, dams, flumes, transmission lines, etc. and to instal the required hydraulic and generating equipment for a partial development and expects to have the undermentioned power named:-

With the July installation it is expected to deliver at the substation switchboard 6,400,000 k.w.h. per year and with the full development above mentioned 20,000,000 k.w.h. per year.

The Water Powers Commission proposes that the City shall enter into a thirty year's contract with it which contract shall on the expiration of such period continue from year to year until cancelled or be revised by mutual agreement.

The cost to the City is proposed to be based on the total cost of development and the cost of the property necessary for the development. What these capital costs are estimated to amount, to, the Committee has not been exactly informed. As they understand the matter the annual cost to the City must be such sum as would be sufficient to cover the interest on the capital cost, depreciation, a sinking fund to redeem the debenture issue at maturity and the costs of operation. In his letter of March 7th last, the Chairman of the Water Powers Commission states: "Whatever the power costs is what the City will have to pay. Our understanding is that the costs are matters of adjustment from year to These costs must be made and discussed in such vear. a way that the city will know from year to year the precise amount being charged for these various items. The actual cost will depend upon the administration under actual operation. All these costs as above stated are open to the inspection of the City".

On the basis of the complete installation above referred to, the Water Power Commission estimates that the total annual cost the City will be approximately \$200,000.00. Assuming as is anticipated that 20,000,000 k.w.h. of electric energy will be delivered at the Arm substation per year, the cost to the City at that point would be 1 cent per k.w.h.

To arrive at the rate the City would be able to sell the power for, it is necessary to have the following factors, among others, determined:-

(1) The transformer and distribution losses.

The probable demand for electric energy.

(2) The probable demand for electric energy.
(3) The amount of interest, depreciation, and sinking funds to cover the necessary debenture issued to provide the moneys for the erection or acquisition within the City of distribution lines and equipment. (4) The amount of the maintenance and other operating costs.

As to the first item, the losses referred to cannot In part they are similar and may be combe avoided. pared to the unavoidable losses which are to be met with in water mains or gas mains. They go on continuously while the circuits are alive. It is estimated that an allowance of at least available for 20% should be made to cover these losses. This would leave available for sale by the City to consumers 16,000,000 k.w.h. per year. If this amount could be all sold the price leaving out of consideration items (3) and (4) above, would be 1.35 cents.

As to the next item and on the assumption that the City decides to furnish electric energy itself to both users of light and power and perform its own public building and street lighting, it probably may be taken for granted that the existing demand supplied by the Nova Scotia Tramways & Power Co. Ltd less the portion covered by long term contracts and for its tramway service would be available to the City. As nearly as the Committee can calculate it, such demand works out about as follows:-

Probable available demand including street-lighting.

On the basis that the City must pay \$200,000.00 for the power, the cost to the consumer on the above basis of demand, leaving out of consideration items (3) and (4) above would be 2.43 cents per k.w.h.

In regard to the third item it has been impossible for the Committee to work out a detailed estimate of the capital cost to be incurred in the erection of the necessary distribution lines and equipment, or in the alternative the value of the expropriated rights to string lines on existing poles. The latter course however, does not seem to be feasible as existing poles, due to their length, cannot carry further wires with safety.

Taking as a guide however, the sworn estimates of value placed on the distribution lines, transformers, meters and equipment of the Nova Scotia Tramways & Power Co. Ltd. at a recent hearing before the Utilities Board, such cost would be approximately \$850,000.00.

The overhead charges on this amount, without sinking fund would be as follows:-

Interest (to net par) 6 1/4% Depreciation 4 1/4% \$53,125.00

<u>36,125.00</u> \$89,250.00

Worked out on the above mentioned demand, the rate to cover these overhead charges would be 1,084, cents per k.w.h.

To arrive at an estimate of the 4th item, maintenance, and other operating costs the Committee feels itself safe in taking last year's costs of the Nova Scotia Tramways & Power Co. Ltd. as sworn to in the report of its electrical department to the Public Utilities Board, first deducting therefrom such items of expense including taxes, as would not occur in the cast of the City distribution hydro-power. After making such deductions, these expenses amount to \$175,000.00. As the City's business, at the outset at least, would be somewhat smaller than that of the Company, your Committee felt it might reasonable make a reduction in the applicable costs and estimates that \$150,000.00 should be sufficient to cover operating expenses. On the basis of the above estimated demand for electric

energy, the rate to cover operating costs would be 1.822 cents per k.w.h.

To recapitulate -- In order to break even under the proposed contract, and with on sinking fund allowance, the average cost at which the City would be able to sell power to the consumer on the basis of the above estimated demand would be as follows:-

Cost of power at consumers' terminals 2,429 cents per kwh Overhead on distribution lines, meters 1,084 " " " Maintenance and operating expenses <u>1.822</u> " " " " Average cost for power and light purposes 5.335 " " "

It is to be pointed out that as the amount of electric energy sold increased, the cost of power at the consumers' terminals would be reduced.

For the information of the Council it may be pointed out that the average cost of all consumers of power and light purposes of the Tram Company last year at the consumers' terminals was 5.922 cents per k.w.h. with coal costing \$9.84 per ton.

As to the cost of power to the City, it is to be said that the figure of \$200,000.00 is the amount estimated by the Water Powers Commission required to cover the cost. If the actual operation of the plant shows the cost to be lower the City will get the benefit. If, on the other hand, they turn out to be higher, the City will have to pay the increase. While your committee obtained the above figures from the Commission, it has not been possible to obtain the actual capital expenditures made to date or the estimated expenses yet to be incurred. It, therefore, has been impossible to check the estimates furnished by the Commission. The costs which the City would be called upon to assume are set out in section 35 of the Water Powers Act which enacts as follows:-

A Municipality having a contract with the Commission for a supply of electrical power or energy shall pay the cost of the electrical power or energy so supplied or contracted to be supplied and such contract shall so provide. In adjusting and fixing such cost the Commission shall include:-

Interest at such rate per centum per annuam (a) as from time to time may be fixed by the Governorin-Council, or where no rate has been fixed, then at the rate of five per centum per annum, upon the money expended by the Commission on capital account in the cunstruction or purchase of the works and upon all such other expenditures as the Commission may make under the powers conferred upon the Commission under this Act and upon working capital. (b) an annual amount sufficient to provide a sinking fund for the repayment of loans made to and debentures issued by the Commission, and (c) line loss and the cost of operating, supervising, maintaining, repairing, renewing, and insuring the works, and such sum as the Governor-in-Council may direct to be paid to the Chairman and ither members of the Commission ad remuneration for their services, and such sum as the Governor-in-Council may direct to cover the difference between the five per cent interest charged on the money

so expended on capital account and all charged and expenses of providing such money, and such sum as the Governor-in-Council may direct to cover expenditures by the Commission for any of the purposes of this Act;

(d) The cost of electrical power purchased by the Commission from other persons, firms or corporations.

(e) any other items payable by the Commission chargeable to cost.

The Committee has considered the matter of what course should be adopted in case the costs to the City should be higher than the estimated amount of \$200,000.00 Two courses appear to be open--either add to the rate to be charged consumers an amount to provide a fund to cover any probable increase in costs or wait until the end of the year and then add to the rates of the following year. Such an amount as will provide for the deficit or assess the same in the general tax rate. ΤO assess would be objectionable because part of the deficit would be made up by persons not using the service To make up the deficit by increasing the rate the following year would also be objectionable because perhaps certain consumers might not have been customers the preceding year and therefore did not benefit by the lower rate of that year. Therefore it would seem that the first course of establishing a small reserve by payment every year would appear to be the most equitable plan to follow.

It may of couse turn out that the estimates of the Commission's engineers are not over sanguine and that the costs will not exceed the amount stated by the Committee feels that at the inception of this project with its uncertainties the City should place itself on the safe side.

It is not the intention of the Power Commission to act as the distributors of the power generated. Its policy is to sell to the municipality--in this/case the Oity--and to let/the City attend to the whole matter of distribution. Failing the making of a contract with the City, an attempt would no doubt be made to negot-

iate an agreement with the Nova Scotia Tramways & Power Co. Ltd. hereinafter called the Tram Co.

If the City should enter into a contract with the Commission it could ultimately, if thought desirable, and if legislation now being sought is obtained, enter upon the business of supplying electric energy for light and power purposes. That this cannot be done before power from the first installation is available is quite clear unless power to expropriate the existing distribution sustem, meters, and equipment of the Tram Co. is obtained at once and acted upon promptly. In the event of such a course being followed no doubt the city would be calledupon to pay not only the value established for a compulsory taking of the distribution system but also the heavy consequential damage due to the practical closing down of the tram /Company's plant, This plan would seem therefore wholly untenable.

The Committee has considered the matter of acquiring rights by expropriation to use the poles of the Tram Company but has found that except in small sections in the outlying parts of the City the necessary pole space is not available.

This leaves only the alternative of erecting practically a duplicate transmission system with the difference probably that the City would be required to erect poles of a greater height so as not to interfere with the wires of the Tram Company. This, of course, even if desirable, cannot be accomplished before the proposed power will be available.

Apart from the physical impossibility of erecting a new transmission system in time or the heavy compensation which would in all probability have to be paid if the transmission system of the Tram Company should be expropriated the high cost of obtaining the necessary money must also be considered.

In the next place the City might take over the power and reserving enough to light its streets and public buildings and supply certain power users, sell the balance to the Tram Company.

As to this proposal, the City Electrician was asked to work out a plan and to furnish an approximate estimate of cost. His report provides for distribution lines from the Arm substation to a point near, the Ocean Treminals and to a point near the foot of Rector Street with substations at which these two points with necessary transformers. The estimated cost was \$107,700.00 and the annual maintenance, etc. \$15,797.00. The electrician also prepared an estimate of a street lighting system which amounted to \$121,474.00 the annual maintenance and overhead charges of which he placed at \$49,881.76.

He was unable from the information available either as to the location of the power users to be served or the wire space available on the Tram Company's poles to prepare any satisfactory estimate as to the cost of erecting lines to supply power users. On the whole it would at least appear doubtful whether the cost entailed in providing the equipment necessary to supply electric energy for power users alone would result in any material lowering of power rates. Moreover it would appear to be questionable whether the City should furnish electric energy for some users of power and not for all who desired it. As to the street lighting the Committss is satisfied that the existing poles of the Tram Company will afford the necessary space byt it is not quite clear as to whether the cost of maintenance would be as low if operated by the City as it would be under private operation. This can obly be ascertained by inviting the Tram Co. to submit a tender. Before making a contrace with the Power Commission under this scheme, it would be necessary to see if the Tram Co. would enter into a contract for the surplus power and on what terms, allowing the City to light its streets and City buildings. The next alternative seems to be for the City to enter into a contract with the Power Commission for the power and to hand it over to the Tramways Company for distribution. In this case it would of course first be necessary to see if a satisfactory contract would be made with the Tram Co. before the City entered into a contract

with the Power Commission.

The only justification for this plan would be if the City could thereby make sure that no more than a reasonable rate would be charged consumers by the Company. If it could be arranged, the City should be in a position say at the end of five years or some other term, to cancel the contract and take up the supplying or electric energy for light and power ifself if dissatisfied with the rates or service of the Tram Co. Whether a contract satisfactory to the City would be made with the Tram Co. the Committee on Works does not know as it is not authorized to enter into negotiations with the company with a view to learning what could be done in that direction.

The only remaining course open to the City is to decline to enter into any contract with the Power Commission, allowing that body to make the best arrangement it can for the sale and distribution of its powers. As to this line of action, it is to be said that the Power Commission have always claimed that the St. Margaret's Bay development was entered upon by it in good faith at the unanimous request of the City Council after the Halifax Power Co. Ltd. had notified the City of its inability to proceed.

The Committee on Works has endeavoured to get all the information available and to lay the facts as fairly as possible before the City Council untrammelled by any recommendation and free to use its beat judgment on this important matter.

The correspondence which has passed between the City and the Power Commission, the Board of Trade and the Halifax Shipyards as well as the various reports of the City Electrician are attached hereto.

for the Maritime Delegation to meet and confer with the Federal Cabinet on the morning of Wednesday June 1st, at Ottawa, regarding transportation matters affecting the Maritime Provinces.

Items in the press indicate that an Order-in-Council is to be passed at an early date, bringing all of the Canadian National Railways (including the Intercolonial) under the jurisdiction of the Board of Railway Commiss-Inasmuch as this Board has no authority to ioners. consider any of the political phases of the transportation question, it seems most desirable to ask the Government to appoint a Special Commission to enquire into the underlying principles and conditions surrounding the original construction and operation of the Intercolonial Railway, and report, before the Board of Railway Commissioners is given jurisdiction over the rates. We should insist that the Governmental policy, so far as the management, rates and operation of the Intercolonial Railway are concerned, should be stated before this Railway is included in the pool of the many roads which are to make up the consolidated Canadian National Railway System.

A caucus of the Maritime Delegates is to be held during the afternoon of May 31st, to arrange the details for the presentation of the case, to the Federal Cabinet, on the following morning. This preliminary meeting is of the utmost importance and we trust that your representatives will arrive in Ottawa notlater than noon of May 31st. I do not know where this caucus will be held, but your delegates can find this out by enquiring either from the Honorable Mr. Finn or me at the Chateau Laurier, after they arrive at the capitol.

I cannot urge too strongly the importance of having a large and representative delegation go to Ottawa, and would appreciate having you advise me by return mail if we may expect the co-operation of your Board in this request.

(Extract Evening Echo May 20th,1921) CONFERENCE ON FREIGHT RATES Premier Meighen notifies Hon. R.E. Finn that Maritime Delegation will be Received on June 1st.

Hon. R.E. Finn member of the Provincial Government was last night in receipt of a telegram from the Right Hon. Arthur Meighen, Premier of Canada, that a delegation from the Maritime Provinces would be received by the Cabinet on Wednesday June 1st, at 11.45 a.m. to hear their representatives regarding freight rates on the "Intercolonial Railway".

This conference with the Federal Government will be the consumation of a number of conferences of Maritime Government Representatives, and of the commercial and industrial life of the three provinces which have been held from time to time during the last year, to

discuss the seriouw state of affairs which was being brought about by the freight rates on that part of the Canadian National Railway which was formerly known as "The Intercolonial." The delegation which will go to Ottawa is expected to be the largest, most representative and most influential that has ever visited the Capital from these provinces. This conference with the Government is looked upon as the last effort that will be made with this Government.

It is the outcome directly of unsatisfactory efforts to have the matter of freight rates over "The Intercolonial" considered before the Railway Commission. That particular road is not under the direct jurisdiction of the commission, but the commission would however have considered the matter of freight rates, though only on a scientific basis of readjustment, and not on the political considerations brought about by confederation and of geographical position.

The last time that a delegation appeared before the Railway Commission they were practically told to "go to the Government and take it out of them". This is precisely what is now to happen. The delegation will consist of members of three Governments, representatives from Boards of Trade, Civic Governments, United Farmers Associations, commercial organizations Canadian Manufacturers Association, and numerous other bodies that are interested in this most vital question to the future progress and development of the Maritimes. The matters to be taken up will be the Intercolonial freight rates, restoration of the arbitraries and commodity rates on that road prior to 1916. What makes this of utmost importance is that in view of the Government seriously considering placing the "Intercolonial" under the Railway Comme ission, which Maritime leaders contend is not in accordance with the terms of Confederation, it may be, if the Government is not forced to take action, the last time which such a delegation may have of interviewing the Government on this issue under the present status.

MARITIME CITIZENS TO DEMAND MANAGEMENT OF RAILWAY LINES

Delegation to Leave for Ottawa at end of week to meet Meighen Cabinet in reference to running the Maritime Branch of Railway-Commission is asked to deal with inquiry from a Commercial and Constitutional standpoint-Claim Maritimes are placed at disadvantage.

What will probably be the largest, most influential and most representative delegation of citizens even to go from the Maritime Provinces to Ottawa will leave at the end of next week, so as to be in the Dominion capital in time to mee t the Meighen cabinet

cabinet in reference to the control, management and rates of the Intercolonial Railway now known as part of the Canadian National system, on June 1.

The provincial governments, municipalities, boards of trade, farmers' organizations and other bodies of the Maritimes are demanding that a commission be appointed to inquire into the whole question of the Intercolonial Railway, both from a constitutional and commercial standpoint. When these provinces entered into Dominion confederation one of the terms was that certain standards of fixing railway freight rates on the I.C.R. be adhered to, so as to give these provinces an opportunity to complete in markets which their geopraphical position and the fact that they were shut off from the rest of Canada by the state of Maine might have prevented them from doing advantageously.

These rates called arbitraries, were put into effect and remained in effect until 1918, when the Dominion Railway Commission fixed rates in this part of Canada on the same basis as in other parts, to the great disadyantage of the Maritime Provinces. One of the foremost advocated in the plans to force a restoration of the arbitraries has been Hon. R.E. Finn, minister with portfolio in the Nova Scotia Government, who represented this government in the recent rates hearing at Ottawa. Last night Mr. Finn, in reply to telegrams and letters sent to Ottawa received a wire from Hon. Arthur Meighen setting 11.45 a.m. of Wednesday, June 1, as the time when the delegation from the Maritime Provinces will be heard by the cabinet.

Seen last night, Mr. Finn said that this was a most opportune time for the trip, and he hoped there would be a good representation from all parts of the three provinces affected, as he understands the Government is about to determine whether or not by order-in-Council to place the I, Ø.R. under the control of the Railway Commission. For purposes of fixing rates it really has been under that body's jurisdiction for some time, as Hon. J.D. Reid, minister of railways in the Dominion Government, wrote to the Railway Commission, asking it to so regard it for that purpose. It is', however, admitted that the I.C.R. is not under the control of the commission, but in fixing rates it has declined to take any so called political or geographical conditions into consideration and has fixed the rates here on what is called a scientific hasis, as the other parts of Canada. The commission thru its chairman, Hon. F.B. Cavell in fact, told Mr. Finn at the hearing last December to go to the Government for the relief he seeks; that is, to have the promise made when these provinces entered confederation carried out and the arbitraries and commodity rates in effect prior to 1916 restored.

Of the number admitted 8 were chargeable to the Province and 15 to the City. The total number of inmates on May 31st was 302 made up of 168 men and 126 women and 7 children. On the same date last year there were 136 men, 129 women and 7 children a total of 272.

The Superintendent's report shows that on May 1st, 1921 there were 24 patients admitted to the Tubercular Hospital in Dartmouth, made up of 6 mGn, 16 women and 2 children. During the month 4 patients were admitted, 2 men and 2 women, making a total of 28. During the month 2 women were discharged, and 2 women and 1 man died, leaving the Hospital on May 31st, 7 men. 14 women and 2 children a total of 23.

His Worship the Mayor, and Works Committee. Gentlemen:-Acting under instructions from your Committee, I duly advertised for insurance on the several city properties, as per schedule, totalling \$197,900.00, for

a term of one year from May 31st, 1921, and in a separate letter furnished each firm tendering (a copy of which is attached hereto) stated that as per resolution passed by the Committee May 18th the successful bidder must be prepared to accept the whole risk. In accordance with said advertisement and letter the following firms submitted bids viz:-

Saunders & Duffus G.E. Fraser & Co. Eastern Trust Co. N.S. Realty & Investment Co. Acadia Fire Insurance Co. Rainnie & Keator, Ltd. Geo. J. Lynch A.E. Curren & Co. Ltd. W.R. MacInnes & Co. Major Bros. A.M. Jack & Son Alfred J. Bell & Co. Royal Insurance Co. Ltd. Wm. Currie Dale & Co. Ltd. Thompson Adams & Co. Ltd. Grant Oxley & Co.

also the North Western Mutual Fire Association.

All of the above firms, with the exception of the last named, are members of the Nova Scotia Board of Fire Underwriters, and are, I am credibly informed, bound by all the rules and regulations of said Board while they remain members thereof.

The last named firm, as its name would indicate, is a mutual company whose business is being promoted by the Retail Merchants' Association of Canada with Mr. J. Cuthbertson Doyle as chief agent for Nova Scotia. All the so-called tariff firms submitted bids each of \$2,655.82 for the total amount of \$197,900.00 an average rate of \$1,342 per cent.

The North-Western Mutual Fire Association through its agent offers to undertake the insurance for the total amount of \$2,135.95, and claim that they will at the end of the year be able to rebate on that amount at least \$640.78.

As the Council was not to meet until the 9th inst., which would be the earliest date the matter could be finally disposed of, I have delayed as long as possible before making a report in order to obtain all information in regard to this mutual company. The Company has not been doing business long in Canada, and only recently in the maritime provinces, and outside of those directly interested it is difficult to secure and I have not been able to obtain from independent sources information of such a character that would warrant my making a recommendation that the City should at this time place all its insurance with said company. Possibly later on, when the Company has had an opportunity to demonstrate in this section of Canada its ability to make good, the City might be glad to avail themselves of its good offices to help secure insurance at a cheaper rate than at present enjoyed. A couple of the tariff firms referred to have submitted alternative bids not called for by advertisement or otherwise in which they offer to insure a number of items in the schedule for three years on payment of two years' premium, which, provided no loss occurred during the life of the policy, would save the City approximately four hundred dollars over the period referred to. As before stated, any other firm tendering is in a position to offer similar terms, and unless new tenders

are called for and all those who submitted bids are given an opportunity to quote, I am strongly of opinion that the Board of Underwriters may interfere and cause confusion that to say the least will not help the City financially. My reason for stating this is because the said Board at a meeting held May 31st, made a ruling that several items included in the alternative proposals cannot be insured other than on a yearly premium.

Under these circumstances I can only recommend that the City take its insurance for a term of one year. All quotations being alike, and in view of the fact that the firm of Rainnie & Keator Ltd., in the four years that they have carried the City's insurance, have been called upon to make four adjustments of losses, all of which I am advised by the Assistant Building Inspector were very satisfactorily arranged without recourse to a third party, and considering they have not had an opportunity to recupe their respective companies for losses made under said policies, and without some compensating advantage nothing is to be gained by change, I would recommend that the insurance be awarded them for one year ending May 31st, 1922.

After the ruling made by the N.S. Board of Fire Underwriters May 31st. Alderman of the City of Halifax, N.S. Gentlemen:-

We, the undersigned, people of the Great Explosion of December sixth, 1917, beg to call your attention to the following:

(1) We ask for more police protection by night on account of the disgraceful conditions we are living under in the Halifax Relief Commission's Relief Houses on the Exhibition Grounds.

(2) The Halifax Relief Commission has allowed and we have reason to believe are the investigation of having windows taken out of the Relief Buildings where we are trying to live, or perhaps a better word would be where we are dying.

(3) And we believe the Halifax Relief

Commission are therefore endangering the lives of men, women and children by fire and sickness by having windows taken out and tearing down the Relief Buildings, in which people are still living.

(4) The Halifax Relief Commission has given notice to the Explosion sufferers to vacate the premises they occupy on the Exhibition Grounds regardless of the people who are still homeless regarding a permanent home.

(5) We ask you to take this matter up with the Halifax Relief Commission or the Dominion Government, if need be, and have us placed in permanent houses with rent within our means.

(6) We ask you as citizens of our dear old Halifax are you going to sit idle and allow this disgraceful condition to continue from bad to worse. (7) We ask your Honorable Office to see

that we, the people of this City, if we are forced to quit these temporary dwellings, are put into permanent homes at a rent which we can afford to pay,

as we feel we have suffered enough through the Explosion, and we pray that we will not be forced again on the street as on that terrible day of December sixth.

(8) We would be pleased to have the press of Halifax publish this letter and ask other papers all over the world to please copy.

(9) We ask you to come to the Exhibition Grounds and go from house to house and investigate the treatment we have received from the Halifax Relief Commission. Hoping to see a full investigation started in this matter we are, gentlemen,

His Worship the Mayor, Sir:-

In compliance with instructions of the City Council I beg to report on the condition of the water supply system with recommendations for improvement. While I could have reported on the system generally without delay, some features of the work in this department involved in-quiries from which I have not even yet obtained complete information.

<u>Condition of System</u>. The water supply system has never been in a satisfactory condition during my whole experience with it, and the reports of my predecessor show that for many years his experience was the same. The troubles from the first were caused by the enormous total waste in buildings, chiefly in consequence of defective plumbing.

The officials of the department have worked hard ' for the last forty years to overcome these troubles and they are beginning now to see daylight. The difficulty in our problem has been increased by those who, apparently for supposed temporary personal advantage have sent broadcast reports which they must have known to be incorrect. While your officials have never claimed that the system was in a satisfactory condition yet such service as was given at Wood Bros. Fire, for instance cannot be duplicated by many cities in Canada, and can be surpassed by only one or two. Leaks in mains have been given in the reports referred to as the cause of exhaustion of the supply yet it has been definitely proven over and over again that that was not the cause. Many miles of mains have been renewed in the last twenty or twenty-five years, yet no leakage of any consequence has been discovered on the mains. There is no City water supply in which there is no leakage, but in Halifax it is practically impossible for a leak of any consequence to exist without showing at the surfact or in cellars. Further a leak of any consequence shows at once by a local drop in pressure and our Superintendent gets after it without delay.

Pitometer Inspection In 1917 a Pitometer Inspection of the low service district was made. The experts making the inspection reported that over 1,000,000 gallons of leakage was stopped by their work. A study of their report, however, shows that their total of over 1,000,000 gallons includes the legitimate consumption in the districts in which leakage was found and also waste in buildings in those districts. In one case along a leakage of 70,000 gallons a day was found in a water closet. It is probable that 1/3 to 1/2 of the quantity named should be charged to legitimate use and waste in houses. That means an underground leakage of only from 5% to 7% of the total consumption, a most extraordinarily favorable showing. Further the experts were unable to find a single leak in street mains or in street service pipes, which should be a most cogent answer to the untrue reports The unreliability of such reports was circulated. never more striking than in the case recently before the Council, when it was charged that there was at the time a leak of 500,000 gallons a day, and thorough investigation has failed to locate any such leak up to the present.

The pirometer experts make another statement which I think has not been quoted, viz: "Our investigations show a very bad condition of plumbing fixtures in the houses of the low pressure service and it is our opinion that extensive waste will continue until each service pipe is metered".

The installation of a meter on every service Meters. pipe is practically completed, with already very satisfactory results. The total consumption of January 2nd, 1930, well into the winter but before any great headway had been made with the meter installation was 10,371,000 gallons. On January 29th the effect of the meters was already apparent, the consumption that day being 9,488,000 gallons. The improvement has continued through the cold weather and on March 18th the consumption was 8,900,000 gallons a day although it was the season when the maximum rate of consumption would be expected. As the effect of the new meters is appreciated by the house-holders further improvement and reduction in the consumption will be made and even to-day, although the population of the City had doubled in the last thirty years and the number of service pipes has been multiplied by three, the water supply system generally is in a more satisfactory condition than it has been at any time previously in the whole thirty years.

Reservoir The objection of the reservoir has been wilfully misunderstood and minrepresented. It has been claimed that the reservoir was recommended to increase the supply. What was recommended was, that it would store the surplus water when there was more flowing in through the pipes than was being consumed so that when these conditions were reversed, viz: when there was more water being consumed than the pipes could being in, the reservoir could be used to equalize the service; This is exactly what happens in the summer, but in the coldest weather in winter

the waste has been so great in the past that there was no surplus flow in the pipes and to meet this condition a pumping plans is to be installed. By means of the pump the extra draft on the reservoir in coldest days can be replaced by pumping so that there will always be a supply in case of fire. The fact is, however, that in consequence of the notable improvement in the condition of the system the reservoir was not empty once during the past winter, something that has not happened before since it was constructed.

<u>Present Practice.</u> It has been our practice to adopt all suggestions made by the BOard of Fire Underwriters for improvements in the warer system whenever they were considered reasonable and proper. I think, however, that we should not worry too much over their requirements as I fear that they intend to keep ahead of us by fixing new standards as we come up to the old ones. An attempt has been made to lead the public to believe that the water department officials allow leakage to go on until attention is called to it by some person outside the department.

The practice established in the Water Deparment is to make a thorough examination of every valve and hydrant before the winter and after the winter. The after winter examination is being made now. During the winter all important valves are kept clear of snow and ice and ready to the fir for instant operation every day and the same remarks apply to the fire hydr-This inspection is more effective, in my opinants. ion, that a pitometer test yet it is the intention of the department to make a pitometer test at least once a year. An effort was made to prove that there must be unknown leaks which must account for unmetared water used, but in the statements made public, no account was taken of the consumption in the Relief Commission Temperary Houses where water was running twenty-four hours a day at times in spite of close inspection, for the water used for fire purposes, street sprinkling, City buildings, fountains, garden's pond, egg pond, making skøating rinks and flushing mains, sewers, drains, hydrants, dead ends, etc., miles of paving with contrete base 6" thick, concrete curb, sidewalks, catchpies and other City Works, telephone conduits, construction of new buildings reduction in water accounts and various other uses. Chlorination The method of Chlorination of the water supply is a question which has not been definitely settled. We are still using the system originally established. A communication was received by the Board of Health recommending the use of chlorine gas but inquiries in other cities confirm an earlier report that the use of chlorine gas is not satisfactory. A letter has been received from Prof. Starkey (who at one time made a thorough investigation of our system) in which he pronounces the use of chlorine gas to be unsatisfactory. Apparently the use of chlorine must be confined to two alternatives, one the system at present is suffering by allowing this matter to stand over until it is thoroughly threshed out.

Water Shed I have been trying to get prices on properties on the water shed which are a menace to the purity of the warer supply but up to the present date have been able to get only two or three.

I have come to the conclusion that our efforts in this direction will not meet with success. In my opinion it is most important that we obtain all those properties which are near a water course and which is active during and immediately after rain storms and that we should obtain the more remote properties when they can be obtained at a reasonable price. Respecting the properties on the North side of the Margaret's Bay Road and the Umlah Property at the head of Spruce Hill Lake, I think there should be no delay in acquiring them. A further report will be made on those properties on which prices have been obtained.

Fire Boat The providing of a fire boat is a matter with which I have had no close connection and I am unable to make any definite report. I have no doubt that at some time in the future it may be a part of the equipment of the fire department and I think when it is installed it is most important that it should be operated under the Chief of the Fire Department, preferably with a crew who are members of his department. It would be a desirable addition to the fire fighting equipment of the City but as it would work with salt water has no connection with the fresh water supply problem.

The use of salt water by the establishment Salt Water of pumps or by the use of fire boats might be made to contribute materially to the efficiency of our fire fighting organization. I do not think the City would be justified in establishing a salt water system until weakness of the fresh water makes it absolutely necess-Introducing salf water Hysten makes it akasiateary. xx into fresk water system is out of the question not only in consequence of the nuisance it would be to water consumers but in consequence of the general damage it would do to the metal of the pipes and valves, and for the reason stated, I do not think the establishment of a second system is justifiable at present. If the recommendation at the end of this report is carried out I do not believe that it would be necessary even to install salt water tanks on Water Street as I believe there will be sufficiency of water in the fresk water supply system to meet the demand. This addition to fire fighting service, can however, be obtained whenever it becomes apparent that it is absolutely necessary. Distribution Changes. I have been of the opinion for a long time that there is urgent need of changes in the distribution system to meet the changed condition due to the erection of higher buildings and expecially to the transfer of the Railway Terminals from the North end of the City to the South end, but the waste of water was such a heavy drain on the source of supply that it was absolutely certain that an additional large main would drain the lakes in a dry year. Installation

of meters has made such an improvement already and promises to make such a reduction in the consumption that a much larger quantity of water will be available for fire purposes than before. The Engineer of the Board of Fire Underwriters recommended bringing in a new main from Chain Lakes through the South end to the South end of Water Street. I am of opinion that a similar benefit can be obtained by another method and at a much lower expenditure. While it is possible that it may be found advisable in the future to bring in an additional main to the South end that expenditure may be left until it becomes absolutely necessary. Mr. Johnston and I have made an exhaustive study of the system and I beg to make the following recommendations.

1. That the properties on the North side of Margaret's Bay Road West of Chain Lakes and the portion of the Umlah property on the Water Shed at the head of Spruce Hill be expropriated without delay.

2. That the old pipes running from St. Andrew's Cross through Cogswell Street to Brunswick Street be taken up or abandoned and the 24" low service main extended to Barrington St. via Cogswell, Brunswick and Jacob Streets.

3. That a 20" main be laid in Jacob Street from Barrington Street to Water and continued along Water Street to Hollis Street.

4. That later a 15" main be laid on Water Street from Hollis Street to Morris Street.

5. That a 12" main be laid on Barrington Street from Blower Street to Jacob Street and eventually extended to Cornwallis Street.

6. That a 12" pipe on South Park Street between South and Inglis Streets be replaced by a 15" pipe.

7. That the 15" high service encircling main be connected at Payzant and Preston Streets.

8. That the 6" main on South Street between Park Street and Tower Road be replaced by 12".

9. That a connection be made between the 24" and the 27" main at or near Dutch Village Road.

The effect of extending the 24" pipe and laying the 20" pipe will be to make a much greater volume of water available at the centre of the mercantile district, and help to decrease the drop in pressure as additional streams are put on a fire. <u>Ordinance</u> No

Early Closing of Shops Mens¹ Hats, Furnishings and Clothing.

WHEREAS under the provisions of Chapter 43 of the Laws of the Province of Nova Scotia for the year 1902 and the Acts in amendment thereof including Chapter 88 of the Acts of the Province of the year 1920 entitled "The Halifax Early Closing Act" the Council shall pass such ordinance as may be by said petition appealed for.

AND WHEREAS a petition has been presented to this Council from certain persons engaged in the retail trade in Mens' Hats, Furnishings and Clothing that Wednesday Afternoon for a period during each summer season be observed as a half holiday in their several businesses.

AND WHEREAS under the provisions of said enactments the City Assessor has reported in writing that the signers of the petition constitute seventy-five per cent of those engaged in the retail trade of Mens' Hats, Furnishings and Clothing.

THEREFORE BE IT ORDAINED by the Mayor and Aldermen of the City of Halifax in Council assembled as follows:-

1. In each and every year from the second Wednesday in the month of May until the third Wednesday in the month of September both inclusive, every shop engaged in the retail trade of Mens' Hats, Furnishings and Clothing shall be closed on each Wednesday at one of the clock in the olock in the afternoon Atlantic Standard Time (or if Daylight Saving Time (so called) is in use then at one of the clock in the afternoon Daylight Saving Time) and shall be kept closed until five of the clock on the morning of the following day.

2. This ordinance shall not apply to the Wednesday of any week on which occurs any Public Holiday in force by any statute or proclamation.

3. This Ordinance shall take effect on the 29th day of June 1921.

WHEREAS under the provisions of Chapter 43 of the Laws of the Province of Nova Scotia for the year 1902 and the Acts in amendment thereof including Chapter 88 of the Acts of the Province of the year 1902 entitled "The Halifax Early Closing Act" the Council shall pass such Ordinance as may be by said petition appealed for

AND WHEREAS a petition has been presented to this Council from certain persons engaged in the Barbering business and operating Barber Shops that on every Wednesday afternoon from 12.30 o'clock (except within any week during which a Holiday occurs) all Barber Shops be closed until 8 o'clock on the following morning.

AND FURTHER that on all other days excepting Saturdays the hours shall not exceed the period from 8 o'clock in the morning until 8 o'clock in the evening.

AND WHEREAS under the provisions of said enactments the City Assessor has reported in writing that the signers of the petition constitute seventy-five percent of those engaged in the business of Barber Shops.

THEREFORE BE IT ORDAINED by the Mayor and Aldermen of the City of Halifax in Council assembled as follows:-

On every Wednesday during the months of May, 1. June, July, August and September in every year, every Barber Shop shall be closed at 12.30 o'clock in the afternoon and remain closed until the following morning at 6 o'clock. (a) This section shall not apply in the week during which occurs a Holiday in force under any statute or proclamation. 2. On other days excepting Saturdays no Barber Shop shall be opened before 6 of clock in the morning and every Barber Shop shall be closed at 8 o'clock in the evening and remain closed until 6 o'clock the following morning. In this Ordinance the word "time" means 3. Atlantic Standard Time except that during any period in any year in which during the said months Daylight Saving Time is either the accepted or the official time observed in the City then the word "Time" means Daylight Saving Time. This Ordinance shall take effect on the 29th day of June, 1921.

The Council resumes consideration of the matter of Hydro Electric Power.

The following correspondence and documents are ready

City Electrician's Office, Halifax, N.S. December 7,1921.

His Worship the Mayor,

Dear Sir:-

I beg to submit the following estimates regarding the distribution of Hydro-Electric Power in the City. I have obtained estimates of power requirements from 52 prospective and actual consumers, the aggregate of which is 6802,000 K.W. hours per year. Of this amount 3,317,000 K.W.H. is from users who have estimates their consumption, and in order to make the figures conservative I would deduct 1,000,000 K.W.H. This would leave a total consumption including Shipyards and City Service of 5,802,000 K.W.H., of which 2,366,762 K.W.H. is under contract with Tram Co.

From the total estimated output by the Hydro Commission of 20,000,000 K.W.H, I would deduct for transformation, load factor and other losses 25% leaving the net amount for disposal of 15,000,000 K.W.H. I estimate the cost of equipment to take care of the available supply exclusive of street lighting equipment to be \$315,000.00.

On a masis of 25% less the cost net per K.W.H. would be 1.34ϕ per K.W.H.

The maintenance charges including interest and depreciation will amount to approximately \$67,000.00; this would add to the initial rate .44¢ or a total of 1.78¢ per K.W.H. assuming the whole 15,000,000 K.W.H. would be disposed of.

On the basis of the estimated sale of 5,802,000 K.W.H. the cost would be about 4.1¢ per K.W.H.

I have been instructed by His Worship the Mayor to reply to your letter of February 28th in reference to hydro-electric power.

The City Works Committee have been making a strenuous effort to make progress in this matter for wome months. As the matter stands, the City cannot legally make an agreement or contract for the disposal of the power, and an amendment to existing legislation has been prepared which, if passed, would authorize the City to dispose of the power if they took it from the Nova Scotia Power Commission. The Premier has been asked if the Government will use its good offices to ensure the passing of such legislation, but up to date no assurance has been given the City that it will be placed in a position to dispose of the power if an agreement is made with the Power Commission. The City has also found great difficulty in getting definite written information to enable us to determine whether we can complete a good business proposition with the Power Commission. Just as soon as these matters are cleaned up, the Works Committee will submit the matter to the City Council, but the delay at present is not being caused by the City, and the members of the City Works Committee, including the Mayor, are quite as anxious as anybody else in the City, to have the matter settled.

Nova Scotia Power Commission, Halifax, N.S. June 15th, 1921.

Dear Ma. Mayor:-

In response to your enquiry of June 14th,

I can only reaffirm the information previously given, that if the City of Halifax decides to take power from the St. Margaret's Bay development of the Nova Scotia Power Commission, this power will be supplied to the municipality at cost.

It can now be stated confidently, that the total annual cost of the total output of the present development at St. Margaret's Bay, will be about two hundred thousand dollars (\$200,000.00) per year, including interest, sinking fund, operating and all other charges.

Might I point out that the proposal to furnish power to the municipality at cost is based on the same principle as that how in effect in this Province by virtue of the Public Utilities Act. Under this Act, rates for service by telephone or electric companies cannot be guaranteed, but are subject to modification from time to time based on the cost of service as determined by the Public Utilities Commission. The Power Commission Act outlines definitely the various items entering into the cost of power delivered to a municipality by the Commission.

It may further be noted that the cost of power from a hydro-electric plant, as is under consideration, is constant once the development is completed, whereas the cost of power from steam generating stations varies largely with the cost of fuel, transportation and labor.

For your own information I am enclosing copy of a recent personal letter and copy of a statement submitted to the Halifax Board of Trade some time ago. You may use the figures quoted in these statments as you see fit.

R.W. Hendry, Esq., C/o Hendry Limited, Shipping Merchants, Halifax, N.S. Dear Mr. Hendry: In the last issue of the Commercial Glub Bulletin, I notice an interesting account of a recent meeting of the Board of Trade at which power matters were discussed. There is however, one item in this account which I think might possible have a little explanation. The item to which I refer is as follows: "Mr. Smith's remarks tended to show that the cost of the power might be little higher than we originally expected. " The expectations in regard to this development are expressed very clearly, I think, in the following quotation from a discussion before the Brogressive Club February #3rd, 1920-"As careful estimates of cost as it is now possible to make have been made but as already noted, it is very difficult to guarantee prices under conditions as they exist today. Halifax must have more power as

soon as possible, and the cost of generating power from any other source than water power will vary much the same as the cost from water power pending construction. We can therefore pay with confidence that energy can be supplied in Halifax from water power at one-half the cost of generating it from any other source at least" or again in the following auotations from a letter to the Secretary of the Board of Trade, September 25th, 1920 - "It is estimated that this cost will be about The cost to the individual conl¢ per kilowatt-hour. sumer would be more than this to include the cost of distribution within the City limits. The rates to consumers would depend to a certain extent on the policy of the distributing organization in regard to the rates for different classes of service, such as domestic lighting, commercial lighting and power, Halifax today, the cost of power ready for distribution on the basis mentioned above, would be equivalent to about \$25.00 per commercial horse-power per year".

The statement given to the Board of Trade at the meeting in question was as follows - "With the total capacity of this development utilized, that is, about 21,500,000 k.w.-hrs. or 9,400 h.p., the unit cost would be about 0.9¢ per k.w.hr. or \$21.30 per h.p. per year. I have not the exact figures as to the consumption of electrical energy in Halifax for the year 1920, but understand that it was approximately 17,000,000 k.w.-hrs. or 7,600 h.p. On this basis, the cost of power from the Margaret's Bay development would be 1.2¢ per k.w.hr or \$26.30 per h.p. per year".

When it is further realized that the total cost of generating electrical energy from steam in Halifax is in the vicinity of 3 cents per k.w.-hr., I think it is apparent that in so far as the statement in question is concerned, expectations are being realized. In addition, comparative figures were given at the Board of Trade meeting which indicate that the prices quoted for the St. Margaret's Bay development mean really cheap power.

It may be stated, however, that the general construction is well advanced and that if the promises of the machinery manufacturers are fulfilled, the St. Margaret's Bay development should be in a position to begin supplying power to the City of Halifax in July or August of this year. It has never been difficult at any time to maintain schedules in so far as the general construction is concerned, that is, the erection of dams, pipe lines and buildings. So far as machinery goes, however, we are in the hands of the manufacturers and they have not to date fulfilled all their expectations as expressed to us. The hydraulic units, however are now actually in place and the first electrical unit is completed at the shops in peterboro and will be shipped very shortly if this has not already been done.

Certain slides which I have to show you later will indicate to some extent the progress of the work, although much has been done since these slides were prepared.

Capital Expenditure

It was hoped by this time that hearings before the Governor-in-Council in connection with the expropriation of property for the St. Margaret's Bay development would have been completed. While considerable progress has been made in this matter, some claims remain to be considered, delays having been requested by the parties interested. While at the moment, therefore, the construction costs are fairly well known, it will be understood that property claims now under judical consideration cannot be discussed in detail at this time. However, with the information at our disposal, it is not thought that the figures used herein will be materially altered by any dicision which may finally be rendered in connection with these claims. It might be pointed out that the operating charges remain the same in any case and that land or rights which are largely the subject of the claims in question are not subject to depreciation. Considerable variation may, therefore, take place in the payments for property without materially affecting the unit cost of power from the St. Margaret's Bay development.

From the best information at our disposal, therefore, it would appear that the capital cost of the St. Margaret's Bay development excluding transmission lines and the Halifax Receiving Station, will initially be about \$134.00 per horse power of turbine capacity. When the development is fully completed, it is anticipated that this cost will be reduced to about \$120.00 per horse power of turbine capacity since much of the present construction will be available for future extensions. I quote figures on the above basis as a metter of convenience in comparing the St. Margaret's Bay development with other developments in which we have information on the same basis. In pre-war days, it was generally considered that if a power development could be made at a cost of \$100.00 per h.p. excluding transmission lines, such a development would be very economical, while costs frequently ran to \$200.00 per h.p. and over. For example, the average cost per horse power of a number of large plants in Ruebec built before the war and based on statistical data obtained in 1917,

was \$110.00 per h.p. one plant going as high as \$144.00 per h.p. In British Columbia, the average price per h.p. of thirteen plants was \$96.00 with a masimum cost of \$142.00. In Ontario, we find the cost of pre-war plants as high as \$168.00 per h.p. while the new Queenston development at Niagara Falls concerning which we hear so much, will apparently cost at least \$220.00 per h.p.

Annual Charges

It is estimated that the annual charges of St. Margaret's Bay development will be about \$200,000.00 per year including interest and sinking fund, replacements and renewals, salaries and wages of operating staff, and all other miscellaneous charges. With the total capacity of this development utilized, that is, about \$21,500,000 k.w.hrs. per year or 9,400 h.p., the unit cost would be about 0.9¢ per k.w.hr. or \$21.30 per h.p. per year. I have not the exact figures as to the consumption of electrical energy in Halifax for the year 1920 but understand that it was approximately 17,000,000 k.w.hrs. or 7,600 h.p. On this basis; the cost of power from the St. Margaret's Bay development would be 1.2¢ per k.w.hr. or \$26.30 per \$.p. per year.

There is no question in my mind but that if satisfactory rates are given, the consumption /of electrical energy in Halifax will very quickly amount to the total capacity of the present development. When the consumption in Halifax warrants a further extension to the St. Margaret's Bay development, the unit cost will be somewhat lower than that indicated herein.

The estimated cost of electrical energy delivered to the receiving station at Halifax may be compared with cost to various municipalities in Ontario by a reference to a statement appearing in the 1919 report of the Hydro-Electric Power Commission of the Province of Ontario beginning on page 226. Anyone particularly interested may refer to this statement which is very long but a few examples may be cited. London, Ohtario, in 1912 paid \$28.00 per h.p. and in 1920, \$19.00 per Stratford paid \$32.00 in 1912 and \$25.00 in 1920. h.p. Windsor paid #38.00 in 1914 and \$36.00 in 1920. Guelph paid \$25.00 in 1912 and \$19.00 in 1920. Toronto which is hardly comparable to our situation due to the much larger consumption paid \$18.50 in 1912 and \$14.50 in 1920
