FIRE APPARATUS; BRUNSWICK STREET, GRAFTON STREET AND NORTH END FIRE STATIONS

Read report Committee of Firewards re the purchase of Fire Apparatus, the conversion of certain Horse Drawn Apparatus into Motor Driven Apparatus and re the Brunswick Street, the Grafton Street and the proposed new North End Fire Stations.

Also read minority report of Alderman Ackhurst, Chairman of Firewards in respect to Motor Pumping Engines.

(Both of the foregoing reports will be found incorporated in the minutes of City Council July 6th, 1922. - See also minutes City Council April 18th, 1922).

addition to the Brunswick Street Station and also that the sum of \$20,000.00 be borrowed for the construction of the proposed addition to the Brunswick Street Station under authority of Chapter 71 Acts 1907.

Moved by Alderman Ackhurst seconded by Alderman Finlay that said clause be adopted.

Moved in amendment by Alderman Daw seconded by Alderman Whitman that said clause be referred back to the Committee of Firewards for further report.

By leave of Council the original motion is withdrawn.







His Worship the Mayor, Sir:-

I beg to report on the attached extract from the minutes of the City Council in reference to the extension of the street railway line on Gottingen Street, from Kaye Street to Duffus Street.

The resolution submitted to Council adds, "That the City Engineer shall define the route". The route is defined in the resolution, namely, along Gottingen Street from the end of the line, to Duffus Street. The only work left for the City Engineer in connection with the definition of the route is the exact location in the street.

In considering the proposal for street railway accommodation for the district north of Young Street, a comprehensive scheme for the future should be adopted. Service for the district west of Kempt Road will have to be obtained from the belt line already extended to Willow Park, so that the district to be accommodated by this proposed extension will be that portion of the City north of Young Street and east of Kempt Road.

For a good many years a line through Gottingen Street or Agricola Street or both, would accommodate this district as it has been suggested that a Barrington Street Line should connect with any extension made to Duffus Street, via Demonshire Avenue, the new diagonal street. If there is to be a loop, a line up Gottingen Street to Duffus Street and down Agricola Street would accommodate the whole district. If there is to be one line only then I think it would be better to have a conference with the Tramway authorities before deciding on a location for a single line; that is, whether it should be on Gottingen Street or Agricola Street.

I beg to report on the attached petition asking for the extension of the water and sewer system along Connaught Avenue, formerly Pine Street, north of Quinpool Road.

There are five houses within that portion of the street covered by the petitioners. The shortest way to extend the water pipe would be from Poplar Street, at Oak Street. The district is high service. The estimated cost of extending a 6-inch pipe would be \$2,861.48, interest on the out-lay at 6% is \$171.68, which would make the special rate \$34.34.

If this method of extending the water pipe is adopted I would recommend that a special rate be charged for each property on the line of this extension of \$34.34.

To extend the sewer system it would be necessary to build from Quinpool Road north. The first house is about 800 feet north. The total length of the extension to pass all the houses would be 1264 feet. The cost of the water pipe extension alone for that distance would be \$4,691.96, interest at 6% \$281.51, which would make the special rate \$56.30. As it would be quite possible to make the other extension it does not seem fair to expect the property owners to pay the larger special rate, including 800 feet of vagant land.

The extension of the sewer and water pipe would no doubt mean the sale of more lots and the erection of more buildings, on the other hand it means the City would have to acquire land for the widening to the full width of Connaught Avenue. Under the circumstances I submit the matter without recommendation.

In compliance with instructions from the Works Committee I beg to report that the strip of land required for the widening of Oxford Street, at Mr. W.W. Mr. Foster 's property projects along that line produced as shown on the plan accompanying this report.

On North Street-there have been encroachments all through this street, and we laid down an official line which would be straight although the street would not have the same width all through. The width however, is not of as much importance as the line.

Looking into the future I believe that the City will save a good deal of money by straightening out such places now, or as the opportunity arises.

The area of the land involved is 3,613 sq. ft.

The barn projects over the line on Oxford Street and if any of the Oxford Street lots are built upon the houses must be erected back to the official line, otherwise they will project beyond the line of the street further north.

In compliance with the request of the City Council, I beg to report on the widening of the street at Mr. W.W. Foster's property, corner of North Street and Oxford Street.

Mr. Foster's property extends over the official line on both streets. Mr. Foster made a proposal to the City stating that if the City would furnish an undertaking that the trees at present growing on the strip of land required for street widening purposes shall never be removed and will further agree to move his barn to the rear of the lots on Clive Street, he would accept \$500.00 for the land. and that without the undertaking as to the trees he would require #3,000.00. The Council decided that the City should buy the portion of the Foster property required for street widening on North Street and Oxford Street and that the matter of compensation be left to arbitration and they then named E.J. Kelly as arbitrator, and it was understood by the Council that Mr. Foster agreed to Mr. Kelly's appointment. Mr. Kelly made an appraisal of \$938.56 for the strip of land and the moving of the barn. I have had a careful survey made to locate the trees and find that the City can construct a concrete sidewalk when it is required without disturbing the trees and I can see no objection to the Council declaring that it is

the policy of the City not to disturb the trees and give such an undertaking as they have power to give to Mr. Foster to preserve the trees and to have it confirmed by legislation. I consider that it would be a grave mistake to abandon the official line and not to carry out the widening North Street east of Mr. Foster's property on the north side has been widened and Mr. Foster's corner projects out 10 1/2 feet beyond the line of the rest of the street. Oxford Street, from Mr. Foster's property west, is on the official line while Mr. Foster's property projects beyond that line nine feet. It would be most unsightly in future when curbs and sidewalks are laid to have such projections and in my opinion would not be fair to the rest of the property owners on North Street and Oxford Street as they have accepted the policy of the City, and where buildings have been erected they have concormed to the new lines.

His Worship the Mayor, City Hall. Sir:-

I beg to acknowledge receipt of the Resolution of the Works Committee instructing me to prepare an Arbitration Agreement for the purchase of this property at a price to be determined by the Arbitrator.

I am still, however, at a loss to know exactly what is the wish of the Committee or of the Council. It is a simple matter to prepare such an Arbitration Agreement containing mutual covenants by Mr. Foster to convey his property, and the City to purchase it, at a price to be determined, but I gather from the correspondence and the reports submitted to me, that it is still indefinite as to whether or not the price to be paid is a price for the land and the removal of the barn only, throwing out of account the trees on the property which are to be retained; or whether it is to be a straight price for

the property without any reservations, whatever. If the latter, the City will of course have to pay whatever the Arbitrator awards, which I gather from Mr. Kelly's report may be an amount considerably in excess

Kelly's report may be an amount considerably in excess of the price paid for the land irrespective of the trees. I also gather from the correspondence and reports and from conference with Mr. Doane, that it is not the desire or intention of the City to destroy the trees and that Mr. Foster himself, would prefer to be paid for the land and have the trees retained for the benefit of his adjoining property. Of course, at present the City could not give an undertaking to this effect, but appropriate legislation could easily be obtained for this purpose, and the Arbitration Agreement could be drawn so as to give effect to this mutual understanding. I would, therefore, ask your Committee to give me definite instructions as to whether the Agreement is to

be a flat agreement, which would require the City to pay

for the removal of a number of trees which is not apparently the wish of Mr. Foster or the City to have removed; or whether the agreement is to be drawn so as to retain the trees and pay only for the value of the land with the trees still remaining on it.



Clauses 10,19,29 and 31 have been amended, the change being the same in each case.

Clause 15 has been amended as shown.

Clause 26 has been amended and inserted after clause 24.

Clause 35 has been inserted after 25 and Clause 25 after 27.

The other clauses from 27 to 34 have been renumbered.

The draft of agreement as amended reads as follows:-

This agreement made in duplicate this day of A.D., 1922, by and between the <u>City of Halifax</u>, a body corporate and politic, hereinafter called the "City" of the One Part,

AND

The Nova Scotia Tramways & Power Company, Limited, a body corporate, incorporated under the laws of the Province of Nova Scotia, hereinafter called "The Company" of the Other Part -

WITNESSETH -

That the Company in consideration of the promises 1. and agreements of the City hereinafter contained and the payments to be made by the City under the terms hereof covenants and agrees with the City that it shall and will for the period of fifteen (15) years from and after the 1922 furnish (in the manner hereindav of after described) maintain and operate, and the City, in consideration thereof and during the period aforesaid agrees to take, receive and pay for not less than the number of incandescent lamps and arc lamps of the respective sizes and in the respective locations as shown on the schedule attached to this agreement and marked exhibit "A" together with such additional lamps as are to be installed in accordance with the provisions hereof. The City undertakes the following obligations -2. (a) It will furnish and install series transformers, original lamp installations and all lighting units, carrying the wires for such units to a point at or near the location of the street lighting circuits on the Company's cross arms with enough wire for connection to such circuits. If it requires any of the wiring to be underground (b) it will furnish and install the same, connecting the same to the individual lighting units bringing the feeding leads to a point at or near the street lighting circuits on the Company's cross arms where a suitable transformer or safety coil shall be installed in order to reduce the voltage on the underground system.

<u>October 5th, 1922.</u>

- (c) If any glass ware such as globes or reflectors prove defective or is broken it will replace the same, the reinstallation of the same to be done by the Company.
- (d) It will pay to the Company in addition to the amount hereinafter provided for the operation and maintenance of the lights the cost to the Company of all electric current used in the operation of the street lighting system, payments to be made monthly as hereinafter provided.

(e) It will care for all replacements of equipment furnished by it excluding incandescent lamps.

(f) It agrees that paragraphs a, b, c, d, and e above, shall each and all be applicable to all further extensions of the street lighting service in the City during the existance of this contract.

The Company undertakes the following obligations. 1. It will operate and maintain in manner hereinefter provided, the following lighting units installed by the City at the prices indicated.

If the City requires a greater number of lamps of any of the above sizes, the charge for operation and maintenance shall be **adjusted in accordance with the** foregoing scale.

2. Street lights shall be lighted from dusk to daylight. The Maximum burning hours shall be not exceed 4000 in any year.

3. To serve lamps as shown on schedule attached hereto and marked Exhibit "A", it will extend at its own expense poles, lines, and circuits where such extensions are necessary. It will change the location of not more than 62 poles which the City may decide are not properly located and it will renew 90 poles which the City may decide are at present unsuitable for supporting lighting fixtures. If a greater number of poles than above specified are to be replaced the City will be charged interest on the cost of such replacements and if a lesser number of poles are replaced a similar credit will be given the City. 4. It will serve additional incandescent lamps of the above type if during the continuance of this agreement the City shall desire the installation of additional units. It will serve such new lights at the price per lamp as shown herein providing the extension to serve such lamps does not involve the setting of over two poles per lamp or if poles are not required does not involve the stringing of over 1200 feet of single wire per lamp. In the event that the extension is in excess of this the excess cost will be paid by the City to the Company.

5. It will connect at its own expense all lamp leads and underground leads to its street lighting series system after the same have been extended by the City on the poles to a point at or near the Company's street lighting wires.

6. It will furnish up to 30 D.C. Luminous arc lamps at present in service on Barrington and Granville Streets with the understanding that if a change in location is desired such change shall be made at the expense of the City. Replacement charges on these lamps will be carried by the Company.

7. When the Company has once made connection to any light the City shall have the right to change the location at its own expense to other points on the street lighting circuits. The Company will make the connection to its street lighting circuits as provided hereinbefore.

8. The rental charge for fixtures included in the price shall only cover fixtures installed on the Company's poles, but the Company will use its best efforts to secure the consent of other Companies to the location of fixtures on their poles at a reasonable rental.

9. The poles owned by the Company on which lamps are placed will be distinctly numbered by the Company in the manner now employed and said numbers will be repainted when necessary to preserve legibility. The Company will endeavour to secure permission from other Companies to number their poles in a similar manner when lights are placed on them.

10. It will make at least two lamp renewals yearly and in addition all necessary renewals due to burn outs, breakages, etc. It is estimated that this item of renewals will amount to \$10,930. per year, and is included in the price set forth in paragraph 1, and for this sum the Company will care for all renewals of lamps on the system now proposed. Each periodical renewal to be made after a lamp has been in operation for a maximum period of 2000 hours except as other wise agreed to by the City Engineer or an official of his department on his behalf. If the cost of lamp renewals is less than \$32,790. in consecutive three year periods during the contract after the Company has commenced to instal lamps, the City will be given a credit for this saving but if the figure is exceeded no extra charge will be made. In determining any credit to the City under this clause the invoice cost of the lamps will be used, plus transportation charges, and all delivery charges to the Company's store room. plus 2% for handling and overhead expense.

11. After the system is added to as herein provided the amount allowed for renewals and adjustment of renewals as set forth in the abme paragraph shall be increased in proportion to the new units added.

12. It will furnish to the City each month particulars of all lamperenewals.

13. Only standard types of street lighting lamps will be used.

14. It will agree to replace any lamp becoming seriously inefficient as a lighting unit from being burned out or blackened within 24 hours after its condition has been reported by the City.

15. The Company agrees to maintain its street lighting equipment in good condition at all times and to use its best efforts to the end that each and every street lamp shall burn regularly and constantly. To accomplish this end the Company agrees to co-operate to the fullest extent with the City in replacing or repairing any lamp which is inefficient on out of order and so reported by a City Official.

16. The Company shall forfeit and pay to the City the sum of three cents per hour for each and every lamp reported out by the City but the time shall not commence to run, not the penalty begin to accrue till the night following the recording of such outsge- at the City Hall by a City Official. The City's record of outages shall be open to inspection by representatives of the Company. No penalty shall be enforced where lights are out on account of strikes, lightening, sleet, storms, tempests, Acts of God or the King's enemies or similar matters beyond the Company's control but under such conditions service will be resumed as promptly as reasonably possible.

17. It will agree to operate and maintain in good operating condition all poles, lines, cross arms, fixtures, lamp standards, underground system, substation equipment, etc. including necessary painting but excluding replacement of any equipment furnished by the City excepting lamps. This clause does not apply to glass ware renewals or electric current which have been specifically covered hereinbefore.

18. The street lighting distribution circuits of the Company shall be maintained in good operating condition at all times in accordance with standard engineering practice.

19. The equipment and units owned and installed by the City for street lighting shall be maintained by the Company in good condition as regards painting, repairs etc. Lamps and globes will be thoroughly cleaned three times in the period April to November with other cleanings when the same are clearly necessary. Records pertaining to such cleaning will be kept by the Company open to the inspection of the City Engineer or an Official of his department on his behalf.

20. The Company will renew or repair at its own expense any part of the street lighting units or equipment furnished by the City if the renewal or repair is made necessary by neglect or carelessness on the part of the Company or its employees. The necessity for such renewal or repair work shall be determined by the City Engineer and the work performed in a manner satisfactory to him.

21. The Company will repair any damage caused to street lighting equipment owned by the City if the same becomes damaged by coming in contact with circuits carrying current detrimental to such equipment providing such circuits come under the control of the Company. The necessity for the repair of such damage shall be determined by the City Engineer and the work performed in a manner satisfactory to him. 22. It will supply and deliver as hereinafter set forth all the electrical energy and power necessary for the street lighting system as outlines in Exhibit "A" attached hereto together with sufficient current for additions to said system as hereinafter set forth. 23. The electrical power and energy shall be delivered to the lamp terminal of all the lamps used for street lighting purposes. The energy so delivered shall be of the proper voltage and amperage to light the units in an efficient manner and will be maintained at a constant value of approximately 7.5 amperes. 24. It will furnish said electrical energy and power for street lighting purposes from the electrical development at St. Margaret's Bay when such energy is available in accordance with the terms of the Company's contract with the Nova Scotia Power Commission.

25. The Company agrees that in the event of a failure or deficiency of current from St.Margaret's Bay sufficient to carry out the contract, it will supply such current from its steam generating plant or other alternative generating source, such current to be furnished at the cost of generating the same, and such cost to be fixed by the Nova Scotia Board of Public Utilities, if the Company and the City are unable to agree upon the same.

26. The Company shall not be liable for failure to supply current, or for any interrupted service caused by reason of strikes, lightning, sleet storms or tempest, acts of God or the King's enemies, or by accidents to plant, machinery, poles, wires, lamps or fixtures of any nature which are beyond the Company's control.

27. It will sell hydro power secured from the St. Margaret's Bay plant at cost, said costs to include the transformer loss in stepping the street lighting current down to 2200 volts where the street lighting meter will be located.

28. The supply of electric power for street lighting purposes will be metered at the point of supply for street lighting only. The said source of supply to be disconnected on the primary side of the constant current transformers when not required for lighting the streets or test purposes.

29. The Company shall furnish from time to time as required by the City, records of current regulation as indicated by a graphic instrument located in the Company's power house.

30. The consumption of current for street lighting purposes shall be measured on a standard meter which can be checked each month by the City Engineer or an official of his department on his behalf. This meter is subject also to the test of the Dominion Government official appointed for that purpose, whose test will settle any dispute as to accuracy.

31. The Company will reduce the current supplied for street lighting during certain portions of any night op nights if so required by the City for economic reasons.

32. The street lighting equipment owned by the Company shall be open for inspection by the City Engineer or an official of his department on his behalf, at any time that an inspection may be considered necessary by him.

33. The Company shall furnish the City with two plans (scale 1 in. 300 ft) showing each street lighting circuit and individual lamp locations plainly marked there on. Prints for this purpose will be furnished by the City. The Company agrees that it will complete its portion 34. of the street lighting work within five months after the signing of the contract and will use its best endeavor to complete the work at the earliest possible moment. 35. The Company will bill the City each month 1/12 of the total annual cost of the amount paid for current to be tentative with adjustments once a year. All bills presented for payment on or before the third of the month shall be payable within thirty days and interest at six per centre per annum shall be paid by the City on all overdue accounts. If bills are not presented on or before the third of the month the same shall not become due for gixty days. 36. Except as specifically provided herein all differences which may arise between the parties hereto shall be submitted and two arbitrators, one to be appointed by the

City and the other by the Company, which arbitrators whall be at liberty to appoint an umpire, and all proceedings of such arbitrators shall be subject to the Arbitration Act.

37. AND IT IS FURTHER AGREED that the terms of this agreement are subject to the approval of the Nova Scotia Board of Commissioners of Public Utilities.

owner of the property states that the tenants, who were in arrears for rent, did not let her know about the broken pipe.

This case is only one of many similar ones that have to be dealt with every year. In numerous cases the owners report that some tenants after disagreements about rents or notices to quit, waste the water in order to run up a big bill against the landlord.

Color worker There is no doubt in my mind that the water passed Pthrough the meter and while I have every sympathy for the owner under the law, I am unable to recommend any reduction.

In this connection, I would like to repeat the recommendation made last year, that now that all premises are metered, the bills for water should be sent out monthly to the tenants of properties in a similar manner to the way the bills for the telephone service, electric light and gas services are rendered. A discount could be allowed if payment was made within ten days and the water should be turned off if the bills are not paid within twenty days. This refers only to the amount of water consumed by the tenants. The bills for the fire protection could be sent out to the owner of properties as at present, as fire protection rate is a fair charge against the property itself.

Suggestions-as to the most appropriate form of memorial have been presented before different organizations as well as through the public press--with all of this you will be thoroughly familiar. Up to the present time, the matter has not been dealt with in any official way by the City. It would seem fitting that the views of Council be obtained and a decision reached as to just what part the City is to take.

I am anxious that this be taken up at our next meeting and would suggest, in the meantime, that you give consideration to the following;

- (1) Should the City, itself, undertake the erection of a suitable War Memorial?
- (2) Should it be undertaken jointly by the City and by public subscription.
- (3) Should it be confined entirely to public subscription?

The question of its form and location are subjects for later consideration. The committee, which has been working on the proposal, have secured a number of sketches, largely confined to arches, the estimated costs of which range anywhere from \$40,000. to \$100,000. All these designs can be seen at my office.

Opinions seem to widely differ as to whether the memorial should take the form of an arch, column, cenotaph, or some such memorial; or if it should be in the nature of a building, such as public library and art gallery.

Various sites have been considered but the decision, on this point, would necessarily be guided by the form of memorial decided on.

The above, in a condensed way, covers what has so far passed and I would ask that you give the matter your best thought so that we can discuss it fully at our next meeting.

entered into by themselves and the National Surety Company to the same effect. The terms of payment provide that the City can retain fifteen per cent. of the contract price, which in this case amounts to about \$4,300. for thirty days after the completion of the contract including the adjustment of any claims for damages. The contract has been completed and the City has retained it for more than thirty days, and apart from the matter which I am about to mention, the contractors will be entitled to receive the balance retained by the City.

A claim, however, has been made by Mr. Busch, for damages to his house by blasting in connection with the Sewer. This claim is estimated by him to be not in excess of \$2,000. The contractors have applied for a release of the Guarantee Bond, so as to enable them to obtain a return of the premium for the unexpired term, the City retaining the balance of the contract money as an indemnity against any loss which the City may have to meet, arising out of Mr. Busch's claim. It appears to me that the City will be amply protected by retaining the \$4,300. I think the contract is clear that we have a right to do so to meet any claim arising from damages occasioned by the default of the contractors, but to make assurance doubly sure, I suggest an express undertaking by the contractors that we may retain the money for that purpose, and apply it to meet any claim on that account.

I have drafted such an agreement in the form of a letter to accompany this report.
