As particular instances, the cases of two large tax-9. payers, Mr. W.F. Page and Mr. J.E. Roy, have been selected the unaccounted for sums amounting approximately to \$32,000. and the particulars respecting them are set out in detail in the reports of Mr. McCombe, Chief of the Independent Auditing Staff, copies of which are hereto attached. Numerous other similar cases have been discovered and are being discovered as the audit and investigation proceeds. 10. That he has wilfully failed and neglected to carry out his duties and obligations imposed on him by the City Charter in collecting taxes and has wilfully disobeyed and disregarded the provisions of Sections 437 and 319 of the Oity Charter 1914 (owing to which neglect and disobedience

a very large sum of taxes remains uncollected and unpaid and the City will lose a very large sum of money by such neglect and disobedience.

He has wilfully failed to discharge his duty and has disobeyed the imperative directions contained in the City Charter and has neglected his duty to make monthly returns to the City Council of the amount of rates and taxes, including water rates, collected by him, specifying the name of each ratepayer and taxpayer with the amounts paid by him and of the aggregate amount of rates and taxes and of such water rates respectively remaining uncollected as required by section 321 of the City Charter 1914 and has not performed any of his duties required of him by said section 321.

13. He has wilfully disobeyed and disregarded and neglected the imperative duty and obligation imposed on him by the City Charter to sell all real estate on which taxes are in arrear within three years as provided by sections of the City Charter from 447 to 472 (1914).

We questioned the Collector as to why he shoulds accept payment of taxes for the years 1915 to 1918 inclusive and those of years subsequent to 1919 when the above years remained unpaid and his reply was that he knew that these taxes were unpaid but that he had an arrangement with Mr. Page in regard to his tax accounts. We aksed him for the correspondence and he stated that the arrangement was verbal and that there was nothing in writing in regard to it. On further inquiry as to the nature of the arrangement he stated that he could get the money any time. We expressed dissatisfaction with the explanation and pointed out that considerable sums of interest would be involved.

We then consulted you as to whether it would be probable that Mr. Page would be in arrears to this extent and suggested that Mr. Page should be communicated with.

The taxes for the years 1915-16 and 1917-18 have, according to the books been paid in full.

When questioned in regard to the status of Mr. Roy's account the Collector informed us that only the taxes for the year 1922-23 which we have not included in the above summary remained unpaid. We pointed out to him that the above items according to his records were also unpaid, but he offered no explanation.

The matter was taken up with Mr. Roy, who claims that with the exception of items (5) and (7), all the amounts have been paid. He has not been able so far to locate his cheques and receipts for items (1) and (2), but we have seen the following cancelled cheques given in payment of items (3), (4) and (6), together with accrued interest thereon.

None of the above cheques have been dredited to Mr. Roy's tax accounts and we have not been able to find stubs of receipts given by the Collector.

We find that it has not been the practice of the Collector to make regular daily transfers of all cash received to the Treasurer as required by the City Charter and, at the time of thereceipt of Mr. Roy's cheques, moneys had been held back for periods of varying length and the amounts of the deposits with the Treasurer were brought up to the amounts called for by the Cash books by the utilization of these cheques.

Ltd., are considerably lower than the other firms, and with the matter of cost as the chief consideration, this firm offers the lowest tender. G.H. His Worship the Mayor, Sir:-The City Electrician has been looking into the question of a possible saving that might be affected by the purchase of the electric incandescent lamps required by the several departments of the City from one dealer. He -- 83 --

finds that such an arrangement can be made and a saving of from 21% upwards can be made by the City in this service. A copy of his report attached shows that the tender for the Mazda Lamp from the Canadian General Electric Co., W.W. Hoyt, Cragg Bros., and the Northern Electric Co. and Canadian Westinghouse Co. Ltd., are the same provided the lamps are purchased in standard packages on which there would be a discount of 21% from the regular price. Farquhar Bros. tender however, on the volt lamp at a figure about 25% less than the Mazda lamp. They offer to replace any defective lamps. Neither the City Electrician nor myself have any personal experience to enable us to pronounce on this lamp. As the bidder offers to replace any defective lamps the risk in adopting a lamp which is new to us is largely covered.

E would recommend that the City purchase all the lamps required for the year from one dealer and that the different departments be nofified accordingly. If there is any defect in any department in connection with the standard package that is, that they might require part of a package to complete their total there should be no difficulty in the distribution if made through the City Works Storekeeper.

SAILORS HOME EXEMPTION FROM TAXATION ETC.

Read letter Capt. Wm. G. deCarteret, President Nova Sobtia Division The Navy League of Canada re exemption from Civic taxation of the Sailors Home property at the north west corner of South Street and Barrington Street.

> The Navy League of Canada, Halifax, Canada, June 26th, 1923.

His Worship the Mayor, and Members of the City Council. Halifax, Nova Scotia. Dear Sirs:-We have carried on the work in connection with the Sailors in this Port for upwards of forty-three years, during which time we have had threes Sailors' Homes - all of which have been exempt from taxation. None of these Homes were large enough to accommodate the number of Sailors that frequented the Port. During all these years we have been endeavouring to secure from our Citizens sufficient funds to give us a suitable building for our work and one that would be a credit to our Port. We have failed in all our efforts in this direction. The Navy League of Canada are taking a large interest in the Sailors the world over and, seeing that the facilities in this Port were inadequate, they came forward with ample funds which, with what we were able to furnish. -- 84 --

enabled us to provide ourselves with a suitable building fully equipped with home comforts, a building which is in every way a credit to our City.

We have at all times been compelled to assist a large number of men who were not able to pay their board. In 1922 there were 59,124 men housed by the Home, besides which we supplied, without charge, 885 beds and 2,229 meals as well as boots, clothing and socks to those who needed them, so it is abundantly apparent that the Home is justifying its existence in the Port.

Our chief difficulty now is in meeting the taxes demanded by the City. When this matter originally came up, Mr. Brookfield, one of the Directors, saw His Worship the Mayor and he appointed a Committee to deal with the matter. The Committee met on February 22nd. 1921 and the whole matter was fully discussed. Hearing nothing from this Meeting, a Committee of the Navy League met by appointment with the Laws and Privileges Committee on January 20th. 1922 in the Council Chambers and the matter was fully gone into. The Extract from the Minutes of the Executive -Nova Scotia Division held on Friday, January 20th. 1922 at 1 P.M. states as follows:

"In the interview with the Mayor, His Worship was reminded that no other Institute under the operation of the Navy League in any other City in Canada was burdened with taxation, and he was also informed as to the amount of bontributions to the Navy League given by other Cities in Canada, in addition to their exemption of the Navy League institutes from taxation. He was also reminded that itwould not be possible to procure further assistance from the Navy League contributors in these other parts of Canada, so long as such a heavy tax bill was levied locally. His Worship also promised his personal interest, but stated that in order to procure exemption from Taxation, it would be necessary to interview the Laws and Privileges Committee, and an appointment was arranged at four o'clock. Every Member of the Navy League was urged to make it convenient to attend on this deputation".

Although we were informed that the matter would receive every consideration, no results materialized. We have no funds to meet the taxes assessed against us and all we request is to be placed in the same position as other charitable Institutions carried on in the City. The Legislation exempting the Sailors Home from taxation was cancelled without our knowledge, nor was there any notice given us at that time. The City has taken approximately 12 ft. of our ground on Pleasant Street and 1 ft. on South Street, as a result of which we were compelled to purchase the property to the North at a cost of \$15,000 in order to get a rear entrance. This amount we have had to borrow. We cannot place a mortgage upon the building until the taxes are paid and we respectfully submit to you that the value of the land taken by the City from us to be offset against the outstanding taxes which we consider would be an equitable settlement. As a basis for future assessment on the Navy League Building, we respectfully consider that it should be determined on the revenue producing portion of said building. As the earnings of the property has fluctuated so

much since we occupied the building, and to save future difficulties we would be willing to have the building assessed in accordance with its Commercial revenue only. The only other alternative is for the City to sell the property, which would be a great blow to the Navy League of Canada which has provided us with such a splendid home for our Sailors to whom this Port owes so much, but more particularly Canada which was protected by them during the War and we have no doubt they stand ready to do it again if necessary.

Trusting that you will give this matter your very earliest consideration and advise us as soon as convenient of what we may expect from your Council in this matter. His Worship the Mayor has had very detailed statements given him regarding our financial position, revenue and expenses. All of which is respectfully submitted. On behalf of the Committee.

WHEREAS by an Acti of the Legislature of the Province of Nova Scotia passed in the year 1919 as Chapter 82, the City of Halifax is authorized to borrow for the improvement of the Market building a sum not exceeding \$10,000.00. THEREFORE BE IT RESOLVED that for the purpose aforesaid there shall be borrowed on the credit of the City of Halifax at large and as part of the Consolidated Fund 1905 and amendments thereto a sum not exceeding \$10,000.00 for the purpose aforesaid and debentures or stock sufficient to yield a sum not exceeding \$10,000.00 shall be issued therefor, dated the first day of July 1923, bearing interest at the rate of Five per centum per annum, payable half yearly on the first of January and July in each year. The said stock or debentures shall be payable in ten years from the date thereof in ten equal serial payments with the interest thereon as authorized by Section 28 Sub-section 2-A Chapter 84 Acts 1917.

If it be deemed more advisable, Section 35 Chap. 36 Acts 1916 may apply viz: "Chap. 51 Acts 1905 is amended by adding thereto the following section. 12. Whenever under the authority of this Act or of any amendment the City is authorized to borrow money and to secure the same by the issue of stock or debentures, therefor, the City may, instead of selling such stock or debentures, pledge or hypothecate the same as security for a temporary loan of money to the City".

To the Gity Council. Gentlemen:-

At a meeting of the works Committee held May 2nd, 1923 the City Engineer submitted a report on sewer and water extension in Ivanhoe St. petitioned for by the Eastern Trust Co. et al. Action was deferred on the report, and the City Engineer was requested to get in touch with Mr. Stevens of the Eastern Trust Co. and ascertain just how many residences it could be assured would be erected within twelve months if the city would undertake to make the extension asked for. At a subsequent meeting held May 9th. 1923 Mr.

Stevens, Manager of the Real Estate Department of the Eastern Trust Co., confferred with the committee in re sewer and water extension Ivanhoe St. stating that if the City was not in a position to proceed with the work at present their clients might be willing to finance the undertaking, if the City would reimburse them later, and he would like to know the Committee's attitude in that fespect. He was advised to submit the proposal in writing to the Committee, stating definitely what his clients were prepared to do. In the meantime, the committee agreed that in the event of the proposal being satisfactory it would be recommended to Council that the offer of financing be accepted and the work proceeded with, repayment to be made in three instalments without interest, first instalment to be payable after two houses have been completely erected, and for each additional two houses erected a further payment will be made until the whole amount advanced is repaid, it being further understood that extension was to cover the drainage facilities for Mr. MacDonalds house, and that payment of frontage rates, as provided by

law, were not to be considered waived by any agreement made, and, exdept as to financing, the work shall be arranged for by the City and under the supervision of the City Engineer. Any agreement made shall be as may be approved by the City Solicitor.

Under date of May 15th. 1923 the Eastern Trust Co. replied in writing their letter being attached hereto, and which was read at a meeting of the Works Committee held May 16th, 1923.

On May 30th, 1923 a further communication was received from the Eastern Trust Co. dated May 29th, 1923 in respect to financing the construction of sewer and water extension in Ivanhoe St. The communication was referred to the City Engineer and the City Solicitor to embody in an agreement, stating terms under which the work could be undertaken, the same to accompany a report to Council recommending the construction of sewer and water extension in Ivanhoe St.

At a meeting of the Works Committee held June 27th. 1923 draft agreement re sewer and water extension Ivanhoe St. (referred to in Minutes of Works Committee held May 30th. 1923) was approved and ordered to accompany other documents to Council in fespect to such construction, which draft agreement has been submitted to and approved by the Eastern Trust Co. and it is now recommended on the signing of said agreement that said extensions be made.

WHEREAS mails landed at Halifax can be delivered at New York and in the Eastern States at least as quickly as if they had been landed at New York and in the Middle West and West of the North American continent in a much shorter time,

THEREFORE RESOLVED that the City Council direct His Worship to cable Rear Admiral Gaunt, thanking him for the interest he is taking in the development of a fast Atlantic mail service via Halifax and that the Council also direct His Worship to cable the British Postmaster General, informing him that Halifax posses unsurpassed facilities for the expeditious handling and transit of mails for practically the whole of the continent, involvingOno extra handling, except in the case of New York City, and respectfully suggesting that if a test with a steamer of the Mauretania type were made by the British Post Office Department, the superiority of the Halifax route would be clearly demonstrated.

His Worship the Mayor, Sir:-In compliance with the instructions of the Works Committee I beg to report on the paving questions referred to me. The estimated cost of paving Quinpool Road under the prices named in the last tender, is \$38,804.00; the estimated cost of paving South Park Street, \$26,160.00; total \$64,964.00. The balance of money on hand, plus \$60,000.00 authorized to be borrowed this year for payment petitioned for will be sufficient to pay for this work. The estimated cost of paving Agricola Street, from Cunard to West is \$11,200.00, but I am informed by the City Assessor that the petition for this work is not signed by the majority of the property owners. The estimated cost of paving Agricola Street, from Bloomfield to Almon is \$2,500.00; Almon Street, from Agricola to Robie \$6,750.00 Jacob Street, from Argyle to Brunswick \$10,000.00. The two links on Agricola Street and the block on Almon Street are needed to make a connection of the Agricola Street pavement with the other paved streets in the north end. There is a connection at North Street, but the fact that these links are missing causes a considerable increase of traffic at North Street and RobieStreet which is a very dangerous intersection on account of the volumne of traffic on both streets. The paving of the links referred to would tend to relieve the congestion at this intersection and would complete the connections which are missing. This work cannot be paid for out of the loan anthorized this year but there is other money which should be made available for this purpose and should be used for it, namely, \$1,040.80 not borrowed last year under the legislation of 1922. Also of the money that was borrowed \$30,695.00 has been used to pay the abutters' share although it is not legal to do so, but a portion only of the money which should have been borrowed for this purpose was borrowed from the bank and under the Legislation in force previous to the last session this \$30,695.00 should have been borrowed

from the bank; possibly it is too late now to borrow it from the Bank but it should be borrowed under the Legislation of 1923, or if that cannot be done it should be repaid from the amount collected from abutters so that the account will be correct and the appropriations show the balance that it should show; as it is now, as already stated \$30,695.00 has been taken from money borrowed for one purpose and used temporarily for another purpose; it has always been repaid and should be repaid now. We should then be in a position to complete the pawing on Agricola, Almon and Jacob Streets.

We beg to acknowledge your letter of June 29th, requesting information concerning the Company's attitude on the subject of street paving. In reply thereto we beg to advise that the Company stands ready to undertake paving up to a maximum cost of \$100,000. or approximately one mile of double track. The Company will undertake such work this year or next year as the City may direct.

We desire however to take this opportunity of stating that the Company's financial position is still such that the City's paving requirements are bearing heavily upon its resources. The Company at the present time is not earning a fair rate of return on the value of its property and of course this situation is becoming worse as additional street paving is required. Obviously the Company gains nothing from the paving it does as expenses are not decreased nor are earnings increased because of it. The burden is a heavy one and since the Company thas no other income than that which it receives from its

customers, those who use the tram cars are ultimately going to have to pay these increased costs through the rate of fare.

Because of these conditions the Company would respectfully urge that serious consideration be given to a curtailment of postponement of all street paving.

"The Company shall pave and keep in good repair all "the spaces between the rails and tracks, and two feet "outside of each rail, with such material and in such "manner as the City Council shall approve on the recommen-"dation of the City Engineer, and on such streets and at "such time or times as the said City Council shall determine "by a two third vote thereof. The Company shall not put "or place any material whatever on its road-bed between the "tracks and for two feet outside of each rail, or any part "thereof, without the said material having been first app-"roved by the said City Engineer in writing, whose decision "thereon shall be final, but nothing herein contained shall "in any way relieve said company from maintaining and keep-"ing its roadbed and tracks in proper repair, as required "by this Act. No salt shall be used by the Company except "on the rails, and then only in the manner approved of from "time to time by the City Engineer".

His Worship the Mayor, Sir:-

I beg to report on the question referred to me as to the relative merits of sheet pavement on a concrete base, tarvia macadam and oil macadam for Quinpool Road and South Park Street.

It was suggested that a separate report should be made for each street but practically all that I can say on the question affects both streets in the same way. I am quite as anxious as any member of the Council can be or as any property owner is, that the cost of paving should be kept as low as possible but I have to try to look ahead to decide what should be really cheapest and in the best interests of all concerned. A tarvia macadam street or an ciled street is affected by the frost much more injuriously than a pavement with a concrete base, the latter will settle back to its place practically without damage but the two former are permanently injured and have to be repaired or It is difficult to make repairs on roadways left uneven. without a concrete base so that there will be no settlement It will be argued that on certain streets or uneveness. the pavement laid has given best satisfaction the roadway is forty eight feet wide and the traffic is distributed all over it, nevertheless the roadway will not last one season, it has to be repaired at least once a year; on other streets where the traffic is more confined like Tower Road and Robie Street, the oil coat cannot resist the suction of the motor car tires and will not last one season. On Duke Street where there is tarvia macadam there is a heavy grade which prevents fast traffic and consequently the suction of the tires is not so destructive, yet the surface has had to be repaired practically every year. On Quinpool Road and South Park Street cars or teams standing at the ourb and the double track dar line in the center confines the traffic, in addition 'the flat grades on these streets would cause water to lie on the pavement and the life of the tarvia is very much shortened. The Bedford Road which has been referred to would have been in a pretty bad shape now if it had not been repaired last year and will require repairing every year to maintain it. The cost of tarvia macadam based on the last tenders we had is at least two-thirds of the cost of the sheet asphalt on a concrete base; the asphalt pavement in Halifax has been in use fifteen or sixteen years. A suggestion was made that the street appropriation should be used to pave these roadways; it would be legal to do it but until the streets generally are in better condition we cannot afford to take such large sums out of the street appropriation for such work. Both the roadways in question are main thoroughfares and important roadways and should not require annual or semi-annual repairs. The material should

be chosen to fit conditions. There is a place for tar macadam and a place also for ciling and those materials will be suitable on many streets in the City where grades are favorable or traffic less destructive, but in my opinion they are not suitable for the sections of roadway under discussion and I would recommend that these roadways be paved with a sheet surface on a concrete base which the majority of the property owners have petitioned for and for which they are prepared to pay their part of the cost. Our tender this year for Sheet asphalt on concrete base is \$4.20 per square yard.

It will be noticed that the largest consumption was during the winter months and the meter reader reported at the time that the water was let run to prevent freezing and also that there was a waste in the closet.

I have had the meter tested and it is found to register accurately. There are six taps and one closet in the premises. At the time of inspection this month there was no waste found on the property. Two flats are vacant and the occupant of the other flat stated that the water was allowed to run to prevent freezing. This would account for the large consumption.

Under the circumstances I am unable to recommend any reduction in the bill.

HEARTY GREETING TO GOVERNOR COX

Civic Address of Welcome Emphasizes Ties Between Halifax and Massachusetts; Our Gratitude For the Bay State's Assistance After Great Explosion is Again Voiced—Distinguished Visitors Guests of Honor at Civic Luncheon.

A large number of people gathered at the South Terminals at 12.50 today to witness the arrival of Governor Cox, of Massachusetts, and party, from Pictou, where they had been attending the Hector celebration. The teminals were flooded with brilliant sunshine and the warmth of the day was tempered by a typical Halifax breeze. The reception committee, who greeted the Governor of Massachusetts, consisted of Mayor Murphy and City Solicitor Bell, representing the City of Halifax, Hon. Attorney General O'Hearn and Deputy Provincial Secretary Barnstead, representing the Provincial Government, G. Fred Pearson and Hon. R. G. Beazley, representing the Massachusetts-Halifax Health Commission, United States Consul Reynolds and H. R. Silver.

Premier Armstrong arrived with Governor Cox and party. The reception committee proceeded immediately upon the arrival of the tráin to the Govenor's special car. They then passed to the waiting automobiles in which the guests were conveyed to the Province Building, where the visitors were received by members of the Provincial Government, and then to City Ha?. A guard of six policemen were drawn up in front of the cars with an officer in charge. The Governor Cox car, driven by Mr. Meagher, was decorated with crossed American and Canadian flags. Governor Cox was accompanied by Mrs. Cox, Mr. and Mrs. Frederick R. Clay, Louis Cox and Mr. J. E. Kerr.

The Civic Address.

On the party being seated in the Council chambers, where there was a big gathering of citizens, many of whom were presented to Governor Cox, the following address to him was read by City Clerk Monaghan, his excellency making a most happy reply.

"His Excellency Channing H. Cox,

Governor of the Commonwealth of Massachusetts.

"Your Excellency:----

"On behalf of the Corporation of the City of Halifax and the citizens of this City, we beg to extend to you a hearty welcome.

"The ties between this City and the Commonwealth of Massachusetts have always been of the closest and most intimate character. From the founding of our City in 1749 to the present time our relations in business, in law, in literature and in social and personal connections have never ceased to draw us one to the other. Some of our earliest lawyers and judges came to us from you, bringing with them the education and culture of your great University of Harvard.

"Many of our people have found warm welcome and new homes in the cities of your State, and no small number of them have risen to prominence. Social intercourse has been so close and common that many of our citizens feel nearly as much at home in your cities especially Boston, as in their own native city.

"We have been indebted to you for no small part of the laws on our Statute Book. When it was decided in 1841 to incorporate the inhabitants of this peninsula, it was to the Charter of Boston that we in great part looked for our guide and model.

"But above all else, no inhabitant of Halifax can ever forget or cease to be most grateful for the wonderful way in which your citizens came to our help at the time of our great misfortune—the Explosion of 1917. The crash of that had hardly died

Not only did you send us material assistance in goods and money, but citizens whose wisdom and experience w invaluable to us in that timinfinite confusion and distress. have thanked your people be but we can never the you much or too often. a movement is on foot more widely known the attractions of this City and Province. We trust that you will have full opportunity of seeing for yourself how great these are and will make them known to others. "We hope that in every way your stay among us, all too brief, will be a pleasant one, and such as will induce you to return.

S. flags over the Mayor's presiding chair flanked a big "Welcome" and the chamber wall panels all carried stands of little British, Canadian and U. S. flags. On the wall at the rear of the chamber was another "Welcome" banner with the Prince of Wales flag and bannerettes. The decorative work was done by District Fire Chief Hawley and firemen. City Painter Thomas, Gardens. Superintendent Hall and his men and City Hall Janitor Lynch.

Then the Governor and Mrs. Cox called at Government House, where they were received most cordially by the 'Lieutenant-Governor of Nova Scotia and Mrs. Grant. An inspection of the institutions of the Massachusetts-Halifax Health Commission followed. The inspection over, the Governor and his party enjoyed an automobile tour of the city, visiting various points of interest, including the reconstructed area in the North End. Last evening they were the guests of the Provincial Government at dinner at the Halifax Club and later visited the Public Gardens, where a oplendid band concert was presented.

The Governor's Arrival

A large number of Halifax citizens gathered at the Terminal Railway Station yesterday afternoon to greet Governor Cox. The train to which his private car was attached arrived at ten minutes to one o'clock. The official reception committee consisted of Mayor Murphy and City Solicitor F. H. Bell, representing the City of Halifax; Attorney General O'Hearn, and Deputy Provincial Secretary Barnstead, representing the Provincial Government; G. Fred Pearson and Hon. R. G. Beazley, representing the Maosachusetts-Halifax Health Commission; United States Consul Reynolds and H. R. Silver. Premier Armstrong returned from Pictou with Governor Cox.

Leaving the railway station the Governor and his party motored to the Province Building, where they were received by the Attorney General in the absence of the Premier. They were conducted through the building and expressed delight over the stately architecture of the structure and its interesting interior. They were particularly interested in the oil paintings in the Legislative Council Chamber.

Hours In Town the Party Proceeded to Boston.

Special to The Morning Chronicle YARMOUTH, July 22-Governor Channing H. Cox and Mrs. Cox and party arrived in Yarmouth by special train from Digby at four o'clock yesterday afternoon, and at oeven o'clock they sailed on the Boston-Yarmouth liner Prince George, for Boston, which concluded one of the greatest weeks of pleasure they had ever enjoyed.

While here, however, and for the short time at their disposal, the visit of the Governor and his party was made a memorable one.

The weather was ideal and owing to the remarkable summer which Western Nova Scotia is this year enjoying, Yarmouth Town and County was never more picturesque than at the present time. To add to that beauty the town was gaily decorated with bunting and flags everywhere. It was the first time in many years, if not in the history of Yarmouth, that a State Governor of the Union to the south of us has visited Yarmouth, and the entire town was out to bid them welcome.

When the train, drawn by a locomotive named "Governor Cox" in honor of the event. pulled into the Dominion Atlantic Depot, the Governor and his party were met by J. M. Walker, Mayor of Yarmouth, and several citizens. After a few minutes spont in becoming acquainted, the party was taken for a short auto drive about the town and immediate vicinity, after which they returned to the Club House of the Yarmouth Golf and Country Club.

Here they were met by a very large number of Yarmouthians and happy greetings were extended to them.

A light luncheon was served and at its conclusion Hon. E. K. Spinney, as President of that organization, extended on behalf of the Club and citizens of the town of Yarmouth a hearty welcome.

Governor Cox replied eloquently and after another cordial hand shake, the party left by auto for the Evangeline docks, where they embarked on the steamer. At the wharf the Governor was met by a large delegation of members of Philae Temple of Mystic Shriners of Halifax, of which there is a very large number in Yarmouth. Governor Channing Cox Charmed With Halifax

"You have a fine city, inhabited by fine people. I cannot speak too highly of the treatment given me—it has been most wonderful." In these crisp, yet feeling phrases, Hon. Channing Cox, Governor of Massachusetts, in the course of an interview given a representative of The Morning Chronicle, last night, expressed his appreciation of the reception given him during his visit to Halifax yesterday.

Expressing his delight with "the wonderful hospitality" displayed on all sides since his arrival in Nova Scotia, which he said was more reminiscent of an "Old Home Week," at home, than of a visit to another country, Governor Cox said it was a revelation to see, displayed in all parts of the city; a wonderful recovery from the disaster of 1917.

He was amazed, he said, on his arrival here to find a city combining age old dignity with the highest degree of modernity, and he was pleased and delighted with the wonderful expanse of water and trees. This was his first visit to Halifax, but it would not be his last. His brief contact with the city left in him a desire to return, some day, not in the dim future, and enjoy nature in all its beateous aspects.

Asked regarding his opinion of the Public Gardens, where he attended a reception last evening, Governor Cox said, "You can say with all truth that neither myself nor any member of my party has ever seen a natural beauty spot that could equal your Public Gardens. They are delightful."

One feature, he said, which particularly attracted his attention, was the work of the Halifax-Massachusetts Relief. His brief survey, he said, convinced him that not only the City of Halifax, but also his own State of Massachusetts owes a great deal to those Halifax men who have devoted their time and energies to this work. "Not only in your own city have I been wonderfully well treated, he concluded, "but also at the various other parts of the Province at which I happened to touch. The warm hearted manner in which I have been received by the people of Nova Scotia will live long in my heart, and I will always owe you a great debt of gratitude. I will carry back with me to Massachusetts, back to my people, the memory of a wonderful reception accorded me by the people of this Province, and the recollection of princely treatment which could not possibly have been surpassed. I will communicate to the people of my State, as best I can, the story of the wonderful hospitality you have accorded me, and I know that story will cement even closer, if possible, the bonds of friendship already existing between your people and mine."

We hope that in every way your stay among us, all too brief, will be a pleasant one, and such as will induce you to return.

Gentlemen:

RE: Appointment City Collector

The meeting, this evening, was called under a resolution of Finance Committee for the purpose of dealing with the recommendations of this Committee respecting the position of City Collector, the applications for which vacancy were referred to them for investigation and report. I have felt throughout that there has been undue haste, on the part of at least the Chairman of this Committee to have this permanent appointment made. I am free to admit that he undoubtedly feels the City's interests will be best served by this course. My judgment has been against moving too quickly, as I felt we could deal with the matter to better advantage after this investigation has taken more definite shape, when we could tell just what re-organization

is necessary in the Department and I still hold this view.

We advertised through different channels for applicants and received sixty (60) applications. No doubt the Finance Committee have satisfied themselves respecting the qualifications of these applicants. It is noticeable, however, that they had apparently little difficulty in making their selection.

Under the peculiar conditions confronting the City it was reasonable to hope that Members of Council would have been left free to reach their bes t conclusion in dealing with this matter. This, however, seems impossible, as the usual wire-pulling has been at work to make more difficult the task of Council in coming to an unbiased decision.

In case this matter is disposed of to-night, I think it advisable, so that no man will accept this Office under any misapprehension, that the Council place on record its intention of having existing sections of City Charter, surrounding this appointment and that of other permanent officials, amended at the coming Session of the Legislature, to provide that they be subject to dismissal by a majority vote of Council and that any other restrictions surrounding the Office be removed, both as regards salaries and duties.

We beg to acknowledge your memorandum of July 5th containing a resolution moved by Alderman Daw and passed unanimously by the City Council with reference to a reduction in the tram service on the Belt Line. We feel that there would have been no occasion for this resolution had the Aldermen understood that when the change is made a better service on the Belt Line will probably result. At the present time travel throughout the system is materially lower than it was a year ago yet at certain times of the day namely morning, noon and night, when people are going to or returning from their work, the cars are fairly well loaded. It is the purpose of the Company to remove from service two of the sixteen cars on the Belt Line during the periods of day when travel is lightest, namely, in the middle of the morning, in the middle of the afternoon and late in the evening but to operate these two cars, with whatever others may be necessary during the rush periods, morning, noon and The result of this will be that a much better night. service will be provided during these rush periods and during the hours when there is no rush there will only be an interval of one-half minute greater than at present between cars. We feel that this will not be noticeable during the time of day when travel is light.
