3. The fire protection water rate to be rated for same period on \$260,000. Water consumption rates to be such as are legally in force from time to time.

4. For the civic year 1927-28 the owners of hotel agree to pay taxes and water rates on the valuations aforesaid at the rates hereinbefore specified for the period of the civic year remaining unexpored after the opening of the hotel for business.

5. That nothing herein contained shall affect the assessment or taxation of the said property and building unless and until the said hotel is carried to completion.

6. That this Exemption shall not be in force unless the said hotel is completed within two years from date.

The statement of the appropriation for the City Health Board up to August 31st, as received from the Auditors shows that our appropriation for the year is about exhausted. The appropriation totalled \$850.00 and was made up as follows:-

This is a decrease of \$1,100 compared with the appropriation for the previous year. The heaviest item of expenditure this year, was for the examination of milk, and unfortunately the amount was reduced from \$600.00 to \$200.00, a decrease of \$400.00 If this amount was available, the appropriation of the City Health Board would not now be exhausted. The Board did not contemplate at the first of the year fitting up a place for the examination of milk. This has since been done and although the cost has been reasonable, the amount of \$200.00 was inadequate compared with what has been provided.

For that amount practically all the necessary machinary has been installed, but there are no further funds to carry on the work. The contract for putting in the plumbing at the City Market for milk examination totalled \$110.00 and an extra amount of \$6.00 was required for connecting up and providing material for a gas meter. Supplies had to be purchased such as a babcock testing machine, \$68.00 sediment discs, acid stands, seals for milk tins, thermometers, glass bottles and other equipment used in the examination of milk. All this material has been purchased as ordered by the Board, the total cost running about \$350.00

Our appropriation for advertising was only \$100.00 and this item was used up within six weeks after the Civic Year started. The amount was far insufficient to meet statutory requirements for advertising purposes such as publication of amendments to the milk regulations, notices to fish and milk vendors, proprietors of restaurants and shops to obtain their permits in addition to Official notices for clean- up week.

Unless an additional appropriation is granted by the City Council, no further orders for the City Health Board can be issued as there will be no appropriation to cover them. In order that the examination of milk and other necessary work can be carried out it will be necessary to ask the Council to authorize the Board to make a further expenditure under Section 976 of the Acts of 1924, and I would recommend that the City Council be asked to authorize the Board to spend a further amount not exceeding \$500.00. About one half of the amount of this year's appropriation totalling \$50.00, was spent for permanent work which will last easily, without practically any replacements, for ten It will also be necessary to ask the City Council years. to authorize a further appropriation of at least \$200.00 to cover the cost of making repairs at the Isolation Hospital in agreement with the report of the Building Inspector and if a further amount is necessary, say from \$50.00 to \$100.00 it can be taken out of the appropriation already available. This work, as the Board knows, must be done right away so as to make the building reasonably suitable for patients during the winter months and also to protect the building from further damage due to leaks.

Gentlemen:-

As instructed by you I wish to further report on the lavatory accommodation at Joseph Howe School.

In company with Mr. H.W. Johnston, City Engineer, we visited thisschool on April 10th, and went very thoroughly into the situation and we both are agreed that, while the scheme as originally proposed would be no doubt the most satisfactory from every standpoint, except that of cost, conditions could be greatly improved at the present time by building one addition only for the girls lavatory as planned and enlarge and remodel the present basement lavatory in the south west corner for the boys lavatory. This we estimate would mean a saving of from twenty-five hundred to three thousand dollars over the lowest estimate already submitted to build and equip the two lavatory additions as at first proposed.

To carry on the above, the south west lavatory would require to be enlarged by taking in part of the present coal cellar, enlarging the windows in same and finishing this lavatory in all respects similaryly to the new addition; that is, to cover the floor with one inch of asphalt, tile the walls to a heaght of 5' 6" and finish the balance of walls and ceiling in cement, plasters painted, three coats. The present toilet bowls could be reused as far as found fit. The urinals to be of the stall type in white porcelain. The present

lavatories, three in number, under the main building could then be dispensed with.

Sirs:-

On the 2nd of August last, our Cashier was \$95.70 (Ninety-Eight and 70/100 Dollars) short in her cash. We were in hopes that the error would eventually turn up but there seems no probability of this happening now. The books and vouchers were all carefully checked at the time. Instances where cheques are received in payment of taxes, the amount of the cheque is marked upon the receipt, all cheques received that day, for which receipts were given , were accounted for, there was very little actual cash handled and very little changing done, so that the occurrence is a complete mystery to us.

I do not believe the money was stolen; the Cashier's desk is, of course, open and unprotected except a rather antiquated wooden lattice between her and the public. While this is the first occurrence of its kind since I took over the Collectorship, I think we should have installed a regular Teller's cage such as is used by the Banks, this should preclude the probability of similar occurrences. The lack of a Teller's cage is obvious to any one looking the situation over, the matter has been discussed at various times but owing to lack of room definite action has/been I think a cage should be installed at once, and taken. so recommend The custom, I believe generally followed by Banks is, that the Teller is responsible for all shortages and must make them good. He is, of course, protected by the safeguard of an enclosed wire cage so constructed that it is practically impossible for any cash or vouchers to be removed therefrom while he is in Compensation for losses suffered is frequently charge. made in various ways such as, additional increases in salary, bonuses, etc. In a private business I believe losses of this nature are charged to profit and loss, in any case, I think it would be unjust to hold Miss King

responsible for this loss, because I am perfectly satisfied in my own mind that she did not take the money, she is capable and efficient, makes very few mistakes, which are of a minor nature when they do occur, she has handled millions of dollars, and further, I do not believe any one in the Office took it.

I am sorry I am unable to throw any further light on the matter, and would recommend that it be provided for by the Auditor.

There are portions of two streets where the asphalt pavement laid about twenty years ago are in such a bad state of repair as to be practically incapable of being economically patched and require resurfacing. I refer to the east side of Barrington Street between Gray Street and Cornwallis Street, and Hollis Street between Duke and Water Streets.

The contractor for the Robie Street paving has finished work on that street, and while his plant and organization are available it would appear to be a favourable opportunity to do the work.

The area required to be done is about 1200 square yards on Barrington Street and 700 on Hollis Street.

The tender price of Stephen Bros., for surfacing alone was \$2.30 per square yard, after consultation with your Committee they agree to tear up and remove the old surface and resurface in accordance with our specifications for \$2.60 per yard.

There is not more than \$3,000 available in the street appropriation for this work.

We have a fund of over \$7,000 which was paid by the Canadian Bituminous Paving Company in lien of their being required to repair pavements laid by them at the end of the guarantee period of their contract. It would seem to be good policy to take the balance required for the present renewals from this fund and when the guaranteed pavements have to be repaired the cost of the work may be taken from the street appropriation for next year.

If this is done, I would recommend that a contract be made with Stephen Bros., for resurfacing the two streets, with a proviso in the specification that the contract may be concelled if and whenever the weather proves unfavourable to completing the work.

A notice was sent on the 25th of June 1926, and the premises were inspected on the 22nd Sept., The Inspector reports that he found a w.c. wasting in the upper flat and the tenant stated that this W.C. wasted for over a year and no repairs had been made. The fittings in the lower flat were in good condition at the time of the inspection, but this tenant stated that the pipe was leaking in the cellar and has been repaired. There is water dropping from the pipe in one place at the present time. This pipe is sagged and hanging from the ceiling of the cellar.

A previous reduction was asked for in March 1926, but was refused.

Under these conditions and since the water actually passed through the meter and was either used or wasted on the premises, I cannot recommend a reduction.
