Dear Sir:-

I understand that there is a meeting of the City Council this evening to consider, amongst other things, the question of leasing the City abattoir. I have made an offer for the abattoir of \$75.00 per month, and I understand that the person who is competing against me has offered \$55.00, and that the Board of Works are recommending to the City Council that the lease be given to him for the reason that I have failed to disclose the purpose for which I desire to use this building.

I may say that at the present time I regret it is impossible for me to state the purpose for which I wish the Abattoir. At the same time I can assure you and the members of the Council that I do not wish to use it for any objectionable purpose and that I am willing to have a clause inserted in the lease from the City to myself that the Abattoir shall not be used by me for any purpose which does not meet with the approval of the City Council. I do not think that I could make a fairer proposition than that to the City, and with that clause inserted in the lease I cannot see that it makes any difference to the City at this stage for what purpose I intend to use the building.

I could not reasonable have any complaint to make or feel that I was being treated unfairly if my competitor offered more for the building than I am prepared to give. On the other hand, I certainly feel that it is most unfair treatment to lease this building to another party for \$20.00 less per month than I am prepared to pay. Should my competitor go above my offer I shall certainly have nothing to say, but it seems to me that, especially with the clause inserted in the lease which I have peferred to above, the City will be discriminating against me unjustly if they lease this building to Mr. Kendall as the matter stands at present.

## INVESTIGATION CITY COLLECTORS OFFICE

Read report of Special Committee appointed to investigate all matters relating to the Collection of Taxes, the accounting thereof and the duties of employees in the City Collector's Department:-

RESOLVED that a Special Committee of "Council, consisting of Alderman Shannon "and McCarthy, together with the City "Auditor, be appointed with power to "investigate all matters relating to the "collection of taxes, the accounting there-"of and the duties of employees in the "Collector's Department, and report thereon "to Council at as early a date as possible"

Pursuant t such resolution the Special Committee has held eight sessions and interrogated the City Solicitor, the City Assessor, the City Collector, and certain members of the Staff, as well as looking into the manner in which the accounts are handled in the City Collector's Office.

It would appear from investigation that the foundation of the City taxes is laid in the Assessors Department where the Rolls are prepared for the City Collector's Office. These Rolls are made up from the Assessors books where entries are made by the Assessors from their daily inspection of properties, such assessments commence in May and end by December 31st for the ensuing year beginning May 1st. After these Rolls are completed and the total arrived at for assessment purposes, the Assessor has to wait until Council passes the Estimates before he can compute the rate to be assessed for the ensuing year. If Council delays the passing of Estimates until the latter part of March it is impossible for the Assessor to fix the rate and make out all the bills for taxes until some time afterwards, so it is imperative that the estimates should be prepared by the various Departments by December 31st, and that Council passes same not later than the end of January in order that all bills shall be sent out to the taxpayers by the let of June as provided for in the City Charter-

> "Notices of Assessment valuation are sent out by the Assessor as soon after December 31st as possible in order that any appeal may be brought before the Tax Appeal Court which meets on January 20th, and holds Court for one month"

After the Court has finished its duties and reported any changes allowed to the Assessor, the Rolls are prepared and are supposed to be forwarded to the Collector early in June, but it appears that this year they were not forwarded until the middle of August- but the Assessor informs us that the reason for the lateness was owing to the preparation of an index.

It will be noticed that the bills are sent out by the Assessor and as the taxpayer has until July 31st to pay in order to obtain the discount, no great rush of payments would take place until towards the end of that month, but that if the Rolls were in the Collectors hands by the 1st of June, work could be commenced on entering them on cards prior to such rush.

It will be remembered that an investigation was held by Price, Waterhouse & Company into the financial position of the City; to do so, they commenced with the financial year 1908-1909 and worked up from that year so that they completed 16 books, one for eachyear, containing arrears of taxes, and in addition two books of betterment charges, - but they did not instal any system for the collection of arrears for the reason that the City did not instruct them to do so.

Subsequently, they were instructed to instal a modern system, but before they reached the Collector's Office, their services were dispensed with by the City on adcount of cost, so that the only system in the Collector's Office that they had anything to do with was the cash book and form of receipt. Upon interrogating the Collector it was found that he had been in that capacity for three years and he claims that his great difficulty has been to ascertain the amount of arrears due by the individual taxpayer, he also admitted that it would be quite possible for a taxpayer to call at his office and they would be unable to tell him the amount of taxes due, owing to the records not being up to date.

The public should clearly understand that Price, Waterhouse & Company did not prepare and instal a system for collection of taxes or the consolidation of the amounts due, this knowledge is essential in order to properly understand the difficulties under which the Collector laboured. To our mind, it is rather remarkable that the City Collector, after three years in charge of the work, has not succeeded in consolidating practically all accounts due.

In explanation the Collector states that he repeatedly asked for an increase of Staff, but instead of receiving more help he had his staff reduced. He first endeavoured to write up individual accounts in ledgers, giving names and amounts due from 1908 up to date; his idea being to have a complete record in alphabetical order. In reply to a question he informed us that he could form no idea as to how long it would have taken to complete this work, and while this work was being done, no statements could be prepared, showing taxes due by an individual.

In the Spring of 1925, after consulting the City Auditor, and largely on his recommendation, a card system was inaugurated, owrking on the basis of properties for real estate and of names for personal taxes- this meant practically abandoning the previous scheme of writing up the ledgers. This change was agreed to by the Finance Committee after discussion. This card system was all written up with the exception of betterment charges, and the posting of the cash received during the time the cards were being written up which has since been added to a point but is still in arrears- these omissions making the cards very unsatisfactory for a complete record.

Since the reduction of Staff, this work, which is absolutely necessary in order that a proper system of knowing exactly what each taxpayer owes, has not been continued. We would most earnestly point out to the members of the City Council that any business man or corporation has a ledger for accounts receivable whereby they can at any time ascertain what any debtor may owe them and how vitally important it is that the City should be in a similar position.

It is estimated that had not the Staff been decreased in February last, that by this time the consolidation of the accounts would be completed.

Your Committee feel, in view of the foregoing, that a great effort should be made to bring this card system of consolidation of accounts up to date quickly and would recommend that instead of any additional staff being granted that certain members of the Staff to be chosen by Mr. Morrow, Chief Tax Adjuster be paid at the rate of 50 cents an hour for overtime during the next three months, it being estimated by us that by doing this, the expense would not exceed \$500.00 and the results in the way of getting the cards posted up to date, will make it possible to get out statements quickly and expedite the collection of arrears.

In the course of our investigation into the Staff we found that Miss Hopewell is known as Chief Clrk, having been so appointed, but that she does not assume the responsibility for supervising the other Clerks in the Office, as would naturally be called for by the title given her. Upon questioning the City Collector, he informed us that he did not consider Miss Hopewell capable of assuming the responsibility to supervise, check up, or to be responsible for the efficient work of the Office. He further stated that there was no person under him whom he could hold responsible for the general efficiency of his staff and that in his opinion the staff did not require supervision of this nature

He assured the Committee that every member of his office staff and the sub-sollectors on the street were efficient and satisfactory in every respect

<u>Nov.25th</u>, 1926

The City Collector makes no suggestion or recommendations towards improvements, no criticism of his staff, as a whole, and assures us that there is only one course to pursue in his opinion, and that is to give him more clerks in his office, in order to hasten the consolidation of the tax accounts. He recommends that several additional clerks be procured and that a total of at least six outside collectors, or one for each ward, are necessary and that twelve would be better.

It would appear to your Committee, considering the territory covered by the City of Halifax that one sub-collector to each Ward is not excessive, and that it would be in the interest of the City in order that better collections of arrears can be had that an increase of two sub-collectors to the outside staff should be approved by Council and they would so accordingly recommend.

Your Committee spent some time in the Collector's Office, in an endeavour to obtain a sufficient knowledge of the methods adopted to carry on the work to enable them to intelligently understand same, and to acquire the necessary information as to what each individual clerk was doing, and as to how the office is being conducted with a view of making recommendations for a greater general efficiency, have asked many questions and received much information which it is impossible to embody in this report.

We wish to Stress the fact that we have been most courteously received by the City Collector, and much appreciate the patience with which he listened to our many questions, and his earnest endeavour to place before us all particulars of the situation as he sees it. He has our sympathy as we believe he has done his best to handle a most difficult and trying problem. However, we are not convinced that everything has been done that might have been done, either as regards the system adopted or the efficient carrying out of same and we feel that our Oath of Office as well as our duty to the citizens of Halifax, force us to speak frankly and fearlessly even at the expense of our personal feelings

We feel that the Collector found on his taking office a lamentable condition of affairs and that his first duty was to endeavour to correct matters. It would appear that he endeavoured to do so, but he considered that the panacea was more staff, and when he was repeatedly refused same, became discouraged and the position became distastefull as well as onerous.

Your Committee not being able to obtain any constructive or agreesive suggestions from the Collector, other than the staff being increased, called for Mr. Morrow the Chief Tax Adjuster. We had a lengthy interview with him and it was refreshing to obtain from him much

valuable information . We were much impressed with his cheerfulness, optimism and his very earnest desire to give halpful suggestions to the Committee, although not one word of criticism was made by him regarding his superior officer. In our opinion the City has in Mr. Morrow a young man of exceptional ability.

Mr.Morrow was particular in his views about the increase of staff and pointed out by certain alterations in the outside room, it would be possible to obtain better supervision of the staff which would tend to a greater efficiency, and that there was no necessity to add to the staff of the Office. We found a bright young man of 24 years of age named R.J. Campbell doing a good class of work, but only receiving a salary of \$600.00 per annum not a living wage at the present rate of pay. We were informed by all his superiors that he is bright and capable of greater responsibilities than he now has. We recommend that his salary be increased to \$900.00. We do not recommend any addition to the inside staff but that the staff be kept up to their same strength for the present.

The Committee attach herewith a proposed plan of the outside office and placing of the Olerks, which we believe will, if adopted, be of advantage. You will note that we advise the removing of a partition and the opening up of the whole office in such a manner as to have all clerks in plain view of the Chief Clerk, this in the Committee's opinion is very important.

Without going into details, we are of opinion from information received that it is most important the staff in the City Collector's Office be placed under careful supervision, that care be taken that there is neither time wasted by idling, by duplication of work or in any other manner, and the staff be imbued with possibly greater sense of loyalty to their employer, the City of Halifax, and finally that they must be given to understand that the present situation requires the very best effort on the part of every individual clerk with greater concentration on the work before them, and less on the clock.

The foregoing is submitted for your careful consideration, for if our report is adopted and carried out, we have every confidence that a decided improvement in the whole organization will be the result and should mean an almost immediate increase of collections.

Your Committee desires to express their great appreciation of the assistance they have received from Alderman Weston, Chairman of the Finance Committee, who has attended all their meetings and by his thoughtful advice and suggestions, has been a great help to them.

Your Committee suggests, at the risk of being considered presumptuous, that the Finance Committee either as a whole or by appointment of a subcommittee, keep in close touch with the work of the Collector's Office, both as an encouragement to the City Collector and for their own edification.

Your Committee, after due deliberation, beg to make the following recommendations.

1. That Mr. Morrow be appointed Chief Clerk to be responsible for the supervision of the Staff under the Collector.

2. That Mr. Morrow select certain members of the Staff to be employed after hours to complete the necessary work to the cards, said staff to be remunerated at the rate of 50 cents an hour and that the total amount so to be paid shall not exceed \$500.00

3. That the salary of Mr. R.J. Gampbell be increased from \$600.00 to \$900.00 per annum

4. That Mr. Traise ,Sub-Collector, 84 years of age and who is showing signs of his great age, be superannuated.

5. That in addition to the four subcollectors now employed, two additional sub-collectors be appointed.

6. That the staff be re-organized and placed under strict supervision.

7. That the partition in the Collector's outside office be removed, the Cabhier's desk and cage moved to the southwest corner of the room as per plan attached.

That in the preparation of the

8.

estimates for next year due consideration of the salary of each Clerk in the Collector's Office be given in order that sale may be adjusted in commensurate with the services rendered

9. That the present Cahier when not employed in that capacity shall be given other work to perform.

10. That the appointment of the present bailiff be approved by the City Council, and that the Collector be empowered to appoint additional bailiffs if found necessary. The same to be paid by fees only collectible from the delinquent taxpayers.

## EXPROPRIATION MORASH PROPERTY

#### Sir:-

In compliance with the resolution of the Committee on Works passed at their meeting held on the 17th of November 1926, that steps be taken to expropriate the Morash Property, so called on Kempt Road, I beg to report that if it is the intention to continue and extend the present City Dump in the vicinity of the property, it would seem to be necessary

that some steps be taken to prevent further claims from the owners of this property. I am informed by the City Solicitor that at the conclusion of the recent trail, the learned Judge intimated to the Council engaged the desirability of some amicable adjustment or settlement being made. In view of these circumstances there would appear to be two courses open to the City, one, the obtaining of the whole of the Morash Property and the other the confining to the acquisition by the City to the water rights on the brook through the property. The former course would probably be the more expensive in the first instance, but it would forever extinguish all claims in respect to that property and the expense might be reduced by some revenues from the property.

By following the second course there would always remain the possibility that claims might be made for the pollution of the well due to seepage or percolation between the Morash property and the dumpt and from the other causes in connection with the use of the dump, which in the end may be troublesome and ultimately compel the expropriation of the whole property.

Unless it is decided that the dump shall be contined and extended in its present location, it is difficult to arrive at any settled policy. If it is such intention, it will be necessar to come to some determination in respect to the Farrell and Hendry properties lying between the Morash property and the Sullivan property.

For the information of the Committee the following brief resume of the conditions formerly existing in the brook and the steps then proposed for their remedy are given.

W hen the Railway Roundhouse and Repair shop were erected at the so called Willow Park site, the drainage from the various plumbing fixtures in these buildings, together with the surface water, was collected into a tank and discharged through a sewer across Kempt Road into the open brook flowing through the Sullivan, Hendry, Farrell and Morash properties. It was evidently realized at the time by the Railway authorities that the book would become polluted and a strip of land fifteen feet wide was acquired by them in 1907 or 1908, including the brook within the boundaries of the land through the Hendry and what is now the Sullivan Property, for the purpose of extinguishing the rights of these properties to the brook and for a right of way for an extension of the sewer.

In 1913 Mr. Gutelius the General Manager of the Government Railways wrote the City that additional drainage would be required for the engine house and Machine shop and suggested that the City build a sewer in such a way that the property could be connected to it and that the

-447-

Railways would make a contribution towards it, equal to the cost of the independent sewer which would have to be built by them. As there was no immediate prospect for an early demand for a public sewer in the district, the City Council at a meeting held on the 13th of May, 1914, decided not to accept the offer. during this and the following year, there was further correspondence and reports on the matter, culminating in a letter from Mr. Gutelius stating that his appropriation for the sewer was \$15,000 and that he was satisfied he could construct it for this amount and asked permission to build it as a private sewer on the streets shewn.

In October 1916 the then Mayor reported to the Board of Control that he had conferred with Mr. Gutelius in respect to the Sewer from the Willow Park Yard to Bedford Basin and that the latter had promised to have the appropriation included in the estimates for this work.

In 1917 a letter was sent to the then General Manager, Mr. Hayes, asking when action was contemplated to relieve the nuisance caused by the discharge of the sewerage into the open brook. A reply was received that no provision had been made in the estimates of that fiscal year for the construction of the sewer and that due to the financial conditions existing it was doubtful if the work could then be undertaken, especially in view of the difficulty in obtaining men and material.

Further complaints were made as to the condition of the Brook and a report was made to the Board of Control in 1918 recommending that the Railway Department be urged to construct the sewer

No further action was taken by the Railways and the matter was agains taken up by correspondence during the past year with unsatisfactory results, the attitude of the Department being now apparently that owing to the presence of the City dump the water is fouled more by it than by the drainage from the Round house and that if any damage is being suffered by citizens, the sewer should be constructed by the City as an ordinary City sewer.

In view of what has taken place and the repeated assurances from the manager that this sewer would be built, it is hard to understand this volte-face.

It is evident from the records that originally the Railway department recognized its res ponsibility of taking care of the polluted water discharged into the brook from its premises. From recent analyses of the water taken before it reaches the dump the pollution still exists. Assuming but not admitting) that by reason of the use of the dump,

the pollution still exists. Assuming ( but not admitting) that by reason of the use of the dump, more polluting matter is added to the stream, this would not appear to be sufficient reason for justifying the department in repudiating its liability previously acknowledged, to dispose of in a sanitary manner, the polluted water discharged by them into the brook to the danger of those who inadvertendly use it.

Before any money is expended by the City in the matter it is strongly recommended that the Railway authorities be approached and urged to carry out their original expressed intention of building the sewer; or in the alternative to contribute their share of the cost of remedying conditions.

If however, the Committee after hearing the legal aspect of the case from the City Solicitor, is of the opinion that something will have to be done immediately in connection with the Morash Property, for the reasons given it would seem to be more in the interest of the City to expropriate the whole property rather than the rights to the brook only, always assuming that the dump will be continued on the present site and on the properties between it and the Morash Lot.

I am attaching a plan and description of the property and also a form of resolution drafted by the City Solicitor to be passed by the Committee, if it is decided to go on with the expropriation.
