LEGISLATION RE INTEREST ON TAXES

Read report of the Finance Committee recommending that the City Solicitor be instructed to prepare legislation changing the date for the payment of interest on unpaid taxes in any year from October 1st to September 1st:

Treasure

You will remember that Legislation was obtained at the last session of the Legislature substantially changing the method of collecting taxes -318-

Commencing with the Civic Year May 1st, 1929, taxes will be payable in two installments. The first payable in May and the second payable in August. The Chief purpose of the plan was to advance the time when the City would first receive funds on accounts of taxes. In the original plan as it came before Council interest was to become effective at the rate of 7% on September 1st., of the Current Civic Year. When the matter of interest was discussed in Council Aldermen O'Toole moved, and without discussion it was decided to make the date on which interest would commence October 1st, the same as it is at present.

Council evidently lost sight of the fact that the object of the plan was to move ahead the time when the City would receive its taxes, and to have altered the interest clause was to defeat the particular purpose in view . There is no logic in a free period during which interest is not charged. That is a part of the present system and as it is well known the present system is obsolete by comparison with methods in vogue in other Canadian Cities.

Chapter 60 of the Acts of 1928, Section 24, Sub-Section 436A (2) reads " On all other amounts for rates or taxes remaining unpaid on the 1st of October interest shall be charged thereafter at the rate aforesaid" The rate of interest referred to in the preceding paragraph is 7%. I would recommend that the legislation be obtained so that interest will commence on September 1st, immediately following the last day on which the second installment may be paid with discount.

PENALTY

You will recall that it was a part of the plan to charge a penalty on taxes unpaid on February 1st of the current civic year. The rate suggested was 3%. Council would not entertain this provision, and it has been suggested that there is also little chance of obtaining the approval of the Legislature to make it law.

However, I am bringing the matter to your attention feeling that you may want to discuss it now. The penalty certainly has its merits! It is one of the chief factors in the collection of taxes in other Cities, and it has been largely adopted throughout in Canada.

If it is out of the question to obtain the necessary legislation to enforce a penalty then in lieu of this step should be taken to obtain legislation to reduce the present three year lien to a two year lien. This would give the Collector an opportunity to use his lien .a full year before he can now do so. It is true that he has the remedy at any time to sue the taxpayer, but to sue taxpayers by the hundreds would tend to create a chaotic condition in his office, Moreover, it has been found that the lien is a far more effective way of getting taxpayers to attend to their obligations than the warrant. The question of reducing the three year lien to a two year lien has been discussed for some time, and the consensus of opinion was and is that the more businesslike method to follow is to have a two year lien.

PROVINCIAL EXHIBITION-STATEMENT 1928

Eead report of the City Auditor cover-

ing audit and annual statement of the Provincial

Exhibition Commission:

City Auditor's Office, December 5th, 1928.

The Chairman and Members Provincial Exhibition Commission, Halifax, N.S. and His Worship the Mayor and Members of City Council.

Gentlemen:-

Pursuant to the provisions of the Halifax City Charter and the By-Laws of the Provincial Exhibition Commission I have audited the books and accounts of the Commission for the year ending October 31st 1928, and submit herewith statements of Revenue and Expenditure, and assets and liabilities.

PLANT AND EQUIPMENT ETC.

Plant and equipment acquired to date represents a cost of \$459,326.34. Advances by the Province and City for re-establishment purposes, and for the construction of an artificial ice plant amount to \$435,000.00 Capital account has therefore been over-expended a gross amount of \$24,326.34, and affer applying the earned surplus for the financial year, namely \$23,177.55, the over-expenditure amounts to \$1,148.79, There is accordingly an insufficiency of cash of \$1,148,79 to meet current liabilities.

SEWERAGE

I wish to direct your attention to an account due the City of Halifax for sewerage amounting to \$5,863.76. It was at my direction that this liability was taken on the books. Details of the accounts follows:

The Almon Street sewer was constructed in 1907, and the Engineer's return filed March 26, 1908. It is an undecided question whether betterment charges constitute a perpetual lien, whether the lien runs out in twenty years from the date when the first installment is payable, or whether the installments outlaw according to their respective maturities, but assuming the Commission may be liable for the whole debt I have shown it as such in the statement in order that the matter will be settled forthwith. I would recommend that the Members of the Commission interest themselves to obtain an early adjustment of this account

INTEREST AND SINKING FUND ON COST OF ARTIFICIAL ICE PLANT

Under a resolution of the Halifax Oity Council passed at the time of borrowing the sum of \$17,500.00 for 50% of the construction of an artificial ice plant for the Forum it was stipulated that interest and sinking fund not to exceed 7% of the amount must be paid to the City annually. The Commission agreed to this. With this restrictive rate it will be necessary for the Commission to pay this charge for approximately twenty-eight years. This I understand far exceeds the life of the plant, and I would suggest the Commission consider the question of agreeing to pay such a rate as would pay off the cost of the plant in fifteen years.

As no doubt the Provincial Government will exact similar terms in connection with its advance for its share of the ice plant I have set up a reserve to pay the Government 7% for interest and sinking fund onits loan.

SURPLUS

Surplus from operations amounts to \$23,177.55 as shown in the statement of Revenue and Expenditure. As mentioned above this surplus has been wholly spent on Capital account. When discussing surplus it should not be overlooked that the Commission is enjoying the free use of \$400,000.00, capital which represents at 4.50% for interest and, 1,36% for sinking fund, an amount of \$23,440,00 annually.

CASH OVERAGE

An amount of \$236.09 has been placed in a suspense account representing a cash overage on account of revenue for the year. It is impossible to trace this item to the point of origin as the cash received record lacks the ordinary detail which should be shown with all cash receipts.

CONTROL OF DISBURSEMENTS

In the case of the majority of payments the voucher is not signed by the Chairman of the Committee concerned. If it is not always convenient for the Chairman of the Committee to sign then the Chairman or Vice-Chairman of the Commission should sign in his absence. The voucher form indicates the necessity for the signature, and I think it should be obtained in every case. If a proper control of disbursements is not maintained by Chairmen of the various committees it imposes an extra responsibility on the audit staff.

ADMISSIONS

I am unable to certify to the returns for admissions as the information in the record fails to show full details of the unsold tickets in a number of rolls. All tickets sold and collected, and all tickets unsold have been destroyed, and because of this circumstance no check can be made. A complete record of the number of tickets printed, and all tickets sold or unsold should be retained until an opportunity to inspect them has been given.

BONDS FOR EMPLOYEES

I would recommend that such employees of the Commission whose duties require them to account for the revenues of the Commission be bonded for amounts consistent with their responsibilities.

TAXATION CANADIAN WATIONAL RAILWAY HOTEL

Read report of the Special

Committee appointed at a meeting of this Gouncil on the 15th November last to enquire into the question of taxation of thenew hotel now being constructed by the Canadian National Railway,

Halifax, N.S. Dec.13th, 1928

His Worship the Mayor, and Members of City Council.

Gentlemen:-

Council at its meeting held on the 15th of November appointed a Special Committee consisting of Aldermen Shannon, McCarthy and Cragg to go into the question of the taxation of the new hotel being constructed by the Canadian National Railways. Your Committee held a special meeting to consider the question, and it was decided that a dèlegation consisting of Aldermen Shannon and Cragg, together with the City Solicitor go to Montreal to interview the Railway authorities. The City Solicitor being sick was unable to go to Montreal so your Committee substituted the City Auditor for the City Solicitor.

The delegation went to Montreal on December 6th, and on the 7th inst., tmet the senior Vice President, who is also a member of the Board of Directors of the National Railways.

They had a very interesting and instructive meeting with Mr.Ruel and after going into the matter thoroughly with him the Chairman of the Special Committee wrote the following letter to Mr. Ruel.

Montreal, Dec. 7th, 1928

Gerard Ruel, Esq.,K.C., Vice-President, Canadian National Railways, Montreal, Que.

Dear Sir:-

With reference to cur conversation to-day with the delegates of the City of Halifax in connection with the proposed assessment of "The Nova Scotia" hotel, it is suggested by such delegation that the basis of taxation of the hotel should be the same as they which has been arranged with the Lord Nelson Hotel Company namely, at the rate of \$1,262.00 per room, in addition to the business tax of 50% of the taxation on the hotel, less the shops which are rented by the Lord Nelson, and which shops will pay their proportion of such business tax for a period of ten years,

I will be glad if you could see your way clear to recommend to your Board of Directors and to the Government of Canada that this proposition, which to my mind is a fair proposition considering that the "Nova Scotia" hotel will be in competition with the "Lord Nelson hotel and other privately owned hotels which pay taxes in the City of Halifax and should be accepted.

For the information of Council it may be stated that the question of taxation comes under the direction of the Legal Department of the Railways, of which Mr.Ruel is the head, and his recommendation to the Board carries with it his influence as the responsible head of that Department, as well as his influence as a Director of the Company, and he was prepared to justify his recommendation to the Board as being fair and reasonable and we therefore have reason to believe that at the next meeting of the Board his recommendation willbe authorized.

Your delegation then discussed the subject of receiving a proportion of the amount paid annually by the Railway to the Province of Nova Soctia. The Ganadian National Railways with the object of arranging an equitable basis of taxation had offered to pay an additional amount on account of taxes of \$250,000.00 annually to be shared by all the Provinces. When the plan to put the tax payments on an equitable basis was suggested to the representatives of the Provinces some of them seeing in this redistribution a loss of taxation decided they would prefer to allow the present basis to stand.

At this conference, however, they agreed to allow the Maritime Provinces to receive and divide the extra tax to be paid. The representatives of the Maritimes immediately seized this opportunity to improve the Provincial Finances without regard to Municipal claims. Accordingly the amount of \$250,000.00 was allocated to the Maritime Provinces, and the division was left in the hands of the representatives of these Provinces with the result that Nova Scotia receives \$91,000.00, New Brunswick \$112,000.00 and Prince Edward Island \$47,000.00 in payment of all Provincial and Municipal Taxes. The reason the words 2Municipal Taxes" are used in the order-in-council is to prevent Municipalities coming back and asking the Canadian National Railways for a share of the taxes,

The delegation was also informed that the Canadian National Railways is simply a company formed to manage and operate the Grand Trunk Railway, the Canadian Northern Railway, Canadian Government Railways which includes the Intercolonial Railway, and numercus other lines which have been taken over by the Government of Canada, the entities of which have been maintained. In other words the Canadian National Railways system does not own any of the lines which it operates; this is the reason that the Grand Trunk and Canadian Northern Systems are paying taxes to the Provinces and Municipalities where they are located, because as stated their identities have been mtaintained. The reason for this lies in the fact that some of these lines, particularly the Intercolonial Railway was and is Crown property, and therefore, not liable to taxation.

The financial condition of the systems operated by the Canadian National Railways is rapidly improving and it was suggested to us that it is the intention of the Government to reorganize the various lines now operated into one big national system taking in all the companies now operated by the Canadian National Railways. When this condition comes about the property of the Intercolenial Railways now vested in the Crown will be vested in the Canadian National Railways and be liable for taxation.
