In my opinion it is advisable to replace the present wooden structure with a permanent one, and to do so will require that authority be obtained to borrow a sum not exceeding \$2,000.00 for the purpose.

- LEGISLATION -

The City Solicitor submits Draft of the Legislation prepared under instructions from the Council and the various Committees.

By unanimous consent the legislation is considered clause by clause and the various clauses as submitted with several slight amendments are approved and adopted.

- AN ACT TO AMEND THE LAW RELATING TO THE - CITY OF HALIFAX.

BE IT ENACTED by the Governor, and Assembly as follows:-

1. In this Act the expression "City" means the City of Halifax, the expression "Council" means the City Council of that City, and any committee or official herein mentioned by name means the committee or official of that name of the said Council or City; the expression "Charter" means the Halifax City Charter of 1907 or the Halifax City Charter of 1914, and any amendments thereto according to the sections of those Charters respectively as now in force under and by virtue of Chapters 79 and 80 of the Acts of 1919 and sections referred to by numbers without any reference are the sections of the said Charters, or any amendments thereto now in force under the said Chapters 79 and 80 of the Acts of 1919 and this Act shall relate exclusively to the City of Halifax.

2. The Board for the Adjustment of Tax Arrears constituted by Section 10 of Chapter 83 of the Acts of 1925 is hereby continued for a further period of one year from the date hereof.

3. Section 2 of Chapter 63 of the Acts of 1928 is hereby amended by striking out the figures 1929-30 in the fourth line thereof and substituting therefor the figures 1930-31 and by striking out the figures 1929 in the fifth line thereof and substituting therefor the figures 1930.

4. The payment of his salary to Police Constable Howard Smith while absent from duty on account of illness is hereby ratified notwithstanding such payment was for a period of more than two months.

5. Sub-section (2) of Section 436A as substituted by Section 24 of Chapter 60 of the Acts of 1928 is amended by striking out the word "October" therefrom and substituting the word "September",

6. (1)Sub-section (6) of Section 18 of Chapter 46 of the Acts of 1915 is hereby amended by striking out the words "Board of Control" in the last line thereof and substituting the words "Council on the recommendation of the Committee on Works".

(2)Any permit granted by the Committee on Works previous to the 10th day of December 1928 purporting to be under the authority of the said sub-section is hereby ratified and confirmed.

(1) When any property of the Housing Commission 7. of the City of Halifax, in this section referred to as the Commission, is sold, the Commission shall out of any moneys received for such sale appropriate as a first charge thereon an amount sufficient to pay any sums due to the City for taxes, water rates or betterment charges rated or imposed in respect to such property with interest, and shall pay the amount so appropriated to the Collector in discharge of such indebtedness. The Commission shall also out of such moneys reimburse itself for any sums due for premiums of insurance, or other charges paid or incurred by the Commission. The balance of such moneys shall be disposed of by the Commission in accordance with the provisions of Section 29, Sub-section (2) of the Nova Scotia Housing Act 1919. Neither the purchaser nor the Commission shall have any right to make any appro-priation of such money or any part thereof contrary to the foregoing provision.

(2) In any case in which a property is offered for sale by the Commission after repossession thereof by the Commission no sale or agreement for sale shall be entered into which does not require an initial payment by the purchaser of the property of an amount sufficient to pay the City any sums due the City for taxes, water rates and betterment charges with interest, except the City Collector signifies his assent in writing to the said payment, with interest thereon at the rate of 7% per annum, being deferred for a period not exceeding one year.

(3) In any case in which a property which has been sold by the Commission after repossession thereof by the Commission, and in respect to which taxes, water rates or any betterment charge due by the person to whom such property was first sold is in arrears, the Collector may write off the same as uncollectible.

(4) In respect to any property owned by the Commission and thereafter rented the Commission shall out of the monies received for rentals pay to the Collector by instalments of not less than two-thirds of the money so received on account of arrears of taxes including interest levied or imposed in respect to such property, since the civic year

1924-25, and for arrears of water rates and betterment charges kevied or imposed at any time, including all interest thereon. Any tax not including any water rate or betterment charge, levied or imposed previous to May 1st, 1925, shall be written off by the Collector as uncollectible.

8. Section 16 of Chapter 79 of the Acts of 1919 is amended by striking out the word "ten" in the first line thereof and substituting the word "fifteen".

9. The City may sell for the best price available any land owned by the City on the west side of Queen Street between Victoria Road and Fenwick Street.

10. Section 37 of Chapter 60 of the Acts of 1928 is hereby repealed and the following section substituted:

37. (1) In the event of the City being itself the purchaser of any land sold for non-payment of taxes the City may, after the period for redemption of the same has expired, sell, lease or otherwise dispose of the same in same way as any other purchaser of the same might do.

(2) Any money derived from the sale, rental or other disposition of any such property shall be applied

(a) to payment of the amount due for taxes and expenses in respect to which the said property was sold, with interest thereon;

(b) to payment of an amount which would have been paid for taxes in respect to the said property if the purchaser thereof had been any person or corporation other than the city.

and any balance remaining from such sale, or from money otherwise derived from such property, shall be applied in reduction of any losses sustained in connection with other properties so purchased by the City.

(3) The Mayor, the Chairman of the Finance Committee, the Engineer, the Collector, the Assessor and one member of the Council appointed by the Council, shall be a committee to dispose of all properties so purchased by the City, and that Committee may without further reference to the Council make on behalf of the City such sale, lease or other disposition of the same as in their judgment is in the best interest of the City.

11. The proceeds derived from the sale of lots in Camp Hill Cemetery shown on Plan 6101, the sale of which was authorized by resolution of the Council passed at a meeting held on the 16th day of August, 1928, shall be invested from time to time as the same are received and the interest on such investment shall be applied solely to the care and maintenance of the fence around that cemetery.

12. No person shall place any tank, pump or other structure or receptacle for the storage or supply of any inflammable oil or other inflammable substance, whether liquid, solid or gasecus in any part of the City without having first obtained a permit therefor from the Council on the recommendation of the Committee on Works.

13. Section 777 is amended by striking out the clause interpreting the word "building" and substituting the following:

The expression "building" includes every structure placed on, over or under any land and every part of the same, and also any external chimney, stairway, porch or other structure used in connection with any building.

14. The clause marked (b) of Sub-section (2) of Section 341 is hereby amended by striking cut the word "forty" and substituting therefor the words "two hundred".

15. Notwithstanding any enactment to the contrary the City may apply any moneys realized by the sale of the engine houses on Isleville Street and Gerrish Street to the purchase of additional apparatus for the Fire Department, and may apply any moneys realized by the sale of horses of the department to reduction of the amount to be raised by taxation for the maintenance of the department for the Civic Year 1929-30.

16. Section 6 of Chapter 60 of the Acts of 1928 is amended by changing the figures 1919 in the fifth line thereof, to 1918, the same having been inserted therein through error.

17. Section 2 of Chapter 65 of the Acts of 1928 is hereby amended by striking out therefrom the words "and such buildings shall conform for external architectural appearance to those destroyed".

18. (1) In any case in which a person is convicted for a contravention of, or failure to comply with, any provision of the Charter, or of any Ordinance or By-law made under the authority thereof, the Court before whom he is convicted may, if it sees fit, instead of sentencing him at once to any punishment, direct that he be released on his entering into a recognizance, with or without sureties and during such period as the Court directs, to appear and receive judgment when called upon, and in the meantime to refrain from a continuance or repetition of the contravention or failure to comply in respect of which he is convicted.

(2) The Court may, if it thinks fit, direct that the offender shall pay the costs of the prosecution or some portion of the same, within such period or by such instalments as the Court decides.

(3) If a Court having power to deal with such offender in respect of his original offence, or any justice of the peace, is satisfied by information on oath that the offender has failed to observe any of the conditions of his recognizance such court or justice may issue a warrant for his apprehension, and on the offender being apprehended may impose on him such punishment as might have been imposed at the original hearing of the case.

19. Section 899 is amended by striking out the first three lines thereof and substituting the follow-ing:-

"The Treasurer shall on the first day of each month pay to the board an instalment of onetwelfth of the amount so specified by the"

20. In respect to the tax assessed upon any person for a business tax or a household tax personal property in the possession of any person shall be deemed to be the property of such person and the lien of the City for such taxes for the year then current shall apply to the same and it may be taken and sold under warrant for the amount of such tax, Any balance at such sale after payment of the said tax and the expenses of advertising and selling shall be paid to such person or to such other person as proves to the satisfaction of the Collector that he is entitled to the same.

21. The Section substituted by Section 32 of Chapter 60 of the Acts of 1928 for Section 380 is hereby repealed, and the following substituted therefor:

380. Every person male or female between the ages of twenty-one and sixty five, who

(a) has been resident in the City for any period of not less than two months continuously, between the first day of January and the first day of August in any year, and

(b) has been in receipt of a salary, remuneration, income during such period of two months at the rate of not less than four hundred dollars, or more than eight hundred dollars yearly, and

(c) who has not been otherwise assessed or rated for the Civic Year then current

shall pay to the City a Poll Tax of Five Dollars;

(2) If the salary, remuneration or income of such person exceeds eight hundred dollars such person shall pay to the City a Poll Tax of Ten Dollars.

(3) Any tax imposed by this Section shall be payable immediately on receipt of a notice to pay the same from the Assessor.

22. Any money received from the Canadian National Railway Corporation in lieu of taxes on property owned by it in the City shall not be placed in the Ganeral Sinking Fund, but shall be applied in reduction of the amount to be raised by taxation for the Civic Year next ensuing that in which the same is received.

23. The Council shall appoint persons to hold the offices of Assistant Clerk, Assistant Treasurer, Assistant Collector and Assistant Building Inspector. Such officers shall respectively discharge the duties of their respective chiefs when the chiefs are not in attendance. Each of such officers shall, except in the case of a casual vacancy, be appointed at the first regular menthly meeting in May in each year, or at any subsequent meeting or meetings of the Council, and shall hold office until the thirtieth of April next succeeding and shall be eligible for re-appointment.

24. The Council may by ordinance regulate the use of the Market on Market Street, the maintenance of the same in good order and condition, and the fees to be paid by persons selling goods or produce therein.

25. The City may apply any part of the amount appropriated in the estimates for 1925-29 for the maintenance of the Anti-Tuberculosis Hospital remaining unspent at the close of that civic year to the discharge of the debt due to the Nova Scotia Hospital for the maintenance therein of Clara Hawkeswell, and any further amount required for that purpose may be borrowed from any bank or fund available and with the interest thereon included in the estimates for 1930-31.

26. In respect to any amount borrowed for a subscription to a War Memorial under the authority of Section 42 of Chapter 60 of the Act of 1928 the first instalment of the repayment of the same shall be made on the first day of August in the Civic Year succeeding that in which the money was borrowed, and succeeding instalments on the first days of August the next succeeding years. The amount for each instalment to be included in the estimates for the year in which it is to be repaid.

27. The City may borrow from any bank or fund available the amounts set out in the first schedule hereto and apply the same to the purposes set opposite each item respectively and the amounts so borrowed with interest thereon shall be included in the estimates for 1930-31.

28. The City may borrow the amounts set out in the second schedule hereto and apply the same to the purposes set opposite to each item respectively. The amounts so borrowed shall be repaid with interest in five yearly instalments, the first to be paid on the first day of August in the civic year next succeeding that in which the money is borrowed, and thereafter on each succeeding first day of August and the amount of each instalment shall be included in the estimates of the year in which it is to be paid.

29. The City may borrow the amounts set out in the third schedule hereto and apply the same to the purposes set opposite each item respectively. The amounts so borrowed shall be repaid with interest in ten yearly instalments, the first to be paid on the first day of August in the civic year next succeeding that in which the money is borrowed, and thereafter on each succeeding first day of August, and the amount of each instalment shall be included in the estimates of the year in which the same is payable.
