WHEREAS by Section 32 of an Act passed by the Legislature of Nova Scotia being Chapter 57 of the Acts of 1930, it was enacted that whenever any of certain loans set out in the fifst schedule to the said Act, and which formed part of the City of Halifax Consolidated Fund 1905 fell due, the City of Halifax might without further legislative authority issue the stock or debentures of the City for the purpose of obtaining the money to retire such loans, and that such stock or debentures should be issued under the authority of and in conformity with the provisions of the Halifax City Consolidated Fund 1905, and should form part of the Act City of Halifax Consolidated Fund 1905 and that any stock or debentures issued under the authority of the said section should mature in 1952.

MOTOR SWEEPER -WORKS DEPT.

MOTOR SWEEPER

His Worship the Mayor.

Sir:

At the last session of the House the City was authorized to borrow a sum not exceeding \$8,500.00 for the purchase of a Motor Sweeper to replace the one which has been in use for the past twelve years.

There are two types of Motor Driven Pickup Sweepers which have proven satisfactory in service, the Elgin and the Austin, the former is

a type which has been in use in the City and has given good satisfaction throughout its life. The Audtin came on the market after the Elgin and is in use in quite a number of Cities. St.John purchased one last year and their Commissioner of Works and Superintendent of Streets informed me that it has given splendid results.

Accompanied by our Mechanical Superintendent, I made a trip to St.John at the end of last week and made a thorough examination of this machine and also saw it in operation.

The Austin is a four wheel machine and the Elgin a three one and the main difference is the conveyor, in the case of the former it is formed by two chains running on sprocket wheels with rubber cleats held in place by metal angles, in the case of the Elgin the conveyor is a wide rubber belt with rubber cleats riveted to it. The capacity, brooms, etc., do not vary very much in either type. I have tenders for these two machines as follows:

these prices are f.o.b. Halifax, N.S.all taxes paid including excise, sales tax and duty under the new tariff.

If the prices were equal I would be inclined to recommend the Elgin due to our experience with it, but inview of the difference of nearly \$1,000. in the price and to the fact that from examination of the machine and the experience had by other cities, it seems to be equally satisfactory, I would recommend that the City purchase the Austin Motor Pickup Sweeper at the price quoted.

The difference between \$8,500 and the price of the machine can be taken from the appropriation for cleaning paved streets.

PAVING JUBILEE ROAD

JUBILEE ROAD PAVING

His Worship the Mayor.

Sir:

I beg to report on the question of paving the block on Jubilee Road between Summer Street and Robie Street, that about three-quarters of the frontage is owned by the City the remainder being owned by the Department of National Defence.

It has been difficult to keep this street in repair especially in the Spring of the year. It carries a large volume of traffic and should be permanently improved. Before the work is done, owing to the formation of the ground, it will be necessary to construct drainage on the north side for the whole length of the block and for about half the length on the south side where Camp Hill Cemetery is higher than the street.
