#### Re - Reciprocity

Enclosed please find a copy of the memorandum on reciprocity which the Victoria Chamber of Commerce has brought to the attention of the Chambers of Commerce of Canada ~ and the Chambers of Commerc ...d Boards of Trade across Canada.

While this is not commended as a cure-all, it certainly would effect a positive improvement in commercial conditions, and, with this object in view, it is submitted for your consideration.

One thing we have learned is that the money value of real estate is based on the total volume of Commerce. On a contracted volume of commerce, real estate has practically no selling value and very little rental value. The only way to bring feal estate back into value as a realizable asset is to increase the volume of commerce.

It is possible that Ottawa will accede to a nation-wide, non-political, request for reciprocal trade facilities. Municipal co-operation to any extend deemed justified will be greatly appreciated.

## <u>M E M O R A N D U M</u>

The four year period of national isolation, which was put into effect on practically a world-wide basis, including Canada, has demonstrated two things:~

lst。

2nd.

No nation will send out cash to buy food products abroad; there must be a trade opening for the interchange of products - or the use of food substitutes will be enforced.

A nation confronted with the necessity of obtaining any one food product, at the cost of sending cash abroad to pay for it, will see about devising means to produce that food product within its own borders.

The application of these two rules to Canada is seen:

As to the first: Great Britain is embarking on a national policy of increasing its agricultural production, - including wheat, - so as to become in as large measure as possible selfsustaining; and on a secondary national policy of trade treaties with adjacent nations of for instance, with Denmark for dairy products.

As to the 2nd: France, Italy, and Germany in Europe, and Japan in the Orient are enforcing the growing of wheat at home - even at much greater cost than the cost of buying wheat abroad, - rather than send cash abroad. Importation of foreign wheat is placed under strict quota, - regardless of the fact that the quality of the bread offered for sale is lowered.

The United States Congress has recognized the application of the two rules above stated to American commerce; and is negotiating reciprocity treaties with outside nations, under a law empowering the President to sign treaties altering duties 50% without referring to the Senate for ratification.

Canada has a greatly restricted list of exportable commodities to deal with as compared with the United States; and is under more vital necessity to sell its primary products such as wheat, minerals, fish and lumber in world-wide commerce, - not restricted to a reciprocity treaty with any one or more nations. -283~

It would seen, therefore, a reasonable policy that every member of Commerce in Canada, and every agricultural and co-operative association in Canada unite on a basis of urging the Government at Ottawa to re-open world markets.

The most direct basis, giving most promise of increased trade results, would be that Canada make a reciprocal trade offer to all the nations of the world as follows;-

> An international Trade Account will be opened with each nation buying Canadian exports:

The current time unit shall be the calendar year.

In respect of the amount of Canadian exports bought ' by any nation in any calendar year, that nation shall have the right to sell its goods in Canada up to an equal amount with that so bought on the basis of paying thereon fifty percent of the current Canadian Customs duties, Without any dump duties, or special valuations, or other exactions whatever.

Where purchases are made in the last quarter of a year, the time for resale shall extend over the first quarter of the next year.

Each nation to keep its own accounts with its own nationals; the agreement by Canada to be made with each nation direct and not with its nationals; the system of collection of duties to be agreed upon between Canada and each contracting nation respectively; and in the event of Canada making any refund of duties collected, such refund to be made to the order or orders of the nation concerned, so that all adjustments will be made by each Government with (The accounts of its own nationals. the Australian Wool Shipments in the post-war period would furnish a practical precedent: Explained in 1931 Appeal Cases, pages 224 to 257).

On this basis there would be no danger of dumping, because the foreign nation would have to buy Canadian exports first, and get the reduced tariff privilege afterwards.

There could be no factor of adverse balance of trade, because the tariff preference would be strictly limited to the amount of Canadian exports bought abroad.

As one reason for adopting such a policy the Chamber would draw your attention to the trade relations between Great Britain and Germany. In order to enable Germany to buy British yarns and cottons, a special credit is being opened by the British Government; the amount of assistance being defined by the amount of British goods bought.

There would be no interference with the Ottawa Conference Agreements, as the offer would amount to an offer of better trade advantage to all nations concerned.

Unless Canadian action is taken now, and made of world-wide application, Canada will be trailing the United States in a hopeless stern-chase; because in addition to negotiating treaties the United States Government subsidizes on a most liberal scale, American Stamship lines to give regular services to each of the countries with which reciprocity is arranged.

The following resume of the treaty with Cuba will throw real light on the necessity for immediate action by Canada;

#### EXTRACT FROM "BUSINESS WEEK"

Reciprocity agreements in foreigh trade are now a fact and not an economic theory. The first has been signed by Secretary Hull and Senor Cosme de la Torriente, Cuban Secretary of State.

The start made with Cuba is, to be sure, not entirely clear-out. In this case, Washington had a fine chance to make concessions without worrying about their effect on imports from other countries, covered by most-favored-nation treaties. All such treaties expressly exclude any agrangement with Cuba from affecting trade relations with the countries to which they apply. As one Washington commentator put it, the Cuban treaty is more an inspiration than an example in the negotiation of reciprocity agreements under the new authorization.

None the less, the way has been shown, and it is a wide, generous way. It affects Ouban economy by raising the value to Ouba of our sugar imports from that island by somewhere between 20 millions and 40 millions without increasing the Ouban quota or affecting the domestic price seriously, though in general it follows the duty-paid Ouban price. Giving Ouba 0.6¢ of the 1.5¢ duty we formerly collected touches only the United States Treasury. The millions

added to the buying power of Ouba in this country are an outright subsidy out of the absolutely sure customs receipts on quota Guban sugar imports of 1,902,000 short tons annually. The Roosevelt Administration has shown that it really meant what it shid about foreign trade.

Cuba also gains in reductions on the rum duty to a point at which that beverage can be sold, after September 3rd, at considerably below what the sonsumer now pays — which is approximately the same as for Sootoh Whiskey. This should increase Cuban rum sales perceptibly. Furthermore, seasonal duty reductions are made in fresh fruits and vegetables - which stirs up protests from Florida - but avocados are not to be shipped in the winter (apparently to keep prices up for the local variety, during the best avocado season).

in voturn the Cuban market is again opened to American products, which have been strongly barred. The biggest gestures are made toward agricultural products, as was to be expected. Our Cuban Lard market seems to have an excellent chance for revival, for the Ouban duty is cut from over  $9\phi$  per 1b., to less than 3¢ and in 1936 will drop below  $1\frac{1}{2}\phi$ . There is also a long list of large and small concessions on American food products. Flour Gabs a fine break, and American cigarettes will hereafter be sold in Cuba for 25¢ a package instead of 75¢. Textiles will see considerable gains, chiefly in rayons, for Cuba has its own cotton mills and continues to protect them. Automobiles are given definite concessions in all classes. Automobile men expect their Cuban market to increase by hundreds of thousands of dollars annually, both from lowered duties opening wide differentials between American cars and Auropean. and from the increased prosperity of sugar planters resulting from higher returns on their exports to the United States.

"TARIFF TRUCE"

A second state of the seco

The most significant gains certainly so far as the effect on future trade treaties with other countrates is concerned - lie in the definite concessions and agreements outside the clauses lowering specific duties. The new deal sets up a virtual "tariff truce", which will eliminate jumps in duties during its 3-year life, rules out internal and "consumption" taxes, eschews changes in methods of assessing duties, conversion of currencies, and jumps in duties on the grounds of currency depreciation (unless this is over k0%). -286-

The Cuban treaty's provisions against the blocking of exchange are of outstanding importance. Exchange problems stick out like sore thumbs in virtually all the Latin American countries with which succeeding reciprocity agreements will be negotiated. Exporters hold almost uniformly that they have done more to block American trade with these countries than the ordinary tariff barriers. The clear-cut setting of these provisions in the Cuban treaty gives hope that they may be obtained in other treaties.

#### NEXT IN LINE

Treaties to follow at once include those with Brazil (BW-Aug. 25: 34) all Central America, Panama, Venezuela, Haiti and the Dominican Republic. With the Colombian Treaty - which has been virtually comploted, although little is known of its contents - all the coffee exporting countries are covered. Washington is easing into its job by tackling the "one-crop nations" first. For negotiations with those whose big crop is coffee it feels that it holds a high card in its apparent ability to guarantee them against imposition of an American import duty on that product". ("BUSINESS WEEK" - September 1st, 1934)

The question was raised at the last meeting of the City Council as to whether proper steps had been taken to protect the City's interest under the bond protecting the City against defalcations of N. A. Macalder. The defalcations were discovered on July 7th, 1934, and on July 12th, 1934, I am advised that the Bonding Company through its agents in this City was notified to this effect. I have prepared proofs of loss with respect to the defalcations insofar as the bicycle license fees are concerned.

For the information of your committee these proofs of loss were submitted to cover the bonds in force from August 1st, 1931 to July 31st, 1932; August 1st, 1932, to July 31st, 1933; August 1st, 1933 to July 31st, 1934. In my opinion the bond for each of these years is a separate entity and if a default becomes known to have occurred during the year of any bond and is discovered within twenty-four months after the expiration of any such suretyship, that the Oity can claim against the Bonding Company up to the amount of the bond in respect to such year. For this reason I have prepared

claims on behalf of the City in respect to three bonds as above stated, and therefore out total claim against the Bonding Company will exceed \$1,000.00. If however, we had claimed on one such bond, the total amount which we could recover would not exceed \$1,000.00. I feel that the stand I have suggested is correct and I would advise that every effort possible be asserted to maintain the same.

In July 1916 a report recommending the extension of the six inch high service main through this street was adopted by the City Council provided the owners of the property desiring the water would sign a bond for a special rate guaranteeing the interest on the expenditure. They refused to sign the bond and subsequently obtained permission to connect through private property with the twenty-seven inch low service main.

In December 1919 another report

was made giving an estimate of cost and also the amount of the special rate to be fixed. The rate was considered too high by the owners of the houses then built and since then the various houses on this street have been connected as stated before to the twenty-seven inch main. The attached sketch shows the location of the houses and various mains.

In order to improve the supply it will be necessary to extend the six inch high service main in Windsor Street about fifty feet northwardly and westwardly along Bayers Road for a distance of about eight hundred feet. The estimated cost of the work is \$2900.00 and the interest on this expenditure at 7% is \$203.00.

This includes the extension to the property of Mr. W. P. Little but as this property already receives a supply from the high service main on Young Street it will be unnecessary to make a proposed new extension beyond the lot west of his property which will reduce the cost to about \$2600.00. The interest on this at 7% is \$182.00.

Nine houses will be supplied and if the water is taken by all of them the special rate for each house will be \$20.23.

It is recommended that the extension be made provided the owners will sign a bond for a special rate which is recommended to be fixed at \$20.23 provided the nine houses sign, if not the rate to be made in proportion so as to yield the total interest from those who sign the bond and take the water.

I am attaching herewith a copy of a report from the City Solicitor enclosing the decision of the Judge of the Supreme Court in the matter of the City of Halifax vs. The Nova Scotia Light and Power Company Limited in connection with the alteration of the location of the tracks on South Park Street butween Spring Garden Road and South Street, before paving.

It will be seen that the Judge decides that the City cannot compel the company to re-locate its tracks on this portion of the -318-

street and in effect, means that when once the tracks are laid on any street the location is final as far as the Company is concerned, no matter what changes in conditions may arise.

The Solicitor states in his report that he would hesitate advising an appeal. Up to the present each side is paying its own costs. In the event of an appeal the losers would not only have to pay the cost of the appeal but probably the costs of the present reference.
