Alderes show water that a

delegation of persons who are living in properties of the Halifax Housing Commission are present at this meeting and wished to address Council.

Moved by Alderman Ahern, seconded by Alderman Lloyd that the representative of this delegation be permitted to address Council for a period of five minutes. Motion passed. Petty Officer Hall then came

forward and addressed Council.

Petty Officer Hall stated that he was representing about 140 people, including naval men, R.C.M.P. and defence workers.

He said that the Housing Commission had engaged a real estate agent who had, in his mind, used very questionable methods.

The properties, he said, were being sold or viewed for sale and the tenants had been given first chance to buy but the prices were too high.

He said the tenants had not been given a chance to see if arrangements could be made to pay the prices.

Petty Officer Hall stated that if the people living in these houses were forced out they had no place to go as housing conditions were deplorable.

He said the delegation was asking that the sale of these houses be deferred and some representation made to Wartime Housing Ltd. by the City Council so that the houses now unoccupied would be made available to service men and others who could not obtain decent accommodation because of lack of houses and prohibitive prices.

February 12, 19421

Hid Worship the Mayor requested the City Assessor, Chairman of the Housing Commission, to explain to Council the position of the Commission.

The Assessor told the Council that the present Commission was composed of the Commissioner of Finance and Accounts, the Commissioner of Works, and the City Assessor. These officials were appointed in May 1940 following the Brittain report. The instructions of the Council were to liquidate the affairs of the Commission as soon as possible. With this in view the Commission, in 1940, had given to all real estate agents the list of the properties owned by the Commission with a view of selling them. Some progress was made as a result of this action. Present tenants were to be given first preference in buying.

In December 1941, the Commission advertised all properties in a general advertisement. There were practically no replies to the advertisement. Shortly afterwards Mr. J. G. DeWolf requested the Commission to fix prices on certain properties. The prices fixed were the assessments. Subsequently, Mr. DeWolf gave the Commission written offers for some of the properties which offers were accepted by the Commission. Notices to vacate were given to the tenants of properties which were sold.

At a meeting of the Committee on Personnel held this day the following matters were considered.

 Report of Commissioner of Works re salary of Assistant Entry Slerk, on which a report from this Committee was requested at the last meeting of the Council. The Commissioner of Works recommended that an increase of \$60.00 be given to this official effective May 1st, 1941, and a further increase of \$60.00 during the civic year 1942-43.

In view of the fact that the Council was not disposed to adopt the recommendation to this effect, made by this committee in its report of December 6th and contained in column 5 of the detailed report submitted therewith, applicable to all employees in a similar position to the Assistant Entry Clerk, this committee was not of the opinion that this recommendation should be applied to one official only. However, if Column 5 of the detailed report (as amended) is adopted by the Council this will result in the Assistant Entry

Clerk(among others) receiving the increases in salary referred to above.

2. Report of Commissioner of Works re salary of Assistant Superintendent of the Public Gardens. The maximum salary of this official under the old scale was \$1600.00 and during the civic year 1940-41 the salary paid was \$1560.00. The new scale adopted by the Council fixed the maximum at \$1500.00. In view of the action of the Council in permitting the Superintendent of Public Chartties and Welfare to continue on to the maximum under the old scale, your committee recommends that like treatment be accorded to the Assistant Superintendent of the Public Gardens and that, as recommended by the Commissioner of Works, he be permitted to receive during the present civic year the additional sum necessary to reach the former maximum salary for this position - namely \$40.00.

3. Report of Commissioner of Finance and Accounts re salary of Assistant Treasurer. This employee had not reached the maximum for this position under the old scale of \$2,500.00 and did not receive the automatic increase which could have been granted as of May 1st, 19^h1. Your committee recommends that the sum of \$100.00 be added to the salary of this official as and from May 1st, 1941, as submitted by the Commissioner of Finance and Accounts.

4. Report of Commissioner of Health re salary of Matron of the City Prison. It was pointed out by the Commissioner that no cost of living bonus had been paid to the Matron, apparently for the reason that she was sharing in the subsistence allowed to her husband. It was stated that the Matron is practically on duty for 24 hours a day and must secure and herself pay for relief if she desires to leave the institution. Dear Sir:-

I enclose account for professional services to recent date from the City's auditors amounting to \$2,046.37.

The general details of the progress of their audit have been discussed with your committee and the decision has been reached that a recommendation be forwarded to Council to complete all important phases of the reorganization now proceeding in time for audit of the fiscal period which will end April 30th, 1942.

In May 1941 the Council decided to invite tenders for a balance sheet audit.

In June 1941 I wrote the committee at some length on the state of the reorganization and my report is to be found in the minutes of the Council for that month. Part of my report read as follows:-

> "When the legislation dealing with the sweeping reorganization was drafted, it provided permissively for a 1940-41 audit and mandatorily for audits of ensuing years. This was done in order to provide a suitable opportunity for accomplishing several special undertakings, because it was known at that time that they could not be finalized in the first year, but should be completed before an audit, of the type required by the legislation, is undertaken".

Bubsequently the appointment of the iditors was made and their work commenced on ictober 1st last.

Your committee is now aware that the audit for the fiscal period ended April 30th, 1941, can only be pursued at a most substantial cost, because of the incomplete state of the speciel undertakings to which I have referred.

Recommendations already approved by your committee and which should now be forwarded to the Council for its approval, in order to advance the present reorganization sufficiently for audit for the fiscal period which will end April 30th, 1942, are as follows:-

1. All Water Department accounting, for which the Water Department and not the Finance and Accounting Department has been responsible up to now, should be transferred to the Finance and Accounting Department as of April 30th, 1922.

 Immediate steps should be undertaken to establish a machine system for Water Department billing and accounting of their receivables and approval given for the overtime employment of a qualified staff for such purposes.

 Agreement to purchase a public utility accounting machine, addressograph plates and other necessary supplies and equipment to be recommended from time to time.

4. Agreement to transfer to the Finance and Accounting Department, in due course, the duty of the collection effort in respect of hospitals and other accounts receivable of the City and to transfer all staff no longer needed in the department where formerly employed.

5. Authority for a series of conferences between the auditors and the Commissioner of Finance (the cost of which would form part of the audit fee) for the purpose of reviewing and improving the general system of accounting.

It is important that I direct attention to the Legislation of 1940 which makes mandatory an audit for the year to end on April 30th, 1942. This requirement of law cannot of itself produce the auditors' certificate. Only the completion of the reorganization, the refinement of every part of the accounting system, toggthar with the auditors' approval of our method of internal check, will permit of the issuance of the independent audit certificate without qualification. Hence the reason for immediate action on these recommendations.

The initial audit is certain to cost more, and it should be recognized that it may cost substantially more - than ensuing audits, but the cost of the first audit will be much less than it otherwise will be if the recommendations I make herein are not immediately adopted. As I see the situation, the reorganization of the system does not permit of a gradual evolution, and there is, therefore, only one decision to make.

The legislation arising out of the Brittain Report is now a fact and the independent audit is a part of it. It would, I think, be neither economical nor expedient to delay or curtail the scope of the whole associated programme.

If the cost of the first audit develops to an amount much more than its estimated oost in subsequent years, the excess, after assessing the Water Department with its proper share, could be deferred.

My last observation is that the existing audit appropriation should from now on be associated with the general recommendations of this letter; that the Committee and the Council should record its willingness to auguent the audit appropriation as and when the need arises; and that the auditors proceed with the auditing of any available records as soon as may be convenient, leading to the early completion of their audit programme after April 30th, 19¹⁰-2.
