ft. The land in question is a narrow strip about 15/in width, running between the Shipyards and the Dockyard, to the west shore of the harbour. It was granted to the City in the year 1834 and is the remnant of a piece of land once 100 feet in width, as shown on plan.

The City, I understand, has no right-of-way across the C.N.R. on Dockyard property but the crossing owned by the Department of National Defence is used by the travelling public. The stairway consisting of about 45 steps is in first class order and maintained by the railway. There is also a first class float for landing, and benches and a shelter, erected by Dauphinee and Sons.

Up until 1923 J. H. Dauphinee & Sons paid the City \$10.00 per year for the use of the site, but as it was a public landing and Mesers. Dauphinee did not have an exclusive right of landing the annual rental paid by them was cancelled.

The City has several public landing points, two of which are leased, but not to the exclusion of the public. We are of the opinion that a public landing should not be leased to the exclusion of the public.
