# EVENING SESSION

8.10 P. M. Council Chamber, City Hall, July 15, 1943.

A meeting of the City Council was held this evening. At the above named hour there were present His Worship the Mayor Chairman; Aldermen Reardon, Hosterman, Breen, Coffin, Adams, McDonald, Doyle, Walker, Burgess and Ahern.

The meeting was called to proceed with business standing over and the transaction of other business.

# PRESENTATION TO CONST. BLE H. D. MERRICK R.C.M.P.

His Worship, the Mayor stated that he had been requested by Asst. Com. Eames of the R. C. M. P. to present a Royal Canadian Humano Association Award to Constable H. D. Merrick and asked for permission of Council to make the presentation at this time to which Council agreed. The City Clerk read the following citation:

# Re: Harold Dominic Merrick

- ran aground on a reef at Cape LaRonde, N. S. and broke in two. Two of the nine members of the crew were carried overboard by the heavy seas, and in the morning seven members of the crew were still on board. Members of the R. C. M. Police and local residents, who proceeded to the shore prepared to assist the men, were powerless as were two boats of the Royal Canadian Navy because of the rocky nature of the coast and the high breakers.
- During the afternoon as it was evident that the fury of the sea was still increasing and that part of the barge still out of water might founder at any time

the seven crew members plunged into the water and partly swimming, partly carried by the heavy seas were carried to the shore where they were given every assistance by those standing by prepared to help.

- approaching the shore was carried back to deep water by the undertow apparently in a helpless condition.

  Constable H. D. Merrick of the R. C. M. Police sensed the man's predicament and in company with one Leo

  Alphonse MARTELL rushed into the surf and pulled the man to shore. MURPHY'S condition was obviously serious and Constable MERRICK cut off the rubber suit and life belt and began giving artificial respiration which he continued for fifteen to twenty minutes. On signs of returning life, Constable MERRICK wrapped his pea jacket on the man, and with assistance carried him to the nearby lighthouse and there removed the balance of the man's wet clothing, wrapped him in a blanket and massaged his limbs and body until natural circulation returned.
  - 4. Constable MERRICK spent approximately two hours administering artificial respiration and other first aid treatment until the seaman appeared to be well on the way to recovery from his trying experience.
  - 5. It has since been learned that MURPHY fully recovered and suffered no ill effects from the exposure.
  - 6. The action taken by Constable Merrick apparently definitely saved the life of the man.

His Worship the Mayor with a few well chosen words then presented Constable Merrick with a Royal Canadian Humane Association parchment certificate.

ation I regretted having to do so and was not, at the time, too sure of my ground, but, since having an opportunity of delving into the question of increases in the salaries of Tax Collection Clerks that would become effective on the adoption of the motion of Alderman Ahern, I personnaly feel that my action was justifiable. Apparently this whole question hinges on the recommendation for an increase in salary as suggested by the late Commissioner of Finance to Mr. Walker and on this information getting around, the other four clerks, impressed with their all-importance, decided, by the method of lobbying, to endeavour to be compensated on the same basis.

As far as our records show, I can find no recommend ation whatever from the head of the Finance Branch that Messrs. Burbridge, Currie, Leitch and Slattery have been performing such duties as to merit any such increase. Surely the Council will agree that this is not good practise. I personnaly feel that, if any of those mentioned had been entitled to special consideration, they would have received it ere this.

For the information of Council, the following tabulation shows exactly the standing, as to length of service, increases, etc., since coming into the employ of the City, of Five Tax Collection Clerks:

The name of Mr. Stoddard is included here, although he is now performing work in the City Clerk's Office. From this list it will be noted that Mr. Burbridge entered the employ of the City as Junior Clerk in 1935, and in 1937 was promoted to Account Clerk. It will also be noted that so far all of those mentioned in the tabulation have been receiving their annual increases regularly and I personnally see, no reason why we should deviate from that custom.

I wonder if it is realized that, if the motion referred to passes Council, it will involve an additional yearly expenditure of some \$75\( \), 75, and that this unwarranted increase in spending is notice being made on a recommendation of the head of the department or the Personnel Committee, but it will have been made to satisfy the wishes of these particular clerks, and in my estimation, if passed, can be termed "so much luck" as far as they are concerned—and you all know that the best substitute for luck is ambition and if there had been an ample display of it in the past, I am sure that these Clerks would have been recognized by the head of the branch long before this and that the action taken by then would not have

transpired.

The City Clerk at the request of Alderman Adams read the Chief's recommendation to the Safety Committee

It was then noved in amondment by Alderman Burgess, seconded by Alderman Ahern that the City purchase two ladder trucks within the price of \$40,000.00.

The Mayor ruled this amendment out because it was not in order.

The Mayor asked the Deputy Mayor to take the Chair and he remarked that the Chief of the Fire Department asked for two 85 foot ladder trucks, Cab over Engine type in his recommendation if the extra money was available but the extra sum of \$2,000.00 required could not be obtained.

The Mayor assumes the Chair.

Alderman Reardon stated that he was satisfied that both machines could do the work and thought the City should purchase two machines as soon as possible and was very much in favor of buying one from each dealer.

It was then moved by Alderman McDonald, seconded by Alderman Reardon to suspend the rules of order and set aside all motions previously made.

Alderman McDonald stated that there had been a lot of trouble with the LaFrance machine and that the Bickle Scagrave was the originator of the ladder truck.

### Ro: BOILERS

It has been recognized for many months that our boilers are in a dangerous state of repair.

I have given much study to this project and have had competent advice for same and feel that it would require \$3,000.00 to give us a permanent repair job.

My suggestions are as follows:

- 1. Suspend the front ends of our boilers on steel supports of dimensions to conform to the Provincial Boiler Code.
- 2. Remove all brick work and engage a bricklayer to reset the entire battery of boilers.

May I stress the necessity of starting this work without delay, and I would suggest that it would be a waste of time to call for tenders for the part of this work outlined in paragraph 1.

Dear Sir: Re: O'Flaherty vs City of Halifax

The above action was taken by the Plaintiff against the City of Halifax as a result of injuries suffered by the Flaintiff by falling into a citch on the North Side of North Street, which ditch was open for the purpose of installing a new sewer at that point. The matter came on for trial before Mr. Justice Graham with a jury, and certain questions were put to the jury. The questions and answers are as follows:

1. Were the unjuries suffered by the Plaintiff, J. Howard J. O'Flaherty, caused through the negligence of Defendant?

Answer. Yes.

2. If you answer "Yes" to the above question, in what did the negligence consist?

Answer. Not sufficient supervision on part of the night watchman. Also should have been a light on each end of bridge.

3. Did negligence of Plaintiff contribute to the accident?

Answer. Yes.

4. If you answer "Yes", what was his negligence?

Answer. Not sufficient precaution in walking in the dark.

5. If you find the defendant negligent, could the Plaintiff J. Howard J. O'Flaherty, notwithstanding the Defendant's negligence, by the use of reasonable precaution and care have avoided the accident?

. Answer. Yes.

6. At what sum do you assess the damages?

. Answer. \$2400.00.

7. If you find that the accident was caused by the fault of both parties, what was the degree of fault of each?

Answer. 50% to each party.

When the application was made for the order in this case the Trial Judge pointed out the fact that the jury's answers were somewhat inconclusive and wore not definite and might result in a new trial being ordered on appeal. It will be noted that in answer to questions (1), (2), (3) and (4) the jury found that both the Plaintiff and the City were negligent, the City because there was "not sufficient supervision on the part of the night watchman. Also should have been a light on each end of bridge"., and the Plaintiff because he did not exercise "sufficient precaution in walking in the dark".

The jury proceeded to answer the 5th question in the affirmative, thus indicating that regardless of the City's negligence it was the negligence of the Plaintiff which actually caused the accident, as he could have avoided the same by the exercise of reasonable care. If this stood alone, there would, in my opinion, be no question but that the Plaintiff would have failed in his action, but as you will note the jury proceeded to answer two more questions. The first assessed the damages suffered by the Plaintiff at \$2,400.00 and the second found that the accident was caused by a 50% degree of fault of each. This apparently is contradictory to the effect of the answer to question 5 and would seem to indicate the intention of the jury that in spite of the fact that the Plaintiff could have avoided the accident by the exercise of reasonable precaution and care, nevertheless the City was 50% contributory in fault and liable for 50% of the damages suffered.

On the hearing for the Order I argued that the City was not obliged to pay anything in view of the answer to question 5. However, it was suggested by His Lordship that in view of the doubt in interpreting the answers of the jury that some thought should be

given to making a settlement and I am advised by the Solicitor forthe Plaintiff that he is willing to accept the sum of \$1200.00 and the taxed costs and not proceed any further in the case. If this is not acceptable I understand that it is the intention of the Plaintiff to appeal for a new trial. If the, -appeal is allowed and a new trial granted the result, in my opinion, will be uncertain. I am submitting this to you for instructions. If the City feels that we should endeavour to insist upon no payment at all by the City in this case, I will endeavour to take an Order dismissing the action and defend any appeal that may be taken. I am not able to speculate on the outcome because it is impossible to predict the outcome of a jury trial. On the other hand if the City feels that it is advisable to make a settlement in this case I will take out an Order accordingly.

The City Solicitor recommended that the City accept the sum of \$1599.63 in full settlement of the water rates covered by the statements dated April 14, 1943, which in effect include those bates now more than six years old but wathout interest thereon.

He also recommended that the City Council relieve the Collector of any responsibility for collecting the interest on these prescribed water rates and that the City execute the attached acknowledgement and release by the hand of the Mayor and City Clerk.

During the past few months it has been impossible for any firm to submit prices on not more than half of the items contained in the specifications, with the result that purchasing under contract under such conditions has not been satisfactory.

On November 20, 1942 we were notified by the Commissioner of Works that an accident had occurred in which one of the city trucks, driven by Joseph LaPierre, injured Mrs. John A.Smith. It subsequently developed that the accident occurred on August 31st, but that our company was not notified until November 20th.

As we had not received immediate notice of the accident, which is a condition of the policy because lack of such notice deprives us of an opportunity for adequate investigation, we wrote to the Mayor on November 23rd, asking that a waiver agreement be signed, releasing us of any liability in connection with this accident, but permitting us to proceed with our investigations and defense of the case if it was felt advisable. Our investigations led us to believe that the City was not liable in this instance, and we appointed Messrs. MacDonald, McInnes, MacQuarrie & Pattillo to defend the case, in view of the fact that the claimant would not listen to any reasonable settlement.

Mr. Pattillo acted in conjunction with Mr. Bethune, and the case went to trial before Mr. Justice Carroll, Judgement was delivered a few days ago against the City of Halifax in the amount of \$386.50, and \$127.90 costs. Although there is no liability on the part of our company, we have decided that we will not make use of the City's waiver, and that we will pay the judgment and costs. We are accordingly forwarding our cheque to our solicitors in settlement.

# REMARKS BY HIS WORSHIP THE MAYOR

His Worship the Mayor stated that there was a great deal of difficulty in securing men for carrying out the water survey and other projects in the City and that men were urgently needed by the N. S. Light and Power Co., Ltd.

His Worship suggested that the City endeavour to secure a gang of men and pay them at the regular rate of 45 cents an hour and pay \$2.50 per week on their board, the same being \$9.50 per week and that a staff house be secured if possible for the housing of the men. # A F T E R N O O N S E S S I O N S PECIAL MEETING

5:00 o'clock, Council Chamber City Hall, August 3, 1943

A meeting of the City Council was held this day. At the above named hour there were present, His Worship, the Mayor, Alderman, Reardon, Hosterman, Breen Coffin, Adams, DeWolf, McDonald, Doyle, Walker, Burgess and Ahern.

The meeting was called specially to consider the following items:

- 1. Report of Safety Committee re Fire Boat.
- 2. Report of Safety Committee re Ladder Truck.

### FIRE BOAT

Read report of the of the Safety Committee as follows:

Halifax, N.S. Aug. 3, 1943.

To His Worship the Mayor and Members of the City Council.

Gentlemen:

At a meeting of the Safety Committee held on July 29, 1943, Mr. R.W. Hendry, Port Manager, reported that the Dominion Government is forwarding a second fire boat to Halifax for general protection on the waterfront. It is larger than the "Rouille" is modernly equipped and capable of pumping approximately 7000 gallons of water per minute.

Mr. Hendry stated that National Harbours Board would provide the boat and pay all the costs of maintaining the same including the wages of the crew and firemen assigned to the boat and uniforms and equipment for the same and that no expense in respect of the new fire boat would fall upon the City.

Mr. Hendry requested the City to supply six trained firemen for duty on the fire boat who would be paid by the City and the moneys so paid would be refunded to the City by the National Harbours Board.

The Chief of the Fire Department pointed out that this would mean that the City would have to employ six additional firemen to replace those assigned to the fire boat.

THE RESERVE

It was also pointed out that since the Charter of the new fire boat was for six months that the City should not employ the additional firemen for a longer period unless it intended to keep them on the strength of the force indefinitely. Thile it was probable that the new fire boat would remain in service for the duration of the war and some period thereafter there was no assurance that this would be so beyond the period of the original charter.

Apart from the provisions requiring the City to make monthly payments and the term of the agreement the manner of operation of the new fire boat could be covered by an agreement similar to that now in effect concerning the "Rouille".

Your Committee therefore recommends as follows:

1. That six trained members of the Fire Department be assigned for duty on the new fire boat.

2. That the number of men in the Firc Department be increased by appointing six additional firemen to hold office for a period of six months and thence from month to month and that upon the discontinuance of employment of such additional firemen the number of men in the department revert to the number at present in that department.

3. That the City execute an agreement with the National Harbours Board satisfactory in form to the City Solicitor for the purpose of carrying out the intention of the City, said agreement to be similar in form to that respecting the "Rouille", provided that no expense be borne by the City with respect to the said new fire boat.
