WHEREAS the Board on the 20th day of March 1945 issued the following Order dealing with the water system of the City of Halifax,

What an investigation of the entire water system of the said City of Halifax be made by the Engineering Service Company Limited, a body corporate, of said City, to ascertain what necessary improvements should be made to furnish a safe and adequate supply of water, and to present to the Board a statement of the financial setup of the said system as a public utility:

That such investigation be instituted not later than the first day of April, A. D. 1943:

That said Engineering Service Company Limited, on completion of said investigation, do promptly make its report in writing and file the same with the Clerk of this Board, and the said Engineering Service Company, Limited may make such interim reports as it may deem advisable for the temporary improvement of said water system:

That the cost of said investigation be charged to the water utility of the said City of Halifax".

AND WHEREAS the Legistature of the Province by

Section 55 of Chapter 46 of the Acts of the Province of Nova Scotia 1943 enacted as follows:

"The City may borrow such suns as may be required for the purpose of defraying the cost of any survey of and report upon the water department of the City, including the facilities provided for the supply and distribution of water by the City, which may at any, time be ordered by the Board of Commissioners of Public Utilities, and also for the purpose of defreying the cost of providing and installing any improve ements and expensions to such department or to such facilities which may be necessary in order to comply with any Order made by such Board. The sums so borrowed, which may be borrowed from time to time and in such amounts as the Council of the City determines, shall be borrowed in accordance with the provisions of the Halifax City Charter relating to the Halifax City Consolidated Fund, and be in addition to the amounts previously authorized to be borrowed as part of that Fund. They shall be recured by stock or debentures to be issued in conformity with the said provisions at a rate of interest to be determined by the Council of the City air the time of the making of any loan under the authority of this Act, and the doiles on which the same are payable shall be determined by the Council's

AND WHERFAS Engineering Service Company Limited in pursuance of said Order of the Board on the 20th day of March 1943 began its survey on the said water system of the said City of Halifax on or about the 15th day of April, 1943.

AND WHEREAS in carrying out a comprehensive survey the Company regulace the City of Halifax to purchase and instal equipment, move and replace pipes, make certain extensions to the water system of the said City as by reference will more fully appear in the evidence of John R. Kaye, President of the Company, adduced at a special hearing before the Board held at the offices of the Board on Friday the Sist day, of May 1943, and upon hearing Mr. Carl P. Bethune K. C., City Solicitor, and Works Cormissioner R. M. Mackinnon,

IT IS ORDERED that in pursuance of the authority given by Chapter 46 of the Acts of the Legislature 1943, the City do purchase the items of equipment set forth in Schedule "A" hereto, the same having been recommended by Engineering Service Company Limited, and approved by Commissioner of Works R. M. Mackinnon, that the City make available funds for the prompt purchase of equipment, materials and labor necessary in the conduct of the Survey of the water system of the City as recommended by Engineering Service Company Limited and approved by the Works Commissioner and City Solicitor, and that the Highland Park water extension be proceeded with according to the plan suggested by Engineering Service Company Limited and approved by the Works Commissioner.

#### GARBAGE COLLECTION

Gentlemen: -

I have examined the draft of the above proposed regulations prepared by the Commissioner of Works and Superintendant of Health and would recommend that they be re-drafted and brought into effect as a Public Health Regulations under the authority of the Public Health Act.

It may be necessary to modify some of the requirements in the proposed draft due to the impossibility of obtaining proper containers and the fact that containers of garbage and ashes are subject to treatment which makes it difficult for them to be maintained at all times in a perfect condition.

Moreover, there is a suggestion in one section which might be construed as requiring the containers to be of metal, which at the present time at least is not feasible.

Generally speaking, the proposed regulations should be revised and in addition a penalty clause provided. For these reasons, I have suggested the deferment of consideration.

I have spoken to Mr. MacKinnon and he agrees with this course,

#### HOUSING

Fis Yorship the Mayor submitted and read the following letter:

August 12, 1943.

To the Members of the City Council,

Dear Aldermen: -

The lack of housing accommodation in Halifax continues to be our major current problem, Despite the erection of 200 dwellings under the co-operative arrangement with Wartime Housing Ltd., the lack of dwellings to supply the demand continues to be acute.

It is my considered opinion that to continue the erection of new dwellings without some control over the influx of population to this City would only encourage an increased demand beyond our ability to provide same. Furthermore each family that enters the City increases the demand for all the services required by residents of the City such as water, fuel, food supplies, transportation, educational facilities etc. Many of the commodities required by citizens are either directly rationed or on a quota basis to the whole-saler. All of our existing services are being taxed to the limit of their capacity. Unfortunately, no singleagency exists whereby all the factors which enter into the problem can be ascertained. The common factor to all our problems is that of population, in other

words, the number of people in the area, their occupation and their living requirements. A house to house survey conducted under the authority of the Wartime Prices and Trade Board would provide the information on which to determine our future policy with respect to providing housing and other essential services to the residents of this City.

Recently following a discussion of this matter with the Commercial Club of Halifax, I invited any suggestions which they cared to offer in the matter and on July 22nd they passed the following resolution:

"Resolved that the City of Halifax request the Wartime Prices and Trade Board to conduct a survey of the relative housing and population in this City and that the Board invoke the assistance of the H. C. E. C. Organization in completing such a survey."

The foregoing resolution was passed by the Commercial Club following a full discussion at a meeting called for that purpose. Should it meet with your approval, I should like now to make a formal request to the Wartime Prices and Trade Board to authorize and to conduct such a survey.

I also would appreciate your approval of the policy of soliciting; in connection with this very important step towards a solution of our problem, the assistance of the Provincial Government and our Federal Representatives.

In accordance with a request from the Committee on Works at a meeting held on September 14th., plans and estimates are hereby submitted for the drainage of Windsor Street between Regent Street and Connaught Avenue.

It is necessary due to the contour of the ground that the drainage of Windsor Street must be obtained by three separate sower extensions.

Extension No. 1

Regent St. to near Maxwell Ave.This proposed extension is to serve eleven lots on
the west side of Windsor Street and also the new
Ordnance Building on the east side of Windsor Street,
now under construction.

It is proposed to drain this portion south on Windsor Street to Regent Street, thence westwardly on Regent Street to connect to the existing sewer constructed by the Federal Government for the R. C. A. F. "Y" Depot.

The length of this extension for Windsor and Regent Streets is about 1140 ft. and the estimated cost would be about \$10,000. Estimated assessment \$1750.00.

#### Extension No. 2

St. from Maxwell Ave north to Duffus Street and would also drain Windsor Street beyond Duffus St. for about 200 ft. This in turn would be drained through a proposed street of the Hendry property, (Connaught Park Sub-Division) to the existing intercepting sewer west of Connaught Ave. The total length of this extension is 2680 ft. and would serve about 36 lots.

MAYOR'S OFFICE HALIFAX, N. B.

Members of the City Council.

Gentlemen 3-

You no doubt have been giving very serious consideration to the tremendous responsibility which rests upon us as a City Council to make specific plans for the Post War rehabilitation and Reconstruction of our City. You will all agree that we must now take the first step towards crystallizing the varied opinions which have been expressed as to what should be embodied in our Post War plans.

The purpose of this submission is to assist....
you in deciding the procedure to be followed in
achieving a "master plan" for our guidance when the
war ends. May I express the opinion that the task
which lies ahead of us may be divided into five
divisions. They are as follows:

- 1. The finalizing of the Council's efforts towards achieving a maximum of efficiency in civic administration.
- 2. The scope and nature of local public works.
- 3. The coordination of public services with other governmental bodies.
- 4. Economic planning.
- 5. Town planning.
- 1. FINALIZING OF COUNCIL'S EFFORTS, ETC.

The outbreak of the war in 1939 interrupted the spirit of reform which underlined the Council's activities at that time. We were engaged in reorganizing our internal administration, much of which has been accomplished. If we are to have the tools and resources to enable us to play our full part in the Post War Reconstruction Program, certain reforms in the emisting financial, administrative, and legal structure of our civic government are necessary.

Last Monday evening at a meeting of a Committee of the Whole Gouncil we discussed some of the steps which should be considered and on which you will make a decision at this meeting.

The magnitude of the Post War activities of the City Council in our community affairs will leave very little time for consideration of refinements to our machinery of civic government. Therefore it appears to be a very vital essential to the post war program that the Council as quickly as possible resolve its decisions on such matters as, recommendations of the independent auditors, the revision of the City Charter, and such other steps on an administrative nature which will occupy our attention in the ensuing months. In other words, the Council must have the tools with which to implement the post war plans.

It is to be expected that each municipality will finance without assistance its deferred maintenance and back log of public improvements.

In the next ten years approximately \$9,000,000. 00 of our funded debt will mature and be paid off. The retirement of our debt by years is as follows:

The foregoing information indicates that we can plan an expenditure in the next ten years in the City of Halifax of \$9,000,000.00 without increasing the burden of taxation on the local taxpayer.

We must not overlook the possibility of other resources with which to continue the progress of our community.

If the City of Halifax is to have the necessary financial resources with which to carry out an effective post war program, to which it is entitled, we must continue to impress upon the Federal authorities the justification of our claims for compensation in lieu of taxation on Grown property which at the moment comprises approximately fifty percent of the assessed value of real estate in this City.

We must also join with other municipalities in urging the Federal Government to reach an early decision as to its policies so that we, in turn, may coordinate our plans for financing the post war program where it may include projects requiring joint fiscal arrangements.

To summarize the foregoing remarks, we, as a Council, must do everything in our power to bring about an early statement by the Federal and Provincial Governments as to what financial resources are available to this municipality for post war planning.

## 2. THE SCOPE AND NATURE OF PUBLIC WORKS.

We are fully aware of the fact that a vast program of public works will be required during the transition period from war to peace.

As much as possible must be done now to pave the way for the construction of new public buildings, such as a new Police Court, or a new City Hall with modern facilities, a Gymnasium for out new High School, Libraries, a Community Hall, and many other public buildings which have been suggested from time to time as needed in this community. All will require their needs evaluated and costs and details of construction finalized.

By proparing a public works program we contribute to our insurance against post war mass unemployment as well as providing much needed public buildings.

We must also consider the rehabilitation of our streets, water and sewer systems and engineering facilities, necessary to a modern, clean and healthy City.

Slum clearance and the erection of adequate housing accommodation is one of the major post war undertakings which confronts our community.

Many opinions have been expressed as to what should be embodied in our plan for local public works following the cessation of hostilities.

Briefly, our procedure towards attaining a guide for the reconstruction period must afford an opportunity for citizens to attend hearings, present briefs, and to otherwise assist in reaching a democratic plan as to the post war scope and nature of local public works.

# 3. GOORDINATION OF PUBLIC SERVICES WITH OTHER GOVERNMENTAL BODIES.

Our recent attempt to take full advantage of that natural beauty spot, the North West Arm, as a recreational centre for residents of the Halifax area, as well as for our visitors, has definitely indicated the need for an effective Metropolitan Commission, with wider powers than that of a mere Town Planning Board.

The divic Improvement League have from time to time prepared documents setting forth plans for a Metropolitan Commission. The objective of this Commission was, among other things, the acquisition of lands as park areas, the construction of scenic roads, and the preservation of the natural beauties surrounding Halifax within a 25 mile radius.

It is a patent fact that if many of these plans had been carried out the improvements which we desire to accomplish at the present time would have been achieved at much less cost and effort.

We should not, therefore, let our indifferences towards the need for a coordinating body such as a Metropolitan Commission continue, and the creation of such a body with effective powers must be part of our post war planning.

Dr. W. A. McIntosh of the Rockefeller Foundation, when discussing the problem of public health in Halifax, stated that the problems of health are not limited to the City boundaries and that if an effective health administration in the metropolitan area of Halifax is ultimately to be achieved, many public health matters under jurisdiction of a Metropolitan Commission should be an early consideration.

The Federal Government will also be to some extent affected by the creation of a Metropolitan Commission. Full enquiry will have to be made as to what extent the senior Government will have to participate in our improving of the waters which practically surround the peninging of Hallfax.

The matters to which I have referred all serve to indicate that any exhaustive research designated to improve public service in the Halifax area will require a plan to coordinate the functions of our City with those of other Governmental bodies.

#### 4. ECONOMIC PLANNING

Any large scale undertaking which involves the expenditures of public funds depends on the ability of the community to carry the burden of taxation arising therefrom. If our plans for the future are to dis based on a solid foundation the economic life of the City of Halifax must be fully surveyed.

The post war use of the port of Halifax, the transportation system which serves this port, the effects of developments in aerial transportation, the maintenance of a naval garrison in this historic naval base on a basis commensurate with the present status of Canada as a nation, local industries — all of these factors which contribute to the welfare of our community must be examined and a plan evolved for the promotion of the economic welfare of our City and port.

Here again the need for the voluntary assistance of cinisens is apparent and the necessity for providing in our post war plans for a suitable opportunity of the hearing of opinions is indicated.

#### 5. TOWN PLANNING

By town planning I refer to the location of school buildings, parks, recreational facilities, location of commercial and residential areas which is a science in itself.

All of the public works which are proposed for post war Halifax must conform to a well designed

plan to leave room for adequate park and recreational space so badly needed in many parts of the City. In other words, we must intergrate all of our plans so as to place buildings, commercial districts, residential districts, recreational centres, school buildings, where they can be utilized to full advantage by all citizens.

Types of construction, building regulations as to sanitary facilities, etc., will require careful consideration.

#### CONCLUSIONS:

At the last session of the Legislature we secured legislation authorizing the City to spend a sum not exceeding \$5,000.00 for the purpose of defraying any expense incurred by any Committee of the Council for the purpose of studying post war conditions as the same may affect the City and in particular the problems of housing and slum clearance.

For the purpose of initiating your debate as to the procedure to be followed to achieve what I have already referred to as a "master plan" for our guidance when the war ends, I respectfully suggest the following course to be adopted:

- (1) That the holding of hearings, the receiving of briefs, and the preparation of post war plans for the City of Halifax be assigned to a Committee of three qualified and representative citizens.
- (2) That the said Committee be authorized to spend the sum of \$5,000.00 authorized by the City Charter for the purpose of defraying any expenditures which they may incur in the carrying out of their duties.
- (3) That the members of the Committee be nominated by the Mayor and be approved by the Finance and Executive Committee.
- (4) That the Finance and Executive Committee be authorized to draft the terms of reference for the guidance of the said Committee.

#### OFFICE OF THE MAYOR

MEMBERS OF THE CITY COUNCIL:-

Gentlement-

The purpose of this meeting today is to place before you certain proposals as a basis for further reorganization of civic affairs as rapidly as it is in our power to enact same.

Before dealing specifically with the proposate which I wish to bring to your attention, I ask your forgiveness for any apparent delay in conferring with you on many matters of major importance to the progress of our City. The death of my father, followed closely by the passing of my father-in-law shortly after I was elected to office together with the need for a short holiday and the holiday season for staff-made it necessary to defer matters which require the serious consideration of the whole Council.

There are three matters which require your advice and direction. For purposes of discussion, I classify them as follows:

(1) The Complete revision of the City Charter. (2) The need for a full-time Executive Director of

all branches of Civic Service.
(3) The re-organization of Engineering personnel.

#### 1. CITY CHARTER

When attending the Mayor's Conference at Ottawa and on any other occasions when it was possible to do so, I have informally discussed with representatives of other Canadian Cities, Dominion and Provincial Government officials, the method of control of Municipal Affairs by Provincial authorities.

The result of my enquiries confirms an opinion which I have held for some time past that many of the provisions in the City Charter which can only be altered by the Provincial Legislature, should be in the form of Ordinances and Regulations determined by the City Council without reference to the Legislature.

The independent auditors have recommended that the general accounting system of the City should be further re-organized to conform with the standard precedure of accounting, adopted for all. Municipalities by the Dominion Bureau of Statistics and the Provincial Department of Municipal Affairs, By adopting this recommendation of the auditors, much of the financial information which you require on which to base your decision as Aldermen will be simplified. Furthermore, it should be easier to compare the financial affairs of our City with other Canadian cities. It is only by comparison and exchange of views with other communities that we can maintain a progressive City comparable to other Canadian cities.

The fiscal year of the City, ending as it does at April 30th, causes confusion in the minds of taxpayers when dealing with tax accounts. The calendar year basis for our fiscal year would contribute much to simplifying financial and related problems. On many occasions we are faced with pro-. viding funds for capatal expenditures which were not forseen at the last session of the Legislature. The present procedure is such that we must wait until the next session of that body before we have the the power to proceed with our plans. The Municipal Affairs Department of the Province has the power in the case of municipalities to grant approval for bond issue without reference to the Legislature. The tipo has arrived when the City must endeavour to achievo the same measure of autonomy though perhaps by a somewhat different method.

Following the recent Civic elections, all candidates were unanimous in their opinion that the provisions in the City Charter dealing with the taxpayers; eligibility to vote, leaves much to be desired. Each of the Mayoralty candidates, following the election, received mail sacks of returned election literature. This appears to be the result of the preparation of the voter's lists from previous year tax rolls, rather than current records. It is obvious in any event, that we should concentrate our attentions on the clauses of the Charter which deal with qualifications of voters.

Building regulations must be made to conform rapidly and be kept uniform with standard practices in effect in Canada, particularly during the reconstruction period. These regulations would be more effective if amendable by the Council as Ordinances or by automatic adoption of National Building Codes as they become effective.

In short, my observation with reference to the City Charter indicate that if the City of Halifax is to have the necessary degree of flexibility in control of its affairs to meet the demands of post war conditions; the City Charter should be revised in a manner which would place many of the provisions there of under the control of the Council, without reference to the Legislature. The scope of the revision can only be achieved by very careful scrutiny, by very careful analysis of our Charter rights and powers and with the co-operation of the Provincial Government through its Municipal Affairs Department.

# 2. THE NEED FOR A FULL TIME EXECUTIVE DIRECTOR OF ALL BRANCHES OF CIVIC SERVICES.

The City Council in the past few years has made many progressive steps towards improving civic administration. Post war conditions will require all the ingenuity and resourcefulness of the City Council. We must not be hindered by consideration of internal administrative problems. Therefore, if all of our energies are to be devoted in the post war period to the serious task of re-construction, we must now organize our affairs so as to take full advantage of the professional skill and experience of our civil servants.

It is my opinion that the greatest degree of efficiency in the administration of civic affairs and in the carrying out of the policies of the Council will be accomplished by the appointment of an Executive Director of all branches of civic services. His task will be mainly that of acting as a liasion officer between the Council and the civil service and to co-ordinate all branches of civic functions. As a result of our recent re-organization we find professionally trained and skilled men at the head of our four main divisions of service - an Engineer as the Commissioner of Works; a public health trained medical doctor as Commissioner offHealth; a Chartered Accountant as Commissioner of Finance. The next stop we should seriously consider and which has been suggested by this Council on previous occasions is the appointment of a Commissioner of Safety, At the present moment, however, there is obviously lacking a Head to these heads of departmentso

At the present time much of the executive assistance rendered to the Mayor is carried out by the City Solicitor.

It is my opinion that the City Solicitor should become the Chief Commissioner of the City of Halifax and in effect the Executive Director of all Services.

It has been for many years a charter provision that the Mayor of Halifax should not continue in office beyond a period of three years. If that policy is to be sustained then continuity of planning on long-term views can only be preserved by a full-time Executive Director. Such an executive would be a very highly desirable insurance against variations in the executive policy of future mayors.

#### 3. THE RE-ORGANIZATION OF ENGINEERING PERSONNEL

On Thursday night, it is proposed to ask the Council to consider the recommendation under which a Post War Planning Commission is to be established. Without burdening you with the details of this plan, may I briefly state that when considering the approach to this very important and complex problem, I was impressed with the urgent need of an Engineer with executive ability to direct all engineering services of the City. The Post War Planning Commission will require from the Engineering Branch of our Civic Government considerable information, and in detail,

as to public works which the City will undertake with the cessation of hostilities.

It is my carefully considered opinion that the present Commissioner of Works, Mr. MacKinnon, while he has given faithful services and possesses professional and practical engineering qualifications, lacks the necessary executive ability demanded of a Commissioner of Works, in present, as well as post war Halifax.

I have recently conferred with an Engineer whom I believe possesses the desired qualifications.

I submit, for your consideration, the proposal that we should obtain the services of the Engineer in question as Commissioner of Works. It may be necessary to offer him a salary substantially in advance of that paid at present to Mr. MacKinnon. Nevertheless, whatever the advance in salary may be, I feel that the savings effected in future engineering projects will more than offset the increased salary which may be necessary.

I wish to make it abundantly clear that it is only Mr. Mackinnon's lack of executive ability in the light of the tasks which lay ahead of us that I ask you to consider the aforementioned proposal.

Mr. Mackinnon should continue on at his present salary in the capacity of a Chief Engineer advising the new Commissioner of Works. The other personnel in the Engineering Department should have their official designations and duties revised to conform to the proposals of re-organization.

Alderman Walker asked if any provision had been made for supplying gas masks to members of the Police and Fire Departments and also if the matter of erecting fire escapes in the City Hall had been considered.

His Worship the Mayor stated that the Chiefs of the Police and Fire Departments would be requested to report on the matter of gas masks and the Commissioner of Works on the matter of fire hazards in the City Hall.

Alderman Ahern asked if it would not be possible to establish Coal Dumps at the City Field and Incinerator Field.

His Worship the Mayor stated that some enquiries should be made and suggested that Alderman

Ahern and the City Solicitor interview the Fuel Controller on the matter,

Alderman Burgess referred to a case where a heavy crane was moved along Robie Street recently and as a result of this, considerable damage was caused to the surface of the street. He understood the Chief of Police had given the company permission to move the crane, but he questioned very much if the Chief of Police had such authority.

The Chief of Police when asked by His Worship the Mayor to give an explanation, stated that the company had written to him requesting permission to move the crane and he had granted permission as traffic authority only and if any damage were caused to the street, it would be entirely at the company's risk.

At the suggestion of Alderman Coffin, the matter was referred to the Committee on Works and the Chief of Police requested to furnish the Committee with copies of all correspondence he has on the subject.

Alderman Burgess remarked that he noticed a number of vacant houses on Brunswick Street and wondered if they could be utilized to assist in relieving the housing situation.

His Worship the Mayor stated that he had made enquiries about these houses and was advised that they are undergoing alterations and when ready, they will be occupied by N. C. O's in the Army.

Alderman Walker stated that he understood the Brookfield Construction Company was using one of the prefabricated houses at Ardmore for storing paints and tools. He felt that the Company should build a shack for this purpose and release the house for the use of a family.

His Worship the Mayor remarked that he would have Mr. McManus inquire into the matter.
