Gentlemen: -

I attach hereto draft agreement between the City and His Majesty the King relative to the

exchange of land between the City and Mis Majesty. The land being conveyed by the City is the remaining portion of land owned by the City lying southwardly of a line 125 feet southwardly of and parallel to the projection eastwardly of the southern line of Shirley Street.

The agreement provides a minimum value for the land which the City is conveying, namely \$35,000.00, but the agreement contemplates that within two years or such other period as may be agreed upon His Majesty will convey to the City other lands in the City owned by him and acceptable to the City in exchange for the lands now conveyed on Camp Hill.

In view of the great amount of exempt property in this City an agreement of this kind will tend to prevent an increase in the land acquired and held by the Crown in the right of the Dominion of Canada. It must be borne in mind also that the sale of land by the City to an exempted owner is of no benefit to the City, in spite of the fact that a reasonable price is paid by such purchaser.

I am very pleased to be able to report that these negotiations have come to the conclusion which I hoped they would at the beginning and if the policy of trying to narrow down exempted property in the City is carried on, the City will receive the benefit therefrom in future years, which, together with any sums realizeable by the City in taxes from owners now claiming exemption, should assist the City greatly in financing the services which it is obliged to render.

I would recommend that your Committee consider this agreement and recommend it to the Council for execution on behalf of the City by the Mayor and Clerk. I would also suggest that it go to the City Council by way of the Finance and Executive Committee.

# LETTER HIS WORSHIP THE MAYOR RE HALIFAX CIVIL EMERGENCY EXPENDITURES....

The Deputy Mayor assumes the Chair while His Worship the Mayor reads the following letter from the floor at 9.30 P. M.

November 16, 1944.

# MEMBERS OF THE CITY COUNCIL

#### Dear Aldermen:

There are two matters which require your attention at this time -- (a) The Hallfax Citizen's Rehabilitation Committee, and (b) The "V" Day Preparations of the Hallfax Civil Emergency Committee.

Both of the aforementioned committees have been giving careful consideration to the respective problems, and both will require funds for the purpose of carrying out their work.

It is my opinion that the City Council should appoint two Aldermen to each of the aforementioned committees so that the Council may be kept informed of the progress and undertakings of the said Committees.

Inasmuch as we are not aware of the actual time on which our "V" Day preparations will be utilized and as the need for immediate action by the Citizen's Rehabilitation Committee is apparent, I recommend that you make the aforementioned appointments tonight.

I conferred today with Messrs. Bethune, Sherman and Bellew with respect to the provision of funds for the undertakings mentioned herein.

As a result of that conference, it is recommended to you for the purpose of financing the expenses of the Halifax Citizen's Rehabilitation Committee, and of the Halifax Civil Emergency Committee for "V" Day preparations, the Contingent account shall be made available on the basis that expenditures for the above purposes are of a kind to be legitimately and reasonably paid from funds of the City, and that such expenditures be regarded as the business of the City.

expenditures incurred before December 31 next exceed the appropriation provided in the estimates for the Contingent account, such appropriation shall be supplemented under the authority of sub-section (6) of section 314 of the City Charter. (Chap.44, section 6, 1944).

That any expenditures incurred for the aforementioned purposes subsequent to January 1, and prior to the completion of the estimates for 1945 shall be deemed to be necessary expenditures, and shall be included in the appropriation for the Contingent account for 1945.

That in any event, the aforementioned expenditures subject to further action by the County shall not exceed (.) \$5000 and (b) \$5000 for the requirements of the Helifax Citizen's Rehabilitation Committee.

His Worship the Mayor continued by stating that
the Civil Emergency Committee is required to prepare
for V Day when it occurs. It is in the nature of an
emergency. There might be some destruction of proper
when that day occurs. I felt that we must have the account of the contract of th

Alderman Coffin is on that Committee and I was going to suggest that he be appointed to the Executive Committee along with Alderman DeWolf for the purpose of representing the Council on this matter.

Then the Halifax Citizen's Rehabilitation Committee is another item. There is a great deal of work
to prepare in this respect. Col. Mingo and the Committee have compiled a list of all men and women who
enlisted in the services and we have secured some
volunteer workers also. We will have to find out the
status of the Merchant Seamen. Both of these items
are extremely important and they must be proceeded
with at once. Now is the time to do this and I so
recommend them to you.

I wish to name to the Halifax Civilian Rehabilitation Committee, Aldermen Batson and Hosterman, as I feel that the Aldermen should know more about it. They might be called upon to visit a train or ship. The purpose of this is to provide an official from this Council whenever a train or ship strives in Halifax to greet the lads when they return.

Alderman Walker asked if this fund could be used by the Alderman for the purpose of sending telegrams to which His Worship the Mayor replied that the Red Cross and the Canadian Legion look after a lot of work required at the Pier.

I would like to see these lads supplied with two Halifax papers when they arrive. It provides us with an opportunity of seeing how these lads are treated when they arrive. Anything that happens in Halifax, whether we are responsible or not, the City gets the

bad reputation. The money is really required for stationery and for some recognition for those who have returned to show appreciation for what they have done.

Alderman Batson stated that he saw why His Worship the Mayor wanted the Alderman on this Committee and asked His Worship the Mayor what this money would be used for.

His Worship the Mayor stated that it may be used for the purpose of presenting colors to the  $\hat{P}_{o}$  L. F. Unit or we might be able to have a small luncheon for them. There is the matter of stationery and suitable arrangements have to be made if Haligonians returned at once should the war end. The alternative is to render assistance wherever possible to give the service man every benefit for reinstatement back to civil life.

9:40.--P. M., His Worship the Mayor resumes the Chair.

Alderman Walker contended that we should ask them what they want as they will have more ideas than we have. They will have a better idea of what they want when they get home.

Moved by Alderman Ahern, seconded by Alderman Batson that the recommendations as contained in the letter of His Worship the Mayor be approved and also that he name two Alderman to the Civil Emergency Committee and two Alderman to the Halifax Citizen's Rehabilitation Committee. Motion passed.

His Worship the Mayor then named Aldermen Batson and Hosterman to the Halifax Citizen's Rehabilitation Committee and Aldermen Coffin and DeWolf to the Executive of the Halifax Civil Emergency Committee.

#### QUESTIONS

Alderman Batson speaking in regard to the entrance of the City Hall at the Grand Parade stated that it was very dark and asked if something could not be done about the lights.

The matter was referred to Mr. Durling.

Alderman Walker asked if there was any money available to help the children who might want to play hockey.

Alderman Ahern in reply, stated that some time ago the Recreation Committee held a Tag Day and had raised around \$1,000.00. We bought \$350.00 worth of hockey equipment, donated \$25.00 to the Minor Hockey Association and the rest is in the bank. We still have a fund of \$2,400.00 for the school children. We have \$3,000.00 to be used for putting up rinks and Judge J. Elliott Hudson and I looked over about 20 places for rinks. We have 6 dozen hockey sticks and other equipment.

Alderman Walker stated that that is what he wanted to know.

His Worship the Mayor advised the Alderman to apply to the Chairman of the Committee.

Alderman DeWolf speaking in regard to the A. R. P. stated that in other cities the paid officials have been eliminated or reduced and asked for information regarding this.

9:45 p. m. -- The Deputy Mayor assumes the Chair while His Worship the Mayor addresses the Council from the floor.

His Worship the Mayor read the following letter:

#### CIVILIAN DEFENCE

Some two months ago at the request of the Director who expressed a desire to be relieved of his duties as soon as practicable after the danger of an emergency was passed, the H.C.E.C. Executive reviewed the situation carefully and consulted military and Civil Defence Authorities. We were confirmed in our opinion that the danger of an emergency in Halifax has most definitely not passed. The situation of this port is in many respects unique because of its key position in the Allied War Effort. I cannot divulge full details. Suffice it to say that the Military are at great expense, maintaining their coastel and anti-aircreft defences at full efficiency and if the dangers for which they are so ceaselessly on guard should materialize, the Civil Defence organization, which is closely coordinated with the Armed Defences, would be very busy. These Civil Defence duties cannot be performed by the Military.

In addition, quite aside from enemy action, there is the ever present danger of an explosion. We have not forgotten 1917 and I do not need to remind you not forgotten passing through this port now are very that supplies passing through this port now are very large, considerably greater than in 1917, and despite every care, accidents can happen. In fact, there every care, accidents can happen. In fact, there have been several narrow escapes already during this war which may well occur at any time. This danger will probably not be over until war supplied cease to pass through this port.

We have been advised in confidence, of other hazards which I cannot refer to here. Your Executive decided at their meeting of September 14, that we cannot accept the responsibility of relaxing our defence arrangements and unanimously agreed that the Civil Defence Organization and the Office of Director of Civil Defence should be maintained. (Of course, of Civil Defence should be maintained. (Of course, some of our arrangements may change just as the form and extent of some of our dangers change. For example blackouts may be less important, lighting arrangements may be revised by the proper authorities, but these are but minor phases in our defence arrangements.)

The amount which we spend on Civil Defence, about two-thirds of which is refunded to the City, is a mere pittance whether compared to expenditures of the Armed Forces in preparing for similar tures or with the loss of life and property which an alert Civil Defence organization would materially reduce.

Our administrative costs are very low as compared to other vital centres and I believe our organization compares favourably with those where the paid staff, doing the same work as ours, is much larger. At times we have considered increasing it, but have managed to get along without doing so.

Possibly some people may think that the doing away with blackout practices has materially reduced the work of the Civil Defence office. This is not so. Blackouts were never more than a minor part of the duties of the Director and in fact were not even mentioned in the long list of responsibilities which he was asked to undertake. I haven't time to elaborate these. However, I will say that the Civil Defence Organization is a large one with thousands of members, well over a hundred separate groups and some thirty different branches. The supervision of these groups and their training and equipment and the coordination of the different branches is no small task, not to mention the many problems, large or small, which arise daily, the supervision of emergency supplies and equipment, the keeping of records of over 6000 personnel and the materials issued to them.

We have on our charge, supplies belonging to the Federal and the Provincial Civil Defence, the city and other bodies, running into many thousands of dollars, in fact, considerably in excess of \$100,000.00

The Actual outlay of funds of this Committee since its inception in September 12/41 to April 30/44, was approximately \$60,038.59, of which \$38.295.49 has been refunded from Federal and Provincial Funds leaving a net cost to April 30/44 of \$21,745.10 Funds leaving a net cost to April 30/44 of \$21,745.10 approximately 1/3 of this net amount is represented by usable amounts.

The Civil Defence organization is no small one but it is run so economically that the cost to the city is very little. Your H.C.E.C. Executive met again yesterday, November 15, with a representative of Fortress Headquarters. We again reviewed the situation carefully and again are of the unanimous opinion ation carefully and again are of the unanimous opinion that the danger of an emergency is by no means past, that we must continue our preparedness and that no change be made at present which might endanger the efficiency of our organization.

His Worship the Mayor stated that half of Mr. Crowell's salary is paid by Ottawa. He further stated that that is why he wanted members from Council to be appointed on this Committee to know what is going on.

9:50 P. M. -- His Worship the Mayor resumes the Chair.

Alderman DeWolf stated that he appreciated the report and made it known that there was nothing personal when he made the suggestion. I think the whole expense should be borne by the Dominion Government.

Alderman Ahern stated that the other day an employee of the Works Department had died after 32 years of service and Mr. MacKinnon had told him that this party would not receive any pay after November 16.

This man has a number of children and I would like this Council to make a grant to the family. He has certain monies coming to him after the estate is settled. I feel that in view of his condition he would have received some small pension from the City. We should carry this man on the pay roll for three months.

His Worship the Mayor stated that the next meeting of the Committee on Works can take this matter up for discussion.

Alderman Burgess asked if it had been the practice to carry the family for three months.

Alderman Walker asked what had happened in the case of "Landry" to which Mr. MacKinnon replied that he was kept on the payroll during sickness.

Moved by Alderman Batson, seconded by Alderman Ahern that this matter be referred to the Committee on Works. Motion passed.

Alderman Walker requested His Worship the Mayor to name a Committee consisting of two Alderman to deal with future cases.

Alderman Reardon stated that in matters of this nature they should be brought up to the Committee concerned.

Alderman Ahern stated that he did not receive any intimation of this case before the Council meeting tonight.

Alderman Walker stated that Water Street was in very poor condition and should be paved from one end to the other as there is a very great amount of traffic on that street and asked why this was not done.

His Worship the Mayor replied that it/was up to the Council for action.

Alderman Walker stated that he would bring it up at the next meeting of the Committee on Works.

# LETTER TRADES & LABOR COUNCIL

His Worship the Mayor read the following letter: November 16, 1944.

To His Worship the Mayor and Members of the City Council, City Hall, HALIFAX, N. S.

Gentlemen:-

At the last regular meeting of the Halifax District Trades and Labor Council a communication was read from the Allied Civic Unions protesting against recent appointements to the newly formed water Commission, and claiming absolute discrimination against present civic employees who are quite capable of filling any of the positions that this Commission have, or may have in the future.

Having in mind that the Mayor and the City Council of Halifax in their wisdom and judgment saw fit to recognize all civic bodies affiliated with recognized labor, we deplore the fact that any committee or commission subordinate to the City Council would try to break down the good will that exists between the City Fathers and recognized labor, and as representatives of thousands of tax payers of this City we strongly protest the action against those appointments, and deprotest the action against those appointments, and deprotest the interpolation and those at present employed by the City and members of those civic unions have at least the opportunity of applying for the position.

His Worship the Mayor replied "if they were qualified". There were only two cases where it was not done. There was the case of the Meterman; the men were looked over and the Manager felt that it was necessary to obtain an outside person. The other matter was the man at Spruce Hill Lake. The Manager and myself met with the Union and discussed with them this whole question. There were two other employees concerned and they had not answered the add that was in the paper.

Alderman Burgess stated that if we can't find a man in the City's employ that is qualified then we would have to go outside.

Moved by Alderman Burgess, seconded by Alderman Walker that His Worship the Mayor be instructed to reply to this letter. Motion passed.

WHEREAS by section 7A of Chapter 3 of the Acts of 1939, The Municipal Affairs Act, as that Section is enacted by Chapter 38 of the Acts of 1944, it is enacted among other things, in effect, that notwithstanding any of the provisions of any general or special Act of the Legislature of Nova Scotia, the City of Halifax shall have full power and authority to borrow or raise by way of loan from time to time on the credit of the said City, such sum or sums as the Council thereof deems necessary for the purpose of constructing, altering, extending, or improving the water works or water system for the City, and acquiring or purchasing materials, machinery, implements and plant deemed requisite or advisable therefor, or for maintaining such water works or water system;

AND WHEREAS by said Section 7A of said The Municipal Affairs Act, as smended, it is enacted, among other things, in effect, that no money shall be so borrowed until such proposed borrowing has been approved by the Minister of Municipal Affairs;

AND WHEREAS by said The Municipal Affairs Act the said sum shall in the discretion of the City Council be borrowed or raised in one sum at one time or in instalments at different times and the sum required shall be borrowed or raised by the issue and sale of debentures of the City to such an amount as such Council deems necessary to raise such sum;

AND WHEREAS it is deemed necessary by the City Council of the City of Halifax to borrow the sum of Two Hundred and Fifty Thousand Dollars (\$250,000.00) for the purpose of:

- (1) Providing an extension to the building for housing chlorinators at Chain Lake and the purchase and installation of two new chlorinators and the purchase and installation of three new flow meters at this point.
- (2) The acquisition of certain lands at the Dutch Village Road Pumping Station to enable the City to control the land surrounding this Station.
- (3) The enlargement of the building at the Dutch Village Road Station with the purchase and installation of additional pumps, meters, and other equipment for the improvement and control of the supply of water to the City mains.
- (4) The purchase and installation of pipe and fittings for the connection with the 24 and 27 mains necessary in connection with the above booster pump installation.

THAT the issue of said debentures be postponed and that the said City do under and by virtue of the provisions of Section 318A of The Halifax City Charter of 1931 borrow from General Current Account a sum or sums of money not exceeding Two Hundred and Fifty Thousand Dollars (\$250,000.00)

Alderman Ahern stated that we discussed this and we felt the Commons should not be idle two thirds of the year and we might be able to get a race track for a short distance where they could hold a few races. It might encourage horse owners of which there are twenty-four. Every effort should be made by the City to establish a track. I find that we must do some business with the military authorities and I feel the Council should favor the idea generally. We are going to have that place graded without cost.

His Worship the Mayor stated that he thought it was premature to come to any decision regarding the North Common. The Civic Planning Commission is meeting with the Safety Committee on Thursday night for a joint meeting and arrangements are being made to have a meeting with the Council in December and suggestions will be made at the time because they want the Council's view. The final report may take two or three months from there to finalize.

Alderman Burgess asked, "You mean the Commission will give us some ruling regarding the Commons?"

His Worship the Mayor replied that they will give us some idea of the future of what we will be faced with.

Alderman Adams asked if the Commissioner of Works or Chief of Police looked into this matter.

Alderman Burgess stated that the drivers have guaranteed the safety and also assured us that any damages to citizens will be looked after.

Alderman Batson stated that he understood it was the desire of the Riding Club to bank up the race track with earth and said he could see some danger there because there will be crowds watching them. I feel that this thing won't stop at winter racing.

Mr. Gordon Mitchell a representative of the Halifax Harness Horse Club was in the Council Chamber and after Council granted him permission to speak, he remarked as follows:

\*I am Vice President of the Club. As you know in other Cities they race on the ice and they race on the

main street which we are not asking for. We are just asking to have a track. We held thirteen ice meets on Governor's Lake last winter. There is no such thing as banking the track. The Club is taking out an insurance policy in case of accidents.

Moved by Alderman Ahern, seconded by Alderman Burgess that (1) the Halifax Harness Horse Club be granted permission through the Recreation Committee to utilize space on the North Commons suitable for the purpose of horse racing (2) it be clearly understood that this permission be granted annually for only at such times as the Commons is free, and (3) it is only temporary for the winter months.

Alderman Walker wanted to know if there would be a special police there to which Mr. Mitchell replied the Club will pay for the services of special Police.

The motion was then put and passed unanimously.

#### LETTER CITY ASSESSOR RE NATIONAL CONFERENCE ASSESSMENT ADMINISTRATION

November 6, 1944.

His Worship the Mayor and Members of City Council, City Hall, Halifax, N. S.

Gentlemen:-

I beg to report on my attendance at the Eleventh National Conference on Assessment Administration held at Des Moines, Iowa, October 3rd, 4th, and 5th.

The conference was attended by two hundred and forty-eight assessing officers of the United States and Canada.

The opening morning of the Conference was devoted to ordinary routine of all conventions, namely, the addresses of welcome, the president's report and appointment of Committees.

Three metters were discussed in the afternoon of the first day, namely: "Federal Land Bogey" "Post War Housing Problem;" and "An Apprisal of the Occupancy Tax."

The first topic dealt entirely with Federal owned property in the United States, while the third was a review of the English system of taxation on occupants only.

### Post War Housing Problem

Wm. K. Divers, Local Administrator of the National Housing Agency for Iowa, read a paper prepared by John B. Blandford, Jr., Administrator of the National Housing Agency. Looking at the housing question of the future there must be "close and harmonious co-operation among all branches of government--local, state and federal, based on clear cut identification of respective responsibilities and on a common understanding of mutual objectives."

In post war housing consideration must be given to the following factors; Planning, zoning, construction, site location, and quality of living. People will choose cities in respect of living conditions and not in respect to position obtainable.

Mr. Blandford in his paper dealt with the present wartime overbuilding and its effect on the future.

The disposition of wartime housing is a matter to be dealt with by the Federal Government. There were 400,000 prefabricated dwellings erected at an average cost of \$2,800.00 on these properties "the administrator makes payments in lieu of taxes to the administrator makes payments in amounts which approxistates and local communities in amounts which approximate the taxes that would be paid if the property were not tax exempt. All these temporary houses to be removed within two years after the war, except in cases where, after consultation with the local community it is felt there is further need for them.

It is estimated there are 7,000,000 substandard dwellings which must be replaced. 1,400,000 married men in the services, will require housing and hence it is estimated 400,000 houses a year will be required during the first post war decade.

Mr. Blandford's paper is very interesting and I have a copy in my office for those who are interested in reading it.

During the second day's proceedings the following topics were discussed; "Personal property assessments;" "Recent problems in utility assessments;" "Assessments of 'Orphan' Lots;" "Taxation of air Transportation;" "Far income values and Assessments."

These matters consisted almost entirely of discussions of personal property assessments.

The most interesting and I would say, most instructive matter discussed in the entire Conference was: "To what extent should assessments be adjusted to current price levels?"

There was a panel discussion opening the matter followed by a general discussion from the floor. Incidents of great increase in sales prices, such as we have here, were cited. The general opinion of the discussion, however, was that Assessors should not be guided by present day sales but to get at the real value of the property. If this procedure was not followed it would tend to lead to uncertainity in the assessment rolls, which might have far-reaching consequences, such as an inflated assessment roll which would effect the sale of the municipalities' bonds.

Canadian Assessors, up until this year, were associate members, but by an amendment adopted by the Conference, they are now eligible for full membership, the annual fee for same being \$10.00 per annum.

I wish to thank Council for permitting me to attend the Conference and trust I have received some information which will be of benefit to the City.

Halifax, N. S., Council Chamber, City Hall, December 14, 1944, 8:00 P. M.

A meeting of the City Council was held on the above date.

After the meeting was called to order by the Chairman and before considering the regular order of business, the members of Council attending, led by the City Clerk, joined in repeating the Lord's Prayer.

There were present His Worship the Mayor, Chairman; Aldermen Batson, Reardon, Breen, Hosterman, Adams, DeWolf, Doyle, Walker, Burgess and Ahern.

The meeting was called to proceed with business standing over and the transaction of other business.

The following named papers were submitted.

### MINUTES

Moved by Alderman Ahern, seconded by Alderman Adams that the minutes of the previous meetings be approved. Motion passed.

#### ACCOUNTS

A resolution covering the accounts of the various Committees was submitted as follows:

RESOLVED that the Council approve for payment the bills and accounts of expenditures submitted to this meeting by the Finance and Executive Committee amounting to \$11,917.81; the Committee on Safety amounting to \$615.83 chargeable to Fire Alarm;

\$21,416.68 chargeable to Fire Department and \$11,439.97 chargeable to Police Department; the Committee on Public Health and Welfare amounting to \$14,705.40 chargeable to Health Department; \$8,780.31 chargeable to City Home and \$2,649.54 chargeable to City Prison; the Committee on Works amounting to \$25,821.21; the Directors of Point Pleasant Perk amounting to \$496.38 under the provisions of Section 315 of the City Charter.

## LEASE TO NAVY LEAGUE OF CANADA

Read report of the Finance and Executive Committee as follows:

December g/44.

To His Worship the Mayor and Members of the City Council.

Gentlemen:-

At a meeting of the Finance and Executive Committee held on the above date, the matter of the lease of property on Bell Road to the Crown on which it is proposed an auditorium and recreational building will be erected, same to be operated by the Navy League of Canada, was considered.

It was agreed to recommend to Council:

- 1. That the terms of lease as explained by the City Solicitor in a letter under date of August 8/44, to J. E. Ahern, Esq., Deputy Mayor, be approved.
- 2. That the plans and specifications for the proposed building be submitted to the Commissioner of Works for the purpose of ascertaining if same comply with the building regulations of the City of Halifax.

That the management of the building after the cessation of hostilities with Germany, be under the joint control of the City and the Navy League of Canada, with each having equal representation on the Board.

Moved by Alderman Reardon, seconded by Alderman Hosterman that the report be approved.

Alderman Ahern stated that he would like to see this matter referred to the Recreation Committee as there seems to be some misunderstanding about the matter. Some say this is going to be a dance hall end some a recreation hall.

Council agreed to hear Mr. Major on this matter and he addressed the Council as follows: "This building is going to be used for dances, pictures and concerts on the main floor and in the basement there will be bowling alleys.

Alderman Walker contended that this building should be moved so as not to interfere with the Public Gerdens. There are all kinds of halls in the City that are empty.

His Worship the Mayor asked the Alderman to name them.

Alderman Walker named the Forum, the Armouries and some others.

Alderman Burgess stated that they have the Forum now as a dance hall. If they put up this other building it will just about eliminate other people from running dance halls and it is not fair to them. This property will be tax free while the other people

have to pay taxes for their halls.

Moved in amendment by Alderman Ahern, seconded by Alderman Doyle that this matter be referred to the Recreation Committee for further consideration and report.

Alderman Reardon stated that he didn't think this building had any similarity with other buildings in the City and that it was only for the duration of the war, it would not interfere with business men in the City because if it did, I would be against it. We should be able to make some final decision tonight.

Alderman Adams asked if there was a clause covering the period of years in the lease to which His Worship the Mayor replied the term was five years and renewal at the end of that period.

Alderman Adems stated that he was in favor of the building but not the site. He contended that it was too near the canteen and suggested that it be built at the Corner of North Park and Cogswell Streets which would be close to the tram cars.

Alderman DeWolf stated that if they don't get this site they are being offered another site by the Provincial Government and that we would not be losing anything.

Alderman Hosterman stated that he agreed with Alderman DeWolf on the matter. He said that we were not losing any valuable ground and that it was not interfering with the business man. There was in the minds of the Alderman that the present clauses in the suggested lesse did not afford the corporation enough protection. The main issue is that there

should be joint representation between the City of Halifax and the Navy League of Canada.

Alderman Betson stated that he favoured it but he wanted it distinctly understood that there will be no connection with any other building there.

His Worship the Mayor asked Mr. Dunlop who was representing the Navy League when the lease expired would the City have the priority to buy the building before anyone else to which Mr. Dunlop replied in the affirmative.

# HALIFAX PUBLIC UTILITIES COMMISSION

Read report of the Finance and Executive Committee as follows:

December 13/44.

To His Worship the Mayor and Members of the City Council.

Gentlemen:-

At a meeting of the Finance and Executive Committee held this date, at which were present the members of the Halifax Public Utilities Commission, the matter of the transferring of the assets constituting the water system of the City to the Commission was under consideration.

After discussing the matter for some time the following resolution was unanimously approved:

RESOLVED that this Committee recommend to the City Council:

- That the City do transfer, deliver and convey unto the Halifax Public Utilities Commission as of December 31st, 1944, for and in consideration of the sum of One Dollar, the fixed assets constituting the Halifax Water System, including but not limiting the generality of the lands, including rights of way and easements, all buildings, pumps, chlorinating equipment, dams, mains, hydrants, meters, service pipes and all other equipment including tools, vehicles and machinery in use or available for use in connection with the said water system, on such December 31st, 1944, or which, having been ordered by the City for the purposes of the said water system and not having been delivered prior to such date then upon the delivery thereof.
- That the assets in the Water Emergency Fund (so-called) be transferred and delivered to the Commission as of December 31st, 1944, provided however that should legislative authority be required to transfer and deliver such assets, that such legislation be secured authorizing such transfer and delivery as of December 31st, 1944.
- That the City transfer to the Commission the current essets and liabilities constituting as at December 31st, 1944, the working capital of the said Halifax Water System.
- that the City lease to the Commission that portion of the City Field which the Commission sioner of Works and the Manager of the Commission agreed upon at a recent meeting of the Committee on Works for use by the Commission and for its purposes as of December 31st, 1944, at a nominal annual rental of One Dollar and for the term of one year from December 31st, 1944, provided however that upon an agreement being reached between the City and the Commission prior to December 31st, 1945 as to an adequate rental and the ultimate term of the said lease that such rental and term relate back to December 31st, 1944, and be effective as and from that date.
- 5. Due to the fact that the period included in the first billing for rates by the Commission will include the accrued revenue for the months of November and December, 1944, that an allocation of such revenue be made for such two months between the Commission and the City, and the proportion allocated to the City be placed to the credit of the assets of the water system as of December 31st, 1944.

That prior to December 31st, 1945, the City and the Commission will agree upon the amount of such further sum, if any, as may be paid by the Commission to the City as additional compensation for the transfer by the City to the Commission of the assets above referred to and/or any other terms and conditions which may be required to be settled arising out of such transfer.

7. That any difference existing between the current assets and current liabilities of the Commission shall be considered when establishing the amount of any additional compensation to be paid by the Commission to the City as set out in the preceding paragraph.

### AMENDMENT TO ORDINANCE # 23

BE IT ENACTED by the Mayor and City Council of the City of Halifax as follows:

- 1. Section 3 of Ordinance No. 23 is repealed and the following substituted therefor:
  - (3) "Barber shops shall open in the City of Halifax not earlier than eight o'clock in the morning and shall close at six o'clock in the afternoon on each day with the following exceptions, viz:
  - (a) They may remain open until eight o'clock in the evenings on Saturday and on any day preceding a public holiday.
  - (b) They shall close at 12.30 o'clock in the afternoon on every Wednesday except on a Wednesday in any week in which a public holiday occurs, in which case there shall be no half holiday on Wednesday.
  - (c) Where the holiday occurs on a Monday, they shall be permitted to remain open in the forenoon up to 12 o'clock at noon on that day.
  - (d) Except as is provided in Clause (c) hereof they shell remain closed on every day which is declared by statute or proclamation to be a public holiday."

Moved by Alderman Batson, seconded by Alderman Ahern that the amendment to Ordinance #23 as set out above be read and passed a first time, and referred to the Finance and Executive Committee. Motion passed.
