#### QUESTIONS

Alderman Hosterman referred to the slippery condition of the floors in the corridors of the City Hall and stated that he fell recently on entering the

building; he felt that directions should be given to discontinue the use of wax on the floors otherwise someone may be injured and bring an action against the City.

Mr. MacKinnon was requested to look after this matter.

Alderman Batson asked if the nails had been picked up in the parade as yet to which Alderman Hosterman replied that it had been looked after.

Alderman Hosterman drew attention to the flood of water that accumulates at the foot of Cogswell Street on Brunswick Street ofter a heavy rain and asked if something could not be done to remedy this situation and suggested — it would not be a matter of a difficult feat of engineering.

Mr. R. M. Mackinnon, the Commissioner of Works, was requested to report on this matter at the next meeting of Council and also the flooring in City Hell.

Alderman DeWolf referred to an item he read in the paper respecting a statement made by the Provincial Treasurer of Saskatchewan who said that Halifax is a terrible place to live in. He stated that perhaps it might be alright for a private person to make a statement like that but not a man in public life. He suggested that a letter be written to the gentleman in question asking him to clarify his remarks.

Alderman Ahern stated that he agreed with Alderman DeWolf.

Alderman Coffin stated that he thought this was an important matter; there were men who suffered as a result of these disturbances which occurred on V-E Day

whose sons have been overseas and have distinguished records. "I think some words should come from this Council expressing our resentment. We should send a letter to the Attorney General also."

Alderman DeWolf stated that the comment regarding Halifax as a place to live in has been broadcast far and wide and he would like to know what the trouble is.

His Worship the Mayor stated that we will have a letter of protest prepared and send it to this person and also a letter to the Attorney General asking him to take remedial action.

Alderman Ahern wanted to know if the City was authorized to expropriate the MacLeod property across the N. W. Arm as yet.

The City Solicitor replied that no action has been taken as yet by the Council; it will be necessary to pass a formal resolution and pay a sum of money into Court.

Alderman Hosterman stated that he saw an article in the Halifax Mail dealing with the manner in which the town of Amherst handles land owned by the Corporation. The Mail suggests that we sell our land for the assessed value or at least the amount of the taxes. The Alderman stated that this has been the practice of the Finance and Executive Committee of this City for a long time.

Alderman Burgess stated that the Public Service .

Commission is making a survey on the Herring Cove Road and endeavouring to give the people water, and asked why waste money on this matter? "Before the Water

Commission puts water in the County we want it in the City where people have no water. The County authorities would not assist the City in the lighting of D.V. Road."

Alderman Ahern stated that he was not against any person in the County getting benefits from the water system but one section in the North End has been asking for water for twelve years. "I think that is the first duty of the water commission."

His Worship the Mayor stated that he would have a report on the matter for Alderman Burgess within a few days.

## CANADIAN FEDERATION MAYORS & MUNICIPALITIES

His Worship the Mayor stated that the convention of the Federation of Mayors and Municipalities is being held during the week of June 21st, and that he planned to attend and take Alderman Hosterman with him.

Moved by Alderman Ahern, seconded by Alderman Burgess that the action of His Worship the Mayor be approved. Motion passed.

Alderman Walker stated that the Citizens' Rehabilitation Committee had asked him to find out what the Council was going to do about the Halifax men returning from overseas in large numbers, as regards giving them a real welcome home.

Alderman Walker then put forth the following suggestion: "I would suggest that His Worship the Mayor and the whole Council get in a tug equipped with a band and go down the Harbour to meet the boat as it comes into the pier. There would be a loud speaker and the Mayor

could go on the air to tell the people that their soldiers are coming home and give the people the routes they will follow so that there would be a large number on hand at the various street corners to give them a real welcome.

Alderman Doyle retires from the meeting at 9.20 .

Alderman Walker continued: "I think that is as good as anything. It won't take long but it will be a good welcome. The Mayor will notify the people that we are coming a certain way and people can then get at the corners and join in."

Alderman Batson stated that the plan outlined by Alderman Walker was the same as when he returned from the Boer War to Portsmouth. There were bands and flags there to greet the returning men. "My own personal reaction was that I felt very proud."

Alderman Walker stated that this is our own regiment from here. We want to let them know what they have done. I would like to have some help from the Alderman.

Alderman Ahern stated that this matter should be given every consideration and that a special meeting should be held.

His Worship the Mayor stated that this matter could be dealt with at the conference to be held shortly.

Alderman Breen asked if there was any provision made for clothing for the Mounted Squad.

Alderman Hosterman replied that the matter was discussed at the last meeting of the Safety Committee and deferred, for further consideration. The Chief of Police

was requested to report as to where the Mounted Squad was on V-E Day.

Alderman Breen asked: "Are they not under the supervision of the Chief of Police?"

His Worship the Mayor stated that the Chief of Police of going to make a written report on the matter.

Numerous requests have been received from John Simon, asking the City to dredge the slipway adjacent to what is commonly known as McFatridge's Wharf on Water Street.

Upon investigation, it was found that such a request had been granted to a former owner in 1926.

The City has no liability in this matter, and is protected by subsection 2 of Section 592 of the Halifax City Charter which reads, -

(2) No action or proceedings of any sort shall be maintained against the City or any individual for, or on account of any deposit of sewage material or other nuisances occasioned by such sewer at the point where the same discharges or on any property near thereto.

When discussing this matter with the Solicitor, Mr. Bethune, we were of the opinion that, as a request of this kind has been complied with in the case of Mr. Simon's predecessors in 1926, and also in another instance for the Commercial Cable Company in 1937, that without prejudice, the same favor should be granted in this case. The sewer outlet which now discharges at the water's edge should be extended to deeper water where the conditions would in all probability discharge water-borne sand and grit in deeper water and would not interfere with shipping at this point.

The estimated cost of dredging is \$2,500.00 and the estimated cost of the sewer extension, approximately 50 to 55 feet, is \$2,000.00.

I may say that we have had several requests from A. M. Smith and Company, Water Street, of a similar nature. The same favor should be granted them. Dredging of both

slipways under the same contract as well as the extension of the sewer would probably result in lower costs than separate arrangements for each project.

### EVENING SESSION

Council Chamber, City Hall, Halifax, N. S., June 14, 1945,

A meeting of the City Council was held on the above date.

After the meeting was called to order by the Chairman and before considering the regular order of business, the members of Council attending, led by the City Clerk, joined in repeating the Lord's Prayer.

There were present His Worship the Mayor Chairman; Aldermen Batson, Moriarty, Coffin, Adams, DeWolf, Doyle, Walker, Burgess and Ahern.

The meeting was called to proceed with business standing over and the transaction of other business.

The following named papers were submitted.

DELEGATION FROM TRADES AND LABOR COUNCIL RE BEER PARLOURS

His Worship the Mayor stated that there was a delegation present from the Halifax District Trades and Labor Council who wished to speak on the matter of Beer Parlours. He asked if the Council was agreeable.

Moved by Alderman Burgess, seconded by Alderman Doyle that the delegation be heard. Motion passed.

Captain J. M. Cody of the Trades and Labor Council addressed the Council as follows: "Your Worship the Mayor and Gentlemen of this Council. We have made representations time and time again before Council and we never got to first base on it. We think we have free speech in our country as long as we don't abuse the King

and we won't do that or don't want to. We have an idea that one of the outstanding reasons for the V-E Day riots was the liquor laws. We believe that had the liquor laws been amended to the extent that beer parlours were in vogue, half of the things would not have been carried out. I make those observations on my own life. In the old days nearly every shop was a beer tavern. Prohibition is a farce and the present sale of liquor also. We are making a line of comparison. I urge this Council to be what we are sending men overseas for to make it some kind of a democracy and not a farce as we have today. I don't know what the taste of intoxicating liquor is but I make these statements because some ship captains don't care to come to our port because they can't come here and get a drink of beer which they can get anywhere else in the Dominion of Canada. #### AMENDMENT

BE IT ENACTED by the City Council of the City of Halifax as follows:-

Ordinance No. 8 of the Ordinances of the City of Halifax is amended by adding thereto the following parts:-

#### Part 2

# RULES AND REGULATIONS FOR GUARDS AND OTHER OFFICERS

- l. All officers of the Prison are required to yield the most strict, prompt and faithful obedience to the orders of the Governor of the Prison in the discharge of whatever duties may be assigned to them, and shall be liable to instant dismissal for any disobedience of same.
- 2. Guards and other officers are prohibited from selling or buying anything from a prisoner, or giving to or receiving from them anything in the nature of a present or conveying to or from them any message, either written or verbal.
- Any ministers, or other religious instructors permitted to attend the Prison shall not receive from or confer any present upon the prisoners, or become the medium of communication between them and their friends or others, and they shall conform to the rules and regulations adopted for the government of the Prison; any infringement or departure from such rules shall debar them from future intercourse with the prisoners.
- 4. Guards and other officers are prohibited from using profane, indecent, abusive or insulting language toward prisoners, and must refrain at all times from the use of such language in or about the Prison.
- No guard or other officer of the prison shall at any time make the affairs of the Prison or any occurrence therein or any matter relating to a prisoner or the conduct of any guard or officer the subject of conversation or gossip; and no guard or officer shall impart to any person any information as to the matters above mentioned, except when required to do so in the discharge of his duty by the Inspector of Penal Institutions, the Governor, or the Committee on Public Health and Welfare. A violation of this rule will subject the offender to instant dismissal.
- Guards and other officers shall be liable to be disciplined for drunkenness, falsehood, dishonesty, insubordination or disrespectful conduct toward their superior officers, breach of regulations, absence without leave, or beyond leave, neglect of duty, loss of stock or general inefficiency, either by fines, stoppage of promotion or leave of absence, or dismissal from the service, which may be summary or on notice at the discretion of the Committee on Public Health and Welfare.

- 7. Any guard or other officer bringing any intoxicating liquor into the Prison premises, or allowing the same to be brought in will be subject to instant dismissal.
- g. Guards or officers are prohibited from replying in like terms to what they conceive to be impudent or insulting language on the part of a prisoner. Their duty is to report such infraction of discipline.
- 9. All wrangling and disputes upon points of duty between guards or other officers of the Prison are strictly prohibited; questions of this kind must be referred to the Governor and all complaints rendered in writing to him; such complaints must be rendered within 12 hours of the occurrence complained of or it will not be received, and if it should be found that the complaints are frivolous or vaxatious, or arise from a spirit of malice or revenge, the complainent will render himself liable to dismissal.
- 10. Guards and other officers having any grievance in connection with their duties must state the same in writing for the Governor's consideration.
- 11. Guards and other officers are strictly prohibited at all times from smoking in or about the Prison buildings or premises or in the presence of a prisoner. Guards and other officers are permitted to smoke in their rooms if the doors are closed, but nowhere else on the Prison premises.
- 12. Any guard or other officer who shall knowingly bring in or carry out or endeavour to bring in or carry out, or knowingly allow to be brought in or carried out, to or from any prisoner, any money, clothing, provisions, tobacco, letters, papers or other articles whatsoever, shall be subject to instant dismissal.
- 13. When a prisoner escapes, any guard or other officer, who is immediately responsible for the security of that part of the Prison from which an escape is made, may be forthwith suspended from duty, pending an examination into the circumstances of such escape. If It appears that an escape was due to the neglect of a guard or other officer to enforce the rules of the institution, such guard or other officer may be punished by suspension or removal.
- 14. All complaints by prisoners to guards or other officers respecting food shall be promptly communicated to the Governor or headkeeper. Food shall be prepared in a cleanly manner, and no prisoners afflicted with any disease shall be employed in any capacity in the kitchen, or in any other place where food is prepared.
- 15. Every guard or other officer shall give his orders with distinctness and if a prisoner refuses or hesitates to obey, the guard or other officer shall warn him of the consequences of disobedience. If the prisoner shall continue obdurate, he shall be at once reported for misconduct.

- 16. No guard or other officer shall be permitted to strike a prisoner except in self-defence; but should personal violence be offered or the security of the prison endangered, each guard or officer shall be required to use all lawful means to defend himself and the other guards or officers, to maintain order and discipline and to secure the prisoners offering resistance.
- 17. Every guard or other officer is required to report to the Governor, any guard or officer, teamster, or other employee, visitor or other person who violates any rule of the prison.
- 16. All persons employed in the prison, whether designated as officer or otherwise are subject to the provisions of these rules.

### Part 3

## RULES AND REGULATIONS FOR PRISONERS

- 1. The first duty of the prisoner is strict obedience and it will be to his or her interest to obey all rules and regulations.
- 2. On entering the prison, prisoners are required to conduct themselves properly avoiding all unnecessary noise.
- 3. A Prisoner must not speak to any visitor, nor give to or receive from them anything without permission of a guard.
- 4. Prisoners are not permitted to leave their ranks or place of employment without permission. If sick or unable to work, they will make the fact known to the guard in charge and act as he may direct.
- 5. Prisoners are required to wash themselves thoroughly and observe in every respect personal cleanliness. They must keep their clothes neat and clean.
- 6. On no account must a prisoner go to bed with his clothes on. He must keep his bed and bedding in good order, no marking or scratching on the walls or spitting on the floor will be allowed.
- 7. Prisoners will be permitted to smoke in the stone shed for a period of fifteen minutes in the morning and fifteen minutes in the afternoon. Smoking is prohibited in any other department in the Prison.
- g. At the sounding of the gong for retiring all prisoners must undress and be ready to retire when the order is given by the guard in charge.
- 9. At the sounding of the morning gong, every prisoner must turn out, make up his bed neatly and be ready for marching out.

- 10. Prisoners will not be allowed to exchange among themselves or make any alteration in their clothing.
- 11. All prisoners are required to attend religious service on Sunday unless sick or excused by a Guard. During the service, strict attention must be given, unnecessary noise is strictly prohibited.
- 12. No insolent, profance or disrespectful language will be allowed by any prisoner under any circumstances whatever.
- 13. Prisoners will be required to bathe once a week unless excused by a Guard.
- 14. Every prisoner will have permission to write to his or her parents, wife or husband, or other immediate members of his or her family, once in two weeks. (Providing they do not receive a visit.)
- 15. In case of necessity for special letters, permission must be obtained from the Governor. All letters written or received must be examined at the office under the direction of the Governor, before being sent or delivered. Permission to write or receive letters is dependent on the general good conduct and obedience to rules.
- 16. The use of book! and all reading matter, permission to write and receive visits from friends, may be suspended by the Governor for violation of the rules. Visiting days shall be twice a month, second and fourth Monday from 1 to 4 o'clock P. M.
- 17. Prisoners shall be required to labor diligently during the hours detailed for work, they shall be required to communicate with their guards in a respectful manner and with brevity. They must conduct themselves with perfect order and in strict obedience to the direction of such guards.
- 16. Prisoners, whose term of imprisonment has expired, shall be released at any time after 10.00 A. M. on the last day of said term of imprisonment.
- 19. A copy of the Rules and Regulations in Parts 3 and 4 hereof shall be plainly printed on cards and posted up in the Guard Room, Gate House and other convenient places.

## Part 4

1. The Rules and Regulations for Under Keepers and Officers adopted by the City Council at a meeting thereof held November 7th., 1913, are hereby repealed.

If any chimney or flue takes fire the owner of the building in which such fire occurs shall be liable to a penalty unless it appears that the chimney or flue had been properly swept within one year before the fire. If any stove-pipe takes fire the occupant of the premises in which the fire occurs shall be liable to a penalty unless it appears that the stove-pipe had been properly cleaned within ninety days prior to such fire taking place. If any fire occurs within ninety days after the chimney or flue was swept by a licensed sweep, such sweep shall be liable to a penalty unless it appears that the fire was not caused by insufficient sweeping.

Gentlemen:-

In accordance with Chapter 46 of the Acts of Nova Scotia 1944, I am herewith giving you a report of my findings at the completion of my audit for the period ending December 31st., 1944.

I have made a complete and thorough check of all expenditures and receipts relating to the Board of Works, Water Department, Board of School Commissioners, Fire Department, Police Department, City Home, City Prison, Co-operative Health, Infectious Diseases Hospital, Tuberculosis Hospital, Civic Defence, Local Ration Board, Camp Hill Cemetery, City Court, The Finance and Executive Committee and the Victoria General Hospitals items relating to the City of Halifax, or any other expenditures that may be authorized by the City Council, and I have also checked the Security Inventory as at December 31st., 1944, and the Trust Ledger to April 30th., 1944.

I have made periodic checks in the cashier's cage, counting the cash therein, and I have maintained a continuous check of the daily deposit slips; we have ascertained that all monies so received have been turned over to the Treasurer and deposited by him in the Royal Bank of Canada, and we have also reconciled the Bank Account with the Treasurer's records.

CITY HOME: At this Institution I was again unable to verify the Wood Inventory and I had to resort to a book inventory. The same difficulty was expressed by the Superintendent as before, that it was impossible to pile the wood so that it could be measured.

### ACCOUNTS RECEIVABLE:

The Works Department Accounts Receivable, consisting of the following headings, Rent City Property, Rents Morris Street Properties, Tax Sale Rentals, Street Light Maintenance and Sign Licenses.

After thoroughly scrutinizing these accounts I have come to the conclusion that certain of these debit items have no apparent value and should no longer be retained as an asset in the General Ledger. I would suggest that the Clerk of Works or some other Official of the Works Department, should be instructed to prepare a list of the bad accounts and the authority be requested from the Finance and Executive Committee and the Council to have these accounts written off.

## HALIFAX HOUSING COMMISSION:

The books of accounts and financial records of the Halifax Housing Commission, for the period ending December 31st, 1944, have been audited and verified with the receipts and vouchers of the Commission.

#### AUDIT MISCELLANEOUS ACCOUNTS:

The accounts of the Helifax Athletic Commission, the Halifax Welfare Bureau and the Fire Chief's Benevolent Fund have been audited and verified with the receipts and vouchers of such Commission, Bureau and Fund.

## CONFIRMATION OF BANK ACCOUNTS:

I have confirmed and verified the cash balances on Deposit in the Royal Bank of Canada on December 31st., 1944.

### GENERAL COMMENTS:

We have secured Legislation in Chapter 46 of the Acts of Nova Scotia, 1944, to change our civic year so that it now ends on December 31st; in addition to this change in the civic period, the accounting system of the City will also be amended, making it possible in future to submit Financial Statements of the City of Halifax in conformity with the standardized procedure proposed by the Dominion Bureau of Statistics and the Department of Municipal Affairs.

Sir:-

An application has been made by Mr. E.B. Boyd for the erection of a dry cleaning plant at No. 31 Hunter Street, which location lies outside the residential area.

Mr. Boyd gave notice of his intentions by advertising, to comply with the requirements of the City Charter which demands such procedure when it is proposed to set up a steam boiler.

Letters objecting to the establishment of this plant were received from three residents on this street by the Works Department, in response to the advertisement appearing in the Halifax newspapers.

To summarize the objections from these residents, they are chiefly, the reduction of water pressure in the street, noise and smoke nuisance.

The three reside on the opposite side of the street, the residence of the nearest objector being approximately 200 feet from the site of the proposed plant, housing the boiler and the stack.

It would appear to me that the reduction of water pressure would be negligible, as the boiler is small, and is to be used for steam purposes only.

Insofar as noise is concerned, it is my opinion that it would be practically non-existent.

As for the smoke nuisance, Mr. Boyd has informed me that he intends to use coke as fuel for this boiler and it is his opinion, as well as of this Department, that the volume of smoke emitted from this stack would not be more than that from an ordinary household flue.

These residents, I believe, are basing their objections on the recollection of a pasteurizing plant which was located in this district some time ago, but which has since been removed. That plant operated a 50 h.p. boiler, and a continuous supply of water was required for that type of business.

I have been given to understand that one of the residents has since withdrawn his objections against the establishment of this plant.

Therefore, I believe the granting of this application would be justifiable should the Committee care to recommend such to the City Council.

### HOLIDAYS FIELD NURSES

Read report of the Public Health and Welfare Committee as follows:-

Gentlemen:-

At a meeting of the Public Health and Welfare Committee held on the above date a letter from the Commissioner of Health recommending that the members of the Field Nursing Staff be granted three weeks holidays was considered.

After some discussion on the matter, it was decided to forward same to Council without recommendation.

Alderman Hosterman stated that he had spoken on this once before at another meeting and said that it was customary to give nurses one month's vacation with pay. Perhaps our City Nurses are not performing duties as strenuous as nurses in hospital. I contend that they are most certainly entitled to three weeks holidays.

Moved by Alderman Hosterman, seconded by Alderman Coffin that three weeks vacation be granted to the Field Nurses this year.

Alderman Burgess stated that he was not in favor of that on account of the hours.

Alderman Walker wanted to know if everybody is getting the three weeks holidays now to which His Worship the Mayor replied in the negative.

Alderman Hosterman stated that when his daughter was a nurse in the Department, she had to stand by on Sundays and holidays.

Alderman Walker stated that he was going in for a punch clock and that it would be punched from His Worship the Mayor down.

Alderman Batson stated that he was of the same opinion as Alderman Burgess. "We started with the City Home and gave them three weeks because of their work". "The nurses get carfares and I really think we should step a little lightly. I shall vote against this tonight".

Alderman Burgess stated that he thought school nurses go to the homes. "A nurse can't go to the home until 9.30 A. M. Four hours a day is all I can see they work. I don't see how they put in the hours".

Alderman Walker suggested putting them all back and settling it at once if anyone else is looking for three weeks.

Dr. A. R. Morton, Commissioner of Health, then addressed the Council as follows: "The nurses go directly to some of the schools at 9.00 A. M. until 11.00 A. M. and 9.00 A. M. until 12.30 in others. They examine the pupils and assist the Doctor in examinations, from 2.00 P. M. until 3.30 P. M. and following that they make up their reports. All other nurses doing similar work get a month. They asked me what would happen if they walked out and took three weeks and I said I did not know. This is in fairness to other members of the same profession. During July and August they are following children in the homes who will be going to school in September. In addition

they check in the homes and keep the dental appointments going. I have lost quite a few nurses in the past\*\*.

Alderman Ahern asked if that was due to salary or other conditions.

Alderman DeWolf stated that nurses should be given top priority for holidays.

Moved in amendment by Alderman Walker, seconded by Alderman Batson that this matter be referred to the Committee of the Whole Council to be held shortly.

The amendment was put and lost, three voting for the same and seven against it as follows:-

#### QUESTIONS

Alderman Batson stated that he would like to suggest that we consider the advisability of placing a traffic light at Sackville & Barrington Streets.

The Officer stationed there could then be used for some other duty.

Alderman Ahern suggested that Council look into the advisability of having a traffic officer stationed at the Corner of North & Oxford Streets as this was a speed way for service trucks and cars. He said children might be killed. "The squad car went up there and warned them".

His Worship the Mayor stated that the Chief of Police could give consideration to this request.

Alderman Moriarty stated that he was against the lights for the corner of Backville & Barrington Sts., because of horse-drawn vehicles coming up the hills it would be pretty hard to get going with the lights

against them. A traffic officer is very necessary because of the motor and horse drawn vehicles.

Alderman Ahern asked why his question was sidetracked and stated that he would like to have his question disposed of.

His Worship the Mayor stated that the Chief of Police must be given the right to place his men and I asked you if you thought it was necessary if some arrangements were made to protect the school children, you stated every day of the week.

Alderman Ahern stated that there is no reason why the Chief of Police can't be instructed to look after this matter. I wish to be placed on record as to the way this matter was handled here tonight.

Alderman Walker submitted and read the following Notice of Motion:

"I understand that under the provisions of the City Charter respecting the Residential District it is not permitted to erect a roller skating rink in such a district.

Mr. Beed, I understand, desires to erect such a rink on Hunter Street on the extreme limit of this District but a ruling has been made which prohibits this.

I would therefore move that the City Solicitor be requested to prepare and submit legislation at the next session of the Legislature to enable a roller skating rink at the location for which application has been made, notwithstanding the same is within the Residential District."

#### TAXI POOL

Alderman DeWolf wanted to know how long the Taxi
Pool would continue in operation.

His Worship the Mayor stated that about three weeks ago the Cabs Committee discussed this matter with the Taxi representatives and after hearing them,

in operation. The facts presented to us seemed to indicate that much improved efficiency had resulted in the past month to the response for the early morning calls for trains.

Alderman DeWolf stated that he thought he was the only Alderman in Council who did not operate a car and for that reason he used taxis a lot. "Within the last two weeks a friend of mine could not get a car at the switchboard. I suggested that he go to the Lord Nelson Hotel and when he arrived there he found four taxis waiting which proved they are not checking in at the switchboard. I question whether we have any right to legislate over any cab owner who wants to operate his own business. I want a taxi when I want to use it".

Alderman Burgess stated that the Government forced this on the taxi owners and now they want the Cabs Committee to discontinue the Pool. "If Alderman DeWolf calls a taxi and can't get one at the switchboard and then gets four at the Lord Nelson Hotel, that is just proof that the taxi operators are trying to sabotage the Pool. The Cabs Committee is not forcing the taxi owners to carry on a Pool; it is a matter for the Transit Controller."

Alderman DeWolf stated that he wanted to know to whom he was talking when he called for a car.

His Worship the Mayor stated in pre-war days we had 226 cars here and the population has now doubled and all we have is 175 cars.

Alderman Walker stated that it was a sure sign that someone is trying to ruin the Pool. "Today we asked how things were going and we got the answer that things were going along pretty good".

The City Solicitor stated that the authority for the Pool comes under the Transit Controller. "There was a condition that if the taxis were to get gas and tires they would have to work together in a Pool. The Pool was established with the approval of the local authorities. If the Pool is to be abandoned, then the authority that started it should be the one to disband it. That authority wants the City to put it down."

His Worship the Mayor stated that Transit Control is willing to supply the 175 taxis with the same rubber and gas but they won't take the official action themselves that the Pool is at an end.

He asked for explanations from the Aldermen so that it would be a guide for the Cabs Committee. The City is greatly inconvenienced by the present arrangement and the Cabs Committee would be delighted to have your views.

Alderman Doyle stated that if the Pool were abandoned, you would get a lot more service. If you called a taxi, you would know who you were talking to. "I feel that it should be abandoned."

Alderman Batson stated that before the war when it was working by taxi companies themselves, we had a good service. Within 5 minutes I got a taxi after I called for one. I really think the time has come where they should be given a chance to go back for themselves. I am sure the Cabs Committee has worked very hard. I

think the Pool has been horrible. "

Alderman Burgess stated that he had been a member of the Cabs Committee for 5 years and he was tired of it and would like to be replaced.

Alderman Hosterman stated that he was a member of the Cabs Committee and there is a whole lot in what Alderman Burgess says and I can assure you that there is a lot of work. I would be very much displeased to see Alderman Burgess leave that Committee. He is doing a wonderful job on it.

Alderman Burgess stated that the Government should abandon the Pool.

Alderman Walker stated that the big men want to go back and the small man doesn't want to. That is what I think. A person with a lot of cabs has a lot of votes and he wants to go back. Someone is trying to throw a monkey-wrench into it. It is up to the Pool to find this. If they put the right man in charge of the Pool, I believe it can be worked to perfection. I might be wrong.

It was then moved by Alderman DeWolf, seconded by Alderman Adams that His Worship the Mayor consult the Transit Controller, Mr. Mercer, through the Cabs Committee, to release the City of any duty it may have to continue or discontinue the Taxi Pool.

Alderman Ahern stated that this was a Federal matter and has no status here.

The motion was then put and passed unanimously.

#### CAPITAL BORROWINGS

His Worship the Mayor submitted the following resolution respecting the borrowing of the sum of \$234,900.00.

#### RESOLUTION

WHEREAS by Section 7A of Chapter 3 of the Acts of 1939, The Municipal Affairs Act, as that Section is enacted by Chapter 38 of the Acts of 1944, it is enacted among other things, in effect, that notwithstanding any of the provisions of any general or special Act of the Legislature of Nova Scotia, the City of Halifax shall have full power and authority to borrow or raise by way of loan from time to time on the credit of the said City, such sum or sums as the Council thereof deems necessary for any of the following purposes:-

- (a) Erecting, acquiring, purchasing, altering, adding to, improving, furnishing or equipping buildings for public schools, fire department, police office, lockups, city hall or other City purposes;
- (c) Laying out, opening, construction, making and draining streets, roads, bridges, culverts, or retaining walls;
- (d) Constructing, altering, extending and improving public sewers or drains in the City and acquiring or purchasing materials, machinery, implements and plant deemed requisite or advisable therefor or for maintaining such public sewers or drains;
- (e) Equipping a fire department or acquiring or purchasing apparatus, machinery and implements for use in extinguishing fires in the City;
- (g) Paving with permanent pavement the streets and rebuilding bridges or culverts in the City;
- (i) Generally for any City purpose whatsoever;

AND WHEREAS by said Section 7A of said The Municipal Affairs Act, as amended, it is enacted, among other things, in effect, that no money shall be so borrowed until such proposed borrowing has been approved by the Minister of Municipal Affairs;

AND WHEREAS by said The Municipal Affairs Act, the said sum shall in the discretion of the City Council be borrowed or raised in one sum at one time or in instalments at different times and the sum required shall be borrowed or raised by the issue and sale of debentures of the City to such an amount as such Council deems necessary to raise such sum: \$234,900.00;

AND WHEREAS it is deemed necessary by the City Council of the City of Halifax to borrow the sum of \$234,900.00 for the purposes of:-

To defray the cost of improving #6 Fire Station \$ 2,900.00

To defray the cost of construction of a boulevard 

To defray the cost of construction and extension 

To defray the cost of acquiring and purchasing trucks, tractors, ploughs and other equipment for use of the Works Department..... 40,000.00

To defray the cost of purchasing and installing 

To defray the cost of renewals to permanent 

To defray the cost of the construction of a drain and renewal of float at Fleming Park.. 2,000.00

To defray the cost of paving with permanent pavement the streets and rebuilding bridges 

AND WHEREAS the said Council deems that the issue and sale of debentures of the City to the amount of \$234,900.00 as hereinafter mentioned will be necessary to raise that sum;

AND WHEREAS it is deemed expedient to postpone the issue of such debentures and to borrow from any Bank, fund, person or account available, such sums not exceeding \$234,900.00 as may be necessary for the purposes aforesaid; the said sums to be repaid from the proceeds of the debentures when sold;

NOW BE IT THEREFORE RESOLVED: that under and by virtue of the said The Municipal Affairs Act the said City do, subject to the approval of the Minister of Municipal Affairs, borrow or raise by way of loan on the credit of the City the said sum of \$234,900.00 for the purposes aforesaid.

THAT under and in accordance with said The Municipal Affairs Act, the said sum be borrowed or raised by the issue and sale of debentures of the City to the said amount of \$234,900.00.

THAT the issue of said debentures be postponed and that the said City do under and by virtue of the provisions of Section 318A of the Halifax City Charter of 1931 borrow from General Current Account of the City of Halifax a sum or sums of money not exceeding \$234,900.00.

THAT the said sum or sums be so borrowed for a period not exceeding ten months, with interest thereon to be paid at a rate not exceeding 32% and that the amount so borrowed together with the amount of any interest which may have accrued thereon be repaid the said General Current Account of the City of Halifax from the proceeds of the said debentures when sold.

His Worship the Mayor explained the Borrowing Resolution to the Council and stated that certain items were now amended. These items are: There is an increase in the appropriation for #6 Fire Station from \$1,200.00 to \$2,900.00; trucks, tractors and plows for the Works Department has been reduced from \$50,000.00 to \$40,000.00; sidewalks for \$50,000.00 has been removed because the City has a substantial appropriation of \$60,000.00 now which is ample; street lighting has been taken out because of the explanation given by City Officials that that item is more properly maintenance. This money was required to change the strength of the lamp.

Mr. MacKinnon stated that Mr. Durling was to improve the lighting system throughout where it is now lighted. It is for higher power lamps.

Moved by Alderman Hosterman, seconded by Alderman Coffin that the resolution as submitted be approved.

The motion was put and passed unanimously the following Aldermen being present and voting therefor:

## SCHOOL BOARD BORROWING

His Worship the Mayor in referring to the application of the Board of School Commissioners for the borrowing of the sum of \$262,640.00, stated that same is here in detail but certain things are not acceptable. Such items as replacements, automatic stokers, grading, furniture, etc., it is not specified which school this is to go into and the Department of Municipal Affairs insists on that. They object to such items as workshop pay-roll, unemployment insurance and Workmen's Compensation, those items, they say are clearly non-capital. The application has come in in an impossible form.

Alderman Ahern arose in protest. He said "Our decision went to the Finance and Executive Committee and discussed there for several hours. We dealt with it and then it went to the Council. We feel that the Schools have been neglected for a long time. I think there are 12 good men on the School Board who went into it thoroughly. We cannot go on unless that money is voted."

His Worship the Mayor stated that these applications have to be done legally. I would suggest that it go back to the School Board and be drawn up properly.

Mr. Beazley of the Department of Municipal Affairs stated that his Department is quite prepared to approve very rapidly of the greater bulk of the request for the schools. It has to come in a little more better looking form than this application is at the moment.

Moved by Alderman Hosterman, seconded by Alderman Doyle that this matter be referred back to the Board of School Commissioners for clarification of figures and another application.

The motion was put and passed with Alderman Ahern wishing to be recorded against.

Moved by Alderman Ahern that this Council authorize the School Board to borrow \$500,000.00 to proceed with the erection of the Queen Elizabeth High School gymnasium and auditorium.

There was no seconder to this motion.

The Deputy Mayor assumes the Chair while His Wor-ship the Mayor addresses the Council from the floor at 10.30 P. M. as follows:-

"That was a matter for discussion by members of the Government. Mr. Beazley reported to me that the mechanics the City is now using for its borrowings should first come down to his Department from the City. All the City said was that it would raise no objection to an application being placed to the Governor in Council for the borrowing of a sum to complete the Queen Elizabeth High School and I was advised that the Aldermen in this Council must deal with it in a more positive way because of the heavy expenditures for schools. The Aldermen of this Council must take full responsibility for asking for a half million dollars for schools. I believe that that project is in the general plan and someday it will be done but there are other things to be done. I can anticipate a high tax rate in a few years and I would urge the Aldermen to place this matter well down on the program".

Alderman Ahern stated that we realize that we must do something for that high school. It is a completion not an extension.

Alderman DeWolf stated that he understood that the Federal Government has declined to issue a permit for that school. "We could put it in at a later date".

Alderman Ahern stated that permits were granted to St. Francis Xavier, Acadia and others. We feel that we should be permitted to go ahead with our plans. The Federal Government is quite willing to review it.

His Worship the Mayor stated that this application will be approved if the majority of this Council will approve it. The Finance and Executive Committee asked the School Board to bring down the whole program.

10.40 P. M. His Worship the Mayor resumes the Chair.

His Worship the Mayor stated that he thought it was important enough to wait for the program to come from the Board and he so ruled.

Alderman Coffin stated that he agreed with the ruling of His Worship the Mayor because he was not satisfied with the form of the previous application.

Mr. Beazley stated that he was quite prepared to say that when any sums required that can reasonably be shown as a capitalistic nature would be rapidly approved.

## SMOKE NUISANCE LOCOMOTIVES

Read report of the Committee on Works as follows:

The Committee on Works at a meeting held on the 5th instant, considered a report that residents of the south end of the City are complaining of a smoke nuisance caused by Canadian National Railways locomotive engines in the vicinity of Young Avenue, and also

of a traffic hazard caused by the smoke in that vicinity interfering with the vision of operators of motor vehicles.

It was suggested that a relocation of the C. N. R. office now situated in the railway yard just east of Young Avenue might result in less frequent shunting by the locomotives in that vicinity; also that locomotives powered by electricity might be available for use inside the City Limits.

On motion of Alderman Breen, seconded by Alderman Moriarty the Committee recommended to Council that the C. N. R. be asked to overcome the nuisance caused by smoke from the locomotive engines operating within the City of Halifax.

It is proposed by the Works Department to make certain improvements to Lady Hammond Road throughout its entire length from Robie Street to its junction with Kempt Road.

Before these improvements can be undertaken, I find that it is necessary to have the official street lines laid down and confirmed by City Council. Plans have been now completed, viz: Sections 6A, 6B and 7C and public notice of their completion has been advertised in the local papers for not less than four weeks previous to the 14th of June 1945, on which date the public were notified that a meeting of Council would be held to confirm the said plans.

It is recommended that the Council now confirm the said plans, viz: 6A, 6B and 7C by adopting the attached resolution prepared by the City Solicitor.

AND WHEREAS the City Engineer of the said City has completed plans, in conformity with the City Charter, of a portion of the City, Section 6A, 6B and 7C, which is described as follows:-

100 feet North of LEEDS STREET -- ROBIE STREET -- DUFFUS STREET and including both sides of LADY HAMMOND ROAD from ROBIE STREET TO KEMPT ROAD; as shown on Plans Number 6A, 6B, 7C.

AND WHEREAS in conformity with said Charter public notice of the completion of such Plans of such portion of the City and that it was proposed to confirm the same at a meeting of the Council of the said City to be held on THURSDAY, JUNE 14th., 1945, or if there was no meeting of the Council on that date then at the first meeting

of the Council held thereafter, has been given by publication of such notice in the Halifax Herald and Halifax Mail and the Halifax Chronicle and Star, four newspapers published in the City of Halifax, for not less than four weeks previous to the date so appointed for such meeting of the Council.

BE IT THEREFORE RESOLVED that the City Plans hereinbefore referred to be and the same hereby is confirmed.

# LAUNDRY GRAFTON STREET

Read letter from Mr. Harry Long as follows:- June 14, 1945.

With regard to your letter of June 13th, concerning City owned lot offered me, on the West side Grafton Street.

Please be advised that this lot is not satisfactory for my purpose, as we plan to erect a one story brick building, 40 x 80, with modern ventilation on all sides. This particular lot, being on a hill, is not suitable for a building of this type. Please advise if you have anything else to offer me.

Will you kindly let me know if the old fire station, George and Brunswick Streets is for sale.

## CITY FIELD WORKERS PICNIC

### MOVIES FLEMING PARK

Mr. MacKinnon advised Council that outdoor movies are being shown at Fleming Park and the crowds collecting on the wharf constitute a serious danger. He suggested that a Special Constable be placed on duty there to control the traffic to and from the ferries.

It was agreed that the person responsible for the shows there should take the necessary action for the protection of the public.

#### WOODCOCK INN PROPERTY

His Worship the Mayor stated that the owners of this property are anxious to know what our decision will be. He also advised that he had received an answer from the Premier to the effect that they are interested and will undertake any road, bridge or culvert work. Our first move is to authorize some official to undertake negotiations as to the price.

Mr. McManus stated that he and the Commissioner of Works had interviewed the owner of this property

and his thought at the present was that if the Committee or Council is interested in it, a counter offer should be made to them as to the price and we would have it included in the joint report.

Moved by Alderman Hosterman, seconded by Alderman Burgess that the same Committee namely Mr. McManus and Mr. MacKinnon, be appointed to negotiate with Mrs. Dauphinee, make her a counter offer and bring back to the Council the terms of purchase.

Alderman Moriarty stated that he could not see any advantage in acquiring this property.

His Worship the Mayor stated that it is proposed to make a circular drive there and also to build a park to cover the mud flats.

Alderman Moriarty stated that he could not see it at all.

The motion was put and passed.

The meeting was called specially to consider the following item:

Resolution re Capital Borrowing School Board. -

The following Resolution was submitted:-

WHEREAS by Section 8 of Chapter 6 of the Acts of 1945, The Municipal Affairs Act, it is enacted among other things, in effect, that notwithstanding any of the provisions of any general or special Act of the Legislature of Nova Scotia, the City of Halifax shall have full power and authority to borrow or raise by way of loan from time to time on the credit of the said City such sum or sums as the Council thereof deems necessary for the purpose of altering, adding to, improving furnishing and equipping buildings for public schools.

AND WHEREAS by said Section 8 of said The Municipal Affairs Act it is enacted among other things, in effect, that no money shall be so borrowed until such proposed borrowing has been approved by the Minister of Municipal Affairs.

AND WHEREAS by said the Municipal Affairs Act the said sum shall in the discretion of the City Council be borrowed or raised in one sum at one time or in instal ments at different times and the sum required shall be borrowed or raised by the issue and sale of debentures of the City to such an amount as such Council deems necessary to raise such sum.

AND WHEREAS it is deemed necessary by the City Council of the City of Halifax to borrow a sum not exceeding Two Hundred and Fifty Thousand Dollars (\$250,000) for the purpose of altering, adding to, improving, furnishing and equipping buildings for public schools, as shown in the schedule hereto annexed.

and sale of debentures of the City to an amount not exceeding Two Hundred and Fifty Thousand Dollars (\$250,000) as hereinafter mentioned will be necessary to raise that sum.

AND WHEREAS it is deemed expedient to postpone the issue of such debentures and to borrow from any bank, fund, person or account available such sums not exceeding Two Hundred and Fifty Thousand Dollars (\$250,000) as may

be necessary for the purposes aforesaid; the said sums to be repaid from the proceeds of the debentures when sold:

BE IT THEREFORE RESOLVED that under and by virtue of said The Municipal Affairs Act the said City do, subject to the approval of the Minister of Municipal Affairs borrow or raise by way of loan on the credit of the City the said sum of Two Hundred and Fifty Thousand Dollars (\$250,000) for the purposes aforesaid.

THAT under and in accordance with said The Municipal Affairs Act the said sum be borrowed or raised by the issue and sale of debentures of the City to the said amount of Two Hundred and Fifty Thousand Dollars, (\$250,000)

and that the said City do under and by virtue of the provisions of Section 318A of the Halifax City Charter of 1931 borrow from General Current Account a sum or sums of money not exceeding Two Hundred and Fifty Thousand Dollars (\$250,000).

period not exceeding nine months, with interest thereon to be paid at a rate not exceeding three and one-half per centum, and that the amount so borrowed together with the amount of any interest which may have accrued thereon be repaid the said General Current Account from the proceeds of the said debentures when sold.

At a meeting of the Committee on Works held the 3rd instant the above matter was considered. It was felt that the resolution deciding on this sewer extension passed by the Council at the meeting of June 14th was not sufficiently clear and should be amplified.

It was therefore decided to submit the following points to Council for approval.

- The persons desiring the extension should obtain the consent in writing of all persons having any interest in the right-of-way to the installation of the sewer extension therein, and to thereafter maintain the same, and submit this consent to the City prior to commence ment of any work.
- That the good offices of the Premier be sought to facilitate the passage of legislation at the next session to carry out the intention of the parties in this matter.
- That the persons desiring the extension deposit with the City before commencement of any work a sum sufficient to defray the entire cost of the extension, which is presently estimated to be \$2,000.00. If this sum proves insufficient the owners will on request provide any additional sum necessary.
- Such persons will agree to the City submitting legislation enabling it to assess upon the property owned by such persons an amount equal to that

which the City would have been entitled to receive had the right-of-way been a street - namely the sum of \$2.50 per foot on each side of the street less an exemption of 40 feet on the property owned by W. A. Shaw fronting on Jubilee Road. This assessment would be equivalent to the sum of \$5.00 for each foot of the extension less the sum of \$100.00 for the said exemption, or approximately \$1130.00. The said amount so assessed to be divided among the four properties on the east side of the street between Jubilee Road and a point approximately 246 feet southerly therefrom according to the frontage of each property. The method of assessment and the provisions for payment by instalments shall be the same as in the case of an ordinary sewer assessment.

- The persons desiring the sewer must enter into a written agreement with the City embodying all the terms before any work will be commenced, and subject to the approval of the City Solicitor.
- 6. The cost of connecting abutting properties with the sewer is to be borne by the owners of these properties.

Gentlemen:

The front porches on certain houses rented by the City from Wartime Housing Ltd., have separated from the main house.

Wartime Housing Ltd., and the City the Company is to do any major structural repair and the City is to do ordinary maintenance. When the condition of these porches was discovered, I communicated with the local representative, Mr. O'Sullivan, as I considered the matter a major structural repair and in reply was informed that the replacement of these porches was ordinary maintenance and hence the City's responsibility. I then wrote Mr. Brownell and again Mr. O'Sullivan and was subsequently advised that the matter was being taken up with the Head Office.

I am in receipt of a letter from Mr. D.C. Beam, Manager of the Maintenance Department of Wartime Housing Limited. He also contends this work is ordinary maintenance. For your information I am attaching copy of Mr. Beam's letter and my reply thereto.

Mr. MacKinnon and myself have discussed this matter and we are unable to agree that this work is ordinary maintenance. To carry out this work would amount to a considerable sum, particularly in the manner suggested by Mr. Beam.

The time has arrived when something definite should be determined in respect to the phrases in the contract "ordinary maintenance" and "major structural repairs" in order that the City will know its true position in respect to the operation of the houses. I would suggest that the City, through His Worship the Mayor, should take this matter up with Hon. C. D. Howe, Minister of Munitions and Supply under whose Department, Wartime Housing operates.

Dear Sir: re: Halifax Project #5 Front Porches

There has been considerable correspondence between you and Mr. Brownell and Mr. O'Sullivan concerning the porches on the above project which have gradually pulls away from the main part of the building. In your letter to Mr. O'Sullivan of June 1st, you point out that this has become a major structural repair job which according to the contract is the responsibility of Wartime Housing Ltd.

We wish to point out that the heaving of porch posts is common to this type of construction and that it is a matter of ordinary maintenance to either pound these posts back in place each spring or to cut them off and adjust the floor of the porch before any damage is done. The reason this condition has become a major structural repair job of the 29 houses in question, is because the City has neglected to do this ordinary season to season maintenance. Hence, we are of the opinion that these repairs are your responsibility.

In connection with the balance of the houses, we wish to advise you, as I believe we have done previously, that the front and rear porches of the project should be inspected after each winter and adjusted as necessary as a matter of ordinary maintenance, in which case, no major structural repairs are required.

I trust that this inspection will be made and the necessary repairs performed in the near future on all of the houses.

I am in receipt of your letter of the 25th inst. re the above matter and I must confess that I am rather surprised at your idea of what ordinary maintenance means.

It is now quite evident that your Company does not propose to carry out the terms of your contract with the City when you contend that the work entailed on this matter is ordinary maintenance. Work of this nature has never been considered ordinary maintenance and I can assure you was never contemplated by the City at the time of entering into the contract. It was for this reason that the City agreed to pay to your Company the same rental as you receive from your other houses. If your contention is correct then your Company is in a purely money making effort insofar as these houses are concerned having no responsibility therefore. This contention of mine is further borne out by the fact that you have refused to supply the houses with screens, but are supplying them to other houses.

Conforming to a resolution of City Council passed at the regular monthly meeting of Council held on May 15, 1945, the Balance Sheet is submitted subject to examination of the City's auditors, but carries the certificate of the Internal Auditor of the City of Halifax.

In general form the Balance Sheet and exhibits follows that of previous years. Exhibit 21A has been added to show the details on December 31, 1944, of the Post War Rehabilitation Account established by Section 24, Subsection 2, of Chapter 46, of the Acts of 1944.

The supplement to Exhibit 11 and Exhibit 12 have been revised to show subsequent debenture maturities by calendar years.

Exhibit 16, Tax Collections and Outstanding Taxes, shows total tax collections for eight months ending December 31, 1944, of \$2,827,696.67 or 98.86% of the Current Levy, this compares with \$2,785,352.23 collected in the civic year ended April 30, 1944. Taxes outstanding on December 31, 1944 for the years 1925-26 to 1944 were \$954,973.05 against which the City has reserves for uncollected taxes of \$576,461.68. For this period, \$76,582.86 excess tax reserves was transferred to Current Surplus Account.

Exhibits 31,32:- Sinking Funds.

On December 31, 1944, the Sinking Funds held by the Trustees amounted to \$7,009220.93.

Sinking Fund issues of the City outstanding at that date were \$11,882,666.00, the acturial requirements
