QUESTIONS

Alderman Ahern wanted to know what progress was being made with repairing streets to which Mr. MacKinnon replied that during the months of May and June nothing could be done on account of the wet weather but that now they were progressing very well.

WOOD CITY HOME

Alderman Hosterman referred to the difficulty experienced by the Internal Auditor at the City Home with regard to the wood situation and stated that he would like to know whether any action has been or will be taken whereby this wood will be received and measured as so many cords of wood and sales recorded against and so piled that the Internal Auditor can make an inventory. "The citizens interests should be protected. It is not being handled in any business-like manner. The proper authority should take action to see about this.."

His Worship the Mayor stated that Mr. Ettinger gave an explanation to the Public Health and Welfare Committee and a profit statement. "He explained that because of the pressure of incoming wood on his limited machinery for hauling it that that is the only way he could deal with it....by throwing it anywhere in the yard."

Moved by Alderman Hosterman that Mr. Ettinger be instructed that on receipt of future wood that it be properly measured into the yard and properly piled and kept that way so that the Internal Auditor can check it.

There was no seconder to this motion.

Alderman Burgess stated that Mr. Ettinger explained the situation last year. "Some days they unloaded 18 cars of wood. The shortage of help and time is the cause of the

piling the way it was done. "

Alderman Hosterman stated that an effort could be made to get a man to look after this matter. "There is a considerable smount of money involved in this."

Alderman Batson remarked as follows: "When you get 18 cars of wood to come in, I am thinking Alderman Hosterman that you are not very conversant with the matter. The kind of help we had I think it was stacked very well. I think Mr. Ettinger has done a swell job. The space is measured now, I can assure you that it was a difficult job. The citizens of Holifax would not have had wood last year if we had not done this. The wood is accounted for every day."

Alderman Hosterman asked Alderman Batson if he had read the Internal Auditor's Report.

Aldermen Batson stated that he was going to say as Churchill did: "Give us the men and we will do the work."

His Worship the Mayor stated this matter would be brought to the attention of the Public Health and Welfare Committee and a report will be submitted advising what precautions will be taken this year.

HOUSING

Alderman DeWolf asked if the Rehabilitation Committee had any record of the number of houses that might be required for service men to which His Worship the Mayor stated they have no record as yet.

Alderman Walker stated that as a member of that Committee, they have a big list.

Alderman DeWolf stated that he didn't think that 100 houses would serve the needs of the great number looking for homes, "We should have some kind of a special meeting on this matter alone. We could see if materials might be made available for a greater number of houses and we could have a meeting to see how we could erect a greater number in a short time. There are a great many people still looking for houses."

His Worship the Mayor stated that he read in the press that materials and labour are going to be released for that purpose.

Alderman DeWolf stated that he was thinking about permanent homes. We want assurances of labour and materials also.

His Worship the Mayor stated that the Minister of Labor is releasing men for that very thing. "Your program is the National Housing Act."

BATHING BEACH HORSE SHOE ISLAND.....

Alderman Ahern stated that there should be a Special Officer there for supervision. "We have sufficient money in the Recreation Committee to look after this."

His Worship the Mayor suggested, "You should fence it in and get a Special Officer. We will work that out."

MOTOR MECHANICS

Alderman Walker asked that while His Worship the Mayor is in Ottawa that he interview the Minister of Labour with a view to having mechanics released to look after the

trucks and cars which are used for transportation purposes such as fish, etc. He said that if cars and trucks break down there is no one to fix them. Everything is breaking down in the City of Halifax and the streets are bad too.

His Worship the Mayor stated that he would look into it.

FLEMING PARK

Alderman Batson brought attention to the fact that children at Fleming Park are being kept out late at night by the use of movies there and asked if the City had any jurisdiction there.

His Worship the Mayor stated that Mounted Police are patrolling the Park. He also stated that there is supposed to be a currew law in this City and said he didn't know whether he could answer Aldermon Batson's question. "We have a Mounted man there from 2 p. m. to 8 p. m."

CITY DUMP

Alderman Ahern drew attention to the smoke nuisance at the City Dump.

Mr. Mackinnon stated that there is nothing we can do about it. "It is going to burn and we can't stop it. We have to burn refuse there that we can't put in the incinerator."

Mr. MacKinnon was requested to bring in a report on this matter.

VICTORY LOAN ARCH

Mr. MscKinnon asked if he should pay the \$500.00 over to the Victory Loan Committee.

His Worship the Mayor stated that this should be taken down.

Alderman Walker asked if it could be sawed in three parts and taken to the Terminal Road for welcoming returning service men.

Mr. Mackinnon stated that it was not a knock-down type of structure and he didn't think it could be done. He stated that he received an estimate as to tearing down and putting it up at another location and that estimate was \$1,000.00 because it would have to be stripped of the trimmings and painted again.

Alderman Walker stated that the Rehabilitation Committee is meeting Wednesday and they will look after it.

His Worship the Mayor stated that we voted \$500.00 for it and it was to be ours.

He asked Alderman Walker to have the Rehabilitation Committee look after it in 15 days.

It was then agreed that \$500.00 be paid to the Victory Loan Committee.

WAIVER FOR FIREMEN ARLINGTON MASS.

His Worship the Mayor submitted and explained a waiver prepared by the City Solicitor of claims against the City of Arlington in respect of any accident which might be sustained by any of our firemen who are taking a course in fire fighting in that City.

Moved by Alderman Hosterman, seconded by Alderman

Batson that the Mayor and City Clerk be authorized to sign

the waiver on behalf of the City of Halifax. Motion passed.

CITY DUMP

Alderman Walker asked what was going to be done about the stench at the City Dumps.

Alderman Ahern stated that he received 8 or 10 calls a day in regard to this. He felt that some effort should be made to secure scows that are at present in Bedford Basin and have the garbage taken out to sea.

Mr. MacKinnon stated that the Dump will only be used for about another year when it will be filled.

Alderman Walker asked if anything was done about dumping bad meat and fish on the dump and was advised by Dr. Morton that it had stopped.

Alderman Hosterman advised that the scows were owned by the C.N.R. and that would be the ultimate solution in Halifax. He suggested to His Worship the Mayor that while he was in Ottawa he might take this matter up with Mr. Lockwood with a view to securing two or more of these scows.

Mr. MacKinnon was requested to see His Worship the Mayor before he goes away to Ottaws.

AFTERNOON SESSION SPECIAL MEETING

Council Chamber, City Hall, Halifax, N. S., July 17/1945, 5.10 p. m.

A meeting of the City Council was held this date, at the above named hour; there were present His Worship the Mayor, Chairman; Aldermen Batson, Coffin, Adams, DeWolf, Walker and Ahern.

5.10 O'clock:

Moved by Alderman Ahern, seconded by Alderman Walker, that the time of meeting be extended for a half-hour. Motion passed.

5.30 O'clock:

The meeting was called to order by the Chairman and before considering the regular order of business, the members of Council attending, led by the City Clerk, joined in repeating the Lord's Prayer.

There were present the above named and Alderman Breen.

The meeting was called specially to consider the following items:

- 1. Report Committees on Works and Finance & Executive re Big Indian Lake Contract.
- 2. Report Committees on Works and Finance and Executive re Tenders for Improvements to building at City Field.

BIG INDIAN LAKE PROJECT

The following letter from Mr. H. W. L. Doane, Manager of the Public Service Commission was considered, -

Halifax, N. S., July 16/1945.

His Worship the Mayor and Members of the City Council.

Gentlemen:

Shortly after the outbreak of the present war the various government services operating in the City came to the conclusion that the supply of water available was not sufficient to ensure an adequate and continuous supply for their purposes. The concern felt by the Government reached such a point that it resulted in negotiations being entered into between the Crown and the City, which led to the execution of an agreement under date of April 17/1942, between the Dominion Government and the City, for certain improvements in the water supply facilities of the City of Halifax. This agreement covered three projects:

- 1. The installation of larger distribution mains on Kaye and Water Streets leading to and along the water front.
- 2. The development of an additional source of supply, namely Big Indian Lake, and the connection of that source with the City's existing water shed at Long Lake.
- 3. The construction of a low service reservoir of approximately 5 million gellons in the City; or alternatively the installation of an additional supply main from Chain Lake to the City.

The total estimated cost of these three projects was set at \$800,000.00, of which the City's share was not to exceed \$600,000.00, and the Government's contribution was to be \$200,000.00. In no event was the City's share to exceed \$600,000.00, so that presumably the Government's share could be any portion of the cost in excess of \$600,000.00.

Only two of these three projects namely the first and second above mentioned, were completed; the first, on March 29, 1943, and the second on August 31, 1944, The costs as fixed under the terms of the contract were as follows:

Mains within the City.....\$242,272.35
 Big Indian Lake......462,468.05

or a total of \$704,740.40, of which the City's share under the terms of the contract, as interpreted by the Crown, was \$504,740.40.

After the setting up of the Public Service Commission this contract was studied by the officers of the Commission in consultation with Mr. J. R. Køye, Engineering Service Company, and Mr. C. P. Bethune, K. C., and it was felt that this development of Big Indian Lake would

not ordinarily be the logical step in the development of an economical water supply to core for the ordinary growth and requirements of the City. It did not provide water for the high service system, on which the largest percentage of growth has occurred and is anticipated to continue, without the heavy expense of pumping both at Big Indian Lake and within the City. It did not provide an additional trunk main from the source of supply to the City to care for an emergency or failure in one of the old mains and it did not provide any improvement in fire protection within the City as a whole, such as would a new and larger main from the high service source of supply to the City. It did not improve in any way the regulation of pressure over the distribution system in the City, which necessitated going ahead with the construction of additional pumping facilities at the Dutch Village Road station. In effect all that it did was to provide at a considerable cost an additional supply of water to the low service of the City if and when required.

The conclusion was reached that in the result the Big Indian project was entirely a wartime necessity in order to ensure an adequate primary supply to care for the very large increment in the consumption of water occasioned directly by the war. It is anticipated that with the termination of the war in Europe, a large part of this increment will disappear, in which case it is most likely that Big Indian would not be required for many years in the future until the normal growth of the City's population and industry had reached such a stage as to warrant it.

As a result of the conclusion arrived at, representations were made to Honorable C. D. Howe by Mr. Doane, Mr. Kaye and Mr. Bethune, and additional conferences were held with Mr. Howe's technical advisors, pointing out the facts above mentioned. Mr. Howe stated that he had every sympathy with our desire to extend and improve the distribution of water in Halifax and noted that the Big Indian Lake diversion would not benefit our plan for providing adequate service. He stated that he was favorably disposed toward recommending to the Government the following proposal:

- 1. The City to pay forthwith the sum of \$242,272.35, which is the cost of the mains within the City, together with interest thereon from March 29, 1943 (the date of the completion) at 31%, which amount as of July 31, 1945, to approximately \$19,700.00, or a total as of that date of \$261,972.35.
- 2. That the Government will assume the full cost of the Big Indian Lake project, amounting to \$462,468.05.
- That the payment by the City of Halifax of \$242,272.35 in cash together with interest thereon to date of payment will be regarded as liquidating in full all obligations entered into under the agreement dated April 17, 1942.

4. That the City or Commission will not apply for rates for water supplied to the Government or to wholly-owned Government properties which will result in a discrimination against the Government as compared with other consumers.

agreed that his offer would stand if the Commission would withdraw its present application for the abolition of the 6¢ block in its water rates and defer action on any changes in rates until sufficiently reliable data is available to permit an application to be made for a general revision of the rate schedule of the Commission, and undertake that any recommendations made by the Commission to the Public Utilities Board will not impose an unfair burden on Federal Government purchases of water.

The net result of the negotiations and tentative agreement arrived at is that the City will be relieved from the obligation of paying an amount of \$262,468.05, being the net cost to the City of the Big Indian Lake project, together with \$8,400.00 of interest thereon to date, or a total of approximately \$271,000.00.

The City will have paid for the new mains installed within the City limits, which were necessary and form a permanent part of the general distribution system within the City, and Big Indian Lake will have been added to the water system free of any cost to the City.

At a meeting of the Commission held the 13th instant it was decided to recommend to the City Council that the proposal above set out be approved and that the City Council authorize the execution of an agreement supplementary to that of April 17, 1942, with the Government of Canada in terms satisfactory to the City Solicitor for this purpose, and that the Mayor and City Clerk be authorized to execute the same on behalf of the City.

It is further recommended that the City take immediate steps to secure the funds with which to pay to the Government the amount of \$242,272.35 with interest as aforesaid and arrange for any necessary financing in connection with the same, in order to save any unnecessary increase in the accrual of interest on this sum.

The meeting was called specially to consider report from His Worship the Mayor re Housing.

Read letter from His Worship the Mayor as follows:
August 6/45.

The Members of the City Council, Halifax, N. S.

Dear Aldermen:-

At the July meeting of the Council, approval was given to undertake a program with Wartime Housing Ltd. which would cause to be erected 100 prefabricated houses in this city for the use of returned men. At this meeting authority was given to arrange for sewer and water extension at a cost of approximately \$43,000. for such improvements.

In due course I conferred with the officials of Wartime Housing Ltd, in Toronto and learned
from them of their willingness to support the program
for 100 houses but their estimate of the requirements
of the City to meet the housing situation which will develop next year is some 500 houses.

I have consulted with our City Assessor the Deputy Commissioner of Works, the local directors of Wartime Housing Ltd and Mr. James Hall of the same company who was sent to Halifax to survey the situation and the conclusion at which we arrived was that the City's

August 6, 1945.

program should be 250 houses. This number, along with the houses now under rental arrangement by the City would involve about 500 homes.

There has been some variation from the original agreement with Wartime Housing Ltd. The original plan required the municipality to provide land serviced with water and sewerage, sidewalks and streets, and an obligation by the company to remove the houses after a certain fixed time.

The agreement under which the company now operates requires the municipality to provide the land with sewerage, water, sidewalks and streets, said land being deeded to the company.

At the conclusion of a period of from 15--18 years, the municipality has the right to purchase the houses for \$1000 each, and it is my understanding that the municipality must purchase all the houses or none at all. If such a purchase is made at the end of the term, the municipality is in a position to arrange for sales for such an amount as will cover its original investment in the land, including improvements and interest. It would appear that the houses which are to be on concrete foundations would be of sufficient value when ready for sale after ownership by the city, to insure against any loss on the undertaking at this time. The contributions made by the government through Wartime Housing Ltd., takes the form of adequate maintenance of the houses throughout the whole period, all rentels received by the company being credited against the original capital cost.

It is planned that Wartime Housing would administer these homes and under the terms of the agreement would make them available exclusively to returned men. The rental in the case of a six roomed house would be \$32.00 and in the case of four roomed houses, either \$27.50 or \$25.00. Taxes are limited to the same arrangement as in the case of the previously built houses, namely \$30.00 for the large houses, and \$24.00 for the smaller ones.

It should be pointed out that at the conclusion of the 15-18 year term when the houses will be re-sold, if the city buys them, the rate of taxation then applicable will be the rate common to all residential realestate.

A reply dated July 5th, 1945, has been received from the Board of School Commissioners, stating in part that, "Quite definitely that this Board will not require any part of the land at Wellington and Inglis Streets."

Mr. MacKinnon stated that he had discussed this street with Mr. Copp today. He said they might hire a steam shovel to fix the street and then it might be oiled but it would be more economical to pave it rather than oil it every year.

Alderman Walker stated that we always hire something.
"We should have our own equipment."

Alderman Walker wanted to know what was wrong with the Alderman who were not present at this meeting. "We often have to wait for a quorum and you see the same vacant seats all the time."

His Worship the Mayor stated that two Aldermen were sick and the others were away on vacation and that the situation will be remedied in September when the Aldermen will be back. "I will write them a letter at your request."

Alderman Walker replied that he would not object if His Worship the Mayor used his name.

RESOLUTION TOWN OF DARTMOUTH RE EXPLOSIONS

WHEREAS on the night of July 18th and the early morning of July 19th, 1945, explosions took place in the Magazine at Burnside as a result of which damages were caused to properties in the Town of Dartmouth, the City of Halifax and surrounding territory; and within the said Town of Dartmouth practically no building escaped being damaged.

AND WHEREAS the Minister of Finance has announced that the policy of the Dominion Government is that these damages will be paid as if they were damages under The War Risk Insurance Act; with the additional proposal that small claims which would not ordinarily be paid under that Act will be paid from other Government funds if they are otherwise qualified;

AND WHEREAS the result of this will be that many persons will have to bear their own loss;

THEREFORE BE IT RESOLVED:

- l. The Town Council of the Town of Dartmouth places itself on record as describing this entire proposal as discriminatory and unjust;
- 2. In the opinion of this Town Council the matter is not one for adjustment under the War Risk Insurance Act; but the damages caused by these explosions are the clear and distinct responsibility, both moral and legal, of the Government of the Dominion of Canada;
- This Town Council therefore requests the Minister of National Defence for Naval Services, under whom the Magazine was operated, to make immediate arrangement for payment in full of all loss and damage caused by the said explasions;
- 4. This Town Council further requests that it be advised without undue delay, what attitude the Minister proposes to take upon this request.

RESOLVED:

sponsible authorities to remove the explosives magazine from its present site at Burnside to some location so far distant from Dartmouth as to eliminate danger to the town in the event of an explosion.

This matter was ordered filed and the City Clerk was directed to write the Fown Clerk of Dartmouth advising that the City has decided to await the report from the Naval Enquiry before taking final action.

AFTERNOON SESSION SPECIAL MEETING

Council Chamber, City Hell, Helifax, N. S., August 20/1945, 5.10 P. M.

An adjourned meeting of the City Council was held on the above date.

After the meeting was called to order by the Chairman and before considering the regular order of business, the members of Council attending, led by the Deputy City Clerk, joined in repeating the Lord's Prayer.

There were present His Worship the Mayor, Chairman;
Aldermen Batson, Moriarty, Hosterman, Adams, DeWolf, Walker,
Burgess and Ahern.

HOUSING

Read letter from George T. Bates as follows:

Helifax, N. S., August 16/1945.

To His Worship the Mayor and Members of the City Council.

Gentlemen:

At the request of Mayor Butler and in cooperation with various officials and individuals the problem of locating sites for 255 houses has been considered.

The problem is of a three fold nature due to the urgency of the housing situation and the fact that Wartime Housing Limited are prepared to cell immediately for tenders for the construction of these houses. Immediate construction requires lots already serviced by sewer, water, and rough grading of streets.

The three main phases of the problem due to these facts are as follows:

- (1) How many lots already serviced by sewer and water and rough grading are there in Halifax?
- (2) How many lots close to existing sewer and water installations are there in Halifax?

(3) What other lots or land suitable for development which could be economically and quickly serviced are there available in Halifax?

In considering possible sites, top priority would naturally be given to land or lots already owned by the City of Halifax. Next in order of priority might be privately owned lots already serviced, and third, privately owned lots which could quickly and economically be serviced.

In the first category there are several properties for consideration. In Highland Park there are 18 lots already serviced by sewer, water and rough grading. These are the only lots owned by the City already serviced. Construction could start immediately on the Highland Park property. The Halifax Relief Commission own approximately 32 lots already serviced by sewer, water and rough grading and which could probably be acquired by the City for their present assessed value which approximates \$300.00 per lot. This would give a total of 50 lots where construction could begin immediately subject to the approval of City Council.

By completing a loop between Union Street and Dartmouth Avenue at an estimated expenditure of \$5,200 an additional 25 lots could be obtained, 16 of which would be City owned, the other 9 being owned by the Halifax Relief Commission and which could probably be acquired for their present assessed value.

There are three privately owned subdivisions which might be obtained by purchase as follows:

- (1) The Merson Property owned by the Lawrence Construction Co. consisting of 35 lots as outlined in the attached letter dated August 8th, to His Worship Mayor Butler and members of the City Council.
- (2) The Vaughan Property on Prescott Street consisting of 23 lots as outlined in the attached letter dated August 14th, and addressed to Mayor A. M. Butler.
- (3) The Barss Property consisting of 23 lots on Connaught Ave., and approximately 50 lots near Windsor Street as outlined in the attached letter dated August 14th, to His Worship the Mayor and members of City Council.

The Commissioner of Works Department has estimated that sewer and water installations on the Vaughan Property would cost approximately 66,500.00. On the Merson Property as noted in the letter from the Lawrence Construction Company sewer and water mains have been laid. Regarding the Barss Property, it is estimated that sewer and water installations for the 23 lots on Connaught Avenue would approximate \$2,100.00. I have no figures on the estimated cost of installation of sewer and water on the 50 lots near Windsor Street but understand that this matter is now being considered by the Commissioner of Works due to the building development in this area.

The development of Fort Needham in accordance with a plan attached would give an additional 57 lots on City owned property.

Other possibilities including 18 City owned lots on Windsor Street and Kempt Road, upwards of 150 City owned lots on Bayers Road, approximately 150 lots on St. Paul's Glebe Property on Bayers Road and approximately 60 lots of Halifax Relief Commission Property on Robie Street together with several other possibilities of approximately 10 to 25 lots per property are under consideration, all of which, however, would require the installation of sewer, water and rough grading which might not be as economical as the ones already outlined.

The important step at this time is the acquisition by the City of improved lots in order that construction can begin immediately.

Alderman Walker remarked as follows: "How long are these houses going to stay up? There are men going away by the hundreds. There are lots of big places in the North End where they are storing equipment for War Assets Corporation. They could be turned into two or three flats. There were houses on the Commons in the last war. They don't pay any rent. The Alderman should think this over for a while. I am not against the houses going up."

His Worship the Mayor stated that the Government made a survey of this City and they estimate that 500 houses are needed. "We have cut that down to 250 houses. Real Estate Agencies state that the demand for places is greater now then it was lest year. The rooming house situation is improved. There will be troops coming back for enother ten months. When they come home they must have a place to live. If the City does not do something about it, it will cause discontent. The City will be able to purchase these houses at the end of 15 to 18 years for \$1,000.00 each. I see a strong reason for this program."

Alderman Walker drew attention to the discharges from the Navy, Army and Airforce.

His Worship the Mayor stated that that matter was gone into and the Civic Planning Commission say that the City is going to retain a big part of our population.

Alderman Walker stated that the slums should be cleared out and the houses should go up in their place.

Alderman Batson stated that he was in agreement that these places should be built. "We needed them before the war and we need them now. If we have to spend money for slum clearance we should buy those properties in."

His Worship the Mayor stated that when we approve of the 250 houses we will be brok here to select the sites. The slum clearance is too big an issue to confuse with this plan."

Mr. Bates stated that in slum clearance you have a different type of problem. "The properties that are torn down will be replaced with multi-dwelling units rather than single ones. The number of dwellings in this City should be increased every ten years by 15%. Today we have a terrific shortage of housing in the low income group."

Mr. Bates then informed Council that there were several privately owned subdivisions that could be acquired for their assessed values, viz:

- 41 lots of Helifex Relief Commission Property
- 23 lots of the Vaughan Subdivision
- 35 lots of the Merson Subdivision
- 16 lots owned by the City and -

August 20/1945.

73 lots of the Barss Property making a total of 188 lots with an approximate cost of \$101,075.00.

After considerable discussion on the matter His Worship the Mayor suggested that Council think the matter over and meet again on Friday, August 24, 1945 at 5. P.M.

AGREEMENT WARTIME HOUSING LTD.

His Worship the Mayor stated that there were letters from the Solicitor's Department pointing out that there

Gentlemen:

Re: Agreement Wartime Housing Limited (Pictou Houses).

I wish to report on the draft agreement re the above submitted to me for approval. This agreement is between the City of the One Part and His Majesty in the right of Canada and Wartime Housing Limited of the other parts.

The agreement contemplates certain lands to be conveyed for \$1.00 per lot to his Majesty — all such lands to be on streets of the City and serviced with sidewalks, water mains, sewers and street-lighting services. The agreement recites that the City is the registered owner of the land to be conveyed. This is not a fact and this recital should be altered to fit the facts.

The land to be conveyed is to be set out in the schedule to the agreement and I understand the Council has now before it the matter of selecting a portion of such land which the City must acquire for the purposes of the The land to be conveyed must be acceptable to His Majesty. Clause 1 of the agreements (on page 2 of the agreement. agreement) is not clear in that it is not certain whether all of the land set out in the Schedule "A" is acceptable and is to be conveyed or whether his Majesty may make a selection from various areas set out in Schedule "A". This of course can be clarified and in my judgment it would be better to set out the exact land to be conveyed, particularly because it is possible that legislative authority to convey may be required by the City if the land is not "tax sale land" (so-called) or if legislative authority is required by the City to purchase the land prior to conveying the same to His Majesty.

In addition the City will have to instal services such as sever and water and sidewalks in respect of certain of the land to be so conveyed.

2. The Company will move houses on to the lots so conveyed and set forth in the Schedule.

The Company will instal water services and drain connections from the house to the street (or lot) line, the City to instal the portions from the street (or lot) line to the sewer or main. The agreement provides that the City may do all the work and His Hajesty or the Company will pay its share.

I would point out that the connection from the street (or lot) line to the house should be according to the City's specifications and satisfactory to the Public Service Commission. This should also extend to the plumbing in

the houses, which should follow our plumbing regulations in order to prevent cross-connections and other defects in installation.

The agreement proceeds to state that:

"upon the completion of all such installations the portions of such connections lying within the boundaries of public streets shall become the sole property of the City without the payment of any compensation whatever therefor by the City to His Majesty and/or the Company and shall thereafter be maintained and repaired by the City at its own cost and expense except the cost of repairs to any private drain connection that has become blocked or obstructed by causes other than faulty construction or maintenance of such connection, which cost of repairs shall be paid by His Majesty or the Company to the City."

This paragraph raises the question of thetitle to new streets (if any are laid out.) Do they vest in the City? If so why is it necessary to say that the City owns the installations therein when the City under the terms of the agreement pays for such installations itself. particularly true of existing streets.

Moreover, unless the installations in the houses and from the house to the street line are not done in accordan co with the specifications of the City and the Bublic Service Commission, but done by the Company or His Majesty,-why should the City be responsible in such places for faulty construction or maintenance of the connections.

Presumably the liability accepted by His Majesty or the Company is for negligence and carelessness of the tenants,

Company is to lease houses to sailors, soldiers 3. or airmen returned from general duty and if there are not enough of these to fill the houses they can be let to anyone. Dependents of such service men are also eligible for the houses.

All water, gas and electric rates must be paid by the tenants.

The Company will carry out the management of the 4. houses and

> "shall at all times well and sufficiently repair, maintain and keep the houses, with the appurtenances and all fixtures and things thereto belonging, in good and substantial repair, reasonable wear and tear and damage by fire, lightning, tempest, acts of God and His Majesty's chemies only excepted.

In view of the fact that the City, as a prospective purchaser, has an interest in the condition of the houses, I would suggest that some provision be made to enable the City to require the upkeep to be of a definite standard or to the Otherwise the houses may depreciate to City's approval. such an extent that they may not be worth \$1000.00 and the City would not be justified in exercising the option and would them find its investment in land and local improvements jeopardized.

City to provide normal municipal services to the 5. houses.

- 6. Company to pay on October 1st in each of years 1946-1960 inclusive an annual sum for municipal services of \$24.00 for houses with 2 bedrooms and \$30.00 for those with more than two the first payment to be prorated.
- 7. Company will pay \$1.00 per house per year for street lighting.
- The agreement states that the dates and payments mentioned in the agreement are the same as those in the agreement dated August 9th, 1945. In my opinion this agreement is of no legal effect as it was not authorized at any meeting of the City Council and the terms and conditions were not before the Council, and the City in such agreement has agreed to the sale of land beyond its power to do so. In my opinion the execution of this agreement was unauthorized.
- or nunicipal or school charges of any kind or nature on or from the tenants or occupants of these houses while the same are owned by His Majesty.

This eliminates the imposition of <u>Household tax</u> which has been permitted under all previous agreements. I suggest that the words "or Household tax" be inserted after the words "business tax" at the bottom of page 5.

I am unable to understand the reason why if His Majesty sells any of the lots between the date of the agreement and December 31st, 1950, the City will receive \$400.00 for each lot, while if the same are sold between January 1st, 1951 and December 31st, 1955, the City only receives \$200.00.

No provision is made as to the period between January 1st, 1956 and January 1st, 1961.

- It is important to note that although the City has an option to purchase the building lots owned by His Majesty on January 1st, 1961, His Majesty reserves the right to sell any or all of the houses and lands at such time or times as His Majesty may see fit.
- The City receives an irrevocable option to purchase all the lots and buildings, etc., owned by His Majesty on January 1st, 1961 as a whole and not individual parcels. The option is to be open for three months January 1st, 1961 to March 31st, 1961. If the City exercises the option it must post 10% of the amount with the notice of acceptance of the option and the balance to be paid within 60 days.

Since His Majesty has the right to sell from time to time - the City's option only goes to what is left, and since probably the best locations will be sold the City may not be justified in buying the remaining houses and consequently may lose the greater part of its investment in land and improvements.

Moreover the three months clause may make it difficult for the City to come to a decision and obtain the necessary legislative authority and the funds to make the purchase. I would suggest that this period be at least

six months - having regard to the date of the sitting of the Legislature from whom the authority to purchase must come.

I do not find any provision protecting the City's investment in the land and improvements if the option is not exercised. How and when does it get it back?

I would like to refer to the agreement for the City-administered houses made in 1943 where the City was protected in the event of a sale by His Majesty by receiving out of the proceeds of the sale

- (a) the agreed value of the lot, and
- (b) the proportional part of the cost of the improvements together with interest thereon relating to the house and lot so sold, the same to be calculated by dividing the total cost of such improvements by the humber of houses erected hereunder.
- The agreement provides that after April 1st, 1961, if the land is owned by His Majesty, full taxes will be paid thereon.
- 14. As to paragraph 13 of the agreement:

"Any existing or future provisions of the charter and/or by-laws of the City respecting the manner, mode, location and type of construction of buildings shall not apply to any of the houses whether owned by His Majesty or otherwise."

I cannot approve of this paragraph without specific direction. It should not be proper for the City to bind its hands for all time regardless of the ownership of the land and houses and the physical condition of the same.

- In signing the agreement the City is bound to submit legislation at the next session of the Legislature to validate and confirm the same. This means the entire agreement.
- has no legal authority to purchase land for the purposes set out in the agreement nor to raise or borrow money for this purpose. Legislative authority will be necessary and the purpose. Legislative authority will be necessary and the only agreement which should or can be entered into by the City would be to submit permissive legislation.
- from encumbrances" until we have had the opportunity of searching the titles to make certain that they are in fact free from encumbrances.
- I would point out that in the message from the Mayor to the Council at its meeting on August 6th in the last paragraph the words "authority is sought to conclude the customary agreement with Wartime Housing Limited."

no "customary agreement". In fact the present series of agreements seem to differ greatly from those of past years to which we have been accustomed.

were some legal disabilities with regard to the agreement between the City and Wartime Housing Limited and asked Mr. Rooney to explain same.

Mr. Rooney referred to the mimeographed letter from the City Solicitor dated August 24, 1945 a copy of which was supplied to members of the City Council previous to the meeting and same is attached to the original copy of these minutes.

Mr. Rooney stated that this matter was given to him one morning at 11 A. M. and that he did hold it up for some time before approving it. We have since gone into this matter thoroughly and we would suggest for your approval, that Wartime Housing Limited be requested to expropriate the necessary lands. The City has no authority to buy land for the purpose of erecting houses as contemplated by the agreements submitted by Wartime Housing Ltd., and it has no legal capacity to raise money for that purpose.

His Worship the Mayor stated that when Mr. Hall of Wartime Housing Limited was here, he was anxious to take the agreement back with him. "I consulted with Mr. Rooney and he concurred in the agreement being signed if I could contact eight Aldermen by phone and describe which land could be used. I received the assent of eight Aldermen and asked them if they would support it when it came to Council. If there are any disabilities it is the fault of the Legal Department rather than the Council."

His Worship the Mayor then called on Mr. Bates who was present to inform the Council as to what sites could be used.

Mr. Bates then suggested the following sites:

32 lots owned by Relief Commission on the Richmond Slope.

18 lots owned by the City on Highland Park.
16 lots owned by the City by completing a loop from Dartmouth Avenue to Union Street at a cost of approximately \$8,200.00

9 lots owned by Relief Commission by completing the same loop.

75 lots in all.

Mr. McManus stated that at the meeting with Mr. Hall he was very definite as to the number of houses the City would finally get and that was 500. At that meeting it was agreed that the committee recommend to Council that 250 houses be erected with the 260 we now have. It may be possible to go ahead with the 75 now and negotiate with Wartime Housing Limited as to obtaining the balance of the 255 houses. You could see the Premier to get the Legislation passed.

His Worship the Mayor stated that there would be no delay in approaching the Premier.

On August 16th, 1945, Council did approve of the conveyance to Wartime Housing Limited of a lot on Fort Needham on which are situated certain army buildings. These buildings are to be converted into five family units. Wartime Housing Limited is to carry out the work and will reconvey to the City on certain terms at the end of 10 years. The City will require legislation before this property can be conveyed.

As the matter is urgent I would suggest that Wartime Housing Limited use its power of expropriation and then enter into an agreement containing the terms previously agreed on. The Council should ratify this later agreement.

EXECUTED AGREEMENT BETWEEN WARTIME HOUSING LIMITED AND THE - CITY OF HALIFAX -

Read letter from the City Solicitor as follows:

August 24, 1945.

His Worship the Mayor and Members of the City Council, City Hall, Halifax, N. S.

Gentlemen:

FOR THE MOTION:

On August 6th a special meeting of the Council authorized the City to enter into an agreement

with Wartime Housing Limited regarding 255 houses on sites to be selected. Apparently on August 9th such an agreement was signed and attached to this agreement are plans showing lots in Highland Park owned by the City and all of Fort Needham. I am informed that this agreement was signed on behalf of the City after the Aldermen were contacted by telephone.

With regard to this agreement I wish to make the following comments:

- This agreement, in my opinion, is invalid, inasmuch as the "sites to be selected" were never selected by the Council in meeting duly convened. The question of these sites should be passed on by the Council, meeting in the manner prescribed by the Charter.
- The agreement itself should be presented to Council for its approval. There are no Council minutes on record showing that Council has approved the agreement in its final form. The consent of the Aldermen by telephone is merely an expression of opinion. Their consent must be given at a meeting of Council convened in the usual and proper manner.
- The agreement requires the City to convey the lands in the Schedule annexed to His Majesty the King. Insofar as the Highland Park lots are concerned, they can be conveyed, having been bought in by the City at tax sale. Fort Needham on the other hand can only be conveyed after legislation is secured authorizing its transfer. The Fort Needham property was conveyed to the City in 1942 by the Relief Commission in exchange for other land and this transfer was authorized by statute. It is therefore not tax sale land and cannot be sold or conveyed without legislation.
- perty attached to the agreement, it also appears that the plan is incorrect as it includes a lot belonging to the Relief Commission. The lines should be corrected to eliminate this lot.
- ment also appear to include a lot already sold by the City to one Christobel Wilson by deed dated December 5th, 1932. This lot would also have to be eliminated from the plan.
- are open to the same objections mentioned in my letter respecting the lands proposed being purchased by the City for Wartime Housing Limited. The two agreements are almost identical.

LETTER FROM SOLICITOR RE WATER EXTENSIONS

Read letter from the Solicitor for the Public Service Commission as follows:

Gentlemen:

Re: Water Extensions Belmont and Greenwood Streets and Fairfield Rd.

At the hearing of the application on behalf of Public Service Commission by the Public Utilities Board this morning for approval of the above extension, as required by the Public Utilities Act, the Board was pleased to indicate its approval of the making of such extensions upon the following conditions, Namely:

That all consumers taking water from the new extension be required to pay as a surcharge, in addition to the present service charge and consumption rates, an annual payment of 25 cents for each foot of the property occupied by such consumer and that the same be approved as an interim water rate.

The Board made this decision upon it being shown that under present day costs of construction no extension for residential dwellings could provide a return to the Commission sufficient to carry the cost of the installation, even though all the lots were built upon and a normal consumption of water ensued. The above surcharge will enable the extension to be carried without loss.

In view of the fact that it is not considered likely that such costs will materially decrease for many years, it is probable that some revision of the general rates will have to be attempted. The proposed surcharge is intended to fill the gap between the present time and such revision in order that building development and normal expansion may continue.
