Gentlemen:

As you have seen in the daily newspapers the Board of Public Utilities has filed its decision on the valuation of the property used in connection with the supply of water to the City. The decision states that the Board finds this value, after providing for accrued depreciation up to December 31st, 1944, to be \$4,690,388.

51. The valuation found by the Board at the previous valuation hearing (commenced in 1923) as at April 30th, 1925, was \$2,788,266.00. It will be noted therefore that there has been a substantial increase in the net value of this plant during the last twenty years.

The Board in its decision reviewed the history of the water system in Halifax and set out the more important additions made since the commencement of the war. Mention is made of the appointment by the Board in 1943 of Engineering Service Company for the purpose of making a complete investigation of the system and a report to the Board. This was done because of the fact that for various reasons the pressure was low and the supply of water considered to be inadequate.

There were a number of additions which were not completed by December 31st, 1944, and were not therefore included in the above valuation. These were as follows:

Pumping station, Dutch Village Road \$200,000.00 Chlorinating building and equipment 50,000.00

These amounts will, of course, increase the value of the plant when the same are taken into account.

Among the items included in the 1923 valuation and omitted in the present valuation is the Going Concern Value, \$200,000.00, omitted because of an amendment to the Public Utilities Act in 1943.

Some modification was made in the submission to the Board on behalf of the Commission as to Working Capital. The net amount fixed by the Board for this heading was \$200,020.00.

I attach hereto a copy of this decision for the information of Council and as part of the City's official record. I have also sent a full copy of the decision to each member of the Council for his information.

On January 15th last, I reported to your Committee respecting the above nineteen lots which were expropriated by Wartime Housing Limited for Veterans' homes. To my report was attached an offer from the owner, Mr. B. J. Vaughan. The matter was deferred at that time in order to negotiate further with Mr. Vaughan who, however, repeated his previous offer. The matter then went to Council and was referred back to this Committee. Early decision should be reached on the matter of arranging for a celebration of the bicentennial anniversary, in 1949, of the settlement of Halifax.

I would request approval of your committee for legislation to permit an initial authorization of \$250, 000. as an appropriation to be financed from any civic funds available until such time as the final cost is known, the same then to be repaid on a fifteen year installment plan.

The legislation should authorize:

- (a) The formation of an Executive Committee consisting of such former mayors and mayors elected in the years 1946, 1947, 1948 and 1949 who are agreeable to act, and who would be given power to elect their own chairman, and to employ any person or persons whose services are deemed necessary under direction of the committee, to develop, plan, and promote arrangements for the said Celebrations, and at any time, in their discretion, to remove any person or persons from office.
- The Executive Committee to add thereto such persons (b) deemed suitable by the members as likely to cause the Celebrations to succeed.
- (c) The Executive Committee to make contracts or other arrangements concerning the Celebrations, including carnivals, entertainments, shows, sporting events, festivals of music, educational displays, portrayal of historic incidents, erection or leasing of buildings for the purpose of the Celebrations and for the housing and feeding of visitors thereto, the compensation to be paid to persons employed by the said committee, and to defrey all other expenses incurred by the committee or its employees for travel or otherwise in respect of the Celebrations.
- The Executive Committee to administer its own accounts (a) and finances, and the auditing thereof.
- The Executive Committee to invite distinguished persons (e)

to be patrons of the Celebrations, and solicit financial support from any source whatsoever.

- (f) The Executive Committee to establish other committees to be formed from citizens or organized groups, and to regulate the powers of such committees.
- (g) The formation of an Advisory Committee to consist of the aldermen in office who would meet from time to time to draft proposals relating to the Celebrations, such proposals to be presented to the executive committee for approval.

Gentlemen: -

I feel that I should make a further report on the progress being made in the taxation proceedings against the Canadian National Railway Company.

In the month of January I attended at Montreal with Mr. Teed, representing the City of Saint John, at a conference with the solicitors for the Railway Company. The purpose of this meeting was to try to agree on certain relevant facts in order that a proper statement of facts could be submitted to the Court in order that it could come to a decision in this matter. I had rather hoped that the Company and the Department of Justice would see fit to agree to most of these facts and thus reduce to a

minimum the number of facts which had to be established by taking evidence to be submitted to the Court. Unfortunately the solicitors for the Company and the Department of Justice were unwilling to agree to certain statements which Mr. Teed and myself thought were correct statements of fact and it will therefore be necessary at some time in the very near future to take evidence to submit to the Court which we feel will establish these matters as facts. Some of the matters which were not agreed to were:

- (1) those relating to joint use of terminals and terminal facilities, both at Halifax and Saint John.
- (2) any reference to the fact that in financing the purchase of railway equipment the Dominion Government dealt in a similar way with the Canadian Pacific Railway as it did with the Canadian National Railway.
- (3) the fact that the Canadian National Railway System is operated by the Canadian National Railway Company.
  - (4) the fact that Company operates hotels.
- (5) certain matters relating to employees, methods of employment, and employee-employer relationship.
- (6) any reference to the fact that in certain parts of Canada municipal taxes are paid and charged as \* part of the cost of operating the Canadian National Railway System.
- (7) the fact and the method of setting up depreciation reserves.
- (8) that the railways comprised in the Canadian Northern Railway System, the Grand Trunk Railway System were operated by the Canadian National Railway Company or by some constituent and /or subsidiary company.

You will realize that in the absence of an agreement as to these facts that the task of securing and taking evidence which will be sufficient for the Court to decide these facts is a major undertaking and will take a considerable amount of time and will, unfortunately, result in some further delay in getting the matter before the Court. I would expect that in the course of the next month further arrangements will be made to take this evidence on commission in Montreal and when this has been completed there is comparatively little more to do in the way of preparing the case for the Court, and I would expect that we will be able to commence the arguments which themselves may take a considerable amount of time.

# LETTER AND PROPOSAL FROM HIS WORSHIP THE MAYOR RE: INVESTIGATION

Read letter from His Worship the Mayor as follows: February 22, 1946.

To Members of the City Council, Halifax, Nova Scotia.

Dear Sirs:

I am attaching a resolution which the Council should consider today. It is a proposal to investigate statments alleged to have been made by a former Mayor, my predecessor in office, to the general effect that the control of the civic administration has passed to other hands who are utilizing it for the purposes of gain.

Members of Council will appreciate the seriousness of a statement of this kind, particularly when it comes from a person who received the highest honor in the gift of the citizens of Halifax, and will be keen, I believe to have the enquiry undertaken in order to protect the reputations of all who hold membership in the Council.

I have mentioned in the resolution a proposal to engage the services of C. B. Smith, K. C., and my reason for doing this is to save embarrassment to the City Solici-

tor who would otherwise be required to represent the city. The alleged statements to be investigated having been made by a former mayor, who continues to be interested in civic politics, and who, therefore, may return the the council as a member, should be enquired into by an independent solicitor.

5.05 P. M. the Deputy Mayor assumes the Chair while His Worship the Mayor reads the following resolution from the floor:

WHEREAS it is reported in the Halifax Herald, a newspaper published in the City of Halifax, in the issue thereof of February 21st, 1946, that a statement, alleged to have been made by John E. Lloyd, a former Mayor of Halifax, in an address stated to have been given by him at the 59th anniversary banquet of Halifax Lodge, No. 12, Knights of Pythias, held in the Lord Nelson Hotel, in the City of Halifax on the preceding evening, namely February 20th, 1946, charged that

"Halifax' civic administration now is being controlled by persons never seen inside City Council Chambers, whose interest is personal gain rather than the welfare of the City as a whole, and the 'logical arrangement' of a City Managerial System faces its greatest threat from those who place political party consideration ahead of community consideration."

AND WHEREAS in the opinion of this Council such statements are untrue and tend to reflect upon the honesty and integrity of all members of the Council by imputing to them malfeasance in office, breach of trust or disgraceful or improper conduct.

AND WHEREAS in the opinion of this Council such statements so allegedly made should be investigated.

BE IT THEREFORE RESOLVED that this Council by a two-thirds vote thereof, under the authority of section 136 of the Halifax City Charter, 1931, do and it hereby does request the Honourable, the Judge of the County Court for District Number One to investigate

- (a) Whether the statement above referred to was in fact made or issued.
- (b) Whether the same was made or issued by the said John E. Lloyd.
- (c) Whether the facts contained in the statement hereinbefore set out, namely:

"Halifax' civic administration now is being controlled by persons never seen inside City Council Chembers, whose interest is personal gain rather than the welfare of the City as a whole, and the 'logical arrangement' of a city managerial system faces its greatest threat from those who place political party consideration ahead of community consideration." -- are true.

immediately deliver to the said the Judge of the County Court for District Number One a certified copy of this resolution.

His Worship the Mayor: "It is my duty to move this resolution and I do so."

# MESSAGE HIS WORSHIP THE MAYOR RE VETO APPOINTMENT FIRE CHIEF

Read Message from His Worship the Mayor as fol-

lows:

February 22, 1946.

To Members of the City Council, Halifax, Nova Scotia.

Dear Sire:

Following my first veto of the appointment of F. C. MacGillivray as Chief of the Fire Department, I sent you a message which contained the records of both Mr. MacGillivray and Mr. Harber, the purpose of this being to seek consideration of what I regarded to be the outstanding qualifications of Mr. Harber for the position.

The facts which I furnished you then are the main facts in support of my action in vetoing the appointment of Mr. MacGillivray a second time. The only additional information I have to add is to quote from a letter written by the late Chief of the Fire Department under date of April 20, 1945, in which you will note that a recommendation for the appointment of Second Deputy Chief Joseph Harber to be the First Deputy Chief is in the direct line of succession, and that the recommendation is also based on the late Chief's belief that it was in the best interest of the city.

Theletter in part follows: "It is my prerogative to recommend his (lst Deputy Chief Joseph P. Ryan) successor who will be acting Chief during my convalescence, therefore, I am recommending that 2nd Deputy Chief Joseph Harber be promoted to the rank of lst Deputy Chief and that Captain Richard Young be promoted to the rank of 2nd Deputy Chief."

The recommendation of Deputy Chief Harber is in the direct line of succession. The recommendation of Captain Young is based on my personal observations over a period his 15 years of service.

"In making those recommendations, I feel that they are in the best interests of the City."

It is my sincere hope that the members of the Council will realize that the excellent work done by the First Deputy Chief who has been acting as Chief for the past several months will be such as to merit their confidence in appointing him after they have given further consideration to the situation, and have taken into account what is best for the City of Halifax.

"Shall the proposed expenditure authorized by the resolution appointing Mr. F. C. MacGillivray as Chief of the Halifax Fire Department, which was disapproved by the Mayor, be confirmed."

City Solicitor: \*If you are in favor of Harber,

vote "no"; if you are in favor of MacGillivray, vote "yes".

Alderman Adams: "The motion I made was that Mr. MacGillivray be appointed Chief. The Mayor asked me about the salary and I said I was not naming any salary."

tion which in itself does not authorize an expenditure. The last meeting I found it very difficult to come to a decision but I have given it a great deal of time and I trust that you will take it as a well considered opinion. If you will permit me to explain why Alderman Adams statement at the last meeting did not carry out what he intended, it is this. The net result is that under the facts before the Council the Mayor has power to veto the resolution and here is the reason: It is a fact that to make an appointment to Heads of Departments there must be a salary attached to that appointment.

On receipt on Friday last from the City Clerk of a certified extract of the Minutes of the City Council of February 14th, 1946, relating to the appointment of the Chief of the Fire Department, I feel that I must express my opinion on the situation which exists as a result of the proceedings of this meeting.

The matter in question was the appointment of a Fire Chief and the resolution appointing Captain MacGillivray was vetoed by the Mayor.

I would like to express my views on the matter as follows:

1. In my opinion in the case of all "heads of Departments" as defined by section 119(6) it is necessary to

eventually provide for a selery.

Section 119(4) provides that "Each of the officers mentioned in this section shall be paid such annual salary as the Council from time to time determines."

In addition, in the case of the Chief of the Fire Department, section 839 is as follows:

839. The Council shall appoint a chief officer for the fire department, hereinafter referred to as the chief officer, who shall be paid such salary as the Council determines, and shall hold office as hereinbefore provided.

Therefore in the case of every such appointment the question of an expenditure for a salary for such appointment must eventually inevitably arise, and for this reason I think that an appointment is not complete if the salary is not provided.

2. In my opinion it <u>is</u> permissible, if the Council is willing, to consider all the applicants for a position and by resolution to select one for the position and when doing so to exclude completely up to that point any question of salary at all.

But this does not become a final appointment until the Council has agreed to an amount of salary.

I come to this conclusion because it appears that in both sections 119(1) and 839 the word "shall" is used and by Chapter 1 of the Revised Statutes 1923, section 23(11), the word "shall" is to be construed as imperative.

J. In the present case a difficulty arises in that there are two motions, one for the purpose of nominating Mr. Harber and one for the purpose of nominating Mr. Mac-Gillivray, each similar in form, but each containing different references to salary.

In addition there is a paragraph in the Minutes + 139 -

immediately preceding the vote in these words:

"Council agreed to accept the names submitted as nominations and the vote was then taken with the following result."

In the case of the nomination of Harber an amount of \$3200.00 was mentioned.

In the case of the nomination of MacGillivray no amount is stated and in addition Alderman Adams after making this monination is reported as stating: "I am not naming any amount for the salary." This was said in answer to a question from the Mayor asking if he wished to include the salary. I presume the Mayor meant "in the nomination."

Apart from these words the nomination of MacGillivray itself was consistent with the view that whatever salary was provided in the appropriation for the salary of Fire Chief would apply.

The Words used by Alderman Adams are in my opinion capable of two meanings, depending upon which words are accented.

- (1) If emphasis is placed on "naming" (i.e. I am not naming any amount for the salary) this would I think be equivalent to saying "I am silent as to the amount", in which case the appropriated salary would apply.
- (2) If emphasis is placed on "any" (i.e. I am not naming any amount for the salary) this could I think be construed as meaning "at no salary at all."

I have to determine whether the answer by Alderman Adams to the Mayor's question, to which I have referred, can be considered as part of his nomination and in explanationthereof or whether it is extraneous to it.

Without considering these words, the nomination

itself would as I have said automatically carry with it the amount appropriated for the Fire Chief's salary.

as part of the nomination and in explanation of it the same result would follow if the first interpretation given to his words is accepted. I think the reasonable interpretation is to take Alderman Adams; ensuer as being in explanation of his nomination and consistent with it rather than being in conflict with it. The second interpretation would conflict. Therefore I have to come to the conclusion that the net result of Mr. MacGillivray's nomination is that the appropriated salary is automatically associated with it.

By accepting this interpretation the last paragraph becomes quite consistent.

I would also like to call attention in support of the conclusion above expressed that, at this meeting, the Council adopted a report of the Finance and Executive Committee recommending that "the appointment be made at this meeting", that is the appointment of a Fire Chief.

It was therefore the apparent desire of the Council to "appoint" and not merely do a part of the act of appointing - namely the "selecting" of the man.

The conclusion I have arrived at gives full weight to this fact.

This being so, I have to say that in my opinion the Mayor has the right to veto the resolution on the grounds that it authorized an expenditure.

I would add, however that there is nothing to prevent the Council under an appropriate resolution from selecting the person it wished to appoint as Fire Chief and without providing any salary until after the selection has been made.

The Mayor would have no power to veto the selection of a man but the resolution fixing the amount of the salary end which in effect would be completing the appointment would be subject to veto under section 317 on the grounds that it authorized an expenditure.

During the reading of the Solicitor's letter Alderman Adams asked the following questions:

Alderman Adams: "I rise to a point of order, I said "I was not naming any salary". After the vote was taken you (His Worship the Mayor) declared that Captain MacGillivray was appointed. The Mayor only has power to veto an expenditure. The Charter says the Council shall select these officers."

Recently I had a conference with Hon. Harold Connolly, Minister of Industry and Publicity for the Province of Nova Scotia, and at this conference, representatives of the Junior Board of Trade were present.

The proposal discussed was the erection of a suitable tourist bureau, and I suggest to you that the time has arrived when the city should participate in this important project.

The capital cost of the building could be assumed on a half and half basis between the province and the city; the capital cost would likely amount to \$30,000 or \$40,000.

The maintenance of the building in future years would be something to be borne completely by the province and the city as would also be the cost of clerical assistance and free literature. The management of the bureau would be undertaken without charge as a permanent civic service by members of the Junior Board of Trade.

Mr. Connolly has indicated his willingness to arrange for the drawing of plans and the erection of the building, and all that remains to be done now, if you agree that the project should be developed at once, is firstly, to appoint a member of the Council to serve on a committee to select a site, and secondly, arrange necessary legislation to allow the city to enter the plan.

Alderman DeWolf: "We have not given this enough discussion. I was only suggesting permissive legislation and then the incoming Council could decide if they want to put it through."

His Worship the Mayor: "In order to put it through and make it operative you would have to have the duties laid down."

Alderman DeWolf: "I would like to get permissive legislation for salaries."

Alderman Coffin: "I don't see what you want, legislation for because you have an executive Committee. All you are trying to do is to establish a committee that will meet more frequently. Regarding paying the Aldermen; I have my own views on this matter.

At the meeting it was suggested that the Executive Committee meet every day, I would like to know now many men could do that. I can't see where you are adding anything by inserting this this year. If you want to discuss a City Manager I would be only too delighted to discuss it. As for the payment of Aldermen there is a lot of merit in what Alderman DeWolf says. However I came in here for three years on another basis. I certainly can't see where you are adding anything if you put a new Executive Committee on the books, you can use the one you have. They are meeting with Heads of Departments and their reports are either accepted or rejected. I think you should be careful in going to the Legislature. I would like to see the incoming Council work on this for a start."

Alderman Doyle: "As for an Executive Committee, we have four now. An Executive Committee of the Council,

I can't see it. Who would they be and how would they
deal with matters any better than we are. I am not
clear on it. One resolution is to pay the Alderman and
the other is for an Executive Committee of Council."

His Worship the Mayor: "It is really that we are appointing a Committee with managerial powers. I see a lot of merit in Alderman DeWolf's suggestion. I don't think we would need daily meetings."

Alderman DeWolf: "As an illustration the Master

Plan for example, I can't see now that can be taken

care of unless we have ony meetings and my thought

was that perhaps all Aldermen could not attend all

meetings that would be necessary to take care of that

situation and that is why I suggested a challer group,

that was all I had in mind. It was not to exclude

anyone. A smaller group would be able to operate better."

His Worship the Mayor: "If we arrange to pay the Aldermen we could without any embarrassment call a weekly meeting of the Council and deal with all matters accumulating."

Alderman Adams: "I am against paying the Alderman.

I think there is a lot of merit in what Alderman DeWolf says. I think if the Executive Committee met every week they would get through a lot of work."

His Worship the Mayor: "It would be better for the Council."

Alderman Adams: "I would say the Executive Committee meet and then call the Council."

Alderman Coffin: "If you meet every week and briefly, you would have much greater efficiency."

Alderman Walker: "The only loop-hole in this is that if you appoint this Executive Committee, would be to give them power and authority to do things the same as a City Manager and what they say would be law. Once the Committee did something the Council would be tied. There will be a little company of three or four."

Alderman Ahern: "Can we deal with these resolutions separately? I will support that first resolution."

Alderman Batson: "I consider that the Finance and Executive Committee which has been the Executive Committee, have done a rattling good job and I have often

times praised them because they have voiced a good many things that I thought should have gone through. I am against paying the Aldermen but I will support a City Manager. I would cut the Mayor and Deputy Mayor's salary and plunk it all in with the City Manager. The City Manager would relieve the Mayor of a lot of things. It was suggested that we have a City Manager and that we pay him a salary of \$15,000.00 and it was poo-pooed."

His Worship the Mayor: "There was no suggestion that this man was to be paid \$15,000.00."

Alderman Batson: "If it is a City Manager you want I would say "Yes" but I can't see why you want to throw the onus of the city's business on three or four."

Alderman DeWolf: "If the Alderman would come more frequently to meetings that would fill the bill."

His Worship the Mayor: "I really believe that if we can get through the Legislature permission to pay the Aldermen the matter might be solved because the Mayor of the day may not feel any embarrassment in calling the Council once a week. If they don't attend they will lose part of their pay. There you have your elected representatives functioning once a week."

Alderman Coffin: "I think this Council is afraid of the man who might get the job or that they won't pick the right man. I respect their feelings but I do say that I question how you can get me to attend any more meetings if you pay me or not."

Alderman DeWolf: "Would the City Manager decide with respect to the Master Plan?"

Alderman Coffin: "He could certainly consolidate reports and keep a managerial eye over the whole business of the City."

Alderman Burgess: "Would it help any by paying the

Aldermen so as to give you a chance to call meetings, an Alderman doesn't have to take the cheque, he can give it to some institution.

His Worship the Mayor: "I believe that men who give their time to the City are entitled to reward."

Alderman Doyle: "I am willing to support this paying Aldermen again."

It was agreed that the motion should be that the principle of paying the Aldermen be approved and the necessary legislation obtained.

The motion was put and passed, seven voting for the same and four against it as follows:

### LEGISLATION RE STREET GRADING COSTS.

Chairman and Members of the

Finance and Executive Committee,

Gentlemen:

At a meeting of the Works and Finance and Executive Committees held jointly on May 28th 1945 a report was submitted by the Commissioner of Works on behalf of a sub-committee which had been appointed to study the existing basis of frontage assessment for Street Grading and other improvements.

In the said report the Commissioner advised in part that, "At the present time the City has a petition from the residents of Rockcliffe for acceptance of this street. The estimated assessment per foot for this project in extraordinarily high, and for this reason we are submitting a proposal on street grading only at this time. "...also that "At a meeting of the Committee held on May 25, it was decided to recommend that the City of Halifax secure an amendment to the present authority whereby the cost of that portion of the assessment exceeding \$2.00 per foot frontage be borns by the City, and provided for in the appropriation of the following year."

The Committees' recommendation to Council thereon was as follows: "Due to the dangerous condition of this street it is recommended that the Commissioner of Works be authorized to do sufficient work in grading to eliminate any hazards and that the charges for same be deferred until such time as legislation confirming this action is obtained; it is further recommended that legislation be obtained to establish a new system in respect to the acceptance and grading of streets."

At the City Council meeting held on June 14th, 1945 it was moved by Alderman DeWolf, seconded by Alderman Batson that the report be approved and that the matter of securing legislation to establish a new system in respect to the acceptance and grading of streets be referred to the Committee on Works for consideration and report. Motion passed.

The matter was referred to the Committee on Works, which on August 8th, 1945 further deferred decision.

The problem arose from the estimated high assessment, which would have been imposed on the abutters of Rockcliffe Street if this street had been improved according to regulation.

The Committee on Works at a meeting held on the 5th instant recommended that legislation be sought whereby the charge against each abutter toward the cost to the City of Grading Rockcliffe Street or any other street in the City of Halifax, would be limited to a maximum of \$2.00 per lineal foot, and that further legislation be sought to ratify the action of the City Couldil on June 14th, 1945 in authorizing the Commissioner of Works to do sufficient work in grading Rockcliffe Street to eliminate any hazards and that the charges for same be deferred until such time as legislation confirming this action is obtained; and the work completed; also that such legislation enable the City to act in the case of any other street as it did in the case of Rockcliffe Street.

Dear Sir:-

As an institution of higher learning, embracing the professional schools as well, Dalhousie University occupies a high position in Canada and beyond. The presence of the University makes Halifax the intellectual capital of the Maritimes, and gives the city a name of distinction far and wide. It has given to our citizens a significant pride because Halifax is the home of this outstanding seat of learning. I do not doubt that the intangible values flowing to our city from the presence of the University here cannot be accurately computed.

The tangible values, however, are something else, and they can be evaluated with accuracy. This is an industry of organized teaching worth over \$1,000,000 annually to the community. The calculation in support of this statement may be seen in the following summary:

Annual expenditure of 756 out-of-town students for 30 weeks, at \$15.00 per week, in addition to fees

\$340,200

Annual amount saved to parents of 521 Halifax students who would otherwise have to pay \$500.00 a year to maintain such students in other universities

260,500

University disbursements for year \$482,831.69

\$1,083,531.69

The city, of course, grants tax exemption to Dalhousie, but this is a situation common to all like institutions.

The President of the University has represented to me the extent of civic assistance given to the University of Western Ontario and Queen's University of London, Ontario, and Kingston, Ontario, respectively. This help has been substantial and the President of Dalhousie has asked me to invite consideration by the Halifax City Council to an annual grant, and my proposal is that the sum of \$15,000 be approved.

It is my hope that you will see in this proposal much that is worthy. It will nelp the growth of Dalhousie, and our interest, as citizens, will thereby increase. It will assist the cause of learning, and I believe that if we, as a Council, were to initiate this financial programme, the action would be appreciated not only as a forward step, but as indicative of our understanding of the needs of a famous seat of learning.

The proposal to grant \$15,000 annually would be in addition to the grant of \$10,000 given to the Health Clinic.

It has come to my attention that in finalizing the estimates this year a portion of the amount standing to the credit of the Current Surplus Account was included in the estimates. This action is such all by subsection (2) of section 308 of the Charter.

I understand that the final resolution takes this amount into consideration but I think it would have been better to have passed a separate resolution specifically determining the amount of such current surplus account to be included and then to proceed to include it as was done.

While I do not think the failure to pass such a formal specific resolution effects the validity of the Council's action to the extent that the estimates are improperly passed or that there will be any defect in striking the rate, I am of the opinion that to make definitely certain that no such defect exists some legislation should be obtained ratifying the inclusion of the above sum in the general revenue portion of the estimates and then ratifying the estimates themselves.

This is the first time that the current surplus account has been used for this purpose and I would suggest that in future years the decision to use this source of revenue should be made in sufficient time to permit the preparation of the proper resolution.

Gentlemen:

While this matter may, strictly speaking, be one for the Committee on Works, I am anxious to have the matter referred to Council for a decision and I felt that it could go to Council through your Committee.

At a meeting of the Council held February 14th, 1946, a report from the Committee on Works was approved. This report contained the following words: "The Committee recommended to Council that provided the building restrictions placed upon the land by the Eastern Trust Company be continued and specified in the deeds" that certain lots be sold. The following are the restrictions imposed by the Eastern Trust Company:

"The said hereinbefore described lands shall be subject to the following building and other restrictions and conditions which shall be deemed to be covenants running with the lands for the benefit of the owner or owners from time to time of the lands now owned and occupied and in possession of the Grantor fronting on Inglis Street aforesaid, of which the said hereinbefore specifically described lands form a part:

- (a) That no building shall be erected nearer than 20 feet from any city street line.
- (b) That no building shall be erected except a residential building for the use of a single family nor shall any building now or hereafter erected be used for other than residential purposes.
- (c) That no building shall be erected costing less than \$7000.00.
- (d) That only two buildings shall be erected, provided however that necessary garages or other outbuildings may be erected in connection with a private residence.

I particularly wish to refer to clause (c) which states: \*That no building shall be erected costing less

than \$7000.00. This limit of valuation was first inserted in a deed in 1942, and I was under the impression that in the discussions about this matter the amount of \$7500.00 was mentioned as being the minimum value and that such value was to be considered at present day building costs. This seems to be somewhat different from the provision provided by the Eastern Trust Company and I would like to have the matter definitely established. It is not improbable that a building which would cost \$7000.00 might not be the same type of building which could be built for this money in five years time. I think that even since 1942 building costs have them.

Inquiry has been made as to the general practice of financing concrete sidewalk renewals in various cities. Replies were received from the following: Engineering News-Record, Moncton, Quebec, Montreal and Saint John.

Engineering News-Record: In general you will find that large and medium-sized cities of the United States the sidewalk becomes the responsibility of the abuttor who is liable for injury or damage incurred by disrepair. Replacement is at the abuttors expense. This report is based on the survey made by the American Public Works Association of Chicago.

Moncton: Reparis are paid for from annual appropriations. Only renewal was a stretch 200 to 300 feet long of faulty construction on which bonds had expired and

which was renewed by capital expenditures.

Quebec: Sidewalk renewal are governed by the same principle of new construction, the abutting property owner paying 50 per cent of the cost.

Montreal: A special assessment is made against the abutting property for concrete sidewalk renewal as in the case of new construction, 99 per cent of the cost is assessed in all cases.

St. John: After such structures are 1:'d, the City by present arrangements, agrees to keep the same in repair without further direct costs to the owners of the abutting properties.

The Committee is contemplating but has not yet decided to recommend to Council the acquisition of sites for approximately 24 prefabricated nouses at the Barss property, and sites for approximately 24 prefabricated houses at the Peregrine property, if available.

The sites selected by Council last fall for Veterans' homes have now been reduced to two. Many of the sites suggested were rejected by Wartime Housing Limited and some additional sites, not previously listed, were purchased. At the present time, of the original list, there remains the St. Paul's Glebe Land and the Barss lots, twenty-four in number on Connaught Avenue.

The St. Paul's Glebe land has been surveyed and according to this survey, contains approximately twenty-nine acres and has been appraised by our Appraisers for the sum of Twenty-three Thousand Two Hundred Dollars (\$23,200.00.) The owners are asking for Eight Hundred (\$23,200.00.) The owners are asking for Eight Hundred and Fifty Dollars (\$50.00) an acre and based on our figures, this would amount to Twenty-four Thousand Six figures, this would amount (\$24,650.00.)

Our engineers have subdivided this land and the subdivision gives a total of 192 lots with some vacant land left over south of Fairview Cemetery. Approximately 186 lots are necessary to finish the project. Our engineers

have made estimates of the cost to provide sewer and water, streets, grading, etc. for this subdivision and the figures are as follows:-

Sewer and water Grading and stoning for various streets Grading of lots (if required)

\$ 100,000.00 10,000.00 15,000.00

\$ 125,000.00

Should Council decided to take this land, it will not be necessary to take the Barss lots which front on Connaught Avenue which are 24 in number.

Negotistions were started with War Assets Corporation for a 100 ft. strip off the back of Peregrine, fronting on Connaught Ave. to balance the Barss lots. These negotiations have not yet been concluded and if St. Paul's Glebe land is taken, this 100 ft. strip off Peregrine will not be required.

#### LETTER C. C. F. RE: HOUSING

February 25, 1946.

Halifax City Council, Halifax, N. S.

#### Gentlemen:

Certain information regarding the Housing Project on the North Common has been released through the local press. We fully realize the desperate situation facing this City in regard to housing, and we do not wish to obstruct or delay any reasonable plan which will provide living space for our citizens.

However, before action is taken to lease a large section of the North Common to a private Company on a \$1.00 basis for fifty years, we would like to call your attention to the following aspects of the whole matter.

- other locations in the City upon which this housing development could take place, and we feel that the whole field should be thoroughly canvassed with a view to the possibility of this development being located so that the North Common is not eliminated as a recreation centre for the City.
- 2. The rental scale of the proposed apartments has not yet been made public, but indications are that the rentals will be beyond the reach of the lower income group, that is, the people who need nousing most. We feel that it is not good policy to allow a private Company to use all this land for a type of housing which does not cater to the greatest need.
- regarding the plans of the City of Halifax for an adequate program of low cost homes. The four hundred projected apartments is but a small start on the six thousand or more homes needed in this area. If the City Council decides it is absolutely essential to use the North Common as building space, it would hardly seem to be good policy to give away its choice land before Municipal plans for low cost housing are drawn up. The North Common would seem to be a more logical situation for low rental homes than for ones higher in the scale. Consideration should be given to the total overall construction picture before final action is taken in allowing a private Corporation title to the best building site in the City.
