TRAFFIC CONTROL MILLER STREET

Read report of the Committee on Works as follows:

Gentlemen:-

At a meeting of the Committee on Works held on December 3rd, the question of closing a portion of Miller Street to heavy traffic was again considered.

On Motion of Alderman Sullivan, seconded by Alderman Doyle, the Committee recommended that Miller Street be left open during the Winter months and that the Chief of Police be instructed to stop speeding and overloading; also that truck drivers be asked to use that road as little as possible, and the Engineering Department be instructed to make a survey of the situation and submit a plan.

Moved by Alderman Sullivan, seconded by Alderman Doyle that the report be approved.

At this point Ex-Mayor E. J. Cragg, who was in the Council Chamber, was invited by His Worship the Mayor to sit on the rostrum.

Mr. Cragg accepted the invitation and sat to the right of His Worship the Mayor.

Read letter from Mr. H. P. Briggs as follows:

To His Worship, The Mayor of Halifax, City Hall, Halifax.

Dear Mayor Ahern: <u>Re: Miller Street Traffic</u>

It is hoped that this matter will receive the serious consideration of the City Council at this week's meeting.

It is the feeling of a great many citizen, property owners and taxpayers that their interests should have first consideration in this matter.

Miller Street was never intended to be a heavy traffic route to or from the piers on the waterfront and was transferred to the City by the National Harbours Board with a definite exception to its being used as such.

Interested taxpayers do not live only on Tower Road, Young Avenue and Bouth Park Street, but are more particularly the thousands of pedestrians who use Miller Street as a walk in their approach to the Point Pleasant roads adjoining the Harbour waters.

The "Golden Gates" only permit the passage of one car at a time and present a definite hazard to heavy traffic using that entrance.

At the recent meeting of the Board of Works the principal reason given by the Trucking Company for not using the Terminal road was the delays caused by Rail traffic. There was no proof submitted that these statements were correct and enquiries made by me today would indicate that they are not correct.

The Superintendant's office of the C. N. Ry. today informed me that freight movements on the waterfront were made for the most part at night or early in the morning. But on such occasions as shunts are necessary in day-time that these seldom hold up traffic for more than a half minute at a time.

During the past several years troop movements did : occasion such delays by passenger trains but these movements are now almost a thing of the past.

The heavily laden sand and gravel trucks now using the Point Pleasant route have at their disposal the same Waterfront route presently being used by the 80% or more firms who are using that route voluntaril;

There can only be one reason for the use of Miller street by water-front traffic: It is a longer route but a faster one. Those trucks can't speed on Terminal road but they can on the Parkway route.

It was then agreed to hear Mr. H. P. MacKeen,K.C. who addressed the Council as follows: "I am a Director of Point Pleasant Park but I am not here representing that body because I have no authority to do so but I don't see why I should not refer to the Agreement made between the City, Point Pleasant Park Directors and the Harbour Commission when Miller Street was opened up."

He then read a section of the Agreement.

Mr. MacKeen: "That was the agreement made by the City. I have nothing else to add. Thank you Mr. Mayor."

Mr. J. L. Hetherington then addressed the Coun-

"Gentlemen there is very little to add. The whole matter is well explained by Mr. MacKeen. I do not wish to take up your time. My point in being here is to ask the Aldermen to implement the agreement entered into by the City and the Harbour Board. It was agreed as to what was to take place. The City was to do everything that was within its power. I do suggest that it does lie with the City to stop heavy traffic now that the war is over. We ask you to make good that sgreement. Thank you."

Mr. Cragg then addressed the Council as follows: "I was asked to come here on behalf of a delegation as I was a party to the agreement. It was arranged between myself and Mr. Hetherington. It was definitely the

intention to prohibit the use of heavy traffic on that road. It was definitely written into the agreement. I don't think the City of Halifax has the right to permit heavy traffic on that road according to the agreement. I think it is mandatory. It was the intention at that time. The road will not stand heavy traffic. It is definitely written into the agreement that the City is to do all within its power to prohibit heavy traffic. I would suggest to you to prohibit it."

Alderman Walker: "I believe that when that road was opened up it was when the Yacht Squadron was opened there and the passenger cars had to go around all the bumps and right through the terminals. I believe it was brought up, but I am not sure, it was opened up for traffic. Now the war is over and they want to close it. I don't think it is right to stop the trucks coming up there. It has been carrying heavier trucks that were going over it before. I am still of the same opinion."

Mr. Gragg: "I think the Alderman is quite correct. The real object was to get the \$2,500.00 from the Harbour Commission. To get it we agreed to open that road to give access to the Yacht Squadron. We were anxious to get that money. Council agreed to take that money and to use that money specific. That is the conditions which we had in mind at that time that the City could not prohibit military traffic over that road in time of war. There was no objections during the war. Definitely that was the reason why we opened the road to give access to the Park and the Yacht Squadron. I think you must abide by that agreement now."

Alderman Doyle: "As seconder to the motion I asked in the Committee on Works, what was the reason for closing

Miller Street. There were three reasons (1) Overloading of trucks on Miller Street (2) Speeding on Young Avenue and (3) A child may be killed on Young Avenue. I think you will agree with me that these are all matters for the Police to control. I could not see sufficient reasons to vote any other way. We had a delegation of truck drivers at the Committee on Works, drivers who make their living. The only time they use it is when trains are across Pier 20."

Alderman Coffin: "Was the Agreement read to the Committee on Works?"

His Worship the Mayor: "It was read."

Alderman Breen: "May I correct Alderman Doyle that he was a seconder to an amendment."

City Solicitor: "The Harbour Commission is released from the City and the Park Commission in respect to the taking over by the Crown of certain portions of the Park. It also deals with Clarence Street."

Alderman Lloyd: "If it was between the Park Commissioners and the City there might be some reason but I don't see what interest the Harbour Commission has to do with the closing of streets in the City. I think the Harbour Board was to lop off some land to make this road. Could the Park Commissioners enter into an agreement with the City to do certain things?"

City Solicitor: "They are the lessees. They hold it in trust for the people of the City. There is definitely a certain amount of trusteeship."

Alderman Lloyd: "It occurred to me that it was a three-way agreement and as far as closing the street or prohibiting its use it was the concern of the Trustees. The Harbour Commission only entered into the agreement so that they could get a release because they were paying

some money. I would say that we have no power as a Council to depart from that agreement until it is proven that the City has a legal right to abrogate same. Unless the residents agree that there is an emergency situation existing we will have to keep the agreement. I would like to point out that no motion is any good."

The report of the Directors of Point Pleasant Park was then read to the Council.

Alderman Sullivan: "There was a very strong delegation of truck drivers here and the main point brought out was as Alderman Doyle stated was overloading and speeding. It was felt that a compromise could be made. I embodied in the amendment that the Chief of Police stop the speeding on Young Avenue and the truck drivers stop the overloading."

. City Solicitor: "Clarence Street was closed and Miller Street was opened while Pier B was being constructed."

Alderman Sullivan: "It was only during the construction that the street was closed?"

The City Solicitor then read a Clause in the agreement.

Alderman Sullivan: "Another idea brought out was that in the event of all traffic coming North on Terminal Road it would cause considerable congestion on South and Morris Streets. I am in sympathy with the residents down there and it would work a hardship on the truck drivers too. If it was left open till the Spring, the matter could be taken up again."

Alderman DeWolf: "Has the City any jurisdiction over this matter?"

His Worship the Mayor: "The upper part is a City street. I will have to ask the Solicitor as to the

legality of that agreement."

City Solicitor: "I would like to have the indulgence of the Council to give a proper considered opinion. I can tell you this much that as between the City and the Point Pleasant Park I think there is an enforceable agreement. I can say that."

Moved in amendment by Alderman Breen, seconded by Alderman Moriarty that the Chief of Police be instructed by this Council to implement the agreement and also the wishes of the Park Commission.

Alderman Lloyd: "I don't think you can entertain the amendment any more than you can the motion. I would Bay that we are legally bound to keep that agreement. I have every sympathy for both sides in this argument. We have already agreed under the agreement not to permit heavy traffic on that street. I think that is a matter for the Chief of Police to interpret. He requires directions from this Council before he will put up the signs. Neither one of these resolutions are in order until you (The City Solicitor) give your interpretation."

, His Worship the Mayor: "The Chief of Police is Traffic Authority and he does not come to the Council or Safety Committee for direction."

Alderman Breen: "I can assure you that the Park Commission will ask for a piece of land there and it will not be too long. One portion must be as valid as the other."

Alderman Lloyd: "I asked the City Solicitor if he could give a decision tonight. If the agreement is binding on the City then all you do is live by the agreement. You don't need Alderman Breen's resolution."

His Worship the Mayor: "That is what I say." Alderman Breen: "Has the City any authority to

regulate traffic in a restricted residential area?"

City Solicitor: "The Chief of Police can. The Chief of Police only acts after a resolution of a Municipal Council in the case of a prohibition. The Chief then puts up the signs."

Alderman Lloyd: "Is the agreement on the part of the City enforceable against the City and if so why bother with the signs?"

Mr. Cragg: "Has the City the right to permit heavy traffic on that road with the agreement in existence?*

Alderman Coffin: "I thought we were going to give the Solicitor time to answer that and I think it is fair to do so."

His Worship the Mayor: "I think the Solicitor should have time to study this."

Alderman Burgess: "Was this an exchange for closing Clarence Street?"

His Worship the Mayor: "I think you are quite right on that."

Alderman Burgess: "I think the recommendation of the Committee on Works would not hurt anything if that went through tonight."

Alderman DeWolf: "Would the sum of \$2,500.00 have been paid to the City if heavy trucks were going to use that road?"

Alderman Lloyd: "The City would have to go some-

where else to pave a street."

Mr. Cragg: "Clarence Street did not exist at that

time. After some negotiations with Mr. Hetherington

they agreed to give that money for the purpose of paving

Miller Street. The Park Commission then came into the

picture. The present end of Miller Street is in the Park

now. Regardless of what this Council can do, any heavy traffic over that is committing an offence."

Alderman Moriarty: "It was never anticipated for anything else other than the members of the Yacht Club to have access to the property. The other street was just a rabbit path to my memory. It was no road at all. In the South End we were anxious to have that road constructed. It does not look so nice at the present time."

His Worship the Mayor: "I think you should have all the facts from the legal department and also the Works."

Alderman Coffin: "There are some of us who have not heard the truck drivers point of view at all. I think we are missing the whole point."

Moved by Alderman Lloyd, seconded by Alderman Doyle that the matter be deferred until the decision of the City Solicitor is received.

The motion was then put and passed unanimously the following Aldermen being present and voting therefor: FOR THE MOTION

His Worship, the Mayor, and Members of the City Council, HALIFAX, Nova Scotia.

Gentlemen:-

In the recent submission of the Board of School Commissioners for permission to purchase land in the north end of the City for use for future school purposes, sufficient information was not furnished to enable you to complete your considerations.

I beg to submit the following for your consideration:-

Within a short time, judging from the growth of the City in the area north of Duffus Street, it will be necessary to provide school accommodation for the children in this area. The nearest schools to this area are Richmond and Mulgrave, both of which are now being enlarged but which, even with their increased accommodation, will not take care of any large increase in school population such as will be experienced when this north end area is developed. Land, for building purposes in this area under consideration, is selling quite rapidly and there remains available only one section of land suitable for a school site.

Therefore it is the earnest wish of the Board that permission be granted to complete and pay for the following land purchases.

- 1. From R. H. Cordes 9 lots of land on the west side of Isleville Street, and area of approx. 375' x 130' - 1.14 acres - at a cost of...\$1,800.00
- 2. From R.H. Cordes 6 lots of land on the east side of Isleville Street, an area 250'x100' - 0.575 acres - at a cost of\$1,200.0
- 3. From R.H. Cordes 5 lots of land on the west side of Leaman Street, an area 206'x100' -0.47 acre - at a cost of\$1,000.0(

It is, therefore, my opinion, most implicant that this growth should be protected, and until such time as the City owns the property or the existing lines of the City owned property can be determined by survey, that our recommendations of October should be given further consideration. I therefore trust that the Committee or Finance will recommend to the City Council an early study of our report which was deferred at the October meeting of Council.

At its meeting of December 2, 1946 the Committee on Public Health and Welfare considered the principle recommendations contained in the Rockefeller Foundation Report dated May 1, 1946 entitled "A Survey of Governmental Public Health Organization Operating Within the County of Halifax Nova Scotia" and the summary thereof as prepared by Dr. Morton, Commissioner of Health.

It is recommended to City Council that whereas Halifax City should take a lead in this urgent matter, that City Council appoint the Committee on Public Health and Welfare as its representative to meet with similar representatives from the Dartmouth Town Council and the Halifax Municipal Council at the call of Hon. F. R. Davis, Minister of Health, to further discuss this Survey and prepare plans for its formal adoption.

And it further recommends that Hon. Dr. Davis be notified of this action and asked to have the other interested governing bodies appoint their representatives and meet at his call at an early date so that any necessary legislation can be prepared for the next session of the Provincial House.

At the October meeting of City Council you were provided with copies of "A Survey of Governmental Public Health Organizations operating with the County of Halifax, Nova Scotia, with recommendations for their Administrative Unification". This Survey, was requested by the County Council and the Dartmouth Town Council through the Hon. F. R. Davis, Minister of Health and was made by two Doctors of the International Health Division of the Rockefeller Foundation.

-904 --

I do not intend to go into the details of conditions found as you have all had the report, but I do want to point out to this Committee and through it to City Council, that the health of Halifax City is materially interwoven with the health of these surrounding areas. The problem to be considered is, therefore, the formulation of a plan of local health administration to cover the whole metropolitan area of Halifax City, Dartmouth, and Halifax County in part or as a whole.

They point out three possible solutions:

1. Modernization of public health services in Dartmouth and the municipality on a full-time local unit basis. To bring them in line with the services now being received by the citizens of the City, but separate units.

2. Interrelated budgets and employment; in common, of supervisory personnel - which I do not believe would work out as it would mean either Halifax City Health Department would be given sums of money to spend in the County and Dartmouth, or that the Provincial Department would administer the area and control to some extent the health activities in the City as well as the town and county.

3. The establishment of a joint Board of Health to serve as the public health administrative agency for all these divisions, or for the City. Town and the immediate suburban areas which lie in a radius around the Harbour and Basin and inside this radius lie 78% of the population of the County. (Eastern Passage, Imperoyal, Woodside, Woodlawn, Tufts Cove, Albro Lake Road, Bedford, Rockingham, Fairview, St. Margaret's Bay, Kline Heights, Spryfield, Melville Cove, Jollimore and Purcell's Cove).

This is the area most concerned and where the greatest health hazards lie, and are quoted in the report as constituting an emergency problem. During the past few years I have seen, time after time, evidence that any outbreak of digease in these areas would be a distinct menace to the City.

In my opinion the best protection of the area can come about by adopting the third recommendation and bringing into being a metropolitan health area to be set up as suggested by them on pages 16, 17 and 18 of the report.

I submit this to you gentlemen after careful study and I urge that City Council go into this matter thoroughly and at an early date so that legislation this year may be obtained to put into operation a plan to protect the health of the citizens of this City by building up better health conditions among the immediate suburban areas where most of the people come to our City daily either to work or to shop.

City Solicitor: "Once the Council decides that the occupation is incompatible then the employee cannot engage in such occupations".

Alderman Lloyd: "I think some of our employees have opened up stores while they were Policemen".

City Solicitor: "The Council has taken no action as far as I know".

Alderman Hosterman: "There is nothing to say that a wife of an employee cannot open a store. I understand that the Cabs Committee took action with regard to Firemen driving taxis".

Alderman Burgess: "I think if a man is employed with the City he should be satisfied instead of taking the bread out of another man's mouth. It was alright in wartime".

Alderman Lloyd: "I think it would be wise to change the legislation to allow the employee to make a request. He can ask for a ruling if he thinks he is violating a rule".

Moved by Alderman Lloyd, seconded by Alderman Sullivan that the Safety Committee be requested to

review this whole matter. Motion passed.

His Worship the Mayor stated that he had an agreement prepared by the City Solicitor whereby the steel in the grandstand at the Exhibition Grounds would be exchanged for the materials from one of the buildings at the South Barracks.

Moved by Alderman Burgess, seconded by Alderman Walker that His Worship the Mayor and City Clerk be authorized to execute the agreement on behalf of the City. Motion passed.

QUESTIONS

Alderman Hosterman: "I had a call from a contractor who has made application to the Board of Works to have water and sewer installations made and he tells me he cannot get anywhere. You Your Worship told him that his method of approach was not clear. His name is Mr. Vaughan".

His Worship the Mayor: "In this case the City was called upon to pay \$40,000.00 or \$50,000.00".

Alderman Sullivan: "Some months ago the application was made to serve 7 or 5 lots and the cost was somewhere around \$50,000.00 with an income to the City of \$7,000.00 or \$5,000.00. There was absolutely no property that could be served by the sewer. I voted against it because the expenditure of that money to serve those lots did not warrant the spending of this much money. There was nothing

personal at all in the matter. I think I was grac-

ious and I don't think I was arbitrary".

His Worship the Mayor: "I would vote against

it too if I had the voting power".

Alderman Lloyd: "I am not interested in Mr. Vaughan's interests or anybody else's in this matter but I am informed that you did put in a drain in that area from the Irving Oil Station or from the Railway Crossing Bridge down through the City Dump".

Mr. MacKinnon: "Just a short way Morth. We did not do any work on the Dump".

Alderman Lloyd: "How much did it cost the City in labor, materials and time"?

Mr. MacKinnon: "It was just a small cost in comparison to the sewer".

Alderman Lloyd: "The essence was that you might as well lay the sewer and water in one trench. If Mr. Vaughan's observations are wrong to me they might be wrong to other people. I think we should settle the question once and for all about the drain being put in".

Mr. MacKinnon: "That was only repair work. It would not be deep enough for a sewer".

TRAFFIC SERGEANT

Alderman Lloyd: "We had a lot of talks on traffic. Did we delegate to the study of traffic a Sergeant in the Police Department?"

His Worship the Mayor: "I thought we had one but I find the Traffic Sergeant is doing other duties".

Alderman Lloyd: "I think you should have a Sergeant studying traffic problems at all times. I

understand that directions have not been carried out".

His Worship the Mayor: "I was surprised that

Sergeant Malay was doing other duties".

Chief Fox: "We never had any authority for a Traffic Sergeant. All Sergeants are to be detailed by the Chief of Police. When I took over as Chief of Police I had a Sergeant going around the streets with 'Traffic' marked on his shoulder and one with 'Clerk'. I have been doing it myself as Traffic Authority for the City of Halifax".

Alderman Lloyd: "Don't you think it would be of some advantage to have a Sergeant studying traffic?"

Chief Fox: "I have in mind the setting up of a Traffic Bureau with a head".

Alderman Hosterman: "Was not Malay to replace Power?"

Chief Fox: "That appointment was made in Chief Conrod's time".

Alderman Lloyd: "The directions of the Committee should be changed by the Committee and I think it should be looked into".

His Worship the Mayor: "We will have a meeting of that Committee soon and Traffic Control will be discussed".

Alderman Doyle: "Regarding the matter of a permit to build a shop on Duffus Street; has that permit been granted?"

Mr. MacKinnon: "No, that section is under the Halifax Relief Commission. We sent that recommendat-

ion to them and they said they could not recommend it[#].

Alderman Doyle: "Why?"

,

Mr. MacKinnon: "I have a letter here from Mr.

Tibbs". He then read the letter.

Alderman Moriarty: "That case was a returned man that was unable to work and the Committee thought it was a good idea to place a returned veteran there so he would make a living".

I feel we must have additional revenue".

Alderman Hosterman: "So we can pay the salaries?"

His Worship the Mayor: "I don't know".

Read letter from the Civic Workers Association regarding rights, privileges and benefits in respect to salary (as amended from time to time), cost of living bonus, hours of employment, holidays, vacations, etc.

Alderman Hosterman: "This is no time to talk

about salaries. The Finance and Executive Committee

turned them down until the estimates are prepared

and that is the time to discuss it[#].

HOUSING ENTERPRISES LIMITED

HOME BUILDERS ASSOCIATION

His Worship the Mayor stated that he had received a letter from the Home Builders Association which read as follows:

Your Worship:-

In a recent issue of our press, we note that the City is making available an "ideal site" to Housing Enterprises Ltd. for the development of housing units.

We appreciate that housing of any description is the urgent need, and would be the last to obstruct any method the City may choose to secure housing units, if it were the only way of getting results.

As local house builders we know the urgent need and how little this City has shared in such development, and feel that, as local house builders, we know how urgent this need is and how little we have been able to do about it, notwithstanding many attempts.

This association after many discussions, has come to the conclusion that only by harnessing the energy of the entire house building industry in co-operation with the City, can real relief from this condition of virtual stagnation be gained, and then only if a comprehensive plan is evolved with all of us working to its fulfillment.

We are prepared to develop such a plan, if given the co-operation of the City, and we think this co-operation should begin by extending to local builders the same concession granted to Housing Enterprises Limited.

During the past year the lack of co-operation and organization lost to Halifax, materials of a quantity, to build scores of homes.

With this in mind, the time to start working out our problem is now, so that this City will secure a reasonable share of the 1947 production of building materials for housing, we remain,

The purpose is to give the veteran priority on a house at a price within his reach. I think that should be encouraged by the City. If the Home Builders Association is willing to undertake

that plan with co-operation with Central Mortgage

Corporation they could build a number of homes and

keep themselves employed in their technical skill

until such time as materials became available for

general house building purposes. It is there. They

speak to us about a plan. I think that information should be made known to them and they make their arrangements with the Central Mortgage Corporation and we indicate that we will give priority for the construction of sewers and water and the like and we should be prepared to go ahead with the bargain. I think Housing Enterprises Limited in the field will not interfere for about two or three years due to the housing shortage".

His Worship the Mayor: "All I brought to your attention was the letter".

consideration".

Alderman Coffin: "I think it is inevitable that we have a City Manager and I have said so for five years. I would like to have a discussion on this matter".

Alderman Lloyd: "If Council decides not to have a City Manager then we will have to have a re-alignment of the Committees and the work imposed on the Aldermen. It is really not fair".

Moved by Alderman Doyle, seconded by Alderman Walker that the City Manager question be dealt with next Thursday evening. Motion passed.

It was also agreed that the Transportation Meeting would be held two days after Christmas.

Alderman Coffin: "I was told that the paving estimate was too high. The tracks could be covered by a thin veneer".

Alderman Hosterman: "The Tram Officials gave us to understand that the heavy pavement was not necessary".

Alderman Breen: "Many of the street scenes that were shown the busses were running over the

streets as they were".

Alderman Moriarty: "The weight of a bus would,

I think, necessitate a heavy pavement".

Alderman Doyle: "I would like to see these
