# EVENING SESSION

Council Chamber, City Hall, Halifax, N. S., June 17, 1948, 8:00 P. M.

A meeting of the City Council was held on the above date. After the meeting was called to order by the Chairman and before considering the regular order of business, the members of Council attending, led by the City Clerk, joined in repeating the Lord's Prayer.

There were present His Worship the Mayor Chairman; Aldermen DeWolf, Moriarty, Breen, Hosterman, Abbott, Adams, Lloyd, Kitz, Doyle, Walker, Burgess and Sullivan.

The meeting was called to proceed with business standing over and the transaction of other business.

The following named papers were submitted.

#### MINUTES

Moved by Alderman Burgess, seconded by Alderman Sullivan that the minutes of the previous meetings be approved. Motion passed.

MOTION ALDERMAN WALKER - RECONSIDERATION BALARY CITY SOLICITOR

Moved by Alderman Walker that the resolution passed at the last regular meeting of the City Council respecting the salary of the City Solicitor be reconsidered.

There being no seconder to the motion His Worship the Mayor called for the next item of business.

# MOTION ALDERMAN KITZ - CITY ARCHITECT

Alderman Kitz: "Last month I spoke at some length on the matter of hiring a City Architect. I don't intend to go over the matters I covered again tonight except to say that it is a very opportune time when there is going to be a re-organization of the Works Department. I am very glad indeed and I hope that when they re-organize, if my motion passes, that a place can then be made

for the City Architect and incorporated into our general Works Department. As we are now there are some four qualified engineers working for the City of Halifax. During the last three years the architect fees on buildings, plus what was paid for the Queen Elizabeth High School was \$77,000.00 and if our ordinary building program for the next 2 or 3 years is proceeded with we will have approximately \$100,000.00 extra. I am well aware that all of that money which is paid out in architect fees do not solely and alone go to the pocket of the consulting architect. I would point out for the knowledge of this Council that there was approximately one quarter of a million dollars worth of buildings supervised by the School Board Architect which have been around \$18,000.00 in architect fees paid out and I am advised that the total outside expenditure did not exceed \$500.00. I do not think that when you get into larger buildings that you will have that good fortune. If we save one-half we will still be to the good. When we considered our legal fees 6 months ago with respect to the C. N. R. case they were covered by our day to day costs of our City Solicitor while St. John, our sister City, was \$32,000.00. We have our own drafting room and facilities which an architect can use without difficulty."

Moved by Alderman Kitz, seconded by Alderman Doyle that this City advertise for the hiring of an architect in our local press and such trade journals as may be recommended by the Commissioner of Works and that applications be made to the Committee on Works and that the time of limiting such applications be 30 days from this date.

Alderman Hosterman: "I feel we should have more information before we take action on such a motion. At the same time I feel that with the staff we have under Mr. MacKinnon and the amount of work performed here; is Mr. MacKinnon going to supply the necessary drafting and clerical staffs to carry along an architect? It seems that we should be supplied with what this is going to cost for

additional draftsmen."

Alderman Burgess: "This should be referred to the Finance and Executive Committee. Without any more information I would have to vote against it."

His Worship the Mayor: "How do you feel about that Alderman Kitz?"

Alderman Kitz: "This was put over from last month. If there is sympathy with my motion, it can be mapped out and integrated when the Committee on Works make up their new set up and go into the actual formation of the Works. The place to thrash it out is not the Finance and Executive Committee but the Works Committee, when they re-organize they can go into that."

Alderman Hosterman: "I am sure that Alderman Burgess will go along in sending it back to the Committee on Works. We should get more information from Mr. MacKinnon."

Alderman Sullivan: "I feel there is a lot of merit to it. We sat in Committee the other day and we were hogtied. I thought there was going to be some kind of a joint meeting with the School Board. Is it Alderman Kitz's intention that should the City employ an architect that he would also do the work for the School Board with their sanction?"

Alderman Kitz: "By all means."

Alderman Sullivan: "I would like to know if there is any reaction from the School Board. We should have some costs of setting up another Department of the City of Halifax."

His Worship the Mayor: "We have an architect now who has been doing a lot of work."

Alderman Kitz: "The point that Alderman Sullivan has raised that we should meet with the School Board; we should not lose sight of the fact that the School Board is financed out of money raised by the tax payers.

His Worship the Mayor: "I will have that meeting July 6th." Alderman Kitz: "I suggest that the Committee on Works is the proper Committee to meet with the School Board."

Alderman Lloyd: This kind of debate does stimulate constructive thinking. It focusses our attention on our methods. Alderman Kitz's motion since it has been tabled has aroused a great deal of interest among the Aldermen. First of all with respect to the School Buildings that have been constructed under Mr. Downie. That situation could not continue at the present rate of salary and Mr. Downie made it quite clear that he was satisfied and felt there was sufficient work for him to do as Building Superintendent. To say that we have saved money is a question. The School Board has engaged another gentleman who looks after the maintenance. To bring out your costs you would have to take into consideration all the other costs you incurred while the Building Superintendent was engaged on operations of working out plans and specifications of new buildings. It was also made clear to us that if that arrangement were to continue, the Building Superintendent would expect over 50% of what we are now paying to an architect outside.

The Alderman compared the City's legal fees in the C. N. R. case with St. John. The reason we added to our staff was to enable the Solicitor to explore, more effectively than in the past, more avenues of tax exempt property of the Crown. That job has just begun. To compare the City of Halifax costs with that of St. John is not a true picture. On the surface, yes. We made it quite clear to them that we engaged additional staff so that the Solicitor could be free for this kind of work. St. John felt we should pay some of their costs. The total cost to the City was certainly reasonable considering the problem at hand.

Now our own drafting and engineering Department. What has been our relations in the past with an architect? The Alderman has

stimulated a great deal of constructive criticism. We must borrow the money before we hire the architect. We should not apply for any capital construction until our own Engineering Department has investigated all the costs and given us a reasonable good figure to work with before we apply for any borrowing. Then the preliminary plans are prepared and we take care of that out of our funds. The Department of Municipal Affairs concurs in that view point. When it comes to architect fees he will charge you a total of 6% for plans, specifications and supervision. It is because of these facts that I join with Alderman Hosterman that we should proceed slowly. All your preliminary plans may be done by your Engineers and Draftsmen and your Town Planning Engineer. Your supervision might be fully undertaken by your Engineering staff. Let us look at the picture presented by Alderman Kitz. We will have to add draftsmen, office space, secretarial staff, blue printing, etc. This might cost the City in the vicinity of \$20,000.00 a year before you get through. Suppose you carry that for 20 years; that would be \$400,000.00. Can the City spend \$8,000,000.00 over the next 20 years. What happens when we no longer require the architect? Is it understood that his staff is to be out back or are we to find something else for them to do? There may be merit in the Alderman's suggestion but I join with Alderman Hosterman that a great deal of research work should be conducted before we agree. Today it is possible for the City to borrow money at a reasonably low rate. To make a prediction if they are going up would be foolhardy. They cannot go down very much lower than what they are now. The chances are they will rise. That is one reason why we should go ahead with our building and build with a reasonably low rate of interest. The Westmount area should not be delayed because the School Board and the Council has not decided on an architect or not. Gorsebrook also. In view of the matters I have raised tonight, I do not believe the Council will make a quick decision. Your Worship the Alderman has

certainly focussed attention on our costs. I submit that by exploring the matter further we may be able to work out a new arrangement with an architect and re-organization of the Works Department that will cut the costs to serve the public interest."

Alderman Kitz: "I don't wish to answer Alderman Lloyd item for item but there are several answers to the points he makes. We have had an architect on our staff for the last couple of years and you have an architect on the School Board. To consider that your School architect is a City employee and to realize that such an employee can plan buildings when they are to be planned and look after the supervision, seems to be the way to look at it. I am quite in accord and agreement that the Committee on Works should meet with the School Board and we have a report for the next meeting of Council and the matter can then be considered."

Alderman Breen: "As far as I am concerned, there is great merit in what Alderman Kitz says but I will not support the hiring of a high priced official until the Board of Works is re-organized. That should come first. It has been on the go for 3 years."

His Worship the Mayor: "I have a very long report to submit to the Committee on Works."

Alderman Kitz then agreed to add to his motion "That the Committee on Works, School Board and himself meet on July 8, 1948 to discuss this matter further."

Moved in amendment by Alderman Lloyd, seconded by Alderman Sullivan provided however that in the meantime the Committee on Works has finalized its re-organization plans of the Board of Works.

His Worship the Mayor: "The re-organization will come before the meeting for the architect."

The amendment was then put and passed.

PROPOSED ALTERATIONS TO OFFICIAL STREET LINES - HIGH ST. ACQUISITION OF PROPERTIES INVOLVED, ETC.

His Worship the Mayor.

Sir:

At a meeting held on June 9th, 1948, the various parties concerned were heard regarding the alterations to the official City Street Lines on High Street at Lady Hammond Road.

The existing official street lines appear to coincide with those of the Bayers Sub-Division of Wellington Park, which subdivision was laid out around 1850. The first proposed alteration, as shown in red lines on Plan NN - 1-10453, was auggested in order to avoid the one-story dwelling owned by Mrs. Veinot. It was found that in avoiding Mrs. Veinot's dwelling, the lines cut in on the fenced land used by Mr. Horne.

After hearing the various objections, the Committee decided to inspect the site and did so on the ground on June 10th, 1948.

When considering all the factors involved, the Committee recommended to purchase the property of Mrs. Veinot and endeavour to find a place for her. Assuming this to be done, the proposed alteration to the street line could be made as shown in green on Plan NN - 1-10453.

On June 11th, Mr. M. F. Hubley was contacted to find out if his uncompleted dwelling at 968 Robie Street was available for sale. Mr. Hubley stated that it was and the price asked was \$1900. plus \$116.53, the 1947 sidewalk charge. The estimated cost to complete this dwelling would be about \$2500., making the total cost involved \$4516.53.

On June 12th, it was learned that a one-story five room bungalow was available for sale at #136 Duffus Street for \$2000. This bungalow is located between Isleville Street and Agricola Street and possesses all the advantages of street paving, concrete sidewalk, sewer and water, etc. and was shown to Mrs. Veinot.

On June 14th, Mrs. Veinot replied that this place on Duffus Street would not be suitable, although she lived there some years ago, and stated she would accept \$4000. for her property and vacate it by the end of the month.

Last April, when the properties involved were considered, it was thought that Mr. Horwill was to receive \$350. for that portion of High Street occupied by him. In regard to the Horne Property, at the northeast corner of High Street and Lady Hammond Road, an exchange of land could be made if the street lines shown in green, are adopted.

It is fully realized that it is difficult to make a decision but it is respectfully suggested that these matters be decided; the street lines be altered; and work of extending the sewer and water, be started.

<u>AND WHEREAS</u> the said notice stated the intention of the Council to vary the said official street lines, and the date of

the meeting of the Council appointed for the consideration of the matter, and that the plan proposed change thereof may be inspected at the office of the Commissioner of Works at any time during office hours up to the day so appointed for consideration of the matter.

<u>AND WHEREAS</u> the Council has considered the said matter and has determined to vary the said official street lines in the manner set out on the said plan filed in the office of the Commissioner of Works as plan No. NN-1-10453, and being also filed in the office of the Commissioner of Works as Sheet No. 6A of the Official City Plan;

<u>NOW THEREFORE BE IT RESOLVED</u> that, pursuant to the authority in it vested by section 551A of the City Charter as aforesaid, the Official City Plan of the City be amended by relocating the official street lines of High Street lying between Lady Hammond Road and Alma Street in the manner shown on the said plan No. NN-1-10453 and on Sheet No. 6A of the Official City Plan;

AND BE IT FURTHER RESOLVED that the official street lines of High Street so varied be so indicated on the Official Plan of the City and on the copy thereof filed in the office of the Registrar of Deeds at Halifax, Nova Scotia;

AND BE IT FURTHER RESOLVED that in accordance with the provisions of section 549 of the City Charter the Commissioner of Works do forthwith set up adequate bounds or monuments to mark the said official street lines and make a record of the date of the setting up of such bounds or monuments and the location and nature of the same.

Alderman Hosterman wished to know if Mr. Horne was satisfied in this connection and was assured by Alderman Sullivan that he was.

Moved by Alderman Sullivan, seconded by Alderman Burgess that the reports and resolution be approved. Motion passed.

# APPEAL CHILDREN'S HOSPITAL

Halifax, N. S., June 15, 1948.

To His Worship the Mayor and Members of the City Council.

Gentlemen:-

At a meeting of the Finance and Executive Committee held on the above date a letter was submitted from Mr. G. W. Tingley, Chairman of the Campaign Committee to raise funds for the Children's Hospital requesting the city to make a substantial contribution to this appeal.

Your Committee recommends that a representative of the Children's Hospital be permitted to address Council on this matter.

Moved by Alderman Lloyd, seconded by Alderman Hosterman that the report be approved. Motion passed.

Mr. F. M. Covert, Chairman of the Board of Management of the Hospital then addressed the Council as follows: "I want to say first that there are five points that you gentlemen should bear in mind when you consider this appeal. (1) That it is the only Children's Hospital east of Montreal (2) No child has ever been turned away from the doors of that hospital because of the inability of the parents to pay (3) It now admits over 2500 children every year and over 35,000 children have been treated in that hospital (4) It employs over 170 people and (5) It has spent over \$1,000,000.00 in this City. It is true that we serve the whole province but last year over 53.7% of all children were from the City of Halifax. The contributions to date have been extremely generous. We have had three \$10,000.00 subscriptions; four or five \$5,000.00 and we have some \$3,000.00; \$2,500.00 etc. We are still a long way from our

objective and we need a great deal of assistance yet. I would like you to bear in mind that this is a capital campaign. Today we are breaking all records; there are times that we have to put children in the halls. We have no admitting room. Part of the hospital is nearly 40 years old. You may have heard that the Province has contributed \$10,000.00 and a few weeks ago they gave us \$20,000.00 in addition to that. They have contributed somewhere in the vicinity of \$100,000.00 over a period of years. Our patient day costs this year were \$6.40. I have seen the reports of four other Childrens! Hospitals in Canada and they have ranged in 1946 from \$8.70 to over \$12.00 a day. The hospital must be enlarged and that is the purpose of the campaign. \$250,000.00 is for this purpose and \$25,000.00 is for Operating Account. This is not an annual affair and only once in its history has the hospital appealed for funds. A young girl was in the hospital for 200 odd days and the costs for her treatment were \$2,168.00. We recovered \$822.00. There was a deficit of \$1,300.00. They still stay there and get the finest treatment."

Alderman Lloyd: "We could say that this contribution be used for capital purposes only."

City Solicitor: "This will require legislation."

Alderman Adams: "Can we contribute from the Post War Fund without legislation for that purpose?"

City Solicitor: "I don't think so. I don't think the legislation could be used as grants to organizations. It is for Post War Rehabilitation."

Alderman Adams: "It is for building a new wing on the Hospital." Alderman Walker: "I am against taking money from the Post War Fund. We can get it for them and this is a deserving case." Alderman Lloyd: "If this is used for capital purposes the Depart-

Alderman Lloyd: "II only and the set to a borrowing."

Alderman Breen: "If you got it for Dalhousie from the Post War Fund I see no reason why we can't get it for this. I would suggest that it come out of current account next year if it is not approved from the Post War Fund."

Alderman Lloyd: "We have financed other undertakings. You can benefit by a long term borrowing."

Alderman Breen: "I do worry about the source. I am definitely 100% in favor of the subscription to the campaign. I have always tried to protect the Post War Fund. Here is one case where I would be pleased to see the money taken from this fund. May I be told when the grant of \$50,000.00 was made to Dalhousie. If the amount can be taken from the Post War Fund and if it was to come from some other source it should come from current and paid in 1949."

Alderman Lloyd: "If it is taken from Current it affect the tax rate."

His Worship the Mayor: "I am not concerned over the source."

Alderman Hosterman: "The Mayor could assure us that he will use his good office to confer with the Premier."

Moved by Alderman Lloyd, seconded by Alderman Breen that the City of Halifax contribute the sum of \$25,000.00 to the Children's Hospital Campaign provided however that the money must be used for capital purposes of the hospital; the foregoing amount to be obtained either from the Post War Fund or by way of capital borrowing on receipt of a recommendation with respect to this financing from the Finance & Executive Committee. Motion passed unanimously.

I have made a complete and thorough check of all receipts and expenditures relating to the Board of Works; Board of School Commiss-







Alderman Breen: "Is there any plan for this work. Are you going to spend money for lighting and then tear down for pointing? Are these lights to be used all the year around or summer months? Has there been any thought given to the matter of vandalism?"

His Worship the Mayor in answer to the last question: "Yes."

Alderman Breen: "I would like to know if it is correct that if one of these lights become broken that it will cost \$200.00 to replace."

His Worship the Mayor: "The same as your City lights."

Alderman Breen: "Has there been any thought given to the cost of maintenance?"

His Worship the Mayor: "Yes it went through the Council."

Alderman Breen: "We have the grand amount of \$20,000.00 for the maintenance of 60 to 80 miles of paved and oiled streets. Here we are spending \$12,000.00 to light a tower in the woods. It is all tax payers money. I notice \$20,000.00 for improvements to Point Pleasant Park; I know of no such program that will run into that unless plans are coming for that. We have put a limit on the amount for the canteen in Fleming Park."

His Worship the Mayor: "Fleming Park is for the benefit of the children. We have other places for \$3,000.00 cars."

Alderman Breen: "Where is the place for \$3,000.00 cars?" His Worship the Mayor: "Down at Point Pleasant Park."

Alderman Breen: "I would like to see the City have some decent streets."

His Worship the Mayor: "We are going ahead with this." Alderman Breen: "The streets are not patched yet. Bearing in mind labor costs today you will have to get funds from other appropriations. Time will tell. I repeat that \$20,000.00 will not adequately repair your paved and oiled streets."

Alderman Lloyd: "Alderman Breen was here when we passed the estimates; that was the time to criticize when the tax rate was struck."

Alderman Breen: "There was \$15,000.00 cut from that." Alderman Sullivan: "I see \$136,000.00 for streets."

Alderman Breen: "That is for dirt roads I suppose. The evidence is there for anyone to go over the paved and oiled streets.

Alderman Lloyd: "12,500.00 for lighting Fleming Park Tower; there is no more objection to that than could be raised to the \$55,000.00 for the Memorial Drive. It seems the Alderman mentioned that we should not light up something hid in the woods. To light up in Ganada would do no harm and light it up well. It would do no harm whatsoever to let the rest of Ganada know that we like Responsible Government. We retain what we believe is good and we believe that Responsible Government is good. We Ganadians need to learn what Responsible Government means to us. Light it up; certainly light it up. If there is criticism of the way it is planned; that is another matter."

Alderman Breen: "I go along with your Memorial Drive for \$55,000.00. There is probably some justification for that. I am against \$12,500.00 being spent for the illumination of the Tower. I would like that particular item to go back to the Committee on Works to be further discussed to see if some plan cannot be devised for a cheaper cost of illumination. I will have to oppose it. This is the first information I have received on this."

Alderman Sullivan: "Is it necessary to spend a capital borrow-

City Solicitor: "No."

Alderman Sullivan: "We will have a chance to voice our question when this comes up."

Alderman Breen: "This is finalized if this goes through." His Worship the Mayor: "This comes back to the Committee on Works later on."

Alderman Walker: "There was a lot of money put on the Tower years ago and the man over there said it was leaking a year after." The motion was then put and passed, nine voting for the same

AND BE IT FURTHER RESOLVED, that should this report prove unfavorable to the present management by reason of extravagance, inefficiency or otherwise, steps be taken to return control of the water utility to the city.

Alderman Breen wanted to know if the City Market had been advertised for sale as yet as he understood that it had passed the Committee on Works.

#### STREPTOMYCIN

His Worship the Mayor and Members of City Council, City Hall.

Gentlemen:-

At the Finance and Executive Committee meeting June 15th, I was asked to report on a request from the Commissioner of Health for an additional appropriation for the amount of \$5,000.00 to provide for the purchase of Streptomycin for the balance of the year 1948.

Under Section 314, Sub-section 6 of the City Charter, the Commissioner of Finance and Accounts, after the same has been approved by the Finance and Executive Committee and the Council, may supplement such appropriation by transferring to it, funds from any other appropriation provided for such year in respect of any other purpose, work or service in which it is apparent that a surplus will occur in respect of such year but the amount so transferred shall not exceed the amount of such apparent surplus, provided that no such transfer shall in any civic year be made prior to the first day of July in such year.

It is very difficult to estimate the apparent surplus of any

appropriation that may exist at December 31st, 1948, and we cannot at the present time operate under Section 314, Sub-Section 6 as this is prior to July 1st. I therefore recommend that we provide the amount of \$5,000.00 for the purchase of Streptomycin as requested by the Commissioner of Health and show the same as an expenditure made by the City in the civic year 1948 according to Chapter 316 B of the City Charter which reads as follows:

(1) Roads across Garrison Barracks, formerly Peregrine, formerly "Y" Depot. This property was expropriated by the Crown from its existing owners. Included in the boundaries of this property were certain streets which had not been opened but which had been reserved by the City in its conveyance of the balance of the property to the purchasers from the City. On the basis therefore a quid pro quo it would seem reasonable that the request of the Grown for the conveyance of the streets, in the Garrison Barracks for \$1.00 should be favourably considered.

#### RESOLUTION

RESOLUTION BY ALDERMAN J. E. LLOYD RE: RE-ORGANIZATION OF THE CITY OF HALIFAX ADMINISTRATIVE PROCEDURES

RESOLVED: -

That the powers and responsibilities now vested under the City Charter and the Finance & Executive Committee, the Safety Committee, the Committee on Works and the Public Health and Welfare Committee be rescinded and that the said powers and responsibilities be vested in the City Council for the purposes of re-organization of the civic administrative procedures.

That the City Council establish as of May 1st., 1949 the following civic departments to carry out the policies and services of the City Council in accordance with civic erdinances defining the departmental duties and powers to be approved and adopted by the City Council:

The Public Works Department The Public Health & Welfare Department The Police Department The Fire Department The Law Department Tax and Assessment Department The Finance and Accounts Department

That the City Council appoint on or before the 1st day of May, 1949, a Chief Executive Officer to be designated the Director of Departments who shall be responsible to the Council in accordance with civic ordinances and the City Charter for 8

- A. Enforcement of all laws and ordinances of the City.
- B. Supervision, control, co-ordination and direction of all civic departments.
- G. The preparation of and submission to the City Council of the annual current and capital budgets.
- D. The preparation and submission to the Council of all reports required by the Council.
- E. The appointment of all civic employees other than heads of departments in accordance with civil service regulations prescribed by City Ordinance.
- F. The promotion of all civic employees in accordance with a merit system prescribed by City Ordinance
- G. The informing of the public through reports to the Council of the operations of the civic government.
- H. The supervision and control of expenditures made from the annual current and capital budget appropriations.
- I. Such duties and responsibilities as the Council may by ordinance or resolution prescribe.

That the City shall on or before May 1st, 1949, by ordinance, establish civil service regulations governing the appointment of all employees in the civic departments and promotions of employees based upon a merit system provided however, that such regulations shall not apply to the heads of departments and provided further that such appointments and promotions shall be made by the Director of Departments upon recommendation of the head of the department.

That the City shall effective May 1st, 1949, rescind the present two-thirds vote of the Council required for dismissal of heads of Departments and certain other officials employed by the City.

That effective as from May 1st, 1949, the Director of Departments and the heads of departments shall be protected in their tenure of office by a "dismissal for cause after hearing" provision in the City Charter.

That as from May 1st, 1949, all new appointments as heads of departments shall be made by the Council upon receipt of a recommendation from the Director of Departments.

That as from May 1st, 1949, the following heads of departments shall be designated as follows:

Public Works Dept. - Director of Public Works. Public Health & Welfare Dept. - Director of Public Health and Welfare.

Police Department - Chief of Police Dept. Fire Department - Chief of Fire Dept. Law Department - Director of Law. Finance & Accounts Dept. - Director of Finance & Accounts.

Tax and Assessment Dept. - Director of Taxation & Assessment.

That effective as from May 1st, 1949, the City Council shall hold regular meetings of the Council every Monday afternoon of each week.

That as from May 1st, 1949, the City Clerk shall be appointed by the City Council and shall enjoy the same rights with respect to tenure of office as that accorded the heads of departments, and that he shall be directly responsible to the City Council for the performance of his duties in accordance with a civic ordinance prescribing same.

That the City Solicitor be instructed to prepare the necessary legislation for enactment at the next session of the legislature to make the provisions of this resolution effective and mandatory under the City Charter.

That the City Solicitor submit his draft legislation to the Council for approval as to its conformity with the intent of this resolution.

Moved by Alderman Lloyd, seconded by Alderman Hosterman

that the resolution as set out above be approved.

Alderman Walker submitted and read a brief in reply to the Deputy Mayor and same is attached to the original copy of these munites.

His Worship the Mayor then submitted and read the following

brief:

July 15, 1948.

Members, City Council, Halifax, Nova Scotia.

Dear Aldermen:

A Brief prepared by Deputy Mayor J. E. Lloyd, relating to the City Manager form of Government appeared in the local press recently, and no doubt, members of the Council also received copies, which I understand, were prepared for distribution .

While I do not intend to enter into a lengthy discussion on such a drastic change in the form of Givic Government, I feel it is my duty to take issue with Deputy Mayor Lloyd on several matters outlined in his Brief, because we have had a sort of City Manager-Mayor during the past two years.

Many of the things Deputy Mayor Lloyd says the City should have, have been in operation for more than two years, and I must bring to the attention of the Council members what has been done to improve the services at City Hall during the two years of my stewardship.

I regret exceedingly that Deputy Mayor Lloyd's Brief should have

been so widely publicized, because I have in mind the effect the suggestion that we need to drastically re-organize our affairs, might have on our forthcoming bond issue. It is my duty to keep this City in a favorable position with other cities in Canada. I feel I have not failed you in this. Therefore, I have striven to place Halifax's financial standing high in the markets where our bonds are usually quickly purchased. I could tell you confidentially of some of the things I have had to do to retain our high standing, but for the present, we must not divulge our well-organized procedure, to those who might misunderstand us.

1. I think we have a dignified Council, whose responsibilities each and every Alderman realizes.

2. The Capital City of Nova Scotia has long given clean, efficient and exemplary form of Civic Government.

3. When a new service is suggested, I feel that it is the democratic right of all members of the Council to be given all facts concerning such a service. It has been our practice for the past two years to provide such information.

4. All reports now submitted to the Council come via expert hands.

5. The Deputy Mayor points out we should have Council meetings each week. If he will check the records, he will find we have had many, many meetings during the year, at which our problems were ironed out.

6. No matter has been dealt with without full information being available, although quite often a matter was brought in "cold", and it was deferred until information could be provided.

7. As to his reference to information or guidance on some matters involving contracts with several departments, this information is always available.

8. His reference to appointments is misleading because there is a suggestion that many office holders have been appointed despite their lack of qualifications. He must agree that during the past few years, no such procedure has taken place at City Hall, and that those who receive promotions and those who sought positions were carefully screened before they were considered.

9. In answer to Deputy Mayor Lloyd's reference to our Budget Policy and also other financial matters, I wish to point out that during the past few years, drastic changes have taken place in our financial setup, so much so we were able to command a splendid price on our last bond issue.

10. In his reference to supervision and coordination of the work of department heads, I wish to point out to all members of Council, that I have, during the past few years personally investigated all our major projects such as Streets, Sidewalks, Etc. Etc.

My reason for so doing is that I feel your Mayor should be in a position at all times to advise the Council with first hand information.

11. During the past two years, we have had many confidential conferences which have been highly satisfactory in conducting the affairs of this City.

12. A progressive Mayor should at all times be ready to take off

his coat and go to work as I have done, which involves personal inspection of all departments daily.

13. During the past two years, you have had calls weekly regarding matters trivial and major, and I think you have been informed of everything that has gone on at City Hall.

14. It is not unusual to find a ward not represented on a certain committee, although Deputy Mayor Lloyd refers to the fact that neither he nor Alderman Kitz is on the Works Committee. Unfortunately, since the adoption of the Brittain Report, only four major committees have been in operation, and it would be impossible to give full representation to all the wards on all the committees. I do not think the services of Ward four have been neglected, because I have personally inspected the ward, after which I advised the two Aldermen representing that ward of what was needed, and what would be done for the taxpayers.

15. Under your City Charter, your Mayor is virtually a City Manager, that is, if he carries out his duties in a true spirit, and he must look into all departments almost daily. I think that is a good law--a democratic law, and has worked to the advantage of the taxpayers.

16. When I became Mayor, I felt it was my duty to immediately look into the position of our Sinking Funds, and changes were made on the advice of some of the best financial men in Canada. Naturally, the nature of these changes could not be made public, in view of our friendly relations with other sections of Canada.

17. Your Mayor has coordinated all the Departments into a smooth working civic organization. My experience as an organizer and administrator enabled me, without great difficulty to build up at City Hall one of the finest civic organizations in Canada, and I feel, on behalf of many of our employees, that our organization is equal to any in similar business in this Dominion.

His Worship the Mayor and Members of the Council, City Hall, Halifax, N. S.

#### RE: <u>RE-ORGANIZATION OF CIVIC ADMINISTRATION</u> Gentlemen:

At the last meeting of the City Council held on Thursday, 17 June 1948, I gave notice of motion as follows:-

"At the next regular meeting of the City Council I shall introduce a motion designed to accomplish the delegation of certain administrative responsibilities now discharged by the City Council to an appointed executive who shall become the chief appointed executive officer of the city."

A copy of the resolution whereof the above notice was given is attached hereto. The resolution when adopted will result in a form of civic administration generally described as "The Council-Manager plan of organization.

Also attached hereto are organization charts showing:-

(a) The form of civic organization after the attached resolution becomes effective.

(b) The present form of civic organization.

From the above mentioned charts you will observe that the proposed re-organization results in:-

(a) The discontinuance of the four major or standing committees of the City Council.

(b) The delegation of responsibility for the carrying out of council policies and services to an appointed chief executive to whom all department heads, with the exception of the City Clerk, will be responsible for the administration of their departments.

The re-organization is designed to attain the following objectives:

(1) Unification of the powers and duties of the City Council members.

(2) Concentration of the activities of council members on matters of policy.

(3) Stricter control of current and capital expenditures.


(4) The compilation and publication of comprehensive reports on the activities, results and trends in the various branches of civic government.

(5) The establishment of civil service regulations to govern appointment.

(6) The establishment of a civil service merit system to govern promotions of civic employees.

(7) To keep within reasonable limits the demands upon the time

of council members and thus maintain an appeal to citizens to offer for service in the council.



(8) To maintain the position of council members as one of dignity, responsibility and honor.

(9) To provide in the Capital city of the Province of Nova Scotia a real example of clean, efficient, modern and exemplary form of civic government.

A prompt attainment of those objectives is a matter of urgent necessity. Needs that must be met before we can rightfully claim that our city is efficiently managed. Efficiently managed, yet controlled in its direction by democratic methods.

My authority for the foregoing declaration is in the first instance your own experiences in meeting the responsibilities you have undertaken. You recall your feeling of frustration on many occasions when you have not had at hand the required information on which to base decisions. This is not the fault of any civic employee nor any unwillingness to do his best. It is the shortcomings of an organization which requires the heads of seven departments to report to thirteen bosses.

Under our present system official exchange of views and opinions between department heads in anticipation of council needs is not encouraged. Regular department head meetings to exchange technical information and to co-ordinate the work of civic services are unknown in the City of Halifax. For example, the city requires a new street lighting system. Under the present arrangements the city electrician would usually wait until some interested alderman requests action be taken. The electrician later brings his plans to the Works Committee. After the pros and cons have been considered the plan then goes to the Finance & Executive Committee. The pros and cons of the proposal are again discussed in detail and the financial and legal details discussed. The proposal then goes to the foregoing committees, the pros and cons of the proposal are again discussed in detail. Because of no regular staff meetings and the council - committee system the electrician must explain his proposal in detail on separate occasions to:-

- (1) His Worship the Mayor.
- (2) The Commissioner of Works.
- (3) The City Solicitor.
- (4) The Commissioner of Finance.
- (5) The Committee on Works.
- (6) The Finance and Executive Committee.
- (7) The City Council.

Seven times the electrician has to be available to explain his plans. He is lucky if his explanations stop there.

Having run the gauntlet of civic official committees many proposals have been turned down at the council meeting and at some later date the aforementioned process of explanations must be repeated. We have witnessed similar events on many occasions. It is obvious that under existing circumstances staff initiative and enterprise is stifled and eventually becomes non-existent.

The Mayor or Alderman who may wish to establish a new service must travel the same road as the electrician. The proposed re-organization provides the machinery whereby:

(1) Action on improvements or extension of existing services would be initiated as the result of regular staff meetings. The need for such action in many cases would be prompted by the dayto-day study of reports submitted to the chief executive officer.

(2) Explanations to the Council members by the heads of departments or the Chief Executive Officer in the majority of cases would only be required at one Council meeting.

(3) The Mayor or an Alderman desiring factual information or assistance on any civic matter involving more than one department will be saved considerable time. He can obtain his requirements from one source, the chief executive officer. He may also attend staff meetings to obtain guidance on his problem.

(4) Any citizen or group of citizens desiring information or guidance on some matter involving contracts with several departments, would be saved valuable time in obtaining action from the city.

Other illustrations from our experiences as council members are available to justify our action in undertaking an immediate adoption of the attached resolution.

There is also ample evidence available from the experiences of other cities to prove the soundness of the "Council-Manager plan."


Extensive studies of well managed cities in Great Britain, United States and Canada have been made by competent authorities. These studies reveal in practically all instances the existence of a chief executive officer who performs supervisory duties over the various civic departments. The Council, in most cases, delegates the carrying out of its policies to the appointed civic staff through a chief executive.

It is officially reported that over 600 cities in Canada and the United States have adopted the approved or standard form of council-manager form of government. If those cities that follow the main principles of organization proposed herein were tabulated, thousands of cities would be added to the official list.

The town or city clerk of Great Britain who is usually a solicitor skilled in Municipal Administration is the chief executive officer. The City of Montreal has its Director of Departments, a lawyer. Quebec City has its Director of Services, the City Treasurer. The City of Toronto has an executive assistant to the Mayor. That city is considering the appointment of an executive director. The City of St. John, N. B., recently appointed its Assessor as its Chief Executive Officer to supervise and direct its heads of civic departments. You will note two characteristics.

(1) The appointment, as against election, of a chief executive officer.

(2) A wide variety of names to describe officials performing



My final reference to the experience and practices of other cities is found in this following quotation. It is taken from a comprehensive, impartial authoritative appraisal conducted over a three-year period (1937-40) by the Committee of Fublic Administration of the Social Science Research Council of the U. S. A. The Committee found with respect to the manager-plan that it - "by comparison with the preceding forms of government... brought a diminution of partisen or factional influence over the government....furthered long-range planning....raising the standards of public employment....improving the methods of financial management.... The great contribution of the new form of government was to make a single small governing body collectively responsible to the voters for all aspects of the city government."

May I further explain the objectives outlined earlier in this report. The present powers and duties of the individual council members are not uniform. Powers and duties are delegated to the Mayor and Aldermen as Committee members. Each Alderman, however, usually serves on only two committees. For example, neither Alderman Kitz nor myself, representing Ward 4, are members of the important Works Committee. In many instances the nonrepresentation of an alderman on a Committee results in services for a ward being neglected.

By transferring under proper control full responsibility for carrying out our policies to a chief executive officer most of the work of the present committees is eliminated. Thus, we meet to consider and decide all civic problems as a single unit, the Council. We all receive the same information at the same time. We are able to represent our taxpayers with equal opportunity to meet their needs.

We differ from senior governments in that we are not responsible for the economic conditions of the community although we should strive to influence its progress. We do not, for example, have to decide tariff policy or educational curriculum. We are chiefly responsible for the appointment of competent civil staff to conduct police, fire, health, welfare and waste disposal and other direct <u>services to taxpayers</u>. Our responsibility is more like the undertakings of private business than those responsibilities of national or provincial governments. Because of this direct service responsibility our civic affairs should be organized, supervised and managed in the same manner as the Board of Directors of a large corporation handles its affairs, through a General Manager. The taxpayers occupy a position similar to shareholders. Instead of cash dividends, however, they expect and demand services at the minimum unit cost of operation.

Stricter control of current and capital expenditures is another objective requiring further explanation. At the present time, the City is spending on current operations over \$4,000,000 annually. Such a large amount must be expended under standard and formal procedures if funds are not to be wasted or mishandled. We have made considerable progress in setting up the accounting control for the budget. Conscious control of that spending is actually left to the head of each division making the expenditures. While the committees are legally responsible for the commitment of funds, this duty is not performed as it should be.

In Halifax we have assumed that the approval of the annual detailed budget estimates, on which the tax rate is based, automatically becomes an appropriation of funds. The question of the limitation on each object class of expenditure has never been clearly defined. We should appropriate by resolution the sums required for

each department of the City. This resolution would clearly direct the maximum amount that could be spent for example on:

(e) Fixed charges.

With an orderly and standard arrangement of budgeting procedures the supervision and control of the annual current expenditures is delegated entirely to the chief executive officer. He is required to make all purchases of materials and supplies on a competitive tender basis.

We often overlook the effect on our current tax rate of the carrying charges of capital expenditures. We have recently attempted to control capital spending on a budget basis. To date, we cannot say we have a firm and orderly procedure. While we can justify our present capital commitments, it would be sheer folly to continue planning capital projects without exhaustive study of every new proposal. The maintenance costs, unit costs of construction, rates of interest and principal repayment and their effect on future budgets require a great deal more consideration than we accorded such items in the past.

Two and one-half million dollars spent on capital account in 1947 and a similar sum facing us for 1948 brings us close to that point where our capital borrowings will exceed over a five year period our rate of bond repayments. We are faced in 1952, despite retirements of capital debt, with an increase in our outstanding funded debt. It is therefore imperative that we equip ourselves immediately with the civic machinery which undertakes for the council full and detailed studies of all matters pertaining to capital expenditures. We cannot substantially increase our net civic debt without sound and justifiable reasons therefor.

The extent and variety of our civic services in common with other cities in recent years have become exceedingly complex. Parttime aldermen must receive many explanatory and statistical reports from civic departments on which to base policy decisions. Under our present system, well prepared informative written reports are the exception rather than the general rule. Report writing and statistical studies have not been a feature of our civic government. The major and only report prepared for public information and distribution is the important annual financial statement. No explanatory interpretation is attached to this report for the information of council members and taxpayers. Graphic presentations and other comparative tables showing the trend in civic finances etc. are notable by their absence. The informative and often required statistics available from our Assessment Department are not available to the public in published form. This Department might well become a source of valuable information for the business community. Too little attention has been paid to this important revenue producing department and its potential value in the production of reports on housing, population, business and industrial conditions, etc. We can never hope to sell the advantages to business men of locating their plants and undertakings in this metropolitan area until all the facts concerning local conditions are readily avail-

able for that purpose. The maintenance of streets, waste disposal equipment, public buildings, unit costs of public works operations, have never been the subject of regular reports to the City Council. H anata

They should be readily available, and at least published once a year for general distribution. The lack of interesting descriptive information and required written reports on civic affairs has been one of the major reasons for the continuance of the time-wasting committee system.

The proposed re-organization requires the regular production of written reports and statistics for the operations of the Chief Executive Officer. Thus the major function of the present committees time consuming search for many facts on which to base decisions will be unnecessary. The Council can then concentrate their efforts on studies of reports and supporting data from which their policies will be formulated.

We live at a time in history when our democratic forms of government are challanged by those who favor a centralized author-Itarian state. We hear much talk about subversive activities of Communism. It is necessary for us to openly condemn this insidious destruction of confidence in our methods of organizing a society of free men. It is most important that we do not give those enemies of our society ammunition to achieve their ends. We must be constantly on the alert to maintain confidence in efficient responsible We easily maintain that confidence if the public is government. kept informed of our problems. If they receive honest, straight forward reports of our methods. If we show that we have the determination and the courage to keep our government bodies free of the infection of unsavory politics. If we give tangible evidence as elected representatives that our sole interest is responsible efficient government. Municipal government must meet the challenge squarely. There is no logical reason in the municipal field to tolerate the existence of partisan politics. There is no justification for election funds, the result of a municipal spoils system. Log rolling in the purchase of supplies and equipment, aldermanic influence in the appointment and promotion of employees are the inevitable result of our committee system of medaling in administrative details. We erect strong barriers against these abuses of public office in the municipal field by delegating to a competent executive responsibility for:

(a) Appointment of civic employees in accordance with council approved civil service regulations.

(b) Promotion of civic employees in accordance with a council approved merit system.

(c) Expenditure of current funds in accordance with council approved ordinances or administrative orders.

(d) Supervision and co-ordination of the work of department heads under council approved written instructions as to duties and responsibilities.

It is of interest to note that many civic employees holding responsible positions have not had the scope of their duties and the extent of their powers defined by city ordinances as required by the present city charter.

With respect to the effect of the reorganization upon the present duties of the Mayor, the following is quoted from the National Municipal League of the United States. The quotation

refers to the Council-Manager form of civic government.


"Paradoxically, the plan gives a mayor a better chance for really important service to the voters than does the strong mayor plan. This is so because the mayor is freed from technical administrative duties for which he may not be fitted and in which he frequently has no real interest. And, above all, he is freed from the usual procession of job and favor seekers. So the mayor can concentrate on leadership of the council while it shapes the allimportant policies which determine the course of city government, the kinds of services it renders, and the amount of the people's money it spends.

It is the mayor's job also to preside over council meetings, to act in emergencies, to interpret to the voters the work of the city, to take the spotlight on all occasions on which the city must be officially represented, and to defend the administration in elections. The mayor becomes in the finest sense of the word, the city's political leader."

Discussions of this proposed re-organization have revealed unwarranted fears that a chief executive officer with the necessary qualifications would be difficult to find. May I emphasize that the success of the undertaking depends in a large measure on a clean cut, thorough understanding of the objectives. Its success also depends on adopting proven methods of organization without major experimental compromises. In this city we have department heads competent to carry out the required departmental duties. All they need is the green light from an appointed executive to co-ordinate their work with other departments. The chief executive officer's job is in essence one of co-ordination and direction. He must have a capacity to issue concise and understandable orders. He must be capable, with the help of his department heads on technical matters, of writing reports for the information of the council. He requires from practical experience a general knowledge of current municipal problems and of municipal administration. We may have such an executive available in our present staff. If so, appoint him. If. not, let us not be disturbed by those who oppose the plan and use the weak excuse that a trained chief executive is not available. With the plan of organization agreed upon and established many capable executives in government agencies and in private business would readily apply for the post. The salary would not be less than \$8,000 a year but need not in any event go much higher than that figure to attract the qualified applicant.

There may be further information you require not contained herein or obvious from the resolution itself. I shall be pleased to answer any questions you care to ask either before or during the next council meeting.

This report is not intended to belittle or detract from the many major progressive steps we have taken in recent years to make Halifax a better governed and a better city. It is intended to assure that our progress shall continue and be maintained into the future. You will note that the effective date of the proposal is 1 May 1949. This date is suggested because of the necessary legislative enactments to legalize the re-organization. It is also a fitting date, just preceding our 200th birthday, to erect another milestone of progress, marking the pathway of responsible government



## ORGANIZATION CHARTS


