PORT OF HALIFAX FLAG

To His Worship the Mayor and

Your Worship & Aldermen:

Re: Port of Halifax Flag

Some time ago it became apparent that for promotional purposes, the Port of Halifax should have a distinctive flag.

With the approval of your commission, calls for proposals for design were put out and one was chosen. Substantially, the flag consists of the diagonal blue cross of the Nova Scotian standard on a white background with the City's arms superimposed at the centre of the cross. Above the arms are the words "Port of Halifax" and beneath, the word "Canada".

The design having been approved, the undersigned went ahead and used it firstly on the front cover of the new port directory, and secondly on some miniature standards your commission required for promotional purposes. A copy of the port directory and a miniature standard are sent with this letter.

It now appears that the commission erred in using the City arms for these purposes without the express permission of Council, and, of course, for this the undersigned must accept full responsibility. The error was made in good faith on the assumption that, as your commission is entitled to use the City arms on its letterhead, it was also entitled to use them in this way.

The undersigned therefore apologizes to City Council and requests now that the use of the City arms in this way be approved.

It is further requested that this approval include the production of full sized Port of Halifax flags with permission that such flags may be flown by the vessels to which they are presented by your commission.

ENGAGEMENT - CONSULTANTS FOR TRANSIT STUDY

To His Worship the Mayor and
Members of the City Council.

The Finance and Executive Committee, at a meeting held on May 31, 1962, considered a report from the City Manager entitled "Consultants - Transit System Study".

Your Committee recommends:

- (a) that Messrs. Urwick Currie Limited be appointed to complete a comprehensive study of the present operation of the Transit System in Halifax in order to appraise the present situation;
- (b) to make recommendations for future action by the City in the matter of the alternatives set forth by the Nova Scotia Light and Power Company Limited in its letter to His Worship the Mayor, dated February 6, 1962, (copy attached).
- (c) that provisions be made under the authority of Section 316 C of the City Charter for an appropriation of \$12,000.00 for this purpose;
- (d) the terms of Reference shall be as follows:
 1. to carry out a comprehensive study of the present operations of the Transit System of the Nova Scotia Light & Power Company Ltd. for the City of Halifax, in order to appraise the present situation and to make recommendations for future action.

This will involve a study of -

- A. The operating efficiency of all Departments, the scope for improvement and the effectiveness of management.

- B. The level of service provided to the transit rider, hours of service, rush hour service, route patterns and headways.
 - C. The financial position of the system, its debt structure, depreciation policies and earning potential.
 - D. The fare structure; the increase in revenues which might be expected to result from a fare increase and the increase in patronage which might result from a decrease in fares.
 - E. The expected life of the existing trolley coach fleet and the provisions now being made for its eventual replacement.
2. To consider whether the Nova Scotia Light and Power Company Ltd. should be paid a subsidy in order to enable it to maintain an acceptable level of service to the transit rider. If a subsidy is recommended, to set out the basis for determining its amount.
 3. To consider whether an immediate fare increase is necessary or advisable, and if so, the amount of such increase.
 4. To determine whether the transit system should be operated by another authority, such as the City of Halifax, the Public Service Commission or a regional authority.
 5. To examine the services provided by other public transportation systems in neighbouring municipalities in order to be certain that any changes which are recommended are compatible with the pattern of growth and development of the seaport region and any possible future merger with other transit systems in the region.
 6. Based on an analysis of the findings from the foregoing, to prepare a report setting out the consultant's recommendations.
 7. To endeavour to complete this work by August 31, 1962.

QUESTION - ALDERMAN O'BRIEN RE: CONSTRUCTION WORK, DUTCH VILLAGE ROAD

Alderman O'Brien asked if there was a definite plan for the construction work on the Dutch Village Road. He said the work on the far side of the road, near the Rotary has been the cause of a dust nuisance.

His Worship the Mayor called the Minister of Highways in this regard.

The Commissioner of Works stated that a progress report would be distributed to the members of Council the first of the week. He said the work was proceeding on the City side and the only two bottlenecks concerned are the lowering of the County sewer main and the grade near Mumford Road which is a problem for the Highways Department.

Supposing the City received full cooperation from the Province, the Alderman asked how soon the work would be completed.

The Commissioner stated they are aiming for completion by August 15th and are in constant touch with the Highways Department engineers. All specifications are in the final stages of completion in order to call for tenders for the road surfacing. The City has a small section of storm sewer to be laid down which will be started the first of the week.

His Worship the Mayor stated that the matter is under control as far as the City is concerned and the only possible holdup would be that of the Province.

The Commissioner further stated that it was intimated to him that some approval had to be given from policy level of the Government.

Alderman Trainor said he was led to believe that the Province has no money in its budget for the paving of Dutch Village Road.

His Worship the Mayor stated he was waiting for a reply to his letter from the Minister on this regard.

QUESTION - ALDERMAN CONNOLLY RE: FIRES ON CITY DUMP

Alderman Connolly referred to recent fires on the City Dump.

The Commissioner stated that most likely there would always be fires on the City Dump even though his Department takes action to prevent same. He gave the following reasons for such fires:

- (1) Surface fires started by scavengers.
- (2) Spontaneous combustion.

He hoped by constant effort to alleviate, if not eliminate, such fires. He advised that this problem exists with many major cities on the North American Continent, and he suggested purchase of a conical type burner which controls burning but as long as the decomposed materials are burning underground and certain spots erupt, the situation will just have to be combatted to the best of the ability of his Department.

LETTER - ALDERMAN DEWOLF RE: STOP SIGN, INGLIS STREET AND BEAUFORT AVENUE

Alderman DeWolf submitted and read the following letter from Mr. R. Miller, 6177 Inglis Street.

As Alderman in our district would you give the following matter your kind attention.

The speeding on Inglis Street, drag racing, etc., which goes on nightly.

Could a stop sign be erected on Inglis Street, at Belliveau Corner? This could I feel help the screaming of tires and braking that occurs when these cars try and make the bad curve which Ritchie Drive enters into.

At present, a car may leave the stop sign at Tower Road, and come full speed up Inglis to the next stop sign at Beaufort, the dangerous curve being in the middle of all this.

I personally have seen five (5) cars not make this curve---the result, much property damage, and one life.

A petition signed by the residents of Inglis Street requesting that something be done has been ignored, therefore, your assistance in doing something about this matter before more damage or another loss of life occurs would be greatly appreciated.

The letter was referred to the City Manager and Traffic Authority to take the necessary steps to effect a remedy and advise the writer of the action taken. The Chief of Police advised that he had directed extra patrols in the area to check on the speeding especially at night.

QUESTION - ALDERMAN WYMAN RE: STOP SIGN, SOUTHWEST CORNER GOTTINGEN & KAYE STS.

Alderman Wyman advised that a stop sign recently erected at the above location is too far around the corner and in his opinion it is not properly placed. He suggested that same be relocated.

The matter was referred to the City Manager for action.

LETTER - NEW DEMOCRATIC PARTY REQUESTING USE OF CITY PROPERTY FOR PUBLIC MEETINGS

A letter was submitted and read from the above political party requesting use of City Property for public meetings to be held on the North Common, Victoria Park and the Grand Parade.

As this matter was not on the Council Agenda, Aldermen Butler, Healy and Wyman objected to its consideration and same was referred to the Committee on Works.

DIVERSION OF WATER FROM LEPPERT'S BROOK

Mr. Donald McInnes, Q.C., of the law firm of McInnes, Cooper and Robertson, has written the following letter to His Worship the Mayor:

" May 11, 1962

Dear Mr. Lloyd:

We are the Solicitors for Mr. Bernard Lockwood in connection with his property on the Dutch Village Road, Halifax. We attach hereto a copy of a letter we have written to Brentwood Park Investments Limited and which concerns Leppert's Brook and the diversion of water therefrom as a consequence of activities of Brentwood Park Investments Limited.

Our understanding is that the City of Halifax have permitted Brentwood Park Investments Limited to divert the water of Leppert's Brook into the City's sewer. This cannot be permitted either for the present time or in the future. Notwithstanding a hearing before the Committee of Works and letters to City officials, we must say that the City seems completely indifferent to this matter.

We feel obliged to advise you that proceedings will have to be instituted against Brentwood Park Investments Limited and the City unless this matter is corrected forthwith. As we have mentioned, nothing less than a 36" sewer will suffice.

City Council has agreed that Brentwood Park Investments Limited may divert any overflow from Leppert's Brook where it passed through the property of Brentwood Park Investments Limited, into a City sewer, provided that the City is indemnified against any claim for such diversion.

Mr. Ralph Medjuck of Brentwood Park Investments Limited has agreed to execute a document indemnifying the City against any such action and such document is now in the process of preparation and will be executed in the near future. Consequently, if Mr. Lockwood commences an action for such diversion and can prove that he has suffered any loss from such diversion, then the City of Halifax is indemnified by Brentwood Park Investments Limited.

I would recommend that this letter from Mr. McInnes be tabled and if Mr. Lockwood wishes to commence an action and prove loss from such diversion, then that is his privilege under our judicial system.

The City Solicitor has reported to me that under Section 47 of Chapter 39 of the Statutes of Canada, 1960, Canada Elections Act, it is provided that every employee who is a qualified elector shall, while the polls are open on election day, have three consecutive hours for the purpose of casting his vote; and if the hours of his employment do not allow for such three consecutive hours, his employer shall allow him such additional time for voting as may be necessary to provide the three consecutive hours.

Section 31 of the Canada Elections Act provides that the polls shall be open from 8 a.m. to 7 p.m. Standard Time, which in effect means in the forthcoming Election polls will be open from 9 a.m. to 8 p.m. Atlantic Daylight Time.

While an employee whose regular hours of work stop at 5 p.m. will have three consecutive hours until the polls close at 8 p.m. in which to vote it should be pointed out that since the polls do not open until 9 a.m. it would be impossible for an employee to vote on his way to work. In all probability there would be a large congestion of traffic from the hours of 5 p.m. on, thus making it difficult for not only employees residing in the City of Halifax, but also those living outside, to reach the polls within the allotted time.

It is a policy decision of City Council whether or not City Employees should be granted time off prior to 5 p.m. to ensure that they reach the polls in time to vote on Election Day.

MOTOR VEHICLE VIOLATIONS

Alderman LeBlanc referred to the series of articles appearing in the Press respecting speeding and other motor violations, one of which advised the citizens to contact the Aldermen if they observed any violation, and he asked if the Chief of Police could give an explanation for the series of articles.

The Chief of Police stated that he had endeavoured to ascertain the source of the articles without success.

He stated that the question of motor vehicle violations is a responsibility delegated to him by Council which has supplied the necessary manpower and equipment, for this purpose. He also stated that the incidence of such violations had increased 100% in May, 1962 over the corresponding period in 1961 and that extra measures are being taken in an endeavour to overcome the problem.

It was agreed to direct the Chief of Police to prepare a comprehensive report on the matter of motor vehicle violations for submission to the Safety Committee.

The Chief of Police stated that preparation of such a report could not be completed in time for the next regular meeting of the Safety Committee, but that he would be prepared to answer questions at that meeting.

QUESTION - ALDERMAN HEALY RE: PAVED SIDEWALK, POINT PLEASANT DRIVE

Alderman Healy asked if consideration has been given to the construction of a paved sidewalk on the north side of Point Pleasant Drive from Young Avenue to the waterfront.

His Worship the Mayor stated that the City Manager would be directed to investigate the matter and report.

QUESTION - ALDERMAN LeBLANC RE: FOUR-WAY STOP SIGN - BAYERS ROAD
AND HOWE AVENUE

Alderman LeBlanc stated that he had received a number of complaints about the four-way stop signs recently erected at the above-noted intersection and he asked the Traffic Engineer if he had received similar complaints.

The Traffic Engineer stated that the four-way Stop Signs are a temporary measure pending the installation of traffic control signal lights which installation has been delayed because of negotiations with the Board of Transport Commissioners respecting signals for the railway crossing at that location.

QUESTION - ALDERMAN MEAGHER RE: STOP SIGNS

Alderman Meagher referred to the fact that some stop signs are being raised, and he asked if it is planned to cut the low-hanging branches on trees so that these raised signs will be clearly visible.

The Traffic Engineer stated that the purpose in raising the signs is to make them visible over parked cars which creates the necessity for tree trimming as suggested by Alderman Meagher, but that funds have not been provided for that purpose.

His Worship the Mayor directed the Traffic Engineer to take action to have the trees trimmed wherever necessary and if funds are required he is to request the City Manager to provide the same.

QUESTION - ALDERMAN O'BRIEN RE: TRAFFIC LANE MARKINGS

Alderman O'Brien asked the Traffic Engineer to explain the changes in the lane markings at the Connaught-Quinpool and Connaught-Chebucto intersections, which only partly obliterate the former markings.

The Traffic Engineer stated that a portion of the main laning work had been done by the Department of Highways truck which had been aimed incorrectly, but he assured Council that it would be rectified.

QUESTION - ALDERMAN MACDONALD RE: PARKING

Alderman Macdonald asked if there are regulations governing the parking of vehicles close to intersections which impairs the visibility of cars wishing to enter the intersection.

The Traffic Engineer stated that parking is restricted 25 feet from an intersection and 30 feet from a stop sign which is not sufficient for reasonable visibility in some locations, and action is being taken to erect signs prohibiting that type of parking where necessary.

QUESTION - ALDERMAN LeBLANC RE: STREET LIGHTING

Alderman LeBlanc referred to the request made by Alderman Meagher and himself several months ago for improved street lighting on streets in the block bounded by Connaught Avenue, Quinpool Road, Monastery Lane, Harvard Street and Chebucto Road, and he asked for a report on the progress being made with the installations.

His Worship the Mayor directed the City Manager to investigate the matter and report to Alderman LeBlanc.

It was agreed to consider the following additional items, not on the agenda.

City Council has approved the hiring of an Articled Clerk for three months at a salary of \$150.00 per month, and Mr. Reginald Edwards will be filling this position in the Law Department, commencing on June 15, 1962.
