Increase in Letter Writing and Visiting Privileges - City Prison

The following recommendation was submitted from the Public Health and Welfare Committee:

It is recommended that the following additional privileges similar to those in effect in like institutions across Canada be granted on an interim basis until provisions for these privileges now set out in Ordinance #108 can be amended:

#### 1. Letter Writing:

Every prisoner shall be permitted to write his or her parents, wife or husband or other immediate members of his or her family, once every two weeks.

#### 2. Visiting Days:

Each prisoner shall have one visiting day each week. Prisoners with a surname beginning with the letters A to L inclusive shall have visiting days on Tuesday. Prisoners with a surname beginning with the letters M to Z inclusive shall have visiting days on Thursday.

The hours on each visiting day shall be from 9:00 - 11:00 o'clock in the forenoon, and from 1:00 - 4:00 o'clock in the afternoon.

Alderman Black contended that the letter writing privilege should be unlimited as he could see no reason why a prisoner should not be able to write a letter every day should he so desire.

With regard to visiting days, he contended that the Governor should be invited to make further suggestions with regard to the visiting privileges. He said that what is proposed is an improvement, but leaves a let to be desired.

The Commissioner of Health stated that the reason for limiting the letter writing privileges is budgetary and the visiting days' limitation is because of lack of proper facilities for this purpose.

MOVED by Alderman Moir, seconded by Alderman Black, that the recommendation of the Public Health and Welfare Committee be approved and that the City Manager be directed to re-examine the matter and submit a further report. Motion passed.

Mr. Hogan asked for early action on their proposal with respect to the provision of additional parking facilities in the downtown area and he contended that increasing the capacity of Tex-Park parking garage would not solve the problem as many of the spaces in the Tex-Park garage are let out on a permanent basis and what is needed is provision for parking facilities for shoppers.

Alderman LeBlanc contended that Council should not be giving any consideration to providing parking facilities for permanent parking but that parking should be provided for shoppers to stimulate business in the downtown area.

Alderman O'Brien contended that the main aim of Council should be to save the downtown area as a vital area of the City and

it is necessary to provide parking facilities not only for shoppers but also for people who occupy offices in the downtown area; therefore he contended that provision has to be made for short-term, midterm and long-term parking facilities to save the downtown area and maintain the level of assessments in the downtown area for the benefit of the City as a whole.

He asked when the market analysis will be received from the firm of Canadian Urban Economics Limited and when the priorities will be established on the various projects.

His Worship the Mayor said that the report of the Canadian Urban Economics Limited should be available by June 30, 1965 and that a meeting on the matter of priorities will be held at the earliest possible opportunity.

MOVED by Alderman O'Brien, seconded by Alderman LeBlanc, that the matter be deferred for consideration at the first meeting of Council to be held in July, 1965. Motion passed. Doctor's Office in R-2 Zone - #1674 Oxford Street

MOVED by Alderman Lane, seconded by Alderman O'Brien that, as recommended by the Town Planning Board:

- 1. The owner of the single family dwelling-house known as Civic Number 1674 Oxford Street, Halifax, be permitted to locate the office of a medical doctor in such single family dwelling-house notwithstanding that such single family dwelling house is not used as a residence by such medical doctor; provided, however, that only one such office shall be permitted in such single family dwellinghouse.
- The office of such medical doctor shall be staffed by not more than one medical doctor and two other persons to include stenographic and nursing assistance.
- No exterior architectural changes be made to such single family dwelling-house without the permission of the City Council.

Motion passed.

### Harbour Drive - Street Line - Lower Water Street

MOVED by Alderman Black, seconded by Alderman Doyle, that in response to their query, Construction Equipment Limited be advised that the Council concurs in the opinion of Staff that sixty feet (60') will not be sufficient width in any location on Water Street but a final decision as to the width of the street will be withheld until after the report of the Engineering Consultants has been received. Motion passed.

#### MOTIONS

Motion - Alderman Trainor Re: Agreement with Architect - New Halifax Mental Hospital

MOVED by Alderman Trainer that the centract agreement to be entered into by the City with the architectural firm appointed to draw up the plans and specifications for the new Balifax Mental Hospital, contain a provision which would provide that such architectural firm be required to engage on its staff an architect who is extremely knowledgeable in the field of hospital construction.

Tabled at this time was a letter dated May 19, 1965 addressed to His Worship the Mayor and members of Council from the City Solicitor, respecting the appointment of architects for the Halifax Mental Hospital, which contained an opinion as to the validity of the resolution passed at the meeting of City Council held on April 29, 1965 respecting such appointment.

Alderman O'Brien stated that he originally held the view that architectural experts in the field of hospital construction should be involved but had indicated same to the Director of Hospitals who was of the opinion that an involvement of this type of experts was not necessary in the initial stages of the construction of a Mental Hospital.

Alderman O'Brien then suggested that the matter should be considered by the Board of Management of the Halifax Mental Hospital, the Public Health and Welfare Committee and the Finance and Executive Committee after each of these bodies had received a staff report on the question.

He suggested that the three words: surreptitious, clandestine and stealthy, used by Alderman A. M. Butler at the May 13th meeting of City Council to describe the action of the Board of Management in dealing with the matter of appointments of architects for the Mental Hospital, be withdrawn as there is no support in the report of the City Solicitor to substantiate such a claim.

Alderman A. M. Butler stated that the three words were used to describe the hasty manner in which the Board of Management had requested Council to make the appointment of architects in that no written recommendation was submitted, the request having been made verbally by Alderman O'Brien, Chairman of the Board of Management.

Furthermore, other architects were not invited to submit their proposals and no funds were available for this purpose.

In answer to a question by His Worship the Mayor, Alderman A. M. Butler stated that his basic objection to the appointment of L. R. Fairn and Associates by Council was the failure of the Board of Management of the Halifax Mental Hospital to be fair with all other architects and to give them a chance to express their views and to forward their proposals on a project costing four and one-half million dollars, for which the architects' fee would be very substantial.

His Worship the Mayor stated that Alderman Butler had been out of order when he had used the three words in question.

Alderman A. M. Butler stated that the three words were used at the previous meeting of City Council and that he had not been called to order by the Chairman, Deputy-Mayor LeBlanc, and he contended that His Worship the Mayor had no right to call him to order at this time and he said: "And anyway, I repeat them."

His Worship the Mayor: "I must censure you and I will ask you to withdraw the remarks because they are without foundation."

Alderman Black questioned the right of the Mayor to censure Alderman Butler.

Alderman Moir said that as a member of the Board of Management of the Hospital, he felt that any error that had been made by the Board in taking this action was an honest one.

His Worship the Mayor said that in his opinion, Alderman Butler had used improper language when referring to the action of the Board of Management and he asked him to apologize.

Alderman Butler: "I will make an explanation at the next meeting of Council and give my reason for using the words I did."

MOVED by Alderman Trainor, seconded by Alderman Meagher, that the matter of the appointment of architects be referred to the Finance and Executive Committee for further consideration. Motion passed.

Motion - Alderman Black Res Repeal of Section 17(3) of Halifax City Charter

MOVED by Alderman Black, seconded by Alderman LeBlanc, that sub-section 3 of section 17 of the Halifax City Charter be repealed.

Alderman Black, speaking on the motion, contended that the law, as expressed in the sub-section, is undemocratic and that

citizens should be entitled to elect any worthy person for one or more terms for public office and he said he could see no difference in a provision for re-electing a Mayor and a provision for reelecting an Alderman.

The motion was put and passed as follows:

For the Motion: Aldermen Black, Abbott, Moir, Lane, LeBlanc, Trainor, Doyle, Richard and O'Brien - 9 -

Against it: Aldermen A. M. Butler, Meagher, Connolly and H. W. Butler - 4 -

### Motion - Alderman O'Brien Re: Legislation Regarding Poll Tax Errors

Alderman O'Brien stated that at the last meeting, he gave notice that he would make the following motion:

"that the City Solicitor be instructed to draft legislation to make it possible for the City to correct administrative errors in the levying of poll tax and to make possible a refund in a case where a poll tax has been incorrectly assessed and paid for seven years."

He said that he would have to make his motion in two parts, one being to seek general legislation to correct administrative errors in the levying of poll tax and the other to seek specific legislation to make a refund to a taxpayer named Mason, a resident on Connolly Street who had been incorrectly assessed and has paid poll tax for seven years.

MOVED by Alderman O'Brien, seconded by Alderman Black, that the City Solicitor be directed to draft legislation whereby the City would be enabled to:

 (a) Correct administrative errors in the levying of poll tax.

(b) Grant a refund of poll tax paid by Mrs. Laura Mason, a resident at 3201 Connolly Street for the years 1959-65 inclusive.

Motion passed.

#### MISCELLANEOUS BUSINESS

Appointment - Acting Commissioner of Finance

A report was submitted from the City Manager respecting the appointment of a Commissioner of Finance and Accounts.

MOVED by Alderman Abbott, seconded by Alderman H. W.

Butler that, as recommended by the City Manager:

- (a) Mr. John L. Leitch be appointed Acting Commissioner of Finance, effective May 1, 1965 for a period of one year from that date.
- (b) Council defer making a permanent appointment to the position during this period.
- (c) Mr. Leitch be granted a pay adjustment of \$680.00 for the period January 1, 1965 to April 30, 1965 when he, as Deputy Commissioner of Finance, was required to resume additional responsibilities of the position of Commissioner of Finance and Accounts.
- (d) Effective May 1, 1965, the salary of Mr. John L. Leitch as acting Commissioner of Finance and Accounts, be fixed at \$11,840.00.
- (e) The City Manager be authorized to notify all applicants that the filling of this position has been deferred and if necessary, a new advertisement will appear one year hence.

Motion passed.

#### Letter - Spryfield Service Commission Re: North West Arm Bridge

A letter dated May 21, 1965 was submitted from the Spryfield Service Commission urging City Council to give top priority to the implementation of the North West Arm Bridge construction programme.

MOVED by Alderman Abbott, seconded by Alderman Moir, that the letter be tabled. Motion passed.

Letter - Halifax-Dartmouth Regional Authority Re: Establishment of a Regional Park

A letter was submitted from the Halifax-Dartmouth Regional Authority requesting that authority be given to negotiate for acquisition of lands owned by the Department of National Defence

and the Department of Northern Affairs and Natural Resources on McNab's Island and George's Island to be developed for park purposes.

MOVED by Alderman Richard, seconded by Alderman Connolly, that the letter be referred to the Town Planning Board and the Finance and Executive Committee for consideration. Motion passed. Report - City Solicitor Re: Appointment of Architects - Halifax Mental Hospital

The report of the City Solicitor had been considered earlier during consideration of item 16A.

Question - Alderman Trainor Re: Sweeping Streets - Ward 5

Alderman Trainor asked: "When will it be possible to have the streets in Ward 5 swept?"

Question - Alderman Trainor Re: Dust Nuisance - North Common

# Question - Alderman Trainor Re: Inspection of Food Dispensing Trucks

The Chief of Police stated that the changed phasing had been authorized by the former traffic authority but that he would investigate the matter referred by Alderman LeBlanc and submit a report.

Question - Alderman LeBlanc re: Rumoured Resignation - Director of Planning

Alderman LeBlanc asked if their was any foundation to the rumour to the effect that the Director of Planning has resigned his

position.

The City Manager replied in the negative but he stated that the Director of Planning has indicated that he has been offered a position in another country. The City Manager further stated that he expects the Director of Planning will accept the position if all arrangements can be made.

Question - Alderman LeBlanc re: Welfare Officer

Alderman LeBlanc asked if the discussion held a few weeks ago concerning the Welfare Officer and Africville had been resolved.

The City Manager stated that the matter had not been thoroughly resolved as yet but that he has conferred with a senior member of the staff of the Halifax Mail Star who promised to submit further information which has not, as yet, been received.

Alderman LeBlanc then asked if the Health and Welfare Committee had invited any particular person to appear before it.

His Worship stated that Alderman LeBlanc's question would be answered when item 20A on the Order of Business was considered. Question - Alderman Richard re: Abuttor's Charges for Paving Trolley Couch Routes

## Question - Alderman Richard re: Smoke Nuisance

Alderman Richard stated that the smoke problem in the City seems to be increasing as a result of emissions from the stack at the Nova Scotia Light and Power Company and the Mulgrave Park Housing Project and he asked if any action is being taken by the Staff to curtail this.

The Development Officer stated that a study is being carried out at the present time at the Mulgrave Park Housing Project to determine whether or not the present fuel can be used more economically or whether a change should be made in fuels.

## Question - Alderman O'Brien re: Flemming Park

Alderman O'Brien asked if any consideration has been given to the "rounding out of the City's holdings in the area of Fleming Park".

The City Manager stated that the matter is being processed and a report will be submitted in due course.

Alderman Moir asked if the senior members of the Staff will be returning to the center table in the Council Chamber now that adequate facilities have been provided for representatives of the Press.

His Worship the Mayor stated that the City Manager should direct those members he requires to be present at the Council meetings to sit at the center table.
