commercial - which would enable the type of light industry which is located there to expand. He asked that if the City were not prepared to approve the zoning, that it take action to expropriate the whole block.

At the meeting of City Council held February 14th, 1966, the City Manager was asked to report to the Council meeting of February 17th whether commercial facilities such as a bank, a restaurant, a pastry shop and a dry cleaning establishment would be operated within the Park Victoria Apartment building.

The original proposal submitted to the Town Planning Board on March 9th, 1964, was a request for modification of setbacks and side yards and also partial rezoning for a number of shops proposed for the ground floor of the building now known as Park Victoria Apartments. By letter dated April 6th, 1964, the applicant withdrew the portion of the application dealing with the rezoning and stated that the area which had been proposed for shopping would be occupied by auxiliary R-3 uses.

City Council approved the modifications for set backs and side yards on April 30th, 1964.

It is noted that a brochure describing Park Victoria, which is being handed to visitors and residents, contains a sentence describing a restaurant and service shops in the following words:

> "For your added convenience, there will be a restaurant and service shops on the premises for your everday needs."

The Halifax Zoning By-Law provides the following uses in R-3 zones:

Boarding House Lodging or Rooming House Apartment House Hotel Sports or Social Club Hospital (excepting hospitals for the treatment of infections diseases) Institutions (other than for correctional use or for the treatment of mental cases) Office of a medical doctor, lawyer, dentist, accountant, registered professional engineer or registered architect Office of a dispensing optician or optometrist (not including manufacturing lenses) A greenhouse, and

Uses accessory to the foregoing uses where not prohibited.

- (1) that the management of the funds be left to the Trustees of the City's Sinking Funds who will engage a competent person or persons to be the Investment Officer or Officers with power to purchase, sell and exchange securities;
- (2) that notice be given to the Eastern and Chartered Trust Company of the termination of the contract between the said Company and the City of Halifax.

that, as recommended by the Committee of the Whole:

That the City of Halifax Superannuation Plan should (1)be integrated with the Canada Pension Plan on the basis that pension benefits accruing on and after 1st January, 1966, will be at the rate of 1-1/2%, for each year of service, in respect of that part of each individual's earnings that count as "eligible earnings" for the purposes of the Canada Pension Plan, rather than the present 2% rate. However, the 2% rate will continue to apply in respect of that part of each individual's earnings over and above the Canada Pension Plan maximum (initially set at the \$5,000 per annum level). Furthermore, any pension benefits under the plan that may have accrued to any member before 1st January, 1966, will not in any way be affected by these changes.

- (2) In view of the fact that members of the police and fire departments normally retire at age 60, whereas the Canada Pension Plan pension does not commence until age 65, provision has been made for the pension accruing to these employees on and after 1st January, 1966, to be payable on the basis of the 2% formula between ages 60 and 65, but dropping to 1-1/2% level (as described above in (1) when the Canada Pension Plan becomes payable at age 65.
  - (3) Every employee is to be given the option to retire at any time within 5 years before his or her normal retirement date (subject to having completed 10 years' service with the City) and to receive an actuarially reduced pension commencing from "early retirement date". This does not in any way alter the existing rule relating to ill-health retirement.
  - (4) That the City of Halifax Superannuation Plan should be amended to include survivors' benefits similar in nature to those which are being introduced in the Canada Pension Plan, in particular:
    - (a) Widows' pensions to be calculated on the basis of 1% for each year of service prior to December 31, 1965; all service prior to 1944 based upon the 1944 salary and a benefit of three-quarters of one percent for each year of service subsequent to January 1, 1966.

This is to apply in all cases where the widow is over age 45 at the date her husband dies and in every case where a widow is disabled or has dependent children.

Any widow under age 45 at widowhood who is not disabled and does not have dependent children would be eligible to receive pension on the following basis:

of the pension as calculated in #4(a) above.

Orphans' benefits would be available to "dependent" children of married or widowed members of the plan and also to divorced members who have custody of the children of their former marriage. The definition of "dependent" children shall be that as contained in the Canada Pension Plan, namely that the child must be:

 the natural or adopted child of the member, or child in the custody and control of the member;

(ii) unmarried;

(iii) under age 18, or between 18 and 25 and continuing to go to school or university fulltime.

Disabled widowers' pensions to be based on the same calculation as widows in Section #4(a). This to be payable where the individual was deemed to be fully dependent upon his wife.

Definition of a disabled widower shall be that as defined in the Canada Pension Plan.

The five year guarantee on pension payments shall only apply to that of the benefit accrued up to 31 December, 1965; no guarantee shall apply for benefits accruing on and after January 1, 1966.

(5) For the employees with service prior to the year 1951, their pension shall be calculated on the following basis:

For the years prior to 1966, they will receive 2% for each year of service based on the average salary from 1961 to 1965 inclusive with a maximum not to exceed 60% of the 3 years from 1963 to 1965 inclusive;

For service after January 1, 1966, such members of the plan shall receive the same benefits calculated for the years 1966 and subsequent years on the same basis as the other members of the plan provided however, this basis of calculation of pension benefits for persons referred to in this section shall only be payable if the employee was a member of the Halifax Superannuation Plan and in the employ of the City on January 1, 1966.

- (6) The City is prepared to accept financial responsibility for these benefits that have been granted on the basis of existing legislation and is prepared to continue these payments; to give effect to this declaration, the City of Balifax will contribute annually a sum of money sufficient to provide for these benefits on a funded basis.
- (7) In the preparation of this legislation, and to give effect to this recommendation, the City Solicitor shall draft the legislation in a manner which would prohibit the payment of ex gratia payments to survivors of employees who were or are eligible under the Superannuation Plan.
- (8) The City Solicitor is hereby instructed to prepare draft legislation to give effect to the foregoing.
- (9) That the management of the funds of the City of Halifax Superannuation Plan be left to the Trustees of the City's Sinking Funds who will engage a competent person or persons to be the Investment Officer or Officers with power to purchase, sell and exchange securities;
  - (10) That notice be given to the Eastern and Chartered Trust Company of the termination of the contract between the said Company and the City of Halifax.

### ALTERNATIVE LEGISLATION RE: SUPERANNUATION PLAN

Alderman Trainor suggested that consideration be given to an increase in parking meter fines from \$1.00 to \$2.00 and the ticket be payable within 7-10 days, and if the fine has not been paid within that period of time, the fee would automatically go to \$4.00.

It was agreed that Alderman Trainor's suggestion be presented to the Finance and Executive Committee for consideration

Alderman Trainor also requested that the Finance and Executive Committee consider the fact that deceased residents of the County are being buried at Camp Hill and Fairview Cemeteries as well as the fact that the City is recovering less than 60% of the expenses of upkeep of the cemeteries.

The Cpty Manager stated that this matter is already under study by Staff.

Discussion ensued respecting the following items appearing in the budget -

> unfilled positions - Finance Department overtime - Finance Department purchase of electric typewriter - Wiring Inspection Division.

Alderman Matheson referred to the fact that the Council had deferred purchase of equipment including filing cabinets and that an arbitrary amount would have to be deleted from Office Furniture and Equipment for the various Departments.

Alderman O'Brien suggested a cut of 10% and requested the City Manager to determine where the cut would take place.

MOVED by Alderman Trainor, seconded by Alderman Meagher, that 50% of the amount, \$17,300, be deleted from Office Furniture and Equipment of the various Departments.

MOVED in amendment by Alderman Black, seconded by Alderman O'Brien, that the amount of the cut be fixed at 10%.

The amendment was put and lost, five voting for the same and six against it as follows:

MOVED by Alderman Richard, seconded by Alderman Abbott, that the list of revisions be approved after adding an amount of \$1,500 for the grant to the Nova Scotia Hall of Fame and deleting an amount of \$4,325 for Office Furniture and Equipment. Motion passed.

At this time, Alderman A. M. Butler submitted the following statement and calculations supporting withdrawals from the Consolidated Sinking Fund:

"In the establishment of a sinking fund to redeem a bond issue conservative calculations of earnings should be employed. Throughout, the City has followed this course.

In 1971, the last of our debt issues (those due at one time) will mature. This issue amounts to \$3,726,500.

Projecting the present resources of the sinking fund, and such that will be added in the next six years, there is now an excess of three quarters of one million dollars in the fund.

Most of this surplus is available for use by the City in its budget and should be used in view of the alliance pending between the City and its environs. Since dowries have become old-fashioned, we should make an earnest effort to avoid complicating the affair. Moreover, the taxpayers of Halifax built this surplus.

The use of the surplus in question will provide the opportunity to equalize the amount of taxes paid in 1965 with the amount to be paid in 1966, particularly in the case of residential taxes.

Taking such action we will have achieved a three-year level of taxes free of increase, throughout a period when our council-leadership was unchanged.

I suggest a business rate of 4.26 and a residential rate of 1.70 which is in proportion of 100/140 to 40/140. My view is that the residential rate should be a little below what could be expected normally, in order to offset the reassessment increase of about 31% on average, and in some cases increases well above 31%.

The following points should be considered in justification of this course:

Business enterprise absorbs its taxes from gross profits for income tax purposes;

The City undertakes a costly snow removal program from its streets, mainly for the benefit of business;

Other enterprises supported by the City confer advantage mainly to business;

The proposed "bed-tax" is being opposed actively by business, and because of this, could meet with rejection;

Residential taxes increased 60% in the six years prior to 1964. In the past eight years business rates have remained constant.

It will be time enough to consider a heavier impost on the homeowner when he is permitted to deduct most of his municipal taxes from his income tax return as an expense."

Alderman A. M. Butler suggested the following rates be determined: a Busiess Rate of \$4.26 and Residential Rate of \$1.70.

Alderman Black suggested that Council would not be wise to spend all the money in the Sinking Fund Account and said he would prefer that the tax rates be set so they will reflect an increase of 5%. He further suggested that the available money in the Sinking Fund Account be held for further use when the need would be greater.

MOVED by Alderman Black, seconded by Alderman Moir, that the residential and business rates be set at such a figure which will produce a 5% increase in taxes for the year 1966.

MOVED in amendment by Alderman A. M. Butler, seconded by Alderman LeBlanc, that the trustees of the Consolidated Sinking Funds meet and, subject to their approval of the withdrawal of a certain amount, and that such amount be entered into the revenue estimates, that the total estimates be set at an amoun which will produce a business rate of \$4.21 and a residential rate of \$1.73.

Alderman O'Brien referred to the ratio between the business and residential tax rates and suggested that Council hold the ratio as the present law requires.

Alderman Black maintained that the residential tax rate for 1967 would have to be increased to about \$1.90 according to the law.

Alderman Matheson favored the suggestion of Alderman A. <sup>M</sup>. Butler.

His Worship the Mayor suggested that the rates should be \$4.34, business and \$1.81, residential.

Alderman O'Brien suggested that a report be prepared and submitted to the Council advising of available funds in hidden accounts while the budget is being considered and finalized.

4:45 p.m. Committee adjourned for a short recess to permit a meeting of the trustees of the Consolidated Sinking Funds.

5:10 p.m. Committee reconvened with the same members being present.

In view of the standing of the Sinking Fund account and the amount of investments, the City Manager felt that it vo would be quite in order to utilize an amount which should not be more than 75% of the last known surplus of the fund. He

indicated he would agree to an amount of \$415,000.

His Worship the Mayor advised that if the sum of \$450,000 were included in the Budget as revenue, the tax rates would be \$4.21, business and \$1.73, residential, which would be equal to the amount of tax dollars which were paid in 1965.

Alderman Matheson asked for assurance from His Worship the Mayor and City Manager that this procedure is a sound practice in dealing with estimates. He also asked if they recommended this solution.

The City Mahager stated that any prudent City maintains certain reserves against the rainy day and where all reserves are depleted there is only one recourse and that is to add to the taxes of future years. When the situation is analysed with which the City is faced at the present time, certain events in connection with education for vocational schools will mean that the City will receive a capital gain in the City's capital account, In addition to this, the City is contemplating tax revenue from the Central Redevelopment Area Project. Adding up these items, it appeared to him that there is justification for the action proposed. He said he was not aware of the proposal being made by the trustees of the Sinking Fund as he had not attended an official meeting, but having looked at the Fund, he felt it was in excess of the requirements for the maturities of 1971.

MOVED by Alderman A. M. Butler, seconded by Alderman LeBlanc, that the Committee of the Whole (1) accept the recommendation of the Trustees of the Consolidated Sinking Fund to withdraw the sum of \$415,000 for inclusion in the revenue account of the Budget; (2) withdraw the sum of \$450,000 from the

Deferred Revenue Account; (3) withdraw the sum of \$50,000 from the the Prefabricated Housing Account; and (4) such amount from the Current Surplus Account which will produce a tax rate of \$1.73, residential and \$4.21, business.
