Report - Advisory Committee on Parking

This matter was considered in conjunction with Item

#12B from the Safety Committee, "Parking Hospital Area - University Avenue Boulevard".

Capital Expenditures Forecast

His Worship the Mayor referred to the brief which had been prepared entitled, "Submission of the City of Halifax to the Government of the Province of Nova Scotia", dated April 25, 1967.

The submission, as stated in the letter of transmittal to the Honorable R. L. Stanfield, P.C., Premier of
Nova Scotia, is in effect "a statement of the capital
financial forecase of the City, together with a request for
substantial assistance from the Province".

His Worship the Mayor said that subsequent to submission of the brief, a delegation composed of himself,
Aldermen A. M. Butler and Black and Staff representatives
consisting of the Acting City Manager, Acting Director of
Works and the Development Officer, met with the Premier, the
Minister of Municipal Affairs, the Deputy Minister and other
officials of the Department.

He reported that the Premier indicated that the matter would have to be carefully considered by the Government and various parts of the brief will have to be studied by the officials of the appropriate Provincial Departments.

Council, April 27, 1967 His Worship the Mayor said that following the morning meeting with the Premier, he and the Acting City Manager had met with the Minister of Municipal Affairs and the Deputy Minister of Municipal Affairs in the afternoon of the same day, and following is a report of the meeting as prepared by the Acting City Manager: "The Mayor and the Director of Finance met with the Minister of Municipal Affairs, the Deputy Minister of Municipal Affairs and a member of their staff, on April 25th, to discuss the 1967 capital budget. "After preliminary discussion, the Deputy Minister expressed his doubts as to whether the City could afford to increase its allocation of revenue for debt service charges. It was pointed out that the City felt that the increase in allocation of revenues to debt service charges from 20% to 25% over a five year period was within its financial capacity, but it was being done reluctantly because it is always prudent to avoid a maximum figure so that some margin is left for manoeuvering. "Possibly the reason for the Deputy Minister's doubts is that a number of municipalities have overextended themselves in this regard and are now asking the Province for grants for current purposes. The Deputy Minister did not foresee any problems in issuing debentures to the extent of approximately \$7 million per annum. "It seemed to be the firm intention of the Department of Municipal Affairs that the City's 1967 Capital Budget be cut because it was too high. They were told that the budget had already been considerably reduced from the initial presentation and what remained was only the bare essentials. City representatives then requested guidance in deciding what items might be eliminated but this was not forthcoming. "The Minister wanted some time to consider whether or not the capital budget should be reduced, but it was pointed out that this could cause delay on certain urgent projects. He then asked what borrowing resolutions should be approved immediately. The urgent items were therefore indicated with the result that approximately \$1.5 million of borrowing resolutions have been deferred until a final decision is made on the 1967 capital budget." - 409 -

His Worship the Mayor said that approval of the 1967 Capital Budget has not as yet been received from the Minister but that presumably approval will be received shortly of some parts of the budget so that the work can be proceeded with.

He said that it was clear that the Minister of Municipal Affairs did not want to stand in the way of action on some of the work that is important, but there was a great deal of caution expressed by the Deputy Minister of Municipal Affairs about the burdens that the City was proposing to undertake in the way of capital expenditures and debt service charges as a proportion of its current budget each year.

He stated further that if the Deputy Minister's caution was translated into a prohibition of certain parts of the current budget and were carried on into prohibition of projected spending plans in 1968 and beyond, then the shortage of capital funds as shown in our Brief of an average of \$7,500,000 per year, would be higher.

He said that Council had tried to indicate that the City was willing to do everything it could to finance the required expenditures within the kind of revenue resources available to it so that it would not be in a position of having to ask the Province for substantial assistance each year.

His Worship the Mayor said that following the session with the Provincial Government Official, he had asked the Acting City Manager to tabulate the Capital Works Projects, which have not yet begun, in a certain order so that the members

of Council can make a decision as to which should be given priority if the capital expenditures have to be reduced to five or six million dollars.

MOVED by Alderman Meagher, seconded by Alderman

Ivany that the brief dated April 25, 1967, entitled, "Submission

of the City of Halifax to the Government of the Province of

the Province of Nova Scotia", be approved. Motion passed

unanimously.

QUESTIONS

Question - Alderman Ahern Re: Closing of Rainnie Drive

Alderman Ahern asked if there is any truth in the rumour that Rainnie Drive is to be closed off.

His Worship the Mayor stated that the City is experiencing serious traffic problems at the willow Tree Intersection and the North Park - Cogswell Street Intersection and that Staff are considering possible changes in the traffic patterns affecting those intersections; and there is a possibility that one of the proposed changes will affect a portion of Rainnie Drive.

He said that a report respecting the proposed changes will be submitted to the appropriate committee and Council within the near future.

Alderman Ahern said he would disagree with any attempt to eliminate Rainnie Drive.

Question - Alderman Matheson Re: Tenders for Milk and Cream

Alderman Matheson asked if economy could be effected in the tabulation of tenders for milk and cream; and if there

is any point in calling for tenders when all the local dairies are owned by the same Company.

The City Manager said that Council could authorize Staff to accept the tenders since the prices are all set by the Board of Public Utilities.

Notice of Motion - Alderman Connolly to Rescind Motion of Council Respecting the Site for the Proposed New Home for Special Care

Alderman Connolly gave notice that at the next regular meeting of City Council to be held on May 11, 1967, he will move that the resolution approved on September 16, 1965, respecting the site for the proposed new Home for Special Care, be rescinded.

ADDED ITEM

Citadel Hill Renovations

Alderman Ivany said that when the stone wall was completed around Citadel Hill, the steps leading to the Town Clock were not completed and he said that at the present time, there is only an inadequate set of stairs leading to the clock.

He said that it is his understanding that there is a ten million dollar project of improvement being carried out over a tenyear period, and he felt that it would be appropriate if Council made inquiries to determine what plans have been made for further improvements to Citadel Hill and if they include a proper approach to the Old Town Clock.

His Worship the Mayor suggested that Staff be directed to ascertain from local officials of the Department of Northern Affairs and National Resources if the plans are available and if it is determined that they are not available locally, he will make inquiries to the Minister at Ottawa.

It was agreed to follow the suggestion of His Worship the Mayor.
