Gentlemen:

At a regular meeting of the Halifax-Dartmouth Retail Grocers Association held May 17, considerable discussion again took place about the forthcoming June 28th holiday. Those present again deplored the action of City Council in selecting this date with a second holiday, Saturday, July 1, following in the same week.

A protest was filed originally on February 16, over the signature of the then President, George Coates. (Incidentally, a reply to that letter was never received.)

We respectfully request that when future Halifax Natal Day dates are selected, that the Retail Community be consulted well in advance and that their views be given some consideration.

After discussion, it was agreed that His Worship the Mayor write a letter to the Association advising that in future years they will be notified when Council is to consider a date for Natal Day.

Holiday, July 3, 1967

Considerable discussion ensued with respect to the Dominion Day holiday on July 1 and a holiday being declared on July 3.

The City Solicitor advised that July 1 is a Statutory holiday and that before July 3, this year, can be declared such a holiday, three readings are required by Parliament.

After further discussion, it was agreed to defer this matter until the next regular meeting of City Council, when the decision of Parliament will be made known.

QUESTIONS

Question Alderman Ahern - Court House on Waterfront

Alderman Ahern asked how plans are progressing at the present time with respect to the Court House on the Waterfront site.

Alderman Black replied, as a member of the Court House Commission, and stated that there have been no meetings recently with respect to this matter, but that certain meetings have been held with the representatives of the Barristers' Society. He further stated that he would contact the Chairman of the Commission and request a meeting in the near future. Question Alderman Ahern - Low Cost Housing Brunswick & Creighton

Streets

Alderman Ahern asked how plans are progressing at the present time with respect to the proposed low cost housing on Brunswick Street and Creighton Street.

His Worship the Mayor replied that plans for the Brunswick Street development are being held up at this time pending a report from the consultants, A. D. Margison and Associates, on Harbour Drive. He stated that the project may be located farther to the east which will enable approximately 50 more units to be constructed. He informed Council that the plans for Creighton Street project are proceeding according to schedule.

Question Alderman Ahern - Trucks on Willow Street

Alderman Ahern asked if there is any way in which trucks could be prohibited from using Willow Street late at night.

His Worship the Mayor suggested that this question be referred to the Safety Committee.

Question Alderman Connolly - Parking of Cars on Vacant Land North of the Branch Library

Alderman Connolly referred to a piece of vacant land north of the Branch Library on Gottingen Street and stated that persons are driving over the curb of Gottingen Street and parking cars in this location. He suggested that this piece of land might be fenced to obviate this situation.

His Worship the Mayor stated that this land was reserved for private housing development and suggested that the question be referred to the Town Planning Board to be considered with a Staff Report on the timing of a Call for Proposals for private housing development. He further stated that since the land is in the ownership of the City, it might be surfaced and used for temporary parking perhaps with meters until such time as the Call for Proposals is advertised. He asked the Acting City Manager to look into this matter.

Question Alderman Meagher - Left-Turn on Quinn Street from Chebucto Road

Alderman Meagher asked if the citizens of Quinn Street, who requested the City to permit left turns into Quinn Street from Chebucto Road, have the right to appeal the decision of the Safety Committee.

The City Solicitor replied in the negative.

Question Alderman Matheson - Pigeon Nuisance - Oxford Street

Alderman Matheson referred to several complaints he had received from citizens about the pigeon nuisance on Oxford Street. He asked if there is anything the City could do about it.

His Worship the Mayor asked the Acting City Manager to look into this matter and ascertain whether or not the City has any responsibility.

Question Alderman Matheson - Establishment of Truck Routes

Alderman Matheson referred to a decision by the Safety Committee at its last meeting to discuss the proposed truck routes with representatives of the Truckers Associations. He asked whether or not a public hearing would be held on this matter.

His Worship the Mayor replied that there will be a public hearing on this matter when discussions have been held and certain truck routes proposed.

Question Alderman Moir - Meeting to Discuss Angular Controls and Zoning By-law

Alderman Moir suggested that sometime in the near future a meeting be called of the Committee of the Whole to discuss the whole aspect of Angular Controls and the Zoning By-law, as he felt that these regulations are prohibiting new apartment development in the City.

His Worship the Mayor stated that the tight money situation could have a bearing on the lack of apartment development.

Alderman Moir felt that this was not the case and suggested that perhaps Staff should take a look at these controls and do some research on them before the meeting is called.

Question Alderman A. M. Butler - Parking for Mental Hospital

at the last meeting of the Board of Management of the Mental Hospital with respect to parking at the Hospital for visitors and employees which might be eliminated under the lease the City has entered into with the Children's Hospital. He asked if some arrangements could be made whereby certain parking could be retained in this location.

His Worship the Mayor stated that the City might be able to negotiate a temporary basis and suggested that the City Solicitor consider this in any discussions he may have with representatives of the Children's Hospital.

Question Alderman Sullivan - Federal Owned Land Russell Street

Alderman Sullivan referred to a petition which had been submitted earlier in the meeting from residents of Russell Street, and asked if His Worship the Mayor knew the purpose for which the piece of land was bought by the Federal Government on Russell Street.

His Worship the Mayor replied that he did not know, but that it might have been purchased to permit access to C. F. B. Stadacona if Harbour Drive construction should eliminate the Barrington Street access. He suggested that the Development Officer inform Alderman Sullivan of the name of a person he might call to ascertain this information.

Question Alderman Sullivan - Aldermanic Stipend

Alderman Sullivan asked if the amount of Aldermanic Stipend increase, which he did not accept, could be given to the Halifax Association of Canadian Retarded Children.

The City Solicitor said he would look into the matter.

Question Alderman Ahern - Plans for Provincial Museum of Science

Alderman Ahern referred to the Plans for the Provincial Museum of Science and asked if they are available and whether or not any encroachment is anticipated on the Wanderers Grounds.

His Worship the Mayor replied that, to his knowledge, the Province has not requested any land from the Wanderers Grounds, and that no plans have been presented as yet, but they will have to be submitted to the City before any permits to build are granted.

Question Alderman Ivany - Housing Development Citadel Hill and City Prison Lands

Alderman Ivany referred to a statement made by Mr.

Malcolm Latham before he left the employ of the City, with
respect to housing developments below Citadel Hill on Brunswick
Street and on the City Prison Land. He asked if anything is
going to be done about these suggestions and if so, when?

His Worship the Mayor stated that the City Prison lands seem to be the only land available for any further low-cost housing projects. He asked the Acting City Manager to notify him when a Staff Report is available on this matter.

Question Alderman Ivany - Town Clock Steps

Alderman Ivany asked if anything further had been heard relating to the improvements to the steps leading to the Old Town Clock. He said the situation seems to be getting worse.

The Acting City Manager said he would take note of this question.

Question Alderman LeBlanc - Sidewalk Quinpool Road between Robie Street and Parker Street

Alderman LeBlanc referred to a question he had asked before with respect to the encroachment over the sidewalk outside the B. A. Station on the portion of Quinpool Road between Robie Street and Parker Street. He stated that he is still awaiting a reply.

The Commissioner of Works advised that a work order was issued yesterday for work to proceed in this location and any encroachments will be removed, and the whole situation corrected.

Second Council Meeting in July

His Worship the Mayor referred to the fact that some members of Council will not have returned from the Mayor's Conference in Montreal in time to be present at the meeting of City Council scheduled for July 27, 1967. He suggested that this item should be put on the Order of Business for the next meeting of City Council, to decide on a date for the second Council meeting in July.

Dr Togo. CITY COUNCIL MINUTES Council Chamber, City Hall, Halifax, N. S., June 29, 1967 8:00 p.m. A meeting of City Council was held on the above date. After the meeting was called to order, the members of Council attending, led by the City Clerk, joined in reciting the Lord's Prayer. There were present: His Worship the Mayor, Chairman; and Aldermen Abbott, Matheson, Moir, A. M. Butler, Meagher, LeBlanc, Ahern, Connolly, Doyle, Sullivan, Fitzgerald and H. W. Butler. Also present were the Acting City Manager, City Clerk, Deputy City Solicitor and other Staff members. CONGRATULATIONS TO CITY CLERK - MR. R.H. STODDARD His Worship the Mayor extended congratulations to the City Clerk, R. H. Stoddard, who since the last meeting of Council, had passed the anniversary date of his 30th year of service to the City. MINUTES Minutes of the meeting of Council held on June 15, 1967, were approved on motion of Alderman Abbott, seconded by Alderman Connolly. APPROVAL OF ORDER OF BUSINESS - ADDITIONS & DELETIONS The City Clerk requested that two items be added to the Order of Business as follows: Demolition - 2128-38-46 Barrington Street 20(a) Modification of Lot Area and Frontage - 1584 Robie Street 20(b) - 559 -

Council, June 29, 1967.

MOVED by Alderman Connolly, seconded by Alderman

Doyle that Item 20A be added to the Order of Business but that

Item 20B be referred to the Town Planning Board for consideration. Motion passed with Alderman Moir voting against.

Alderman Ahern asked that an item be added to the Order of Business respecting, "Proposed Auxiliary Police Force".

It was agreed to add the item to the Order of Business. 8:05 p.m. Alderman Black arrives.

Alderman Fitzgerald asked that an item be added to the Order of Business as follows:

"Policy Respecting Special Awards"

His Worship the Mayor asked that an item be added entitled, "Congratulations to Natal Day Committee".

It was agreed to add the itemsto the Order of Business.

The City Clerk asked that the Order of Business be amended by changing Item 16(c) to read, "Motion - Alderman Meagher" instead of "Motion - Alderman Ahern".

MOVED by Alderman H. W. Butler, seconded by Alderman Fitzgerald that the Order of Business as amended be approved. Motion passed.

DEFERRED ITEMS

Public Hearing Re: Closing Portion of James Street

His Worship the Mayor stated that the public hearing in connection with the proposed closing of James Street had been concluded at the last meeting but that a decision had been deferred pending further Staff report which has now been

received as follows:

"On April 6, 1967, the Finance and Executive Committee deferred the acquisition of the vacant land owned by Miss Margaret Meehan.

The reason this possible acquisition was deferred was because it was learned that the owner would have no right-of-way for fuel deliveries. This request was made after the owner agreed to accept \$7,500.00.

Since the Finance and Executive meeting on April 6, 1967, Staff have spent considerable time trying to accommodate the owner. The owner now requests having fuel deliveries and the parking of motor vehicles on the right-of-way.

The request to park motor vehicles cannot be granted without considerable expense to the City due to the fact that the plans for the Central Fire Department Headquarters would have to be drastically redesigned.

Staff have been constantly in touch with Mr. R. A. Kanigsberg, Q. C., Solicitor for the owner, and have offered a vacant piece of City-owned land to Miss Meehan located on the southwest corner of West and Maynard Streets. The City will also erect a fence at a cost of approximately \$150 to \$200 to protect Miss Meehan's trucks and cars. The rental would be \$25.00 per month.

Negotiations for this property are still being carried on with Miss Meehan's Solicitor. Should the City and Miss Meehan fail to reach an agreeable solution, expropriation proceedings shall be required if construction of the Fire Station is to proceed as planned."

MOVED by Alderman Moir, seconded by Alderman Black that the portion of James Street shown hatched in red on Plan No. T-7-16978 dated May 2, 1967, be closed to public use.

Aldermen Sullivan, Connolly and Ahern spoke against the proposal.

After considerable discussion, it was MOVED by Alderman Sullivan, seconded by Alderman Meagher that a representative of the Meehan Family be permitted to address Council. Motion passed.

Alderman LeBlanc felt that if a representative of the Meehan Family is to address Council, the Fire Chief should be

heard.

His Worship the Mayor asked the Fire Chief if the portion of James Street proposed to be closed is not closed, would it be necessary to re-design the Fire Department Headquarters or would the City have to seek another location.

The Fire Chief stated that if James Street were not closed, it would mean that the intended approach by way of James Street, would have to be abandoned and another five properties would have to be purchased and the Headquarters set back another thirty feet.

He said that of the three sites considered, the site selected for the Fire Station Headquarters will cause the lease inconvenience to the owners of the property.

Mr. Reginald Meehan addressed Council on behalf of the owners of the property abutting on James Street which is affected by the proposed closing and expressed objection to the closing of the portion of James Street on the grounds that it would interfere with the family trucking business which has been in operation since 1895.

He said that the use of the lot offered by the City at the corner of West and Maynard Streets would present difficulties. It would have to be patrolled during the early hours of the morning to obviate damage by vandals to the trucks which would be parked there.

The motion was passed with Aldermen Ahern, Connolly and Sullivan voting against.

A formal resolution to give effect to the foregoing motion of Council was submitted.

MOVED by Alderman Moir, seconded by Alderman Black that the resolution, as submitted, be approved.

Motion passed with Aldermen Ahern, Connolly and Sullivan voting against.

With Council permission, Alderman Black then presented to Alderman Doyle a mechanical device consisting of a miniature set of battery operated traffic lights on which Alderman Doyle could register whether or not he was for or against a particular motion or was undecided.

It was agreed to defer consideration of this item until after item 7(a) had been disposed of.

MOTION OF RESCISSION

Alderman Matheson Re: Council Resolutions - Commitments, Narrows

Bridge

had given in general terms a notice of motion to rescind any resolution of Council made containing a commitment by the City of Halifax relating to the Narrows Bridge; but he said that it was his intention only to rescind the resolution dealing with the City's financial commitment with respect to approach roads on the Halifax side of the Narrows Bridge and that it was never his intention to rescind any resolution by which the City undertook to pay the statutory portion of any deficit that might be incurred in the operation of the Narrows Bridge.

8:40 p.m. Alderman Ivany arrives.

Alderman Matheson referred to the report of the Mayor dated June 14, 1967, which had been submitted at the Council meeting held on June 15, 1967; and he said that it was now time to "wipe the slate clean and start off with a new resolution", the Bridge Commission having failed to meet the conditions set forth in the resolution passed by City Council on March 9, 1966 and the commitment made in the resolution passed by the Bridge Commission on June 8, 1966, respecting the simultaneous construction of the North West Arm Bridge with the Narrows Bridge.

MOVED by Alderman Matheson, seconded by Alderman A. M. Butler that the following resolution passed by City Council on March 9, 1966, be rescinded:

"MOVED by Alderman O'Brien, seconded by Alderman Abbott that, as recommended by the Committee of the Whole Council, His Worship the Mayor be authorized to write a letter to the Chairman of the Halifax-Dartmouth Bridge Commission stating that it was the intention of the City Council, in its resolution of December 20, 1965, to approve the items laid down in the letter from the Halifax-Dartmouth Bridge Commission dated March 10, 1965, and that the matter of the construction of the North West Arm Bridge be again emphasized. Motion passed unanimously."

Alderman Black, with the consent of Council, declined to make a motion to reconsider the resolution of Council passed on June 15, 1967, re: Bridges, notice of which he had given at the said meeting.

PUBLIC HEARINGS AND HEARINGS

Public Hearing - Rezoning #5778 South Street from R3 Zone to C2 Zone

A public hearing was held at this time in connection with an application to re-zone land on the southern side of South Street between Tower Road and Wellington Street, being civic No. 5778 South Street, from R3 Zone to C2 Zone.

The City Clerk advised that the matter had been duly advertised and that letters of objection had been received from Mr. and Mrs. Raymond McCarthy of 5784 South Street and from Margaret Brooks of 1166 Tower Road.

The Senior Planning Techician displayed a plan of the area and explained the proposal to re-zone the property to permit the use of the land as an off-street commercial parking area. Drawings Nos. P200/2230-2231 refer.

Mr. Andrew Mathews of 5784 Tower Terrace appeared and asked Council to carefully consider that the south side

of South Street is residential in character and in order to maintain it as such, Council should, if the application is approved, obtain from the applicant an agreement to guarantee that the area is kept free of abusive language, indecent exposures and litter which might spoil the appearance of the locality.

He also pointed out that this could be another mistake the City has made in spot re-zoning when the time comes for a complete redevelopment of the City.

No other person wished to be heard in connection with the proposed re-zoning.

Dr. I. K. Lubetsky, the applicant for the re-zoning, appeared and made a number of points as follows:

- (1) The area próposed to be re-zoned is one of the two areas designated as a parking area to serve the Victoria General Hospital and other institutions in the area for parking;
- (2) The land is vacant and immediately available for development as a parking lot;
- (3) The Advisory Committee on Parking pointed out to Council that there is need for off-street parking space in the area;
- (4) To obviate traffic congestion, exits could be made on right turns only going south on South Street;
- (5) The applicant is prepared to enter into a binding agreement with the City that the land will only be used for offstreet parking which will be a condition of re-sale any time in the future; and, if the use was changed, the land would automatically revert to the present zening.

Alderman Connolly asked why the applicant's letter of commitment to so use the land is not in the possession of the City at this time.

Dr. Lubetsky explained that this is due to the fact that his Solicitor, Mr. R. A. Kanigsberg, is out of town.
