The Chief Planner advised that the land in question was rezoned by Council some time ago, and when the owner applied for a building permit he was informed that he must have a subdivision approved before a building permit could be granted.

5:15 p.m. Alderman LeBlanc arrives.

Alderman Connolly felt the matter should be referred to the Town Planning Board for further study and an explanation as to who actually owns the property in question. He said

he would like to know why part of the land is up for sale.

The Chief Planner explained that the subdivision application is necessary in order for Mr. Bremner, the developer, to purchase a parcel of land from St. John's Church Corporation for the construction of a warehouse. If Mr. Bremner should wish to subdivide again, then he would have to make a further application to the Town Planning Board for permission to do so.

Aldermen Connolly, Meagher and Sullivan voted against the recommendation.

Second Airline Service into Halifax

The Town Planning Board, at its meeting held on May 7, 1969, recommends that Council ask the Industrial and Port Commission, and the Halifax Visitors and Conventions Bureau, to consider the advisability of a second airline service into Halifax, so that with advice from them, a request could be forwarded to the appropriate bodies.

Alderman Ivany thought this matter should be treated with some urgency and some immediate action taken by City Council.

MOVED by Alderman Ivany, seconded by Alderman Meagher that the following resolution be directed to the Industrial and Port Commission, and the Halifax Visitors and Conventions Bureau for consideration:

"WHEREAS Halifax City Council in session today express grave concern for the hardship being inflicted on businesses and other services due to the Air Canada strike. Despite the best efforts of other air lines business activity is being seriously affected. In 1966 the Atlantic provinces were equally affected.

WHEREAS Canada west of Montreal is serviced by alternate airline to Air Canada and CanadaEast of Montreal (New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland) is not and thus a serious obstacle to Maritime development and particularly the City of Halifax.

BE IT RESOLVED that City of Halifax urgently request that consideration be given to a permanent alternate airline into the Maritimes and particularly Halifax and that the City express its concern on the strike.

Alderman McGuire asked what would be the relationship of the Unions should a second airline service to Halifax be approved, and the Union of one airline went on strike.

His Worship the Mayor said there had been some

mention in the press of the possibility of a strike in relation to Canadian Pacific Airlines in other parts of Canada, but negotiations can be carried out to alleviate this problem.

Alderman McGuire asked if there is sufficient traffic in Halifax to warrant a second airline service, to which Alderman Ivany replied that it was his understanding that Air Canada are considering eliminating some of its feeder lines in the Maritimes from Halifax to Moncton and Fredericton, so there is a possibility of more services being required.

His Worship the Mayor referred to the fact that while the Air Canada strike is on, another airline is servicing Halifax, but he did not know whether the level of service provided by Nordair as a proportion of the total requirements is different, more or less, than the ratio of service given by Canadian Pacific in the west to the total demand in normal circumstances.

A short discussion ensued, Alderman LeBlanc was of the opinion that the City would benefit from a second airline service to Halifax, and he suggested that the Department of Transport be asked to assess whether Halifax truly needs a second air service, and to what extent they will provide assistance in obtaining a second airline.

Alderman LeBlanc suggested that the motion should be amended to include that the Transportation Committee of the Board of Trade be asked to consider the matter. He said he would like the matter to be studied in more detail and

documented evidence submitted before the motion is put.

Alderman Sullivan agreed with the remarks of Alderman Leblanc that more detailed study be made before the motion is passed.

Alderman Connolly felt the Port and Industrial Commission should be the body to study the matter.

At this time the motion was read to the Council members and in answer to a question it was agreed that the resolution should be directed to the Minister of Transport, the Hon. Donald Jamieson.

Alderman LeBlanc thought the resolution should be revised. He contended that any action taken by the City should be in conjunction with the City of Dartmouth, County of Halifax and the Maritime Provinces Board of Trade, and these bodies should be approached prior to the resolution being directed to the Minister of Transport.

MOVED in amendment by Alderman Meagher, seconded by Alderman LeBlanc that the resolution, as set out above, be forwarded to the Port and Industrial Commission, and the Transportation Committee of the Board of Trade for consideration by those bodies prior to forwarding to the Minister of Transport.

He said that if Mr. Bryant were to include the sort of accommodation the City would have in its own Home, then it would save the City approximately \$2½ million of capital funds.

Alderman McGuire asked if the Technical Advisory Committee - Home for the Elderly, has the jurisdiction to hold up a project to which the City is committed.

The City Manager replied in the affirmative. He advised that the Technical Advisory Committee is composed of members from Central Mortgage and Housing Corporation, the

The staff report states the present Rental Authority has tendered his resignation from this position largely as a result of the position taken by the Labour Council, and suggests that if City Council wishes to continue Rent Control a new appointment be made.

The City Manager advised that he was now looking for a replacement for the position of Rental Authority.

Alderman LeBlanc asked if this position had been vacated by someone who has left the establishment, to which the City Manager replied that this was not so, the person still remains a member of the staff but no longer wishes to continue the function of Rental Authority.

Alderman LeBlanc asked if this was the case, is there a salary reduction involved.

The City Manager said this was not part of the job specification when the person was hired, and was an appointment subsequent to the initial hiring. He further advised that it would probably mean that someone from outside would have to be appointed to this position, as he did not feel anyone on the present staff would be willing to undertake these duties.

Alderman LeBlanc contended that if an outside person was hired as Rental Authority it would cost the City another \$6,000 or \$7,000 a year in salary.

The City Manager agreed with the remarks of Alderman LeBlanc and said this would probably be a full time job in the future.

Alderman McGuire asked if His Worship the Mayor had replied to the letter from the Labour Council.

QUESTIONS

Question Alderman McGuire Re: New City Hall Complex

Alderman McGuire referred to discussions relating to a building consisting of a new City Hall and perhaps an Educational Building, and asked if any substantial work had been done in this regard.

The City Manager stated that there was a feeling that a Police Station might be a logical part of a new City Hall but the time factor is one of the problems. He said the City Planning staff feel that if a civic complex is to be contemplated the proper location should be sought, which would take approximately six months, and due to pressure of work it is estimated this would only commence during the Fall. The Police Station cannot be delayed and the need for having the Police Station combined with the complex is not an urgent necessity.

The City Manager also stated that meetings had been held with various Boards and Commissions to ascertain their

thoughts on the matter and some are interested in being combined with a new City Hall and others wish to be as far removed as possible.

Question Alderman LeBlanc Re: Improvements to Armdale Fire Hall

Alderman LeBlanc stated that some time ago Council approved an amount of money for improvements to the old Armdale Fire Hall. He said 95% of the improvements have been carried out but due to the exhaustion of funds, the lower floor of the Fire Hall cannot be used. He asked if the City Manager would look into the matter to see what could be done to furnish the lower floor of the Fire Hall.

The City Manager said he would investigate the matter.

Question Alderman Sullivan Re: Pockwock Project

Alderman Sullivan asked what progess has been made to date in the Pockwock Project.

His Worship the Mayor said he was unable to report anything new although he has seen an exchange of complicated correspondence between governing bodies since the last discussion in Council. He said discussions have taken place between the Federal and Provincial Governments, Cities of Halifax and Dartmouth and the Public Servic Commission, and efforts are continuing to obtain an answer from the Federal Government that they will accept sufficient responsibility to provide the funds for this project.

His Worship the Mayor continued that the Federal Government is interested in a regional solution to the water

problem and if they will provide the funds for the project, the Public Service Commission may find it preferable to going alone on the Pockwock scheme. He advised that if the Public Service Commission undertook the project alone, it would probably mean a 100% increase in the water rate, and would involve great difficulties in borrowing the funds required in the present market position. A decision on the matter is estimated to be forthcoming within two months. Question Alderman LeBlanc Re: Meeting with Aldermen

Alderman LeBlanc asked if His Worship the Mayor would consider a meeting with the Aldermen to bring them up-to-date on some of the discussions he has had in Ottawa recently, if such information is not of a confidential nature.

3. The City Council of the City of Halifax hereby certifies that the sums contained in the 1969 Current Budget and items subsequently approved by City Council for grants contained in Section 2 of this Administrative Order, which includes grants formerly made under the

Purchase of Transit Buses

A report was submitted from staff relating to the purchase of transit buses and recommending that the City purchase from General Motors Diesel Limited twenty 45-passenger diesel buses, model T6H4521, at a maximum cost of \$34,300 each, payment to be made on such basis as may be determined by the agency designated by the City to operate the transit system.

Alderman LeBlanc asked if the price of \$34,300 for each bus, still does not include the cost of tires as was mentioned at a previous Transit Committee meeting.

The representative from Kates, Peat, Marwick -Consultants, advised that the cost does not include tires as they are usually rented under a contract agreement.

Alderman LeBlanc suggested that since the City is paying such a large amount of money for the buses, an attempt should be made to get the tires at no cost to the City.

Alderman LeBlanc said he hoped that when the buses were ready for delivery, the tires would be ready at the same time if they were attained under a rental contract. Alderman Sullivan was of the opinion that further

information should be submitted on the cost of buses from other companies in order to make comparisons before he could approve the staff recommendation.

His Worship the Mayor said that further information would be available on other companies selling buses before subsequent purchases will be made, but because of the timing factor in this instance the City has no choice but to accept the General Motors buses.

MOVED by Alderman Ivany, seconded by Alderman Meagher that the City purchase from General Motors Diesel Limited twenty 45-passenger diesel buses, model T6H4521, at a maximum cost of \$34,300 each, payment to be made on such basis as may be determined by the agency designated by the City to operate the transit system.

In answer to a question from Alderman LeBlanc relating to the colour of the buses to be purchased, His Worship the Mayor advised that either City Council or the Transit Commission will be required to make a decision on colour by a certain date.

The motion was then put and passed with Alderman Sullivan voting against.

Draft Letter - Commissioner - Enquiry Under the Canada Labour (Standards) Code

A draft letter was submitted from Mr. Ray March, Executive Secretary of the Port and Industrial Commission relating to the Enquiry Under the Canada Labour (Standards) Code respecting hours of work of persons employed in vessels operating in the St. Lawrence River and the East Coast of Canada (excluding Newfoundland).

His Worship the Mayor advised that this letter is a request of the Labour Council and the Port Commission in order to resolve some misunderstanding about representations that were made to the Commissioner of the Enquiry, when he sat in Halifax, and it is requested that Council approve of the draft letter. (Copy of which is attached to the Offical Minutes).

MOVED by Alderman Meagher, seconded by Alderman LeBlanc that the draft letter, as submitted, be directed to Mr. Jacques St. Laurent, Commissioner, Enquiry Under the Canada Labour (Standards) Code. Motion passed.

Staff Morale

Alderman LeBlanc said that this particular topic concerning staff morale is of extreme magnitude, and a matter that should be discussed with the entire Council Members in attendance and the senior Department Heads, and he contended the meeting should be held at the earliest possible opportunity.

He said the recent publicity on staff morale results from a statement given by the City Manager to the press, and subsequent statements by His Worship the Mayor, City Manager and himself have opened a persistent wound which has not been healing.

Alderman LeBlanc felt that the problems staff have relate to facilities, staff, resistence, opposition and criticism must be considered on the same basis as the role of the Alderman. He said there must be a relationship between the two and a happy medium established. He felt there was a serious morale problem, and requested that

IN THE MATTER OF AN ENQUIRY PURSUANT TO THE CANADA LABOUR (STANDARDS) CODE RESPECTING HOURS OF WORK OF PERSONS EMPLOYED IN VESSELS OPERATING IN THE ST. LAWRENCE RIVER AND THE EAST COAST OF CANADA (EXCLUDING NEWFOUNDLAND).

Mr. Commissioner:

This Commission's original brief to you on this subject is dated April 8, 1969. This present document is supplementary to that original brief.

Since submission of the original brief abovementioned, it has been pointed out to this Commission that its attitude towards the Canada Labour (Standards) Code is not entirely clear.

In clarification, then, of our original submission, we would draw attention to page 3, lines 1 to 3 thereof, where it is clearly implied we, in principle, approve of the Canada Labour (Standards) Code. Further to, and in clarification of this point, we would like to go on record as supporting the implementation of the Code.

However, as noted previously, the steamship services of concern in our original brief are of considerable importance to this port, and will in all probability be terminated if increased costs of any significance are to be borne by the operators, as will inevitably result from the implementation of the Code. In furtherance of this point, one of the steamship services named in our original brief is already so marginal it requires and receives Federal Government assistance.

In these circumstances therefore, it is reasonable - considering the objectives of this Commission - that we request that, before such implementation, the Govermment of Canada should assume the responsibility for compensating the respective steamship companies so as to offset fully the incremental costs incurred as a result of implementation of the Code.

Council scrape the wound clean and heal it quickly if at all possible, by allowing all senior personnel to meet with Council with an organizational chart and relate the various jobs, responsibilities, authority, accountability at various levels, and relate or equate it to the role of the Mayor and Aldermen. He felt there was a difference of opinion between the elected officials as to what their respective roles should be, and this should be established once and for all.

Alderman LeBlanc said his concern was prompted for several reasons, one being the growing amount of dissatisfaction by the people he represents in Ward 8, with the service they are getting from City Hall. Their reasons are varied and many, and in fairness felt he must hear both sides of the story. He stated he had heard from senior staff members they are dissatisfied, and he asked that Council meet with senior Staff to assess the problem and all its ramifications so that a dialogue can be established, hoping that the end result will be a harmonious, effective, leadership type of Council with an administration that can be supported.

Alderman Meagher said he would support Alderman LeBlanc's suggestion that a meeting of Council and senior Staff be held.

It was then MOVED by Alderman Meagher, seconded by Alderman Ivany that the Chairman convene a private conference of Aldermen and senior staff members to discuss the question of staff morale, for Tuesday, May 27, 1969.
