MINUTES

Minutes of the meeting held on July 16, 1969 were approved on motion of Alderman Abbott, seconded by Alderman Ivany.

APPROVAL OF ORDER OF BUSINESS, ADDITIONS & DELETIONS

The City Clerk advised that the following two items are to be added to the Order of Business:

DEFERRED ITEMS

Report - A. D. Margison & Associates Limited Re: Alternate Proposals for the Connection of Upper Water Street to the Cogswell Street Interchange

Motion of Rescission - Alderman Abbott Re: Resolution Approved by City Council, June 19, 1969 - Grade and Line -Margison Plan - Harbour Drive - Court House to Cogswell Street Interchange

His Worship the Mayor advised that Mr. W. A. Stewart of A. D. Margison and Associates is in attendance and he

suggested that Council hear from Mr. Stewart while he explained some plates, profiles and pictures on display to members of Council.

His Worship the Mayor felt that the best course of action is to hear from Mr. Stewart and then consider the motion of Alderman Abbott.

In reply to a question from Alderman Connolly, His Worship the Mayor said that he thought the City ought to accept the kind of design which will permit the historic buildings to stay and which, in the initial period, will result in a bottleneck.

Alderman Ivany asked if Staff was satisfied with the report prepared by A. D. Margison and Associates. He said that he was disappointed in the report and found the printing and paper hard to read without a magnifying glass.

The Acting City Manager said that there had not been any discussions with Staff on this point but he had not received any adverse comments on the report.

Alderman Meagher referred to the report submitted from the Civic Advisory Committee for the Preservation of Historic Buildings containing comments on the Margison report and he asked if Mr. Paul Wendt prepared the report.

Mr. L. W. Collins, Chairman of the Civic Advisory Committee for the Preservation of Historic Buildings advised that the comments are those of Mr. Wendt plus some from the Advisory Committee.

In reply to a question from Alderman McGuire, Mr.

Stewart advised that the design speed is that within which a vehicle can safely move over the clear roadway and the operating speed is generally 10 to 15 miles per hour lower than the design speed.

For the benefit of those Aldermen who were not members of Council at the time discussions and decisions were made with respect to the Cogswell Street Interchange and Harbour Drive, Mr. Stewart reviewed the events which had taken place and the recommendations made since July, 1967.

Mr. Stewart displayed the proposals for the roadway and explained the problems that can be expected when the Cogswell Street Interchange is open. He showed a profile of the roadway indicating the grades which will give a "roller coaster" effect on the portion from the Court House site to the "throat" by the Simon's building. He pointed out that large trailers when passing through the "throat" will no doubt straddle the lanes and prohibit the use of the two 11 foot lanes. He indicated that the curb line of the two lane facility will be approximately 1'6" from the Morse's Tea building and a 5' 4" sidewalk will be provided along by the historic buildings. The light standards, he said would have to be removed and street lights affixed to the faces of the buildings. He stressed the fact that the obstruction at the "throat" will have the effect of reducing the capacity of the roadway approximately 20%. He predicted that during a rush hour period, traffic could be backed up on Water Street down to the Hotel Nova Scotian.

In reply to a question, Mr. Stewart said that pedestrians crossing Water Street would have to do so at the traffic lights which will be installed at the foot of Duke Street.

Some discussion followed with respect to parking for visitors viewing the historic buildings or for tour buses. Mr. Stewart said that some arrangement might have to be worked out for parking on the land where the fill is stockpiled, but it was not a matter that concerned him.

In reply to a question from Alderman Sullivan, Mr. Stewart said that by splitting the allowance made for side walks equally into two, making a 3' 5" side walk on both sides of the street, would not help the situation but would create unuseable sidewalks. He said that a fence would have to be erected across the 1' 6" around Morse's Tea to stop pedestrians trying to walk along as it would be dangerous. In reply to a further question, Mr. Stewart said that he did not think that trucks would pass along any other streets as there are no other streets in the area, if Barrington Street is partially made into a mall, leading to the north end of the City.

Discussion ensued on the suggestion that a Call for Proposals be issued for the restoration and re-use of the historical buildings by private enterprise and if no suitable proposal is forthcoming, the buildings then be demolished. Mr. Stewart said that there would be an increased cost if this decision is made and in "ball park" figures the additional

costs could reach \$70,000.00. He said that the contract with Dineen Construction would not be broken if the item relating to the demolition of the historic buildings is taken out.

Mr. Stewart referred to the portion of the report which reads as follows:

"Until a decision is made to extend Harbour Drive further south, the Hollis Street - Upper Water Street one-way connections will be the southerly extension of this facility. In order to provide the proper balance of traffic operations each of these routes should have a design speed of 40 mph and should have 3 lanes for moving traffic with all parking prohibited and stopping and standing prohibited in the peak traffic hours. On the basis of a three-lane pavement and traffic signals installed at all major intersections these roadways would have a practical capacity of about 600 vehicles per hour per lane (1800 vehicles per hour for three lanes). The current plan to provide only two lanes on Upper Water Street north of Duke Street reduces this capacity to about 1200 vehicles per hour. The design volumes provided by the City of Halifax for this northbound movement were 900 vehicles per hour which did not reflect the introduction of the Scotia Square Development, the Court House, the current redevelopment proposals in downtown Halifax, or the proposed Barrington Street Mall."

Mr. Stewart was asked if he had read the comments submitted by the Advisory Committee and if he had any observations on them.

His Worship the Mayor said that he thought this question unfair to Mr. Stewart as he had only just received a copy of the report.

Mr. Stewart said that he had pointed out all the implications of the scheme to members of Council, he had put forward his recommendations and now Council has to make a decision itself.

Alderman Sullivan asked if members of Staff have

any further comments to make.

The City Engineer said that there will be two moving lanes of traffic southbound on Hollis Street with an allowance made on each side for loading and unloading areas in front of some of the commercial properties. He said that there will be no restrictions on traffic stopping on Hollis Street until such action is warranted, but it will be warranted the day that the Interchange opens. He pointed out that people will not drive within l_2^L of the Morse's Tea building and will move over, thus destroying the use of the second lane along Water Street. He explained that vehicles turning right from the Court House parking lot will have the greatest difficulty since they will be in the "roller coaster" lane until they can move over. He said that some further difficulty will be encountered when the pedestrian overpass is constructed to the Court House site when a support will have to be erected in the middle of Water Street. In referring to the "roller coaster" movement of vehicles using Water Street he said that there will also be a slope to the side which will mean that drivers will have to be extremely careful when passing along the road.

After further discussion relating to a proposed North West Arm Bridge and the Narrows Bridge approaches, it was MOVED by Alderman Abbott, seconded by Alderman McGuire that the resolution approved by City Council on June 19, 1969 which reads as follows be rescinded:

"THAT the grade and line of the Margison Plan be re-affirmed from the Court House to the Cogswell Street Interchange."

Alderman Abbott spoke to his motion and said that he did not think the City could ever build highways that could move traffic freely at peak hours and he referred to the difficulties people have in leaving other cities, Detroit in particular. He said that if the historical buildings are demolished now, they will be gone for all time, but if a Call for Proposals is made and they can be retained, it will be of great benefit to the City. He referred to the number of persons who had sent in coupons from the local newspaper indicating their approval of a decision to restore the buildings, one from as far away as Chicago.

His Worship the Mayor referred to the communications received from interested persons and said that approximately 500 had been received up until a week or so ago including 50 written letters supporting the retention of the buildings. He said that to his knowledge no other issue had created that volume of mail.

Alderman Connolly expressed the view that the buildings are not worth restoring and the money could better be spent elsewhere. He said that he would not support the motion.

Alderman LeBlanc also indicated that he would not support the motion saying that he considered the retention of the buildings a luxury the City could not afford.

Alderman McGuire spoke in favour of the motion and felt that the City should try everything it can to preserve the buildings as if they are demolished, it will not have a

second chance.

Alderman Hogan said that he is against the motion and felt that a properly designed roadway should be constructed to move the traffic which will be generated by the new container piers in the south end of the City and which is very important to the economy of the City.

Alderman Allen sympathized with the Aldermen who have discussed this matter for more than two years and said that he feels that he has heard enough about it during the few months he has been on Council. He spoke in favour of Alderman Abbott's motion and said that he was surprised at the number of people who took the time to make their views on the future of the historic buildings known.

His Worship the Mayor said that Mr. L. W. Collins had indicated his desire to address Council.

MOVED by Alderman Meagher, seconded by Alderman Sullivan that Mr. Collins be heard. Motion passed with Alderman Connolly voting against.

Mr. Collins said that he would like to point out that the group of buildings were designated as being of National Historical importance by the Historic Sites and Monuments Board of Canada. He said that the Call for Proposals and consequent restoration and re-use of the buildings will be proceeded with on a business basis. He said that several expressions of interest from local business people have been received.

Alderman Ivany said that he would support the motion

of Alderman Abbott.

Alderman McGuire again spoke in favour of the motion and said that private enterprise has indicated a great deal of interest in the restoration of the buildings and he hoped that the Call for Proposals will be issued as quickly as possible.

The motion was put and passed, six voting for the same and four against it as follows:

For: Aldermen Abbott, MacKeen, Allen, Hogan, Ivany and McGuire

Against: Aldermen Connolly, LeBlanc, Meagher and Sullivan

His Worship the Mayor referred to the conclusion contained in the report submitted from the Civic Advisory Committee for the Preservation of Historic Buildings which reads as follows:

<u>Conclusion</u>: After reviewing the Evaluation mentioned above, it appeared to members of the Civic Advisory Committee that City Council would be faced with making a decision based on political rather than engineering grounds when the issue of the Historic Waterfront Buildings came before Council on July 31, 1969.

Should this decision make possible the retention of these buildings while a call for proposals is prepared, then immediate comment and consideration should be directed to details of maintenance and short-term use of buildings that by Council's decision will have become civic assets whose potential is to be explored. The Chairman of the Civic Advisory Committee is prepared to comment on these issues.

Alderman McGuire suggested that Staff prepare a report on the maintenance of the historic buildings and submit it to the next meeting of the Committee of the Whole Council.

His Worship the Mayor asked if it would be possible for City Staff to meet with Mr. Collins and prepare a report

for the next meeting of the Committee of the Whole Council. He thought that it might be too soon to expect a report by next Tuesday and suggested it be prepared for the following Committee of the Whole meeting.

Alderman Meagher asked Staff if the buildings could be rented on a short term basis.

The Supervisor of Real Estate said that in his opinion the buildings are largely unuseable in their present condition. He said that minimal use is made of a portion of the buildings. He advised that some prospective tenants have been shown through the buildings but have decided they are not suitable. He said that if the buildings are not occupied through the coming winter they will be virtually useless and will further deteriorate. He said that considerable repairs are required.

After further discussion, the Acting City Manager advised that City Staff will meet with Mr. Collins to discuss the question of maintenance of the historic buildings and will submit a report containing recommendations for repairs that are necessary and possible short-term use of the properties to the meeting of the Committee of the Whole Council to be held on August 20, 1969.

REPORT - FINANCE AND EXECUTIVE COMMITTEE

Council considered the report of the Finance and Executive Committee from its meeting held on July 22, 1969 with respect to the following matters:-

Incorporation of a Housing Development Company

MOVED by Alderman Abbott, seconded by Alderman Ivany that, as recommended by the Finance and Executive Committee:

- Approval in principle be given to incorporation by the City of a housing development company, under Section 405(b) of the City Charter, for the purpose of filling the need for housing for families whose incomes are insufficient for them to afford housing provided by the private market; and
- A Committee be appointed by the Chair to prepare terms of reference for the housing development company, and report back to Council.

Alderman Meagher asked His Worship the Mayor to have a conference with members of Council to discuss the appointments to the committee to prepare terms of reference for such housing development company.

His Worship the Mayor said that he would do as Council wished.

The motion was then put and passed with Alderman McGuire voting against.

Heating Tunnels Encroachment - Dalhousie University

The report of the Committee reads as follows:

"It is recommended that approval be given to the encroachments of heating tunnels from a heating plant to be erected on Seymour Street and University Avenue, for a license fee of \$25.00 and annual rental fees based on \$0.25 per square foot, in accordance with Ordinance No. 112."

His Worship the Mayor said that he had received a call from the President of Dalhousie University regarding the annual fee which will be payable for the encroachments. He said that he understood the square footage is larger than was originally anticipated.

Staff advised that the area is 16,884 square feet which would mean an annual fee of \$4,221.00.

After a short discussion, it was MOVED by Alderman Meagher, seconded by Alderman Allen that the matter be referred back to the Committee of the Whole Council and that the President of Dalhousie University be asked to attend the meeting. Motion passed.

Claim - Bruce Froom

MOVED by Alderman Abbott, seconded by Alderman Hogan that, as recommended by the Finance and Executive Committee, approval be given for the payment by the City of \$27.14, representing 50% of Mr. Froom's total damages in the amount of \$54.28. Motion passed.

Question - Alderman Abbott her Start of Construction -Workmen's Compensation Switching, South End of the City Alderman Abboth asked when construction of the above building would be started to which Alderman Depy replied that the contractor advised his that he is working on the drawings and a tender call would be made later.

QUESTIONS

Question - Alderman Hogan Re: Visit of the"S.S. Manhattan"

Alderman Hogan asked if His Worship had received a reply to his letter written to Mr. Michael Wright, Chairman of the Board of Humble Oil Company relating to an invitation to have the "S.S. Manhattan" in the Port of Halifax during her trip to the Arctic, this month.

His Worship the Mayor replied in the affirmative and stated that the ship would be in the Harbour on or about August 15th. He advised he would contact the members of Council in this connection.

Question - Alderman Hogan Re: Traffic, Bedford Highway

Alderman Hogan asked the Traffic Engineer what study he or his Department has made with respect to the problem of getting the traffic out of the City on the Bedford Highway; what the solution he has for same. He requested the answer in writing.

Question - Alderman Hogan Re: Capital Budget Expenditures -New Area of the City

Alderman Hogan asked if the \$1,500,000.00 included in the capital budget for the annexed areas has been spent and if not, why not, and how it is to be spent. He requested the answer in writing.

Question - Alderman Abbott Re: Start of Construction -Workmen's Compensation Building, South End of the City

Alderman Abbott asked when construction of the above building would be started to which Alderman Ivany replied that the contractor advised him that he is working on the drawings and a tender call would be made later.

Alderman Abbott pointed out that property owners in

He requested that some consideration be given to this matter because of the security of persons using these walkways, especially at night when difficulties have been experienced. Question - Alderman Allen Re: Traffic Experiment -Armdale Rotary

Alderman Allen asked if staff has prepared a report relating to the traffic experiment at the Armdale Rotary to which the Acting City Manager replied that the report will be considered at the Committee meeting to be held on August 5, 1969. Question - Alderman Meagher Re: Policy - Citizens Sitting on the Grass - Public Gardens

Alderman Meagher asked what the City policy is with respect to citizens sitting on the grass in the Public Gardens to which His Worship the Mayor replied that the policy over the years has been, as he understood it, that there is one section at the southwest corner, a playground area, on which children are encouraged to play but for the rest of the grass area, people are encouraged to refrain from trespassing. He believed that there

has been some revision of the policy concerning this matter but could not give the details.

Question - Alderman Meagher Re: Crosswalk - Chebucto Road and Elm Street

Alderman Meagher referred to the policy of painting crosswalks on arterial streets and requested that action be taken to provide a crosswalk at the above location because of the heavy traffic using Chebucto Road.

The matter was referred to the Acting City Manager for processing.

Question - Alderman Abbott Re: Half-way House

Alderman Abbott asked if any criticisms or complaints had been received with respect to the operation of the Half-way House. He referred to a letter in the Mail-Star under the "Voice of the People" signed by four ladies who were very much in favor of the House and he said they were to be congratulated for taking such a stand.

His Worship the Mayor said that he had received comments which supported the operation and none supported the objections raised.

The Supervisor of Real Estate advised that there have been no problems of any description.

Question - Alderman MacKeen Re: Eviction of Families

Alderman MacKeen referred to the pending eviction of the family on Lawrence Street and asked if the appropriate staff is aware of this matter and he requested that something be done for the family if it is possible.

His Worship the Mayor pointed out that City staff does not have housing resources to allocate to such families and that Council has never made a policy decision that it would

He advised that meetings had been held and there are several matters which bear upon it. He suggested that a solution be accepted by Council as soon as possible.
