## Sale of City Property - 3297 Prescott Street

Alderman Downey spoke to the item saying that it was his understanding that 3297 Prescott Street was purchased by the City to accommodate Mr. Carvery, but he now believes that the property was purchased to widen the expansion of the Murray MacKay Bridge approaches on Robie Street.

Alderman Downey asked for a report on the matter. He also asked how much the City paid the bridge commission; and how much Mr. Carvery was paid; and Why Mr. Carvery was not able to purchase the property and receive a deed for it.

After further discussion and a brief explanation from Mr. Churchill, it was MOVED by Alderman Downey, seconded by Alderman Sullivan that the matter be deferred. Motion passed.

## Possible Acquisition - 11 Pinegrove Drive

## Amendment to Quinpool Road Agreement

A staff report dated August 10, 1977 was submitted.

MOVED by Alderman Stanbury, seconded by Alderman Walker that His Worship the Mayor and the City Clerk be authorized to sign the Amending Agreement attached to the staff report dated August 10, 1977 entitled "Amendment to the Quinpool Road Agreement", so that it may form part of the original development agreement. <u>Motion passed</u> with Aldermen Shannon and Meagher voting against.

Modification of the Zoning Bylaw for a Proposed Duplex at 192 Herring Cove Road

A supplementary staff report dated August 10, 1977 was submitted.

MOVED by Alderman Walker, seconded by Alderman Connolly that City Council approve a modification of the lot area requirements of the Zoning Bylaw to allow construction of a duplex located at 192 Herring Cove Road, Halifax, Nova Scotia.

Alderman Connolly requested that staff have further conversations with the individual in respect of what the City will pay by way of compensation for land it is acquiring and try and arrive at some agreement on the rear land when and if it becomes available.

#### Motion passed.

Application to Rezone Lot C, Cook Avenue from R-1, Single Family Dwelling, and P & I, Park and Institutional, to R-3, Multiple-Family Dwelling Zone, and an Application to Subdivide, and an Application for Lot Consolidation, Cook Avenue (Westmore Senior Citizen Complex) - DATE FOR PUBLIC HEARING

#### Day Nurseries - DATE FOR PUBLIC HEARING

MOVED by Alderman Connolly, seconded by Alderman Sullivan that, as recommended by the City Planning Committee, a date be set for a public hearing to amend the Peninsula and Mainland Zoning By-laws in the following ways:

- (a) Amend the Peninsula and Mainland By-laws to create a day nursery zone designation, defined as a "D" zone to include (i) a requirement that the "D" zone designation is to be added to the use zone designation of any property for which a day nursery is proposed to be operated and (ii) a schedule of provisions for the "D" zone as identified in Table 1 of the said staff report dated July 27, 1977.
- (b) Amend Part II, Section 8(6) of the Peninsula By-law and Section 11B (2) of the Mainland By-law to require one parking space for every 600 square feet of building space used for day nursery purposes for use by the employees of such day nursery.
- (c) Amend Part 2(0) of the Mainland By-law, and Part I of the Peninsula By-law, respectively, to delete the definition of "day nursery" and substitute therein the definition outlined in the staff report dated July 27, 1977.

Motion passed.

The City Clerk advised that the public hearing re the proposed amendments to the Zoning Bylaws is scheduled to be held on Wednesday, September 21, 1977, at 8:00 p.m. in the Council Chamber.

MOVED by Alderman Walker, seconded by Alderman Lawrence that Ordinance No. 133 respecting "The Emergency Measures Civil Defence Organization", as amended, be now read and passed a First Time. Motion passed.

Motion - Alderman Meagher Re: Amendments to Ordinance No. 167 Respecting "Tax Exemptions for Property Used for Charitable Purposes" - FIRST READING

This item was deleted from the Order of Business.

Motion - Alderman Meagher Re: Introduction of Ordinance No. 170 Under Section 25A of Assessment Act - FIRST READING

MOVED by Alderman Meagher, seconded by Alderman Connolly that Ordinance No. 170 Respecting Partial Tax Exemptions for Certain Properties, as submitted, be now read and passed a First Time. Motion passed.

Alderman Meagher advised that at a subsequent meeting of City Council he will amend the said proposed Ordinance to include a list of names.

#### MISCELLANEOUS BUSINESS

## Retirement Committee Request

A report dated August 3, 1977 was submitted.

Alderman Sullivan stated that the voting rights referred to in the report concerns specifically the number of votes of the union membership on the Committee as opposed to the management representation on the Committee, which appears to present a problem from the union membership point of view and it was at their request that the matter be referred to Council for discussion with the Retirement Committee.

It was agreed that the matter be referred to a meeting of Committee of the Whole Council to be held on September 7, 1977.

#### Consolidated Financial Statements, December 31, 1976

The above statements were circulated to members of City Council.

MOVED by Alderman Sullivan, seconded by Alderman Connolly that the financial statements, together with the Auditor's Report for the fiscal period ended December 31, 1976, be now laid on the table and an early meeting with the City's auditors for the fiscal period under review be arranged. Motion passed.

#### QUESTIONS

#### Question Alderman Lawrence Re: Melody Drive Parking

Alderman Lawrence stated that an overflow of parking from Mount St. Vincent is using Melody Drive. He stated that it is his understanding that there is parking on one side only on a portion of Melody Drive and requested that staff review the situation and attempt to resolve the matter.

## Question Alderman Lawrence Re: Meadowlark Crescent Petition

Alderman Lawrence stated that a petition was submitted about a month ago from the Meadowlark Crescent residents and asked what the status of the matter is. The City Manager advised that the matter will be discussed at the next regular meeting of Committee of the Whole Council.

Alderman Lawrence stated that he has found out that the barrier at the end of Meadowlark Crescent is the responsibility of the Public Service Commission and asked if the City's representatives at the next Public Service Commission meeting would request that the barrier be in place at all times as trucks are using it as a thoroughfare to get to and from Dunbrack Street.

## Question Alderman Lawrence Re: Cutting of Grass on Properties Abutting Sidewalks in the City

Alderman Lawrence asked whose responsibility it is to cut grass on properties abutting City sidewalks, noting that it is not being cut near the Bicentennial Highway sidewalk, on abutting properties going down Kearney Lake Road and near the overpass on Kempt Road near the Westinghouse building. He asked why the ordinance is not being enforced.

### Question Alderman Stanbury Re: Roller Skating at Forum

Alderman Stanbury asked why the roller skating program at the Civic Arena is being terminated.

Question Alderman Connolly Re: Cut on South Street for New Sports Complex

Alderman Connolly stated that he has been advised that the cut in the street is no longer required and requested that staff pave the cut as quickly as possible.

## Question Alderman Meagher Re: Use of Old Studley Field

Alderman Meagher stated that there are rumours circulating that the old Studley Field is to be used as a parking lot. Alderman Connolly advised that the field is now being resodded.

## Question Alderman Connolly Re: Dynamiting Re Sports Complex

Alderman Connolly requested that it be brought to the attention of the residents of the area that all blasting is to cease this week and claims can be submitted. His Worship advised that staff will inquire re the blasting permit and arrangements will be made with Dalhousie University to find out from the contractor whether in fact they have completed all of the blasting required for the sub-structure.

Question Alderman Connolly Re: Sodding of Boulevarded Section of Cogswell Street

Alderman Connolly stated that he personally felt that the sodding on the boulevarded section of Cogswell Street was disgraceful, giving as an example of what should take place the sodding being done on Inglis Street.

His Worship advised that the median strip on Cogswell Street was resodded last week.

Question Alderman Connolly Re: Massage Parlours and Advertising

Alderman Connolly suggested that the Safety

Committee might deal with the matter of massage parlours and advertising for same. He stated that he has received correspondence indicating that residents are quite concerned about some of the massage parlour operations and the advertising being circulated for same. He suggested that the Police Department might wish to investigate to determine whether such establishments are operating within the law. His Worship advised that the Police Department is presently in receipt of three requests for investigation of such advertisements and charges have been laid in one instance.

## Question Alderman Sullivan Re: Sewer on Sullivan Street

Alderman Sullivan advised that residents on Sullivan Street have been complaining about an odour emanating from the sewer on Sullivan Street and, upon investigation by City Field staff, it has been determined that the odour is being caused by by-products coming from Olands Brewery. He stated that staff are endeavouring to have the Brewery treat the by-product with chemicals before it enters the sewer system. Alderman Sullivan asked that staff submit a report on the matter and try to ensure that the by-product is chemically treated before it enters the sewer system.

Mr. Wm. Sullivan, Engineering and Works Dept., advised that staff are working on the matter at this time.

Question Alderman Sullivan Re: Planning Department Report Re: Gottingen, Young, Robie and North Streets

Alderman Sullivan stated that this matter was raised by him several months ago and asked when the report will be submitted. Mr. Matthews, Director of Planning, advised that the report will be submitted to the Committee of the Whole Council to be held on September 7, 1977.

Question Alderman Sullivan Re: 'No Parking - Street Cleaning' signs - Fern Street

Alderman Sullivan stated that several weeks ago

he requested that 'no parking - street cleaning' signs be erected on Fern Street and asked when the signs will be in place.

Mr. Sullivan, Engineering and Works Department, advised that there has been some delay but the signs will be installed shortly.

Alderman Sullivan asked that he be advised of an approximate date.

## Question Alderman Sullivan Re: Availability of Staff on Weekends for Emergency Requests

Alderman Sullivan stated that on occasion he has had to contact staff in emergency situations that developed during the weekend period and there is some difficulty contacting staff who are authorized to make decisions. He asked if consideration has ever been given to having staff on call during weekends who can deal with emergency requests of aldermen.

His Worship advised that in matters of social response the Social Planner has issued a year ago a list of staff who should be contacted. The City Manager advised that the list will be updated and re-circulated.

Alderman Sullivan asked that the suggestion of having staff on call be considered to see if there is any merit in it.

Question Alderman Shannon Re: Installation of a Crosswalk on Spring Garden Road at Carleton Street

Alderman Shannon stated that a large number of senior citizens who are residents of the area use the bus stop at Spring Garden Road and Carleton Street and are experiencing some difficulty crossing the street at that location.

Alderman Connolly stated that several weeks ago he had such a request and, as a result, contacted staff.

He stated that a traffic count has been carried out and staff are proposing the sidewalk be installed on the east side of Carleton Street and the work will take place in the very near future.

Question Alderman Shannon Re: Policy of the National Harbours Board re Leasing of Their Waterfront Lots

Alderman Shannon requested that staff submit a report on the policy of the National Harbours Board in relation to how they lease their waterfront lots.

Question Alderman Meagher Re: Facilities at Central Playground

Alderman Meagher asked if the facilities at the Central Playground will be opened up this year or if they are closed for the rest of the season.

His Worship advised that a recent staff report indicated that major repairs are required at the Central Playrgound and staff ascertained that they could not complete same during the summer and there would have been the added inconvenience of construction equipment on the playground. He advised the workhas been deferred until September.

Question Alderman Meagher Re: Dumping of Garbage on Saturday

Alderman Meagher advised that he had received a telephone call from a small trucker who removes waste products from grocery stores, etc. who is not permitted to dump on the site on Saturday. This individual is of the understanding that the operator of an identical, but larger, business is continuing to dump on the site on Saturday. Alderman Meagher stated that he would advise the names of the parties concerned and asked that the matter be investigated.

Question Alderman Walker Re: Disposition of Captain Wm. Spry Property

Alderman Walker asked that staff submit a report on the disposition of the Captain William Spry property and whether there is any possibility that a Senior Citizens' complex might be built on the site.

Question Alderman Walker Re: Appeal re the Refusal to Issue A Building Permit

Alderman Walker advised that he had been asked whether a private citizen may appeal the refusal of the Building Inspector to issue a building permit and, if so, what procedure is involved. He requested that a written reply be submitted.

Question Alderman Walker Re: Development of the North West Arm Drive from the Old Sambro Road to the Purcell's Cove Road

Alderman Walker requested that staff press the Provincial Government for some understanding as to the further development of the North West Arm Drive from the Old Sambro Road to the Purcell's Cove Road.

His Worship reviewed information released publicly this week.

Question Alderman Downey Re: Confidential Letter from Deputy Chief of the Fire Department

Alderman Downey referred to a confidential letter received by members of City Council from the Deputy Fire Chief and asked if it has been removed. His Worship advised that what is being done has not been completed.

Question Alderman Downey Re: Removal of Vehicle on City-Owned Property at 2421 Creighton Street

Alderman Downey stated that about two months ago he asked about a vehicle on city-owned property at 2421 Creighton Street which is still there. He asked that staff

take appropriate action to have the vehicle removed.

#### ADDED ITEMS

Local 108 Negotiations

A staff report dated August 11, 1977 was submitted.

MOVED by Alderman Lawrence, seconded by Alderman Stanbury that the Mayor and City Clerk be authorized to sign a collective agreement between the City and Local 108, C.U.P.E. incorporating all matters negotiated and proposed by the Industrial Inquiry Commissioner.

Alderman Connolly stated that, in view of the anti-inflation guidelines and negotiations being carried on with other unions as well as contracts which have been settled on the basis of the said guidelines, he could not support the recommendation of the Industrial Inquiry Commissioner.

Alderman Lawrence stated that he felt Council has a duty to the taxpayer and he felt the alternative to accepting the recommendation of the Industrial Inquiry Commission would be the commencement of a curtailment of services in the City of Halifax.

Alderman Sullivan stated that he supports the motion because the alternative would probably be a work stoppage which would go on for a long time and which would have severe consequences for the taxpayers of the City.

Alderman Stanbury stated that she supports the motion as she can understand the request of the union members and until the Federal Government make it illegal for essential services workers to strike, those at the municipal level must protect the people.

Deputy Mayor Moore pointed out that the last negotiations with Local Union 108 resulted in the City approving a wage increase of 39.4%, which was the socalled 'catch-up' contract. He stated that in view of the anti-inflation guidelines, he cannot support a contract

that would give Local Union 108 a benefit that is not in keeping with the stringent negotiating terms that have been applied to other contract negotiations.

Alderman Hanson stated that he felt the wage settlement in this instance is an indication of hard negotiation resulting in a settlement and it is proper at this time to approve the agreement in view of the possible consequences of rejecting it.

The <u>motion was put and passed</u> with Aldermen Connolly, Shannon, Walker and Deputy Mayor Moore voting against.

## Building Sewer Renewals

Alderman Shannon expressed disappointment with a recent information report re the above subject and stated that her intention when requesting a report from staff was that a recommendation be submitted for some action to be taken in regard to the matter.

MOVED by Alderman Shannon, seconded by Alderman Meagher, that the appropriate sections of the Halifax City Charter be reviewed with a view to having them amended so that, particularly in relation to the tree roots of City owned trees on City-owned property that enter other peoples' sewer lines become a matter for the City to repair and take charge of.

Alderman Connolly suggested that the problem could be resolved in most cases if the legislation for the mainland and peninsula areas of the City was identical.

#### Motion passed.

His Worship called the meeting to order and introduced Mr. J. Tofflemire, Traffic Management Board, and asked that he review the report of the Traffic Management Board and explain the proposals to those present.

Mr. Tofflemire advised that the three basic conclusions of the study are:

1. Reversible Lanes, Quinpool Road at Connaught Avenue;

 Semi-actuated Control, Quinpool Road at Preston and Vernon Streets;

3. Optically-Programmed Signals, The Willow Tree.

## #1 - Reversible Lanes, Quinpool Road at Connaught Avenue

Mr. Tofflemire, with the aid of a sketch, explained the proposal as outlined in the report and stated that the primary reason for the proposal is to remove the through traffic which presently uses residential streets in the morning peak hours. He stated that one reason for a two-month trial period is to bring out and resolve potential

problems and provide answers for questions which may arise re the actual operation of reversible lanes.

In response to a question re including reversible lanes as far as Oxford Street, Mr. Tofflemire stated that this is the alternative plan available, but staff would prefer, for a number of reasons, that the present one be considered as a trial one.

In response to a question whether there would be benefits or otherwise in implementing the proposal commencing at the Rotary, Mr. Tofflemire stated that the main reason for not doing so is due to the horizontal and vertical alignment of Quinpool Road beyond MacDonald Street. He stated a further reason is that the extra capacity in that section of Quinpool Road is not warranted at the present time.

In response to a question whether staff considered extending reversible lanes to the Willow Tree, Mr. Tofflemire stated that at the present time the problems associated with such a proposal are not known and solutions to such problems will have to be found. He stated that many questions need to be answered before a very large scale demonstration or implementation of reversing lanes should be undertaken.

In response to a question whether consideration has been given to adding time barriers on residential streets, Mr. Tofflemire stated that there would be an enforcement problem if a stop sign is erected for that purpose only.

It was noted by a resident of Jubilee Road that there is an increase in traffic in the area and he suggested that a stop sign be erected on Jubilee Road, either at Chestnut, Walnut or Vernon Streets, and further suggested that it might be a four-way stop sign, in order to break up the straight run.

In response to a question re reducing speed limits on residential streets, it was pointed out that such suggested restrictions of twenty m.p.h cannot be enforced.

In response to a question re the present status of exclusive transit lanes, Mr. Tofflemire stated that the whole

concept of 'traffic management' is to get as much as possible, in terms of people movement, out of the transportation system. He felt the proposals in the report are in agreement with that philosophy. He stated that another component is to keep the cost in terms of dollars to the City, both capital and operating, at an absolute minimum. He suggested that exclusive transit lanes are not being advanced at the present time due to the cost involved and further suggested that exclusive bus lanes are more properly transit planning aspects.

## #2 - Semi-actuated Control, Quinpool Road at Preston and Vernon Streets

Mr. Tofflemire, with the aid of a sketch, explained the above-noted proposal and its effects on traffic in the area. He stated that more cars will be encouraged to use Vernon Street if cars getting out of Vernon Street are facilitated. Mr. Tofflemire then responded to questions from members of the audience.

## #3 - Optically-Programmed Signals, The Willow Tree

Mr. Tofflemire, with the aid of a sketch, stated that when on Quinpool Road, traffic can either proceed towards Cogswell Street or Bell Road. He stated that at the present time when Bell Road has the green signal, all other traffic is halted. He advised that staff are proposing that both lanes move towards Cogswell Street but only the centre lane may go to Bell Road, that is, to designate the centre lane only for Bell Road and the left lane for Cogswell Street. He stated that the only physical requirement to implement the proposal is an overhead sign to make sure that drivers are in their appropriate lanes.

In response to a question whether the same sort of installation presently at Duffus and Gottingen Streets intersection had been considered, Mr. Tofflemire stated that the sign is the most expensive part of the project and it would be needed in any case. He further stated that it has been suggested that the bus stop in the area be moved back a couple of hundred feet to allow extra space for the merging of traffic but he did not anticipate a major problem in this regard.

Mr. Tofflemire stated that it is proposed for the duration of the trial period to temporarily extend the median on Jubilee Road at Connaught Avenue so that traffic coming out on Jubilee Road will only be able to .urn right on to Connaught Avenue and there would be no through movement on to Jubilee Road. He further stated that there is the possibility of the installation of traffic signals at the intersection. Mr. Tofflemire responded to questions from those present.

After some discussion re various aspects of the three proposals, His Worship stated that it is likely that the matter will be considered by Committee of the Whole Council on September 7, 1977 and might thereafter be considered by City Council on September 15, 1977.

Meeting adjourned - 10:30 p.m.

Mr. Nickerson said they feel the rezoning will reduce the value of their properties and went on to suggest that it would be difficult to sell land zoned R-2 located between the motel and the C-2 property in the area.

A short questioning of Mr. Nickerson and staff ensued on the matter.

No further persons expressed a desire to speak against the proposed rezoning and the Chairman declared the matter to be before Council.

MOVED by Alderman Connolly, seconded by Alderman Stanbury that the matter be referred to the next regular meeting of City Council scheduled for September 15,1977 without recommendation. Motion passed.

City Council, at its meeting held on August 11, 1977, deferred decision with respect to the above noted rezoning.

A supplementary staff report dated August 25, 1977, was submitted.

The City Clerk advised that Alderman Hanson was not present at the public hearing held on August 4, 1977.

Appeal of the Development Officer's Decision to Approve a Minor Variance of the Rear Yard Requirement at 2891 Connaught Avenue

A staff report dated August 19, 1977, was submitted.

Mr. Boyd Algee of the Development Department addressed Council and explained the item and responded to guestions put forth by members of Council.

Mr. C. Hutt of 6576 London Street, the appellant, addressed Council saying he did not wish to stop the development but expressed concern about there being windows in the proposed extension facing his property as well as with respect to a large truck being parked in the applicant's driveway which blocks his view.

Mr. Algee advised that the applicant has assured staff there would be no windows in the proposed extension facing Mr. Hutt's property and also suggested that the extension would not interfere with light at the neighbouring property.

Mr. C. Kelly, the applicant, addressed Council and advised that the truck was parked in the driveway for the protection of the children in the neighbourhood. He felt it presented a dangerous situation by parking the truck on the street.

In reply to a question, Mr. Kelly advised that the truck would not be parked in the driveway any more than three hours per day and it is not left there overnight. Mr. Hutt advised that he could park the vehicle on the street but said it was for the protection of the children in the area that he used the driveway.

Following a further short discussion, <u>it was MOVED</u> by Alderman Stanbury, seconded by Alderman Sullivan that the appeal against the Development Officer's decision to approve a Minor Variance of the rear yard requirement at 2891 Connaught Avenue, be denied by City Council.

## Petition - Traffic Study - Residents of Harvey, Church, and Morris Streets

#### Tree Spraying Brief

The above noted item was forwarded to City Council without recommendation.

MOVED by Alderman Shannon, seconded by Alderman Stanbury that the City not undertake further wide spread spraying of City trees but that the trees be checked for heavy infestation and any trees found to be infested, be treated on an individual basis.

Alderman Shannon also suggested the City could arrange for a public information program by advising of a telephone number which people could call when they discovered trees which appeared to be infested.

It was noted that the City is awaiting reports from the other levels of government with respect to the safety features of the chemicals being used as well as a report from the Childrens' Hospital.

MOVED by Alderman Shannon, seconded by Alderman Connolly that Halifax City Council go on record as approving the principle of Regional Transit as set forth in the MAPC Proposed Regional Transportation System report of June 1977, and indicate its willingness to approve a Bylaw empowering the Regional Authority to accept its municipal responsibilities for Regional Transit subject to the City of Dartmouth and the Municipality of the County of Halifax passing similar Bylaws. Motion passed.

## Investigation of Boarding Homes

MOVED by Alderman Connolly, seconded by Alderman Sullivan that Halifax City Council strike a Task Force or Special Committee to deal with the matter of Investigation of Boarding Homes.

Alderman Stanbury expressed her disagreement with the foregoing motion stating that she felt the investigation of boarding homes infringes upon certain rights of individuals.

Alderman Shannon stated that when she initiated the matter her intent was to look at the licensing of rooming houses for two reasons, one, many of such dwellings are not inspected by the City under the minimum standards bylaw, and secondly, very often people who reside in boarding homes are people who don't usually complain and are paying premium prices for often indifferent accommodations. She further stated that secondary reasons were that there be a licensing fee to cover costs of services provided by the City, that an inspection take place under the minimum standards bylaw before the license is issued, and to find where illegal rooming houses are being operated in the City.

After some discussion, the motion was put and passed with Alderman Stanbury voting against.

#### REPORT - CITY PLANNING COMMITTEE

Council considered the report of the City Planning Committee from its meeting held on August 17, 1977, as follows:

Consolidation of Lots 2, 3, 4, 5, and 6 to form Lot 4A (Civic Nos. 1147-1157) Tower Road

MOVED by Alderman Shannon, seconded by Alderman Downey, that approval of consolidation of lots 2, 3, 4, 5, and 6 to form Lot 4A (Civic Nos. 1147-1157) Tower Road be deferred until such time as Council reviews the demolition and building permits.

The motion was put and lost with Deputy Mayor Moore, Aldermen Connolly, Hanson, Stanbury, Walker, and Lawrence voting against.

MOVED by Alderman Lawrence, seconded by Deputy Mayor Moore that, as recommended by the City Planning Committee, the application to consolidate Lots 2, 3, 4, 5, and 6 to create Lot 4A (Civic No. 1147-1157) Tower Road as shown on Plan No. P200/7961 of Case No. 3435, be approved by City Council. Motion passed with Aldermen Shannon, Downey and Sullivan voting against.

Subdivision and Lot Consolidation - Civic Nos. 3065 and 3095 Olivet Street

MOVED by Alderman Lawrence, seconded by Alderman Hanson that, as recommended by the City Planning Committee, the application to resubdivide land at 3065 Olivet Street, and consolidate lands at 3095 Olivet Street, thereby creating Lot AR containing 64,694 sq. ft. and Lot BR1 containing 32,948 sq. ft., to accommodate a 106-unit addition at 3095 Olivet Street, be approved by City Council. Motion passed.

## Lot Consolidation - 5737 McCully Street

MOVED by Alderman Stanbury, seconded by Alderman Walker that, as recommended by the City Planning Committee, the application to consolidate Lots A and B to create Lot AB, lands of the Nova Scotia Society for the Prevention of Cruelty, McCully Street, be approved by City Council. Motion passed.

## Review of the Planning Act - DATE FOR MEETING

It was agreed that a special meeting of the Committee of the Whole Council be held to deal with the matter of a review of the Planning Act.

His Worship advised that the meeting is scheduled to be held on Friday, September 23, 1977 at 2:00 p.m. in the Council Chamber.

Modification of the Zoning Bylaw to Allow Conversion to a Duplex at 1466 Carlton Street

His Worship called for those persons present who wished to address Council re the matter. No persons present wished to address Council.

MOVED by Alderman Shannon, seconded by Alderman Connolly that City Council approve the application for modification of the Zoning Bylaw requirements to allow the conversion of a single-family dwelling to a duplex at 1466 Carlton Street. Motion passed.

Final Approval - Lot A, St. Margaret's Bay Road and Tentative Approval - Lot B, Crown Drive

MOVED by Alderman Hanson, seconded by Alderman Walker that, as recommended by the City Planning Committee, City Council grant final approval to Lot A, St. Margaret's Bay Road, and tentative approval to Lot B, Crown Drive, as shown on Plan No. P200/8021 of Case No. 3462. <u>Motion</u> passed.

Tentative Approval of Fairmount Master Plan and Final Approval of Lots 146 and 149-168 Inclusive Brook Street, Samuel Terrace and Downs Avenue

MOVED by Deputy Mayor Moore, seconded by Alderman Hanson that, as recommended by the City Planning Committee,

- Halifax City Council grant final approval to Lots 146 and 149-156 inclusive and 159-168 inclusive of Phase I and as shown on Plan No. P200/8093;
- Halifax City Council accept the 1.1 acres of land (approximately) adjacent to the school site as public open space but not to compromise the City's desire for additional open space allocation;
- The Mayor and City Clerk be authorized to sign a subdivision agreement for final approval of the above 19 lots in Phase I; and
- 4. Staff, the developer, and citizen representatives be asked to continue to dialogue with the intent of discerning an additional access to the subdivision and to report back to Council as quickly as possible.

Motion passed.

## Final Approval - Lots A-1 to A-4 Albion Road

A supplementary staff report dated August 22, 1977 was submitted.

Alderman Walker referred to the above-noted report and referred to part 3 of the report and asked how Lot B could be combined with the existing lot on which Civic No. 37 Albion Road now exists. He stated that a number of the residents do not recall the meeting of December, 1973, referred to on page 3 of the report and, further, that the owner of Civic No. 10 Albion Road disagrees with the statement on page 3 that he requested the sewer be extended westward to service that lot.

Alderman Walker further referred to correspondence circulated by P.J.E. McDonough, solicitor for the applicant, and suggested that negotiations re purchase of the said property are underway but felt that insufficient time has elapsed for finalization of such negotiations.

It was agreed that the matter be referred to the next regular meeting of Committee of the Whole Council.

## Tender 77-60(R) Four 1978 Model 4 Wheel Drive Trucks

A staff report dated August 25, 1977 was submitted.

MOVED by Alderman Connolly, seconded by Deputy Mayor Moore that authority be granted to award tender to Bob McDonald Chevrolet Oldsmobile Limited for the combined bid amount of \$28,934.00 for three units with plow and one unit without plow, and that staff be authorized to charge the amount of \$28,934.00 to the vehicle replacement reserve account. Motion passed.

#### Tender 77-78 One Tractor-Loader-Backhoe

A staff report dated August 25, 1977 was submitted.

Alderman Lawrence asked what vehicles are being replaced by the above tender.

It was agreed that the matter be deferred to the next regular meeting of Committee of the Whole Council.

## Award of Tender #77-21, Street and Walkway Lighting

A staff report dated August 16, 1977 was submitted.

In response to a question, Mr. Calda advised that the said tender does not include the sodding and landscaping on North Ridge Road as this work will be done by City forces. Alderman Sullivan stated he would like all the work done at the same time and asked that the matter be clarified.

In response to a question re the University Avenue location, Mr. Calda advised that the tender submitted was in excess of the estimate and there was no account from which to transfer other funds. He stated that a comparison of the two designs will be made and a report will be submitted to City Council.

His Worship requested that staff look at the median lighting on Chebucto Road between Connaught Avenue and Mumford Road.

MOVED by Alderman Lawrence, seconded by Deputy Mayor Moore that tender #77-21 be awarded as follows:

- That the project for Convoy Place be awarded to Kaizer Construction and Services Limited at the unit prices quoted in the staff report dated August 16, 1977;

## QUESTIONS

## Question Alderman Connolly Re: Use of Concrete Poles in the City

Alderman Connolly stated that previously he had raised the matter of the City requiring that concrete poles be used and a staff report was issued indicating that such a requirement was not feasible financially, etc., He stated that a significant number of poles are being installed in the City and the type of pole being used is, in his opinion, an eyesore. He suggested that if overhead wiring is a necessity, the least requirement that can be requested is that the poles be more pleasing in appearance.

Deputy Mayor Moore stated that it is his understanding that when such poles are installed the City issues a permit of some sort but does not specify the area of location and at the present time two such poles are installed on the sidewalk on the bridge at Mumford Road.

It was requested that staff investigate the matters raised and that a representative of the Nova Scotia Power Commission be invited to attend the next regular meeting of the Committee of the Whole Council to discuss the matter.

## Question Alderman Connolly Re: Hazard at North End Library

Alderman Connolly stated that correspondence has been received re a hazard at the North End Library and asked that staff investigate and submit a report.

## Question Alderman Sullivan Re: Fence Repairs at Fort Needham

Alderman Sullivan stated that he had previously asked that the fence on the north side of Fort Needham at the Union Street entrance be repaired and noted that such repairs have not taken place. He requested that the work be done.

## Question Alderman Sullivan Re: Vacant City-Owned Lot on Veith Street

Alderman Sullivan stated that the vacant Cityowned lot on Veith Street located next to Veith House needs to be cleaned up as the grass has not been cut there all summer. He requested that the grass be cut and the lot be cleaned up.

## Question Alderman Sullivan Re: 2878-80 Barrington Street

Alderman Sullivan referred to a private and confidential memorandum from the City Solicitor re the above-noted property and expressed his disappointment in the status of the matter. Alderman Sullivan requested that the City Solicitor take appropriate steps to have notice served on the individual involved and that the matter be resolved as quickly as possible.

#### Question Alderman Sullivan Re: Negro Point Park

Alderman Sullivan noted that an information report dated August 19, 1977 was circulated re the Container Pier - Phase I. He requested that the item 'Negro Point Park' be added to the agenda of the next regular meeting of Committee of the Whole Council and that the City Clerk distribute copies of reports previously circulated re the matter.

## Question Alderman Downey Re: Freeze on Public Housing And Senior Citizens Housing Rents

Alderman Downey requested that staff ask the Minister of Housing to investigate a freeze on public housing and senior citizens housing rents for two years. His Worship requested that staff submit a report on the merits and demerits of the request.
