After the meeting was called to Order, the members of Council attending, led by Monsignor Richard Murphy, joined in reciting the Lord's Prayer.

PUBLIC MEETING TRAFFIC IMPLICATIONS OF THE QUINPOOL ROAD DEVELOPMENT M I N U T E S

> Queen Elizabeth High School 1929 Robie Street Halifax, N. S. September 12, 1977 7:45 p.m.

A public meeting re Traffic Implications of the Quinpool Road Development was held on the above date.

Present: His Worship the Mayor, Chairman; Aldermen Connolly, Shannon, Meagher, Sullivan, and Hanson.

Also Present: Mr. P. Connell, Acting Director of Engineering & Works, Mr. Fred Bradbrook, Traffic Authority; Mr. Scott Stewart, Traffic Management Board, City Clerk and other staff members.

His Worship called the meeting to order and introduced Mr. Fred Bradbrook, Traffic Authority and asked that he explain to those present staff's view of the traffic implications of the Quinpool Road Development.

Mr. Bradbrook explained that staff's views are assumptions based on experience from other locations in the City, experience with other developments in the City and the national level. He indicated that the number of trips generated by this development consisted of Commercial and Residential. He indicated that 700 additional trips where generated during the peak hours from 4:20 p.m. to 5:20 p.m.

He explained that staff tried to determine what the effect would be at the intersections of Quinpool Road and Vernon Street and Quinpool Road and Monastery Lane at the p.m. peak hour and based their design on these assumptions. He indicated that the Vernon Street entrance would serve as the major access for commercial business; the Monastery Lane entrance would serve as secondary access for the commercial business and primary access for the Al and A2 residential sections. He indicated that the main concern is to keep the majority of traffic on the main arterial streets and discourage the motorists from using the surrounding streets.

Public Meeting, September 12, 1977

Mr. Scott Stewart from the Traffic Management Board, explained how the Traffic Management Board was involved and is presently proposing several recommendations such as Reversible lanes on Quinpool Road at Connaught Avenue; Semi-actuated Control signals at Vernon and Preston Street, and Optically-programmed Signals at the Willow Tree.

He indicated that their involvement with the traffic implications of the Quinpool Road Development was looked at from two standpoints, one was to minimize the potential impact it might have on the residential streets and explore the characteristics of Quinpool Road to consider it as a main arterial within the City.

With the aid of a map, Mr. Stewart indicated how the intersection of Vernon St. and Quinpool Road, could be improved by including an exclusive left turn lane, eastbound, into the development.

Mr.P. Vaughan a resident of Vernon Street asked if staff could explain the traffic flow proposed at the intersection of Vernon Street and Quinpool Road.

Mr. Bradbrook responded that the traffic moving northbound on Vernon Street would be allowed to go left or right; traffic moving along Quinpool Road eastbound would be allowed to go straight, right or left (exclusive left turn lane); the traffic moving along Quinpool Road westbound would be allowed be go straight, right or left; and the traffic leaving the Development via Vernon Street would be allowed to make a left or right turn only,onto Quinpool Road.

Mr. Roy Whitley, Cedar Street, suggested that staff look at the possibility of installing 4-way stop signs at every intersection as they have done in Vancover.

Bernice Jones, Walnut Street, asks that the left turn movement from the development onto Quinpool Road, be closely monitored.

Alderman Meagher submitted a petition on behalf of the residents of Yukon Street respecting the effects of Quinpool Road Property Development on their neighbourhood. He requested that staff look at this request and the whole problem that this project will create in the other parts of this ward.

Public Meeting, September 12, 1977

Mike Bradfield, Cornwall Street, suggested that the traffic flow changes should be established before the traffic flow starts. He suggested that Monastery Lane be made a one-way street going north; close off Yukon Street; make Yale Street a one-way street going west and allow only an entrance to the project from Monestary Lane. He suggested that these types of barriers will force traffic onto the main arterial streets.

Mr. Scott spoke on behalf of the Merchants of Quinpool Road. He asked why the free parking within the development has been changed to paid parking.

Mr.Kettless responded that if the parking lot is uncontrolled it will encourage unauthorized users. He said that parking for the users of the Commercial business will be free. He indicated that it would be a ticket validation system.

Mr. Allan Ruffman asked what the cost would be to the City for a traffic study on this project. He suggested that staff look at the techniques used in Ottawa where barriers are used at corners to restrict traffic.

Mr. Brodie, Jubilee Road, indicated that residential populations are not traffic generators and that a majority of the people walk to work or use transit. He said that the people should not accept the project as it now stands but, put more pressure on increased and better residential development on the site.

Mr. John Dick, Vernon Street, asked how the project entrance off Quinpool Road got lined up with Vernon Street; how is this project compared with the Bayers Road Shopping Centre with respect to access from a major artery and how sure can the residents be that once this development goes ahead, that access onto Vernon Street, from the project, will be prohibited.

Mr. Bradbrook responded that the major reason for the line-up with Vernon Street was to eliminate another set of signal controls and also, to provide a buffer between the project and the School. He indicated that the major problem in the City is the lack of arterial roads. Although, Chebucto Rd. & Quinpool Road are functioning as arterial roads, but they do not meet any of the geometrical design requirements.

Public Meeting, September 12, 1977

Sue Wolstenholme, Lawrence Street, expressed concern about the increased traffic that will be generated in the area of Monastery Lane, Yukon Street, Yale Street, and Lawrence Street and the inconvenience of having such a development and to accommodate such a development.

Deputy Mayor Moore arrives - 9:45 p.m.

Marion Kerans, Willow Street, suggested that Monastery Lane be made one-way and also, closing it at Allen Street. She also, suggested making Yale and Yukon Streets one-way going west. She indicated that volumne predications have been done on Vernon Street and would like to see the same done on Allen Street.

Scott Stewart responded that the figure of 50 to 60 vehicles per peak hour will be exiting from the development onto Monastery Lane.

Mr. P. Kerans, Willow Street, expressed concern about the paid parking for this development.

After some disucussion His Worship stated that City Council will be as attentive as they can to the matters discussed at this meeting.

A letter dated September 8, 1977 re the above subject was received from Mr. A. J. Pelley, copies of which were circulated to members of City Council.

A letter dated September 11, 1977 re the above subject was received from Mrs. Margaret Haliburton, copies of which were circulated to members of City Council.

A letter dated September 12, 1977 re the above subject was received from A. J. Pelley, N. Kemp, and Margaret Haliburton, copies of which were circulated to members of City Council.

Alderman Lawrence entered the meeting at 9:05 p.m.

Alderman Shannon stated that it was her understanding when funds were budgeted the purpose was to fence St. Mary's recreation field but, in fact, it was to fence the Fairfield retention tank lands and to make the St. Mary's boat club lands come in one piece across the retention tank lands. She stated that abutting property owners object to the erection of such fencing and would have done so prior to construction had they been aware of the proposed location of the fencing.

Mr. J. Pelley, 6744 Jubilee Road, addressed Council and stated that he initiated the submitted petition. He felt that the abutting property owners should have been

advised and suggested that the construction of a fence in that location would devaluate properties and create a nuisance.

Mr. J. MacLean, Recreation Department, addressed Council and stated that it was proposed to remove a portion of a fence at the end of Fairfield Road and construct a fence on City-owned land behind the retention tank which would allow the City to increase its recreational use of the land behind the retention tank and also for access to it from St. Mary's Boat Club. The motion was put and passed.

Proposed Equipment Purchases - Halifax Metro Centre

Alderman Connolly stated that in his opinion a number of items listed should be part of the construction of the actual building and others appear to be operating items and therefore should be coming out of the operating budget for the facility. He suggested that the request represents an overrun on the cost of the building and an extra cost the City is being asked to put into the building.

Alderman Shannon stated that she thought the cost of the building was the cost of a functioning building and suggested that if there is an overrun on the cost of the building it should be so stated and by how much.

Deputy Mayor Moore stated that in the budget given to construct the facility, all was expended through land acquisition, design and construction. He stated that the listing provided is as accurate as can be developed at this time. He further stated that there is financial participation by the Province of Nova Scotia for the purchases to the extent of \$200,000.

MOVED by Deputy Mayor Moore, seconded by Alderman Hanson that, as recommended by the Finance and Executive Committee:

After some discussion, the <u>motion was put and</u> passed with Aldermen Shannon and Connolly voting against.

Tender 77-78 - One Tractor - Loader - Backhoe

The above noted item was briefly considered earlier in the meeting and was deferred until this time in order that staff may report with respect to two additional bids which were received but which were not included in the staff report.

The Director of Finance advised that he reviewed the file saying that there were two additional bids one of which was clearly deficient in terms of the equipment. Mr. Smith advised that the other one was a qualified bid which met the specifications and the amount involved was less than the tender recommended. He said the bid was qualified with respect to the availability of a particular unit.

Deputy Mayor Moore said he would like to have staff report on the matter and asked that in the future, all bids be noted in staff reports and if there is any reason for which the bids may be invalid and the equipment is not up to specifications, a note be made in the report which is presented to Council.

MOVED by Deputy Mayor Moore, seconded by Alderman Lawrence that the item be deferred to the next meeting of the Committee of the Whole Council and that a report be submitted on the matter.

Motion passed.

His Worship suggested that staff might also address themselves to the matter of bids received after the closing date which are not opened.

Authorization of Expenditure from Sale of Land Account -Metro Centre Land

MOVED by Deputy Mayor Moore, seconded by Alderman Hanson that, as recommended by the Finance & Executive Committee:

1. authority be granted by Council to seek the approval of the Minister of Municipal Affairs for an expenditure of \$2.55 millions from the Sale of Land Account of the City to purchase from Metro Centre Limited, those lands upon which the present Metro Centre facility stands; and

2. authority be given for the City to advance funds from the Sale of Land Account (subject to obtaining the approval noted above) to Metro Centre Limited to a maximum of \$2.55 Millions in the ratio of 2.55:11.5 in return for a deed to the lands on which the Metro Centre facility now stands.

Alderman Shannon asked if the City has the appraised value of the land it is putting into the project and the City Manager advised that she did not have the information at tonight's meeting but that it was available. Alderman Shannon then asked if Council could be supplied with the information.

Alderman Shannon also asked if Council could be informed of the amount paid per square foot as a result of expropriations and Deputy Mayor Moore questioned whether this would be available as the lands are being expropriated by the Crown. Alderman Shannon indicated she was trying to establish the value of the land the City was putting in the project and Deputy Mayor Moore suggested it would be the difference between the \$2.55 Million and \$3 Million.

Further questioning ensued and Alderman Shannon, in referring to the item listed on the back of the report dated September 1st. relating to payments to land owners and related expenses, and asked what this included. The City Manager advised that this is the portion the Province has incorporated as part of the land cost to date that has been settled. Alderman Shannon then asked how many square feet were involved and the City Manager advised she was not informed of this information saying she could ask but did not know whether an answer would be forthcoming.

Alderman Shannon questioned staff further with respect to the value of the street involved and the City Solicitor advised that the City is not going to deed the Streets. Alderman Shannon then asked that Council be informed of the value of the street as well as the information known with respect to the number of square feet the \$3,000,000 represents.

The Motion was put and passed with Aldermen Connolly and Shannon against.

Pre-Retirement Leave Policy Clarification Required

Alderman Sullivan referred to a letter received from Mr. MacDougall of Local Union #108 and MOVED, seconded by Deputy Mayor Moore that the item be deferred.

The City Manager advised that she spoke to Mr. MacDougall who referred to a possible meeting between the City Manager and different Union representatives to discuss the subject as Mr. MacDougall felt there were some questions not considered in the staff report.

The Motion to defer was put and passed.

His Worship advised the City Manager will advise Council when to proceed on the basis of conversations which she has on the subject.

Award of Tender 77-18 - Sidewalk Renewal - Brunswick, Duke, George, and Cheapside Streets

MOVED by Alderman Downey, seconded by Alderman Lawrence that, as recommended by the Finance and Executive Committee, Tender #77-18 be awarded as follows:

1. All projects in Tender 77-18 be awarded to Standard Paving Maritime Limited for the unit prices quoted in Appendix "A" attached to the staff report dated August 29, 1977;

Motion passed.

A short discussion ensued on the matter of senior citizens being able to remain in their own homes and His Worship suggested that perhaps the City should formulate something in this regard. His Worship suggested that one thing that could be done is for one of the City's delegates to present a resolution on the subject of next week's meeting of the Union of Nova Scotia Municipalities requesting that it be supported.

MOVED by Alderman Meagher, seconded by Alderman Stanbury that the Provincial and Federal Authorities be urged to give greater priority to appropriate programs to assist senior citizens to maintain their own domicile.

It was agreed at that time that the item be placed on the agenda for this meeting for the purpose of officially accepting the Statements.

MOVED by Alderman Connolly, seconded by Alderman Sullivan that City Council now receive and accept the audited financial statements of the accounts of the City for the fiscal period ended December 31, 1976.

Motion passed.

QUESTIONS

Question Alderman Sullivan Re: Truck Traffic Corner of Vestry and Barrington Streets

Alderman Sullivan requested that the Police Department monitor traffic on the Corner of Vestry and Barrington Streets saying that truck traffic uses Vestry Street as a short cut between Barrington and Gottingen Streets.

His Worship suggested that both the Police Department and the Traffic Authority should monitor the situation.

Alderman Walker noted there are a number of Streets which have Truck Route signs posted but noted there are also many streets which trucks are not permitted to use and are not signed as such.

The City Solicitor advised that this matter has been discussed saying it is much simplier to place signs on the streets which trucks are permitted to use. As an example, Mr. Murphy referred to a street such as Barrington Street saying that signs would have to be posted at every intersection along the street suggesting this would result in too many signs.

Alderman Walker expressed the feeling that residential areas should be posted with "No Truck" signs.

His Worship suggested that staff could review the matter again to see if there is a compromise that can be worked out on streets where truck traffic is notorious.

Question Alderman Meagher Re: Petition - Residents of Willow St.

Alderman Meagher advised that about one month ago, he presented a petition from the residents of Willow Street and asked if the item could be placed on the Committee on Works agenda for next Wednesday, and that the residents involved be advised it is on the agenda.

Question Alderman Lawrence Re: Traffic Count, Glenforest Drive

Alderman Lawrence requested that staff carry out a traffic count on Glenforest Drive over an appropriate period of time saying there has been a marked increase in traffic on the street.

Question Alderman Lawrence Re: Truck Traffic, Main Avenue

Alderman Lawrence said he would like staff to prepare a report, after investigation, with respect to truck traffic on Main Avenue. Alderman Lawrence referred to construction taking place above Main Avenue saying the problem is that large equipment is being transported on the Street and is ripping the overhead wires off the houses early in the morning.

Question Alderman Shannon Re: Parking area, Quinpool Road

Alderman Shannon noted that in last evening's paper, the President of the Quinpool Road Merchants' Association stated he has been working for two years with staff attempting to find a site for a parking garage to serve the area. Alderman Shannon asked that she be supplied with a report from staff with respect to their understanding of the matter and what is being done on the item.

Question Alderman Downey Re: Report - Traffic Lights

Alderman Downey said he would like to receive a report from the Traffic Department with respect to the matter of traffic lights. Alderman Downey referred to the matter of vehicles being permitted to make a right turn on a red light saying that some of the lights are not equipped with the usual "No Walk" sign for pedestrians. Alderman Downey expressed the feeling that such intersections should be equipped with a caution light.

Question Alderman Downey Re: Cogswell Street Interchange Tender

Alderman Downey asked if the above noted tender has been called and it was advised by Mr. Sullivan of the Engineering Department that the tender has not been called and that members of staff are in consultation with the designers at the moment. Alderman Downey said he noticed a car had dropped in a hole in the area which he had previously mentioned should be repaired and asked if it could be patched with asphalt. Mr. Sullivan advised that City Field would look into the matter.

ADDED ITEMS

Award of Contract 77-81 - Crack Filling of Streets

A staff report dated September 12, 1977, was submitted.

MOVED by Alderman Sullivan, seconded by Alderman

Walker that contract 77-81 for crack filling of streets, be awarded to Duron Ontario Ltd. in an amount not to exceed \$7,740.00 under Account Number 057-138-kK130.

Motion passed.

Circuses

The above noted matter was added to the agenda at the request of Deputy Mayor Moore.

Deputy Mayor Moore, in referring to the recent circus held in Halifax, noted that a large number of citizens enjoyed the event but said the abutting property owners along the southeast side of the parking lot of the shopping centre, suffered inconveniences due to noise. Deputy Mayor Moore advised that the operation was set up after 11:00 p.m. contrary to the noise Ordinance and noted that traffic in the area was congested during the operation of the circus. He said that in addition, the properties abutting the area were used at liberty by employees of the circus.

MOVED by Deputy Mayor Moore, seconded by Alderman Lawrence that City staff be requested to prepare a report on the subject matter with a view to curtailing any re-occurrence of any such activity in a basic neighbourhood locale.

Deputy Mayor Moore suggested that perhaps what is needed is a separate Ordinance on the subject.

Motion passed.

Alderman Walker noted that complimentary tickets were available to many children at many outlets saying that when parents took their children to the circus with the tickets, the seats had already been taken. Alderman Walker felt that the matter should be referred perhaps to the Better Business Bureau.

His Worship said he was of the understanding there was an Amusement Board under Provincial jurisdiction suggesting this might be the proper body to which the subject matter should be referred. His Worship advised that staff would look into the matter.

St. Agnes School Playing Field

The above noted item was added to the agenda at the request of Deputy Mayor Moore.

Deputy Mayor Moore, in referring to the above matter, advised the project totalled \$100,000 over a two year period saying one-half of the money was to be spent for the levelling and filling in of the field area. Deputy Mayor Moore said that what he was wondering is whether there are any funds left in the capital budget for recreation that might be reallocated for the top soil and sodding in order to finish the project.

A staff member of the Recreation Department advised that it is anticipated there will be a surplus of funds in the 1977 approved Capital Budget.

MOVED by Deputy Mayor Moore, seconded by Alderman Hanson that the St. Agnes School Playing Field project be proceeded with to completion to be funded by the unallocated money in the 1977 Capital Budget.

His Worship noted that other members of Council are seeking recreational funds in their Wards and suggested the Department should be asked to supply the estimates of unallocated funds and Council then make a decision as to what projects it wants to do.

A short discussion ensued and <u>it was MOVED by</u> <u>Alderman Connolly, seconded by Alderman Walker that</u> the matter be deferred to the next regular Committee of the Whole meeting in order that Council can be informed of what the surplus funding amounts to.

The Motion to defer was put and passed.

Noise Problem - Albert and Russell Streets

The above noted item was added to the agenda at the request of Alderman Sullivan.

Alderman Sullivan, in referring the subject matter, advised that it is a problem that has re-occurred over the years and stems from the Fleet Club saying that people leaving the Club late in the evening or during the early morning hours create guite a noise.

Alderman Sullivan suggested that one of the problems is that the Police Department cannot enforce the law on the Base saying there must be some way co-operation can be reached on the matter.

Alderman Sullivan said there are signs posted advising patrons not to leave by way of the Russell Street exit but these are not adhered to and indicated the people in the area are asking that people leave by way of the Barrington Street exit.

A short discussion ensued <u>and it was agreed</u> <u>that</u> His Worship and Alderman Sullivan would speak to the Base Commander concerning the problem.
