QUESTIONS_

Question Alderman Lawrence Re: Expansion - Membership of Halifax Forum Commission

Alderman Lawrence said that Council recently discussed the possibility of the expansion of the membership of the Halifax Forum Commission and asked if a status report could be received on the matter.

Question Alderman Lawrence Re: Snow Clearing Vehicles Contracted by the City

Alderman Lawrence, in referring to the vehicles contracted by the City for use in the snow clearing operation, said he noticed that some of these vehicles did not have any type of warning on the rear of the truck. Alderman Lawrence felt they should be equipped with proper emergency lighting and asked if the foreman on duty could check the vehicles. He said he also noticed a couple of trucks which were not equipped with the safety triangle which is to be used by slow moving vehicles.

The Acting City Manager advised that the request would be carried out.

Question Alderman Sullivan Re: Status Report - Building on Barrington Street Across from the North Gate of the Dockyard

Alderman Lawrence asked for a status report with respect to the above noted building.

Question Deputy Mayor Shannon Re: Bus Shelter, City Hall

Deputy Mayor Shannon asked if staff could look into the possibility of locating a bus shelter outside the wall at City Hall in the area of the old garage. She suggested that since the completion of the two bank buildings, the environment in the area has been changed quite dramatically.

Question Deputy Mayor Shannon Re: Upgrading the Status of Cornwall, Norwood, and York Streets - Snow Clearing

Deputy Mayor Shannon requested that staff give consideration to the possibility of upgrading Cornwall, Norwood, and York Streets, on the east side of Oxford Street. She noted the streets are rather steep and they are not on the second class listing for snow plowing.

Question Deputy Mayor Shannon Re: Metro Centre Capital Expenditures

Deputy Mayor Shannon said that three weeks ago she asked for a report from Metro Centre on capital expenditures of equipment from the \$450,000 made available from the City and asked when the report would be submitted.

The Acting City Manager indicated a report would be available very shortly.

Question Alderman Maley Re: Belmont on the Arm

Alderman Maley noted that the above noted item was raised some weeks ago and there was a follow-up report. Alderman Maley said she would like to receive a further report on the matter.

NOTICE OF MOTIONS

Notice of Motion - Alderman Sullivan Re: Amendment to Ordinance #143, the Mobile Home Parks Ordinance

Alderman Sullivan gave notice that at the next regular meeting of the City Council of the City of Halifax to be held on Thursday, the 29th day of December, A.D., 1977, he proposes to introduce an amendment to Ordinance Number 143, the Mobile Home Parks Ordinance. Alderman Sullivan advised that the purpose of the amendment was to eliminate the requirement for a fee for a license to operate a mobile home park.

ADDED ITEMS

Recommendation - Election Procedures Committee

A report dated December 14, 1977, was submitted from the Election Procedures Committee respecting the matter of the return of Candidate's deposits - Civic Election 1977.

Alderman Moore said the intent of the section of the Charter in question was to ensure that the material erected in connection with the election would be removed after the day of the vote. Alderman Moore suggested the spirit of the section was adhered to but said there was some confusion with respect to the application which was to be filed with the City Clerk in order to obtain a rebate of the deposit.

MOVED by Alderman Moore, seconded by Alderman Hanson that the Acting City Manager be asked and, funds being available, authorized to make payments to the various candidates in the 1977 civic election, equivalent to that portion they would have been entitled to.

Metro Centre Lands - City Council Minutes

A staff report dated December 12, 1977, was submitted.

MOVED by Alderman Moore, seconded by Alderman

Hanson that City Council ratify the Agreement between the City and the Province that the purchase price to be paid by the City to the Province for the Metro Centre site be the \$2.55 million dollars already referred to and the portion of Grafton Street recently closed by the City, as indicated on the Servant, Dunbrack, McKenzie & MacDonald Limited's Plan No. 6-55-0, dated October 19, 1977.

Following an explanation by the Acting City Manager, the Motion was put and passed with Deputy Mayor Shannon against.

Metro Centre - Security

The above noted item was added to the agenda at the request of Alderman Lawrence.

Alderman Lawrence expressed some concern with respect to the security contract awarded for Metro Centre saying it was his understanding that the contract was awarded to the same company that provides the service at the Forum. Alderman Lawrence said he would like to receive a report on the matter and would like to receive the full documentation on the particular contract. Alderman Lawrence said he would like City Council to see the tender documents.

His Worship asked if the tender documents could be secured from the Commission and the Acting City Manager advised that he would attempt to do so.

Alderman Clarke asked whether members of Council were entitled to look at the contracts drawn up between the Commission and the Nova Scotia Voyageurs, and His Worship expressed the feeling that any member of Council could look at the documents in private.

His Worship suggested that as the Metro Commission is a civic body, any elected member of the City is entitled, on his or her responsibility, to all information concerning the City's business, but said the information has not been widely disclosed for competitive good business reasons.

Alderman Moore advised that the two pertinent documents have yet to be finalized and executed but expressed the feeling that they will soon be completed.

His Worship then asked if the Commission could be requested to keep the enquiry in mind and to give Council a report, and the Acting City Manager advised that this would be done.

His Worship said that at such time as there is a contract document, a copy will be sent to Alderman Clarke marked Confidential.

Traffic Improvements - Intersection of Connaught Avenue and Jubilee Road

The above noted item was dealt with under the heading "Quinpool Road Traffic", earlier in the minutes.

Intersection Traffic Improvements - Herring Cove Road and Old Sambro Road

The above noted item was added to the agenda at the request of Alderman Wooden.

Alderman Wooden said she would like to have staff report on the effects of the recent opening of North West Arm Drive on the traffic intersection of Herring Cove Road and the Old Sambro Road. Alderman Wooden said that when one is proceeding north on the Herring Cove Road, it is not possible to make a left hand turn on the Old Sambro Road without the traffic backing up. Alderman Wooden indicated she would like to know when some improvements can be made and if the item has been budgeted for.

His Worship suggested that staff be asked to bring in the cost of traffic improvements to permit freer left hand turns onto the Old Sambro Road for in-bound Herring Cove Road traffic as part of the budget considerations for traffic improvements, and Alderman Wooden indicated she would like to make such a request.

Pedestrian Safety - Old Sambro Road

The above noted item was added to the agenda at the request of Alderman Wooden.

Council

Alderman Wooden expressed concern with respect to safety on the Old Sambro Road and requested staff to include the estimate of the cost to include sidewalk installation on the Old Sambro Road in time for capital budget consideration.

CITY COUNCIL MINUTES

> Council Chamber City Hall Halifax, N. S. December 29, 1977 8:00 P. M.

A meeting of City Council was held on the above date.

After the meeting was called to Order, the members of Council attending, led by the City Clerk, joined in reciting the Lord's Prayer.

Present: His Worship the Mayor, Chairman; Deputy Mayor Shannon, and Aldermen Maley, Downey, Meagher, Sullivan, Clarke, Wooden, Hanson, Moore, and Lawrence.

Also Present: Acting City Manager, City Clerk, and other staff members.

MINUTES

Minutes of the City Council meeting held on December 15, 1977, were approved on Motion of Alderman Moore, seconded by Alderman Lawrence.

APPROVAL OF ORDER OF BUSINESS, ADDITIONS AND DELETIONS

At the request of Alderman Moore, Council agreed to add:

20(a) - Appointments, Board of School Commissioners -City of Halifax

At the request of Alderman Maley, Council agreed to add:

20(b) - Local Improvements - Billing & Collection Practices

At the request of Deputy Mayor Shannon, Council agreed to add:

20(c) - Additional Expenditures - Metro Centre

At the request of the City Clerk, Council agreed to add the following item which was inadvertently left off the agenda:

10(m) - Agricola Street Loop.

REPORT - FINANCE & EXECUTIVE COMMITTEE

Council considered the report of the Finance and Executive Committee from its meeting held on December 21, 1977, as follows:

Neighbourhood Improvement Program I - Old Northern Suburb, Implementation Project, Sidewalk, Curb & Gutter Renewal - 1978

MOVED by Alderman Downey, seconded by Alderman Sullivan that, as recommended by the Finance & Executive Committee, Council approve a sidewalk, curb and gutter renewal program in NIP Area I, Old Northern Suburb, up to an amount of \$300,000 for the year 1978, to be funded out of Capital Account 818 190 HA 614.

Motion passed.

Tenders 77-142, 77-143, 77-144, 77-145, 77-146 -Disposal of Surplus Vehicles

The above noted item was forwarded to City Council without recommendation.

Alderman Lawrence advised that he received answers from staff regarding the questions he put forth at the last meeting respecting the plows included with the tendered vehicles.

MOVED by Alderman Lawrence, seconded by Alderman Moore that authority be granted to award tenders to the highest bidder in each case as indicated by an asterisk in Appendix "A" attached to the staff report of December 9, 1977.

Motion passed.

Capital Budget for Group Homes 1977-78 Item HAK01

MOVED by Deputy Mayor Shannon, seconded by Alderman Maley that, as recommended by the Finance & Executive Committee, the amount of \$120,000 allocated in the 1977 budget, and the \$140,000 requested in the 1978 budget, be allocated either for the establishment of Group Homes or for Capital costs involved in establishing sheltered employment or job creation projects.

Current Borrowing Resolution

MOVED by Alderman Moore, seconded by Alderman Sullivan that, as recommended by the Finance and Executive Committee, City Council authorize His Worship the Mayor and the City Clerk to sign a Current Borrowing Resolution covering the period from January 1, 1978 to June 30, 1978 in the amount of \$6,000,000.

Motion passed.

Pound Agreement 1978

MOVED by Alderman Sullivan, seconded by Alderman Meagher that, as recommended by the Finance & Executive Committee, a payment of \$32,800 be authorized to be made to the Society during 1978 to be advanced on a monthly basis on the understanding that the City will continue to have access to the records of the Society and that the Society will maintain separate accounting for the cost of operating their City related activity, and on the further understanding that the fee to the public for acceptance of animals at the pound be held at the present levels.

His Worship asked if staff are **reviewin**g ways of increasing the dog license revenues, and the Acting City Manager replied in the affirmative saying that in the review of the whole problem of dogs running at large, it appears there may be large numbers that are not licensed and staff will be giving attention to the matter in an attempt to increase the revenues.

His Worship asked if the matter would be the subject of an early report and the Acting City Manager advised that it would be.

Motion passed.

Temporary Borrowing Resolution - Quinpool Road

Following a short questioning of staff, it was <u>MOVED by Alderman Sullivan, seconded by Alderman Hanson that</u>, as recommended by the Finance & Executive Committee, Council instruct the City Solicitor to renew the borrowing resolution in the amount of \$4,597,610 for a period of four months expiring March 21, 1978 and at that date, staff propose a renewal in the required amount for the balance of 1978.

South Armdale Childrens Co-op Nursery

MOVED by Alderman Hanson, seconded by Alderman Wooden that, as recommended by the Finance & Executive Committee, City Council approve the extension of the lease for the Co-op in South Armdale Community Centre for a period of one year, January 1, 1978 to December 31, 1978 at the same rent of \$25.00 per month.

Motion passed.

Halifax Housing Authority 1978 Operating Budget

MOVED by Alderman Downey, seconded by Alderman Sullivan that, as recommended by the Finance & Executive Committee, the 1978 Operating Budget be accepted by City Council as is presented in the staff report of December 15, 1977 in the amount of \$537,339 in order that the Authority may proceed with their budgetary process in good time.

Motion passed.

Development Agreement for Phase A of Uniacke Square

The following is the recommendation of the Finance and Executive Committee:

"That City Council approve the Development Agreement for Phase A of Uniacke Square as attached to the staff report of December 14, 1977, subject to Central Mortgage and Housing Corporation's approval and, that Council also authorize His Worship the Mayor and the City Clerk to execute the agreement on behalf of the City when written approval of the agreement has been received from Central Mortgage and Housing Corporation."

Discussion ensued with respect to Section 33 of the Development agreement as attached to the staff report of December 14, 1977 following which, it was <u>MOVED by Alderman</u> <u>Downey, seconded by Deputy Mayor Shannon that</u> City Council approve the Development Agreement for Phase A of Uniacke Square as attached to the staff report of December 14, 1977, subject to Central Mortgage and Housing Corporation's approval and, that Council also authorize His Worship the Mayor and the City Clerk to execute the agreement on hehalf of the City when written approval of the agreement has been received from Central Mortgage and Housing Corporation, subject to the provision that any assignment as provided in Section 33 of the draft agreement be subject to the assent of both parties. Motion passed.

Call for Proposals - City Prison Lands

The above noted item was forwarded to City Council without recommendation.

Discussion ensued with respect to the proposed Call for Proposals document as attached to the staff report of December 12, 1977, with the following changes being made:

- Part I Page #3 The word "expected" in the second line of the fourth paragraph, be changed to "required".

Following a further short discussion and questioning of staff, it was MOVED by Alderman Lawrence, seconded by Alderman <u>Sullivan that</u>, under Section 184 of the City Charter 1963, City Council excuse the Treasurer from collection of the monies due to the City as outlined in the staff report of December 12, 1977, and authorize the write-off of \$176,310.66.

Expenditures in 1978 Prior to Budget Approval

MOVED by Alderman Sullivan, seconded by Alderman Meagher that, as recommended by the Finance & Executive Committee:

1. City Council approve expenditure of funds necessary to maintain the present level of City operations until such time as the budget is finalized for 1978; and

2. City Council approve the listing of special projects attached to the staff report of December 16, 1977, for commencement in 1978 prior to finalization of the budget.

Motion passed.

Agricola Street Loop

The following Motion was put and lost by the Finance & Executive Committee at its meeting held on December 21, 1977:

"That City Council provide funds necessary to maintain the Agricola Street Transit Loop for a further two months."

MOVED by Alderman Downey, seconded by Alderman

Meagher that the City guarantee deficit operation on the Agricola Loop run until February 28, 1978, and said route to be made the subject of a further report to Council not later than February 15, 1978 in detail together with its operating results, and Council agrees that it be funded.

Discussion ensued on the matter and Alderman Moore requested that the review to be conducted by the Transit Corporation, be commenced immediately so that Council will not be faced with the same situation in two months time.

Further discussion ensued and the Motion was put and resulted in a tie vote, five voting for the same and five voting against as follows:

The Chairman cast his vote in favour of the Motion and declared same to be passed.

Council considered the report of the Committee on Works from its meeting held on December 21, 1977, as follows:

North West Arm Sewer Cleaning

MOVED by Alderman Maley, seconded by Alderman Hanson that, as recommended by the Committee on Works, the cleaning of the North West Arm sewer, Phase I, (Horseshoe Island to South Street) be undertaken immediately at an estimated cost of \$300,000 and that an authorization of funds be approved to be added to the Special Items Budget Account, and that this be authorized under Section 201(1) of the City Charter. Motion passed.

Upgrading/Resurfacing of Streets

MOVED by Alderman Moore, seconded by Alderman Hanson that, as recommended by the Committee on Works, staff be instructed to set aside from 1977 Surplus Funds an amount of \$600,000 to be known as the streets Resurfacing Reserve, and that staff be instructed to bring forward a Planned Program of Street Upgrading to be financed from this reserve as a part of the 1978 Budget Submissions. Motion passed.

REPORT - COMMITTEE OF THE WHOLE COUNCIL, BOARD & COMMISSIONS

Repeal and Re-enactment of Ordinance No. 145 respecting "The Payment and Collection of Taxes" SECOND READING

Motion passed.

Application for Rezoning from R-2 Residential General to C-2 Commercial General, Lands of J.E.S. Developments, 6205 Pepperell Street

MOVED by Deputy Mayor Shannon, seconded by Alderman Maley that, as recommended by the City Planning Committee, the application to rezone Civic Number 6205 Pepperell Street, lands of J.E.S. Developments, from R-2 Residential General to C-2 Commercial General, as shown on Plan P200/8178 of Case No. 3278, be refused by City Council, and further that City Council affirm that it would not likely look with favour upon any application for rezoning on the north side of Pepperell Street. Motion passed.

Designation of Third Neighbourhood Improvement Area

MOVED by Alderman Maley, seconded by Alderman Wooden that, as recommended by the City Planning Committee, staff be authorized to examine neighbourhoods Nos. 2 to 5 as outlined on Map I as to eligibility as set out in the federal/provincial agreement of August 24, 1977, and report back to Council as soon as possible. Motion passed.

Senior Citizen Housing Project - Queen and South Streets

A staff report dated December 21, 1977 was submitted.

MOVED by Alderman Moore seconded by Alderman Lawrence that in order to allow construction to proceed that the application to reduce the parking requirement of 1:5 to approximately 1:6 to provide 22 parking spaces for the senior citizens apartment building, Queen Street at South Street, as shown on Plan P200/8208 of Case No. 3544 be approved by City Council.

His Worship indicated that it could be possible for Central Mortgage and Housing Corporation to proceed without asking the City's approval, but that they have been most cooperative in dialoguing with staff on the proposed project.

His Worship indicated that upon receipt of a staff report on the item, City Council will hold a public meeting to review staff's comments and the document.

Alderman Lawrence asked that staff indicate in their report the cost involved in the preparation of the Concept Plan and who paid for it.

MOVED by Aldeman Maley, seconded Deputy Mayor Shannon that Halifax City Council receive the Old South End Neighbourhood Improvement Program Concept Plan and refer it to City Staff for review and report with the intention of holding a Public Meeting. Motion passed.
