The Acting City Manager advised that he is not aware of any community that has been able to resolve the problem legally. He stated that he is aware of communities that have passed legislation but it is not really effective and there does not seem to be a practical way of dealing with the problem.

Alderman Sullivan felt that there was a recommendation in a staff report considered a couple of months ago re the matter and asked that staff review the record and report.

Question Alderman Lawrence Re: Advertising of Telephone Numbers for Dog Control Services

Alderman Lawrence asked that, in view of the recent action by City Council in turning over dog control services to the S.P.C., would the telephone numbers for obtaining such service be publicized so that the public would be informed.

The Acting City Manager advised that publication of such numbers will take place.

Question Alderman Lawrence Re: Painting of School Crosswalks

Alderman Lawrence asked that the painting of school crosswalks take priority over the painting of other intersection pedestrian walkways and that such painting take place before the end of the school term so that the students will be protected.

Question Alderman Wooden Re: Installation of Litter Baskets

Alderman Wooden asked that staff investigate the possibility of installing litter baskets on the lamp posts along the commercial sections of the Herring Cove Road and near retail outlets on other streets in that area. She stated that the litter problem in her ward is becoming atrocious and asked that City Field consider cleaning the streets in her Ward because of their condition.

Question Alderman Wooden Re: Civic No. 428 Herring Cove Road

Alderman Wooden stated that the dwelling at the above noted address was previously boarded up and secured by staff as well as a rodent control program was undertaken by the Health Department to eliminate a problem that existed. Alderman Wooden advised that the building is again open and is being used by vandals and rodents have been seen in the area.

Alderman Wooden requested that staff resecure the building and the Health Department be asked to undertake another rodent control program at that location.

Question Alderman Wooden Re: Use of Carson Street by Students at Rockingstone Heights School

Alderman Wooden stated that students at the Rockingstone Heights School have to walk on the roadway that leads down from the school to get to the steps. She stated that it is a very steep incline and over the past winter teachers have expressed concern re the slippery conditions on the street and the possibility of a serious accident occurring because of the pedestrian traffic and the prevailing conditions.

Alderman Wooden asked that the School Board be requested to investigate the problem.

Question Alderman Wooden Re: Extension of Pavement Around the Rockingstone Heights School

Alderman Wooden asked that staff consider removing the boulders and extending the pavement around the Rockingstone Heights School so that the Police patrol may encircle the building.

His Worship stated that the School Board will be asked to consider the request.

Question Alderman Clarke Re: Policy re Acceptance of Garbage at the Transfer Station on Holidays

Alderman Clarke stated it is his understanding that during a recent holiday citizens were not allowed to take garbage to the transfer station although commercial vehicles were being admitted. He asked that staff advise what the policy is re acceptance of garbage at the Transfer Station on holidays.

Question Alderman Downey Re: Tiling at Centennial Pool

Alderman Downey stated he had received an information staff report which indicated that the tiling at Centennial Pool was not under warranty although he felt that it was. He asked if the matter has been clarified and if the tiles which were lifting have been replaced.

The Acting City Manager stated he thought the staff report responded to the question and that he would contact Alderman Downey tommorow re the matter.

Question Alderman Downey re: Overnight Parking Ban

Alderman Downey asked when the overnight parking ban on City streets will be lifted.

His Worship indicated that the ban will expire at midnight on April 15, 1978.

Question Alderman Sullivan Re: Incinerator on McCully Street

Alderman Sullivan asked when the requested staff report will be received re the SPC incinerator on McCully Street.

The Acting City Manager advised that the report will be forwarded to members of Council tomorrow.

Question Alderman Sullivan Re: Clean Up of Litter at the Approaches to the A. Murray MacKay Bridge

Alderman Sullivan asked who is responsible for the clean up of litter at the approaches to the A. Murray MacKay Bridge, specifically on Barrington Street in back of Kencrest Avenue and over the hill on the actual approach off Barrington.

Mr. Calda advised that he would check and report on the matter.

Question Alderman Sullivan Re: Chip Sealing on Hennessey Place and Stairs Place

Alderman Sullivan asked that staff clean up the chip sealing on Hennessey Place and Stairs Place.

Council, March 30, 1978

Question Alderman Sullivan Re: Spring Clean Up Day

Alderman Sullivan asked if a spring clean up day has been scheduled for this year.

Mr. Calda advised that staff are checking with the other municipalities for a uniform date which will probably be during the middle of May.

Question Alderman Maley Re: Lighting on Tower Road South of South Street

Alderman Maley stated that during the past few weeks it has been drawn to her attention that there is very bad lighting on Tower Road south of South Street due to the construction of two apartment buildings in the area as well as the replacement of poles. She asked that staff submit a report on alternative lighting while the changes are taking place.

Question Alderman Maley Re: Availability of Staff Reports During Meetings of Council

Alderman Maley stated that she has been advised by some members of the public that they find it difficult to come to the centre table to pick up staff reports on matters being considered at meetings of City Council and she asked that some copies of staff reports be made available in the hallway outside the Council Chamber for the convenience of the public.

The Acting City Manager advised that reports would be made available as requested.

Question Deputy Mayor Shannon Re: Street Cleaning

Deputy Mayor Shannon asked when the street cleaning program would commence.

Mr. Calda advised that the street cleaning program commenced on Tuesday, March 28, 1978.

Question Deputy Mayor Shannon Re: Bus Shelter outside of City Hall

Deputy Mayor Shannon stated that some weeks ago she asked about the possibility of recessing a bus shelter

in the wall outside of City Hall, possibly where the Police Garage is. She stated that the staff report subsequently circulated did not refer to the aspect of recessing the bus shelter and possibly her question was misunderstood. She stated that if the garage door was lifted up it might be possible to build a bubble in where the garage door is so that people could stand back off the sidewalk and be sheltered from the weather.

The Acting City Manager stated that the previous question was misunderstood and the request will be considered.

Question Deputy Mayor Shannon Re: Low Water Pressure on Vernon Street between Watt Street and Coburg Rd.

Deputy Mayor Shannon asked that staff contact the Public Service Commission re the low water pressure on Vernon Street between Watt Street and Coburg Road.

Question Deputy Mayor Shannon Re: Street Repairs at Northeast Corner of Norwood and Bloomingdale Streets

Deputy Mayor Shannon asked that a hole at the northeast corner of Norwood and Bloomingdale Streets be repaired within the next few days.

The Acting City Manager advised that the repairs will take place.

Question Alderman Meagher Re: NIP Program Replacement and Related Information

Alderman Meagher asked that staff investigate to determine what replacement will be available for the NIP Program, how soon the replacement will be available, and provide any information pertinent to his request earlier in the meeting that a particular area be included in a NIP program.

Question Alderman Meagher Re: Paving of Willow Street

Alderman Meagher asked if it is intended to repave Willow Street between Windsor Street and Chebucto Road.

Mr. Calda advised that he will check on the matter

Question Alderman Meagher Re: Fire at St. Mary's Bowling Green

Alderman Meagher asked if a recent staff information report re the fire at St. Mary's Bowling Green had been forwarded to the Bowling Club and, if not, that it be sent to Mr. Mel Neilly on MacDonald Street.

Question Alderman Moore Re: Wanderers Grounds

Alderman Moore asked that a staff report be issued prior to the next regular meeting of City Council re the improvements to the Wanderers Grounds, what the schedule will be with respect to the installation of the lights, and when the Senior Hardball league can expect to schedule their games there.

The Acting City Manager advised that it is intended to submit a report to the meeting of Committee of the Whole Council scheduled for April 19, 1978.

Question Alderman Hanson Re: Installation of Sidewalks - St. Margaret's Bay Road - North Side

Alderman Hanson asked that the item in the capital budget for 1979 "Installation of Sidewalks -St. Margaret's Bay Road - North Side - from Keating Road to the Armdale Rotary" in the amount of \$28,000.00, be added to the priority list which Council set up earlier if funding is available.

His Worship advised that an initial approach has been made in this matter but not at this point to this particular Minister and suggested it would be an added encouragement if City Council would endorse the principle of the idea.

MOVED by Alderman Moore, seconded by Alderman Maley that His Worship, through his Office, make representation to the Minister of Municipal Affairs for the Province of Nova Scotia for consideration of Capital City legislation which would provide additional revenue over and above the present grant structure to the City of Halifax in view of the fact that the City of Halifax is the capital city of the Province and is thereby called upon to provide facilities, infrastructure, etc. that it might not otherwise be required to provide. Motion passed unanimously.

School Avenue -- Alderman Moore

Alderman Moore stated that it has been brought to his attention that land is for sale on the western extreme of School Avenue which would be helpful if the City could acquire the lot of land and construct a proper cul-de-sac to allow proper turning of vehicles and trucks servicing the houses on that Street. He stated it is his understanding that the owner is prepared to accept a very reasonable offer from the City of Halifax. He stated he would advise the Acting City Manager of further details re the matter.

PUBLIC MEETING M I N U T E S

> St. Mary's School Gymnasium 5614 Morris Street Halifax, N. S. April 4, 1978 7:50 P. M.

A Public Meeting was held on the above date.

Present: His Worship the Mayor, Chairman; Deputy Mayor Shannon, and Aldermen Maley, Wooden, Hanson, Moore, and Downey.

Also Present: City Clerk, Director of Planning, and other staff members.

The meeting was called for the purpose of discussing the:

Old South End Neighbourhood Improvement Program Concept Plan & the Detailed Rehabilitation Development Plan

A draft document entitled "Old South End Neighbourhood Improvement Program Concept Plan and Detailed Rehabilitation Development Plan", was submitted as well as a staff report dated February 27, 1978.

His Worship advised that the purpose of the meeting is to discuss and exchange views with the public with respect to how the public feels Council should respond to the concept and detailed rehabilitation development plan submitted to Council by the NIP II Core Committee. His Worship then proceeded to introduce members of Council and City staff in attendance.

His Worship questioned how those in attendance wished the meeting to proceed and called for a show of hands in an attempt to ascertain the number of people who felt they considered themselves to be reasonably familiar with the submitted document, which revealed that approximately onehalf of those present were familiar with it. His Worship then suggested that perhaps some time should be spent outlining the contents of the document.

Mr. Gordon Hebb, Chairman of the Nip II Core Committee, then addressed the meeting and briefly outlined the contents of the two parts of the document, one of which dealt with the the Neighbourhood Improvement Program and Concept Plan and the other dealing with the Detailed Rehabilitation Development Plan.

His Worship then advised that a limited number of copies of the staff report on the review of the document were available which he distributed among those present.

Public Meeting April 4, 1978

Mrs. Renata Kartsaklis of the Planning Department then addressed the meeting and briefly outlined the staff report as it relates to the Neighbourhood Improvement Program and Concept Plan section of the document which was followed by a brief review of the staff report by Mr. Richard Matthews, Director of Planning, as it relates to the Detailed Rehabilitation Development Plan section of the document and briefly responded to questions put forth.

His Worship, at this time, suggested that both the NIP II Core Committee and Council made a slight miscalculation and suggested it was assumed there was a wider and more general knowledge about the intricacies of the subject than appear to be evident at tonight's meeting.

His Worship expressed some concern about the document being widely distributed saying it could be re-printed in about one week and suggested it be distributed in the community which would take about another two weeks following which another public meeting could be held.

His Worship and members of staff then responded to some questioning put forth and one resident of the area felt that some flooding occurs in the area of Morris and Brenton Streets during heavy rains and asked whether improvements to the sewers could be carried out under the Plan.

His Worship advised that such improvements were possible and in reply to a question, the Director of Works indicated that staff were not aware of any major problems in the area but advised that if he could be informed of the particulars, the matter would be checked. His Worship then requested that the Director of Works meet with the gentelman during the meeting on the matter. His Worship suggested that those present express views on the general concept of the NIP Core Committee Plan.

Mr. Roger Dial addressed the meeting and spoke in favour of the controls for the area as proposed by the NIP II Core Committee report and in referring to the staff review of the report, asked whether height restrictions and the elimination of lot consolidations was unfair as a land-use tool, which the Director of Planning responded to in relation to the comments contained in the staff report.

The Director of Planning responded to further questions put forth and Mr. Linden Watkins addressed the meeting on the matter and urged the people of the area to support the Plan.

A citizen of the area expressed appreciation to the Core Committee for their work and spoke with respect to the inconveniences caused by high-rise buildings.

Public Meeting April 4, 1978

Mr. Arthur Speed, a property owner in the NIP II area, addressed the Committee and submitted and read a report entitled "NIP II Neighbourhood Improvement Program Concept Plan, and Detailed Rehabilitation Development Plan", dated April 4, 1978, a copy of which is in the official file of this meeting.

One gentleman referred to the staff comments in the staff report in relation to height restriction that small shoe-box three storey developments might be increased, and suggested that staff have a legitimate concern. He suggested that if the plan is adopted, consideration be given to a design Committee to control what goes in any new development and it be compatible with the historic nature of the block.

Mr. Alan Ruffman addressed the meeting with respect to the matter of lot consolidations and made the suggestion that lot consolidations be controlled by a Zoning Bylaw if it is not possible to deal with them from a planning point of view. He suggested that provision be included in a Bylaw to the effect that a building not be permitted on a lot which is greater than a certain size, and His Worship advised that the matter is presently being reviewed.

Another speaker also expressed concern about the loss of tax monies if building is to be restricted.

Mr. Frank Medjuck addressed the meeting on the matter and requested that whatever the results of the process are, that they be plain and easily understood.

Alderman Maley addressed the meeting and suggested that many people have missed one important point with respect to the NIP area and that is that it is about the only area left of what could be considered the Old Halifax. Alderman Maley said it is a very special area to the entire City and to the Province and is unique to North America which is partly the reason it became a NIP area.

Alderman Maley suggested the area has accepted about as much development as any area can accept socially and felt there has to be controls in order to proceed with the Neighbourhood Improvement Program.

His Worship then suggested a way to proceed would be to reprint the document and circulate it to all residents by way of a delivery from door to door and that a second public meeting held in St. Mary's School Gymnasium three weeks from tonight. His Worship advised that the matter would go to the Committee of the Whole Council meeting on May 3rd with the intention of being submitted to the Council on May 11, 1978. His Worship later noted a public hearing would have to be held in the process with respect to a D.R.D.P.

It was asked if a copy of the report containing the staff comments could be distributed as well, and His Worship indicated this could be done.

Public Meeting April 4, 1978

One speaker asked if it would be possible to receive information from C.M.H.C. for the next meeting in relation to a R.R.A.P. program for the area and following some discussion of the matter, His Worship indicated he could not speak for C.M.H.C. as the matter had not been discussed but advised that statistical information would be brought to the next meeting on the subject.

A short discussion ensued with respect to notifying property owners of the next meeting and Mr. Hebb of the Core Committee advised an effort was made to notify assessed owners in the NIP area of tonight's meeting and expressed the hope the same procedure would be followed for the next meeting.

His Worship then advised those present that the registered owners of properties in the NIP area would be informed of the next meeting.

Page III - 171 - Halifax Visitors & Convention Bureau

A supplementary budget summary dated March 23, 1978 was submitted.

Messrs. Robert Chisholm, Director, Halifax Visitors and Convention Bureau, and Mr. Donald Gillis, Chairman, Visitors and Convention Committee, presented the proposed current estimates for the Halifax Visitors and Convention Bureau and responded to questions from members of Council.

Alderman Meagher entered the meeting at 10:00 a.m.

Mr. Calda stated that he would investigate their usefullness while in Ottawa in the near future.
