Alderman Maley asked that when the Commission is preparing the report that the contract be reviewed as she recalled that questions re acoustics were raised when members of City Council toured the building and were assured at that time by the architect or his representative that acoustics would present no problem. She suggested that there might be something in the contract that they could be asked to rectify.

MOVED by Alderman Wooden, seconded by Alderman Hanson that proposed Ordinance No. 137, respecting Deferral of Tax Payments, be now read and passed a Second Time as amended.

The City Manager advised that staff are concerned that a limit be placed on the total tax deferred in time and it is suggested that the limit be the maximum assessed value of the property. Motion passed.

Approval of an Amendment to Ordinance Number 116 respecting the Regulation of Vehicles Transporting Passengers for Hire

A staff report dated June 29, 1978 was submitted by the City Solicitor.

MOVED by Alderman Sullivan, seconded by Alderman Clarke that City Council, pursuant to Section 146 of the City Charter, adopt Ordinance Number 116 with the amendment to Section 17 as suggested by the Minister of Municipal Affairs. Motion passed.

Brunswick Street Housing and Heritage Conservation Area (Non-Profit Housing)

Deputy Mayor Shannon stated that there is some urgency in bringing this matter forward at this time in that changes seem to be taking place in CMHC programs and it was felt that the incorporation is desirable so that the City could approach CMHC as quickly as possible to obtain some committment of funds under the existing programs.

Mr. Barry Allen, Solicitor, and Mr. Doug Corkum, Development Department, responded to questions from members of City Council.

Alderman Moore urged that the proviso that the corporation be used specifically for the refurbishing of the existing houses in the Brunswick Street Housing and Heritage Conservation area be inserted in the Memorandum of Association. Mr. Allen suggested that the appropriate place to insert such a proviso would be in Section 2 of the Memorandum of Association which lists the objects of the Society. He pointed out that it would be subject to the possibility of a change in the objects by the passing of an appropriate resolution by the membership of the Society.

It was agreed that staff include in Section 2 the requested proviso.

It was agreed that the bylaws be amended to provide that the Society deposit regularly summaries of transactions with City Council, that Section 3 of the bylaws be amended to replace the number fourteen with the number seven, and that the Auditor for the Society be the Internal Auditor for the City of Halifax.

MOVED by Deputy Mayor Shannon, seconded by Alderman Downey that City Council approve the memorandum of association and bylaws, as amended, subject to CMHC's approval, and, that Council appoint members to the municipal non-profit housing corporation. Motion passed.

#### QUESTIONS

# Question Alderman Lawrence re: Dunbrack Street -Recreational Use

Alderman Lawrence asked that the matter of the use of a portion of Dunbrack Street for recreational purposes be placed on the agenda for the next regular meeting of Committee of the Whole Council. He stated that the Recreation Department are preparing a staff report and he asked that the report be ready for July 5th as well. He stated that he has received a letter from the Ward 10 Community Association and someone has given them to understand that Dunbrack Street had been turned over to the City and they were prepared to open the Street for recreational purposes on July 9th.

The City Manager advised that Dunbrack Street it not presently City-owned, it is still under contract, and will not be available until September when the contract is finished.

Alderman Lawrence requested that the Ward 10 Association be permitted to address Committee of the Whole Council at the next regular meeting.

# Question Alderman Lawrence re: Street Cleaning

Alderman Lawrence stated that he is not happy with the street cleaning program that is taking place this year and noted the refuse, garbage and debris in the general area of Kempt Road, Lady Hammond Road, and Windsor Street, north Barrington Street and South Street. He requested a staff report on the scheduling of the sweepers and, in the meantime, that the noted areas be cleaned up.

Question Alderman Lawrence re: Safety Measures at City Field

Alderman Lawrence stated that he has recently witnessed a City worker using a saw with a carbon blade cutting cement without using any facial shield. He also noted that hard hats are not being used at construction sites. He asked that a staff report be submitted on who is responsible for safety measures, can they be enforced by the City.

## Question Alderman Lawrence re: Atlantic Winter Fair

Alderman Lawrence asked if City Council could, or should, at this time, endeavour to bring all parties together for another meeting to determine whether the Atlantic Winter Fair will work at the Metro Centre.

His Worship briefly commented on recent events concerning the Atlantic Winter Fair and asked that he be given more time to consider the matter.

## Question Alderman Sullivan re: Sewer at Barrington and Duffus Streets

Alderman Sullivan requested that staff from City Field visit the location tomorrow and contact him re what is the problem with the sewer at the foot of Barrington and Duffus Streets. He asked that it be checked out by a foreman or other staff member each day especially during the hot weather and that the situation be corrected.

Alderman Sullivan further requested that the City Manager give some indication of when the report which was dealt with a few months ago will be coming back to City Council.

Question Alderman Sullivan re: Construction of the Building at Fort Needham

Alderman Sullivan asked when construction will commence on the building at Fort Needham. The City Manager advised that the tender call will be issued within two or three days, it will take approximately three weeks to award, and construction should start shortly thereafter.

Question Alderman Sullivan re: Gate at Fort Needham on Gottingen Street side across from Stanley Place

Alderman Sullivan stated that for the past year and a half an opening has been left in the fence on the Gottingen Street side of Fort Needham across from Stanley Place in order to determine the extent of usage it would have. He stated the usage is considered extensive and asked for a staff report on the installation of a gate at that location.

Alderman Lawrence retired from the meeting at 12:15 a.m.

# Question Alderman Sullivan re: Trimming of Trees -Russell Street and Albert Street between Devonshire Avenue and Young Street

Alderman Sullivan stated he has been advised that trees are blocking the street lights on Russell Street and on Albert Street between Devonshire Avenue and Young Street. He asked that staff from Parks and Grounds visit the area and resolve the matter.

# Question Alderman Maley re: Sidewalk opening on South Street

Alderman Maley referred to a sidewalk opening on South Street in front of a small apartment building next to the Workmen's Compensation site. She stated that this building has been occupied for approximately two months and the sidewalk has been in an atrocious condition since before the snow started and it still has not been closed. Alderman Maley asked that staff consider the possibility of the opening and closing of streets as a condition of obtaining an occupancy permit.

She further requested that action be taken to repair the sidewalk as it is located at a bus stop and it has been reported that citizens have fallen because of the sidewalk opening.

# Question Alderman Maley re: Demolition Controls

Alderman Maley stated that a year or two ago some preparatory work was being done by the Legal Department on demolition controls and she asked for a copy of what has been prepared. She noted that she had requested this information previously and has not received it to date.

Question Alderman Maley re: Pinball Machine in Corner Store on South Street

Alderman Maley requested a report from the Legal Department on the legality of a pinball machine located in a Green Gables corner grocery store on South Street.

## Question Alderman Maley re: Conflict of Interest

Alderman Maley requested that she receive a copy of the staff report being prepared by the Legal Department re conflict of interest.

Question Alderman Downey re: Swimming Pools on the Commons

Alderman Downey asked when the swimming pools will be opened on the Commons.

The City Manager advised that the pools will not be opened this season and a written report will be issued on the matter.

Question Alderman Meagher re: Financial Statements for 1977

Alderman Meagher asked when Council members will receive the financial statements from the external auditors for the year 1977, and whether a meeting will be held on the said subject with members of Council.

The City Manager advised that the financial statements will be circulated shortly and a meeting will be held.

Question Alderman Wooden re: Amendment to Cowie Hill Agreement re Playfields

Alderman Wooden requested that staff prepare a report as soon as possible re an amendment to the Cowie Hill agreement on the matter of taking over the playfields in that complex.

Question Alderman Wooden re: Paving of Lieblin Drive

Alderman Wooden asked when this year would Lieblin Drive be paved.

The City Manager advised that the paving of Lieblin Drive is part of the program which is underway at the present time. He stated he would advise of the specific date.

#### Fairmount

His Worship briefly referred to meetings of City Council held in July 1977 and subsequently when the matter of the Fairmount Subdivision was discussed. His Worship noted that Alderman Sullivan did not pursue that course of action.

His Worship said he has been advised by the City Solicitor that the document has been fully executed by the City and sent forward on Monday saying the Council action authorized on June 29th has been carried out.

The Motion was put and lost with Deputy Mayor Shannon, and Aldermen Maley, Wooden, Hanson, Moore, and Lawrence against.

# PUBLIC HEARINGS, HEARINGS, ETC.

An Appeal of the Refusal of a Lord's Day Permit -The Seachest on the Wharf

A letter dated July 5, 1978, was submitted from the Secretary Treasurer of The Sea Chest appealing the refusal to grant an application for a Lord's Day Permit.

Mr. Richard Ratcliffe, Secretary Treasurer of The Sea Chest, indicated he did not wish to address Council on the matter.

His Worship noted that the application was refused as the Business Occupancy assessment of The Sea Chest exceeded that permitted in Ordinance No. 109. His Worship suggested that the argument that Historic Properties is a mecca for tourists is correct but said it has been pointed out that the legislative capacity of the City cannot exceed the Provincial Statute saying spokesmen for Historic Properties have been advised they should seek Provincial amending legislation on the matter.

His Worship referred to amendments which were made to Ordinance No. 109 last year and suggested this application could be handled by raising the assessment limit from \$12,500 to something that would make it possible to operate but noted that if Council were to do that, it would make it possible for others to be open as well.

Alderman Maley suggested that perhaps a higher business occupancy limit should be used or the assessment matter be dispensed with in the Ordinance and the whole matter be debated again saying she was concerned that the store in question should be permitted to be open. Alderman Maley indicated she would be prepared to present a Notice of Motion at tonight's meeting with respect to an amendment to Ordinance No. 109.

Alderman Wooden asked if there are other stores of the same nature which cater to tourists which have the same difficulty, and the City Clerk advised there are other stores in the same position.

Deputy Mayor Shannon noted the matter was debated last year saying that even if the Ordinance were amended, there are stores that would not come under the Provincial Legislation and suggested there is nothing the City could do until an application was made to the Province.

His Worship suggested that Council could take care of the particular store making application and some others by raising the assessment limit.

Alderman Moore asked if the Tenants' Association at Historic Properties have made representation to the proper Provincial authorities seeking an amendment to the Lord's Day Act and His Worship said he could not answer the question for the present year but said that for earlier periods, representations were made. The City Manager advised that staff would make a formal enquiry of Historic Properties in order to determine whether an approach was made to the Province or not.

Further discussion ensued and <u>it was MOVED by</u> <u>Alderman Maley, seconded by Alderman Lawrence that staff be</u> asked to present a report as quickly as possible to achieve amendment of the Lord's Day Ordinance No. 109 in such a fashion as to allow the liberalization of permits to tourist related operations as set out in Section 3 (1) (c) of Ordinance No. 109 and, that Alderman Moore's request be followed up by staff to determine if Historic Properties has made representations to the Provincial Crown with respect to an Amendment to the Lord's Day Act.

Following a short discussion, the Motion was

put and passed.
