2. Council authorize staff to implement this project in 1978 on the understanding that a portion of the work is included in and is being carried out in advance of the 1979 Spending Program.

Alderman Meagher said he wanted to make sure residents along Windsor, Williams, and Robie Streets are notified of the project and that construction will result in the least amount of disturbance possible to the residents.

Alderman Meagher also noted that the staff report refers to a sewer extension across the Commons saying he was concerned about the project and the proposed expenditure saying he would like a report from staff with respect to the necessity of the project and also proving the large expenditure proposed.

His Worship advised that such a report could be submitted but noted the matter was debated during the Capital Budget and that staff have included in the budget what Council directed.

Motion passed.

Possible Acquisition - 341 Herring Cove Road

The above noted item was referred to staff for a second appraisal on the subject property at the Finance Committee meeting of July 5, 1978.

A supplementary confidential staff report dated July 11, 1978, was submitted.

MOVED by Alderman Wooden, seconded by Alderman Hanson that the property of Kathleen Pearl Stevens, known as Civic No. 341 Herring Cove Road, be purchased for the amount shown in the confidential staff report of June 20, 1978 as settlement in full, funds available from Account No. 806 449 HAF09, Land for Municipal Purposes.

A supplementary staff report dated July 12, 1978 was submitted.

Alderman Maley stated that, in her opinion, the contract as submitted in the supplementary report of July 12, 1978, does not fulfill the Municipal Development Plan, the NIP Concept Plan nor the DRDP.

NOTICE OF MOTION

Notice of Motion - Alderman Maley Re: Amendment to Ordinance No. 109 Respecting the Opening of Stores, Canteens, Fruit Stands, Laundromats, Billiard Halls and Pool Rooms on the Lord's Day

Alderman Maley gave notice that at the next regular meeting of City Council of the City of Halifax, to be held on the 27th day of July, A.D. 1978, she proposes to introduce an amendment to Ordinance Number 109, the Lord's Day Ordinance.

She stated the purpose of the amendment is to provide an easement of the requirements of section 3(1)(c) which deals with tourist related stores to allow such stores to open on a Sunday.

ADDED ITEMS

Street Cleaning - Alderman Lawrence

Alderman Lawrence stated that he had previously requested that staff clean the area of Kempt Road, Lady Hammond Road and Windsor Street, He suggested that it has not taken place and the street cleaning program has not improved the situation. He requested that the matter of street cleaning be placed on the agenda for the next regular meeting of Committee of the Whole Council.

Alderman Lawrence further referred to areas of the Bicentennial Highway, Dutch Village Road, the extension of Barrington Street, the approaches to the Bridges, Spring Garden Road opposite the YMCA and the Lord Nelson, and asked that some cleaning take place in such areas prior to the Committee of the Whole meeting.

He requested that staff provide for the Committee of the Whole meeting a schedule on where the street cleaning machines go, how many times a month they clean certain streets, etc.

Grass Cutting - Alderman Lawrence

Alderman Lawrence stated that the matter of grass cutting is related to the foregoing item and asked that it also be placed on the agenda for the next regular meeting of Committee of the Whole Council. He requested that a schedule for grass cutting in public areas and playgrounds be submitted and that more grass trimming be done prior to the Committee of the Whole meeting, particularly at the overpass and entrances to the City.

Interceptor Sewer - Duffus and Barrington Streets -Alderman Sullivan

Alderman Sullivan expressed his dissatisfaction with a staff information report dated June 30, 1978 re the odour problem associated with the interceptor sewer at Duffus and Barrington Streets. He stated that, as a result of a staff report dated March 21, 1978, it was his understanding that a direction was given to staff to bring forward a recommendation as to what had to be done at the site to eliminate the odour problem as well as what funds, if any, would have to be designated in the capital budget. He stated that the staff information report dated June 30, 1978 indicates to him that nothing has been done since March when the matter was originally brought up.

Alderman Sullivan stated he discussed the matter with the Acting Director of Engineering and Works yesterday and requested some assurance from the City Manager that there is going to be some action on the matter.

The City Manager advised that he has authorized hiring a consultant to bring forward a recommendation for rectification of the problem and the process will commence shortly.

His Worship asked that the City Manager determine whether Alderman Meagher's representation of last year to have the federal authority consulted about the possibility of doing some dredging in the head waters of the North West Arm was able to be prospered at that time or can it be prospered now.

Alderman Hanson advised that he has received a memorandum dated July 5, 1978 from staff which indicates that a report is being prepared on the matter.

Intersection - Abbott Drive and Ashburn Avenue - Alderman Moore

Alderman Moore stated that he has previously requested that a four-way stop be installed at the intersection of Abbott Drive and Ashburn Avenue and, for various reasons, was informed by staff that it could not be done. He advised that last night the third accident in three weeks has occurred at the intersection.

He advised that one set of stop signs are located intersection but the visibility of one of the signs is curtailed by tree growth. He stated that a very large hedge at the northeast corner of the intersection obstructs

the visibility of motor vehicle drivers as well.

Alderman Moore requested that staff initially improve the visibility problems at the intersection with a view to installing a four-way stop control at that location.

Demolition - Kent Street - Alderman Maley

Alderman Maley stated that the demolition of three buildings on Kent Street has been underway for the past two weeks and at this time not one building has been fully removed. She stated that the products from the demolition are being stacked on the sidewalk.

- Alderman (Deputy Mayor) Brenda Shannon, Alderman Dan Clarke and Mayor Edmund Morris be appointed to the Metropolitan Authority of Halifax, Dartmouth and the Municipality of the County of Halifax for terms to expire October 31, 1980;
- Alderman (Deputy Mayor) Brenda Shannon and Edwin C. Harris, Q.C. be appointed to the Metropolitan Transit Commission for terms to expire October 31, 1980.

Motion passed.

Property Acquisitions

REPORT - COMMITTEE ON WORKS

Council considered the report of the Committee on Works from its meeting held on July 19, 1978 as follows:

Rockingham North Sewers

A staff information report dated July 26, 1978 was submitted.

It was agreed that the City Clerk arrange a tentative public meeting re Rockingham North services for Thursday, September 7, 1978 at Grosvenor-Wentworth School.

Petition - Oxford School Parent-Teachers Association

A supplementary staff report dated July 25, 1978, was submitted.

Mr. Fred Bradbrook, Engineering and Works Department, advised various traffic counts on streets in the area affected by the proposed temporary closure. He suggested that there will not be undue pressure on streets in the area in view of the said traffic counts.

Alderman Clarke requested that staff do a traffic count during peak hours prior to setting up the proposed barrier and three months after its installation a comparison be made to determine how traffic has increased on Dublin Street.

MOVED by Alderman Meagher, seconded by Alderman Clarke that, as recommended by the Committee on Works, staff install a tremporary closure of Willow Street where it intersects Chebucto Road and, further, staff be asked to include in the proposed 1979 Capital Budget a design for, and funding for, a permanent cul de sac in approximately the same location, to be so designed so as not to require the acquisition of any private property in the area.

Alderman Meagher requested that residents on Willow Street from the proposed site to Windsor Street, and residents on Chebucto Road from the proposed site to Windsor Street, be advised by letter of the street changes.

The motion was put and passed.
