Reference was also made to a suggestion by Alderman Sullivan with respect to the signs being installed in a consistent location on the vehicle and in reply to a question, the City Manager advised the specific suggestion was not made to the Province as staff are still continuing discussions with the Province on the matter. He advised that a request has been made that the City be informed of the proposed legislation hopefully before it is advanced through proper channels.

In reply to a question from the Chairman, the City Manager advised that in addition to staff discussions, a letter would be forwarded to the Province on the matter and copies of the correspondence would be circulated to members of Council.

Motion passed.

REPORT - COMMITTEE OF THE WHOLE COUNCIL, BOARDS & COMMISSIONS

Tax Concessions and Grants Committee - Ordinance Number 170 - SECOND READING

The above noted matter was read a second time by the Committee of the Whole Council on August 9, 1978.

The proposed amendment to Ordinance No. 170, was submitted.

Deputy Mayor Shannon noted that staff were to respond to a number of questions raised at the Committee of the Whole Council meeting and Mr. B. G. Smith, the Director of Finance, advised that the Loyal True Blue Association, 2788-80 Isleville Street, is no longer in operation at that address in which case the concession would not be granted.

Council then agreed that the Loyal True Blue Association, 2788-80 Isleville Street, be deleted from the proposed amendment.

Mr. Smith then made reference to the Elks Club, 1459 Hollis Street, and St. Paul's Church Hall, 1718 Argyle Street, and advised the same situation applies to both groups saying that where a property is demolished during the year, or is substantially changed, taxes are not reduced until the first of the following year. He suggested that both organizations would appreciate any reduction by way of inclusion in the Ordinance, which Council can grant.

Deputy Mayor Shannon suggested that Council could expect to see the properties deleted from the amendment for next year and Mr. Smith noted it was possible that one of the groups may intend to re-build.

Deputy Mayor Shannon also noted that the R. N. Yacht Club was to be changed to read the Royal Nova Scotia Yacht Squadron, and Mr. Smith advised that this would be done but pointed out that the names of some of the organizations may not be truly accurate and was meant to identify the property saying staff have understood which property was referred to in the past.

Mr. Smith advised, however, that the Spryfield Lions Club, should be shown at the address "Lot A, Drysdale Road", and the address for the N. S. Society for the Prevention of Cruelty, should be shown as "5731-5737 McCully Street", to which Council agreed.

In reply to a question, Mr. Smith also advised that the property of the Royal Order of Buffaloes, 5530 North Street, was sold in September of 1977 and Council agreed that the organization should be deleted from the proposed amendment.

Discussion ensued with respect to a review of groups other than religious or charitable being included in the Ordinance for next year and Alderman Downey in referring to the Halifax Civic Workers' Local 108, 5553 Bloomfield Street, said it is his understanding the group has purchased the Loyal True Blue property across the street and asked why the City would be granting a concession to the group if they had sufficient funds to purchase such a property.

Discussion ensued on the matter and Alderman Sullivan noted that when the City originally gave the concession, the offices of the Civic Workers was located in the subject property but they are now located on Hillside Avenue with the other property being used as a club.

Alderman Downey suggested the matter should be investigated and a further report submitted and Mr. Murphy indicated the rest of the organizations could be approved with the 5553 Blookfield property being subject to a further report saying that if the report is favourable, the property could be forwarded to the Minister as an addendum to the amendment and Second Reading could be given at the next Council meeting, to which Council agreed.

MOVED by Alderman Meagher, seconded by Alderman Sullivan that the proposed amendment to Ordinance No. 170, the Tax Conscessions Ordinance, be read and passed a Second Time, as amended.

Wooden that: MOVED by Alderman Clarke, seconded by Alderman

1. In future, the City require written applications for inclusion in Ordinance #170 stating reasons why any particular group or organization feels a concession should be granted as well as audited financial statements for the current or prior year and a copy of Charters or objectives or purposes of the organizations;

2. Staff be asked to bring forward a policy to be used in reviewing applications for inclusion in Ordinance #170; and

3. Staff notify the groups listed in Ordinance #170 advising that it is not to be assumed that the concessions granted for 1978 will be granted in 1979 because of the review of the policy.

Motion passed.

Amendment to Ordinance Number 109 Respecting the Opening of Stores, Canteens, Fruit Stands, Laundromats, Billiard Halls, and Pool Rooms on the Lord's Day - SECOND READING

Proposed amendments to Ordinance No. 109 were submitted which were read and passed a second time by the Committee of the Whole Council on August 9, 1978.

<u>MOVED by Alderman Maley, seconded by Alderman</u> <u>Clarke that the amendments to Ordinance No. 109, as submitted,</u> be read and passed a Second Time.

Motion passed.

Alderman Downey suggested that past attempts have been made to have the Government place a freeze on rents saying it was also his understanding the expenditure cuts were not to affect people on Old Age Pensions or those with low incomes.

Alderman Downey asked if the Social Planner could advise if he is aware of any proposal with respect to a rent freeze or whether representations could be made to the Government to that effect.

Mr. Crowell addressed Council and noted that staff tested the proposal once before saying the reaction of C.M.H.C. was that they were not prepared to consider any type of freeze at all. Mr. Crowell advised that when the Province instituted rent freezes, C.M.H.C. said they would not share in the increased cost to the Housing Authority and that the Province would have to totally bear such increases.

Mr. Crowell also advised that when this years Housing Authority budget was passed by Council and the Province, C.M.H.C. cut out certain items saying he would not be optimistic the Corporation would put on freezes that would in any way reduce revenues coming to the Housing Authority. Mr. Crowell advised, however, that he would ask the Board to request C.M.H.C. to consider the matter.

Question Alderman Downey Re: Pipe on Sidewalk - Corner of Creighton and Cornwallis Streets

Alderman Downey said that this evening, he noticed a pipe at the above noted location which runs from a hydrant to Maitland Street which is covered with a wooden board and asked if the City would be liable if someone were to trip and fall as a result of it being there. Alderman Downey advised that it runs for about two blocks in the area.

The City Manager advised that the matter would be checked into immediately.

Question Alderman Clarke Re: Municipal Employment Program - Second Phase

Alderman Clarke asked if the City is involved in the second phase of the Municipal Employment Program and the City Manager advised that the City is not involved in Works programs but is involved in the area of community services. Mr. Calda advised that the City has applied for certain programs.

Alderman Clarke noted a sidewalk is not located at the above location and asked whether past consideration has been given to the installation of one.

The City Manager advised that staff would investigate the matter and asked whether staff could take the question as a request to include a sidewalk proposal at that location in the Capital Budget, and Alderman Clarke replied in the affirmative saying he would like the matter looked at. Alderman Clarke also requested an information report on the subject.

Question Alderman Sullivan Re: Union Street from Civic No. 3276 to Dartmouth Avenue - Repairs

Alderman Sullivan said he would like staff to give consideration to the above noted area saying that every time repairs are carried out on Union Street such as curb and gutter, and sidewalks, the work always stops at the end of the built-up area and nothing is ever improved from the area around Fort Needham to Dartmouth Avenue.

Alderman Sullivan said the roadway and particularly the curb and gutters are in a bad condition suggesting it is time the area was reviewed with a view to including a proposal in the budget.

The City Manager advised that staff would investigate the matter.

Alderman Sullivan said he would also like to see included in the report any of the negative things which the City Manager feels may occur as a result of the combination of the two Departments and asked that it be submitted as quickly as possible.

The meeting was called for the purpose of:

Ratifying Arrangements for Municipal Taxing of the Assets of the Halifax Shipyards

His Worship spoke to the matter and noted that late last Spring, the Province asked the City whether it would be sympathetic to giving some consideration, if the Province were able to find a new operator for the Halifax Shipyards, saying he was authorized by Council to advise that if required, the City would give sympathetic consideration.

His Worship noted that at that time, no amount was determined other than the principle of sympathetic consideration saying he communicated with the Province and the Province, therefore, utilized that understanding in seeking new operators.

His Worship advised that when the Province designated the present consortium, certain proposals were made to the City which he proceeded to outline. His Worship said that with the knowledge and authority of Council he wrote to Mr. Single on August 24, 1978 advising that the proposal which Mr. Single made in writing the previous day was not acceptable to Council but that Council was prepared to provide, subject to the Province providing any legislative authority that may be required, that municipal taxes would be payable at the then current Business Realty Rate applied on the assessed value of the land only, for each of the five years commencing in 1979 and including 1983.

Special Council August 29, 1978

His Worship said the letter advised that commencing in 1984, municipal taxes would be levied and payable at full levels in the normal way and in addition, the Fire Protection Rate would apply in the normal way to total assessment throughout. His Worship further noted that the letter advised that this arrangement would be required to be transferable should the ownership of the Halifax Shipyard assets vest with the Province or a new owner during all or any part of the term of the agreement.

His Worship then referred to a letter which he received from Mr. Single dated August 29, 1978 which he read to members of Council. The letter, in part, advised that the City's counter-proposal was discussed with the company that will be operating the Halifax Shipyards and they have advised that they are agreeable to the City's proposal.

His Worship suggested that the correspondence from the Mayor dated August 24, 1978, and Mr. Single's reply dated August 29, 1978, constituted the whole arrangement before Council and should be considered to be the public documents. His Worship further suggested that the way to handle the matter would be to have a motion that Council affirm and ratify the exchange of correspondence.

Quotation 517938 - Landscaping Chocolate Lake Community Recreation Centre

A staff report dated August 28, 1978, was submitted.

MOVED by Alderman Hanson, seconded by Alderman wooden that a contract be awarded to the lowest bidder meeting specifications, D. Coupar Landscaping Ltd., to supply all labour and materials to landscape 4,300 sq. yds. at the Chocolate Lake Community Centre for the contract price of \$12,684.00.

Motion passed.

QUESTIONS

Question Alderman Wooden Re: Sidewalks on Leiblin Drive

Alderman Wooden advised that she is having some problems with respect to constructing a sidewalk on Leiblin Drive saying she would like to receive a report from staff on the pros and cons of area rates as opposed to abuttors charges.

Question Alderman Maley Re: Street Excavations

Alderman Maley referred to excavations on Robie Street and suggested the area requires better illumination saying she would like the Company concerned to be contacted on the matter and to also declare indications of where the traffic is to go. She said the one side of the boulevard is completely closed with there being two lanes of traffic on the other side from University Avenue to South Street and expressed the feeling that the situation is not clear to motorists.

Alderman Maley also referred to work taking place on South Street between Queen Street and Tower Road and suggested the Street should be closed until it is paved. She suggested that only one-half of the Street is able to be used, traffic signs are poor, and there are no lights in the area. Alderman Maley said the situation is extremely dangerous and felt that staff should review the matter tomorrow.

Question Alderman Maley Re: Truck Traffic - Inglis Street

Alderman Maley said trucks are again using Inglis Street as a truck route to Beaufort Avenue and onto Oxford Street which, she suggested, are mainly CN trucks. Alderman Maley advised, however, that she has observed the odd container truck using the route and suggested a letter should be forwarded to the appropriate party to have the practice stopped.

Question Alderman Maley Re: Bicycle Legislation

Alderman Maley advised that she has received many calls with respect to why bicycles are not required to have lights at night. Alderman Maley said she would like the Legal Department to look into the matter as well as the matter of bicycles being required to observe traffic signals.

Question Alderman Maley Re: Bus Stops, South Street at Victoria General Hospital

Alderman Maley noted that the Transit Corporation agreed to move one of the bus stops at the above noted location so that there would not be two stops directly opposite each other. She said that one of them was to be moved during the summer but such action has not yet taken place and felt that it should be moved before winter.

Question Alderman Downey Re: Overhead Crosswalk Signs

Alderman Downey asked to be informed as to when the overhead crosswalk signs proposed for Spring Garden Road and Brunswick Street, and Brunswick Street and Church Street, are to be installed.

The City Manager advised that staff will check into the matter and advise Alderman Downey.

Question Alderman Downey Re: Cogswell Street Interchange

Alderman Downey noted that the interchange is now open to traffic saying he was a bit surprised that the intersection was not resurfaced as there are a lot of holes. Alderman Downey asked if such repairs were included in the price for repairs.

The City Manager expressed the feeling that such an amount was not included but said that staff would check into the matter and take whatever corrective action is required.

Question Deputy Mayor Shannon Re: Accident - Jubilee Road and Henry Street

Deputy Mayor Shannon said she would like to receive a report from staff with respect to the circumstances surrounding the accident which took place at the above noted area today including information regarding what the truck was doing in the area, where a delivery was being made etc. Deputy Mayor Shannon said there is a problem on City streets of trucks of all types not observing truck routes and suggested it was time something was done about it.

Question Deputy Mayor Shannon Re: Crosswalk Repainting -Vernon Street to Watt Street

Deputy Mayor Shannon said that as a result of the above noted area being recently resurfaced, she requested that staff repaint the crosswalk before school opens.

Question Alderman Meagher Re: Truck Traffic - Connaught Ave.

Alderman Meagher said he has received complaints with respect to heavy trucks being on Connaught Avenue before 7:00 a.m. which, he suggested, is contrary to the Ordinance. Alderman Meagher referred to the area from Quinpool Road to Chebucto Road.

Alderman Meagher also referred to a show which he saw on A.T.V. about 10 to 15 days ago on air force which indicated that in communities today with the large trucks and noise which they make, it is affecting citizen's hearing saying he would like staff to see if a copy of the show could be obtained.

Question Alderman Wooden Re: Election Procedures Committee

Alderman Wooden referred to the possibility of changes in Ward boundaries and suggested that perhaps funds should be included in the capital budget in the event the boundaries are changed.

Question Alderman Hanson Re: Overhead Crosswalk signs

Alderman Hanson said he is also concerned about the progress being made with respect to the installation of overhead crosswalk signs now that school is about to open. Alderman Hanson suggested that a member of staff could get in touch with him on when it is expected a start will be made at the various locations which were requested by Council.

Question His Worship the Mayor Re: Naming of Negro Point

His Worship asked that staff look at the question of the name of Negro Point and in doing so, to consult with leaders in the black community and the Black United Front, perhaps with a view to recommending, if it is thought desirable, alternate names. His Worship said it was his impression that the City could not change the name without reference being made to the Canadian Board of Geographical Names in Ottawa.

Alderman Clarke, in referring to the possibility of a Park being located in the area, asked if staff intend to present a report on the matter and the City Manager advised that a report would be submitted in about late October.

Alderman Clarke asked if funds were being set aside for such a purpose and the City Manager suggested that such a determination would be made by Council.
