Installation of Water and Sewer Services in Rockingham North

His Worship opened the meeting saying that Council, in convening the public meeting, had a desire to have as many Aldermen and staff members as possible to attend to assist the residents in responsing to the local improvement notices which have been forwarded and to answer enquiries respecting the provision of water and sewer services.

His Worship advised that the price to the property owner of \$48.00 per linear foot is a maximum price and will not go beyond that, which was not the case in the previous notices which were forwarded in the amount of \$52.00 per linear foot which was an estimate by staff. His Worship said the reason the City knows the cost will not go above the \$48.00 figure is that it is no longer an estimate. His Worship also advised that the amount may be fractionally shaved but suggested it would not be much.

His Worship said a second thing that has come clear is that the construction work is to be completed within 25 months according to the indicated contractor's proposal and also advised that upon completion, the contractor is required to pave the street and put in asphalt curbing.

His Worship also suggested that Council would be agreeable, if the residents wished to use the monthly payment process, to blend the principal and interest saying the interest would be fixed at 10% for the life of the instalment payment period.

Alderman Meagher arrived.

Public Meeting September 7, 1978 The Chairman then introduced members of Council in attendance, City staff, and representatives of the Public Service Commission to those present. A lengthy discussion and questioning ensued with respect to the Rockingham North Services proposal and information contained in the staff report of August 21, 1978 which was responded to by the Chairman, members of City staff, as well as representatives of the Public Service Commission. Public Meeting, September 12, 1978

A letter dated September 12, 1978 was received from Michael L. Hepher, President, Halifax Board of Trade, copies of which were circulated to members of City Council.

Mr. Wayne Anesty, Legal Department, addressed the meeting and briefly reviewed the proposed changes in regulations relating to signs and billboards, as set forth in a staff report dated June 15, 1978.

Mr. G. C. Findlay, Vice-President, Maritime Provinces, Claude Neon Limited, addressed the meeting and advised that he is generally in agreement with proposed Ordinance No. 166 as presented, with the exception of Section 6, a new provision to prohibit billboard type advertising structures which, in his opinion, is discriminatory and extremely damaging to his operation as a business in the City of Halifax.

Mr. Finlay pointed out that his company contributes a quarter of a million dollars yearly to the economy of the City of Halifax. He suggested that at present the City of Halifax has a very tight control on billboards as the Zoning bylaws permit billboards only in a C-2 zone and proper application for a building permit must be made each time in order to erect one.

Mr. Clyde O'Malley of O'Malley Electric Limited, addressed the meeting and expressed his opposition to Section 6 of proposed Ordinance No. 166. Mr. O'Malley stated his support for the position of Claude Neon Ltd. in this matter as put forth by Mr. Findlay.

Mr. Dave Platt, Manager, Dominion Life Assurance Company, addressed the Committee and expressed his dissatisfaction with Section 6 of proposed Ordinance No. 166. Mr. Platt supported the submission of Claude Neon Ltd. and stated that he did not personally feel that billboards were aesthetically displeasing.

Mr. H. Blackadar, Manager of two radio stations in the City, stated that on occasion billboard advertising has been used by his company and has also been recommended by him in response to inquiries from potential customers from other cities in Canada. Mr. Blackadar expressed his support for Mr. Findlay's business operation and the position of Claude Neon Ltd. in this matter.

Public Meeting, September 12, 1978 His Worship referred to Section 5(f) of the proposed Ordinance and requested clarification that this section would also apply to campaign signs erected during municipal elections. He further suggested that the period of fourteen days in the said section be reconsidered and possibly decreased. Alderman Clarke asked when such campaign signs could be erected prior to an election. His Worship suggested that Section 17 be reconsidered in relation to the distance a sign or structure must be from a curb face or the nearest edge of a vehicular passageway or traffic lane. In response to a question, Mr. Anesty pointed out that in Section 14 of the proposed Ordinance, the Building Inspector may revoke a permit if there is a violation of any condition under which the permit was issued or any provision of the Ordinance. Alderman Wooden asked if there is provision in the proposed Ordinance to control the number and variety of signs located on a specific property. His Worship suggested that the proposed Ordinance and Zoning Bylaw provisions would control such a situation. Alderman Wooden stated that her main concerns are the location of signs on properties, a restriction of the hours of use of illuminated signs and a restriction on the extent of time a sign may be located on a property. His Worship stated that staff will be requested to consider representations made this date in respect of Section 6 of the proposed Ordinance and references to portable signage, that is, whether it is possible to have it related to some more adjacent activity rather than non-adjacent activity. Alderman Wooden further suggested that the illuminated signs not have flashing lights. The City Manager suggested that in staff reviewing the matter further for City Council, they should consider the cost benefits or positive effects of advertising on the City's economy. Motion passed.

Council September 14, 1978 REPORT - CITY PLANNING COMMITTEE Council considered the report of the City Planning Committee from its meeting held on September 6, 1978, as follows: Case No. 3517 - Subdivision Approval -C.H.S. Developments Ltd. - Main Avenue MOVED by Deputy Mayor Shannon, seconded by Alderman Hanson that, as recommended by the City Planning Committee, City Council: 1. Approve the upgrading of Main Avenue between North West Arm and the N. S. P. C. right of way to a finished collector street to permit the development of Block E by C. H. S. Developments Limited and facilitate existing development; 2. Approve the financing of the street improvement to Main Avenue under local improvement charges and authorize monies to be funded for these improvements as already outlined in the 1978 Capital Budget under Item CBA41; and Inform the Development Officer that any subdivision 3. approval for this Block E be based on the road improvement to Main Avenue as outlined in the staff report of August 4, 1978, and agreement with respect to cost sharing on peripheral fencing. His Worship referred to the statement in the staff report that staff further proposes that the City consider this procedure as a general policy of upgrading existing City streets where subdivisions/developments proceed and improvements to the roadway are considered necessary, saying the statement is not encompassed by the text of the Motion. His Worship suggested that perhaps Council would pass the proposed Motion and have a supplementary report making a specific recommendation on the matter saying at least the inference would be that the City would use it as a precedent. A short discussion and questioning of staff ensued and Deputy Mayor Shannon suggested Council should deal with the Motion and further review the policy matter. Council agreed that the matter be placed on the agenda of the Committee of the Whole Council in order to obtain a policy. The Motion was put and passed. - 455 -

Council September 14, 1978 Case No. 3563 - Lot Consolidation - Lower Water Street, Bishop Street, Hollis Street, and Salter Street and Street Closure - Portions of Lower Water Street The above noted item was forwarded to City Council without recommendation. A supplementary staff report dated September 11, 1978, was submitted. MOVED by Deputy Mayor Shannon, seconded by Alderman Downey that a date be set for a public hearing to consider altering the official street lines of Water Street between Terminal Road and Salter Street, to consider the lot consolidation of forty-four separate parcels of land in the block bounded by Lower Water Street, Bishop Street, Hollis Street, and Salter Street under the ownership of A. Keith & Son Limited to create Block K, and to consider laying down street lines which would provide for desired corner cut-offs at Hollis, Salter, and Bishop Street intersections as shown on Plan P200/8507 of Case No. 3563. The City Clerk advised that the public hearing has been scheduled for October 18, 1978 at 7:00 P. M. Motion passed. Case No. 3611 - Modification of the Zoning Bylaw under Schedule "C" - DATE FOR PUBLIC HEARING MOVED by Alderman Downey, seconded by Alderman Wooden that, as recommended by the City Planning Committee, City Council, under Sections 83(c) and (d) (Schedule "C") of the Zoning Bylaw (Peninsula Area) set a date for a public hearing to consider permitting the erection of the ambulance port as outlined in the staff report of August 24, 1978, and notify the property owners, as shown on Sketch 4 of the staff report, which may be affected by such approval. The City Clerk advised that the public hearing has been scheduled for October 18, 1978 at 7:00 P. M. Motion passed with Deputy Mayor Shannon abstaining. City Owned Land - North Ridge Road The above noted item was forwarded to City Council without recommendation. Alderman Sullivan said the Condominium Group involved was under the impression that because the area in question, or part of it, was paved by the developer and they had been parking on it since the building was constructed, the land belonged to the group. - 456 -

Council September 14, 1978 Alderman Sullivan said it was not until the City started parceling up the land that it came to their attention it was not their land. He said the group is especially concerned about losing the ongrade parking. MOVED by Alderman Sullivan, seconded by Alderman Meagher that City staff be authorized to enter into an agreement with Halifax Condominium Corporation No. 6 to lease approximately 16,800 sq. ft. of land for a period of three years with an option to renew for an additional three years with an annual rental equal to taxes that would be paid to the City if the Condominium Group were the owners of the land, and to provide an option to purchase the land within six years at the price of \$1.00 per sq. ft.for approximately 16,800 sq. ft. all as set out in a staff report dated August 29, 1978. Motion passed.

Appointments

A report dated September 11, 1978, was submitted from His Worship the Mayor respecting a proposed appointment.

Council agreed that the matter be deferred to the next regular meeting of the Committee of the Whole Council.

Honorary Town Crier

A staff report dated September 12, 1978, was submitted.

MOVED by Alderman Sullivan, seconded by Alderman Clarke that Halifax City Council appoint and endorse Mr. Peter Cox as Honorary Town Crier of Halifax, Nova Scotia, Canada for a term to expire December 31, 1979.

Motion passed.

Aerial Fly Past, City of Halifax - Battle of Britain

A staff report dated September 12, 1978, was submitted.

MOVED by Alderman Meagher, seconded by Alderman Sullivan that no objection be recorded by City Council to the aerial fly past in the vicinity of the City of Halifax on Sunday, September 17, 1978 subject to the approval of the appropriate authority and in compliance with Federal regulations.

Motion passed.

QUESTIONS

Question Alderman Sullivan Re: Crosswalks - Leeds Street

Alderman Sullivan said that during the summer, he requested a traffic count be carried out on Leeds Street because of heavy traffic especially in the mornings coming from Convoy, turning right on Leeds Street, and taking a short-cut through to Lady Hammond Road which, he said, is causing some problems for children attempting to cross the street to St. Stephens School.

Alderman Sullivan advised that staff did not wish to carry out such a count during the summer months but asked that both a pedestrian and traffic count be carried out on Leeds Street between 8 and 9 a.m. if possible. Alderman Sullivan suggested that perhaps a report could be submitted at the next Committee of the Whole meeting and the City Manager indicated that an attempt would be made.

Question Alderman Downey Re: Cornwallis Street

Alderman Downey referred to work taking place on Cornwallis Street and asked for a report with respect to when such work is to be completed, and the City Manager advised that a report would be submitted.

Question Alderman Downey Re: Fence - George Dixon

Alderman Downey said it was his understanding that a car went through the above noted fence and asked when it would be repaired.

The City Manager indicated repairs would be carried out by the insurance company once the claim is settled.

Question Alderman Downey Re: Seasonal Employees, City Field

Alderman Downey said it was his understanding that some seasonal employees will soon be laid off at City Field and asked if he could receive a report with respect to the number involved and whether any employees have been laid off as of today.

The City Manager advised that a report would be available by the next Committee of the Whole Council meeting.

Question Alderman Hanson Re: Overhead Crosswalk Signs

Alderman Hanson asked if it would be possible to proceed with the install ion of the overhead crosswalk sign at Philip Street and Council Road as he has received representations on the matter.

The City Manager advised that a report is being prepared for the next Committee of the Whole meeting with respect to crosswalk signs in order that Council will be advised as to the timing and funding of such signs.

Question Alderman Clarke Re: Tree Spraying

As a result of a short questioning of the City Manager, Alderman Clarke ascertained that the City intends to carry out tree spraying during 1979 and asked if Council could be supplied with a report with respect to the risks and benefits associated with such a program before it commences.

The City Manager advised that staff would report on intended tree spraying.

Question Alderman Clarke Re: School enrolment

Alderman Clarke referred to the rules and regulations with respect to a child having to be five years of age by October 1st in order to start school saying he would like to see a staff report as to whether the date could, or should be extended. He noted that some municipalities extend the date to the end of December of the school term saying people have expressed concern in the past that their children missed a year or could not start with their friends as their birthday was in October or November.

Alderman Clarke said he would like to see the matter discussed with the School Board with a report to be submitted on the pros and cons of extending the date.

The City Manager advised the School Board would be asked to report to Council on the matter.

Question Alderman Wooden Re: Crosswalks & Crossing Guards

Alderman Wooden asked if a survey could be carried out in the Holly Drive School area regarding the need for a crossing guard. She advised that staff are looking at the matter of crosswalks at Woodcrest Avenue but said there seems to be some problem with that location.

Alderman Wooden expressed the feeling that the area requires a crossing guard saying it is difficult to take a survey as the children cross within a 4 mile radius.

Question Alderman Wooden Re: Sussex Street

Alderman Wooden suggested the construction work taking place on Sussex Street is near completion but the fringe areas are very untidy. She referred to the area near the MacIntosh Runs and to the sidewalk in front of the MacIntosh Runs which has been dug up saying she would like to see it replaced before the winter season.

Council September 14, 1978 His Worship advised that he enquired into the

Question His Worship the Mayor Re: Atlantic Canada Plus Program

His Worship asked that the City Manager give consideration to the proposed Atlantic Canada Plus Program and supply Council with a report on ways in which the City might associate with the program by endorsement or other appropriate course. His Worship advised the burden of the program is to convert 1% of all procurement in the area, which is now estimated to run in the order of 15 Billion dollars, into preference for local product.

His Worship supplied the City Manager with a package of material on the matter and asked that staff review it to see under what circumstances the City could convert one or more per cent of its procurement while, at the same time, maintaining a proper accountability for expenditure of public funds.

Question Alderman Downey Re: Dept. of Fisheries Building

Alderman Downey asked what effect the proposed cut backs at the Department of Fisheries building will have on the Waterfront Development Plan and His Worship advised the matter is most carefully being reviewed at the present time.

ADDED ITEMS

Landscaping - Robie Street Extension and Fairview Junior High

matter and a report is being prepared.

A staff report entitled "Commitment Recommendation" dated September 12, 1978, was submitted.

MOVED by Alderman Hanson, seconded by Alderman Sullivan that contract be awarded to the lowest bidder meeting specifications, D. Coupar Landscaping, Elmsdale, Nova Scotia to landscape the Robie Street Extension and Fairview Jr. High School for the lump sum contract prices of \$13,110.00 and \$12,000.00 respectively; extra fill, if required, be placed at a unit cost of \$4.00/cu. yd.

City staff was asked to prepare a report comparing the price of the rose bushes planted on Dunbrack Street with the price of what the alternatives would have been.

Motion passed.

Halifax Shopping Centre - Change in Traffic & Parking

His Worship advised that he requested the subject matter be placed on the agenda and asked that staff look at reports of the changes in the traffic pattern on the centre property particularly on the south side which is causing inconveniences to the residents of Edward Arab Avenue.

Mr. Dodge of the Development Department spoke on the matter and His Worship said the complaints which he has received have to do with alleged sound/noise pollution, the use of the area by trucks with various types of mufflers at odd hours of the day and night, and a steady stream of traffic in the area.

His Worship asked that staff determine whether the City has any authority in the matter, whether any Ordinance is being violated, and to speak to the management and inform them the matter was complained of and was raised at City Council.

Further discussion ensued and it was agreed that staff should pursue the matter.

Expropriation - Lands of Fairfax Developments Limited - Hillcrest Street

Two confidential reports were submitted dated September 14, 1978; one entitled "Expropriation - Lands of Fairfax Developments Limited Hillcrest Street" and the other entitled "Lot "X" - Hillcrest Street - Herman Newman".

Following a discussion and questioning of staff, it was MOVED by Alderman Clarke, seconded by Alderman Wooden that:

- 1. The City of Halifax expropriate the land shown as Lot "X" on a plan of subdivision dated April 19, 1972 and entitled 'Plan Showing Lot "N" Amalgamation of Lands Owned by Herman Newman, Frederick Avenue & Hillcrest Street, Halifax, Nova Scotia' without compensation, pursuant to the provisions of Section 348(5) of the Halifax City Charter, and
- 2. The Attorney General be requested to make an Order granting the City immediate possession of the land pursuant to Section 11(7) of the Expropriation Act.

Motion passed.

Contract Zoning Guidelines

A report dated September 14, 1978, was submitted from the Chairman of the Municipal Development Plan Committee.

His Worship advised the proposed guidelines were considered yesterday at a Municipal Development Plan Committee meeting saying that Council earlier received recommended guidelines and forwarded them to the Municipal Development Plan Committee for review and recommendation.

His Worship proceeded to review the Guidelines for Contract Zoning as attached to the staff report and Alderman Moore, in referring to Step 2(B) of the Guidelines, asked whether reference should be made to the Halifax Mail-Star and, following a short discussion, it was agreed that the words "in a daily newspaper published in Halifax" should be used. His Worship advised that the cost of such an advertisement was to be paid by the applicant.

Reference was also made to the notice of application being sent to abutting property owners and the feeling was expressed that the same area of notification should be used as is presently the case with respect to public hearings on rezoning applications. Various suggestions were made with respect to alternate wording and the City Manager suggested that for the purpose of approving the matter at this meeting, the word "affected" could be used and staff would present a more detailed report as to the actual wording of the guidelines in that regard.

Alderman Moore referred to the costs to the applicant which may be associated with the publication of the notice of application and asked what would happen if the City started requiring more detail in the advertisements which could result in expensive advertising costs. He suggested that perhaps some thought should be given to the matter.

His Worship advised that was not the intention saying it was just intended to inform the public that an application has been made and what it is. His Worship suggested that perhaps staff could be asked to describe the form of the advertisement having regard to the intent, and the City Manager advised that staff could bring in a sample of the advertisement in the further report.

His Worship read the irst paragraph of revised Step 2(B), as follows:

"Notice that an application has been made shall be sent to all property owners in the area affected by the application for which application or contract zoning is made. Notice that an application has been made shall be published at the applicants expense in a daily newspaper published in Halifax including notice where the application may be viewed and notice that citizen comments may be made in writing."

Further discussion ensued and it was MOVED by Alderman Clarke, seconded by Alderman Hanson that City Council endorse the amended guidelines for contract zoning as attached to the report dated September 14, 1978, from the Chairman of the Municipal Development Plan Committee subject to the seventh line of the first paragraph of Step 2(B) being amended to refer to a daily newspaper published in Halifax rather than to the Halifax Mail-Star.

Motion passed.

Crosswalks - Leeds Street

The above noted matter was added to the agenda at the request of Alderman Sullivan. The item, however, was dealt with under the questions section of the agenda.

Extension of Fresh Water Brook Sewer

The above noted item was added to the agenda at the request of Alderman Meagher who asked that the item be included in the agenda of the next regular meeting of the Committee of the Whole Council. Alderman Meagher indicated he would like the item discussed in order to get the rationale as to why the item is being moved up, the cost, and the amount the City will be receiving from C.M.H.C.

Sidewalk Repairs - North, Windsor, and Oxford Streets

The above noted item was added to the agenda at the request of Alderman Meagher who indicated he wished the item placed on the agenda of the next Committee of the Whole Council meeting saying he is not satisfied with the amount of work being carried out in his Ward this year with respect to sidewalks and repairs.

Alderman Meagher said he would like to be informed how much work has been done in his Ward this year on repairs saying that if there is any money available from any fund this year, it be available to carry out more work.

Carson Street - Clean Up & Landscaping

The above noted item was added to the agenda at the request of Alderman Wooden saying she has received complaints from residents of Carson Street about the way garbage is picked up. She said the residents all place their garbage bags in a certain location which attracts dogs with the result being that the garbage is strewn over the area every Friday. Alderman Wooden asked if an alternate method of garbage collection could be considered for the area.

Alderman Wooden also asked for a staff report with respect to the cleanliness of the project saying all the garbage ends along the wooded area.

Alderman Wooden also referred to previous discussions relating to a location for a tot-lot and suggested she may have now found one on Orange Walk.

Alderman Wooden further suggested that some fill be placed in certain locations suggesting that there is a danger that some of the City's concrete and asphalt work will be lost because of erosion.
