Motion passed.

Motion Alderman Clarke Re: Amendment to Ordinance No. 151 Respecting the Automatic Machines Ordinance - SECOND READING

The above item was referred to tonight's meeting of Council without recommendation from the last regular meeting of the Committee of the Whole Council at which time proposed amendments to Ordinance No. 151, which were read and passed a First Time by Council on March 1, 1979, were submitted.

Alderman Clarke Moved a Motion that the proposed amendments be read and passed a Second Time but there was no seconder to the Motion.

Alderman Meagher indicated he would like to see the item be deferred until Council receives a proposal from staff governing arcades.

Alderman Shannon referred trucks that sell french fries etc., on the streets but suggested they do not pay a business tax to the City. Alderman Shannon questioned whether such operations should be included in the Ordinance and if so, should the wording be amended to include them. Alderman Shannon noted the operations are regulated by the Board of Health but suggested they are not taxed to do business in the City.

Mr. Allen of the Legal Department advised that he would check into the matter.

Alderman Meagher noted that last year the City rented the canteen facilities at the public gardens the operator of which paid rent plus taxes. Alderman Meagher advised that there then appeared a number of vendors around the fringes of the Gardens who are not required to pay taxes such as the operator of the canteen. Alderman Meagher suggested that situations such as this should be looked into as well.

MOVED by Alderman Shannon, seconded by Alderman Wooden that the matter be deferred until staff can review the points raised and submit further information.

Motion passed.

Tendering Practices - Supplementary Report

A staff report dated March 8, 1979, was

submitted.

QUESTIONS

Question Alderman Meagher Re: Street Sweeper Operators

Alderman Meagher asked if there are normally two street sweeper operators per machine and if so, is one of the operators being trained to operate the machine.

The Director of Engineering & Works advised that there is normally one operator but advised that a group of employees were sent on a training course and they are now being assigned to a machine with an experienced operator in order that they will be ready for the regular summer program.

Alderman Meagher advised that he recently asked the City Manager to enquire of the Police Department with respect to heavy container traffic on Quinpool Road saying the Police Department informed him that as soon the Water Street improvements are completed which should be shortly, such traffic will be taking its normal route. Alderman Meagher advised that the Police Department was in contact with the various container lines and that they were in agreement with such action.

Question Alderman Shannon Re: Street Lighting

In reply to a question from Alderman Shannon, the City Manager advised as to how the automatic street lighting system operates.

Alderman Shannon advised that she received a complaint that the street lights were not being turned off early enough in the morning, and the City Manager advised that staff have received similar complaints which have been passed on to the Nova Scotia Power Corporation.

Question Alderman Sullivan Re: Summary Statement -Revenues and Expenditures

In reply to a question from Alderman Sullivan, the City Manager advised that the term Grants in Lieu as contained in the Summary Statement of Revenues and Expenditures represented grants from the Province in lieu of real property taxes for some of their properties, and that the term Provincial Transfers represented cost shared programs.

ADDED ITEMS

Appointment - Halifax Forum Commission

The above item was added to the agenda at the request of the City Clerk.

A memo dated Marcy 14, 1979, was submitted from His Worship the Mayor nominating Donald Flemming for appointment to the Halifax Forum Commission.

MOVED by Alderman Hanson, seconded by Alderman Sullivan that Donald Flemming, 56 Nightingale Drive, Halifax, Nova Scotia, be appointed to the Halifax Forum Commission for a term to expire October 31, 1980.

Motion passed.

Sidewalk Renewals in NIP I Area

MOVED by Deputy Mayor Downey, seconded by Alderman Maley that, as recommended by the Finance and Executive Committee, Counci authorize, for the NIP I area, the implementation of an additional sidewalk, curb, and gutter renewal program including tree planting and sodding where applicable up to \$220,000 as outlined in the staff report of March 9, 1979; funds available in Account EH003.

Motion passed.

Possible Acquisition and Sale of Land - Leiblin Drive

The above item was deleted from the agenda during the approval of the Order of Business.

Sale of City Property - 14 Parkhill Road

The above item was forwarded to City Council without recommendation.

A supplementary confidential staff report dated March 27, 1979, was submitted.

MOVED by Alderman Hanson, seconded by Alderman Wooden that the subject lot known as Civic No. 14 Parkhill Road be sold to Mr. Ping Fai Seto for the sum of \$12,000 and the proceeds be deposited in the Sale of Land Account.

Motion passed.

Maintenance Agreement No. 23

The following is the recommendation of the Finance and Executive Committee:

"That City Council accept the Cost Sharing Agreement No. 23 as recommended in the letter from the Department of Highways dated December 27, 1978, but express disappointment with the exclusion of the Bayers Road and Chebucto Road systems, and ask that His Worship the Mayor, Deputy Mayor Downey, and Aldermen Sullivan and Clarke represent the City to the Ministry of Highways seeking to express the City'd disappointment and to have the said exclusions re-inserted."

Alderman Clarke advised he could not support the Maintenance Agreement to remove Bayers Road from Connaught Avenue to Windsor Street. Alderman Clarke indicated he did not mind removing the street from cost sharing if the Province could remove some of the heavy traffic that uses the roadway saying that until he is advised why it is no longer justified for cost sharing, he could not support the agreement.

A short discussion ensued on the matter and in reply to a question, the Director of Engineering and Works advised that action with respect to the proposed agreement could be deferred until after the proposed meeting with the Ministry of Highways.

MOVED by Alderman Hanson, seconded by Alderman moore that, as recommended by the Committee on Works, the central portion of Bayview Road between Trillium Terrace and Woodbank Terrace be accepted as part of the official street system as it fulfills the minimum standards required by the City.

Motion passed.

Award of Tender - Freshwater Brook Sewer Extension -Supplementary Report

A further supplementary report dated March 28, 1979, with attachments, was submitted.

Alderman Clarke, in referring to information contained in the latest report, noted that area #1 is proposed for completion by May 11 and asked when area #2 would be started and completed.

His Worship indicated that staff would check the matter and advised it was his recollection that area #2 was to be completed by July 29th.

Alderman Sullivan referred to the letter from the Recreation Committee as attached to the latest report, and asked if staff were in communication with the Recreation Committee for their comments prior to drawing up the specifications for the tender and also asked how the matter was taken to the Recreation Committee, to which the Director of Engineering and Works responded.

Alderman Moore also referred to the letter from the Recreation Committee and indicated it was his understanding that Alderman Meagher had previously asked about the timing of the project as to whether or not it could be carried out during last fall and winter saying he thought the response was that the project could be carried out prior to the 1979 outdoor activity season.

Further discussion ensued and it was MOVED by Alderman Clarke that the City start Area #1 on April 3, 1979 and that Area #2 be deferred to the Committee of the Whole Council meeting in order for staff to advise when the project will be completed if it is commenced in April or in September, and the extra costs involved.

MOVED by Alderman Maley, seconded by Alderman Shannon that amendments to the Fire Prevention Ordinance No. 168, as submitted, be now read and passed a First Time. Motion passed.

MISCELLANEOUS ITEMS

Tender 79-38 - Spring and Fall Police Jackets

A staff report dated March 21, 1979 was submitted.

MOVED by Alderman Sullivan, seconded by Alderman Clarke that City Council approve the purchase of jackets from Outdoor Outfits, 372 Richmond Street West, Toronto, Ontario for a total cost of \$17,937.50. Motion passed.

Appointments

Memoranda dated March 26, 1979 and March 29, 1979 were submitted by His Worship the Mayor.

MOVED by Alderman Moore, seconded by Alderman Hanson that Mr. S. S. Jacobson be appointed to the Board of the Halifax Public Service Commission for a further three-year term to expire April 30, 1982. Motion passed.

MOVED by Alderman Meagher, seconded by Deputy Mayor Downey that Alderman Terrence Sullivan and Mr. Harold Crowell be appointed to the Board of COMSERV, for terms to expire October 31, 1980. Motion passed.

QUESTIONS

Question Alderman Maley re: Scaffolding Around the Toronto-Dominion Bank Building

Alderman Maley asked why scaffolding remains around the Toronto-Dominion Bank building on Barrington Street.

The City Manager advised that some mouldings on the building became loose and cannot be repaired until the temperatures are more favourable. He stated that the scaffolding was erected by the developer to ensure the safety of the public using the walkways and, as soon as the weather permits, repairs will be made.

Question Alderman Maley re: Appointees to Boards and Commissions

Alderman Maley requested a list of all appointments made by City Council to Boards and Commissions and asked how many of the appointees are female. She requested that, in view of the Provincial Government's recent statement that a certain percentage of appointees to Boards and Commissions should be female, this fact be borne in mind when nominations are being made.

His Worship stated that his office would be delighted to have any further nominations at any time.

Question Alderman Meagher re: Clean-Up Week

Alderman Meagher asked when clean-up week is scheduled.

The City Manager advised that it is slated for the first week in May as usual and a staff report will be submitted on whether it should be held later in the year.

Question Alderman Meagher re: Nova Scotia Power Rate Increase

Alderman Meagher asked what effect the proposed Nova Scotia Power Commission rate increase will have on the City of Halifax budget.

The City Manager advised that the City has considered the matter and have decided not to speculate on what the ruling of the Public Utilities Board will be. He stated that a preliminary check has been made and an increase of 6% to 10% should not have too much of an effect on the budget as it is hoped to gain some savings in the energy management field. He advised that as soon as a decision is made by the Public Utilities Board, a staff report will be submitted to City Council outlining the effects.

Question Alderman Sullivan re: Interceptor Sewer - Duffus Street - Odour Problem

Alderman Sullivan asked when some results would be evident re the odour problem with the interceptor sewer at the foot of Duffus Street.

Mr. Connell, Director of Engineering and Works, advised that five pumps are now operational, the sixth pump is presently being installed, and the consultant is now doing his monitoring on the first proposal, that is, to check it at full capacity to determine if the problem can be solved in that manner.

Mr. Connell further advised that a decision will be reached in approximately two weeks and at that time it will be known if the larger expenditure approach is necessary.

Question Alderman Sullivan re: Animal Control - S.P.C.

Alderman Sullivan stated that at the time City Council considered a report on the takeover of animal control in the City by the S.P.C., there was some mention in a staff report of a situation re the general control of dogs. He asked if there has been any further action by staff on that particular matter and whether a report will be submitted to City Council.

The City Manager advised that the matter is on the agenda of the next regular meeting of Committee of the Whole Council.

Question Alderman Shannon re: Smoke Detectors

Alderman Shannon requested a report from the Fire Department re the installation of smoke detectors in rooming houses, how many buildings have been covered, how many buildings are left, how many people have been taken to court, if any.

Question Alderman Shannon re: Taxes re Dalhousie Heating Tunnels

Alderman Shannon asked if Dalhousie are being charged for the use of space under the streets for their heating tunnels.

The City Manager advised that they have an encroachment license. The City Solicitor advised that Dalhousie also pays an annual fee based on the number of square feet that the pipe would occupy.

Alderman Shannon further asked if they are on schedule to complete the construction by June 1979. The City Manager advised that staff will inquire and a report will be submitted to City Council.

Question Alderman Shannon re: Cleaning of Sidestreets

Alderman Shannon commended staff for their efforts in cleaning the main routes in the City but stated there are still a number of sidestreets which have not been cleaned and asked if they would be done before the winter parking ban is removed on March 31.

Mr. Connell advised that concentration is on the major routes first and there are many secondary streets which will not be done until the regular sweeping program commences in April.

The City Manager stated that members of City Council should bring to the attention of the Director any streets they feel are in dire need of cleaning.

Question Alderman Moore re: Sewage Treatment Plants

Alderman Moore requested that staff prepare a report considering the location, establishment and construction of a number of small sewage treatment plants within the City. He asked whether it would be feasible, worthy of consideration, and whether it would bring closer

to realization treatment of sewage in the City.

Question Alderman Moore re: Metro Centre Acoustics

Alderman Moore referred to an information report from the City Manager re an update of the Metro Centre acoustics and asked if a completion date has been set for the installation, is one indicated, and if there is a penalty clause in the agreement if it is not met.

The City Manager advised that an installation date is not set, the indicated date is June 28, 1979 at the latest, and he does not know if there is a penalty clause as he has not seen the specifications but, as in any other contract, there will be some provision for a deadline and corresponding penalty clause.

Alderman Moore stated that anything that the City Manager could do to expedite the work would be appreciated by the Metro Centre Commission.

Question Alderman Moore re: Detox Centre on South Park St.

Alderman Moore referred to the staff report with respect to the Detox Centre on South Park Street and asked if the Centre is being advanced in conjunction with the Home for Transient Men that City Council has been dealing with, is it a separate facility and, if so, what is the status of the establishment of a Home for Transient Men.

The City Manager stated that the Detox Centre is not related to the Home for Transient Men and a report on the matter will be received by members of City Council tomorrow, and, if it is Council's wish, it can be added to the agenda of Committee of the Whole Council for more detailed discussion.

Question Alderman Clarke re: School Board - Issuance of Transit Tickets to Students

Alderman Clarke requested a report from the School Board re the issuance of transit tickets to students, the ages, the distance factor, and the rules followed re such issuance.

Question Alderman Clarke re: Plans for the Nova Scotia Arts and Convention Place

Alderman Clarke asked when City Council will get to see the plans for the Nova Scotia Arts and Convention Place.

His Worship advised that, upon invitation of members of the Provincial Government, he was shown within the past several hours, plans of the Nova Scotia Arts and Convention Centre Limited. He stated that he advised that the Council of the City awaits a public presentation of details in order that it may make a decision as quickly as possible re the sound amplification side of the total treatment of Metro Centre. He stated that there is no intended invasion of any view plane of the City of Halifax and he was assured that there was no intention to exercise the power to act without recourse to Municipal bylaws.

Question Alderman Clarke re: Yield Signs - Halifax Shopping Centre

Alderman Clarke referred to the location of traffic yield signs at the Halifax Shopping Centre and suggested that they are contrary to what he believes to be good driving practices. He asked if they are governed by the Motor Vehicle Act or by general rules of safety.

The City Solicitor advised that an information report will be submitted by the next regular meeting of Committee of the Whole Council if possible.

Question Alderman Hamshaw re: Obstacle - Melody Drive

Alderman Hamshaw referred to the Bridgeview storm sewer installation and stated Melody Drive will have to be used as an alternative route. He asked that staff report as soon as possible re the removal of the obstacle at the foot of Melody Drive.

Question Alderman Hamshaw re: Access to Dunbrack Street

Alderman Hamshaw asked how soon can an access route to Dunbrack Street be realized.

The City Manager advised that a report will be submitted to Committee of the Whole Council meeting of April 18, 1979.

Question Deputy Mayor Downey re: Appointments to the Halifax Housing Authority

Deputy Mayor Downey asked if all appointments have been made to the Halifax Housing Authority, suggesting that, due to illness, one appointee is unable to accept the nomination.

His Worship stated that it is his understanding that all appointments were filled and had not been informed of the vacancy.

Question Deputy Mayor Downey re: Letters from Halifax Housing Authority in Response to Applications for Accommodations

Deputy Mayor Downey referred to letters being received from the Halifax Housing Authority in response to their applications for accommodations and asked for a report on why the letters are being issued in such form.

Question Alderman Wooden re: Centre Door of Mainland South Fire Station

Alderman Wooden requested that the Fire Department advise when the centre door of the Mainland South Fire Station will be replaced.

Question Alderman Wooden re: Street Cleaning - Business District of the Herring Cove Road

Alderman Wooden requested a staff report re when street cleaning will commence along the business district of the Herring Cove Road.

Question Alderman Wooden re: Lands in Mainland South Declared Surplus by the School Board

Alderman Wooden stated that it is her understanding that the School Board has declared surplus some school lands in Mainland South. She requested a detailed map of each school site, an overall map of City-owned land in Ward 7, the stated policy of the Council re surplus schools and buildings, and, further, she requested that she be informed before such decisions are made regarding changes as such within Ward 7.

Alderman Hanson advised that although the land was declared surplus by the School Board, it remains as City property.

The City Manager advised that as soon as he is informed of the surplus lands, it will be brought to City Council's attention for possible uses.

Alderman Wooden stated she wished to have the requested maps.

Notice of Motion Alderman Hanson re: Amendments to Ordinance No. 147, the Dog Ordinance

Alderman Hanson gave notice that at the next regular meeting of the City Council of the City of Halifax, to be held on Thursday, the 12th day of April, A.D., 1979, he proposes to introduce amendments to Ordinance Number 147, the Dog Ordinance.

He stated that the purpose of the amendments

is:

- 1. to constitute the failure to remove dog defecation a legal nuisance and an offence under the Ordinance;
- to provide for the appointment of by-law enforcement officers under the Police Act;
- to define the word "owner" to assist in the enforcement of the Ordinance;
- to redefine the phrase "running at large" to assist in enforcement;
- 5. to authorize pound keepers to destroy dogs for humane reasons and to charge veterinary fees back to the owner;
- 6. to redefine offences dealing with biting, disturbances, chasing and damage to property and to create a new enforcement procedure regarding these offences;
- 7. to establish larger penalties.

Notice of Motion Alderman Shannon re: Amendment to Ordinance No. 149, the Petty Trades Ordinance

Alderman Shannon gave notice at at the next regular meeting of the City Council of the City of Halifax to be held on Thursday, April 12, 1979, she proposes to introduce an amendment to Ordinance Number 149, the Petty Trades Ordinance.

She stated the purpose of the Ordinance is to clarify the provision regarding licensing of sidewalk vendors.

ADDED ITEMS

Halifax City Charter - Section 542

A report dated March 26, 1979 was submitted by the City Solicitor.

MOVED by Alderman Shannon, seconded by Alderman Maley that amendments to section 542(2) of the Halifax City Charter, as attached to the staff report dated March 26, 1979, be approved. Motion passed.

Proposed Municipal Elections Act - TO BE TABLED

Copies of the Proposed Municipal Elections Act were circulated to members of City Council.

Alderman Moore stated that it is the opinion of the Election Procedures Committee the draft legislation should be referred to staff for review and input in time for the next regular meeting of Committee of the Whole Council.

MOVED by Alderman Moore, seconded by Alderman Hamshaw that the draft legislation re the Municipal Elections Act be tabled, referred to staff for review and input, and placed on the agenda for the next regular meeting of Committee of the Whole Council.

Alderman Moore stated that his intention in referring the matter to staff for a report is to obtain a comparison with present legislation rather than direction to City Council on what should or should not be done.

The motion was put and passed.

Extension of the 1979 Tax Setting Date

A staff report dated March 29, 1979, was submitted.

MOVED by Alderman Clarke, seconded by Alderman Sullivan that to show concurrence, the resolution of February 15, 1979 setting the date for the 1979 tax rate to March 31, 1979, be amended to read April 30, 1979. Motion passed.

Labour Relations - Alderman Moore

Alderman Moore commented upon the decision of the Council of the City of Dartmouth with respect to the prohibition of the right to strike in essential services, particularly as it applies to the public sector, stating his remarks were made after some consideration and deliberation.

Alderman Moore referred to the affects of strikes on the national economy as well as on individual household budgets and stated his belief that it is time some action be taken to ensure that a person who wants to work is given every opportunity to preserve and sustain that desire. Alderman Moore advised that he believed that Council must bring forward legislation providing for a citizen's right to work, and that such legislation should include in its provisions, that a citizen need not join a union if he does not wish to, and that a citizen should not be prevented from entering and working at his place of employment during any strike whether legal or otherwise. Alderman Moore advised that such legislation is presently in effect in many States in the United States of America.

MOVED by Alderman Moore, seconded by Alderman Clarke that the City Council of the City of Halifax endorse the principle of the right to work and the City Clerk be instructed to convey, in writing, that principle to the Minister of Labour of the Province of Nova Scotia and urge the Minister to bring forward as quickly as possible, legislation providing for same.

Alderman Clarke stated that he seconded the Motion for purposes of discussion but he is not certain as to what the boundaries of the right to work entail. He suggested that the matter be deferred to the next regular meeting of the Committee of the Whole Council for discussion.

After some discussion, the Motion was put and lost, one voting for the same and nine voting against.

Punch Bowl Lake - Alderman Wooden

Alderman Wooden stated that residents of the area have been concerned over the past couple of years about the condition of Punch Bowl Lake and its shoreline. She advised that the Department of the Environment has accepted the responsibility and infilling of the waterway comes under their jurisdiction. She advised that infilling of the lake continues after repeated assurances from the

Department that no further permits will be authorized.

Alderman Wooden requested that City staff again pursue the matter of infilling of the Punch Bowl with the Department of the Environment and bring it to a resolution. She further requested that the City's engineering staff make a site inspection of the two 30-inch water pipes and the 24-inch outfall pipes. She stated that it seems that because the 24-inch outfall pipe is too high, basements of surrounding property owners are often flooded during wet periods.

The City Manager advised that the matter would be pursued with the Department of the Environment and a staff report will be issued.

Alderman Wooden advised that the emergency number given by the Department of the Environment is absolutely useless as the phone is not answered at any time.

Water Rates - Alderman Sullivan

Alderman Sullivan referred to the report circulated by His Worship the Mayor to members of City Council this date and asked if it is correct that the Public Service Commission has delayed the issuance of water bills pending the approval of the rate increase.

His Worship advised that the Board of Commissioners of Public Utilities for the Province ruled upon the matter and in their decision stated that the rate schedule approved would be effective for bills rendered on and after March 23, 1979, for a period commencing January 1, 1979.

His Worship responded to further questions from members of City Council re the document circulated.

Halifax Industries Limited - His Worship the Mayor

His Worship reported in detail to City Council on a visit he made to Halifax Industries Limited on March 23, 1979. During his remarks, His Worship distributed to members of City Council a graph given to him by Management depicting the salaried and hourly work force up to the week of March 23, 1979. His Worship further circulated an artist's conception of the Panamax drydock.

His Worship suggested it would be helpful if, at the next regular meeting of Committee of the Whole Council, a resolution was passed authorizing the City of Halifax to encourage the Federal Government to maximize the local construction quotion in the Panamax.

Ordinance No. 151, the Automatic Machines Ordinance -- His Worship the Mayor

This matter was considered for Second Reading at a regular meeting of City Council held on March 15, 1979 at which time it was deferred pending receipt of requested information.

His Worship stated that his concern in raising the matter is that the City Clerk is required to collect fees in this regard.

MOVED by Alderman Clarke, seconded by Alderman Hanson that amendments to Ordinance No. 151, the Automatic Machines Ordinance, as submitted, be now read and passed a Second Time. Motion passed with Aldermen Maley, Shannon and Wooden voting against.

PUBLIC MEETING MINUTES

> Council Chamber City Hall Halifax, N. S. April 2, 1979 7:30 P. M.

A public meeting respecting store hours and Sunday openings was held on the above date.

Present: His Worship the Mayor, Chairman; Deputy Mayor Downey, and Aldermen Maley, Shannon, Meagher, Wooden, Hanson, Moore, and Hamshaw.

Also Present: City Manager, City Clerk, and other staff members.

The public meeting was called for the purpose of considering:

Store Hours and Sunday Openings

His Worship briefly presented some history with respect to store hours and Sunday openings in the City and advised of various amendments made to both Ordinance No. 109, the Lord's Day Ordinance, and Ordinance No. 121, The Retail Shop Closing Ordinance.

His Worship proceeded to outline events leading to the calling of the public meeting saying that last September, the Atlantic Seven-Eleven Limited and Southland Corporation approached Council with a suggestion it would like to consider the possibliity of commencing the operation of Seven-Eleven stores but that it felt it required 2,400 square feet in area and a seven-day operation. His Worship advised that the representatives suggested they would like to have the Ordinance amended to permit consideration for the Seven-Eleven stores which led to setting the date for a public meeting to consider possible amendments to City Ordinances.

His Worship also noted that subsequent to that, the City of Dartmouth amended its Ordinance to permit Lord's Day operations of grocery stores having square footage not in excess of 1,800 square feet not including space used for storage purposes. His Worship also outlined other differences between the City's Ordinance and those of the City of Dartmouth and the County of Halifax.

His Worship advised that the purpose of the meeting was to exchange views and to have the opportunity of citizens' views concerning store hours and Sunday openings in the City of Halifax.

Public Meeting April 2, 1979

Mr. Loring Wilmot representing Seven-Eleven Limited, addressed the meeting and advised he did not have a formal presentation to make at this time and noted that a presentation was previously made on the matter. Mr. Wilmot pointed out the Company defines it stores as convenience stores versus grocery stores and suggested that they do serve a purpose.

Mr. Wilmot advised of stores which it presently operates in New Brunswick and Nova Scotia some of which, he advised, are in close proximity to churches which has not resulted in problems. He advised that the Company desires a 24-hour operation, seven days a week and informed the meeting that the 11 p.m. to 7 a.m. shift represents about 20 per cent of the dollar sales suggesting there is a need for the shift.

7:50 P. M. - Alderman Clarke arrived.

Mr. Wilmot then responded to questions put forth by members of Council.

Mr. Peter McLellan, Solicitor for Dominion Stores Limited, addressed the meeting and noted that a letter dated March 27, 1979, was submitted from the District Manager of Dominion Stores Limited indicating that the matter had been thoroughly canvassed more than one year ago and that Dominion Stores was quite satisfied with the hours and size of stores which had been arrived at by Council after long and careful deliberation. He advised that the present views of Dominion Stores are basically the same as presented to Council at that time.

Mr. McLellan suggested that moving beyond the 1,500 square foot figure, the stores are becoming Supermarkets or Mini-Supermarkets and direct competitors of the larger retail grocery chains. He suggested that such action is not required by the public and that it would force the larger grocery stores to enter into an area which has been properly left to others.

Mr. McLellan further spoke on the matter saying it is also Dominion's position there is no requirement for a change in Ordinance No. 121 as they have found they have been able to meet the needs of the public with the three nights of the week they have been permitted to remain open. Mr. McLellan requested that if Council does proceed further, it not consider any changes in either of the two Ordinances. Mr. McLellan then responded to a short questioning from Council on the matter.

Mr. Jim Youden, Corporate Counsel for Sobeys Stores Limited, addressed the meeting and registered Sobeys Stores Limited's objection to any increase to the square footage for grocery stores on Sundays. He advised it has never been Sobeys policy to open on Sundays but said the larger food chains have a responsibility to their shareholders and to the profit motive to look at competitors to see whether one competitor is obtaining an unfair competitive advantage.

Public Meeting April 2, 1979

Mr. Youden suggested that if the Bylaw is changed to allow for 2,400 square foot food operations, it seems clear it is a mini-supermarket being envisaged and suggested that all the large chain stores would have to consider some alternative mode of operation on Sunday, whereas they presently avoid it as a result of the Bylaw. He advised that the strength of a Bylaw and whether it is enforced or not is important to the large food chains saying Sobeys Stores would like to go on record to indicate same. Mr. Youden then responded to questions put forth by members of Council.

Jean M. Newton, Chairman of the Mothers' Union of the Diocese of Nova Scotia, addressed the meeting and submitted and read a brief dated April 2, 1979 opposed to the opening of stores for business on Sunday. A copy of the brief is in the official file of this meeting. The speaker then responded to questions put forth by Council on the matter.

Mr. Porter representing the Halifax Presbytery of the United Church of Canada, addressed the meeting advising that the Presbytery is the governing body of the United Church for Halifax and Dartmouth and includes the area from Sheet Harbour to Glen Margaret representing about thirty congregations across the area.

Mr. Porter advised that recently, increasing concerns are being raised about the issue before the meeting saying the note sounded is concern for families, and especially for those members required to be absent from their families because of businesses being open on Sunday. He advised that during the past few months, letters have been received from about one-third of the congregations. Mr. Porter then proceeded to read from some of the letters received on the matter.

At the request of the Chairman, Mr. Porter submitted copies of some of the letters for distribution to members of Council, copies of which are in the official file of this meeting.

Reverend Cannon C. R. Elliott of St. John's Anglican Church in Fairview, addressed the meeting and submitted and read a brief dated April 2, 1979, a copy of which is in the official file of this meeting. The brief concluded by urging Council to reject the request to extend open hours and to adopt a positive approach towards weekends as periods of freedom and renewal for citizens.

Mr. Norman Newman addressed the meeting on behalf of Capitol Stores advising that he did not have another written submission but would refer to the presentation made by Capitol Stores previously. He advised that their position has not changed substantially from the previous submission. Mr. Newman advised that Capitol Stores are presently living with 1,500 sq. ft. in Halifax and in Dartmouth, with 1,800 sq. ft. net and expressed the feeling there is no real strain being imposed by the competitive position in Dartmouth. He suggested that both sizes appear to be satisfying the public.

Public Meeting April 2, 1979

Mr. Newman then made reference to the two stores owned by Capitol Stores on Coburg Road and Oxford Street and suggested these stores would be permitted to remain open if the Bylaw were changed to 2,400 square feet net.

Mr. Newman pointed out that in the history of retail grocery operations in North America, stores of 2,400 square feet have tended to pose a serious threat to the supermarket business saying in some cases in the U. S., one can see 2,400 sq. ft., 7-days a week, full size supermarkets operated. Mr. Newman suggested the supermarkets were forced into this position because of the fact that 2,400 net sq. ft. stores were beginning to seriously slice into their market.

Mr. Newman went on to suggest what action the larger chain stores would take if stores such as their Coburg Road and Oxford Street stores were permitted to remain open and expressed the feeling this would lead to considerable pressure from the retail sector to enlarge Sunday opening and, as a spin-off, there would be a push for more liberal nighttime openings. Mr. Newman further spoke to the matter following which he responded to questions put forth by members of Council.

Reverend William Moore of St. Margarets of Scotland Church, addressed the meeting and suggested that if the larger chain stores were permitted to remain open on Sundays and for extended hours, it would not generate additional revenues for the City. Reverend Moore advised that a public meeting was held yesterday by the Halifax-Dartmouth Council of Churches in order for people to express their feelings about the matter.

Reverend Moore advised there were four panelists one being a Baptist Minister from the Bedford-Sackville area, a representative of the Halifax Business Association, a representative of labour in the area, and Judge Dubenski, President of the Halifax-Dartmouth Council of Churches. Reverend Moore advised that all four panelists were very much opposed to any kind of extension and also advised that if anyone at the meeting was opposed to that view, no one spoke up.

Reverend Moore then responded to questions put forth and a short discussion ensued.

Patricia Whitman addressed the meeting on behalf of the Retail Committee of the Halifax Board of Trade and submitted a letter dated April 2, 1979 which had attached the results of a survey by the Board of Trade on the matter. Ms. Whitman advised that the Board of Trade has not been able to come to a consensus of opinion regarding store hours suggesting the members were divided among themselves.

Ms. Whitman noted the submitted survey concerned holidays and which indicated the majority of merchants wanted to be closed on holidays while a minority wanted to be open. She advised that the Committee was not ready to make a firm recommendation to the City at this point.
