Parking Garage - Grafton Street

A short discussion ensued and His Worship noted that the proposed call will be brought back to Council.

QUESTIONS

Question Deputy Mayor Hanson re: Resurfacing of Cottage Road

Deputy Mayor Hanson requested that staff undertake an assessment of Cottage Road, that portion which is City-owned and situated off Crescent Street, to the end, to determine whether it requires resurfacing.

Question Alderman Meagher re: Parking Meters on Quinpool Road

Alderman Meagher referred to discussions during budget deliberations re parking meters on Quinpool Road and requested that the subject matter be included on the agenda of the next regular meeting of Committee of the Whole Council.

Question Alderman Clarke re: Permits for Homeowners to Park in front of their Residences

Alderman Clarke acknowledged that to control the parking of vehicles in front of private residences for extended periods, one-hour parking signs are erected. He stated that there have been instances where the homeowner has been ticketed while at home for lunch. He asked that staff investigate the possibility of issuing permits to homeowners so that they may park in front of their residences for periods in excess of that allowed by the erected parking signs.

Question Alderman Sullivan re: Condition of Property Around the Tranfser Station

Alderman Sullivan stated there has been improvement in the condition of the property around the Transfer Station since the matter was last discussed by City Council, however, he has received recent complaints about the site. He stated that recently he visited the site and encountered debris around the fences and garbage on the roadway coming from the Transfer Station. He asked if staff, or one of the City's representatives on the Metropolitan Authority, could bring this matter to the attention of the staff of the Authority to see if a further effort can be made to clean up the site.

Question Alderman Sullivan re: Fencing for Wanderers Grounds

Aldermah Sullivan stated that the senior baseball group are seeking some kind of fencing for the centre field area of the Wanderers Grounds. He stated there is some fencing by the Forum which has not been used for some time, and requested that staff see if there is fencing available to use this summer for the Wanderers Grounds.

Question Alderman Sullivan re: Field Space for Sports Activities

Alderman Sullivan stated he has received several requests for field space to play soccer, baseball, etc. and requested that staff investigate to determine whether there is a possibility of obtaining another field somewhere in the North end for such purposes. He asked that staff of the Recreation Department identify any space they feel might be available for such purposes in peninsular north.

Question Alderman Maley re: Sidewalks Marked for Repairs

Alderman Maley stated that last year staff marked sidewalks in the City where repairs were to take place and in many instances these repairs have not materialized although the markings remain. She requested a report from staff on the process used to identify what work has been undertaken and what remains to be done.

Question Alderman Maley re: Street Cleaning Program

Alderman Maley requested that the street cleaning program commence with some earnestness, particularly such streets as South Street, Barrington Street, Cogswell Street, Robie Street, etc.

Question Alderman Shannon re: Notice on School Grounds re Dog Ordinance

Alderman Shannon requested a staff report on how soon signage re the Dog Ordinance will be erected on school premises.

Question Alderman Shannon re: Resolutions for Union of Nova Scotia Regional Meeting

Alderman Shannon noted a date will be set shortly for the Union of Nova Scotia regional meeting and asked that any members of City Council who wish to present resolutions to the annual meeting submit them to her within the next two to three weeks.

Question Alderman Shannon re: Mobile Canteen Regulations

Alderman Shannon requested that staff provide a status report on mobile canteen regulations.

Question Alderman Hamshaw re: Dunbrack Street at Ross Street

Alderman Hamshaw noted that recently there has occurred a serious accident at the intersection of Dunbrack and Ross Streets. He noted that there are five light standards missing at that intersection and asked what is wrong with the grade of the roadway at that location. He requested that staff advise why a flashing light cannot be installed at the intersection to warn motorists.

Question Alderman Hamshaw re: Concrete Cradles - Rockingham Sewer Installations

Alderman Hamshaw stated on January 9 installation of sewer pipe was underway in front of his residence, and on April 15 the pipe was replaced, noting that there are four breaks in the pipe on Oakhill Drive, suggesting that it is all caused by the concrete cracking and splitting the sanitary sewer pipes in the north Rockingham area.

He asked who is responsible for costs for replacing the pipes. He stated he has raised the matter before and wishes to have straight answers and all members of City Council be so informed.

Question Alderman Wooden re: Sports Field Area in South Spryfield

Alderman Wooden stated she wished to again ask staff to find a sports field area in South Spryfield. She noted the area has no recreation field.

Question Alderman Wooden re: Litter on School Grounds

Alderman Wooden asked who is responsible for the litter on school grounds, and wondered why some schools do not seem to have the problem others do.

Question Alderman Wooden re: Minutes of School Board Meetings

Alderman Wooden asked if the Board of School Commissioners is forwarding the minutes of their meetings and not just the summary of motions.

Question Alderman Wooden re: Policy in Commercial Areas re Sidewalk Paving of Driveway Widths

Alderman Wooden requested that staff advise what the policy is in commercial areas re sidewalk paving of the driveway widths as she finds that around the City there seems to be a considerable amount of sodding that is damaged because trucks use more than the sidewalk widths. She stated that it would look much better to be concreted all the way across rather than have muddy holes and asked that staff look at new construction to see if some of the problems could be cleaned up.

Question Alderman Wooden re: Members of City Council -Attendance at School Board Meetings

Alderman Wooden asked if members of City Council, who are not members of the Board of School Commissioners, may attend meetings of the Board of School Commissioners designated as Committee of the Whole.

Question Alderman Maley re: Minutes of Boards, Commissions Committees, etc.

Alderman Maley asked that the City Manager advise whether Boards, Commissions and Committees are complying with a previous request by City Council for copies of minutes of meetings.

Question Alderman Downey re: Overhead Sign - Brunswick and Cornwallis Streets

Alderman Downey asked if the overhead stop sign installed at the corner of Brunswick and Cornwallis Streets could flash during the day as well as at night.

Question Alderman Downey re: Clean-Up Week

Alderman Downey stated he is aware that staff pick up general garbage weekly but it is his understanding that there is some debris that the garbage collectors do not pick up because it is not appropriately tied, etc. He asked if a clean-up week could be held in May.

The City Manager advised that funding for a clean up week has been eliminated from the budget and noted that articles will be picked up weekly by garbage collectors. He suggested that Alderman Downey inform him of the instances where garbage has not been picked up and he will have the matters rectified.

Motion passed.
