Alderman Maley advised that the recent application was a different type in that it became necessary because of the work being done on Granville Street during this year.

Alderman Sullivan stated that it is generally agreed that once a spray program is commenced, continued spraying is necessary. He asked if staff have considered in a selective spray program a way to release the City from a spray program using a selective method of spraying along with some other programs. He expressed concern re the implications of having to spray in future years because of commencing a spray program this year. Mr. Connell advised that the City will be doing selective spraying and will only spray where predators have been located, leaf miner, etc. He added that the other part of the program would be the sanitation program which is to remove the dead limbs, etc. which is an ongoing program.

After considerable discussion during which members of Council expressed concern and frustration with the conflicting scientific evidence upon which a decision had to be made, it was MOVED by Alderman Maley, seconded by Alderman Shannon that the City of Halifax do no spraying of trees this year. The motion was put and passed with Aldermen Sullivan, Wooden and Deputy Mayor Hanson voting against.

Parking Meters - Quinpool Road

QUESTIONS

Question Deputy Mayor Hanson re: Larry O'Connell Field

Deputy Mayor Hanson stated that last year considerable concern was expressed re the location of the play equipment and repairs to the area around the Club house at Larry O'Connell field. He noted that the work has not proceeded as quickly as it could have and he requested that staff give the matter a higher priority.

Question Alderman Sullivan re: Drainage Problem on Kaye St.

Alderman Sullivan stated there is a problem with drainage on Kaye Street which seems to be emanating from the Young Street area. He asked if staff would again look at Young Street between Needham and Gottingen Streets to see if the source of the water can be determined. He further requested that staff contact the Public Service Commission re the matter.

Question Alderman Sullivan re: Legislation re New Heating Systems in Homes, etc.

Alderman Sullivan stated a couple of months ago he requested that staff bring forth legislation re the installation of new heating systems in homes, etc. He asked that staff advise in an information report the status of the proposed legislation.

Question Alderman Clarke re: Seaview Park

Alderman Clarke requested that staff advise what the future plans are regarding the Seaview Park area.

Question Alderman Clarke re: Buy Out Costs For the Assets of the Halifax Transit Corporation

Alderman Clarke asked that an up-to-date report be submitted re discussions with the Government concerning the buy out costs for the assets of the Halifax Transit Corporation.

His Worship advised that recent indications are that progress is being made in the discussions.

Question Alderman Wooden re: Landscaping Project at Graves Oakley Park

Alderman Wooden stated that there has been no progress by the contractor re the landscaping project at Graves Oakley Park since late last year. She asked that the contractor advise City Council whether he intends to carry out the terms of the contract or whether it should be awarded to someone else.

His Worship suggested that notice be served on the contactor that his tenders will not be acceptable to the City henceforth until he rectifies this matter.

The City Solicitor suggested that the City should enforce the terms of the contract and the action suggested by His Worship.

Question Alderman Meagher re: Trucks Damaging Curbs

Alderman Meagher stated he received an information report re the problem of trucks driving over curbs. He stated the problem is increasing and asked that the matter be added to the next regular meeting of Committee of the Whole Council.

Question Alderman Meagher re: Fountain at Commons

Alderman Meagher asked when it is expected that the fountain at the Commons will be in operation.

The City Manager stated that the fountain is now operating.

Question His Worship the Mayor re: Northwest Corner of Spring Garden Road and Barrington Street

His Worship stated that at the northwest corner of Spring Garden Road and Barrington Street transit buses are moving up over the curb and breaking the drain. He suggested that perhaps the lanes on Spring Garden Road could be moved further to the south. He asked that staff have a further look at the matter.

Question Alderman Sullivan re: Sodding on Hennessey Place

Alderman Sullivan asked if the City is going to resod the portion of boulevard on Hennessey Place where the equipment for the new sewer on Hennessey Street is being stored. The City Manager advised that staff normally replace damaged grass with sods.

if Council was to deal with the matter of funding, the matter would be reconsidered again at the next Board meeting. He added that he thought Council had made the point that it was prepared to back its motion with any necessary funding, but apparently the message was not conveyed or did not reach the School Board.

Alderman Clarke stated his intention to move two motions, one, that the School Board reconsider Council's request of making the age change and, two, Council advise the School Board if additional funding were necessary, it would be forthcoming. He stated he would seek the advice of the City Manager as to how that could be done.

Alderman Clarke referred to a meeting held in the Council Chamber on April 14, 1980, with the Chairman and members of the School Board present at which Alderman Maley raised the matter of what funding would be needed and how it would be managed. He suggested the consensus at that time was that it would be handled by means of a supplementary matter in the fall.

His Worship stated he is not opposed to the content of the motion but reiterated his opposition to the manner in which the matter is being dealt with. He advised of information given by the Chairman of the Board of School Commissioners during a telephone conversation this date. His Worship drew Council's attention to Section 159(m) of the Halifax City Charter and stated, in his view, City Council cannot appropriate funds without asking the City Manager.

Alderman Hamshaw stated that City Council has requested information from the School Board relating to the number of children attending primary classes and a response has not been received.

Deputy Mayor Hanson advised that he was unable to attend the Board of School Commissioners meeting due to a very serious personal matter but he did contact the Chairman of the Board and urged him to address the Board and ask them to set up a meeting with Halifax City Council to discuss this very important matter.

Alderman Wooden stated a principal has expressed concern to her re the primary/grade 1 mix. She suggested that City Council consider the matter before next year and encourage the Board to not allow a mix at the primary/grade 1 level.

Alderman Sullivan stated there was some confusion as to whether or not the funding was going to be forthcoming as it was not included in the motion presented to the Board of School Commissioners at its meeting on May 13, 1980.

MOVED by Alderman Clarke, seconded by Alderman Hamshaw that Halifax City Council request that the Halifax School Board reconsider the request of City Council that the school age requirement be changed from October 1 to December 31 of the calendar year, commencing September 1980. Motion passed.

MOVED by Alderman Clarke, seconded by

Alderman Hamshaw that Halifax City Council advise the Halifax School Board that it will approve and provide the necessary funding which may be needed if increased costs are incurred to the budget of the Halifax School Board as a result of this implementation of this policy change.

He requested that the City Manager or City Solicitor advise if the motion is contrary to the Halifax City Charter provisions. Alderman Clarke explained that the motion is one of intent rather than the mention of specific funds as he suggested the specific funds needed cannot be truly identified.

Alderman Clarke stated he would be prepared to defer the foregoing motion until the next regular meeting of Committee of the Whole Council for an opinion from the City Solicitor. He further noted that the next meeting of the Board of School Commissioners is scheduled for May 27, 1980, and he would welcome any presentation the School Board wished to make to Council prior to their meeting.

Alderman Clarke requested that the City Manager pass the contents of the motion along to the Chairman of the School Board for him to determine whether it is what he is seeking from City Council and, if it is deficient, the City Manager bring back a recommendation which would include what the Chairman of the Board of School Commissioners is seeking. He stated he wishes to send to the School Board a motion which would satisfy their particular requirement from Halifax City Council, knowing that if increased costs were incurred the School Board could return to City Council for additional funding, without argument from City Council.

Alderman Moore stated he is not satisfied that the additional funds could not be handled within budget and advised that, to assist the City Manager, he is certainly prepared to entertain a review of priority of projects that might pertain to Ward 9, if a reallocation or movement of funds within the budget is required.

MOVED by Deputy Mayor Hanson, seconded by Alderman Wooden that the City Manager ask the Chairman of the Board of School Commissioners if the Board members and the Director of Education would meet privately with members of Halifax City Council at 12:30 p.m. on Wednesday, May 21, 1980. Motion passed.

Interest Rate on Overdue Taxes - His Worship the Mayor

His Worship asked if it was agreed and understood that staff will apply a rate 2% on prime at the time of the payment of the second installment for taxes. The City Manager responded in the negative.

The City Manager suggested that the matter be referred to the next regular meeting of Committee of the Whole Council at which time the necessary information would be available.

Meeting adjourned - 11:00 p.m.

Special Council May 21,1980

Case No. 3808 - CONTRACT DEVELOPMENT - 1585 OXFORD STREET

A public hearing regarding the above matter was held at this time.

Mr. E.B. Algee, Development Control Department, with the aid of maps, addressed members of Council on this application. Mr. Algee advised this was an application for contract development under Section 83 (Schedule C) of the Zoning Bylaw, peninsula area for a property located at 1585 Oxford Street, for permission to use one of the apartments as an office for several businesses. The building was built in 1959 and contained 47 apartment units. At present, there are 46 units in this building. Mr. Algee advised there were five companies operating from this building managing eleven apartment buildings in the City. Mr. Algee advised it was staff's recommendation to refuse the application because it does not meet the Municipal Development Plan policies, in particular Policy 1.4. The building is located in a low density neighbourhood with a professional building in the area and some R-3 in the area of Coburg Road.

Mr. Algee responded to questions from members of Council.

Mr. Elwin MacNeil, counsel for the applicant, addressed members of Council in support of the application. Mr. MacNeil advised this was the residence of Mr. Fletcher Smith, the President of Parkdale Realties and A.M. Smith & Sons Limited. The area used for the accounting purposes is less than 400 feet, and there is no public access, the only entry being if one possesses a key. Mr. MacNeil submitted two submissions containing a petition containing the signatures of all but one of the residents of this building, which is a part of the official file of this meeting.

There were no other persons present wishing to address members of Council in support of the application.

Mr. Keith Vaughan, Chairman, Ward II Planning Committee, addressed members of Council in opposition to this application. Mr. Vaughan stated this use in a R-3 zone is a violation and should not be permitted. The building is in a residential neighbourhood and is surrounded on three sides by single family and duplex residences. Mr. Vaughan further stated that approval of this contract could open the way for other proposals and would lead to change in character and destruction of the neighbourhood. On behalf of the Ward Two Residents, Mr. Vaughan recommended that the application be refused and the business be encouraged to relocate in a commercial area.

There were no other persons present wishing to address Council in support of or in opposition to this application.
