At the request of Alderman Shannon, Council added:

A supplementary staff report dated June 20, 1980, was submitted as well as information reports dated July 4, 1980 and July 30, 1980. In addition, letters dated June 26 and July 23, 1980, were submitted from Peter J. E. McDonough of McInnes, Cooper & Robertson.

MOVED by Alderman Hamshaw, seconded by Alderman Downey that City Council:

Alderman Shannon noted that at the last meeting, a question was asked of staff relating to how Council could create a schedule "E" when one already exists. Alderman Shannon noted the City has implementation policies which address the matter saying she would like to know from staff how the extension of Schedule "E" is going to work. Alderman Shannon asked whether staff have addressed the implementation policies and the matter of how a new Schedule can be created. Alderman Shannon noted a supplementary report was submitted but it did not address the concern which she expressed.

Alderman Shannon requested a statement from staff relating to whether Council can create a Schedule and whether Council can rezone into a Schedule without being in violation of the implementation policies.

Members of staff in attendance were not able to respond to the question however, the Director of Planning in advising that he had only reviewed the matter briefly, expressed the view there may be problems with the implementation policies in the Plan. Mr. Matthews advised that he would prefer not to give an opinion at this time and would prefer to review the matter.

Deputy Mayor Sullivan expressed the view that the matter should be clarified and <u>MOVED</u>, seconded by Alderman Shannon that the matter be deferred to the next regular meeting of the Committee of the Whole Council.

Motion to defer was put and passed.

"If the Grantee does not pay the tax when due, he shall pay interest at a rate equal to the current rate of interest on outstanding taxes or any portion of the tax remaining unpaid, beginning twenty days after the date of transfer, and a penalty of ten per cent on any tax or portion thereof, which remains unpaid after twenty days from the date of the transfer."

Motion passed.

Disposal of Public Service Commission Properties

MOVED by Alderman Wooden, seconded by Alderman Hamshaw that the City of Halifax approve the sale or disposal of approximately 4,000 acres of land situated in the Long Lake-Spruce Hill Lake area, owned by the Public Service Commission of Halifax, to the Province of Nova Scotia for the purpose of establishing a recreation area and other public purposes.

Alderman Clarke noted that in December of 1979, a Motion was approved by Council authorizing staff to review and submit a report to Council on the annexation of lands owned by the Public Service Commission saying he would like to know what became of the intention of that motion.

Alderman Maley expressed the view that Council should rezone the area to Park and indicated she would like to see staff supply a report with respect to the rationale for a park of the size proposed and for the intended use of the land.

Further discussion ensued and the Motion was put and passed with Aldermen Downey, Meagher, and Clarke against.

Alderman Maley proposed a Motion that Council commence the process, including a public hearing, to rezone the lands within the City limits to Park, and Alderman Moore suggested that perhaps Council should first receive a report from staff relating to the control Council would want to see exercised on the land.

Alderman Moore suggested that if Council is not satisfied the proper control exists which Council would wish, then the lands could be rezoned to Park.

Council then agreed that the matter of the proposed rezoning of the watershed lands within the City to Park, be referred to staff for review and report.

Alderman Wooden advised that she would like staff to provide a report with respect to the ecological damage that could be caused by the development of any of the lands in question. Alderman Wooden suggested a number of studies have been done and asked if staff could supply some summaries of those studies especially the Preston Sumard one.

Alderman Downey questioned whether staff is of the opinion that the price being received is the best price the City can obtain over the years.

His Worship, in referring to the questions raised, advised that staff will comment as quickly as possible.

QUESTIONS

Question Alderman Hamshaw Re: Concrete Cradles

Alderman Hamshaw referred to a recent information report which he received in response to previous questions with respect to the use of concrete cradles for underground pipes and suggested the information received in the report indicates that inspections of such installations by staff are not adequate.

His Worship suggested that perhaps a meeting could be arranged between the Mayor, Alderman Hamshaw, and appropriate staff to discuss the problem and Alderman Hamshaw indicated that he would favour such a meeting. His Worship indicated he would arrange such a meeting.

Question Alderman Maley Re: Responsibility for Grass Cutting

Alderman Maley referred to the area between the street curb and the sidewalk and asked for an answer as to whose responsibility it is to see that the grass in such areas is cut.

Question Alderman Maley Re: Basement Excavation, Permit and Insurance Requirements

Alderman Maley advised it has come to her attention that instead of using a method of blasting for the excavation of basements which requires a permit and insurance, a new method is starting to be used involving a machine for which there is no requirement for a permit or insurance. Alderman Maley advised it is her understanding the machine does cause some damage and suggested the matter should be reviewed by staff suggesting it may be there should be a requirement for a permit.

Question Alderman Shannon Re: Schedule - Touch Football

Alderman Shannon advised that persons involved in touch football are experiencing difficulties obtaining a schedule from the Recreation Department and asked if she could be supplied with a schedule.

Question Alderman Shannon Re: Boulevard - Robie Street

Alderman Shannon referred to the boulevard on Robie Street outside the Dalhousie Dental building which was torn up by the contractor and never repaired and requested the matter be looked into to see whose responsibility it is.

Question Alderman Downey Re: Street Sweeper

Alderman Downey advised that the automatic street sweeper has not been operating in the North End for some time saying he would like to see some of the side streets in the area cleaned. The Director of Works indicated that such action would be taken.

Question Alderman Meagher Re: Boulevard, Monestary Lane

Alderman Meagher referred to the boulevard on Monestary Lane near the Canadian Tire Store which was to be repaired but noted that the work has not been started to date.

The Director of Works advised the work is scheduled and that it will be completed.

Motion passed.

Maritime Accessories Limited - Release of Contract Zoning

A staff report dated July 29, 1980, was submitted.

MOVED by Alderman Meagher, seconded by Alderman Sullivan

that:

1. City Council rescind the approval of City Council dated April 12, 1979 permitting the construction by Maritime Accessories Limited of a 10,000 square foot warehouse at 7035 Chebucto Road;

2. Authorize the Mayor and City Clerk to execute the agreement attached to the staff report dated July 29, 1980 as Schedule "A" discharging the development agreement respecting this case; and

3. Rescind the development permit with respect to the development.

Halifax Relief Fund

The above item was added at the request of Alderman Downey who advised that he has received a number of calls from persons enquiring as to whether their pensions are to be increased. Alderman Downey asked whether the Provincial or Federal Governments will be releasing the funds.

Alderman Meagher asked whether it would be possible to have someone in the Social Assistance Department appointed to assist the various pensioners etc. with their claims and renewal applications. Alderman Meagher requested that the City Manger's office give consideration to the matter of having someone who would be responsible for such action before the Pension Review Board.

His Worship advised that a letter has been forwarded to Ottawa requesting release of the funds but that no response has been received.

Alderman Clarke advised that he would like to know who has the legal jurisdiction and final determination with respect to the funds. Alderman Clarke said he would also like to be advised of the number of pensioners remaining and to have the claims reviewed to see if pensions can be upgraded. Alderman Clarke requested further information from staff on the matter including whether the City has any jurisdiction.

The Director of Finance said it was his understanding that during the final wind-up, the City was to be consulted on the matter but it has been difficult to obtain a response to date.

Social Assistance Payments

The above item was added at the request of Alderman Downey who advised that since the coming into force of the new Social Service Act in July, problems have been encountered with senior citizens obtaining drugs and glasses. Alderman Downey asked whether the Province would be increasing the allowances or whether the City would be paying the extra amount.

The City Manager advised that a report is being prepared on the matter and would be submitted to Council shortly.

Snow Plowing - Monestary Lane

The above item was added to the agenda at the request of Alderman Meagher who noted that since the completion of the Quinpool Road project, the sidewalk has been replaced on the west side of the street with there being no clear area left between the street and the sidewalk. Alderman Meagher suggested this will cause problems in the winter time when the street is plowed in that the snow will be pushed onto the sidewalk causing problems for the abuttors who are required to shovel the sidewalk. Alderman Meagher asked that staff look at the west side of Monestary Lane between Allen and Yale Streets to see what methods the City will use in keeping the sidewalk clear during the winter. Sidewalks - Windsor Street

The above item was added to the agenda at the request of Alderman Meagher who advised that he received a letter from a resident on Windsor Street. Alderman Meagher advised he has been attempting to get improvements made to the block from Charles to Cunard Streets on the east side for some time and noted it has been patched for the past three years. Alderman Meagher said that one of the residents on the street was recently injured on the sidewalk and requested that the matter be reviewed to see if repairs can be made to the sidewalk. Alderman Meagher forwarded the letter to staff for review.

191 Herring Cove Road

The above item was added to the agenda at the request of Alderman Wooden who advised that the property in question has been boarded up for some time. Alderman Wooden said the matter has been forwarded to the Legal Department for action but said it was her understanding the City has power to bring the property up to standards.

Alderman Wooden advised she has received a great number of calls with respect to the property in question and she would like the City to unboard the windows and clean up the property and not wait for the legal action to be taken.

His Worship advised that the matter would be referred to staff and that Alderman Wooden would be contacted.

Legislation Re: Deteriorating Buildings & Derelict Vehicles

The above item was added to the agenda at the request of Alderman Wooden who suggested the City requires better legislation to deal with the above-noted problems. Alderman Wooden said she would like to see draft legislation brought before Council within the next month to deal with such problems.

Fire Regulations - City Hotels

The above item was added at the request of Alderman Shannon who requested a report from the Fire Chief with respect to fire regulations in hotels and who is to notify guests of evacuation procedures.

Energy Conservation Measures - New School Buildings

The above item was added at the request of Alderman Maley who referred to the new school building to be built in Spryfield and felt Council should request that energy conservation be taken into account by the Department of Education when approving the design of the Elizabeth Sutherland School.
