time.

PRESENT: His Worship Mayor Ron Wallace, Chairman; Deputy Mayor Clarke and Aldermen Maley, Downey, Meagher, O'Malley, Wooden, Hanson, Jeffrey, LeBlanc, Flynn and Hamshaw.

ALSO PRESENT: Acting City Manager, Acting City Solicitor, City Clerk and other members of staff.

His Worship welcomed Reverend Dr. Charles Anderson to the meeting and Dr. Anderson addressed members of Council thanking them for their support for the City's residents; the dedication of Balcom Square and expressed the wish that the City of Halifax be kept as clean as possible. Members of Council attending, joined Rev. Dr. Anderson in reciting the Lord's Prayer.

The Halifax Chapter Full Gospel Church Businessmen presented a poem " Only A Layman ", composed by Charles Anderson, to His Worship and Members of City Council. Remarks by the President, Mr. Nick Swart, and the recitation of the poem followed. His Worship the Mayor and Deputy Mayor Clarke, on behalf of all members, expressed thanks to the Chapter for their presentation.

The City Clerk advised that Aldermen O'Malley, LeBlanc and Flynn were not present at the public hearing.

Motion put and passed with Aldermen O'Malley, LeBlanc and Flynn abstaining.

Alderman O'Malley advised that a report from the City Solicitor to clarify the City's position in this matter has been requested and has not as yet, been received.

MOVED by Alderman O'Malley, seconded by Alderman Flynn that the matter be deferred until a report from the City Solicitor confirming the sale has been completed.

REPORT - FINANCE AND EXECUTIVE COMMITTEE

Council considered the report of the Finance and Executive Committee from its meeting held on March 4,1981, as follows:

Appointment of Special Collectors of Rates and Taxes

MOVED by Alderman Maley, seconded by Alderman LeBlanc that, as recommended by the Finance & Executive Committee, Rupert J. O'Shaughnessy, City Collector and Kenneth E. Dunsworth, Senior Collector, and Emhen R. Ehler, Outside Collector, be appointed special collectors of rates and taxes under the authority of Section 122(1) of the Assessment Act of the Province of Nova Scotia.

Tenders 81-45 to 81-51 Inclusive - Disposal of Surplus Vehicles

MOVED by Alderman Hamshaw, seconded by Alderman Flynn that, as recommended by the Finance and Executive Committee, each tender be awarded to the highest bidder as indicated by an asterisk in Appendix "A" attached to the staff report dated February 16,1981. Motion passed.

Supplementary Report - Local Improvement Charges

MOVED by Alderman O'Malley, seconded by Alderman Maley that, as recommended by the Finance and Executive Committee, the 1981 Local Improvement Rates as shown in Appendix "A" of the report dated December 8,1980, be approved.

Motion passed.

Smoking Ordinance No. 172

MOVED by Alderman Maley, seconded by Alderman Wooden that \$3,000 be released from the City Manager's 1981 budget to provide samples of the smallest no-smoking signs for the public and the school system.

The above motion was not dealt with.

Discussion on the matter followed, and it was MOVED by Alderman Hanson, seconded by Deputy Mavor Clarke that monies be allocated, amount to be determined by the City Manager's Office so that the City of Halifax may acquire and post enough no - smoking signs for City-Owned buildings. The Motion was put and passed with Aldermen Downey, O'Malley, Jeffrey and Hamshaw voting against.

Alderman Maley requested that staff prepare a report on the best way of communicating to the public the matter of the No Smoking Ordinance, as well as the Dog Ordinance, including costs of advertising. - 98 -

Alderman Wooden advised of concern with a bus bay to be located in that area. Alderman Wooden requested the matter be deferred at this time and staff from Engineering & Works and Metro Transit be asked to prepare a report on the matter.

Possible Expropriation Settlement - Parcel 100, Civic No. 56 Kearney Lake Road

MOVED by Alderman Hamshaw, seconded by Alderman Jeffrey that, as recommended by the Finance & Executive Committee, the expropriation of Parcel 100, as shown on Plan TT-19-20917 be settled for \$2,647. plus simple interest of 6% on \$1,947. from Jan. 22nd, 1975 to respective dates of payment; funds to be made available from Account # 227418 20500 EH016 (Dunbrack Street Land Acquisition Account).

Motion passed.

Quinpool Road Project

MOVED by Alderman Meagher, seconded by Alderman Maley that, as recommended by the Finance & Executive Committee, City Council grant the extension of the date of commencement of construction to March 15,1982, provided that the Willowgate Development Corporation agree to pay monthly to the City, the interest on the purchase price (\$486,500) at the rate of 15% from March 16,1981, until the commencement of construction or March 15, 1982, whichever comes first.

Pensions for Retired Persons

MOVED by Alderman Jeffrey, seconded by Alderman Meagher that, as recommended by the Finance & Executive Committee, John Wrin and Mr. Joe Power meet with the Retirement Committee on behalf of the retired employees of the City of Halifax and a report from the Retirement Committee be submitted to Committee of the Whole Council on April 8,1981.

REPORT - COMMITTEE ON WORKS

Council considered the report of the Committee on Works from its meeting held on March 4,1981 as follows:

Bus Stop - Alderman Jeffrey

MOVED by Alderman Jeffrey, seconded by Alderman LeBlanc that, as recommended by the Committee on Works, City Council request the Transit Corporation to move the bus stop presently locaed at Vimy Avenue between Titus Street and Dutch Village Road to the corner of Vimy Avenue and Dutch Village Road, or near the Capitol Store Corner.

A short discussion followed, and the Motion was put and passed with 6 voting for; four against and Deputy Mayor Clarke abstaining on grounds of conflict of interest.

MOVED by Alderman Maley, seconded by Alderman Hanson that, as recommended by the Committee on Works:

- Tender # 81-09 for projects, materials or services as listed in Appendix "A" attached to the staff report dated February 20,1981, be awarded to Municipal Spraying and Contracting Ltd. for the unit prices quoted;
- 2. Project funds be authorized from Accounts CA068 CA080;
- 3. Funding transfers be approved as shown in the staff report dated Pebruary 20,1981.

Motion passed.

Award of Tender No. 81-12 - Sidewalk Renewals

MOVED by Alderman LeBlanc, seconded by Alderman O'Malley that, as recommended by the Committee on Works:

- Tender # 81-12 for Sidewalk Renewals be awarded to Steed & Evans Limited for the unit prices quoted.
- Project Funds be authorized from the Accounts as shown in Appendix "A" attached to the staff report dated February 23, 1981;
- 3. Funding Transfers be approved as shown in the staff report dated February 23,1981.

His Worship referred to the matter and asked if consideration is given to a number of firms during the tendering call. Mr. Sullivan, Engineering and Works, advised the department policy.

The Motion was put and passed.

REPORT - CITY PLANNING COMMITTEE

Council considered the report of the City Planning Committee from its meeting held on March 4, 1981 as follows:

Case No. 3745 - Development Agreement - Sobeys, Windsor Street

At the City Planning Committee, the following Motion was put and Lost:

"That a date be set for a public hearing to consider the inclusion of a drug store and delicatessen in Sobeys Super-market on Windsor Street."

A supplementary staff report dated March 10, 1981 was submitted.

A letter dated March 12, 1981 was submitted from Mr. Hugh K. Smith of Stewart, MacKeen & Covert as well as a letter dated March 12, 1981 from Mr. David F. Sobey, President of Sobeys.

MOVED by Alderman Meagher, seconded by Alderman LeBlanc that a date be set for a public hearing to consider the changes proposed to the contract development agreement by the applicant including the inclusion of a drug store and delicatessen in Sobeys Supermarket on Windsor Street.

A discussion and questioning of staff ensued on the matter and Mr. Hugh Smith addressed Council in connection with the application. In reply to a question, Mr. Smith indicated the company was surprised it could not proceed, suggested it has not breached the contract, and expressed the view that staff is of the same opinion.

Further discussion and questioning of staff ensued on the matter and the Motion was put and Lost.

MOVED by Alderman Maley, seconded by Alderman Flynn that in the matter of Case #3745 between Sobeys and the City of Halifax, Council allow the delicatessen and drug store, with separate entrances, in the supermarket presently under construction.

Motion passed.

Case No. 3952 - Contract Development - 1379-99 LeMarchant Street - SET DATE FOR PUBLIC HEARING

MOVED by Alderman Maley, seconded by Deputy Mayor Clarke that, as recommended by the City Planning Committee:

1. A date be set for a public hearing to consider the contract devleopment application under Schedule 83 of the Zoning Bylaw, Peninsula Area, to permit the conversion of Civic No. 1397-99 LeMarchant Street from a duplex dwelling to a 3-unit apartment building; and

2. The application be referred to the Planning Advisory Committee, in particular, for resolution of the lot size standards.

A report dated March 8, 1981, was submitted from the Vice-Chairman of the Planning Advisory Committee containing recommendations which were read by Alderman Maley.

The Acting City Manager, in referring to recommendations 2 & 3 from the Planning Advisory Committee, suggested that Council should receive some legal advice on the matter and advised that a report would be prepared.

Motion passed.

The City Clerk advised that the public hearing has been scheduled for Wednesday, April 8, 1981 at 7:30 p.m. in the Council Chamber.

Case No. 3928 - Contract Development and Lot Consolidation -2020-2036 (Lot Z) Gottingen Street

MOVED by Alderman Downey, seconded by Alderman Maley that, as recommended by the City Planning Committee, the application for lot consolidation and contract development to allow construction of the Vimy Arms project at 2020-2036 Gottingen Street, be refused.

Motion passed.

MOTIONS:

Motion Deputy Mayor Clarke Re: Amendments to Ordinance No. 133, the Emergency Measures Civil Defence Organization Ordinance - FIRST READING

Deputy Mayor Clarke presented a Notice of Motion at the February 26th meeting of Council relating to the above item.

Proposed Amendments to the Ordinance were submitted.

MOVED by Deputy Mayor Clarke, seconded by Alderman Hanson that the proposed amendments to Ordinance No. 133, be read and passed a First Time by City Council, as submitted.

Motion passed.

MISCELLANEOUS BUSINESS:

Building Permits - Old South End

A staff report dated March 11, 1981, was submitted.

MOVED by Alderman Maley, seconded by Alderman Downey that Council indicate no objection to the permits for applications that are listed in the staff report dated March 11, 1981.

Motion passed.

Alderman O'Malley suggested the applications should be explained more fully to Council and expressed the desire that in future reports, Council can receive a better explanation as to why it should be approving the applications.

Winwick Subdivision

Two letters dated March 5, 1981 were submitted from Mr. G. B. Robertson, Q.C., of McInnes, Cooper & Robertson on the matter.

Alderman Jeffrey advised there are about ten homes in the subdivision and expressed the view that all the owners have signed a petition opposed to the installation of sidewalks. Alderman Jeffrey questioned why a small subdivision such as the one in question would be forced to have sidewalks installed and asked if there is any way the Bylaw can be changed and whether Council has any input into the Bylaw.

His Worship advised of a report from the Development Officer dated March 10, 1981 which some members of Council had not received.

MOVED by Alderman Jeffrey, seconded by Alderman Hamshaw that the item be deferred to the next regular meeting of the Committee of the Whole Council and that the report be circulated to all members of Council.

Motion passed.

Request for Amendment to the Zoning Bylaw - Mediacom Incorporated

Two letters, one dated March 2nd and the other dated March 6, 1981, were submitted from G. C. Findlay, Vice-President Maritimes, of Mediacom.

MOVED by Alderman O'Malley, seconded by Alderman Maley that the request from Mediacom be referred to the Planning Department for a staff report.

Motion passed.

QUESTIONS

Question Alderman Hanson Re: Intersection of Herring Cove Road and Cowie Hill Road

Alderman Hanson referred to the above intersection and asked if it could be assessed for the adequacy of street lighting, if a crosswalk could be safely installed going from the Cowie Hill Road to the east side of the Herring Cove Road toward the bus stop, and if the traffic counts warrant the street lights that have been partially installed but which have not been completed. Alderman Hanson asked for a report on the matter.

Question Alderman LeBlanc Re: Market Place Plaza

Alderman LeBlanc referred to a letter received from a Mr. Epstein regarding the Market Place Plaza and asked if staff have had an opportunity to peruse it and the Acting City Solicitor advised that the Legal Department has responded to the letter. In reply to a further question, Mr. Anstey also advised that Mr. Stapells was supplied with a copy of the letter from Mr. Epstein as well as the Department's reply.

Alderman LeBlanc also referred to the possibility of the matter being appealed to the Supreme Court and asked whether any of the Committees which the City funds are any party to the appeal. The Acting City Manager advised that staff would have to check into the matter.

Question Alderman Meagher Re: Sobeys Building, Windsor Street

Alderman Meagher asked for a report on whether any inspection is made by City staff or at the direction of staff in connection with the houses in the area of the Sobeys Building which might be affected by blasting or the digging of the foundation, and the City Manager advised that staff would have to report on the matter.

Question Alderman Hamshaw Re: Cable Television Coverage

Alderman Hamshaw indicated he has been contacted regarding the television coverage of meetings and asked if there is any way Council can request better camera coverage at meetings or to have it removed. Alderman Hamshaw asked that the subject be placed on the agenda of the next meeting of the Committee of the Whole Council for discussion.

Question Alderman Downey Re: 1465 Birmingham Street

Alderman Downey, in referring to the above building, said it was his understanding an amount of \$10,000 was available to repair the side of the building but that the City is now attempting to bill people for repairs. Alderman Downey requested a report on the matter. The Acting City Manager advised that a report is being prepared for submission at the April 8th Committee of the Whole meeting.

Question Alderman Downey Re: The Late William Carter

Alderman Downey submitted a report on the late William Carter and asked that it be forwarded to the Retirement Committee for consideration.

Question Alderman Maley Re: City Advertising

Alderman Maley requested a staff report concerning City advertising including information as to whether each department is responsible for its own advertising, and a review of advertising carried out by other municipalities.

Question Alderman Wooden Re: Winter Parking Ban

Alderman Wooden advised that she received some calls from persons who were under the impression that the Parking Ban had been lifted after hearing a report regarding the Dartmouth Ban being lifted. Alderman Wooden said she would like to make sure that in the future when the City lifts its parking ban, the advertising is strictly City of Halifax advertising and that staff relay these types of problems to the media if the media is giving out conflicting information.

NOTICE OF MOTIONS:

Notice of Motion Alderman Meagher Re: Notice of Reconsideration and Rescission - City Council resolutions of March 12, 1981 regarding Development Agreement - Sobeys, Windsor Street

Alderman Meagher gave notice that the at the next regular meeting of City Council to be held on March 26, 1981, he proposes to move reconsideration of the Motion of City Council on March 12, 1981 dealing with a public hearing for Contract Development of Sobeys on Windsor Street, and to move rescission of the Motion passed by City Council in the affirmative.

ADDED ITEMS

Proposed Meeting with the Members of the Legislative Assembly

His Worship noted that Council has discussed the matter of meeting with the Members of the House of Assembly and advised that he arranged a meeting with the Honourable Speaker of the House for Saturday, April 4th from 10:00 A. M. to 12 Noon in the Council Chamber. His Worship suggested that members of Council could advance subjects to be discussed but expressed the view that cost sharing would be one of the main topics.

His Worship also advised that individual letters were to be forwarded to the appropriate Members.

Alderman Maley suggested that staff should be asked to document what the cost sharing arrangements are for the meeting in order that Council will be prepared with factual information.

Alderman LeBlanc asked if another date would be determined if the one proposed is not an acceptable date for the Members of the House of Assembly, and His Worship replied in the affirmative.

Eskimo Sculpture - "Bird of Spring"

A staff report dated March 11, 1981, was submitted.

Alderman Wooden suggested that a letter of appreciation should be forwarded in response to the gift and His Worship concurred with the suggestion.

Following a short quastioning of staff, it was MOVED by Alderman O'Malley, seconded by Alderman Hamshaw that City Council accept the sculpture "Bird of Spring" and that it be located in Motion passed. Cheapside Park.

His Worship left the meeting and Deputy Mayor Clarke took the Chair.

Wanderers Grounds for Soccer

Alderman Maley advised it was her understanding that as a result of the upgrading of the Wanderers Grounds, both soccer and baseball sports could use the field. Alderman Maley said it has come to her attention that the Atlantic Soccer League has been refused access to the field over the summer months saying she would like to receive a written report from the Recreation Department before the next Committee of the Whole Council meeting as to why the Wanderers Grounds can not be shared by the Atlantic Soccer League and the baseball leagues that use it.

Police Commission

Alderman Maley noted that approval to proposed amendments to the Ordinance have now been received and asked that a meeting of the Commission be called and suggested that items for the agenda could be passed to the Mayor or Chairman.

Halterm Limited

Alderman O'Malley referred to efforts being made by the Mayors of Halifax and Dartmouth, the Premier, and the Minister of Development to have the Dart Container Line remain in Halifax. Alderman O'Malley also referred to an article in the newspaper by the President of Halterm which he proceeded to read from.

Alderman O'Malley asked that the City's representatives on the Board of Halterm appear before Council to give Council some indication of what Halterm is doing in terms of representing the funding of the City and that the City's representatives request that the Board review the position of Mr. Howard in terms of his loyalty to the citizens of Halifax and to the Corporation he represents. Alderman O'Malley requested that if such a review is undertaken, the results of that review be reported back to City Council by the City's representatives on the Board.

His Worship returned to the meeting.

A discussion ensued on the matter and the Chairman asked if Alderman O'Malley would agree to first seek a clarification of the remarks of the President to be sure he has been accurately quoted and that those words mean what they appear to mean.

Alderman O'Malley indicated he agreed with the suggestion and that Mr. Howard could be asked to appear before the Committee of the Whole Council on April 8th.

Further discussion ensued and Alderman Flynn, in referring to those who should be invited, expressed the view that that the Chairman of Halterm, Mr. Howard, and the City's two representatives should be invited.

The Chairman suggested that it be left with His Worship to solicit who should be at the meeting with the emphasis being placed mainly on the members of Halterm and a few others His Worship sees fit to invite.

The Chairman advised that the meeting was to be a cooperative effort to see what can be done to keep the Dart Line in Halifax.

Council then agreed that such a meeting should be arranged.

Public Meeting - St. Stephens Property

Alderman O'Malley asked that the City Clerk set up a public meeting of the residents of the Ward 5 area surrounding the former St. Stephen's Annex property early in the month of April preferably on a Monday evening, if possible.

His Worship took the Chair and Deputy Mayor Clarke took his normal seat in Council.

Committee on Concerns of Elderly Citizens

Alderman O'Malley noted that on January 7th., a meeting was held with a representative group of elderly citizens of the City and that on January 29th., Council approved the setting up of a Standing Committee composed of two Aldermen and six representatives from the City.

Alderman O'Malley advised that subsequent to that at a private meeting of members of Council, action on the formation of the Committee was delayed until some terms of reference were set up for the Committee. Alderman O'Malley expressed the view that unless the matter is put into motion, the Committee would not be filled.

MOVED by Alderman O'Malley, seconded by Deputy Mayor Clarke that the Committee be expanded from six to twelve representatives, one representative from each Ward in the City with that representative to be recommended to Council by the Alderman of the Ward and as far as is possible, that Committee to be representative of all the other human properties to which Council has addressed itself over the last months; that the Committee be formed as quickly as possible and that the Committee itself be allowed to establish a tentative set of objectives and tentative terms of references, and that this tentative mandate be forwarded back to Council for ratification, or change, if Council aces fit.

Following a short discussion, the Motion was put and passed with Alderman Maley and Wooden against.

Council Chamber City Hall Halifax, Nova Scotia April 4,1961 10:15 a.m.

A Special Meeting of the members of Halifax City Council was held at this time.

Alderman Flynn felt Provincial property receiving the same amenities as residential or commercial within the City should be taxed and questioned the manner in which the Province of Nova Scotia addresses itself within the formula.

Alderman Maley addressed members of Council and felt that some comparison should be made within the two citis since Halifax supports many events and should be getting assistance from the boundary municipalities. Alderman Maley felt that assistance to the City of Halifax is necessary for the residents, the visitors, and others to the area. With reference to industrial park development, Alderman Maley felt that regionalization is in place and it is unwise to service two nearby areas; with assistance necessary for the City of Halifax in the form of a 'catch-up' grant.

Alderman Meagher addressed members of Council and felt the City of Halifax should look to the creation of an industrial park and consider the past strategy for development as changed. Alderman Meagher felt that the City does not receive its' fair share and would suggest an amount given annually to assist, together with some aspect for development for the commercial basis of the City.

A Special Meeting of Halifax City Council was held at this time.

Deputy Mayor Clarke indicated that staff wished to have Contract Development - Spryfield Mall added to the agenda. It was so agreed by members of Council.

FORT NEEDHAM VIEWS

A public hearing regarding the above matter was held at this time.

Mr. Simpson McLeod, Planning, with the aid of maps and sketches explained in brief the action taken to protect the panaoramic views from Fort Needham Park of the inner harbour and Bedford Basin. Mr. McLeod also stated that the following were recommendations of staff:

That if Council wishes to extend the protection of the views from Fort Needham beyond the measures it has already taken, it is recommended that: City Council Amend Zoning Map M-16 to extend the Schedule "M" area to include the area bounded generally by St. Paul's Street to Newbury Street running eastwards to the Harbour on the north, as shown on Map 1 attached to the staff report dated February 6, 1981.

It is NOT recommended that Council impose any height limitations

Finally, it is recommended that Council refer this matter to the Industrial Development Commission for comment, now that that body has been re-established.

Mr. McLeod responded to questions on height limitation to members of Council.

Mr. Graham Hicks, a resident of the area, spoke to Council indicating that he felt there should be some height restrictions and that he supported the extension of the Schedule "M" area. He also encouraged Council to ensure that the views were protected by some means.

There were no further speakers present wishing to speak in favor of or in opposition to this case.

A submission was received from Petrofina Canada Incorporated, H.D. Wilson, Acting Regional Retail Development Manager, in opposition to the proposed height limitations and distributed at the Public Hearing on May 6, 1981.

MOVED by Alderman O'Malley, seconded by Alderman Meagher that the matter be referred to the next regular meeting of Halifax City Council without recommendation.

MORRIS STREET - POSSIBLE ALTERATION TO STREET LINES

"WHEREAS Dart Container, Lines, a regular user of the container facilities and services of Halterm Limited at Halifax, Nova Scotia for the past 12 years, has announced its intention to transfer its operations to the Port of Montreal;

AND WHEREAS it appears a factor in the decision of Dart Container Lines to transfer its business from Halifax to Montreal is the acquisition of a business interest in Dart by the Canadian Pacific Railway Company;

AND WHEREAS a transfer of the business of Dart Container Lines to the Port of Montreal would not be in the economic or social interest of the City of Halifax, the region, or its citizens;

AND WHEREAS the Canadian Pacific Railway Company requires the approval of the Canadian Transport Commission for the participation in Dart Container Lines Limited;

NOW THEREFORE BE IT RESOLVED the City Council of the City of Halifax expresses its deep concern over the loss of the business of Dart Container Lines from Halifax to Montreal and its adverse economic effect on the City and the region and hereby requests the Halifax-Dartmouth Port Commission to present the position of the City to the Canadian Transport Commission."

Halifax Athletic Commission

Question Alderman Jeffrey Re: Debris located around Train Tracks

Alderman Jeffrey stated that he had referred to this matter at the April 16, 1981 Council meeting. He stated that he was experiencing a problem with debris around the train tracks in the Fairmount Subdivision, at the rear of Brook Street. He indicated that he had received a letter from Mr. C.R. Morgan stating that upon investigation of the matter CNR had said they were not responsible for this debris. He asked if the City could pick up this debris.

It was agreed that His Worship, the Mayor would forward a letter to CNR requesting that some action be taken to clean up this debris.

Alderman Flynn stated that he was having a similar problem in the Simpson's Hall area. He requested that this be included in the letter.

Question Alderman Maley Re: Lower Water Street

Alderman Maley stated that she was concerned with regards to the length of time that Lower Water Street had been dug up. She stated that this would cause traffic difficulties during the summer months particularly in the area of the Fisherman's Market. She asked when work on Lower Water Street would be completed.

She also made mention of grass cutting in the area, and asked who would be responsible for cutting the grass around the small trees in the area.

Council May/4, 1981

Ouestion Alderman Maley Re: Press Release Concerning Budget

Alderman Maley stated that she had recently read an article in the paper reporting on a statement given by Edmund Morris, Minister of Fisneries. The article indicated that the City of Halifax had made an error in the budget of \$900,000.00. Alderman Maley requested some explanation regarding this indicated mistake.

Mr. B.G. Smith, Director of Finance stated that at the time the budget had been tabled in February it had not been known what amount would be received from the Province with regard to Municipal grants. The figures shown in the February budget were based on the best available information. The revised figures from the Provincial government on April 15, 1981. He indicated that no mistake had been made.

Question Alderman Wooden Re: Herring Cove Road Construction

Alderman Wooden stated that construction of the sidewalks on the Herring Cove Road had commenced. She said that apparently this morning traffic had been backed up as a result of only one lane being opened due to this construction. She requested that staff speak to the contractor and request that both lanes remain open during peak traffic hours and work be carried on in off hours. She also stated that lighting around the construction area was poor and requested that additional lighting be supplied in order that this area not be a hazard to traffic.

Question Alderman LeBlanc Re: Granville Street Construction

Alderman LeBlanc voiced concern regarding the apparent slow progress with the construction being carried out on Granville Street. He asked who was responsible for supervising this construction and requested that the construction be speeded up.

Mr. P. Calda, City Manager indicated staff are in touch with the contractor from time to time and would continue checking on the construction to ensure that it stayed on schedule.

Question Alderman LeBlanc Re: Tender for Paper

Alderman LeBlanc stated that an advertisement for tender in the Mail Star for 14 million sheets of paper had caught his attention. He said that he felt this was excessive and questioned as to whether or not, considering the present budgetary constraints, this number could not be reduced. He also asked if this number was settled upon by some scientific calculations, and if so could Council see these.

Council May May/4, 1981

Mr. P. Calda, City Manager replied that this information would be made available to Council once the tender call had been closed and it came to Council for a decision. He also pointed out that this paper not only included paper for central administration but also paper for Boards and Commissions. Mr. Calda advised staff would report on the funds involved.

Question Alderman O'Malley Re: T.P. Calkin Building

Alderman O'Malley stated that he had received a number of complaints about the T.P. Calkin Building, Lady Hammond Road which had recently been closed up. He asked what was going to happen to this building and if on the permit to close there was a date designating reopening or disposal of the building.

Mr. P. Calda indicated that he would have that information the next day.
