## ORDINANCE NO. 36.

Of the Regulation and licensing of Automatic Machines.

Motion passed,

- The words "automatic machine" as used in this ordinance shall mean any pinboard or other automatic or slot-machine(so called) which is operated by the introduction of a coin or coins, or a counter or counters, or a slug or slugs, but shall not include automatic scales, telephone apparatus, gas or electric meters (so called), nor automatic gramaphones, phonographs or pianos, not those things the use or keeping whereof is prohibited by law for the reason that they constitute gamiling devices or for any other reason.
- No person shall in the City of Halifax operate or cause or permit to be operated any automatic machine, as hereinbefore defined, unless a license has been obtained permitting such machine to be operated. Such license shall be obtained by the owner of such machine.
- The fee to be paid for the licanse for each automatic machine shall be Fifty Dollars (\$50.00) and such fee shall be paid to the City Collector and the license shall be issued by the official designated by the Council to sign and issue the same.
- 4. Each license shall state clearly the location at which such automatic machine is proposed to be operated and such machine shall not be operated in any location other than that stated on such license; provided however, that if the owner of such machine desires to operate the same or permit the same to be operated in a location other than that stated in the license issued for such machine, the official who issued such license, on the request of such owner, shall endorse such change of location upon the license, and thereafter such machine may be operated in such new location.
- When any license is issued under this ordinance the official issuing the same shall deliver with the license to the person to whom such license is issued a metal plate bearing the words "licensed automatic machine" and the civic year in which the

license was issued together with a number, and such person shall before operating the automatic machine for which the license was issued or permitting the same to be operated affix or cause to be affixed such metal plate in a conspicuous place upon such machine. It shall be a violation of this ordinance for any person to affix tuch metal plate to any automatic machine other than to that in respect of which the same was issued. Any person who operates or permits to be operated any automatic machine for which any such metal plate has been issued without such plate being affixed to such machine shall be guilty of a violation of this ordinance.

- description of the automatic machine so licensed, with its serial number and other identifying features, and the particulars of such machine, together with the number of such license and the number of the metal plate issued therewith, and the location authorized, shall be entered by the official designated to assue such license in a register kept by him for that purpose. Every change of location of licensed machines shall also be entered in such register.
- 7. It shall constitute a violation of this ordinance for any owner of an automatic machine to operate the same or permit the same to be operated in any location other than that stated upon the license issued in respect of such machine.
- S. If any machine in respect of which a license under the authority of this ordinance has been issued, is used or operated for any purpose prohibited by law or if the owner of the same fails to comply with any of the provisions of this ordinance, the Chief of Folice may direct that the license issued in respect of such machine shall be forthwith suspended for such period as he shall determine or cancelled and upon such direction being served upon or mailed to the owner of such machine any further use or operation of such machine during the period of suspension or cancellation shall constitute a violation of this ordinance by such licensee.
- 9. Every person who contravenes or fails to comply with any provision of this ordinance shall for each such offence be liable to a penalty not exceeding Five Hundred Dollars and in default of payment to imprisonment for a periot not exceeding one year.
- 10. This Ordinance shall be known as Ordinance No. 36.

## ORDINANCE NO.34.

Respecting Children under 14 years of age being on the Streets of the City at night.

BE IT ENACTED by the Mayor and City Council of the City of Halifax as follows:-

- Except as nereinafter provided no person under the age of fourteen years shall be upon any street in the City of Halifax between the hours of half-past seven of clock in the afternoon, Atlantic Standard Time, and six of clock in the following morning, Atlantic Standard Time.
- The provisions of Section 1 of this Ordinance shall not apply to any person under the age of fourteen years or to the parents, guardians or persons with whom such person resides who is on any street between the hours aforesaid and who is accompanied by a person over eighteen years of age in charge of such person, or to any such person under the age of fourteen years who, between the hours aforesaid, is retarning directly to his place of residence, having left such place of residence prior to the hour of half-past seven of clock in the afternoon, Atlantic Standard Time.

The Chief of Police shall issue to any person under the age of fourteen years who is engaged in the employment of messenger boy, errand boy, clerk or similar occupation with the consent of his parents or guardians, a certificate setting forth such employment and consent, and such person shall be exempt from the operation of this ordinance. Such certificate must be produced and shown to any Police Officer when the same is requested.

4. It shall be lawful for any Police Officer of the City of Halifax to take into custody any person under the age of fourteen years who is found upon any street in the said City of Halifax on any day between the hours mentioned in the first section of this ordinance.

This Ordinance shall be known as Ordinance No. 34.

Ordinance No. 34 as heretofore enacted 6. and the amendments thereto are hereby repealed.

# BORROWING RESOLUTIONS

Read report of the Finance and

Executive Committee submitting borrowing resolutions.

Halifax, N. S., July 10th, 1940.

Gentlemen 3-At a meeting of the Finance and Executive Committee held this day, the attached letter

from the Commissioner of Finance and Accounts submitting a resolution covering various borrowings was considered.

Your committee recommends that the resolution as submitted be approved.

WHEREAS the Reserve Fund of the City as defined by Section 334 of the City Charter as it is enacted by Chapter 60 of the Acts of 1934 may amount to \$150,000.00 and on April 30th, 1940, after deducting the value of taxes outstanding on properties acquired at tax sale, amounted to less than such sum.

AND WHEREAS the purpose of the said Reserve Fund is to enable its trustees to make advances to the City, without interest, in anticipation of the collection of taxes for any civic year on account of which taxes are owing in excess of the Reserve Accounts therefor.

AND WHEREAS the City has required and will require the use of any amount to the credit of the said Reserve Fund during the current civic year, for the purpose of financing uncollected taxes in respect of one or more civic years for which there are uncollected taxes, of a value greater than that of the Reserve Accounts therefor.

THEREFORE BE IT RESOLVED that the City Treasurer be authorized to arrange for a continued borrowing from the said trustees of the said Reserve Fund up to the sum of \$150,000.00 and advance the same to any civic year requiring the same for the purpose of financing expenditures that were, by law, required to be made in any year before the taxes were collected.

WHETEAS it is necessary for the purpose of defraying expenditures for which the taxes of the current year 1940-41 would, if now collected, be applied, that the City of Halifax do borrow, under Section 332 of the City Charter from the Royal Bank of Canada a n amount not to exceed in any event thirty percent of such taxes for the current year 19 40-41 or ninety percent of such taxes uncollected at the time of such borrowing.

AND WHEREAS the taxes for the current year 1940-41 amount to the sum of \$2,396,046.76 of which amount the City is authorized to borrow thirty percent, namely \$718,814.03.

AND WHEREAS it is necessary, for the purpose of financing expenditures for which the taxes of the civic year 1939-40 would, if now collected, be applied, that the City of Halifax continue to borrow under Section 332 of the City Charter from the Royal Bank of Canada, an amount not exceeding ninety percent of the uncollected taxes uncollected at the time of such borrowing in respect of the said civic year.

AND WHEREAS on June 1st, 1940, the uncollected taxes for the civic year 1939-40 amounted to \$516,912.43 enabling the City to continue to borrow ninety percent thereof, namely the sum of \$465,221.19.

of the civic year 1940-41 that the City of Halifax do borrow from the Royal Bank of Canada up to the sum of \$650,000-00 available from time to time, in such sums as may be required, to be applied in defraying expenditures for which the taxes for the said civic year, if now collected, would be applied.

AND SE IT FURTHER RESOLVED In respect of the civic year 1939-40 that the City of Halifax do also borrow from the Royal Bank of Canada the sum of \$350,000.00 for expenditures already defrayed and for which the taxes for the said civic year, if now collected, would be applied.

AND BE IT FURTHER RESOLVED that the sums so borrowed from time to time be repaid to the said Royal Bank of Canada out of the taxes for the aforesaid years when collected, and that the City Treasurer be and is hereby authorized on behalf of the City of Halifax to negotiate the said loan and to pledge the credit of the City of Halifax therefor; the amount to be borrowed under this resolution to be at no time more than 90% of the amount of the taxes of the City uncollected at any time during the term of borrowing; and the interest to be paid on the aforesaid loan to be at a rate as agreed between the Bank and the City.

Charter it is enacted that whenever money is required to be borrowed to meet the amount of the deferred obligations of abutters for Local Improvements, the City may borrow from any bank or fund agailable, the amount required, for such purpose and apply the same to the performance of such work and repay the money so borrowed from the monies collected from such abutting owners,

THEREFORE RESOLVED that the City Council, on the recommendation of the Committee on Finance do approve of the City Treasurer arranging with the Royal Bank of Canada for a loan not exceeding the sum of \$100,000.00 which interest will be payable at the rate as agreed by the Bank and the City.

WHEREAS it is necessary for the purpose of maintaining the water service to borrow in anticipation of the collection of water rates for any year, from the Royal Bank of Canada, under Section 679 of the City Charter, an amount otr amounts as from time to time required, not exceeding \$50,000.00.

THEREFORE BE IT RESOLVED that the City Treasurer be authorized to arrange with the said Bank for a loan not exceeding the amount of \$50,000.00; said loan to be repaid as speedily as possible from the collection of water rates; the interest to be paid on the said loan at a rate as agreed between the Bank and the City.

# BEQUEST - CITY OF HALIFAX TUBERCULOSIS HOSPITAL

Read letter from the City Solicitor re bequest to City of Halifax Tuberculosis Hospital.

His Worship the Mayor, and Members of the City Council.

Gentlemen:-

Under the last Will and Testament of the late Agnes Y. Thomson a bequest was made to the City of Halifax Tuberculosis Hospital. The principal of this amount is \$5000.00 and under the terms of the Will the income from this money, less costs and expenses, is to be used to provide fruit, confectionery and temperance drinks from time to time each year for the patients in the said City of Halifax Tuberculosis Hospital, provided however, that in case the said City of Halifax at any time fails to provide for a period of six months fruit, confectionery and temperance drinks for the patients in the Tuberculosis Hospital with the income provided from the said share, then the corpus of the said share shall be divided and distributed equally between other beneficiaries under the Wills

The Eastern Trust Company is Trustee under the Will and they propose to pay the income from this fund quarterly in January, April, July and October. They have requested that a statement be furnished each quarter showing the purchases made in order that they can make certain that the provisions of the Will are being complied with. I took this matter up with the Commissioner of Finance and Accounts and he has suggested that I write to the City Council so that the City Council can deputize the Superintendent of Health and the City Treasurer as the persons to receive this money and see to it that the terms of the bequest are carried out. I would therefore recommend that the City Council authorize and instruct the City Treasurer of the City of Halifax to receive the bequests under the said Will and to make available to the Superintendent of Health the said funds so that such Superintendent of Health may expend the same to comply with the terms of the Willa

I would further recommend that the Superintendent of Health be instructed to prepare and submit to the Eastern Trust Company, trustee under the said Will, a quarterly statement showing how the said funds were applied in the three months previous to the date of such statement.

T have Sorwarded the second payment of income to the Commissioner of Finance and Accounts, and upon the adoption of the recommendations in this letter I will advise the Eastern Trust Company to forward the cheques in the fubube direct to the City Treasurer.

#### LETTER, HIS WORSHIP THE MAYOR RE MAYORS CONFERENCE

Read letter from His Worship the

Mayor as follows:-

July 6th, 1940.

To the Members of the Halifax City Council:

Dear Aldermen:~

I wish to take this opportunity of acquainting you, in a general way, with the proceedings at the Conference of Mayors, held at Ottawa, June 11th to 13th.

I was accompanied to the Convention by the City Solicitor, the Commissioner of Finance and Accounts and the City Assessor. We were cordially received on our arrival by the Executive officers of the Association and by many other Mayors who have attended this meeting on other previous occasions.

I found, on arrival, that I was appointed Chairman of the Resolutions Committee and also a member of the Committee appointed to meet the members of the Dominion Cabinet, and also to preside over one session of the Conference.

Perhaps the most interesting event at the Conference was the opportunity given to us to meet Honourable F. H. LaGuardia, the Mayor of New York City, at a small reception given by Mr. & Mrs. John Farr Simmons, the United States Charge D'Affaires at Ottawa. I was fortunate in having the opportunity of meeting Mayor LaGuardia and found that his attitude as an American was most encouraging to our own Country, Canada, in these most difficult times.

The entry of Italy into the War and the untimely and tragic death of Hon. Norman Rogers, Minister of National Defence, cast a deep shadow over the proceedings of the Convention and it was felt by all present that, in view of world conditions at this time, the interests of Canada and of our own Municipalities would be more greatly assisted by indicating to the Government of Canada our willingness to serve Canada in its war effort rather than our desire to have granted the many requests for Federal assistance which were submitted to the Conference. As a result the following resolution was unanimously passed:-

"THAT we, the Canadian Federation of Mayors and Municipalities representing the whole of the Dominion of Canada, in annual conference here assembled, hereby declare our unswerving loyalty to His Majesty the King, and the Government of the Dominion of Canada. We desire to express to the Government that we support to the fullest extent the efforts of the Government in its arduous task in facing the present difficult and critical condition. We particularly request, and will welcome, any suggestions which the Government may wish to put forward in order that the Municipabities of the Dominion of Canada may to the fullest extent co-operate in any manner in their power to assist the Government in co-ordinating all its efforts toward the common end, fully realizing that the whole resources of the country ought to be utilized for the successful prosecution of the war".

was accordingly constituted and instructed to convey this resolution to the Government of Canada. This was done and was received on behalf of the Government with deep appreciation.

In answer to the request for suggestions as to how the Mayors of Canada could help in the present erisis, Hon. J. L. Ralston, Minister of Finance, urged the fullest support for the purchase of War Savings Certificates. Hon. Norman McLarty, Minister of Labor, expressed on behalf of the Government its sympathy and understanding for any effort to develop youth fitness.

Perhaps the most important manner in which the Mayors of Canada can assist is in the keeping up of the morale of the citizens of Canada, by stamping our everything of a subsersive nature and by educating our people not to refer to nor permit anybody else to say anything which will in any way have a subsersive influence upon or impede any work which may be attempted in connection with the War.

The delegates to the Conference were entertained at a luncheon as guests of the City of Ottawa and were privileged to hear a most inspiring, sympathetic and encouraging address by Mayor LaGuardia, the theme of which was the fact that the Allies could expect the fullest co-operation of the Unites States of America in their execution of the War.

As a mark of respect to the Late Honourable Norman Rogers, the delegates to the Convention attended the funeral service in a body.

The business sessions of the Conference were given over to the discussion of many important matters of interest to municipalities and many of the delegates took part.

From our point of view, perhaps the most important matter was the consideration of the Report of the Royal Commission on Dominion Provincial Relations. Although it was felt in some quarters that the full implementation immediately of this report might possibly detract from Canada's war effort, nevertheless after considerable discussion the following resolution was passed:-

"WHEREAS the report of the Royal Commission on Dominion Provincial Relations has been tabled in Parliament; and

WHEREAS the said Report makes recommendations which, if implemented, would materially assist the proper functioning of all units of government in Canada; and

WHEREAS more particularly the said report recognizes the financial difficulties of the municipalities of Ganada, resulting in large part from the burden of unemployment relief costs and other burdens imposed upon municipalities; and

WHEREAS the report further recommends that the Dominion Government assume the total cost of unemployment relief insofar as "employables" are concerned;

BE IT THEREFORE RESOLVED - That the Canadian Federation of Mayors and Municipalities request the Dominion Government to institute the necessary proceedings for implementing the recommendations of the Commission, and request further that in such implementation the word "employable" be defined in such a way that the burden upon municipalities will be materially decreased in accordance with the intent and spirit of the said Report; and further that pending the implementation of the recommendations of the report, the Dominion Government immediately assume the entire cost of unemployment relief ".

Resolutions were also passed recommending the following:-

- (a) The continuance of the facilities of the Municipal Assistance Act and Federal loans at 2% thereunder;
- (b) Establishment of Home Guard units in places where garrisons do not exist as a protection against sabotage;

- (c) The institution of a nationally subsidized housing scheme for the building of homes to be rented to people of low income;
- (d) The amending of the regulations under the Dependents Allowance Act affecting the personnel of the Active Service Force to include all bona fide dependents.
- (e) A revision of the current rating re Passports for the United States;
- (f) That upon demobilization, if possible, persons who will become a public charge should not be discharged until such persons can be absorbed in industry;
- (g) That the minimum age for Old Age Pensions be reduced from 70 to 65 years and the amount of the monthly pension increased from \$20.00 to \$25.00;
- (h) That the incidence of the sales tax of 8% under the Special War Revenue Act of 1939 be changed so far as domestic electricity and gas is concerned so that it may be applied on a kilowatt cubic foot or other usage basis only rather than on the amount of the bill;
- (i) That all Canadian bondholders of Government bonds payable in U.S. funds, be urged to forego their option for the duration of the war and accept payment in Canadian funds;
- (j) That the Federal Government be requested to provide adequate protection to all public utility properties irrespective of whether they are federally, provincially, municipally or privately owned;
- (k) The Unemployment Insurance be introduced in Canada;
- (1) That the Convention approve of assisting, protecting and directing child refugees of the Empire and its Allies by all Governmental bodies in Canada:
- (m) That the National Housing Act be continued;
- (n) That a study be made to determine the advantage of having basic Fire Insurance Rates fixed by the various Insurance Departments;
- (o) An expression of appreciation be extended to those who assisted the success of the Convention;

All of the above resolutions were carefully debated and were given consideration before being finally adopted. I was impressed by the similarity in the problems of other cities and towns in other parts of Canada as compared with our own.

July 11th, 1940.

At the same time, I could not help but observe that all portions of Canada have not received equivalent treatment from the Government of Canada.

I am convinced that a Conference such as this has a definite value and of benefit to the Mayors and Officials who attend the same, and I trust that at least for the immediate future, this City will be represented at its meeting.

The owner of any motor-drawn vehicle used for transporting for hire passengers who operates or permits the same to be operated for transporting for hire passengers, without the same having installed in it an approved taximeter or ~138**~** 

in which is installed a taximeter which shows a variation in the correctness thereof of more than five percent (5%) shall be liable to a penalty of not less than Fifty Dollars (\$50.00) and not more than One Hundred Dollars (\$100.00), and in default of payment of such penalty to imprisonment for a term not exceeding three months.

I meg to report on a petition from property owners on Connaught Avenue, between Quinpool Road and Chebucto Road, asking that this street be accepted as a City street and that concrete sidewalks, curbs and gutters be laid, that the attached plan shows the properties owned by the signatories colored red.

This street is now very nearly completely built up and the assessed value of the properties excluding those fronting on Quinpool Road is nearly \$150,000.00, and in the interests of both the property owners and the public it would appear that the time has arrived to make improvements in this portion of Connaught Avenue, which will be a continuation of those already made in the portion of the Avenue between Jubilee Road and Quinpool Road.

July 30th, 1940. A reference to the plan will show that before the street can be accepted as a City Street it will be necessary to acquire portions of five properties as follows300 The heirs of John Doull, -c/o Donald MacInnis The heirs of John Henry Sutherland Estate of D. C. Woodill John Simoh - between Becond and Third Streets. John Simon - between Third and Fourth Streets. There is some difficulty in getting in touch with the owners of the Sutherland and Woodill properties and I am unable to reach any agreement which could be considered satisfactory by the City, with John Simon. With regard to the Doull property, the representative is prepared to take Seven Hundred Dollars (\$700,00) for the lot which fronts on Quinpool Road, After consultation with the City Assessor this is considered a very fair price and it is recommended that the City punchase the lot for this amounte Owing to the difficulty in finding the representatives of the Sutherland and Woodill properties, it is recommended that the portion of these lots required, be expropriated, and that the sum of Three Rundred Dollars (\$300.00) be paid into Court for each of them. lots on the west side of the street belonging to It is also recommended that the two John Simon be expropriated and that the sum of Two Thousand One Hundred and Sixty Dollars, (\$2,160.) be paid into Court as a fair price for the two lots. It is further recommended that the City Solicitor be instructed to prepare the formal resolutions for submission to Council. The estimated cost of the construction of concrete curbs, gutters and sidewalks and sodding on both sides of the street between Quinpool Road and Chebucto Road is \$9,500,00 of which the City's share would be about one-half. - The words "automatic machine" as used in this ordinance shall mean any pinboard or other automatic or slot-machine (so-called) which is operated by the introduction of a coin or coins, or a counter or counters, or a slug or slugs, but shall not include automatic scales, telephone apparatus, gas or electric meters (so-called), nor automatic gramophones, phonographs or pianos, nor those things the use or keeping whereof is prhobited by law for the reason that they constitute gambling devices or for any other reason.
- No person shall in the City of Halifax operate or cause or permit to be operated any automatic machine, as hereinbefore defined, unless a license has been obtained permitting such machine to be operated. Such license shall be obtained by the owner of such machine.
- The fee to be paid for the license for each automatic machine shall be Fifty Dollars (\$50.00) and such fee shall be paid to the City Collector and the license shall be issued by the official designated by the Council to sign and issue the same.
- Each license shall state clearly the location at which such automatic machine is proposed to be operated and such machine shall not be operated in any location other than that stated on such license; provided however, that if the owner of such machine desires to operate the same or permit the same to be operated in a location other than that stated in the license issued for such machine, the official who issued such license, on the request of such owner, shall endorse such change of location upon the license, and thereafter such machine may be operated in such new location.
- When any license is issued under this ordinance the official issuing the same shall deliver with the license to the person to whom such license is issued a metal plate bearing the words "licensed automatic machine" and the civic year in which the license was issued together with a number, and such person shall before operating the automatic machine for which the license was issued or permitting the same to be operated affix or cause to be affixed such metal plate in a conspicuous place upon such machine. It shall be a violation of this ordinance for any person to affix such metal plate to any automatic machine other than to that in respect of which the same was issued. Any person who operates or permits to be operated any automatic machine for which any such metal plate has been issued without such plate being affixed to such machine shall be guilty of a violation of this ordinance.

Every change of location of licensed machines shall also be entered in such register.
- 7. It shall constitute a violation of this ordinance for any owner of an automatic machine to operate the same or permit the same to be operated in any location other than that stated upon the license issued in respect of such machine.

Ty of this ordinance has been issued, is used or operated for any purpose prohibited by law or if the owner of the same fails to comply with any of the provisions of this ordinance, the Chief of Police may direct that the license issued in respect of such machine shall be forthwith suspended for such period as he shall determine or cancelled and upon such direction being served upon or mailed to the owner of such machine any further use or operation of such machine during the period of suspension or cancellation shall constitute a violation of this ordinance by such license.
- to comply with any provision of this ordinance shall for each such offence be liable to a penalty not exceeding Five Hundred Dollars and in default of payment to imprisonment for a period not exceeding one year.

# LEASE TO BOARD OF SCHOOL COMMISSIONERS

Read letter from the City Solicitor

as follows:-

August 15th, 1940.

His Worship the Mayor, and Members of the City Council, City Hall, Halifax, N. S.

Gentlemen:-

With reference to the contemplated high school building to be erected on a portion of the Halifax Common known as Camp Hill, it is necessary that a lease be executed between the City and the Board of School Commissioners.

In the year 1932 permission was given to the Nova Scotia College of Art to use this area for the purpose of erecting a School of Art. This project has not been proceeded with and the Board of the College of Art have signified their willingness to relinquich their rights in and to the said property so that it may be transferred to the Board of School Commissioners. This has also been approved by the Committee of the Privy Council which adopted the recommendation of the Minister of National Defence to this end.

I would therefore recommend that the City Council authorize the Mayor and Clerk to execute a lease to the Board of School Commissioners, leasing the area in question at the intersection of Bell Road and Robie Street for a term of ninety-nine years, as authorized by Section 28 of Chapter 70 of the Acts of 1931, as amended by Section 28 of Chapter 57 of the Acts of 1940, at an annual rental of \$1.00 per year, the terms of the lease to be satisfactory to the City Solicitor.

- AND WHEREAS by the Acts of the Province of Nova Scotia passed in the year 1938, Chapter 58, Section 56 and Schedule, the City of Halifax was authorized to borrow a sum not exceeding One Hundred Thousand Dollars (\$100,000.00) for the extension or improvement of the water service, and the City has heretofore under the said authority and for the said purpose borrowed on the 2nd day of January, A. D. 1939, the sum of Twenty-five thousand dollars (\$25,000.00) and on the 18th day of December, A. In view of the question as to assessment for water extension the matter of extending the sewer and water along Warden Street and Leamon Street was postponed. Five houses are now under construction on the east side of Leamon Street south of Warden Street and it is advisable that the sewer and water be extended to service these houses.

The length of sewer required is about 460 feet. The estimated cost is \$3100; estimated assessment \$1700.

The water extension if made in the same trench is estimated to cost \$1600; frontage assessment \$680. Estimated cost to the City \$920.

At a meeting of the Committee on Works held on July 25th, 1940, a motion by Alderman Lloyd that the Committee on Works recommend to Council that the City of Halifax enter into a lease of agreement with the Halifax Aero Club, subject to the Defence of Canada regulations, on a rental basis of \$1.00 per year for the duration of the war and that rentals, at present outstanding because of the previous lease, be cancelled, was defeated and a motion that a sub-committee be appointed by the Mayor to discuss with officials of the Halifax Aero Club a lease of the Airport and report back to the Committee on Works before next Council meeting was approved.

In accordance with this resolution the Mayor appointed the following committee:

The Mayor, Alderman A. M. MacKay, Alderman H. W. Freda and Commissioner of Works.

This committee met with representatives of the Halifax Aero Club in the Mayor's Office at ll o'clock A.M. on Friday, August 9th.

A full discussion of the various points in connection with leasing the Airport was had.

The rental owing to the City by the Halifax Aero Club as of the 1st of September, 1939, was \$1062.57. It also developed that during the past year the Club accounts showed a surplus.

It was decided by the Committee that it would recommend that the Airport be leased to the Halifax Aero Club as and from the 10th day of July, 1940, on the following terms:-

That the Club will release all claims to any buildings erected by it on the property of the Airport and that the same will become the property of the City, this to be considered as offsetting the claim of \$1062.57 for outstanding rental to September 1st, 1939.

The Club will pay to the City a yearly rental of \$1200, payable monthly at the rate of \$100. per month, the Club to assume the management of the Airport, during the term of the lease.

The lease to be for one year and subject to renewal from year to year at the option of the City.

These conditions were agreed to by the representatives of the Halifax Aero Club.

Your sub-committee recommend that the Committee on Works agree to the conditions set out and forward same to City Council for its approval.

The expropriated street which is bounded by the
official lines leaves a portion of the dedicated
street north of the official north line of Inglis
Street, but land between the north line of the

lying to the northward and it is of no use to the
City. It would prevent buildings being erected on the
north side of Inglis Street, to a uniform set-back
from the street line.

Plan KK-1-8846 has been prepared, which shows the new and the old lines of the street.
