#### 6.1 Case 17007: Telecommunication Tower – 9 Estates Road, Sackville

A staff report dated June 21, 2011 was before the Committee.

Ms. Jacqueline Belisle, Planner, presented the report to the Committee.

In response to questions regarding co-location with an existing tower, it was noted that each option was examined and one tower is currently at maximum capacity and the second is unable to provide the height needed for the necessary coverage.

In response to questions regarding the dismantling of the tower should the company go bankrupt, it was noted that there is no current municipal requirement put in place to state if a company goes bankrupt who would have to be in charge of dismantling of the tower.

In response to questions regarding future development of buildings within the height range of the town should it collapse, it was noted that currently there is no policy put in place. As well, that HRM is currently working on a functional plan to deal with telecommunication towers and this is an issue that will be address in that plan.

EastLink for the construction of a new 60 meter (197 foot) self support telecommunication tower and associated equipment cabinet at 9 Estates Road (PID# 00635201), Sackville, as shown on Map 1 and Attachment B of the June 21, 2011 report.
